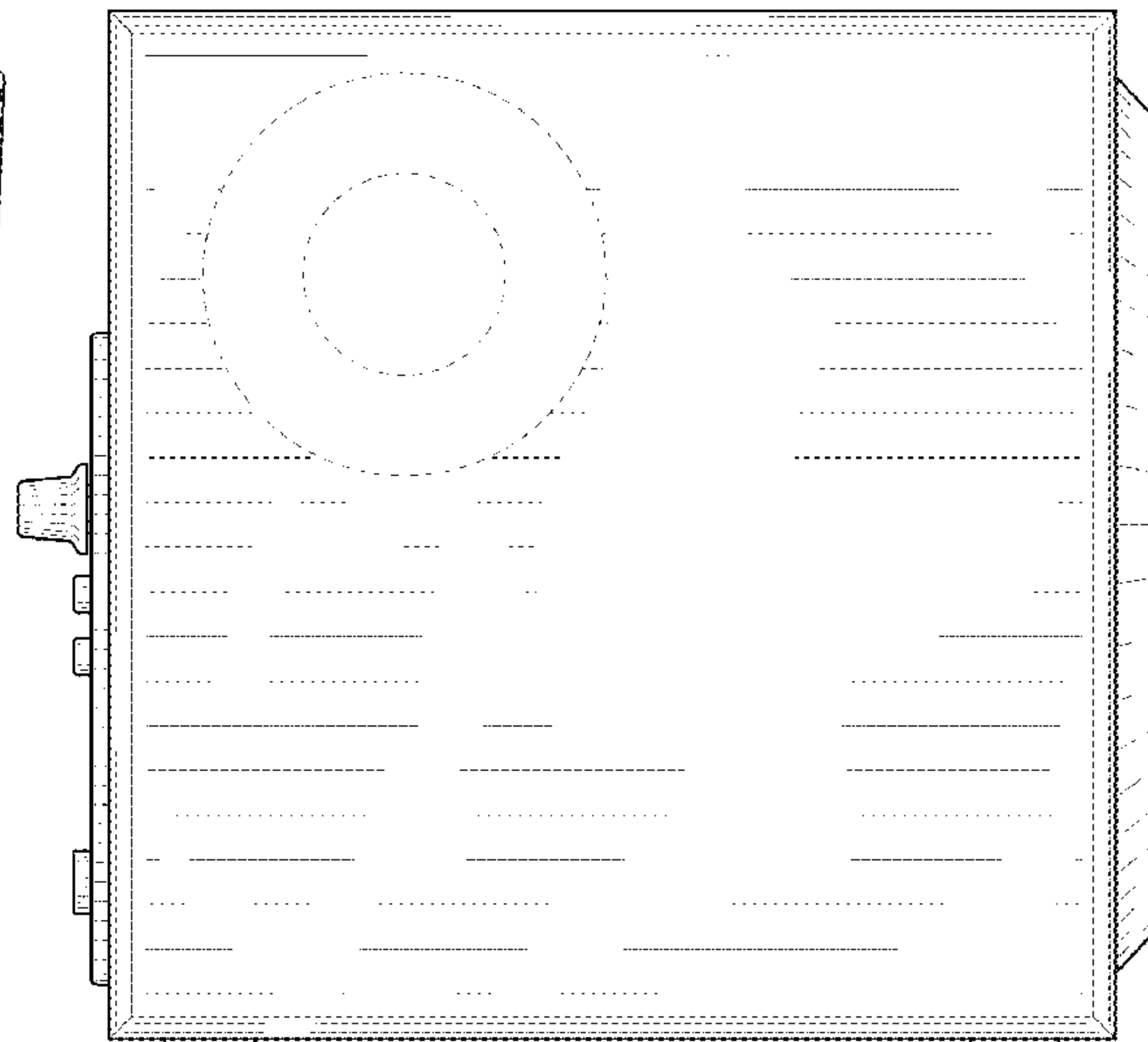
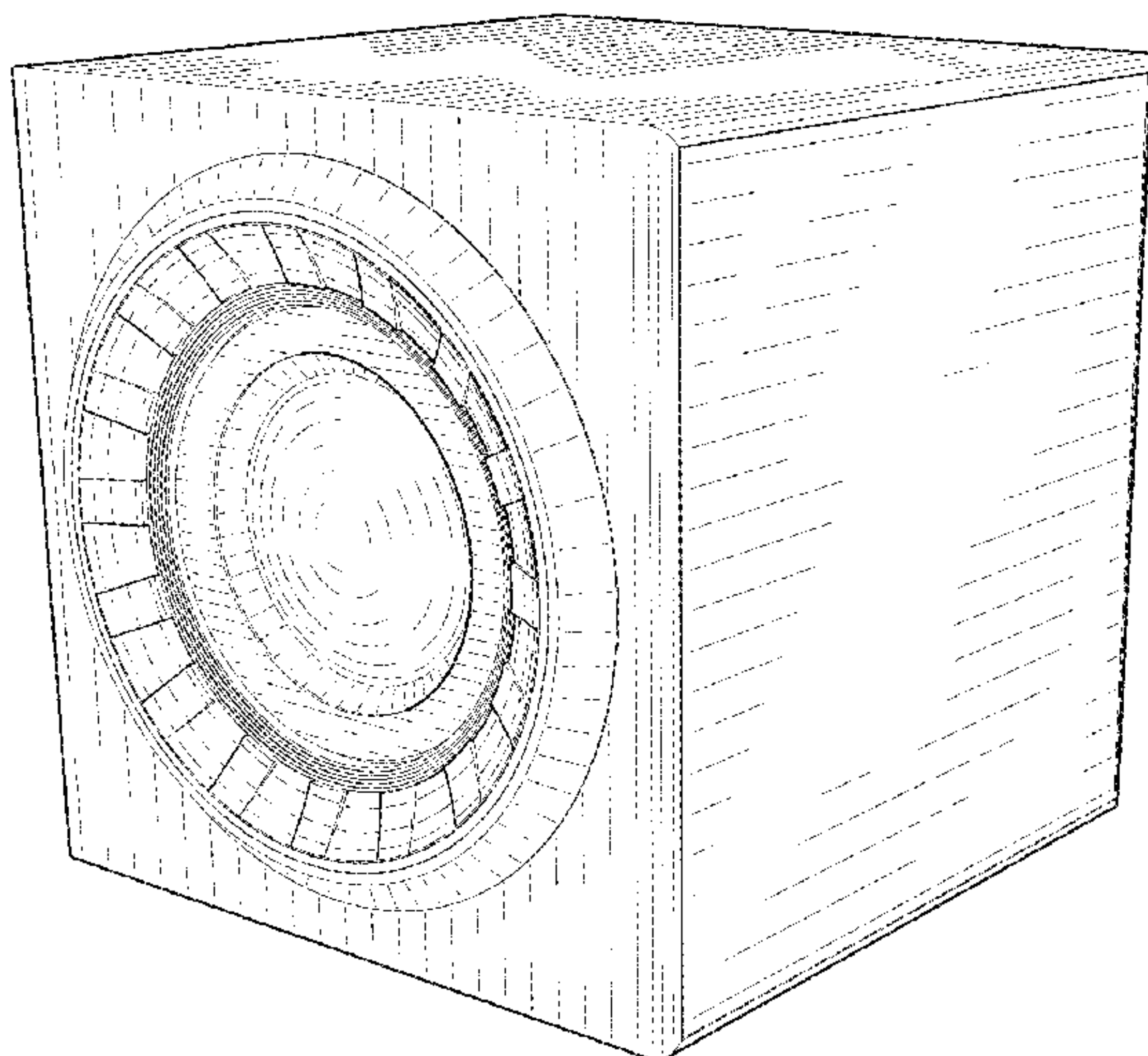
The ornamental design for a subwoofer, as shown.

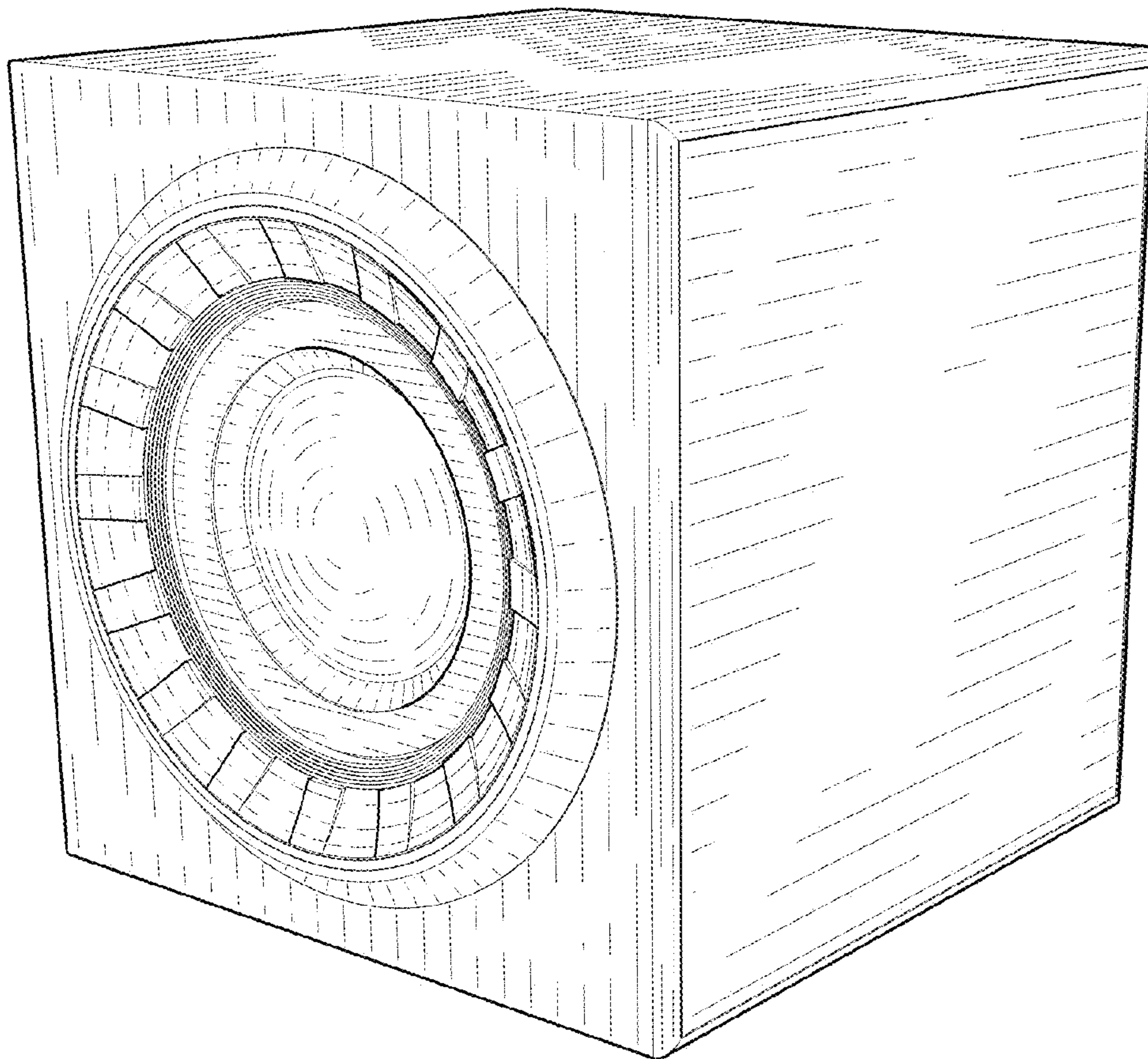

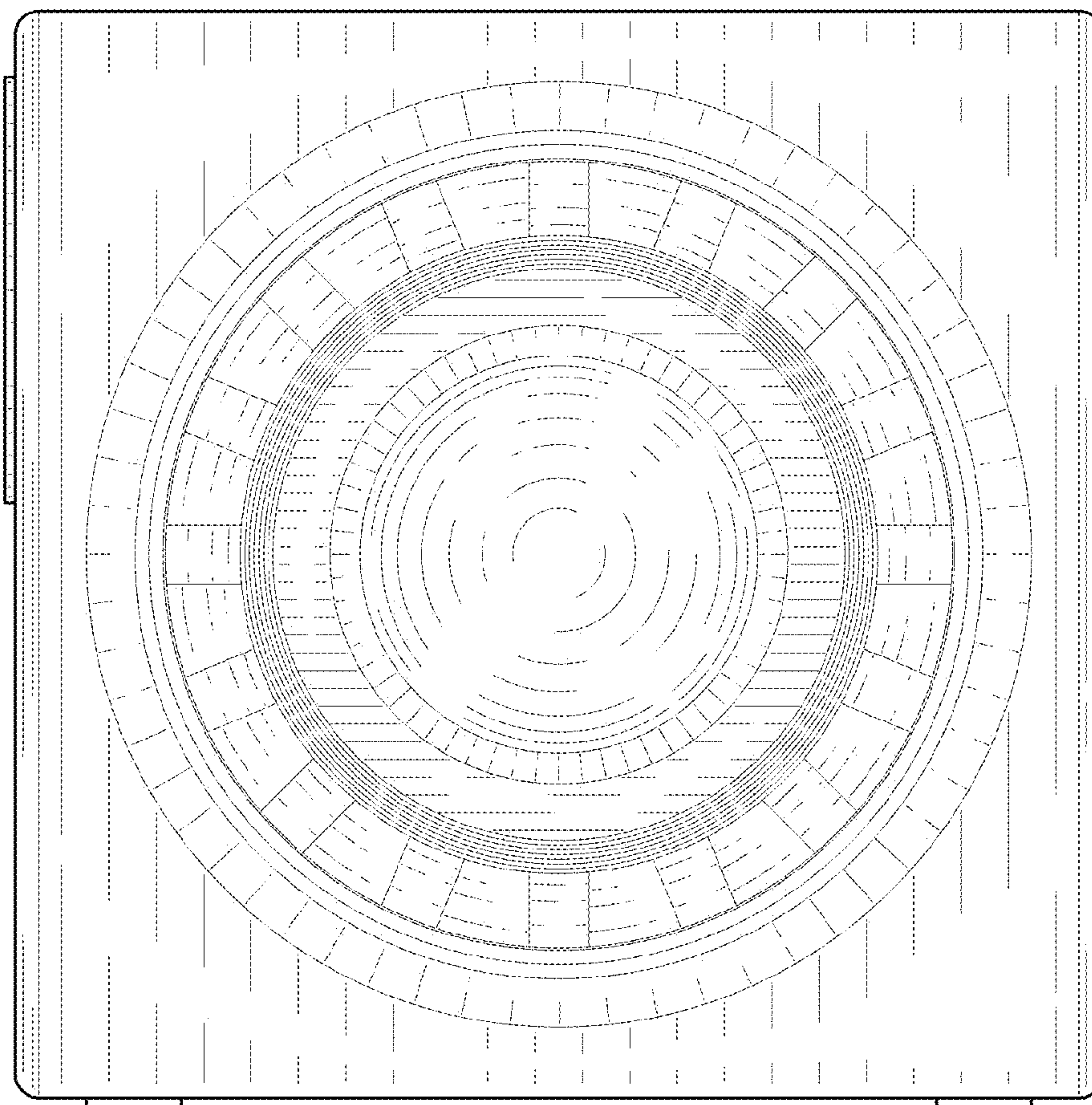

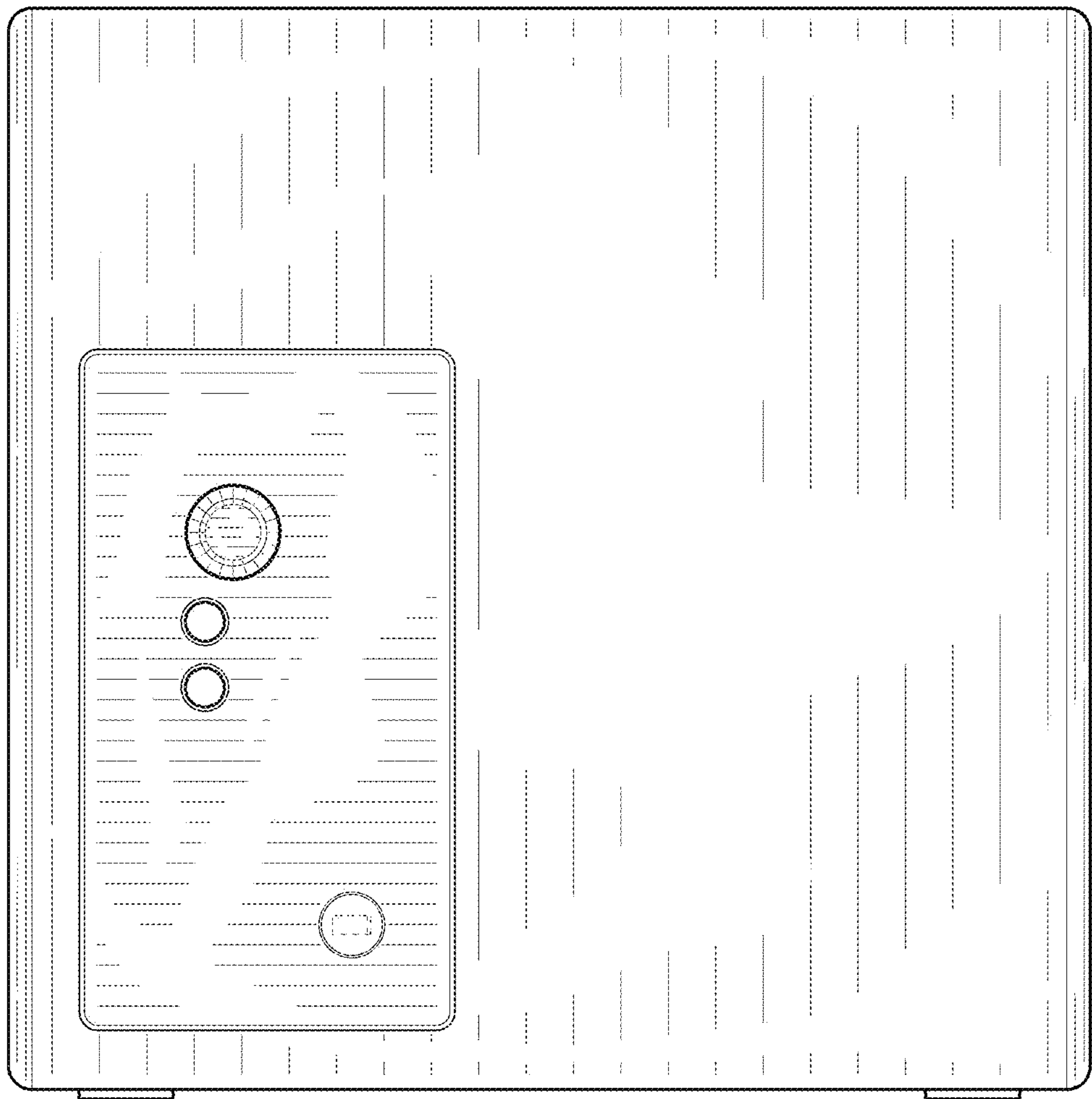

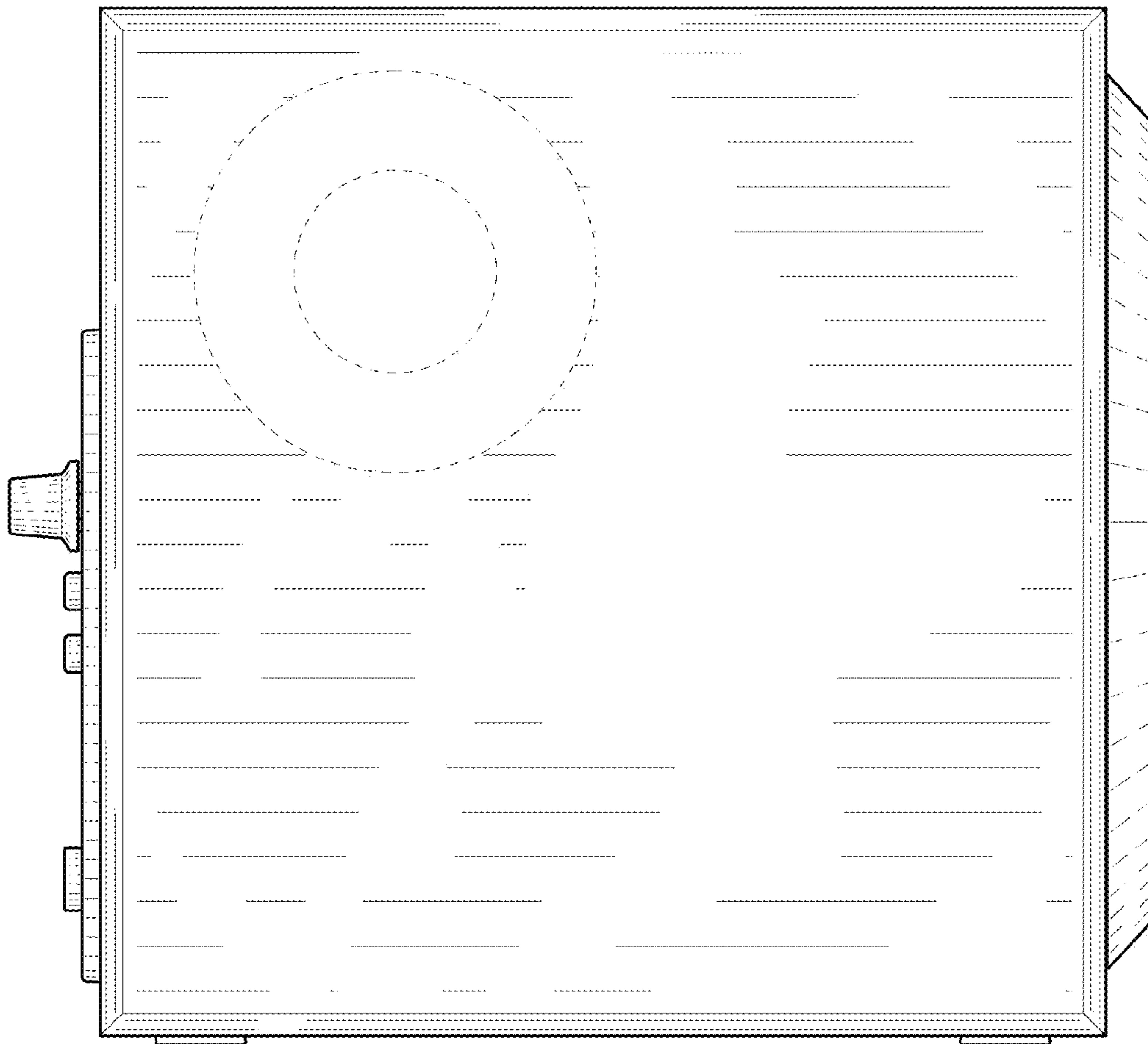

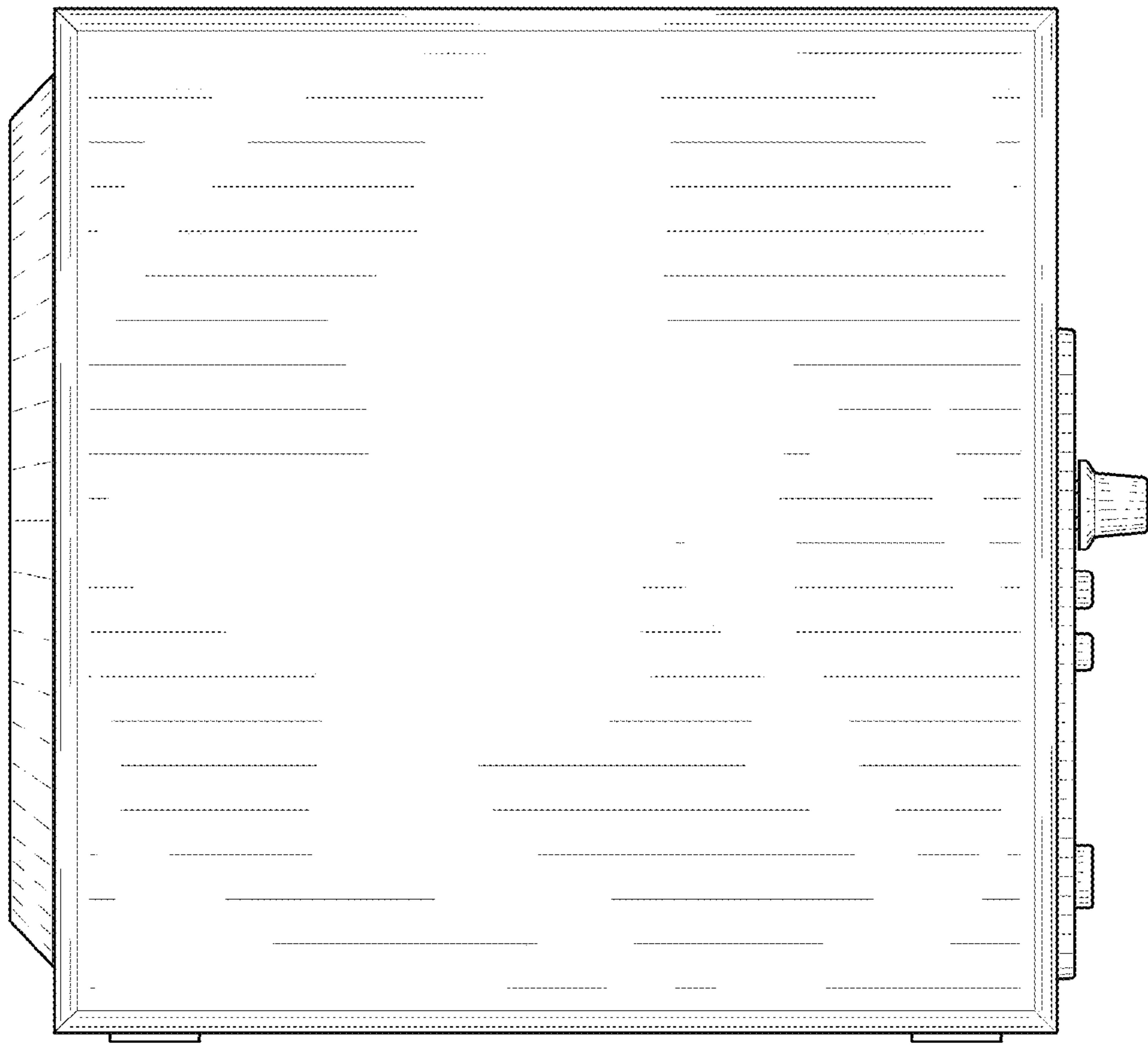

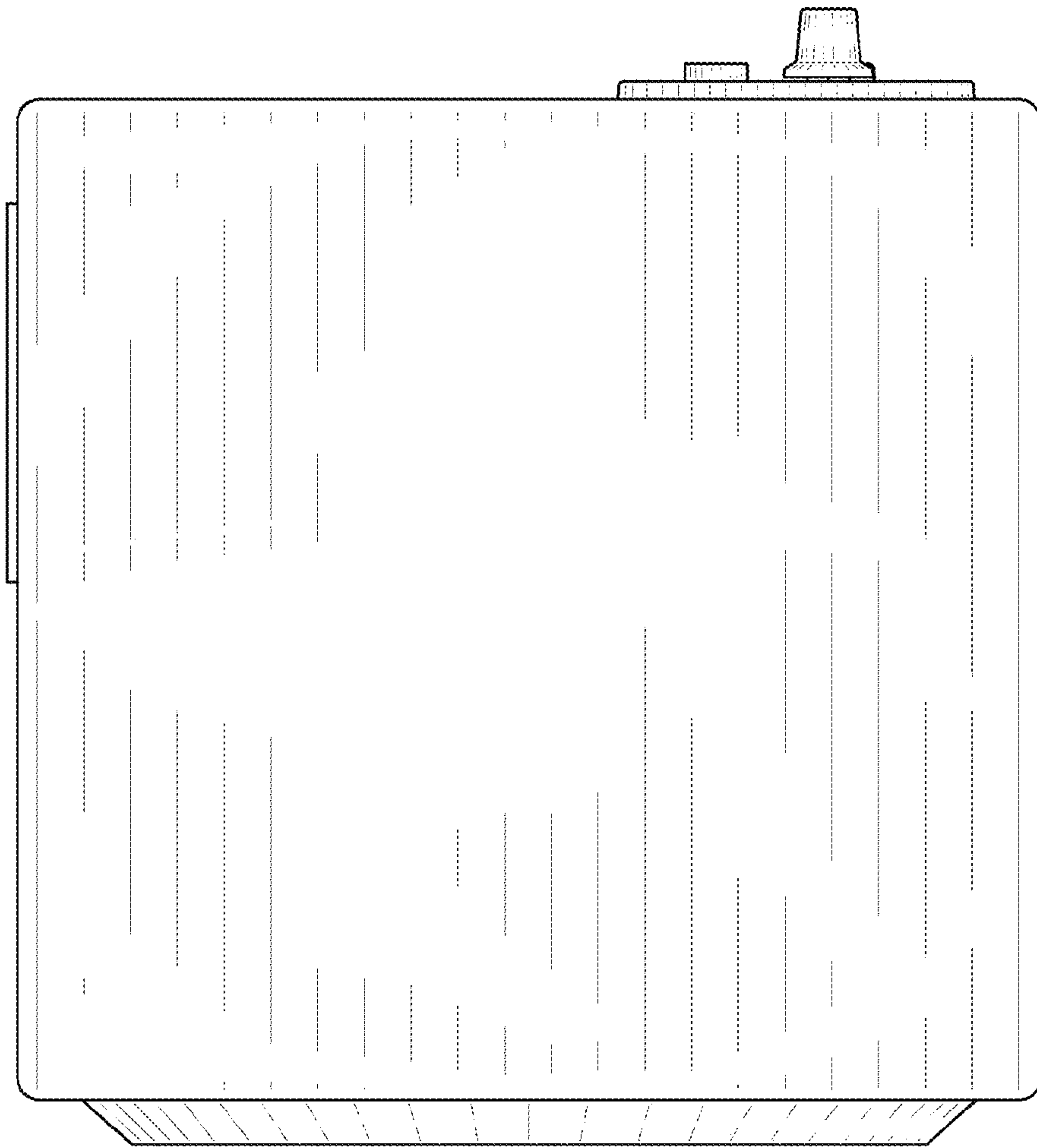

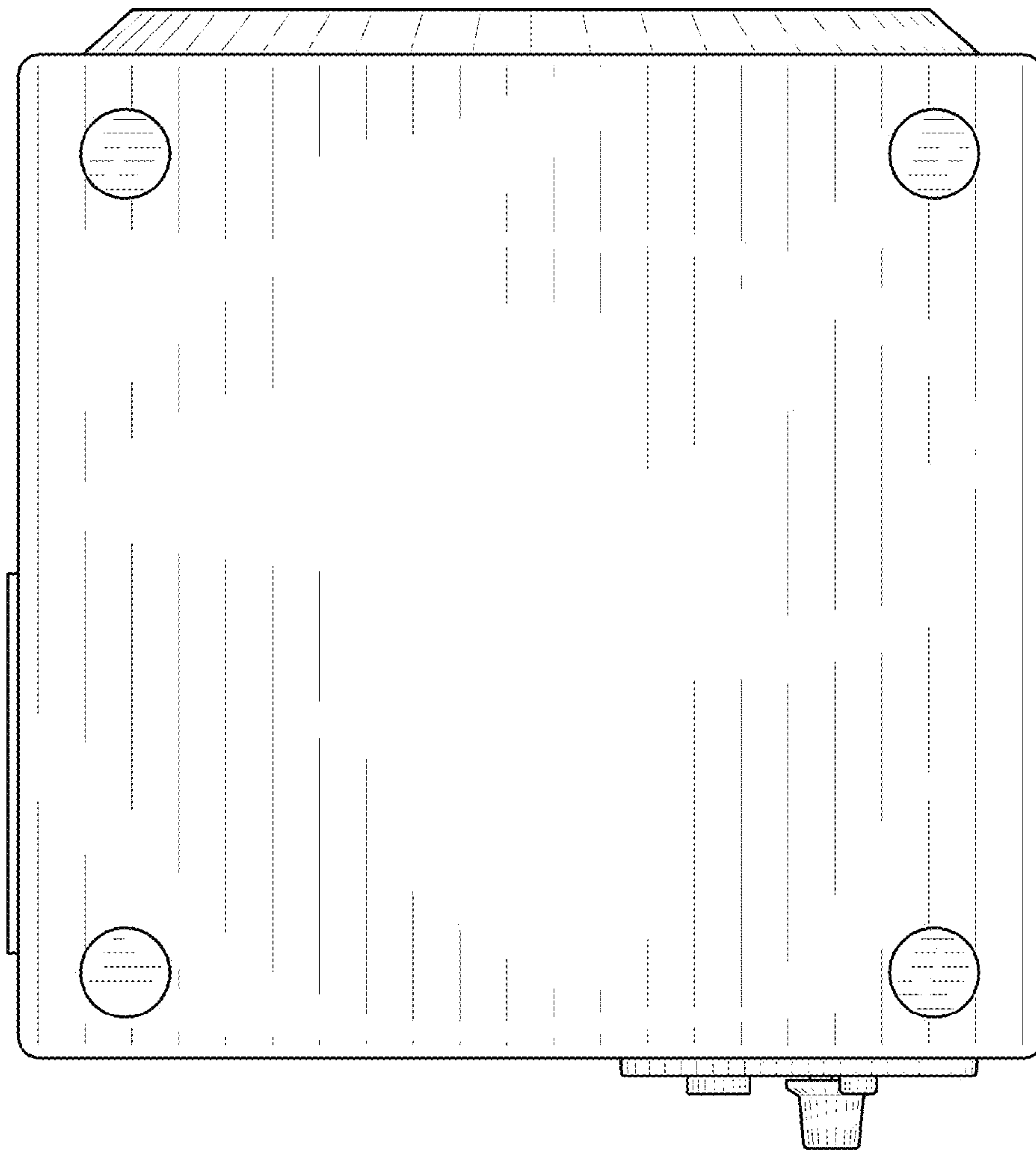
