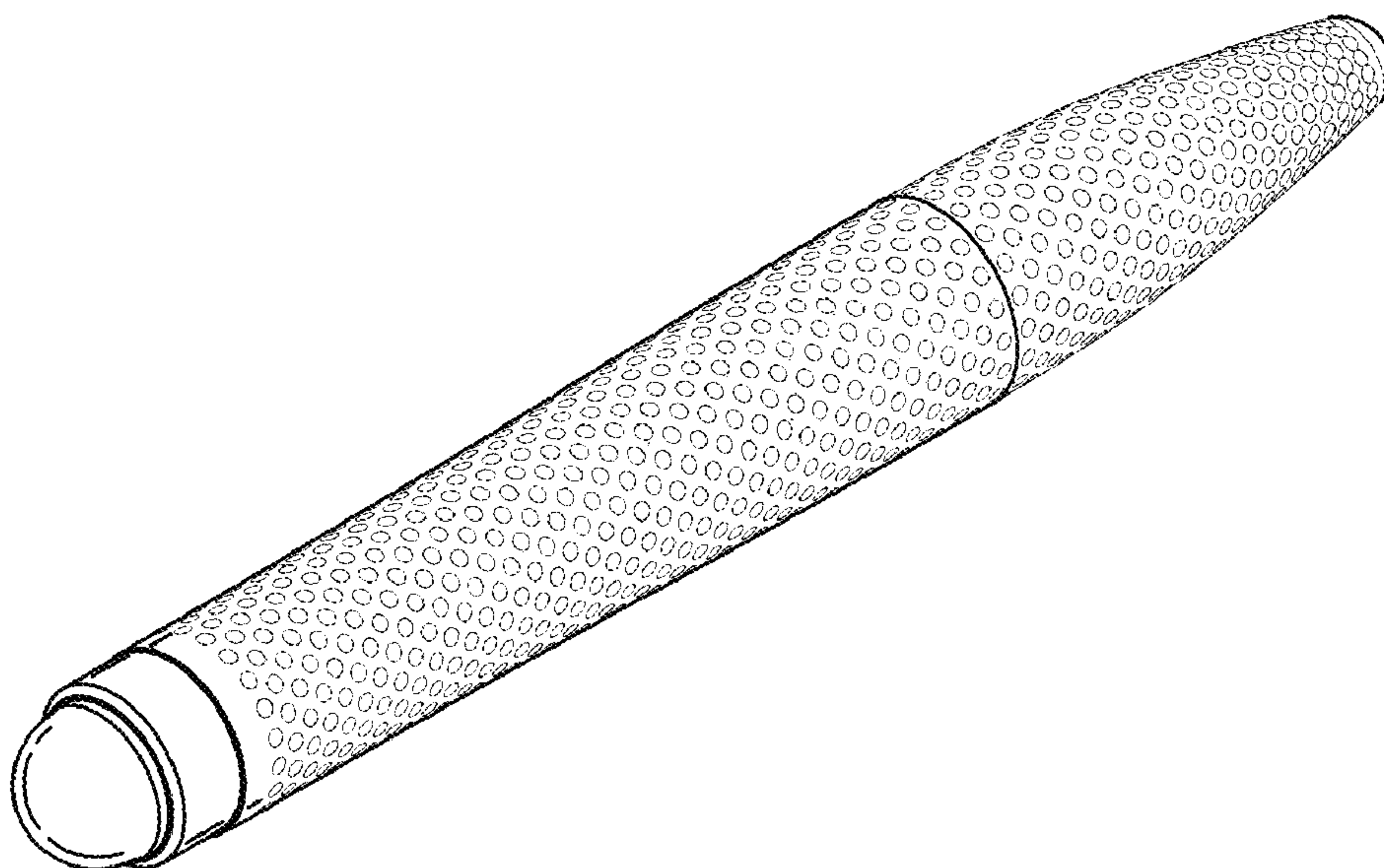
(57) **CLAIM**

We claim the ornamental design for a jeweled stylus, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the jeweled stylus;
FIG. 2 is a front view of the jeweled stylus;
FIG. 3 is a back view of the jeweled stylus;
FIG. 4 is a top side view of the jeweled stylus;
FIG. 5 is a bottom side view of the jeweled stylus;

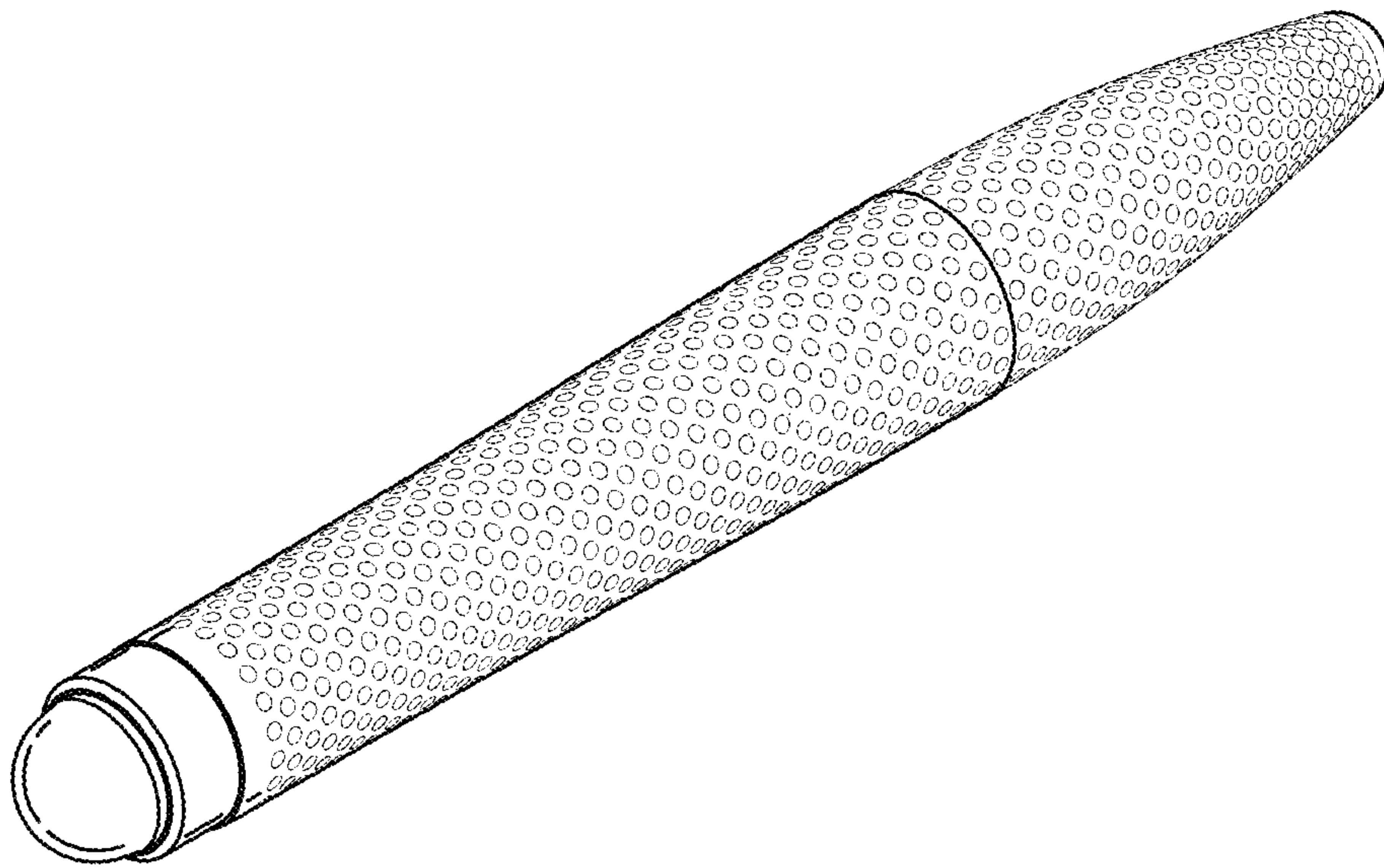

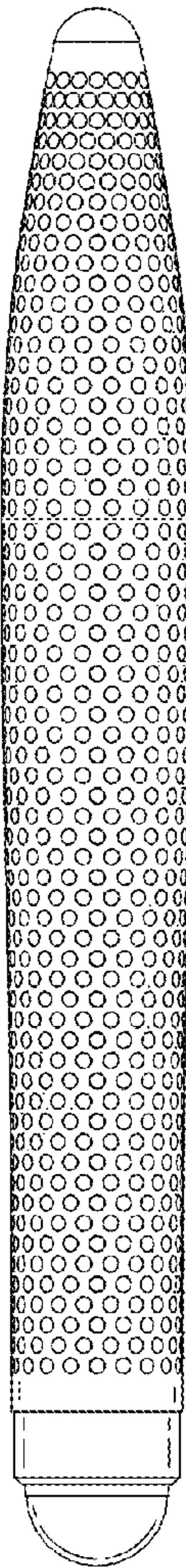

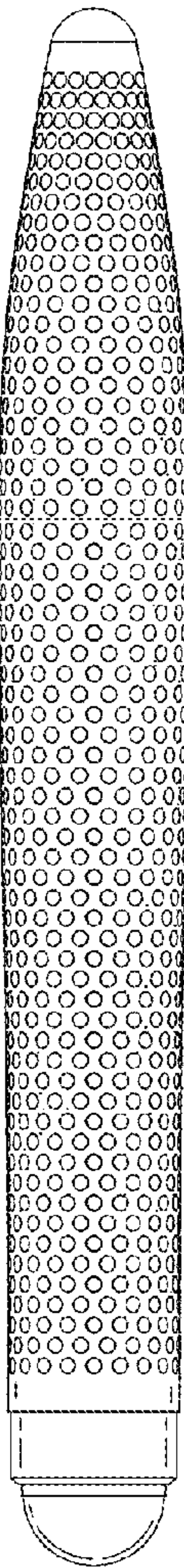

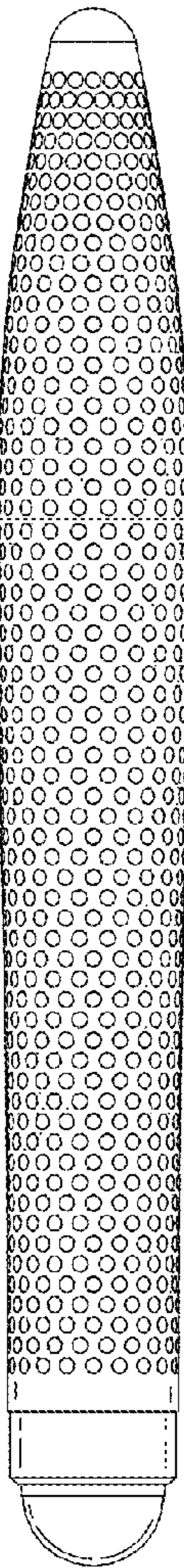

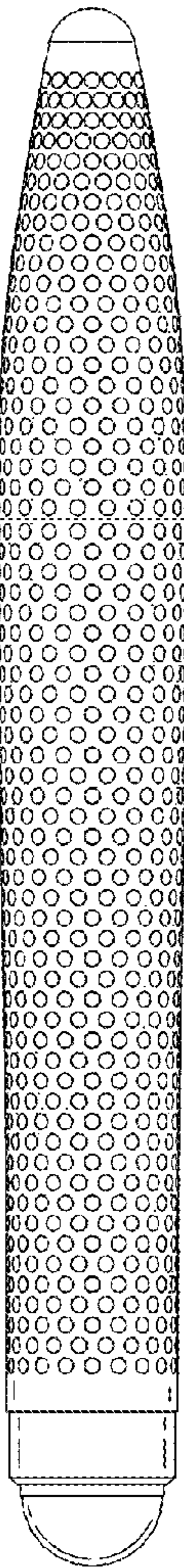

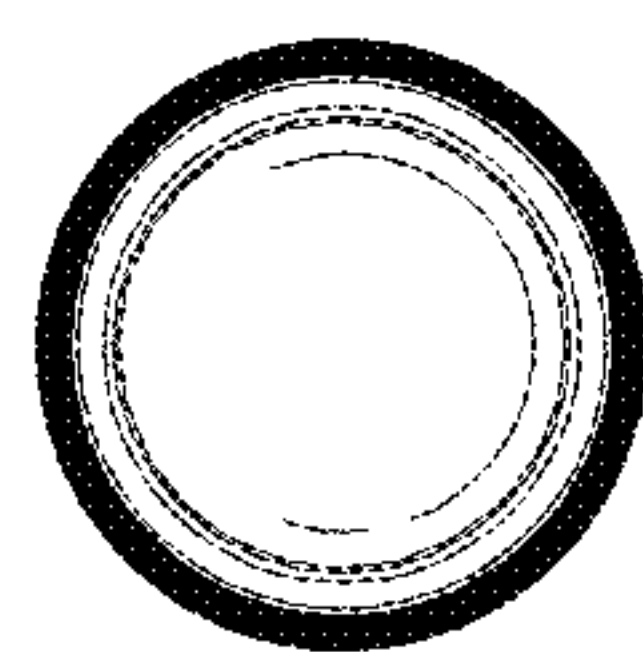

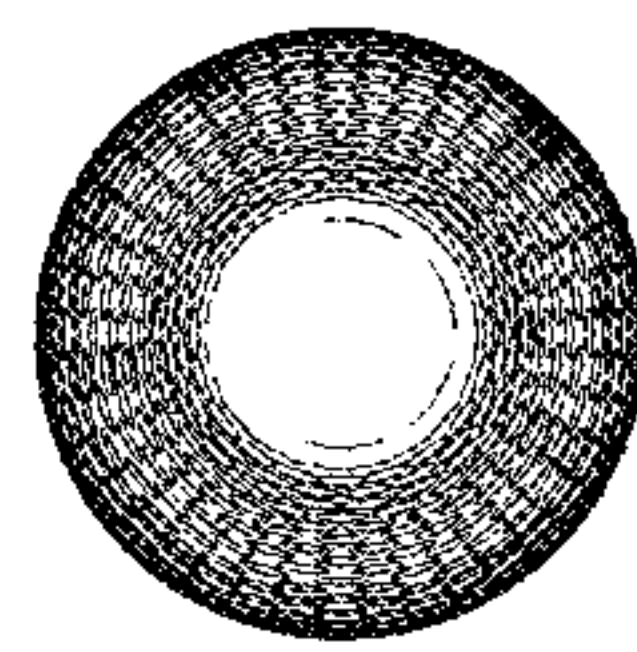
