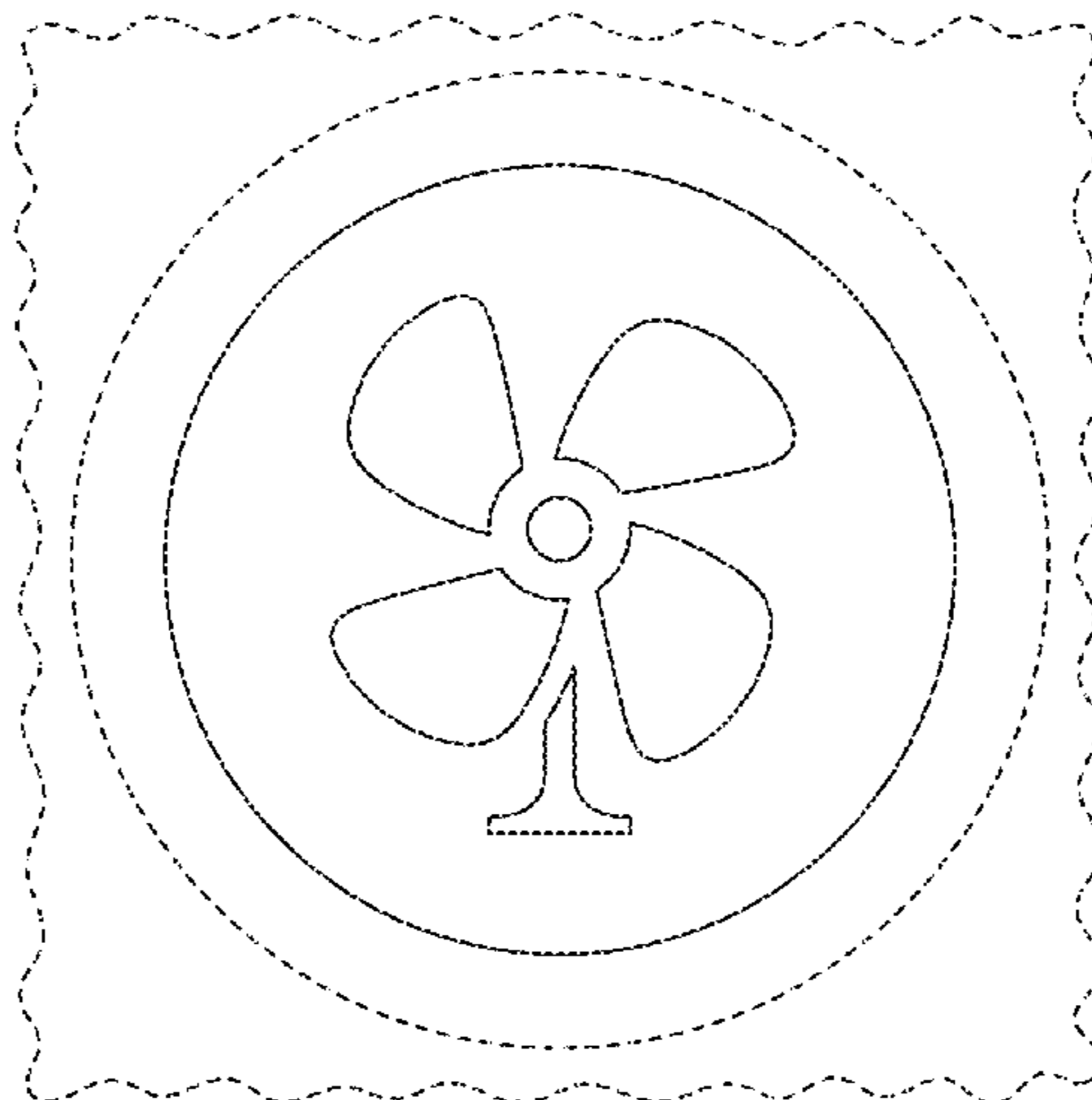
FIG. 1 is the first image in a sequence for a display screen with animated icon showing my new design;

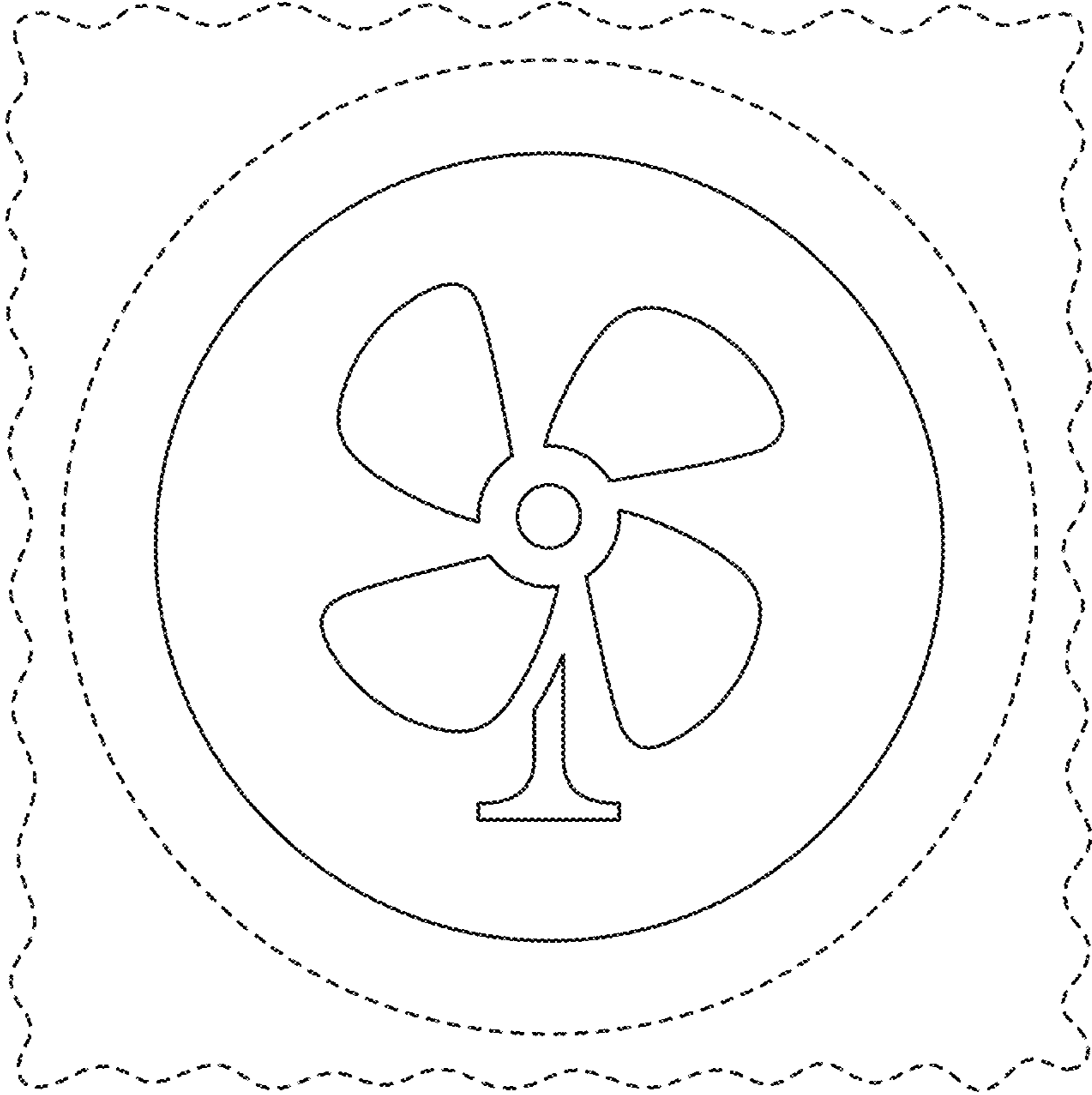

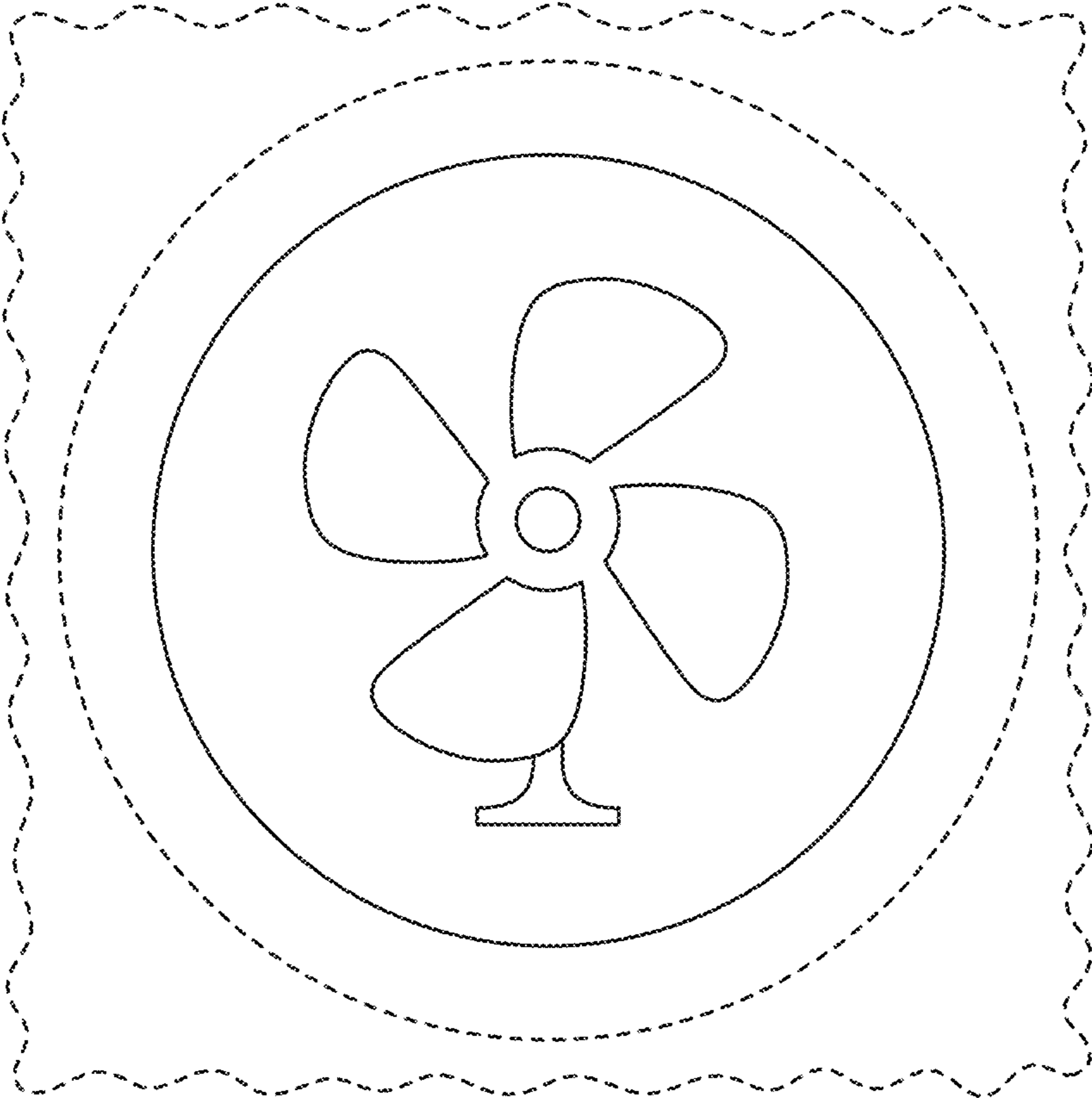

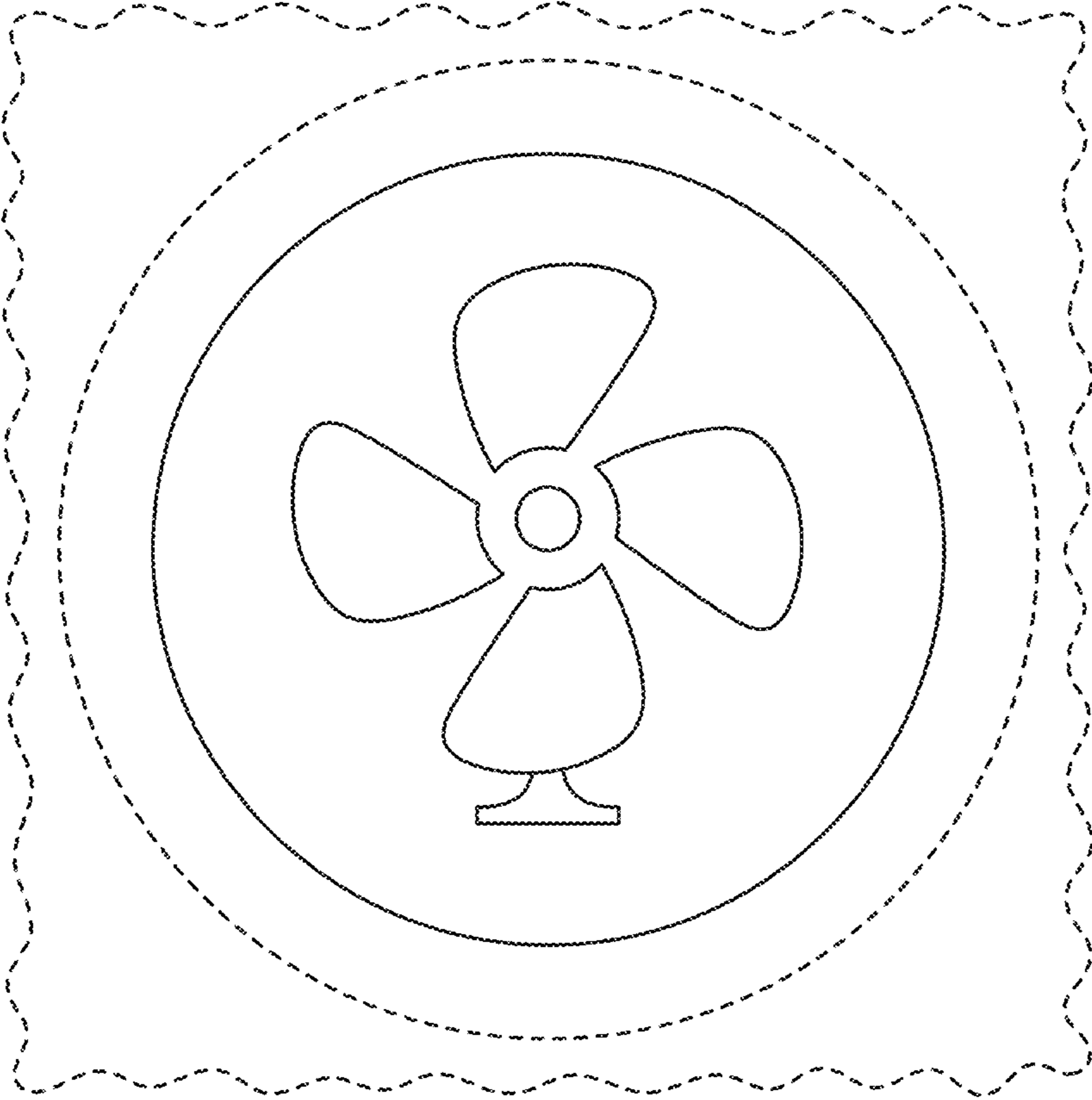

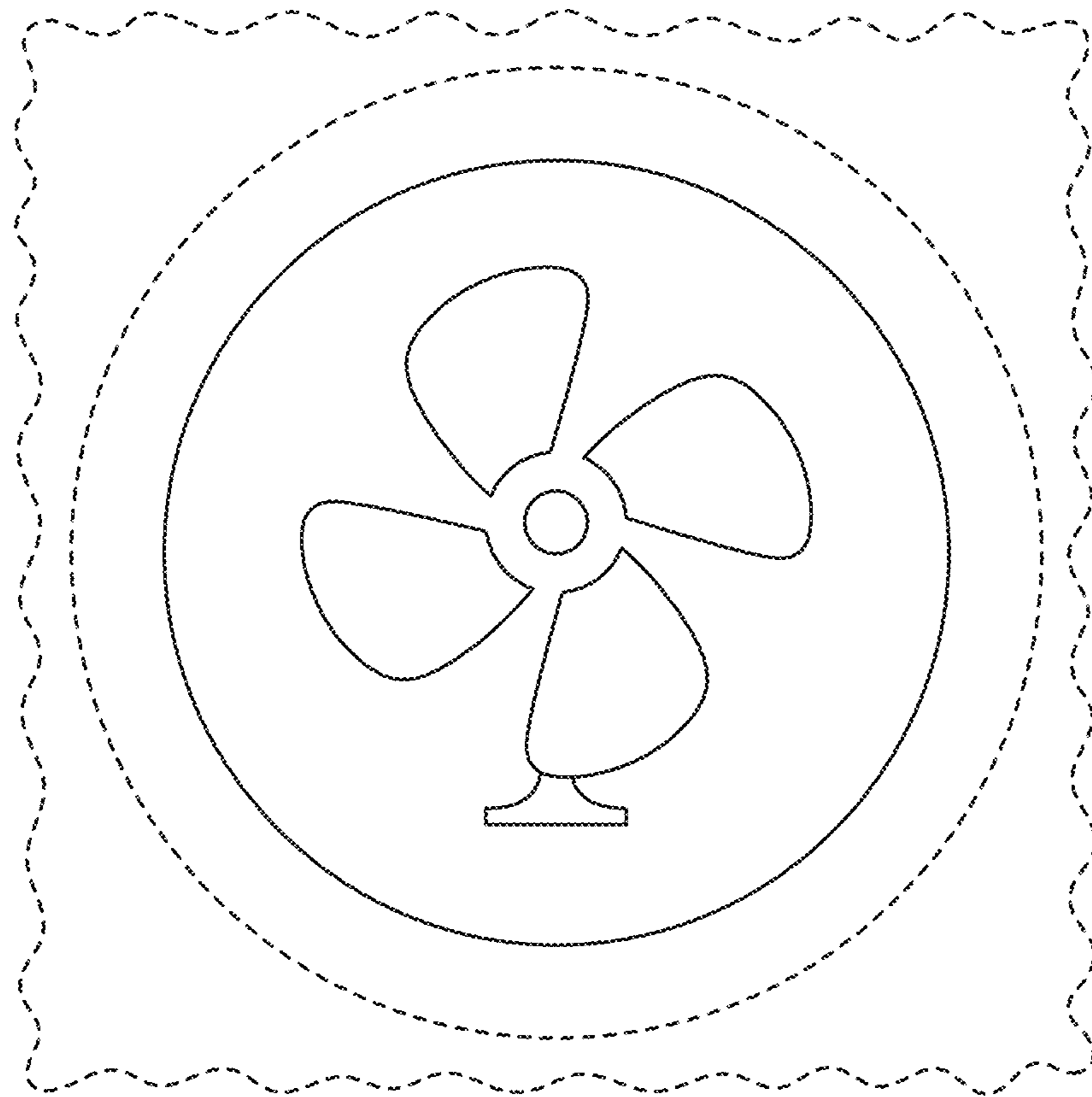

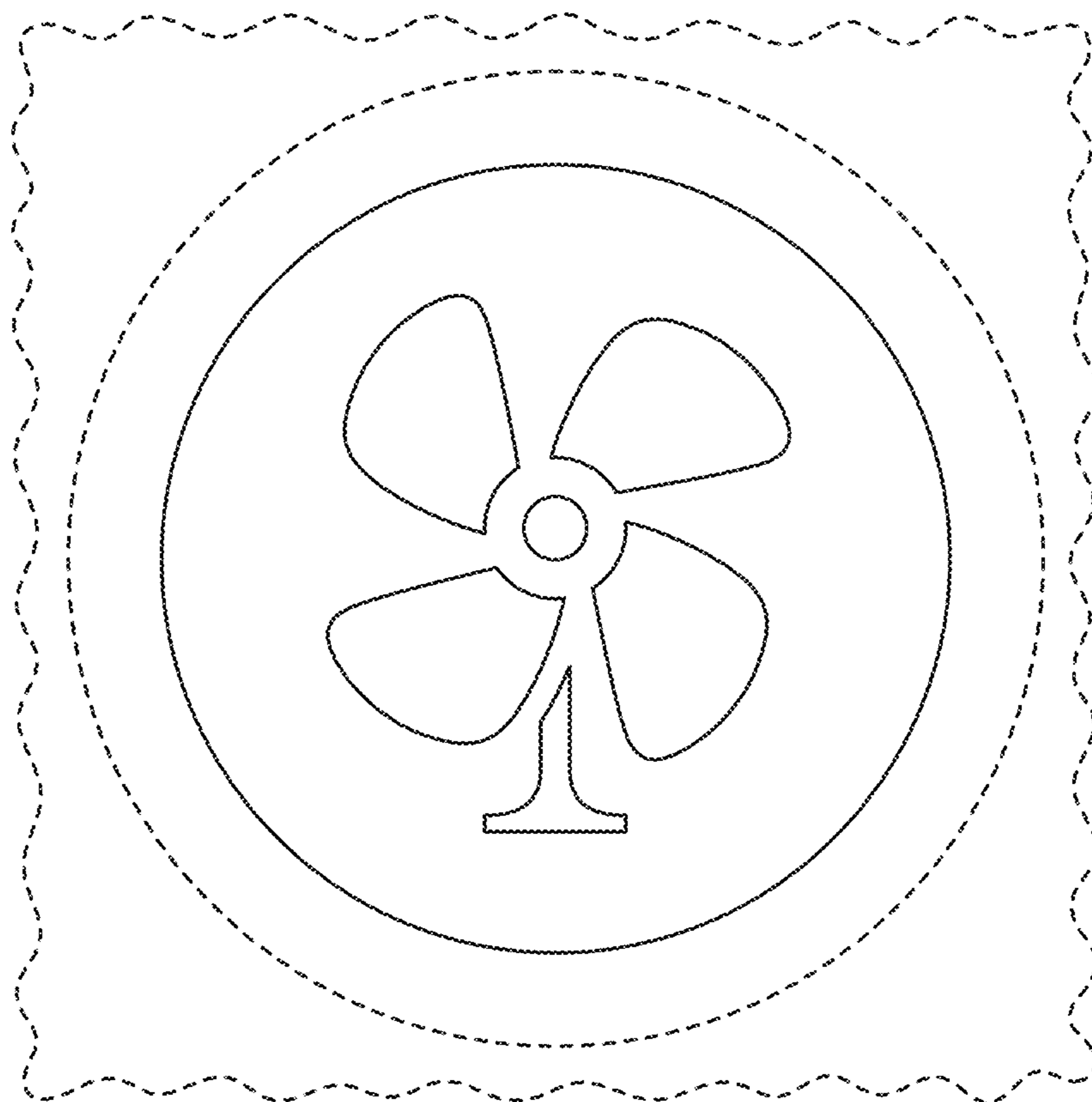

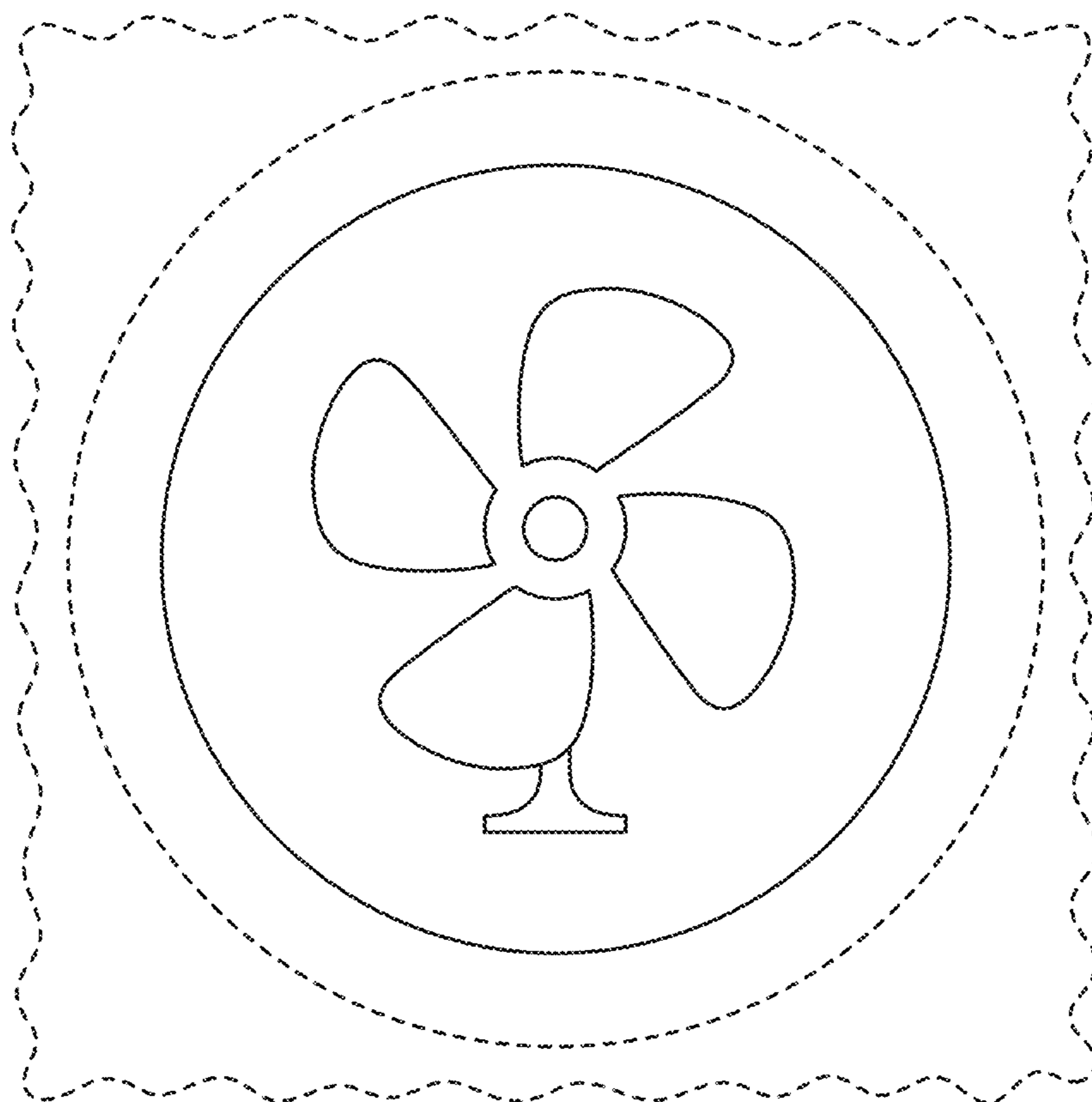

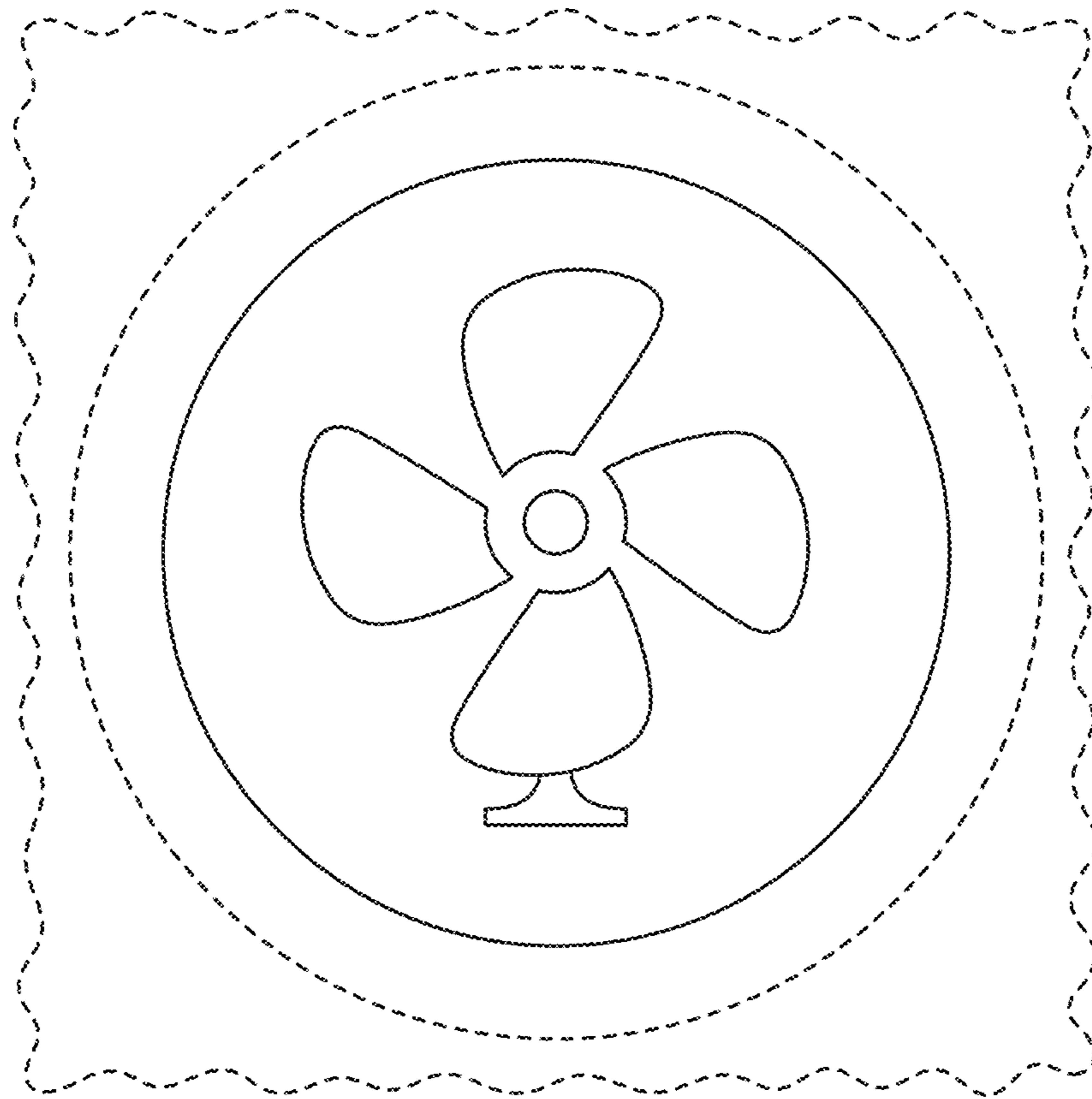

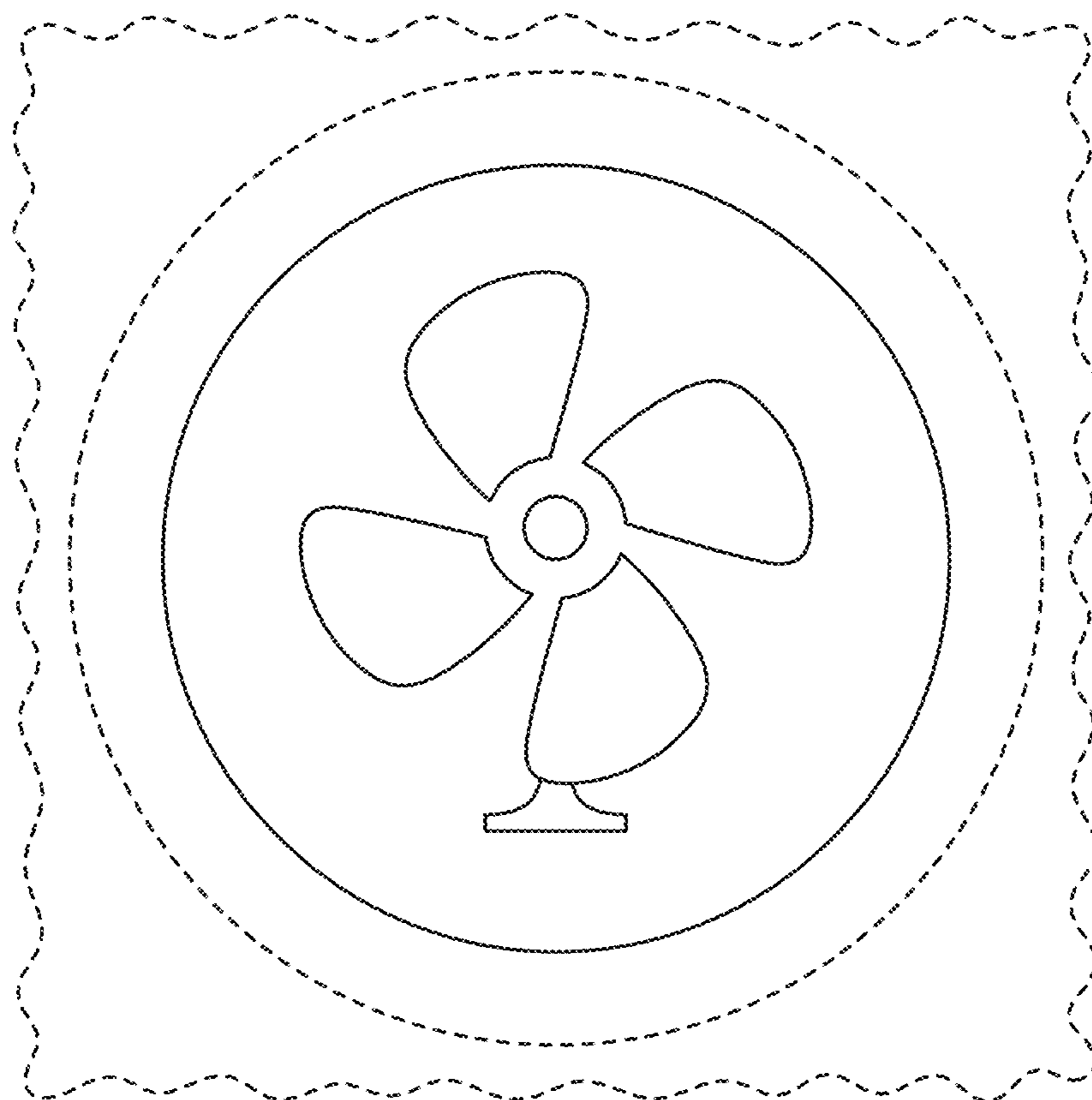

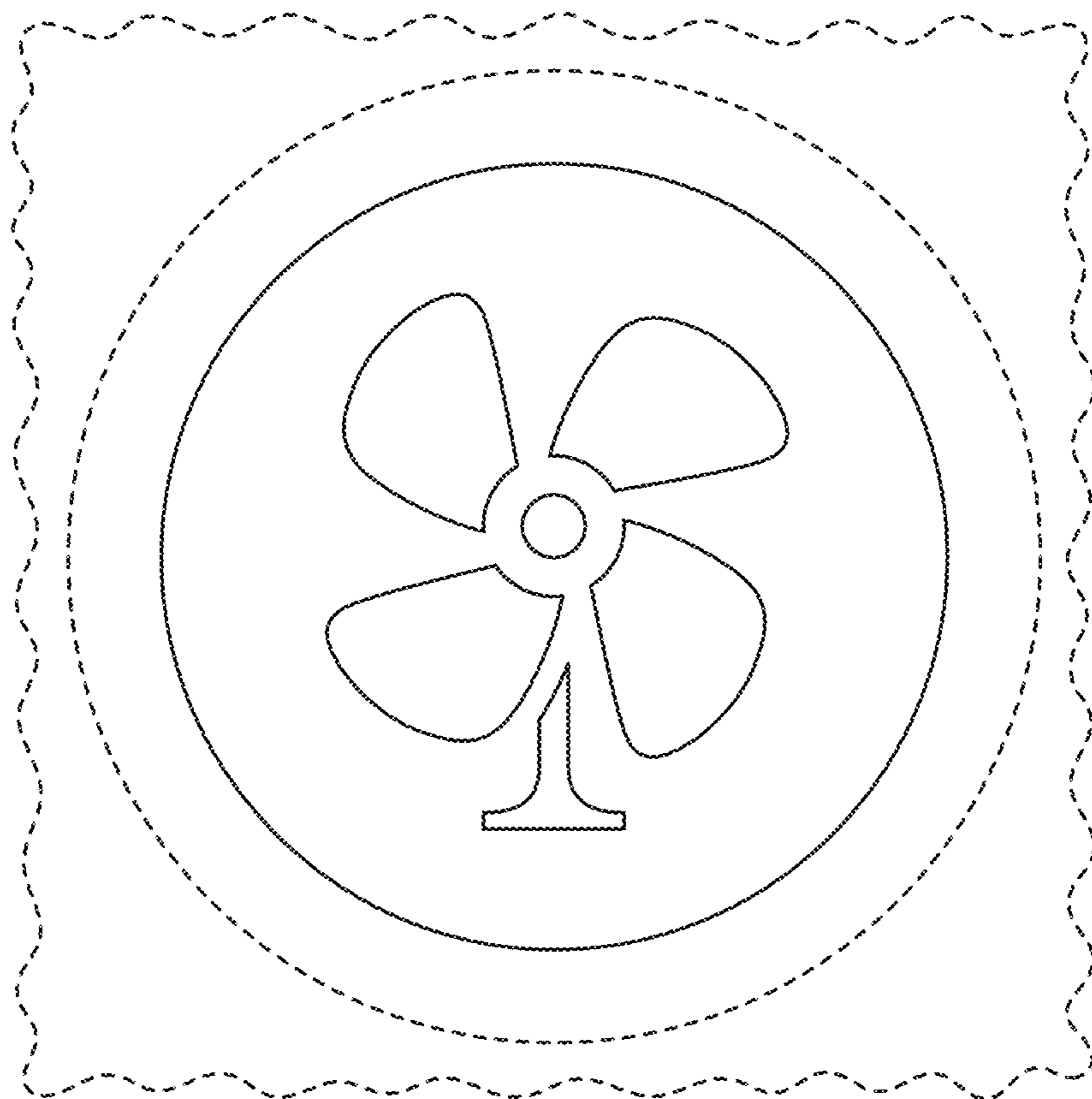

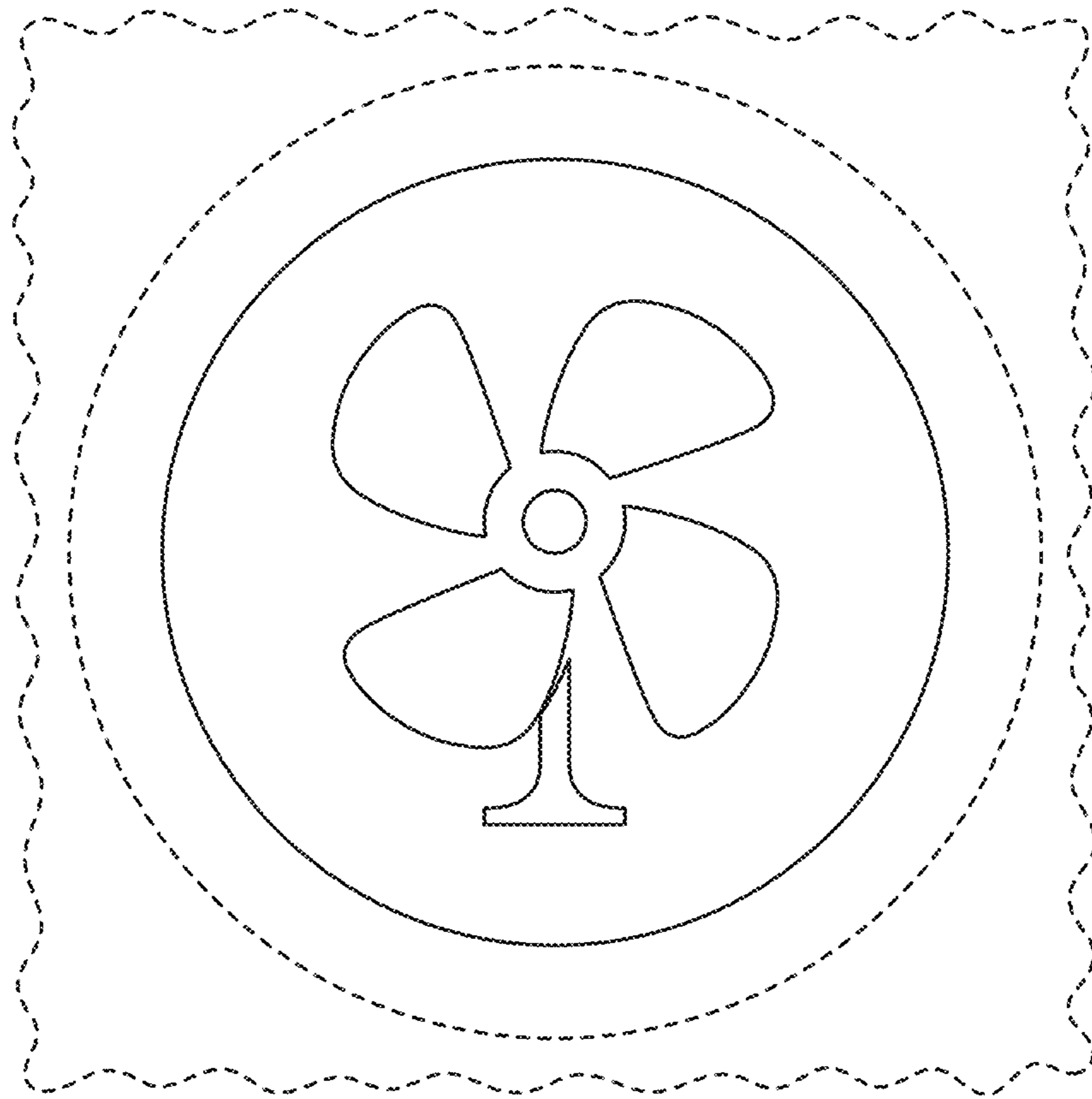

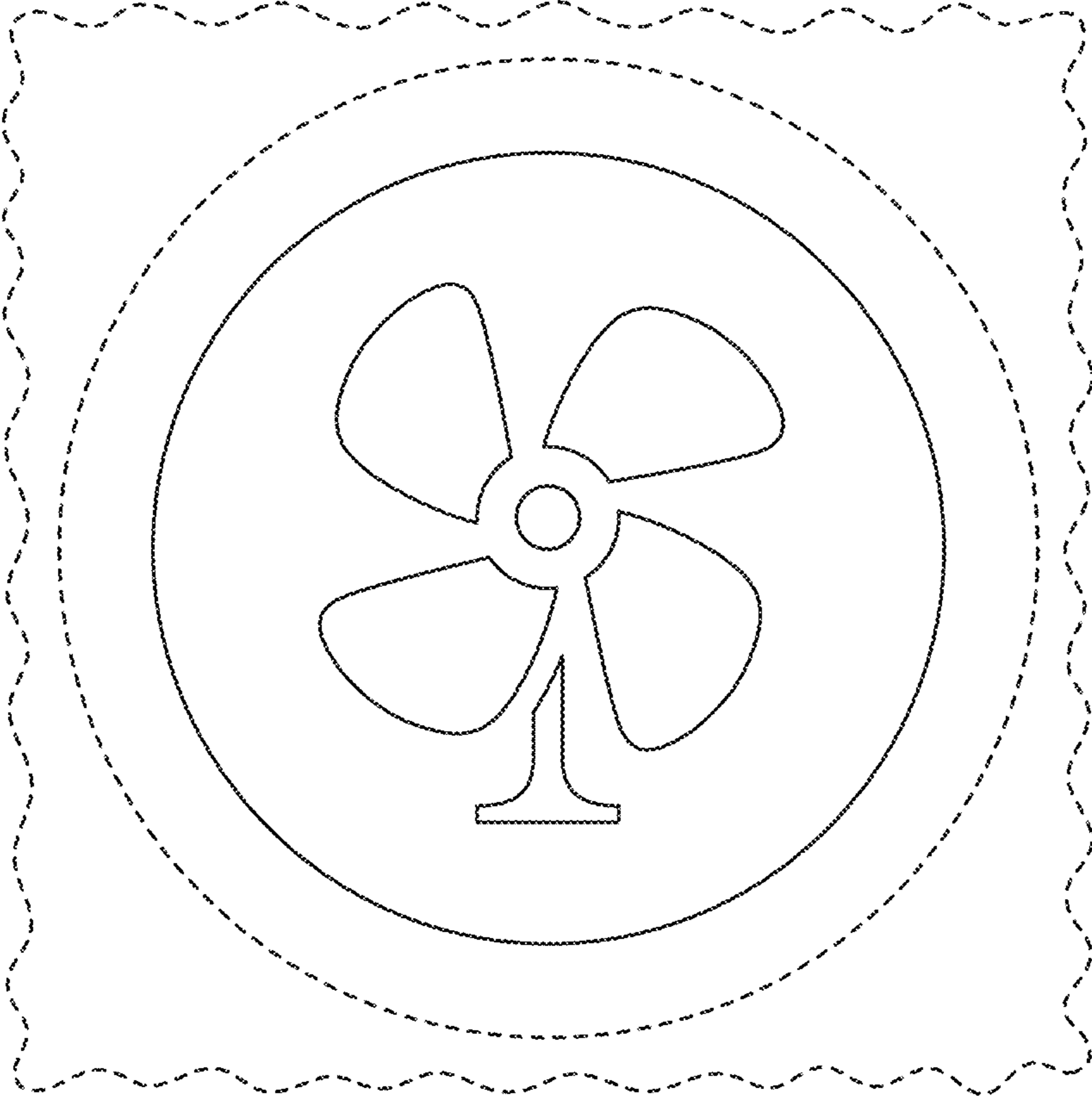

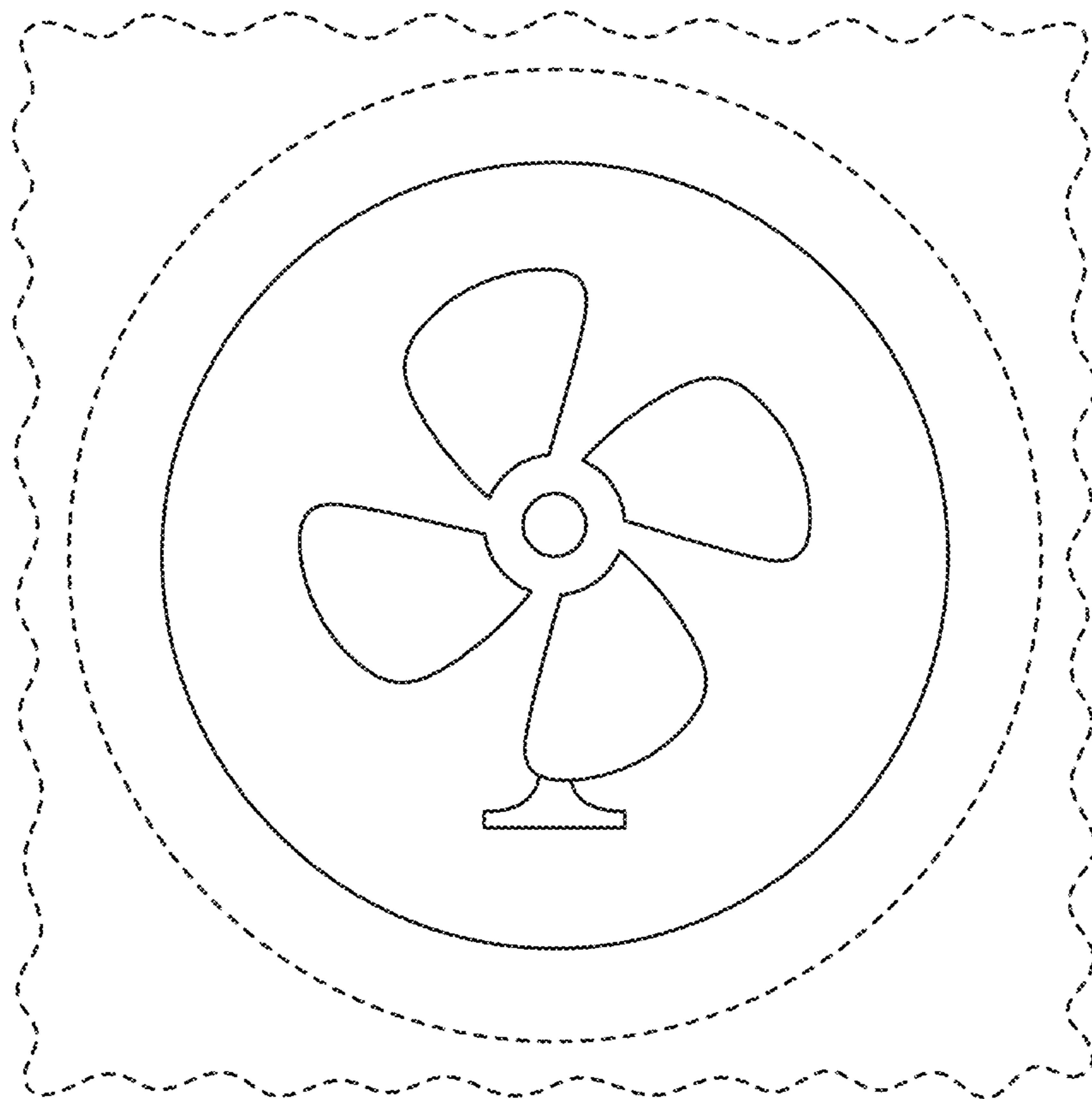

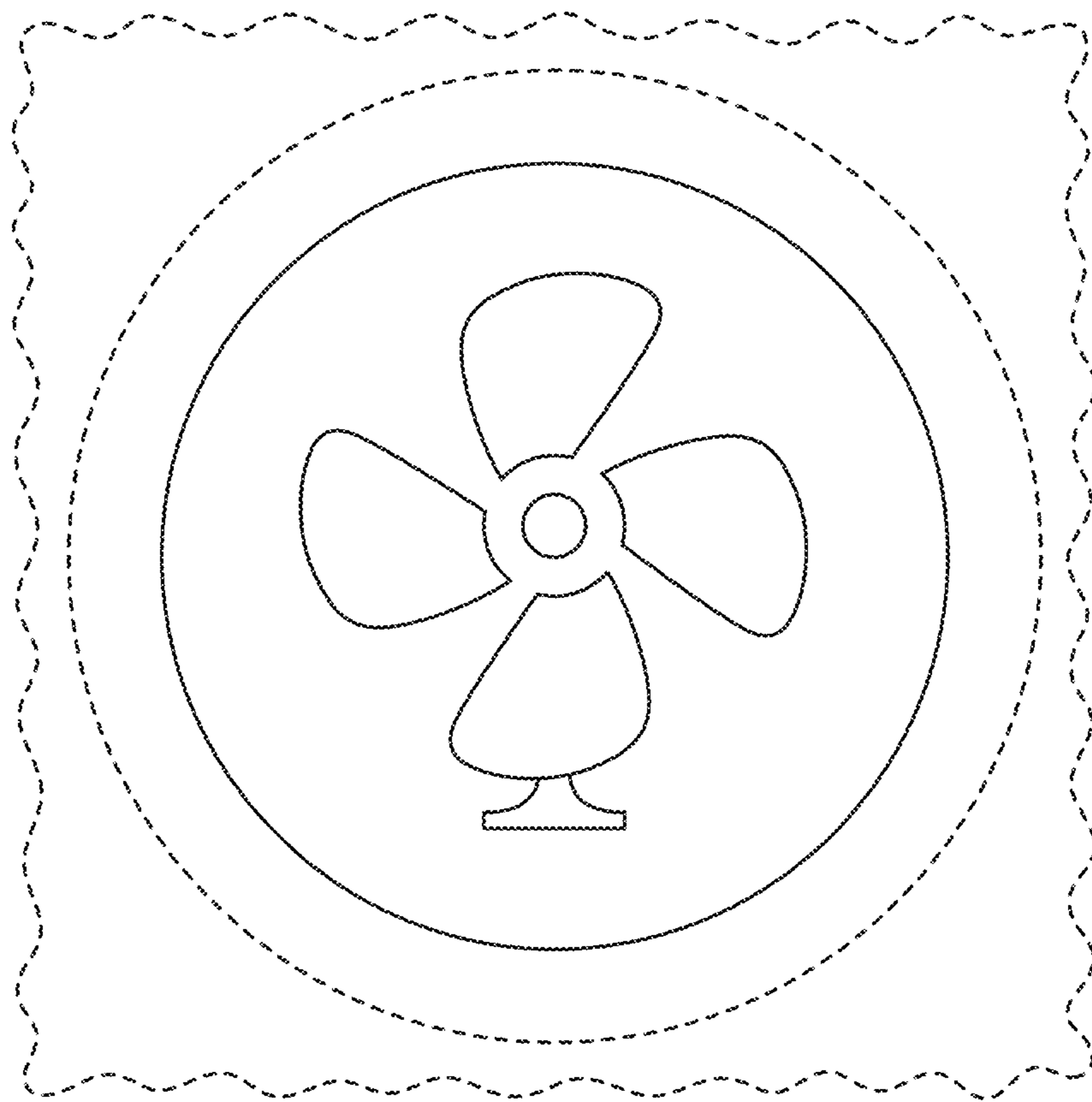

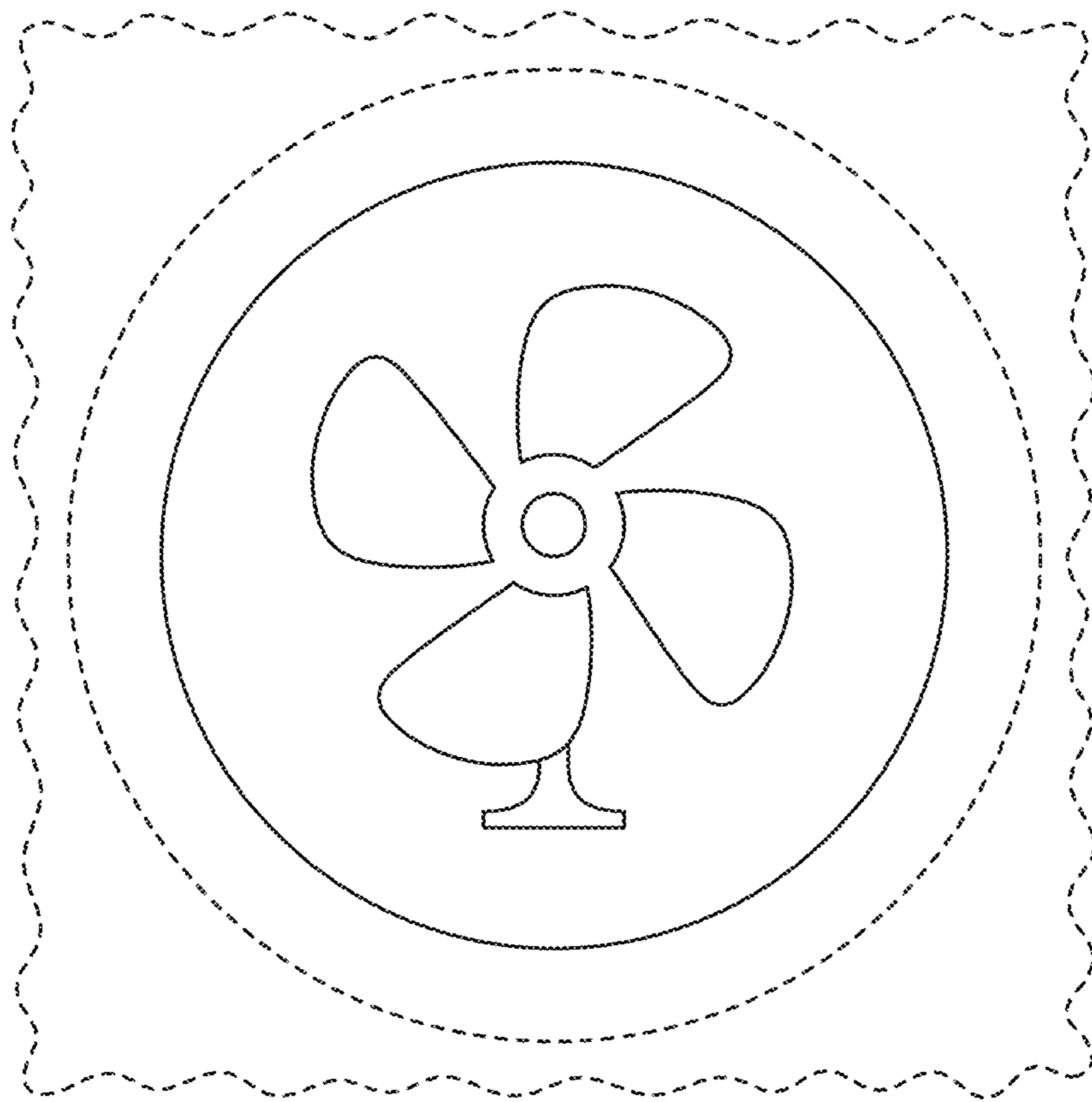

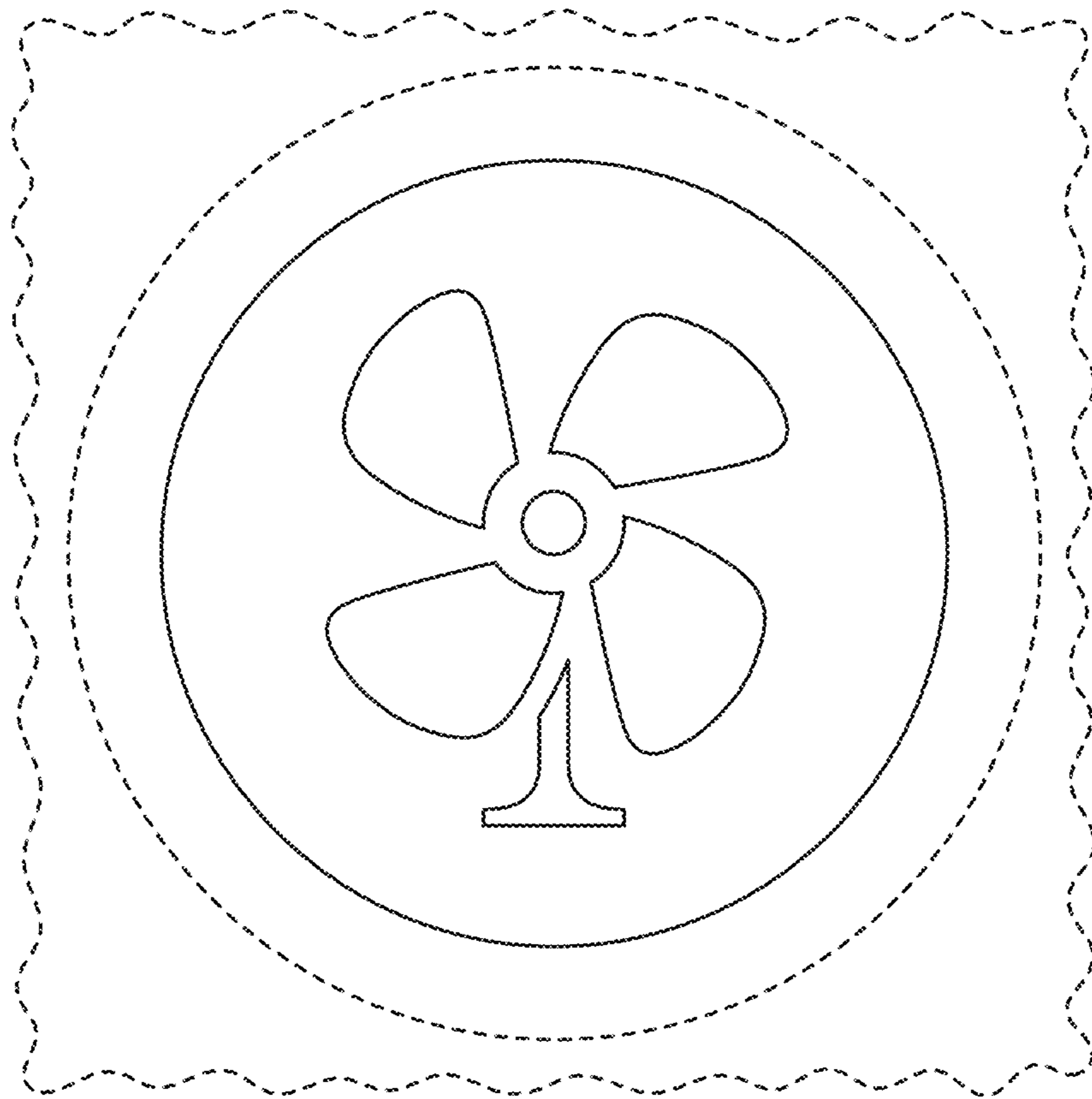

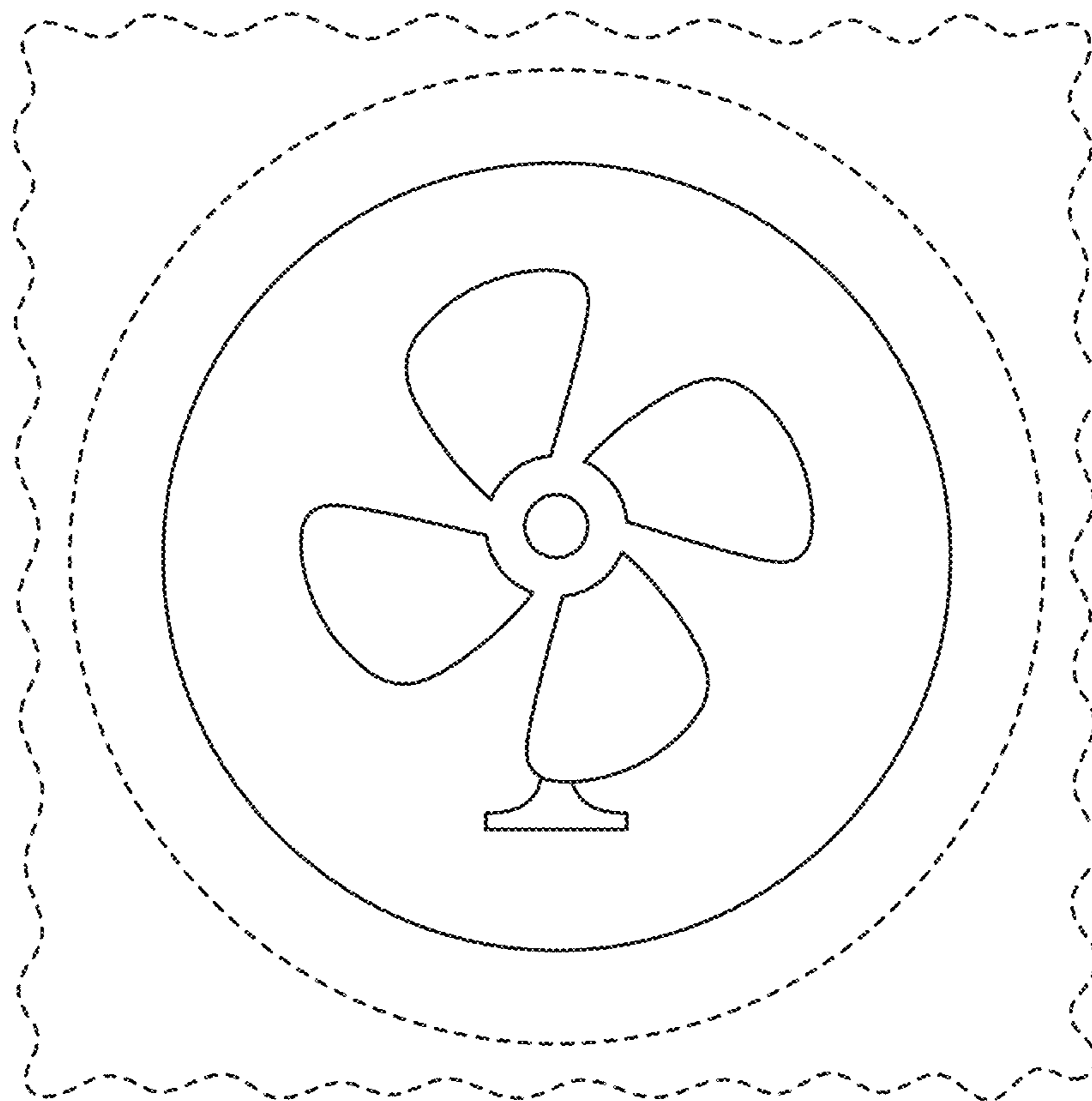

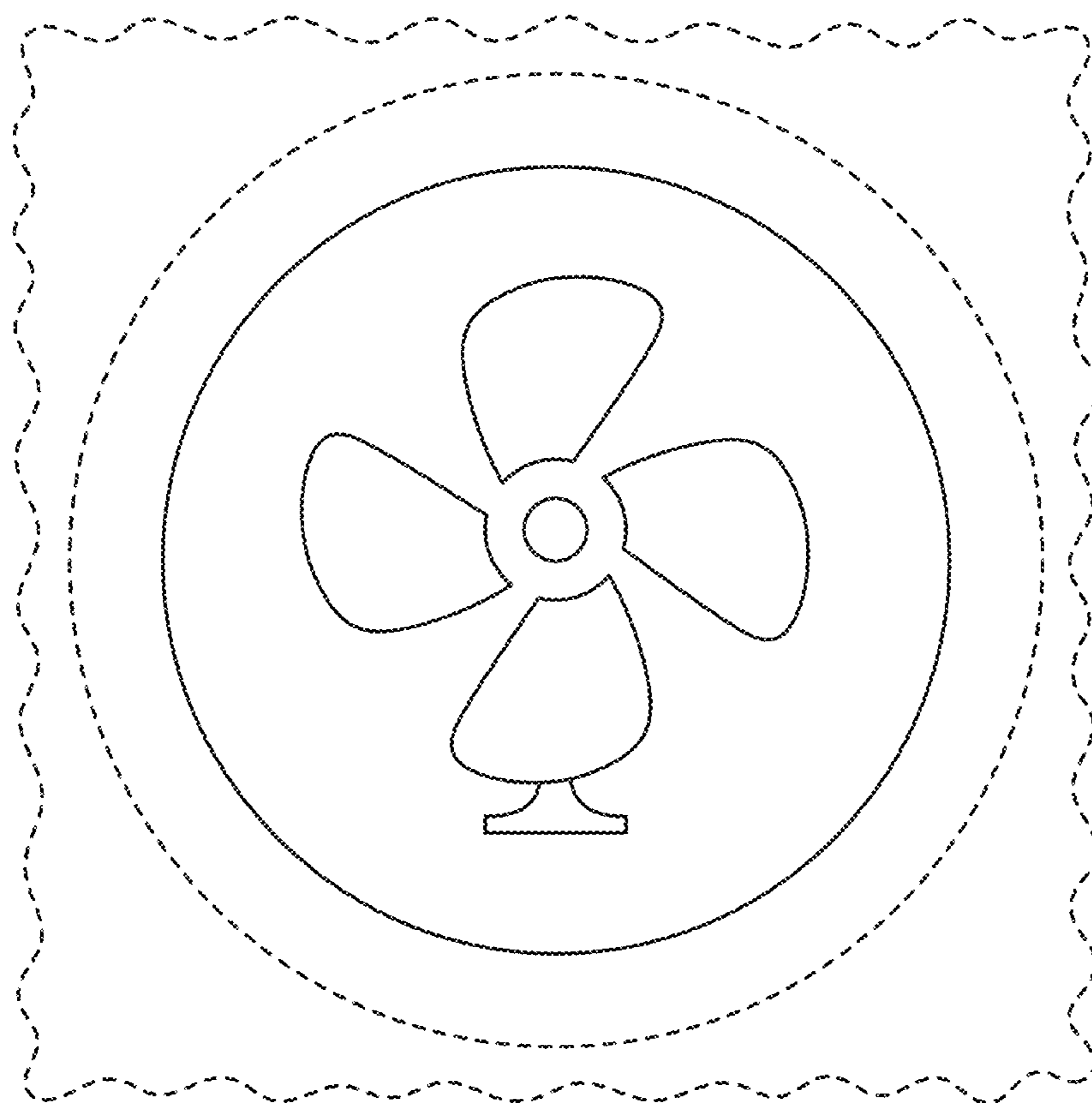

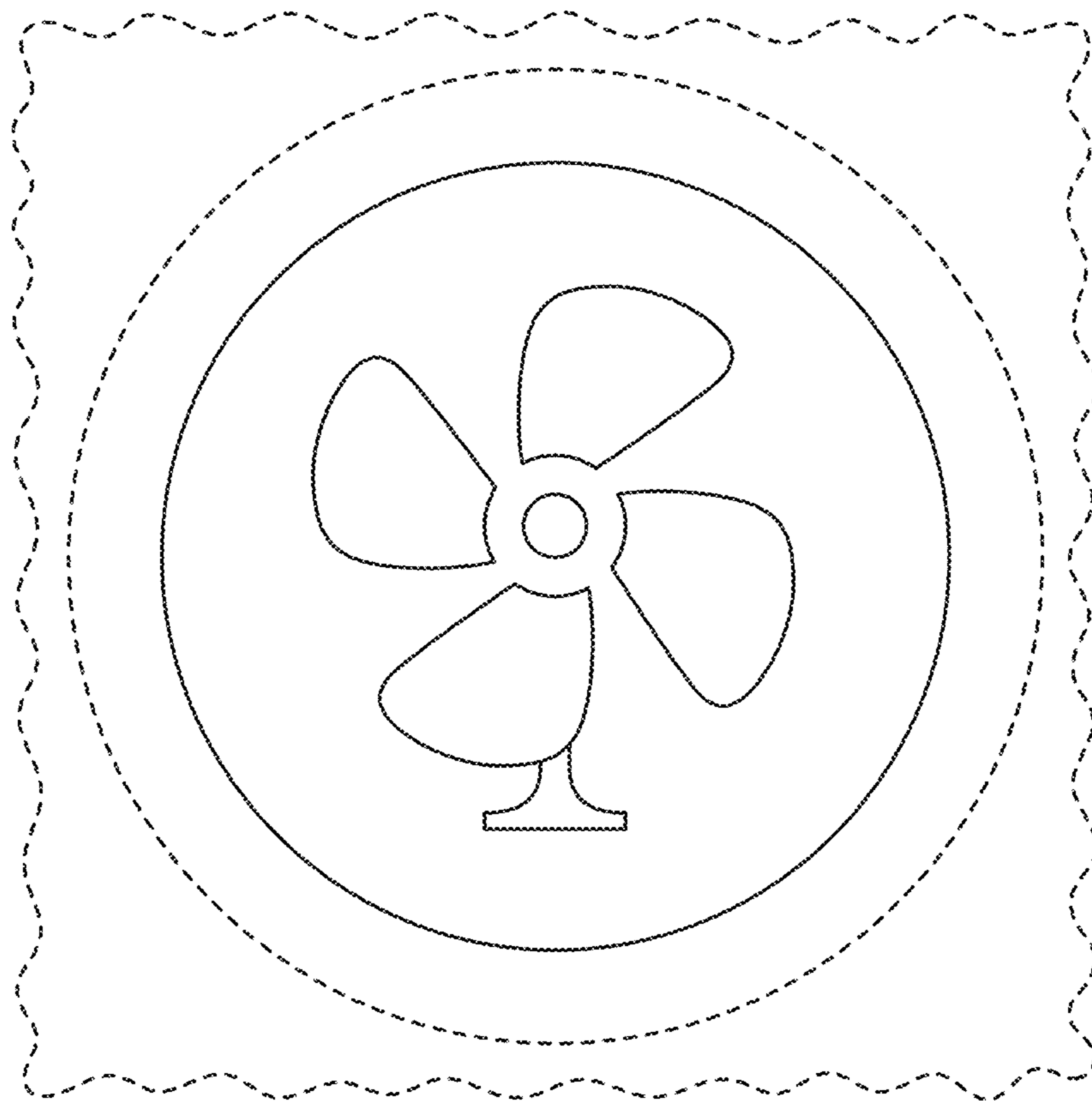

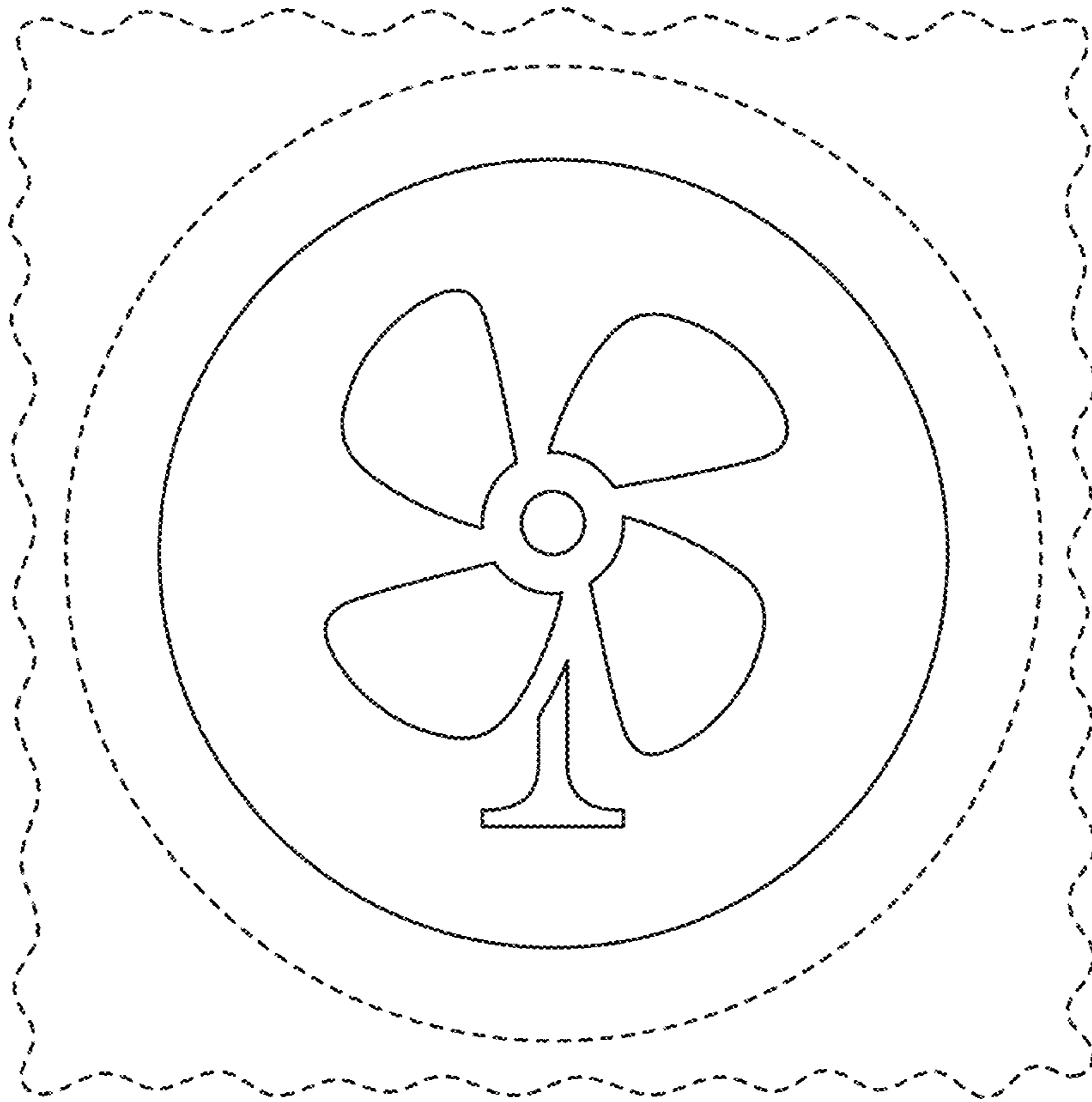

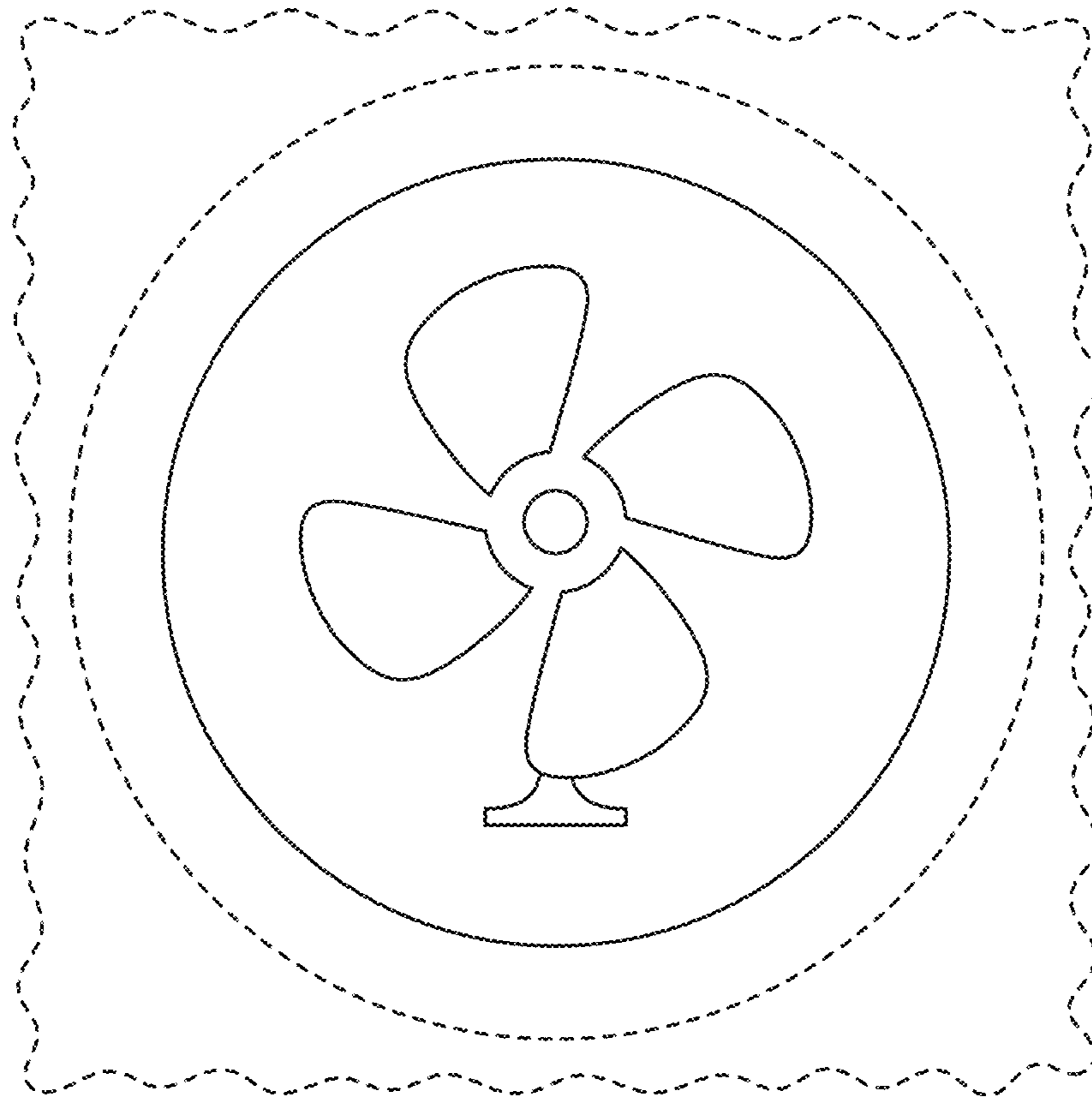

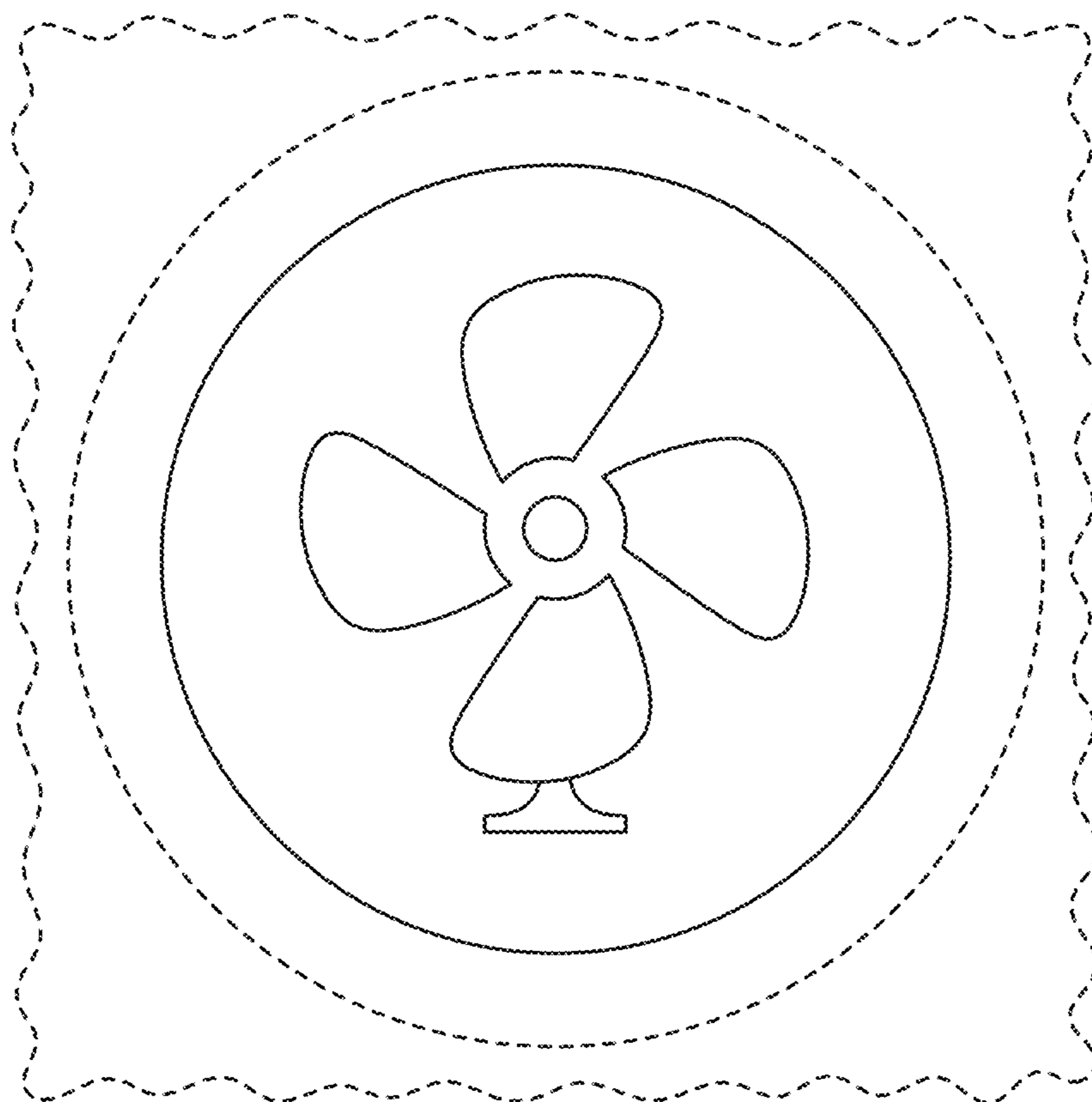

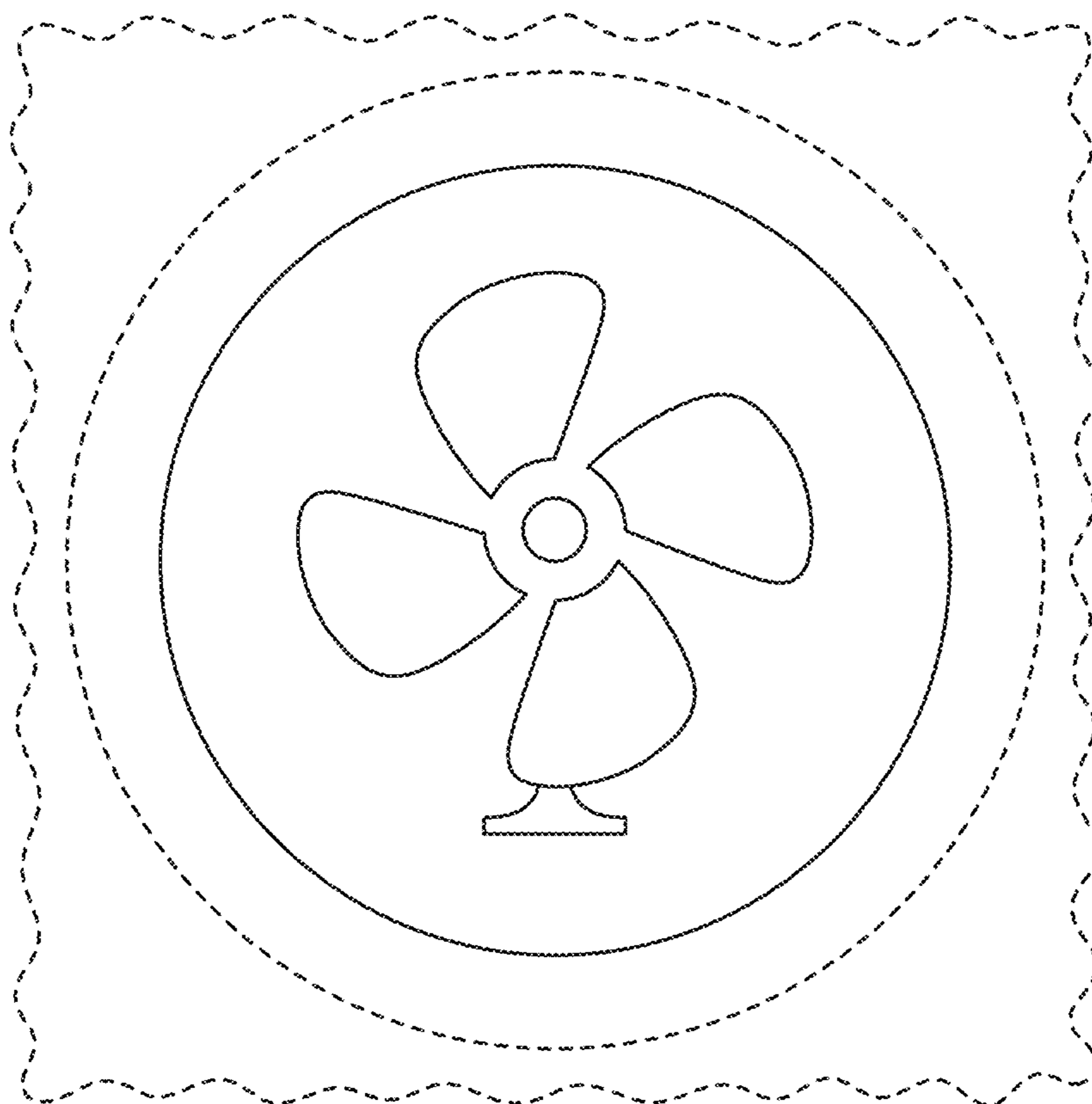

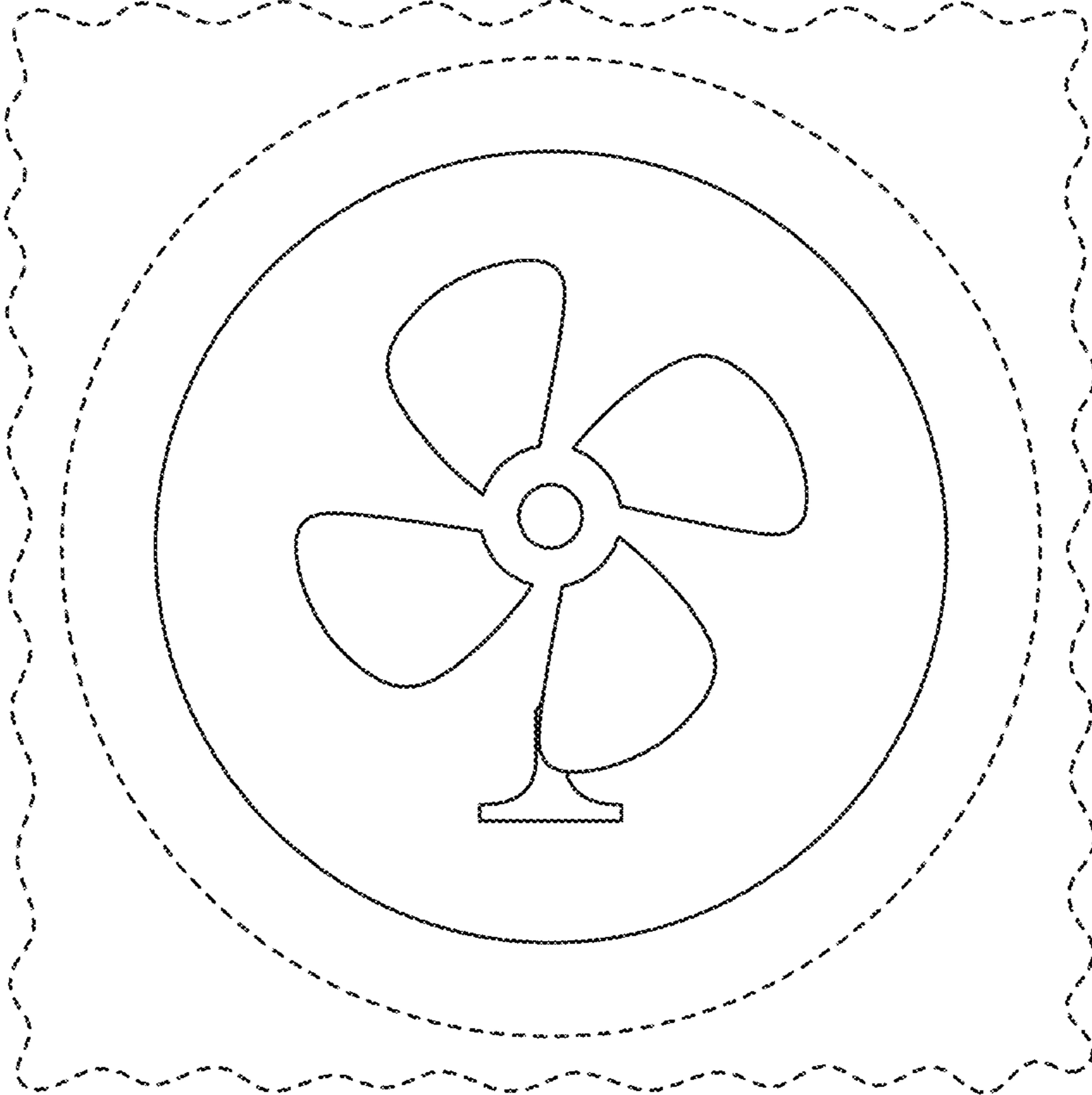

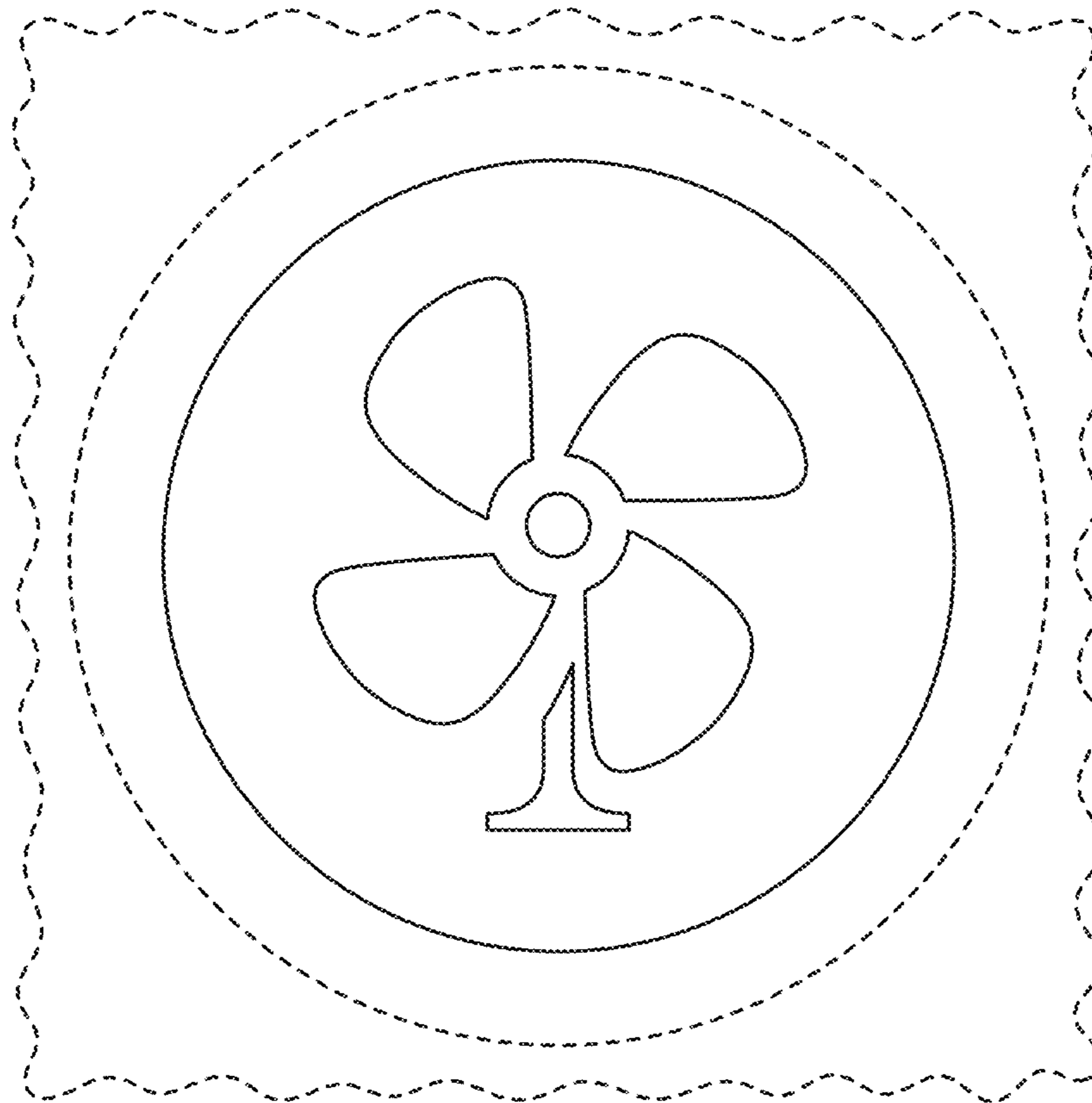

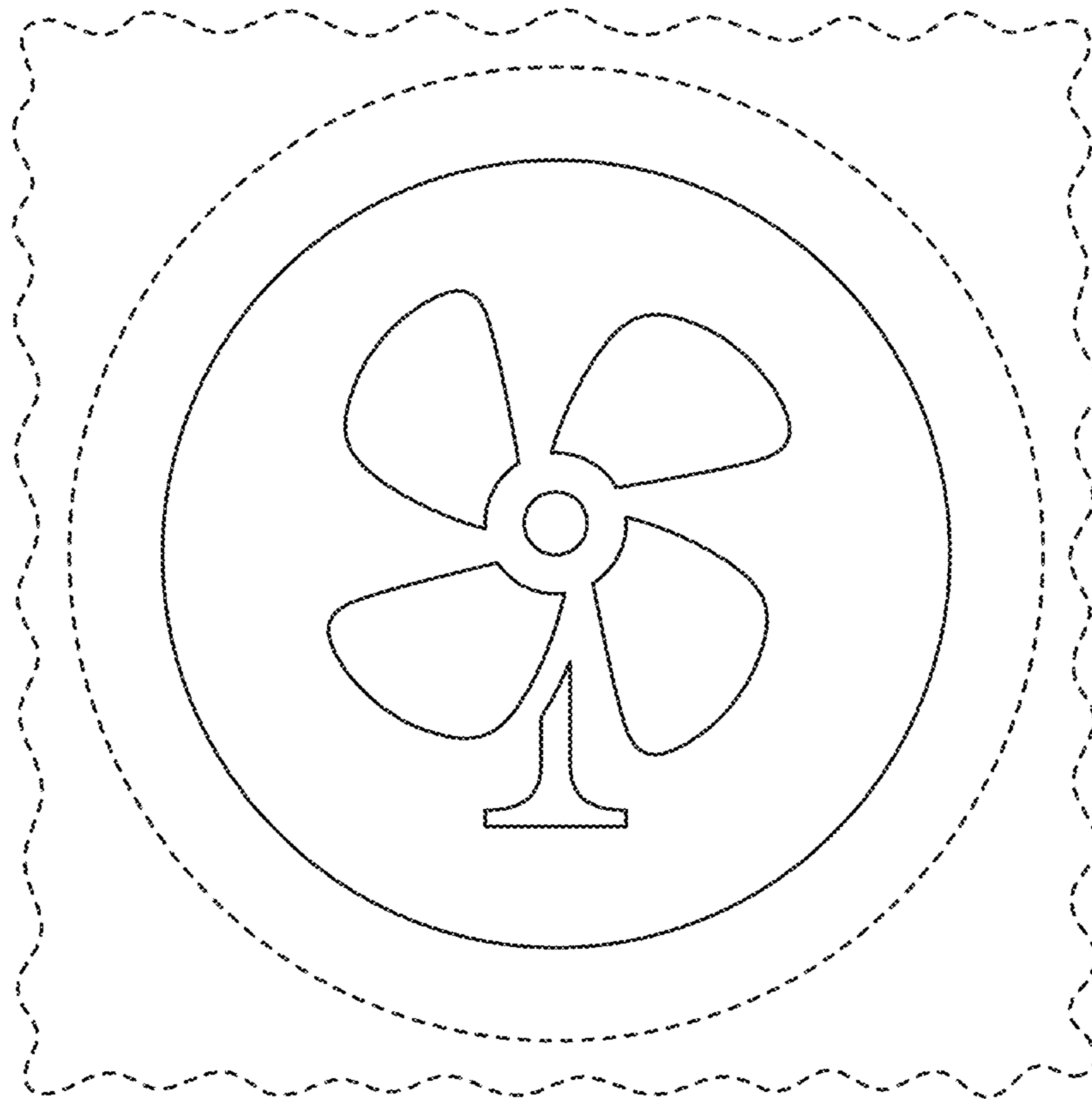
