DESCRIPTION

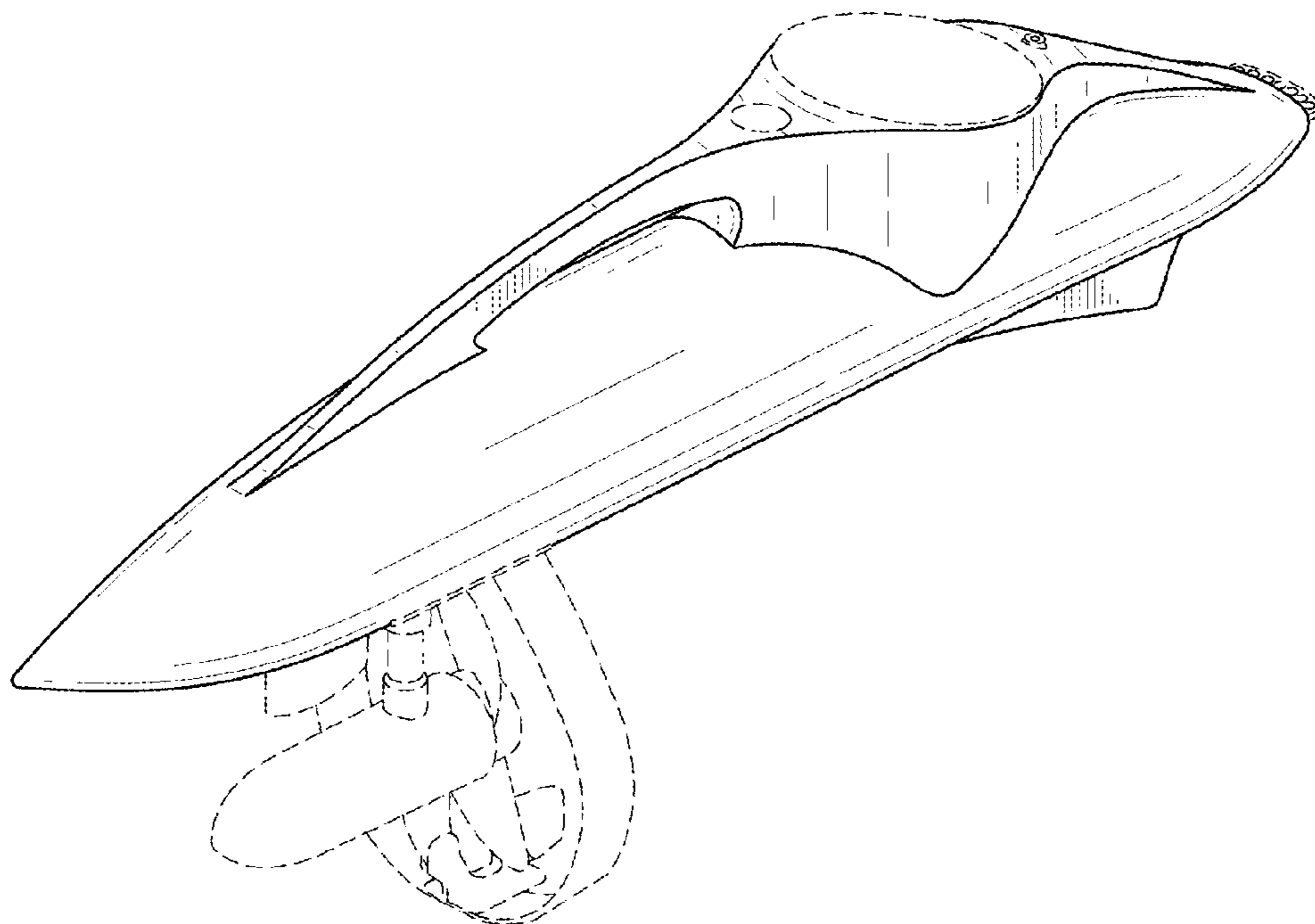
FIG. 1 is a perspective top front view of the electronic fishing device showing my new design;

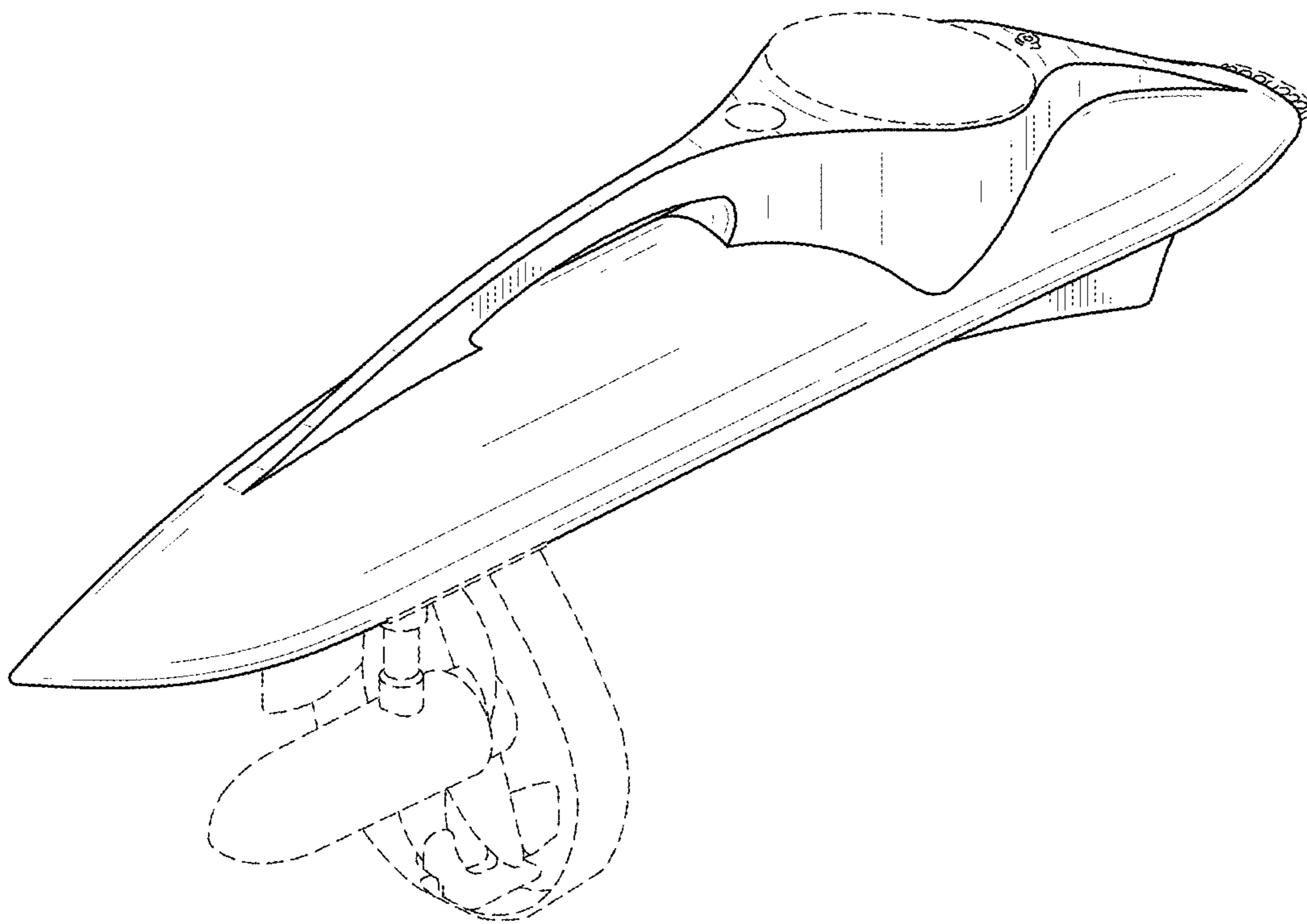

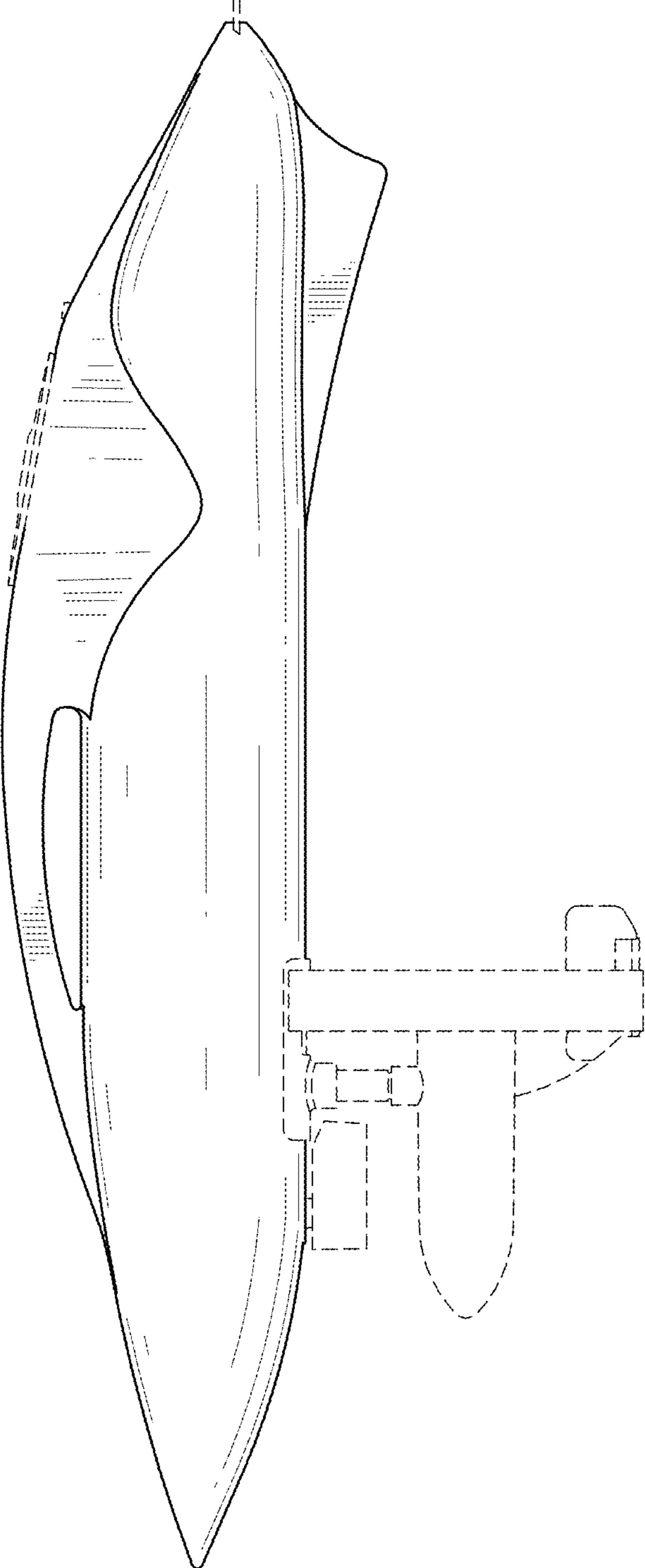

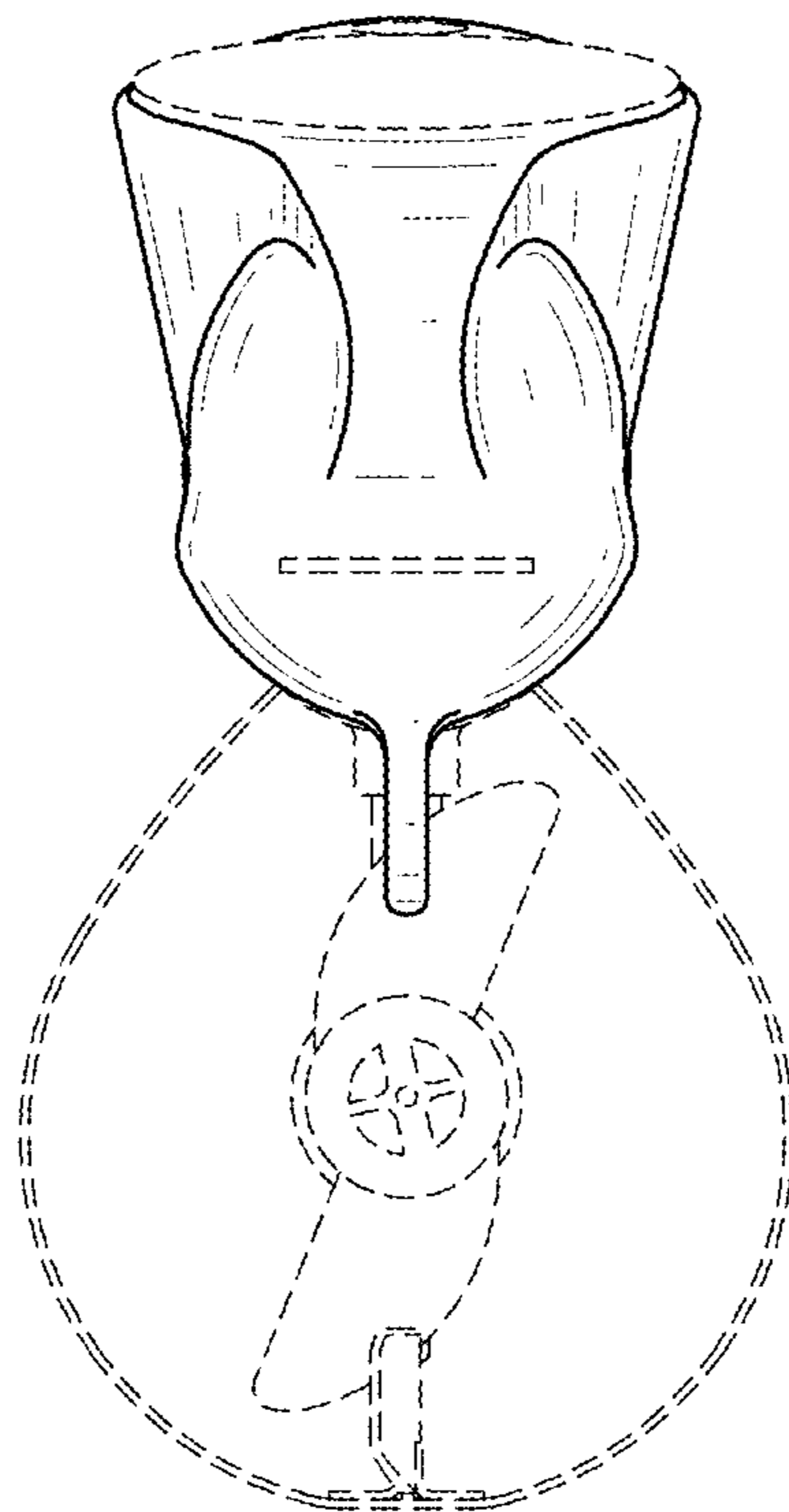

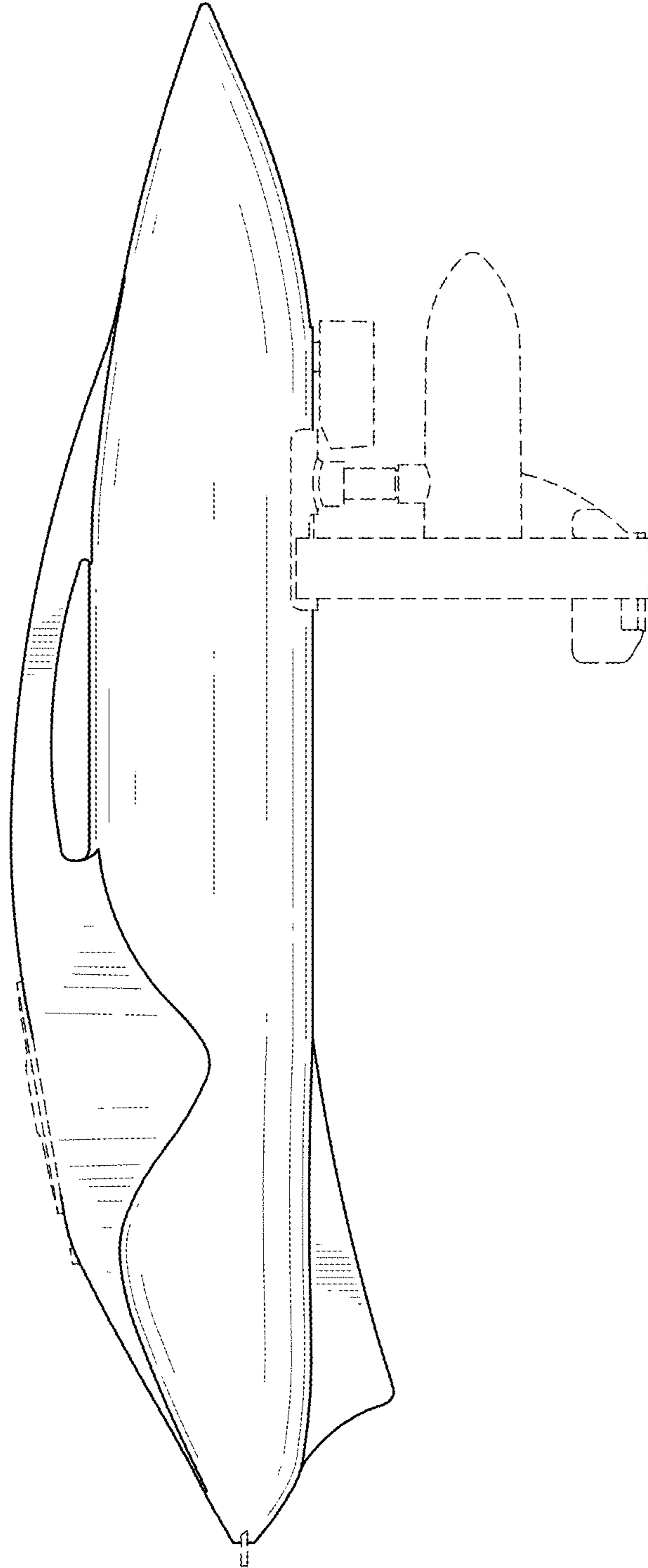

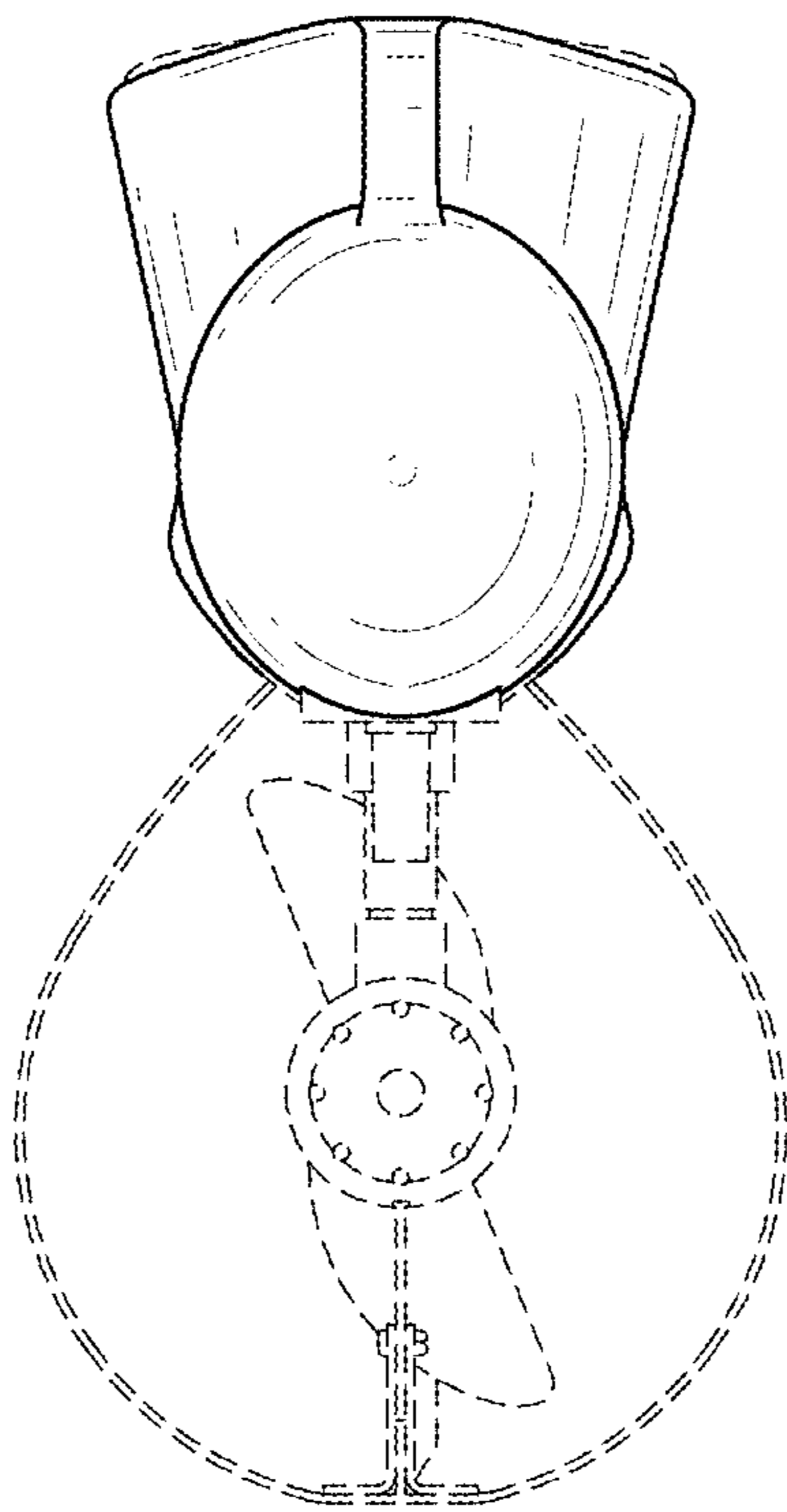

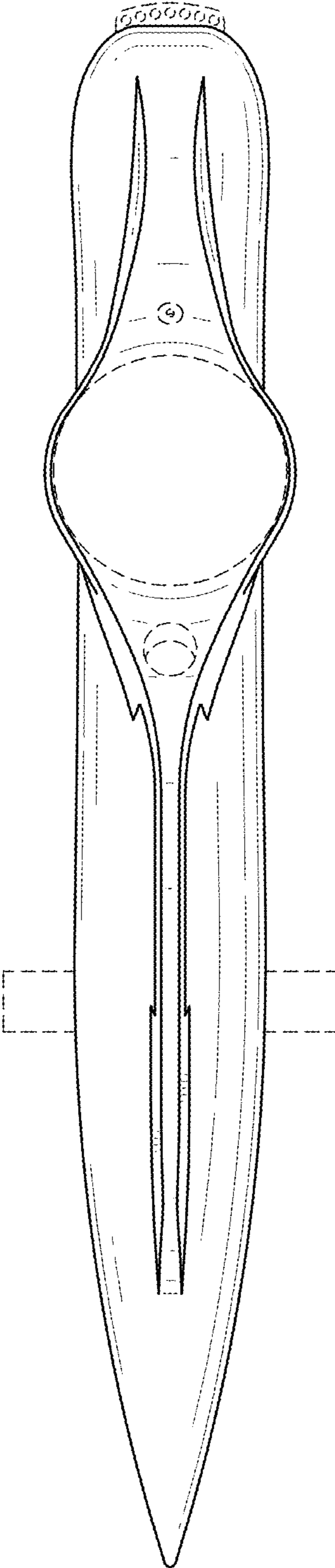

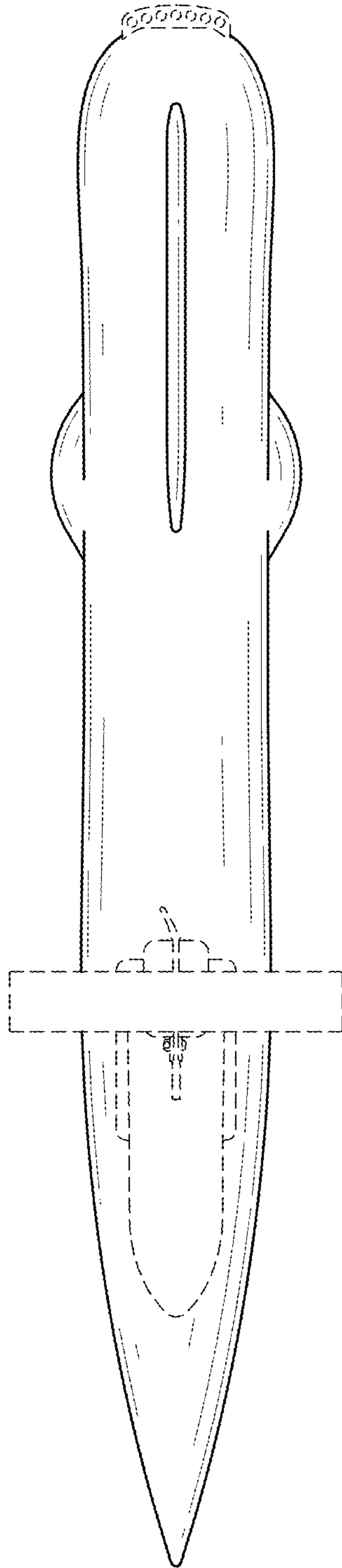

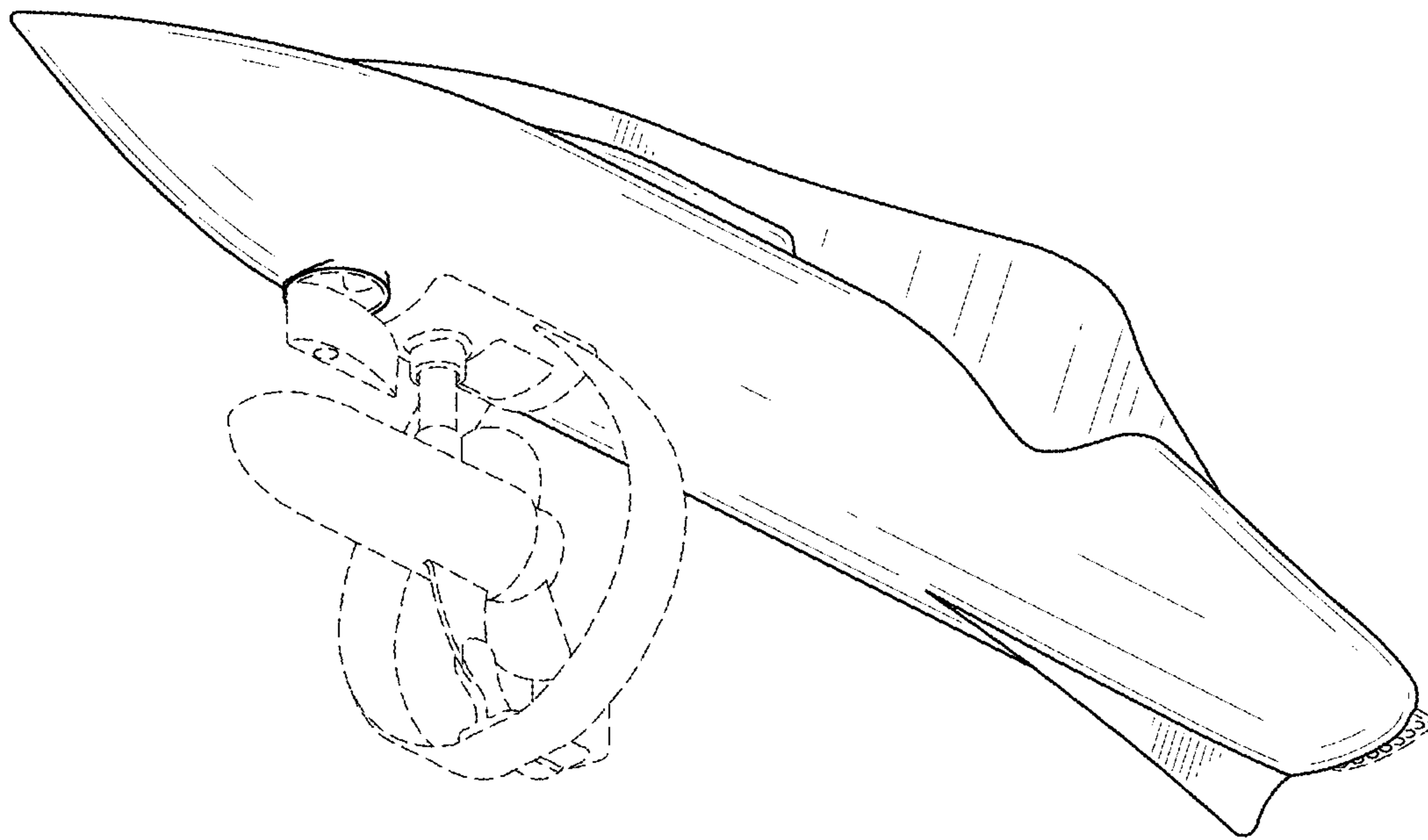
