The ornamental design for a shower control panel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shower control panel showing our design;

FIG. 2 is a front elevation view;

FIG. 3 is a rear elevation view;

FIG. 4 is a left side elevation view;

FIG. 5 is a right side elevation view;

FIG. 6 is a top plan view; and,

FIG. 7 is a bottom plan view.

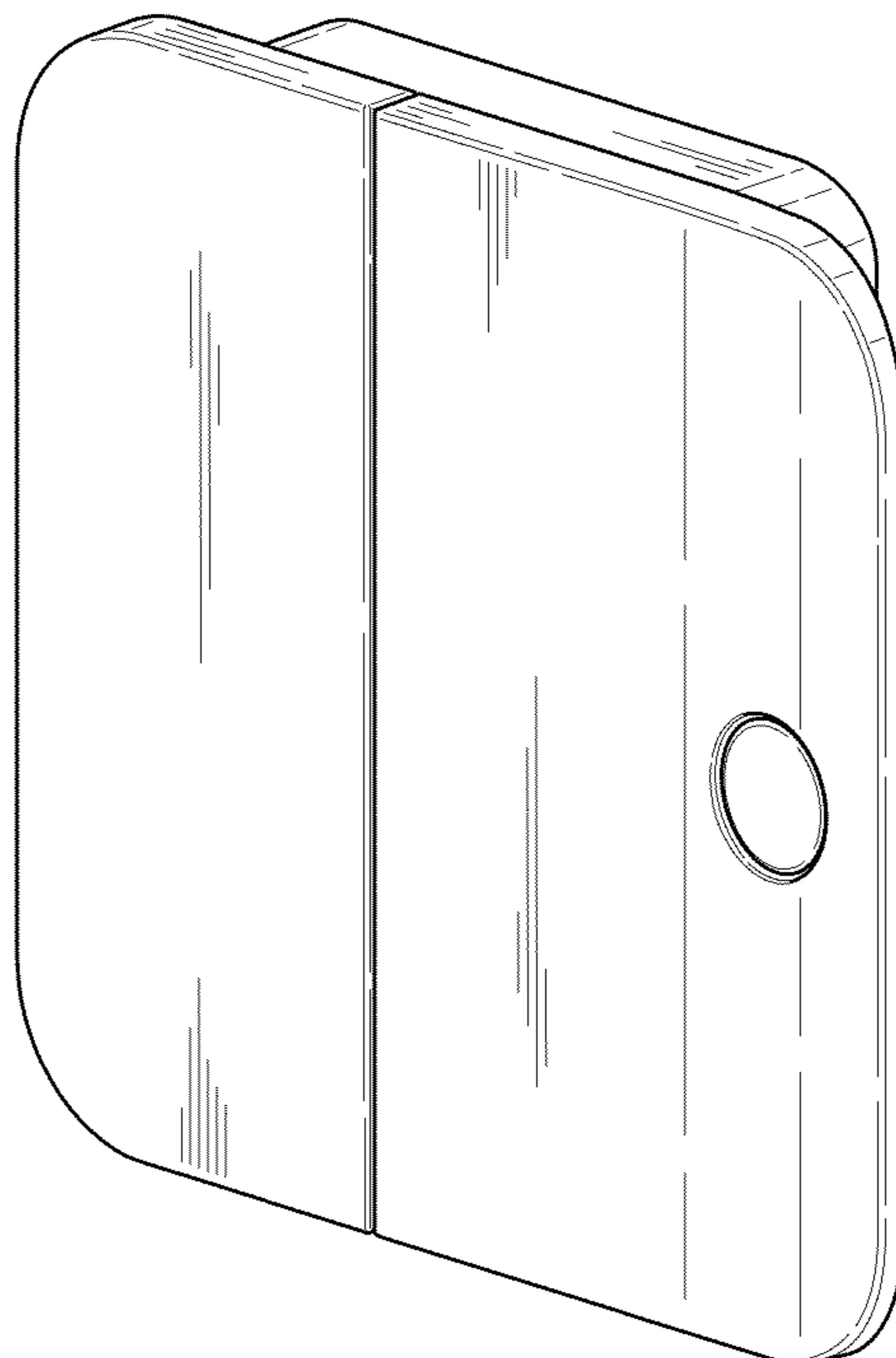

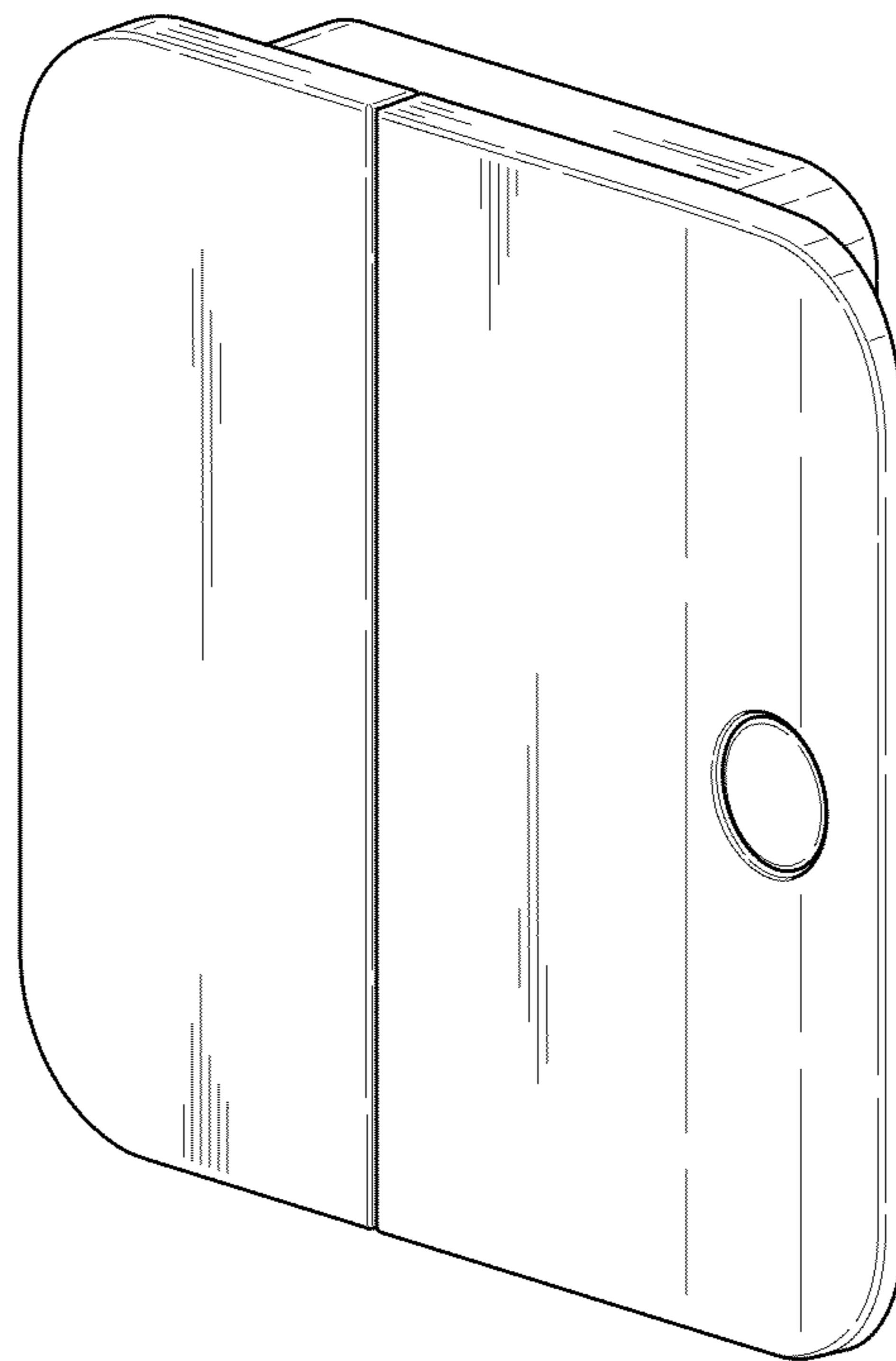

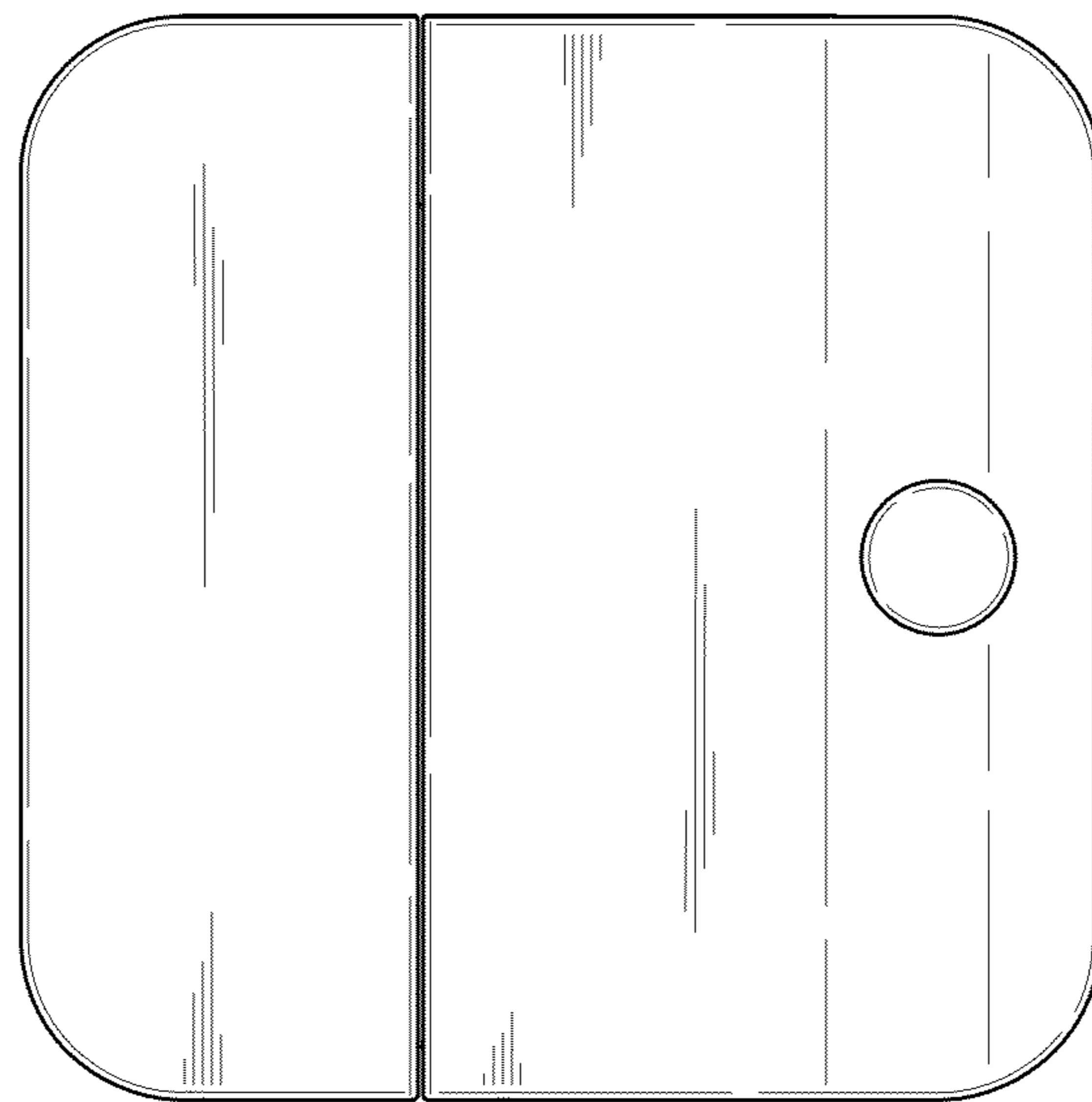

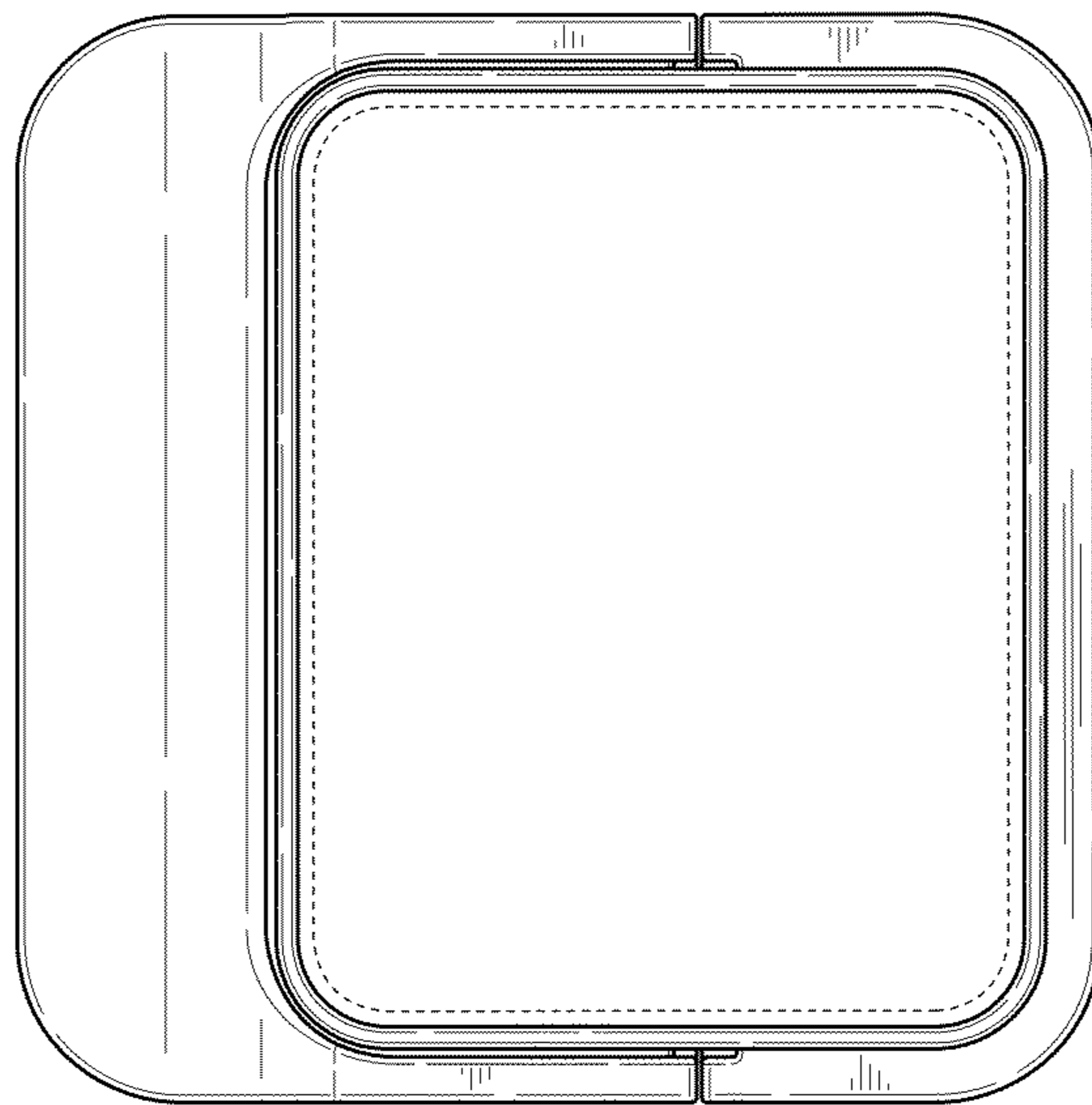

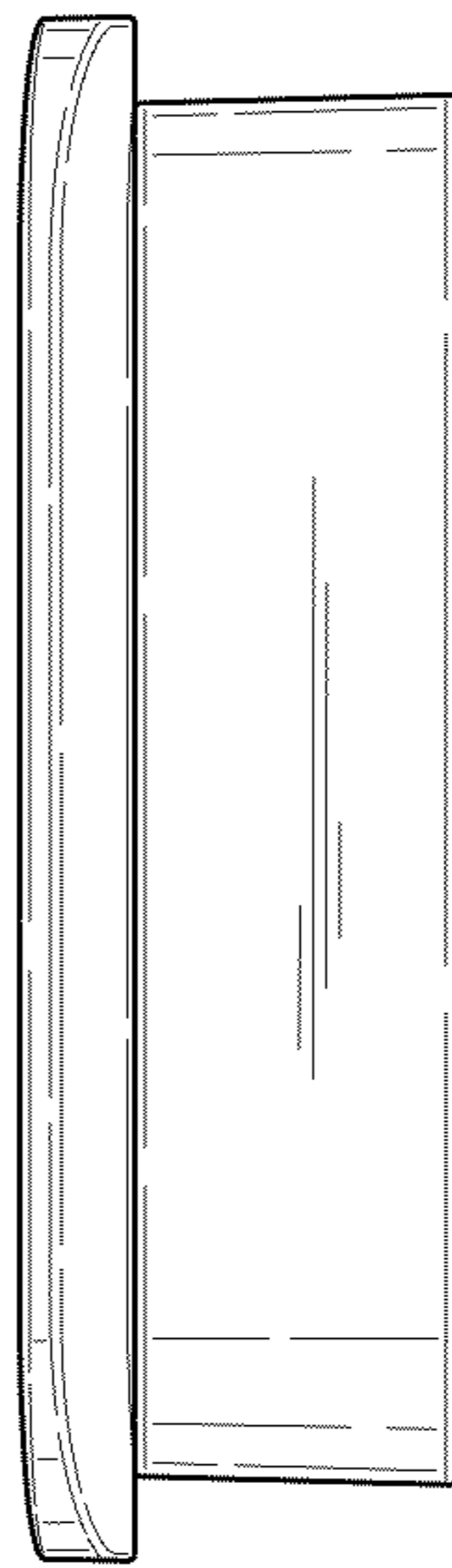

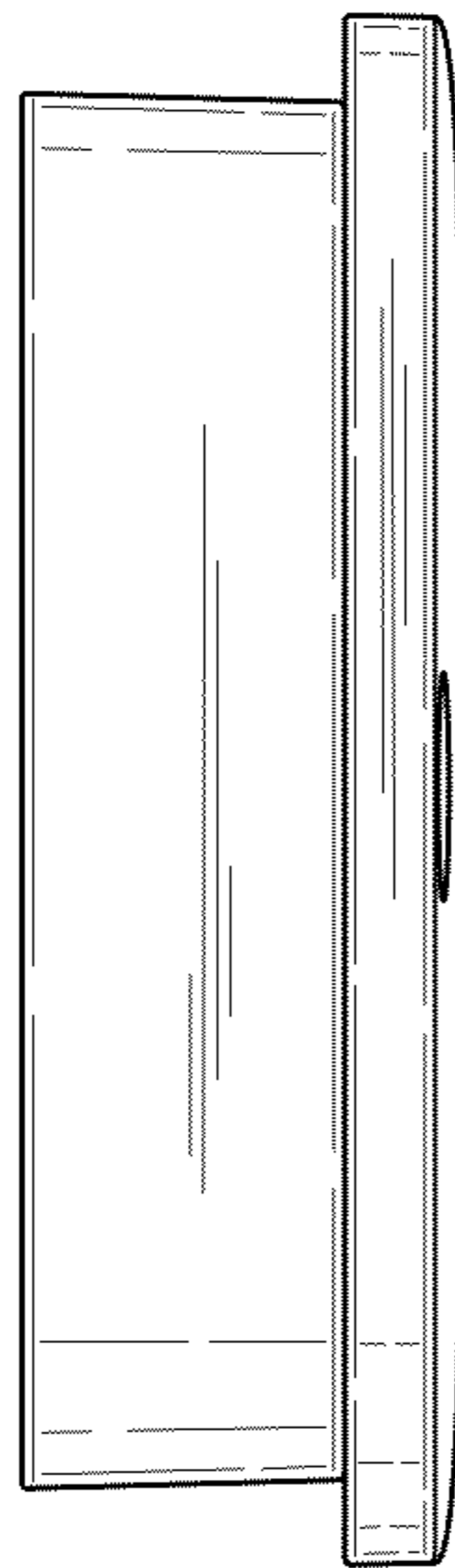

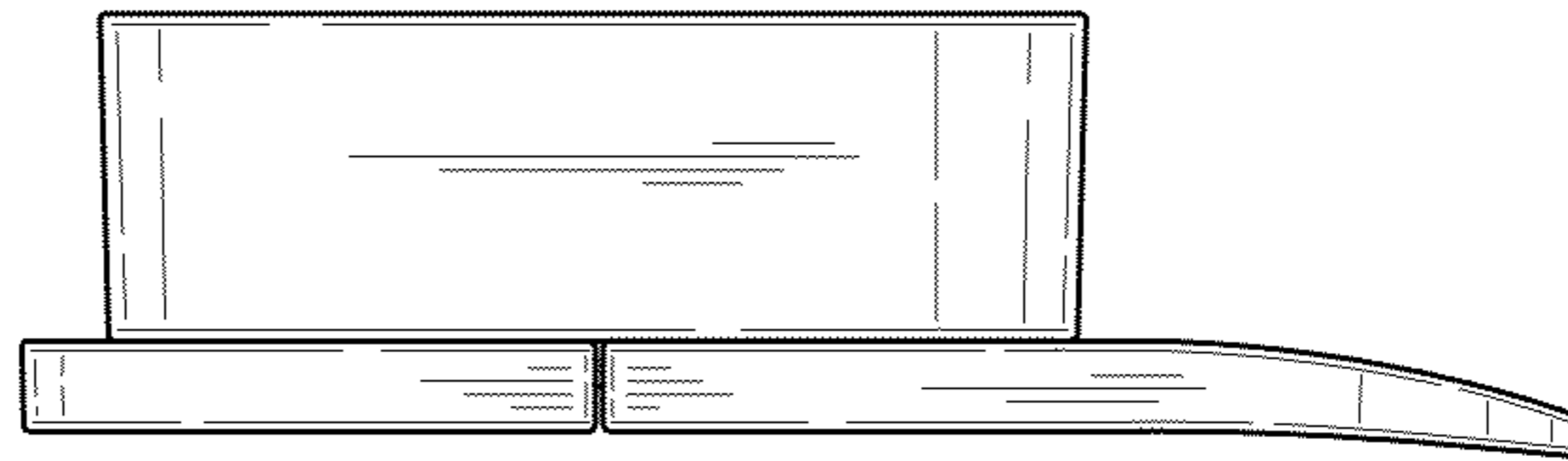
