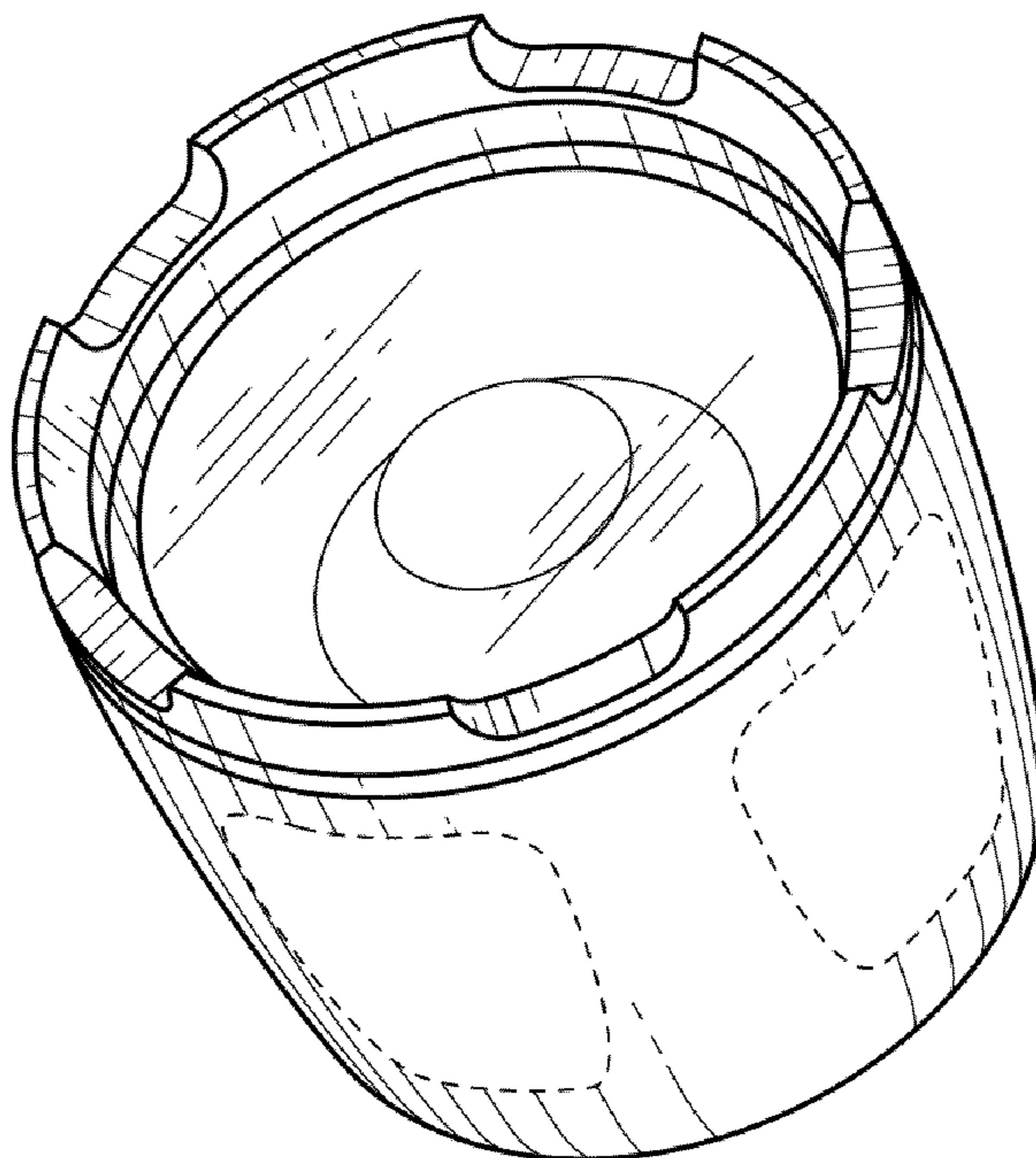
(57) **CLAIM**

The ornamental design for a flashlight head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the flashlight head;
FIG. 2 is a front elevational view of the flashlight head;
FIG. 3 is a rear elevational view of the flashlight head;
FIG. 4 is a right side elevational view of the flashlight head;
FIG. 5 is a left side elevational view of the flashlight head;
FIG. 6 is a top plan view of the flashlight head; and,

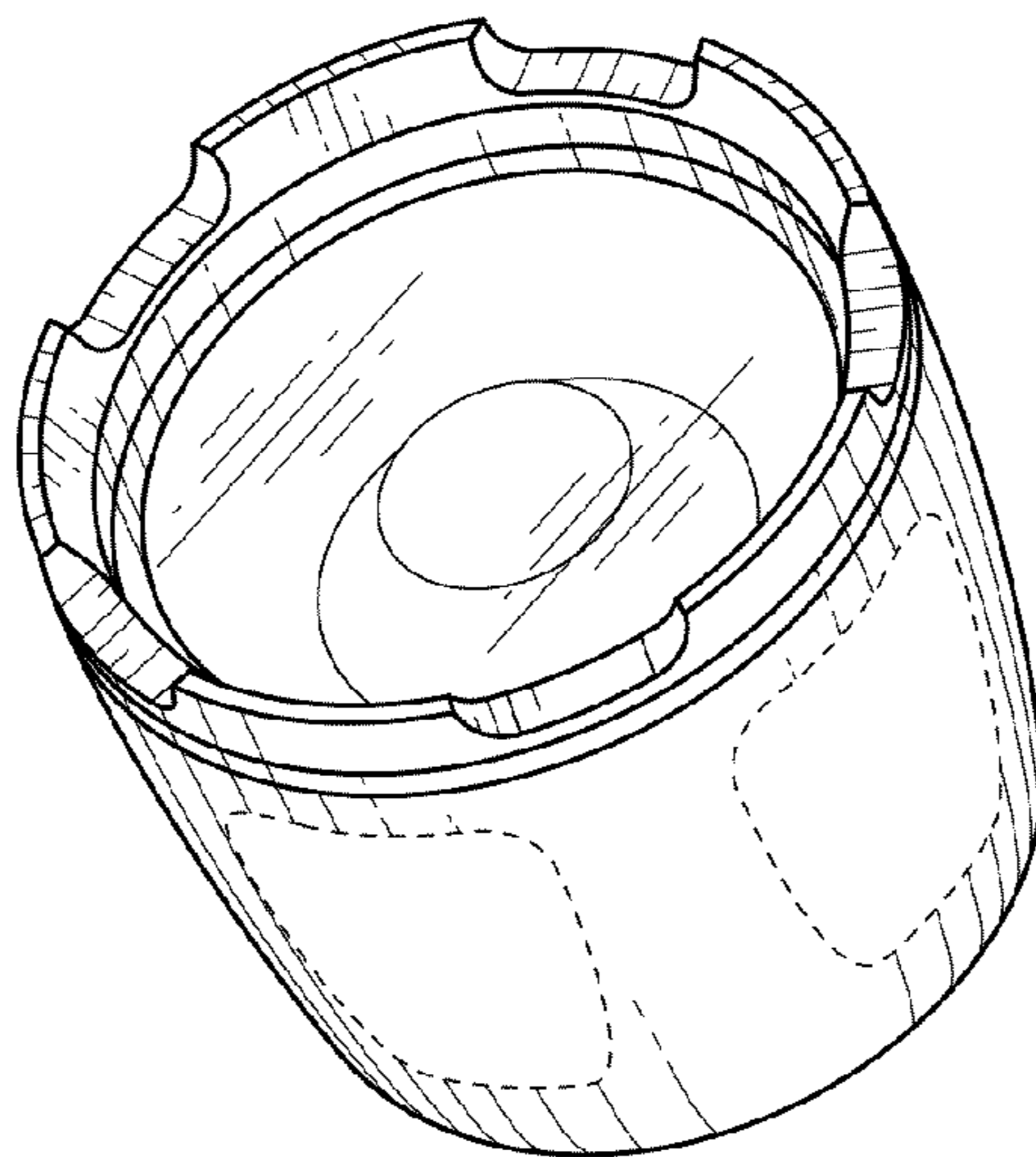

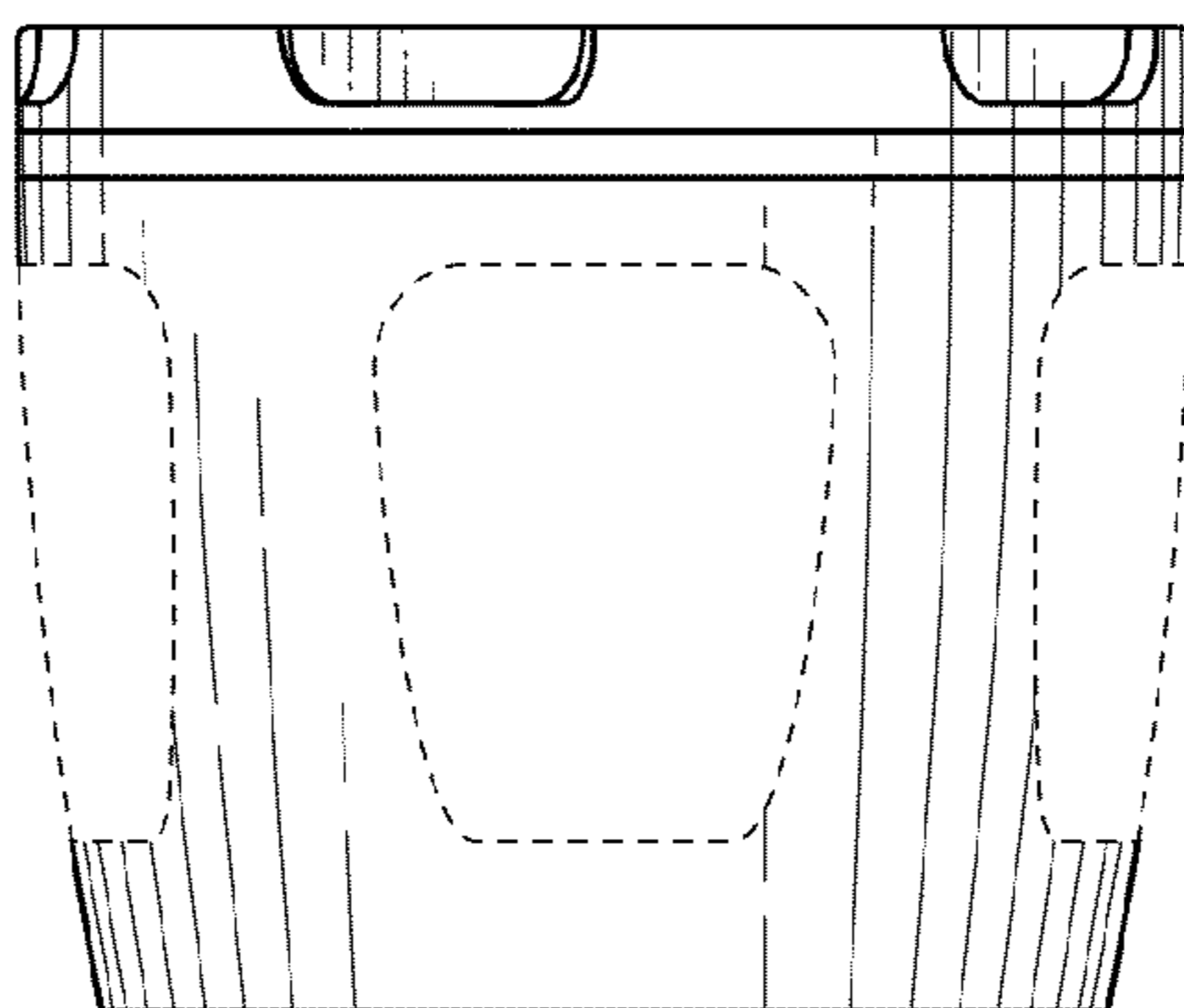

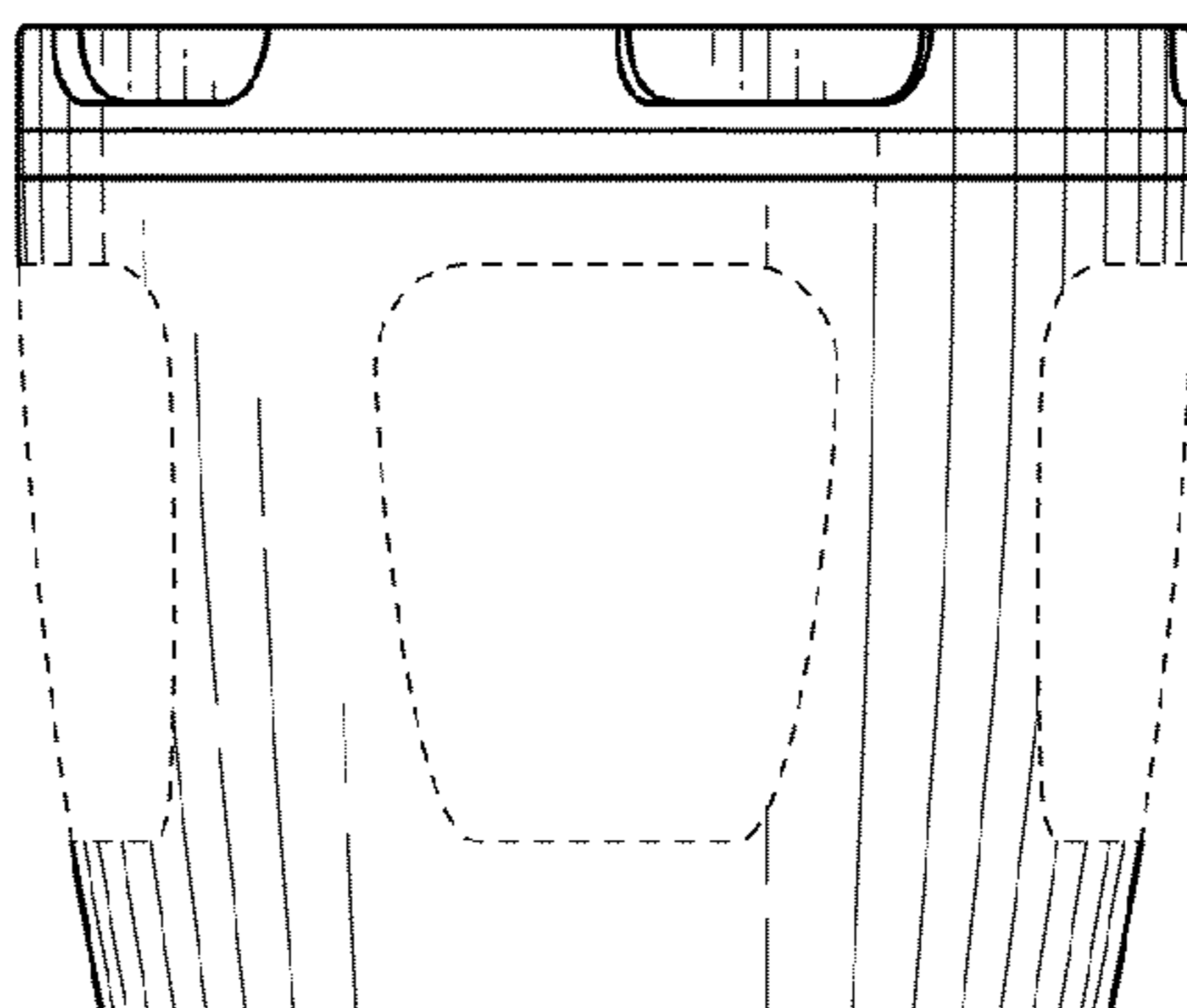

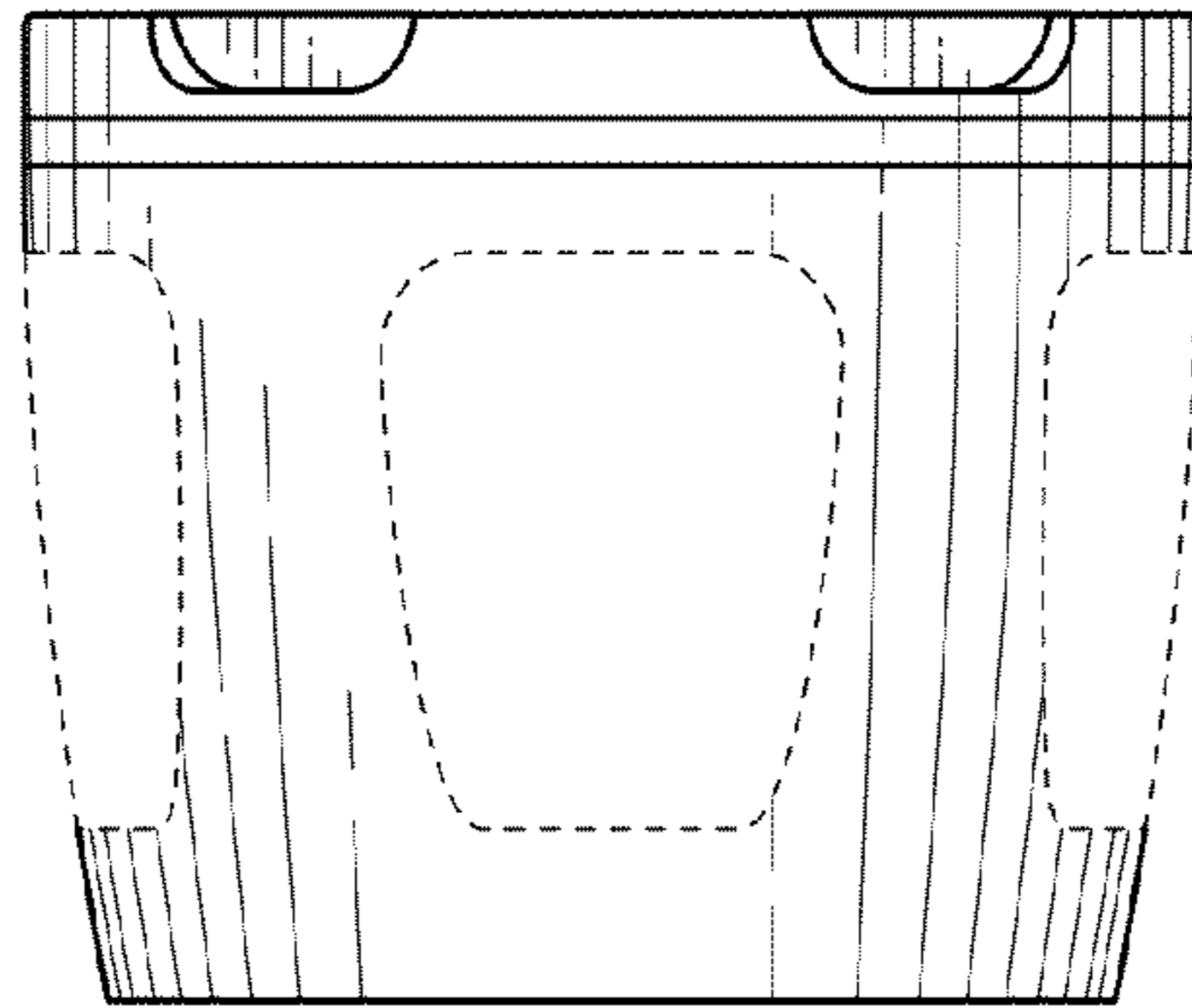

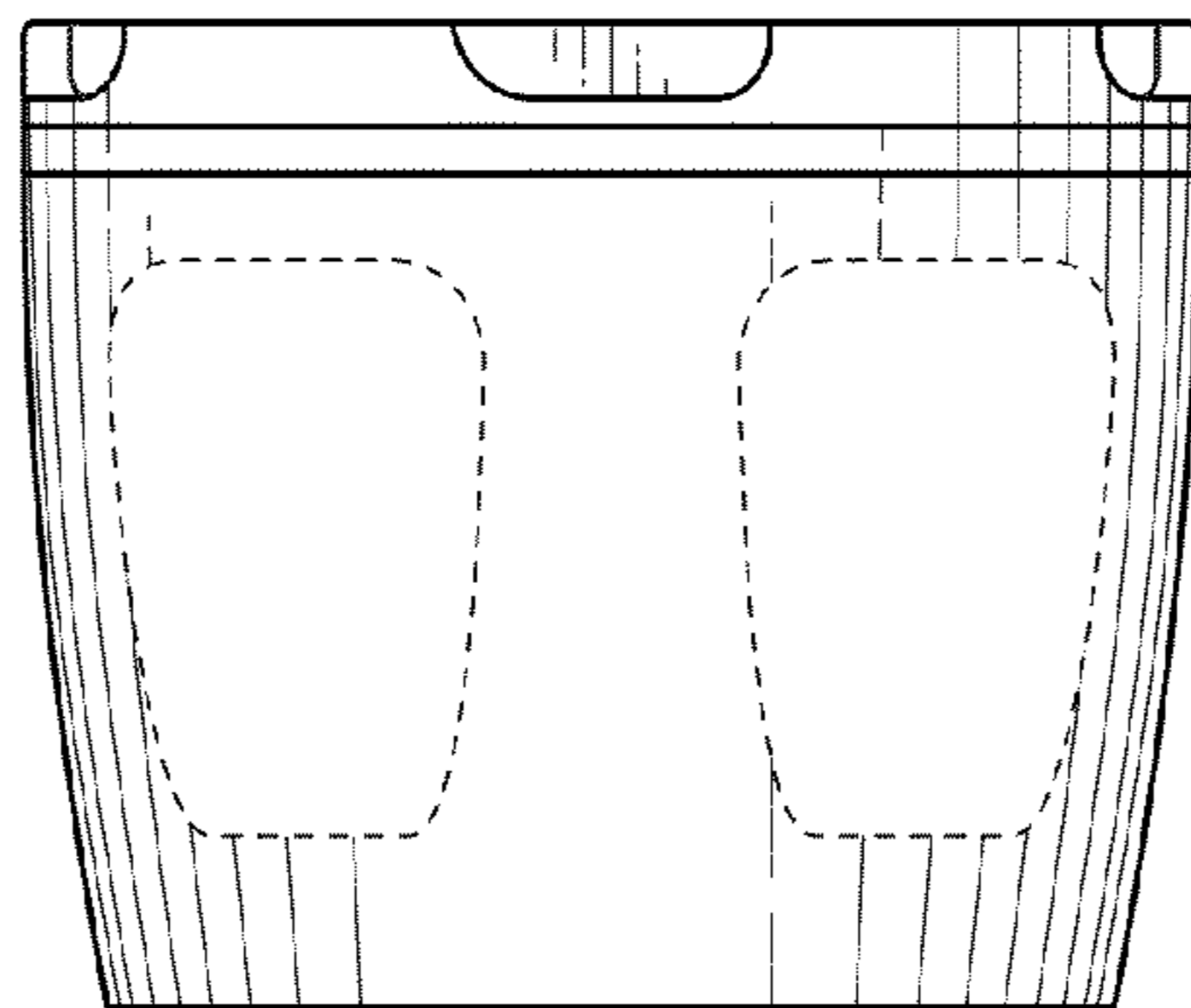

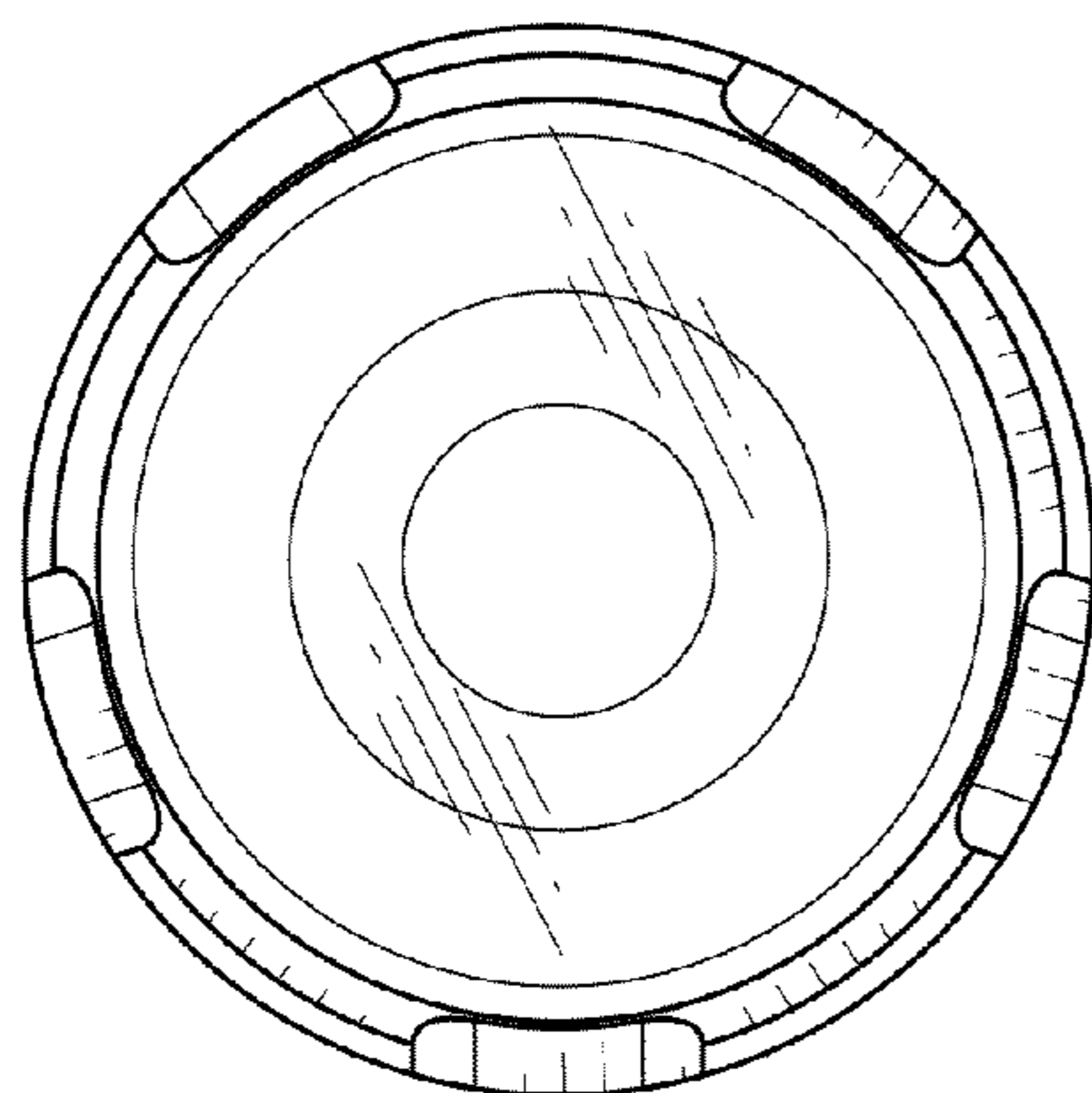

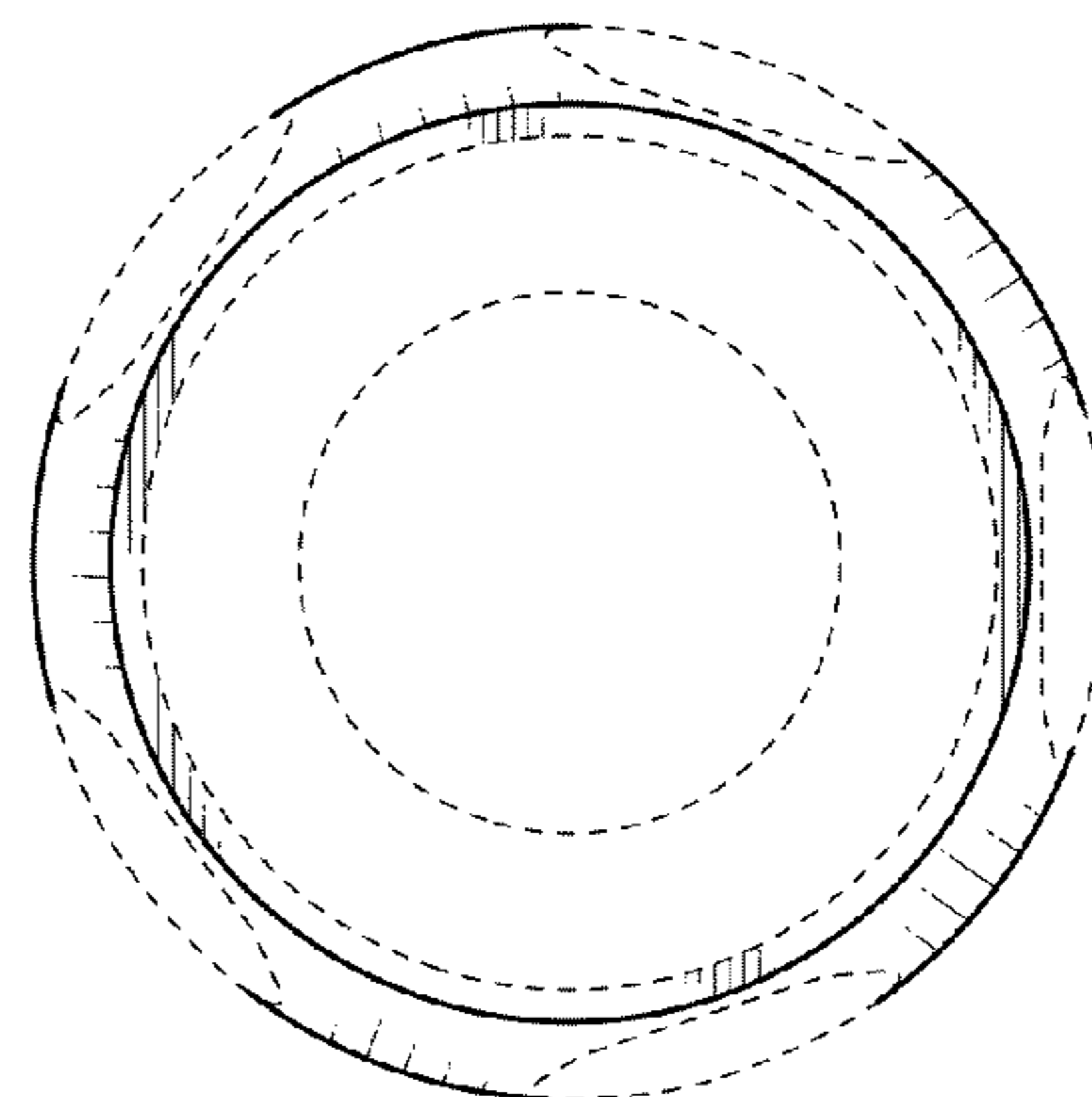
