The ornamental design for a calf transporter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a calf transporter showing my new design;
 FIG. 2 is an enlarged perspective view thereof;
 FIG. 3 is a top plan view of FIG. 2;
 FIG. 4 is a bottom plan view of FIG. 2;
 FIG. 5 is a left side elevational view of FIG. 2;
 FIG. 6 is a right side elevational view of FIG. 2;
 FIG. 7 is a front elevational view of FIG. 2; and,
 FIG. 8 is a rear elevational view thereof.
















