DESCRIPTION

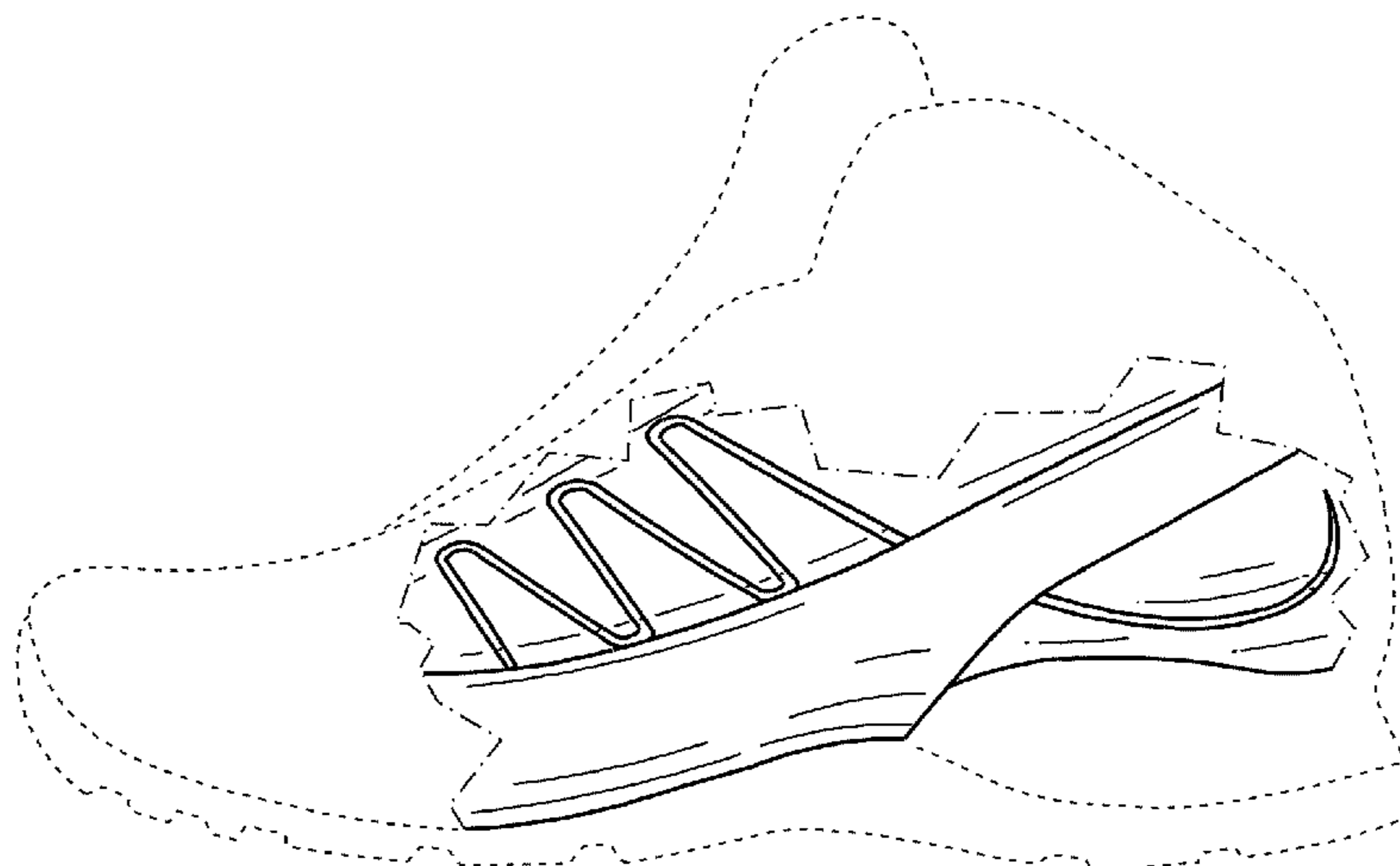
FIG. 1 is a side perspective view of an upper of a footwear article;

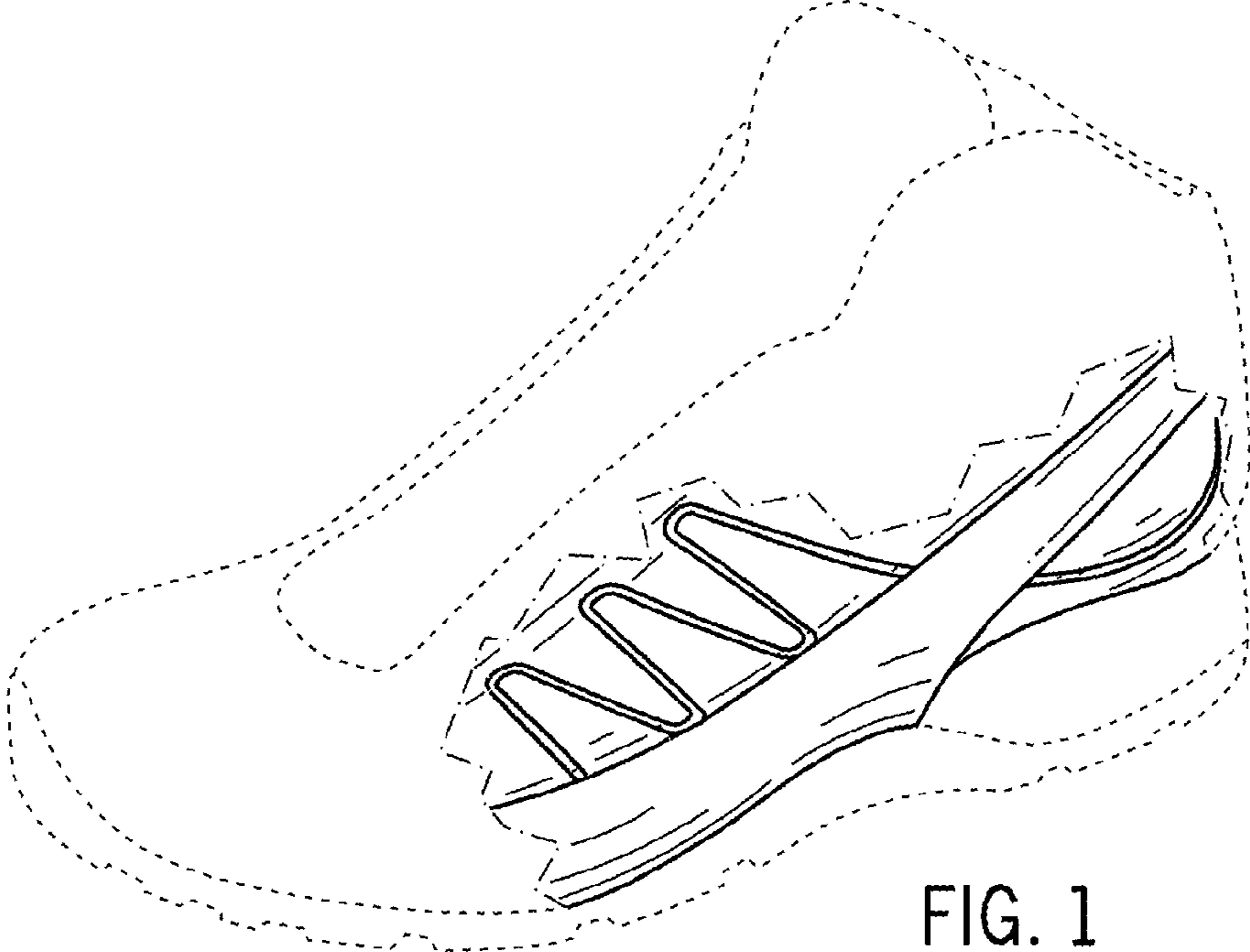

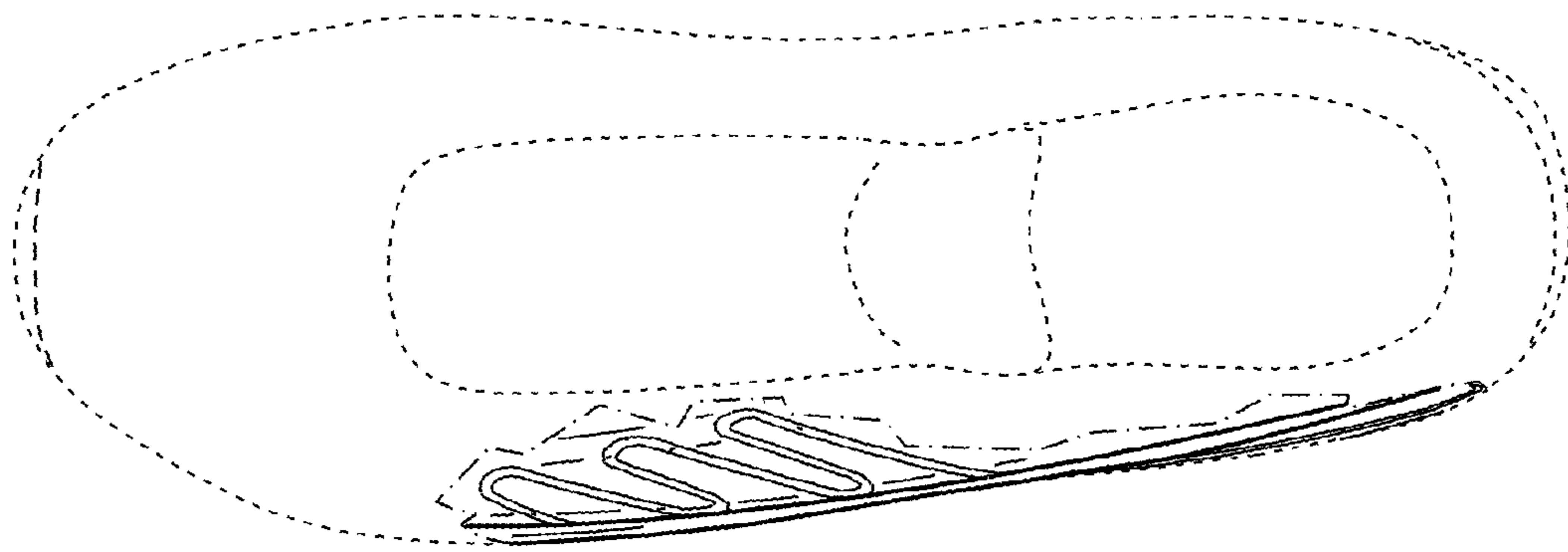
