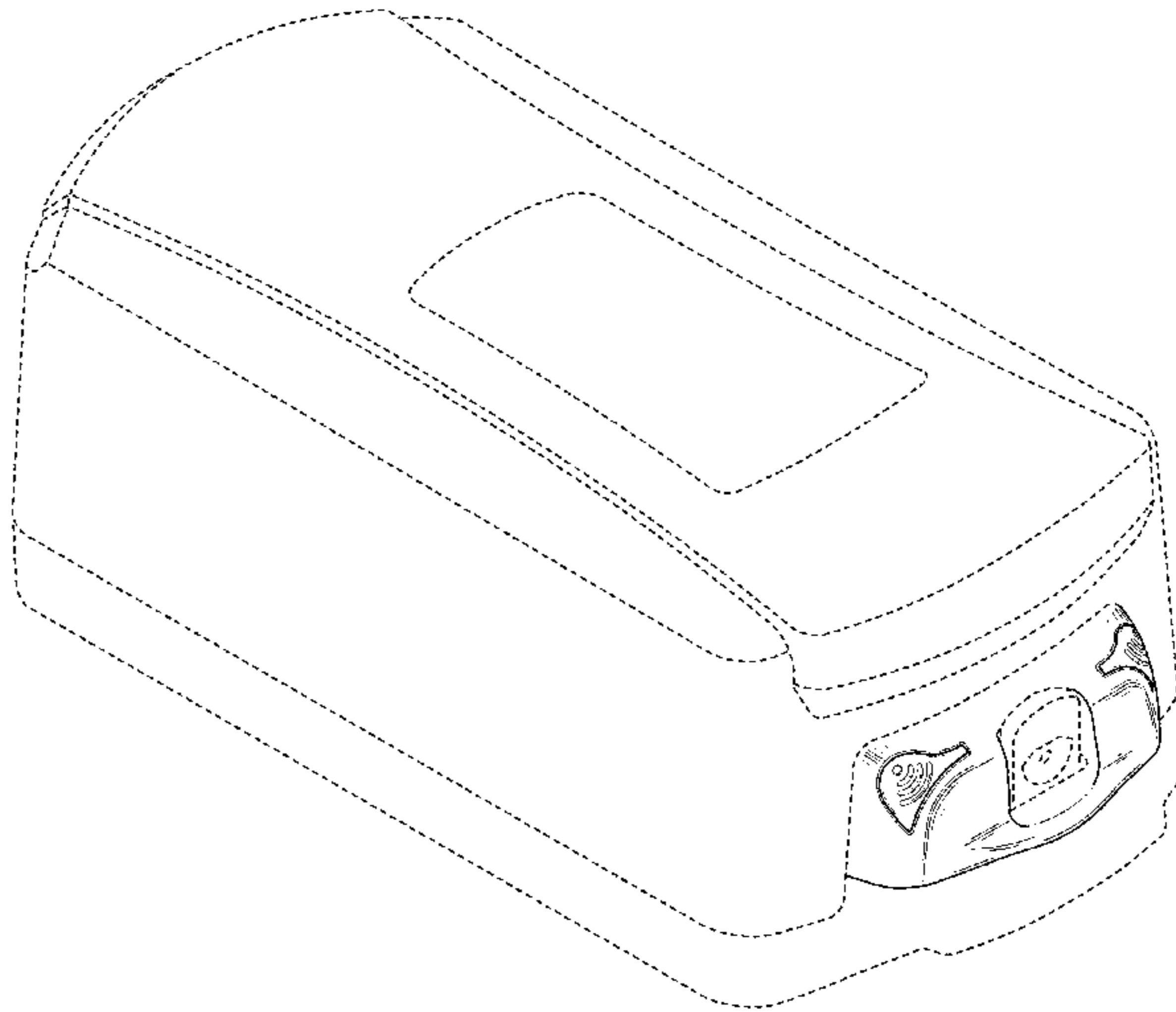
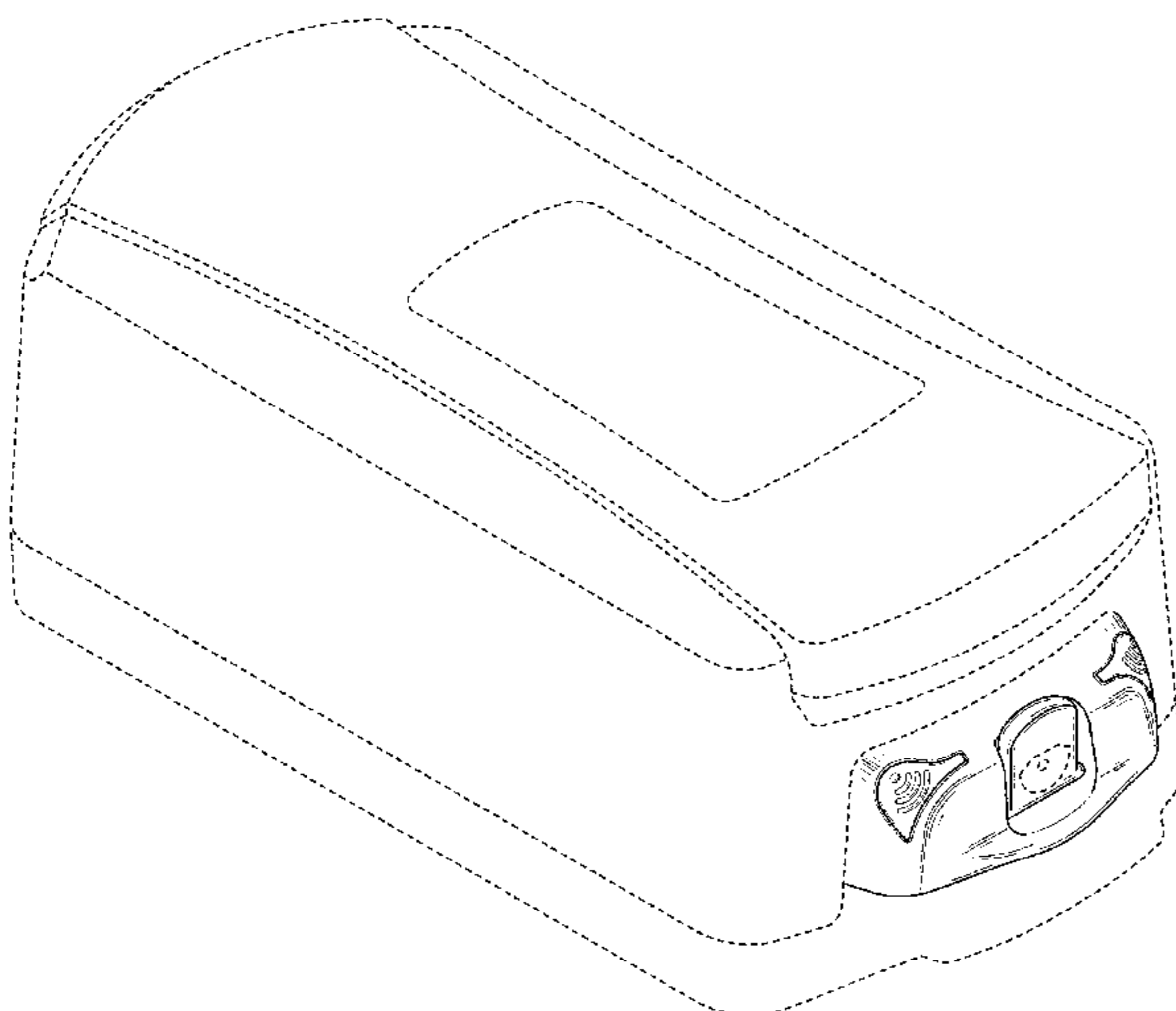
The ornamental design for a dispenser cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a dispenser cap of the new design;  
FIG. 2 is a front elevational view of the dispenser cap of FIG. 1;  
FIG. 3 is a rear elevational view of the dispenser cap of FIG. 1;  
FIG. 4 is a right elevational view of the dispenser cap of FIG. 1;  
FIG. 5 is a left elevational view of the dispenser cap of FIG. 1;  
FIG. 6 is a top plan view of the dispenser cap of FIG. 1, of which the bottom surface of the first embodiment of the dispenser cap is unornamented;  
FIG. 7 is a perspective view of a second embodiment of the dispenser cap shown in FIG. 1; and  
FIG. 8 is a front elevational view of the dispenser cap of FIG. 7;  
FIG. 9 is a rear elevational view of the dispenser cap of FIG. 7;  
FIG. 10 is a right elevational view of the dispenser cap of FIG. 7;  
FIG. 11 is a left elevational view of the dispenser cap of FIG. 7; and,  
FIG. 12 is a top plan view of the dispenser cap of FIG. 7, of which the bottom of the second embodiment of the dispenser cap is unornamented.

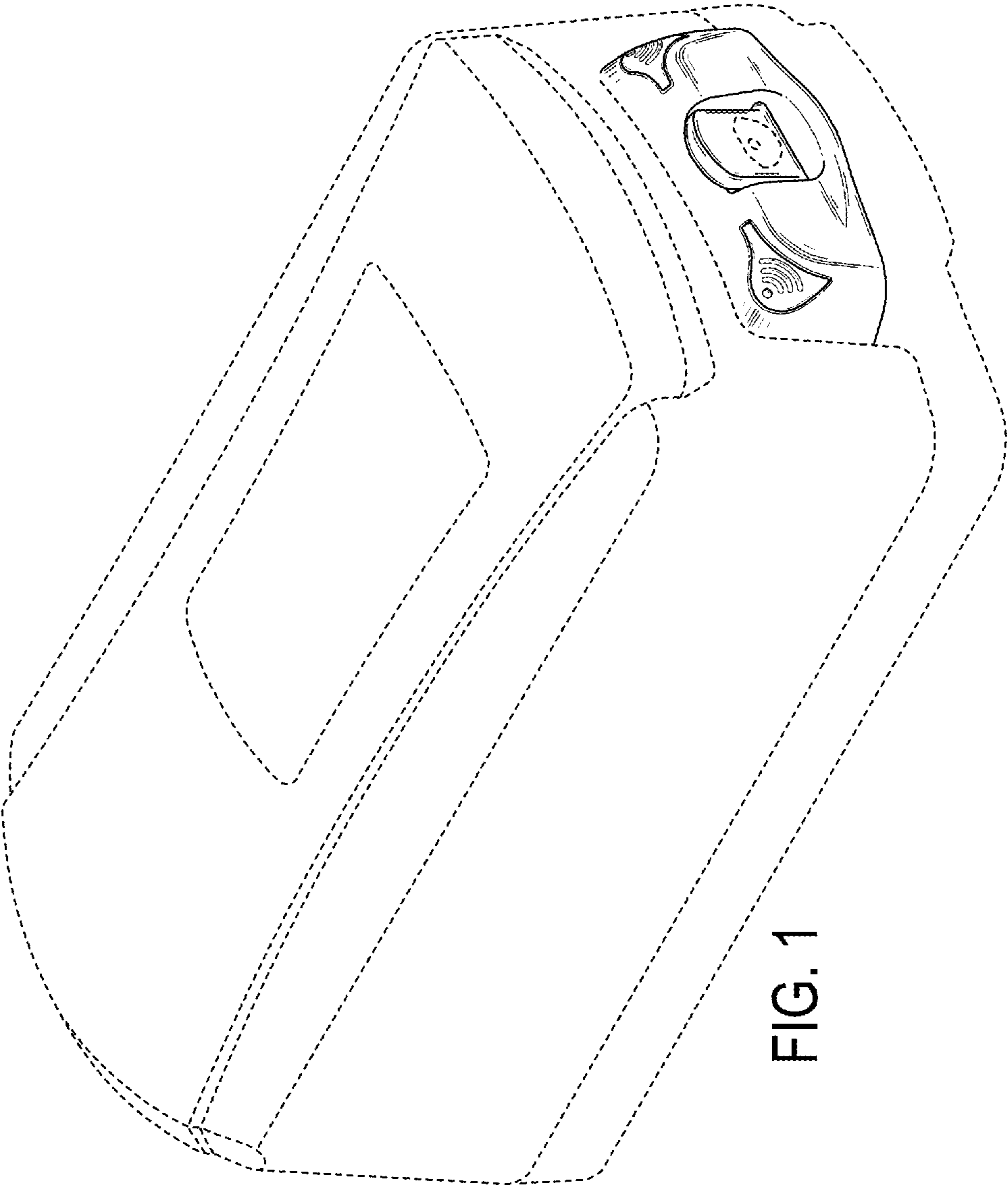

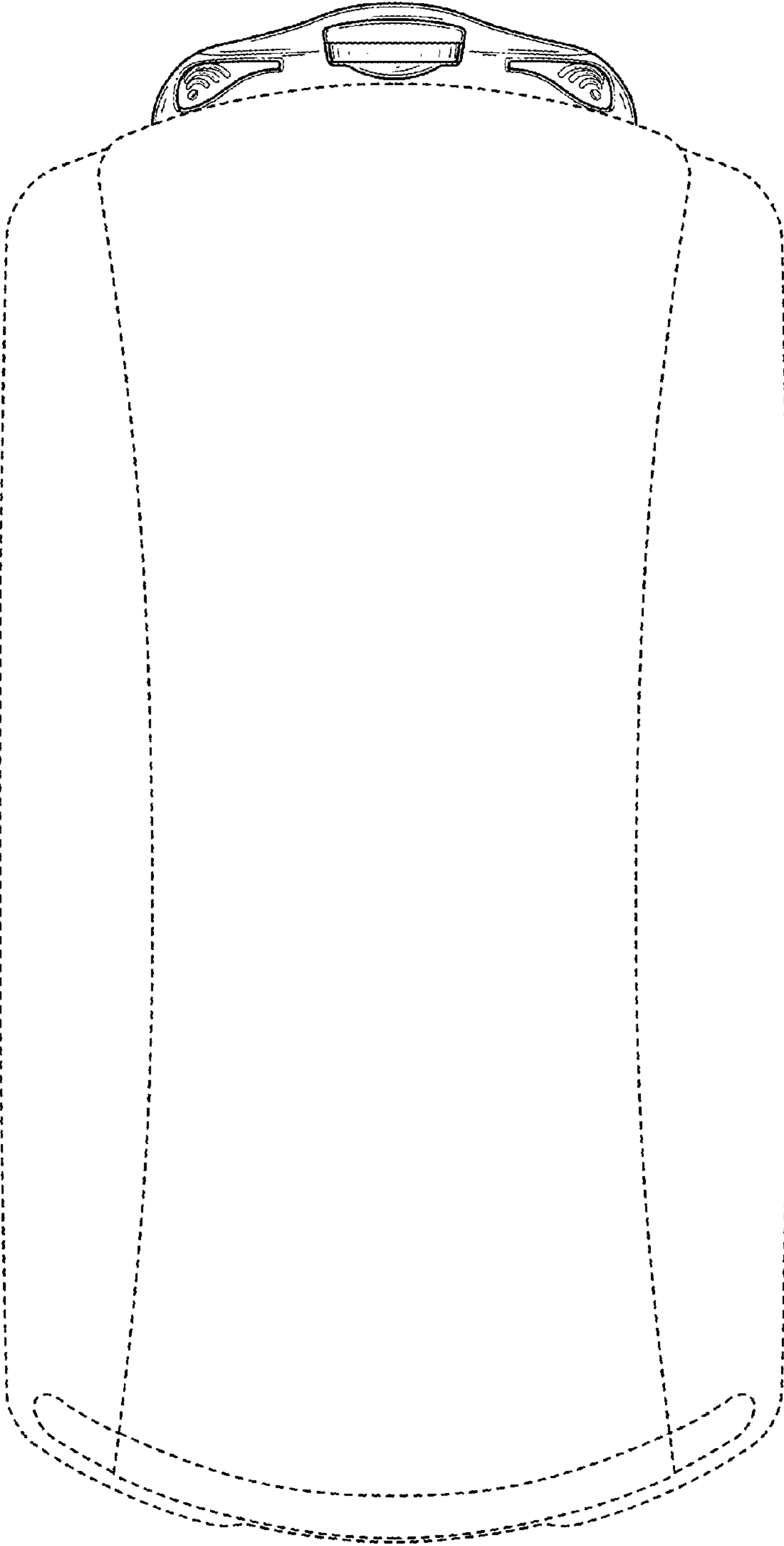

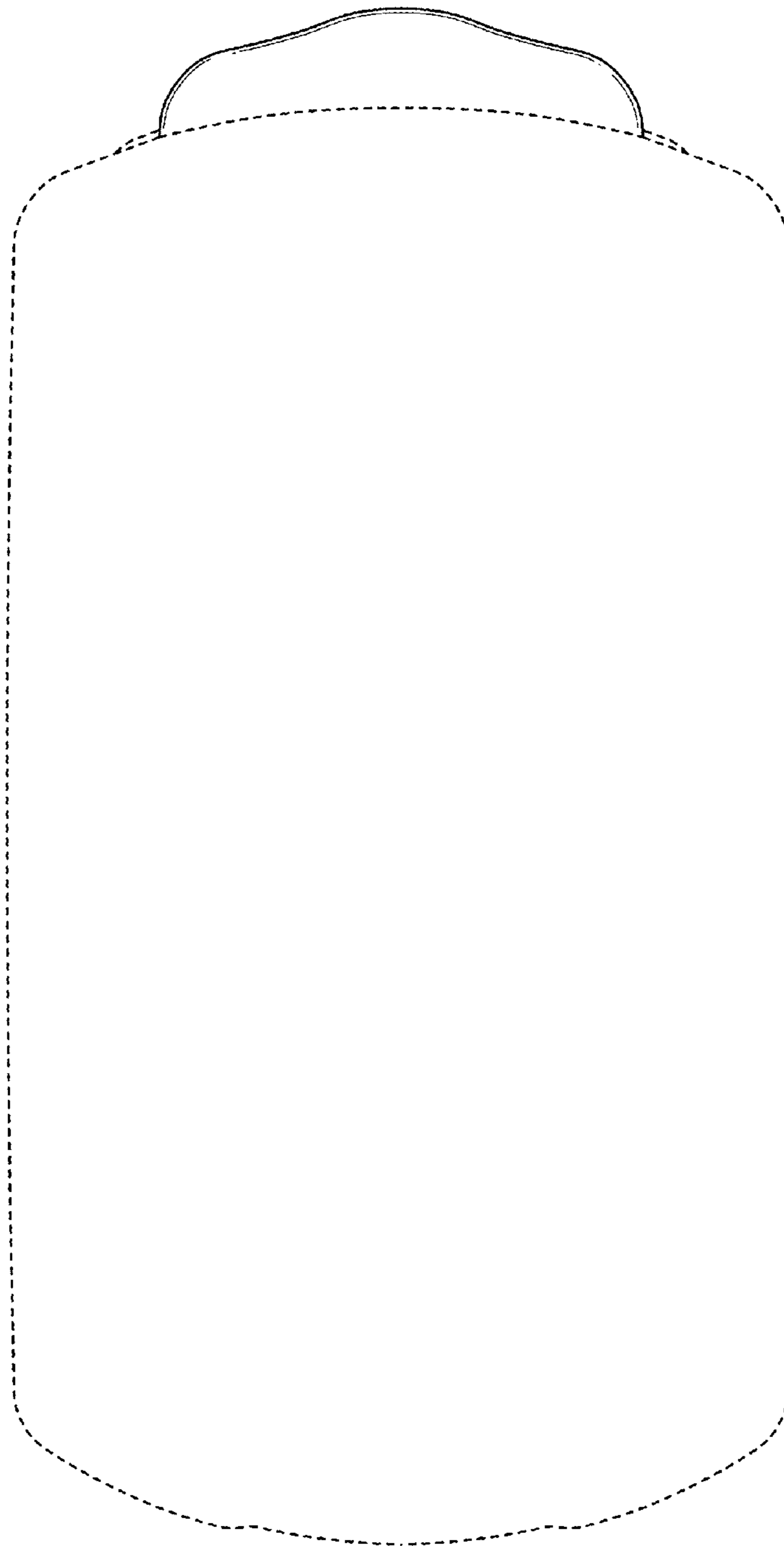

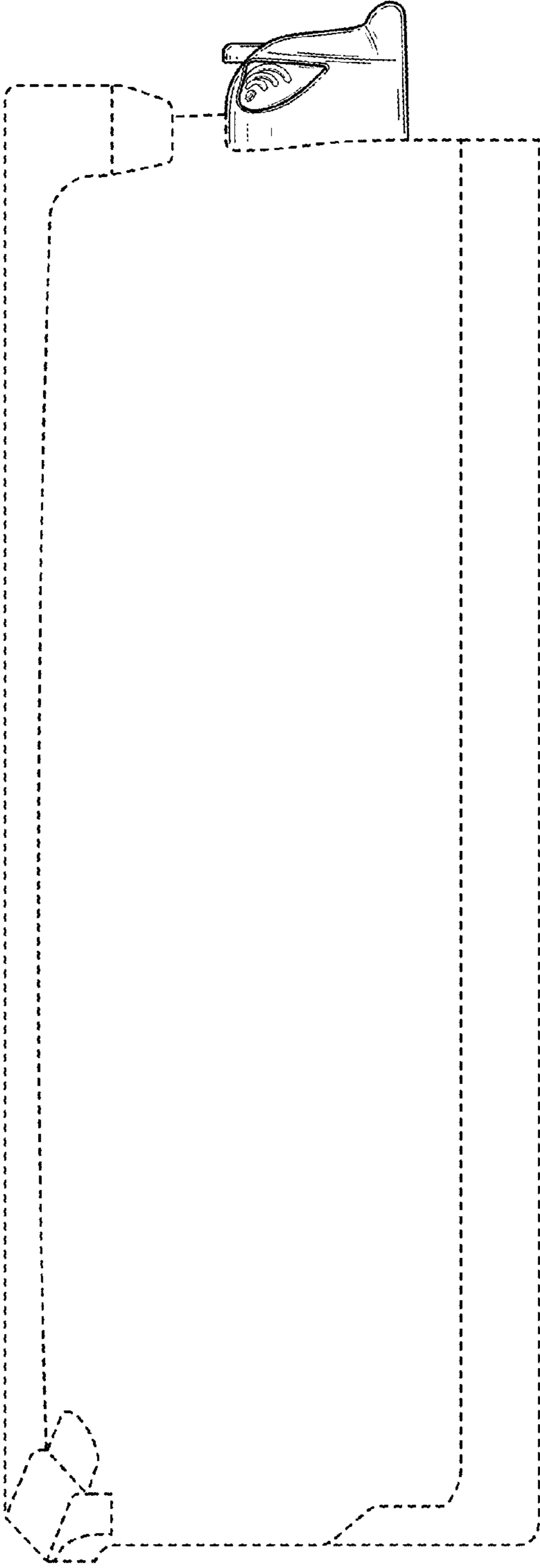

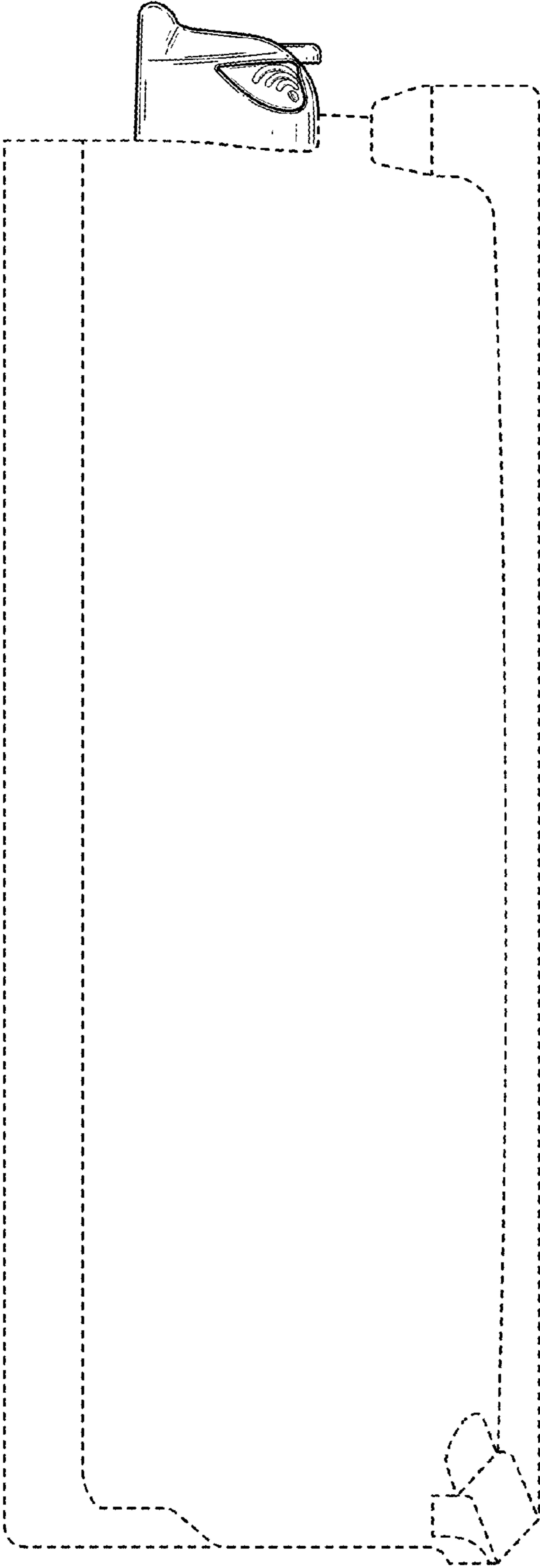

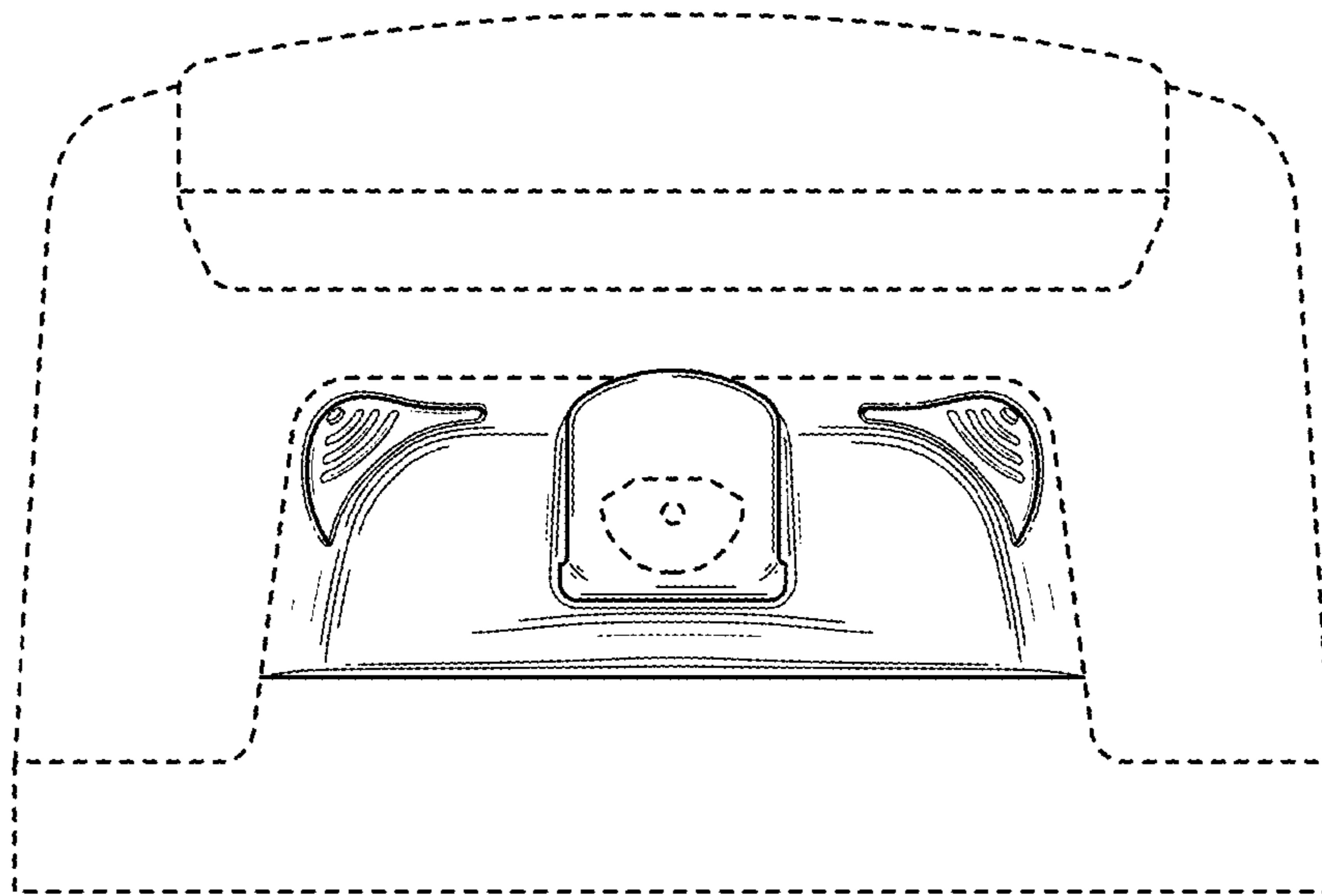

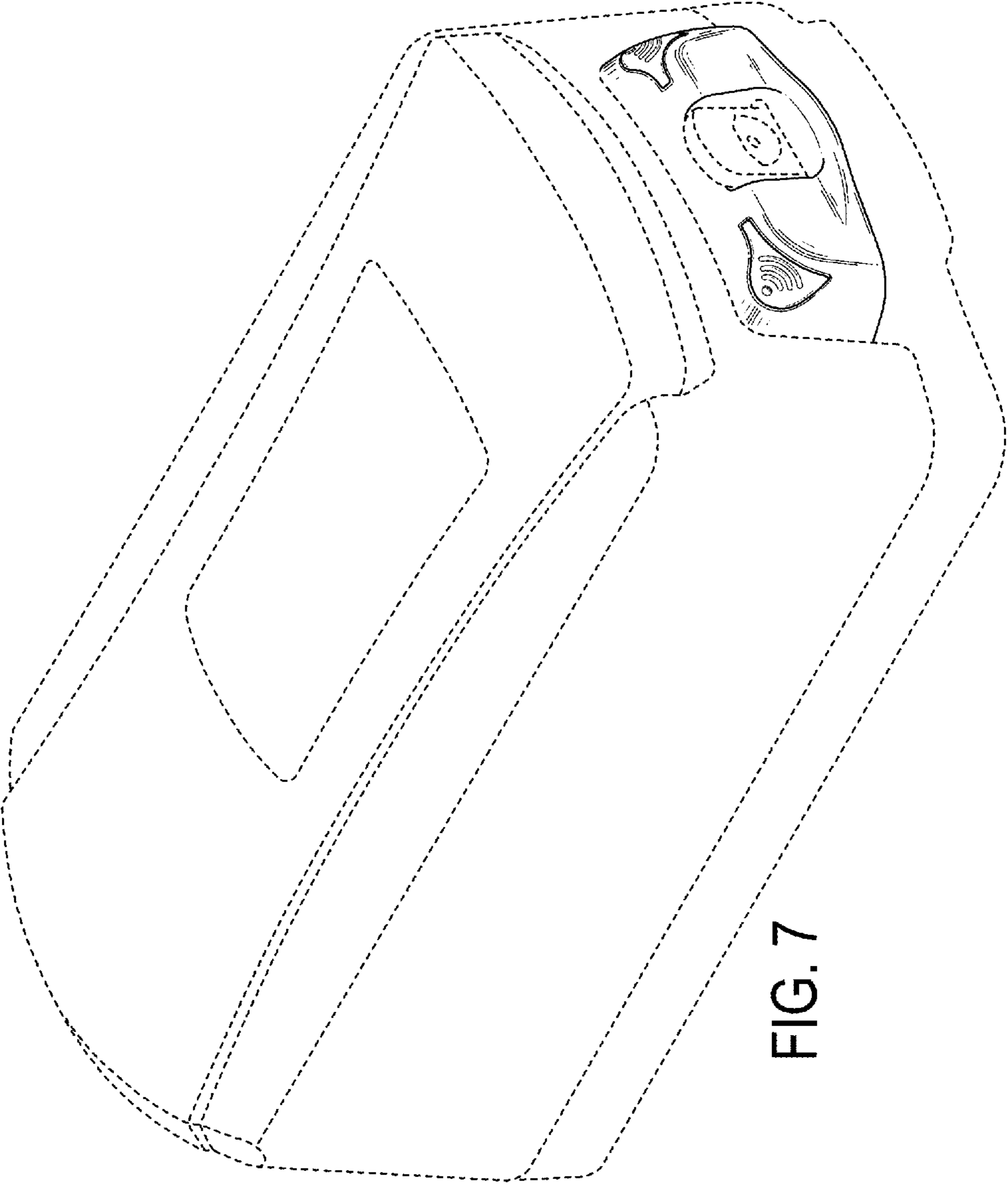

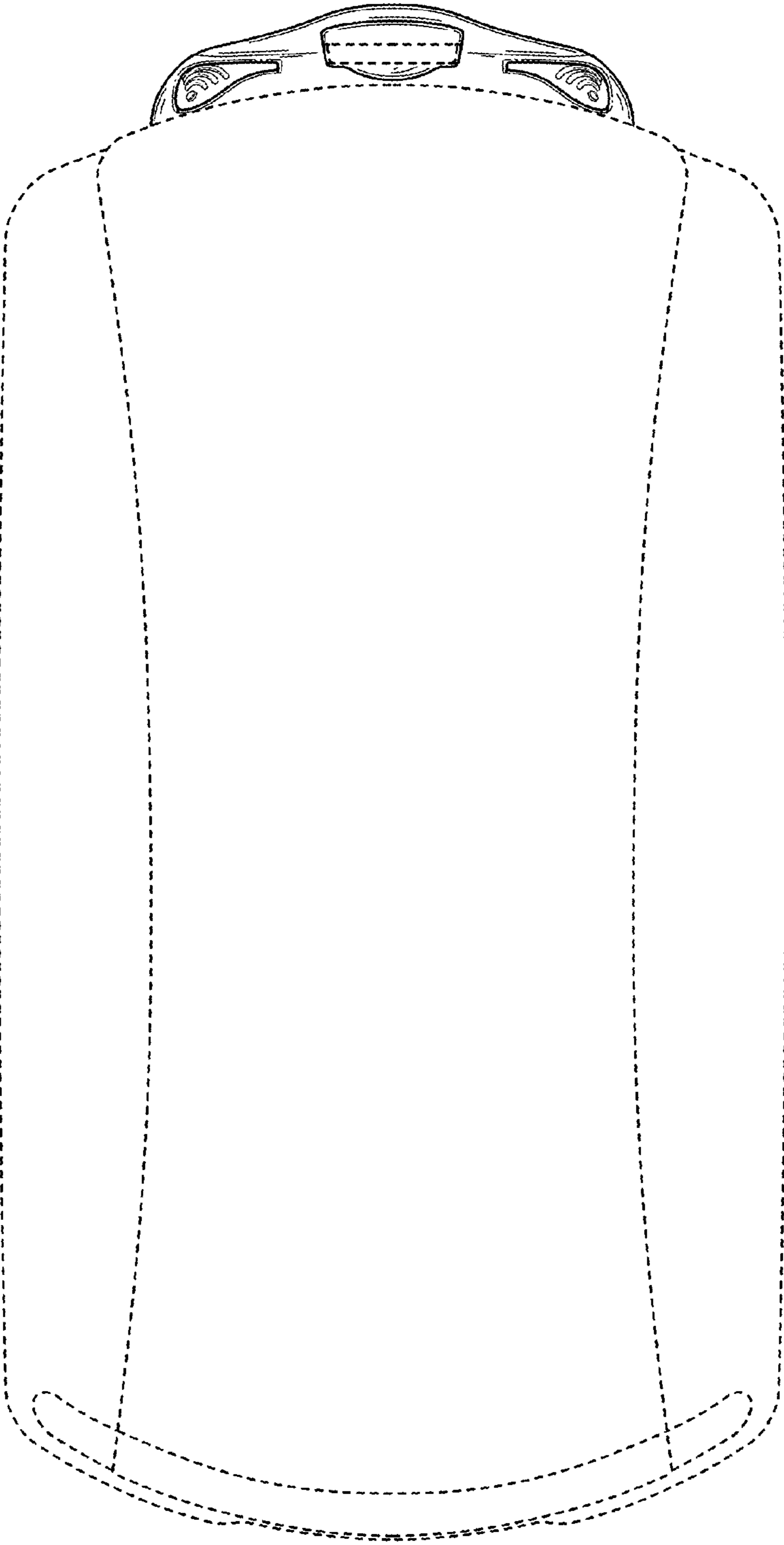

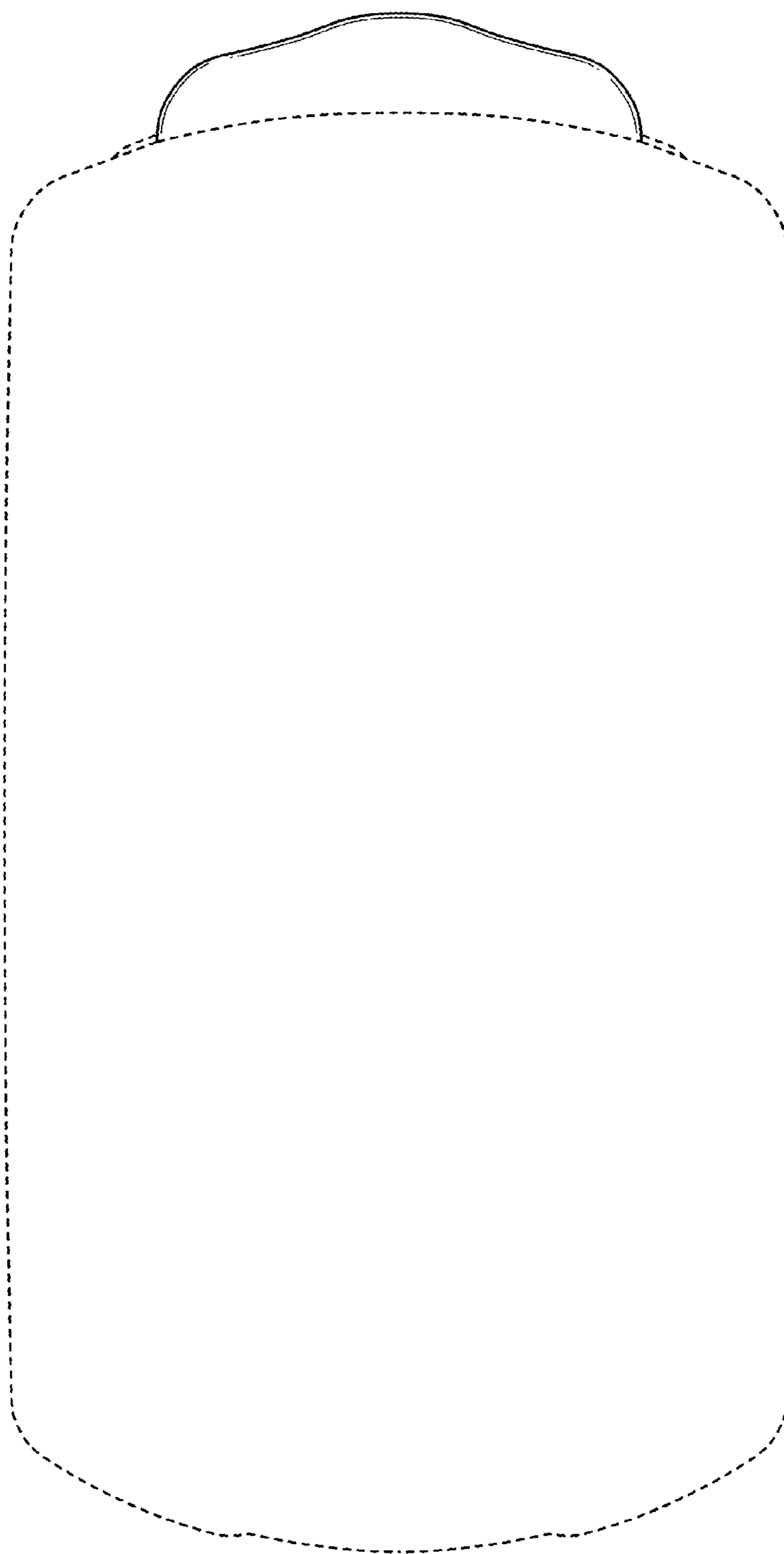

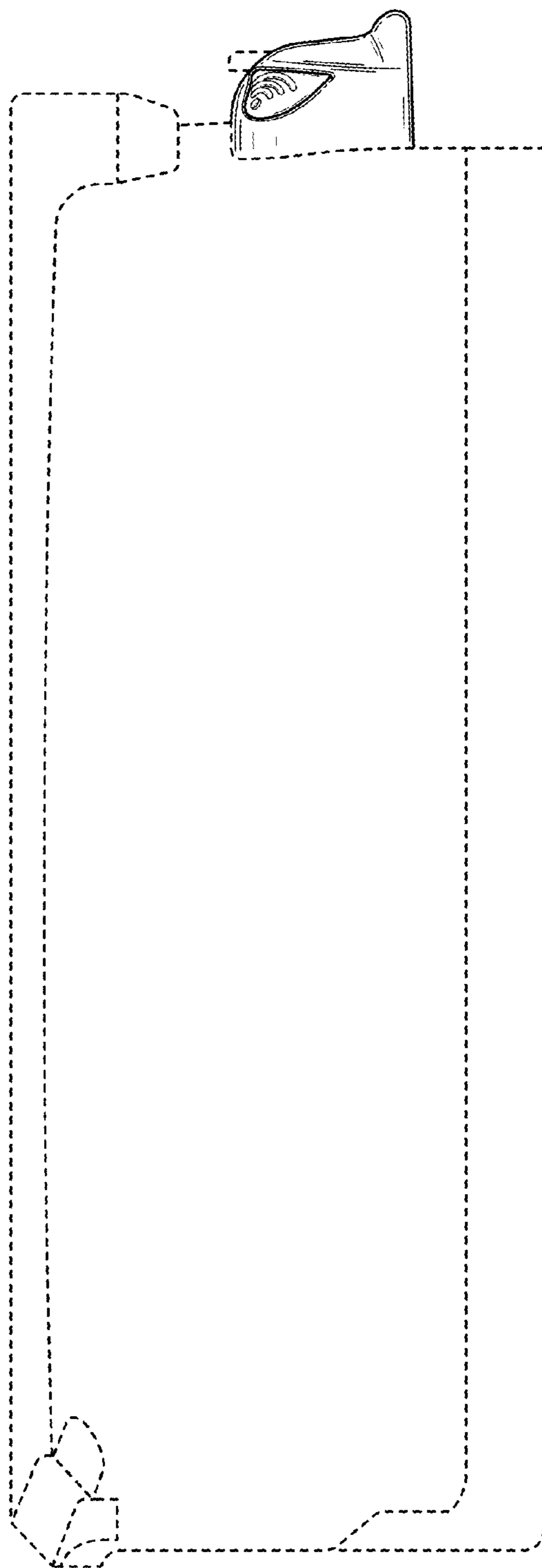

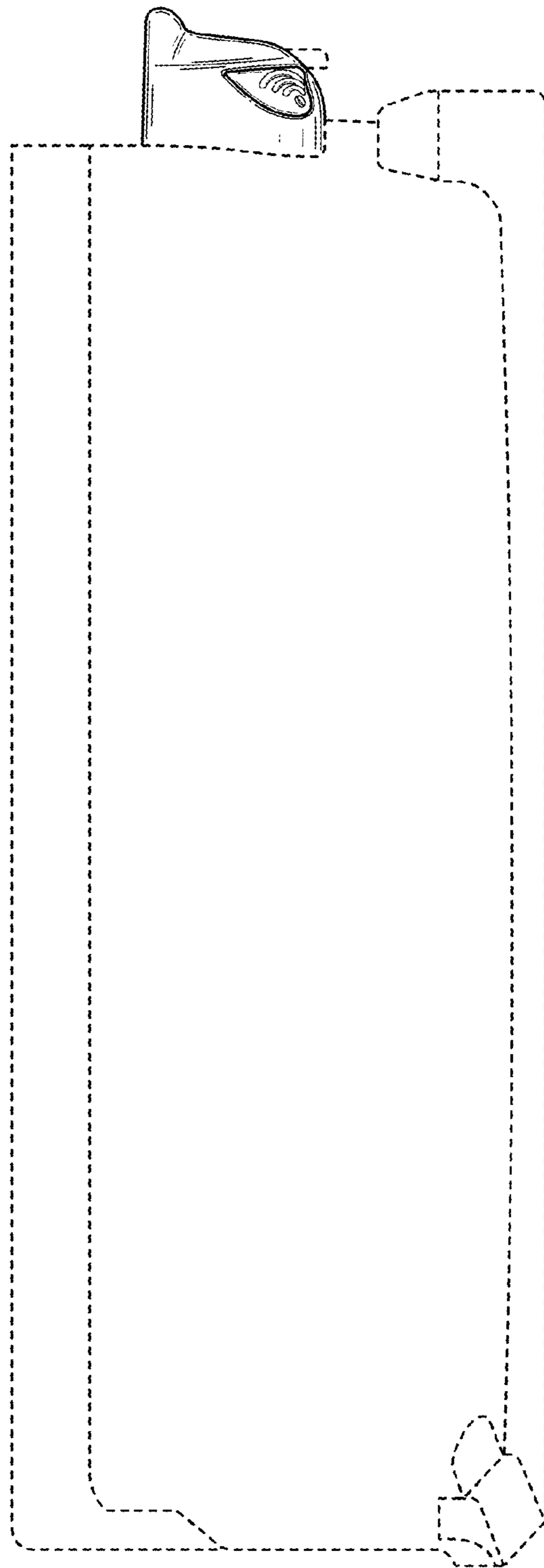

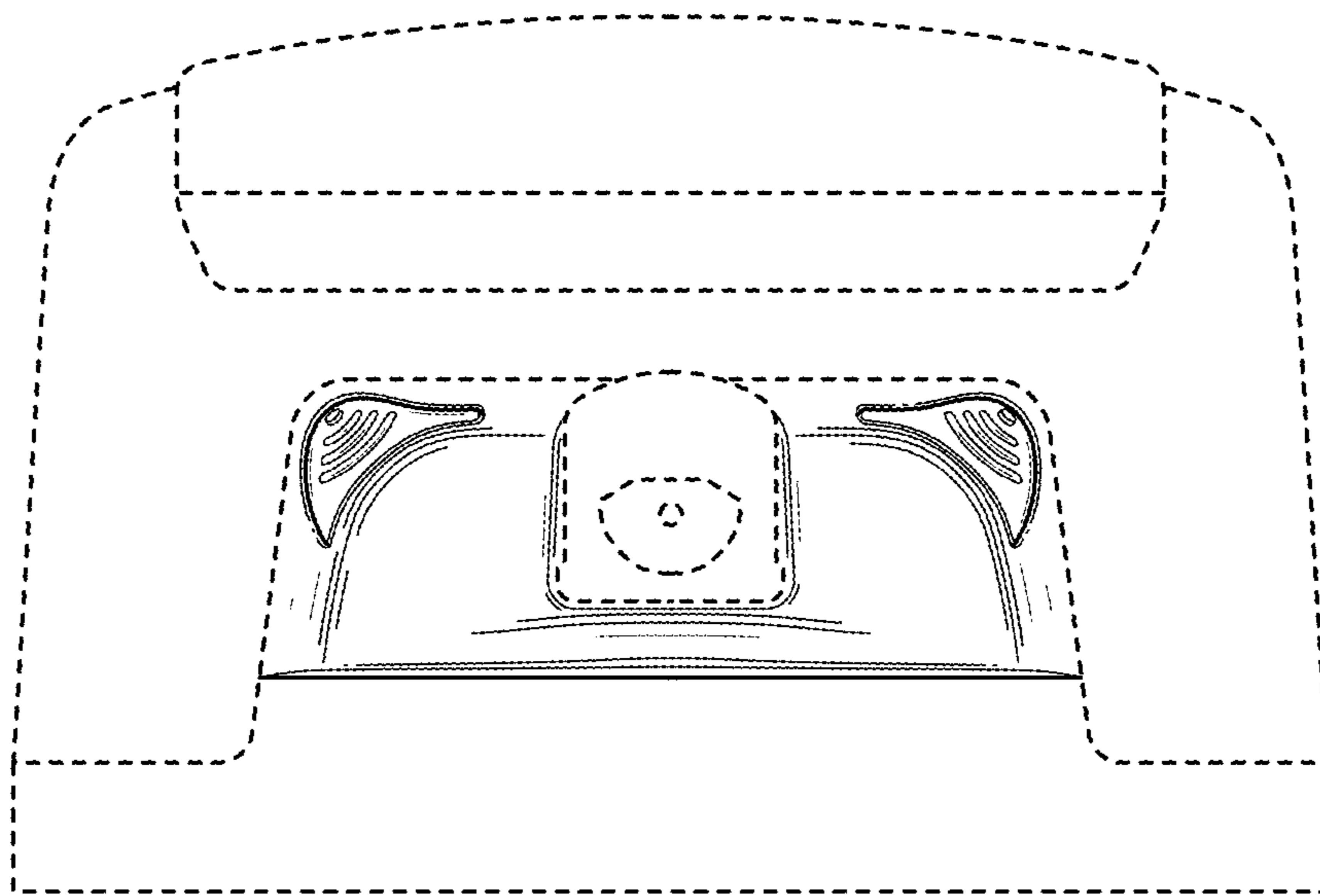
