**DESCRIPTION**

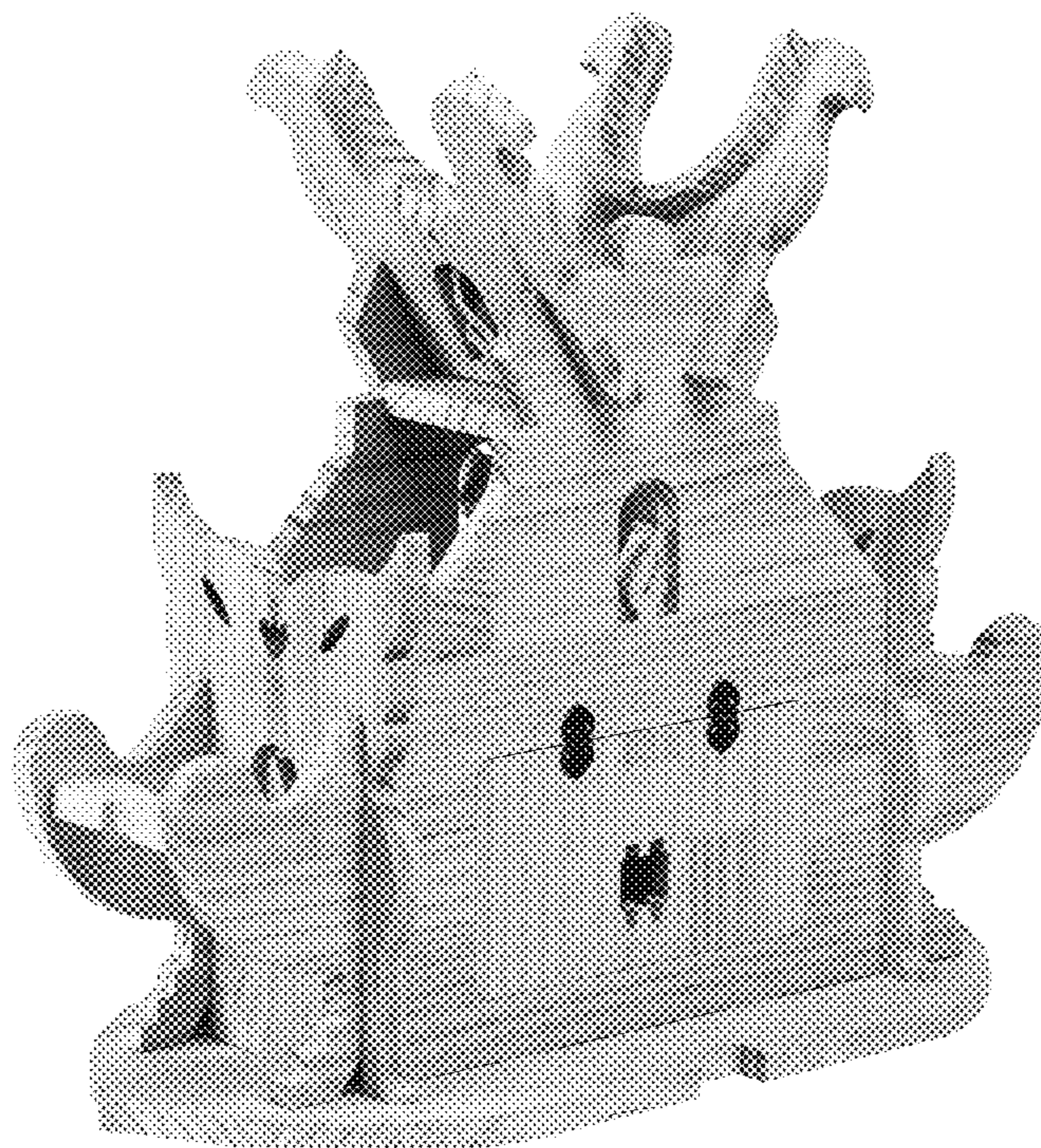

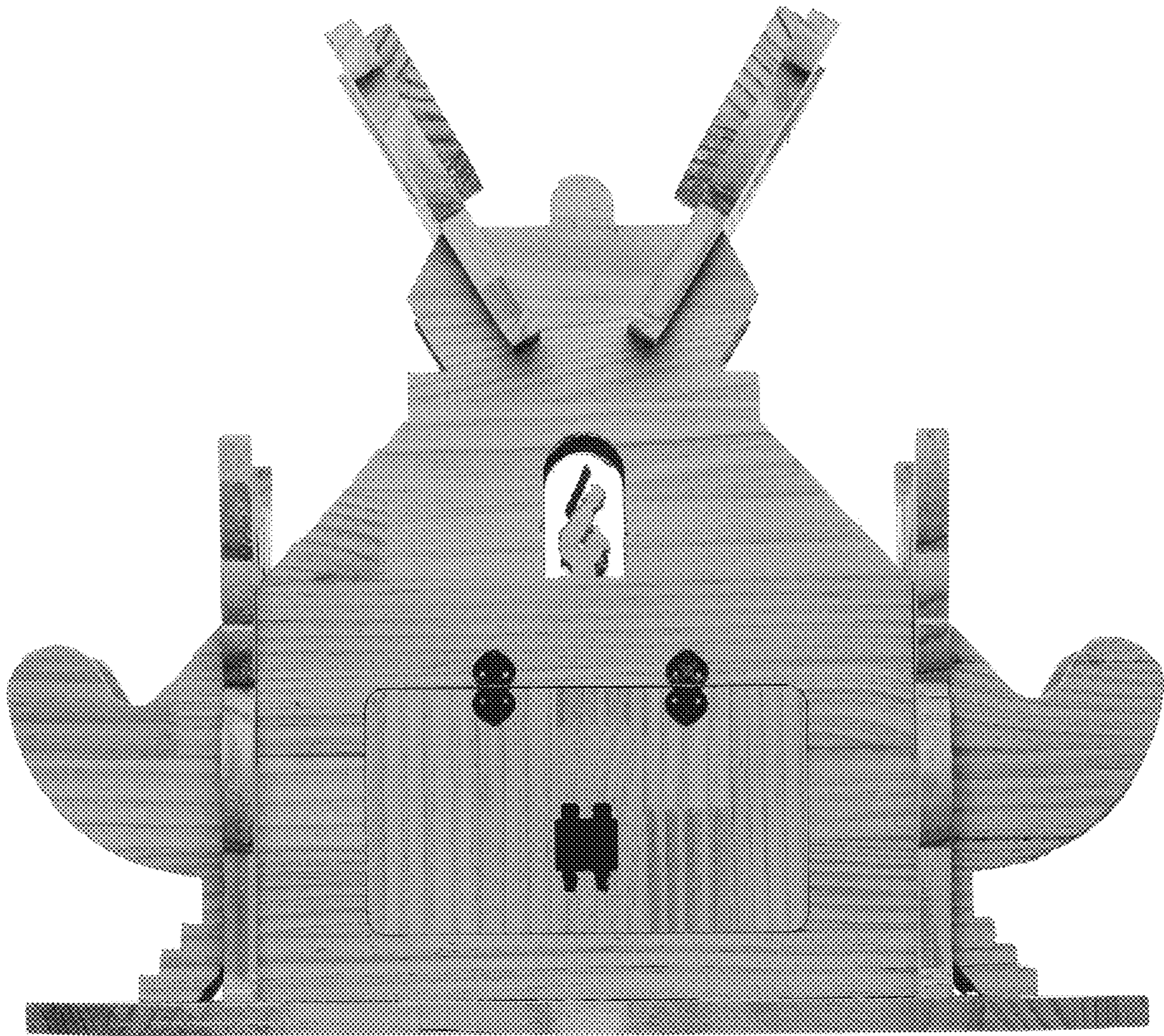

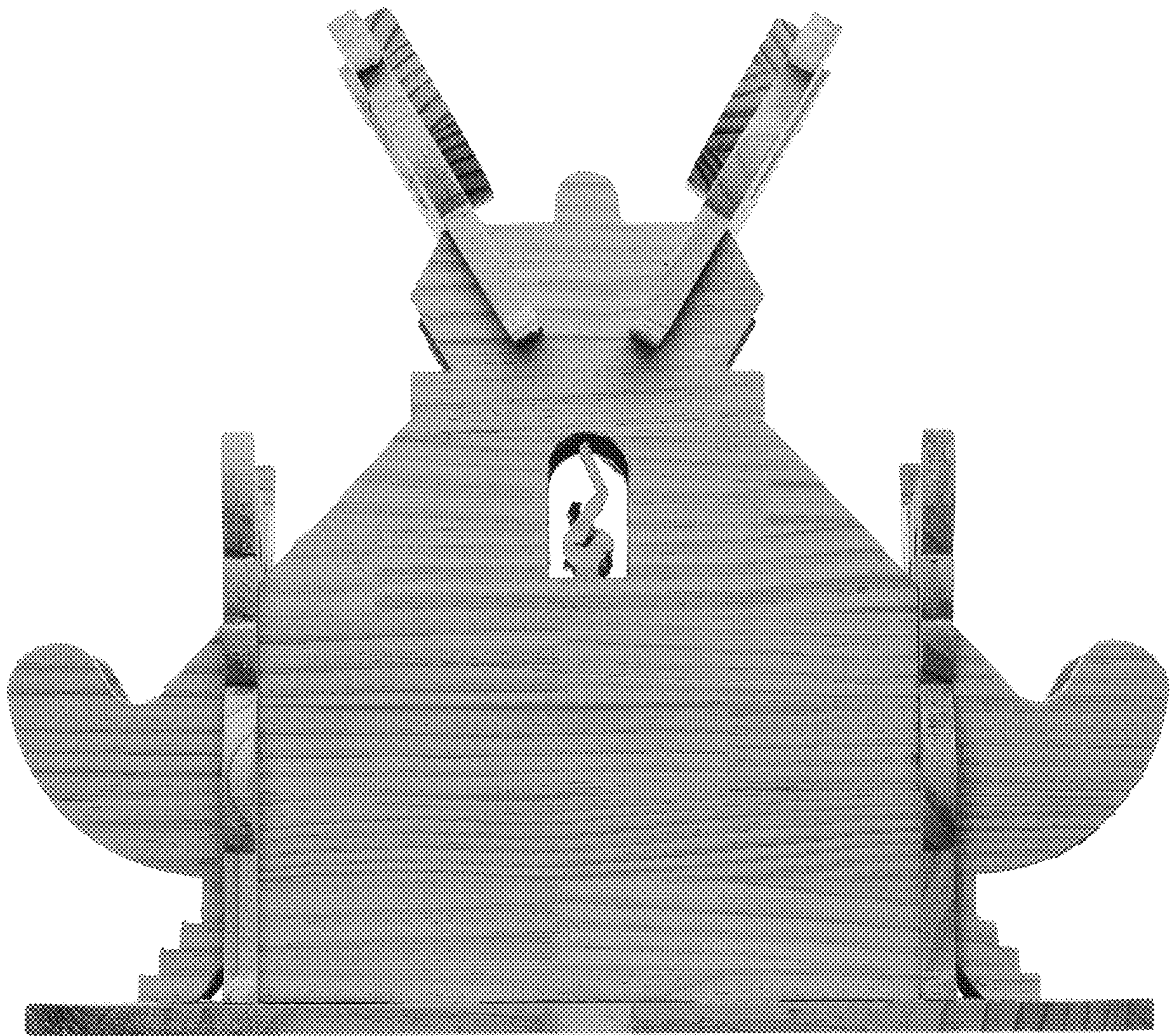

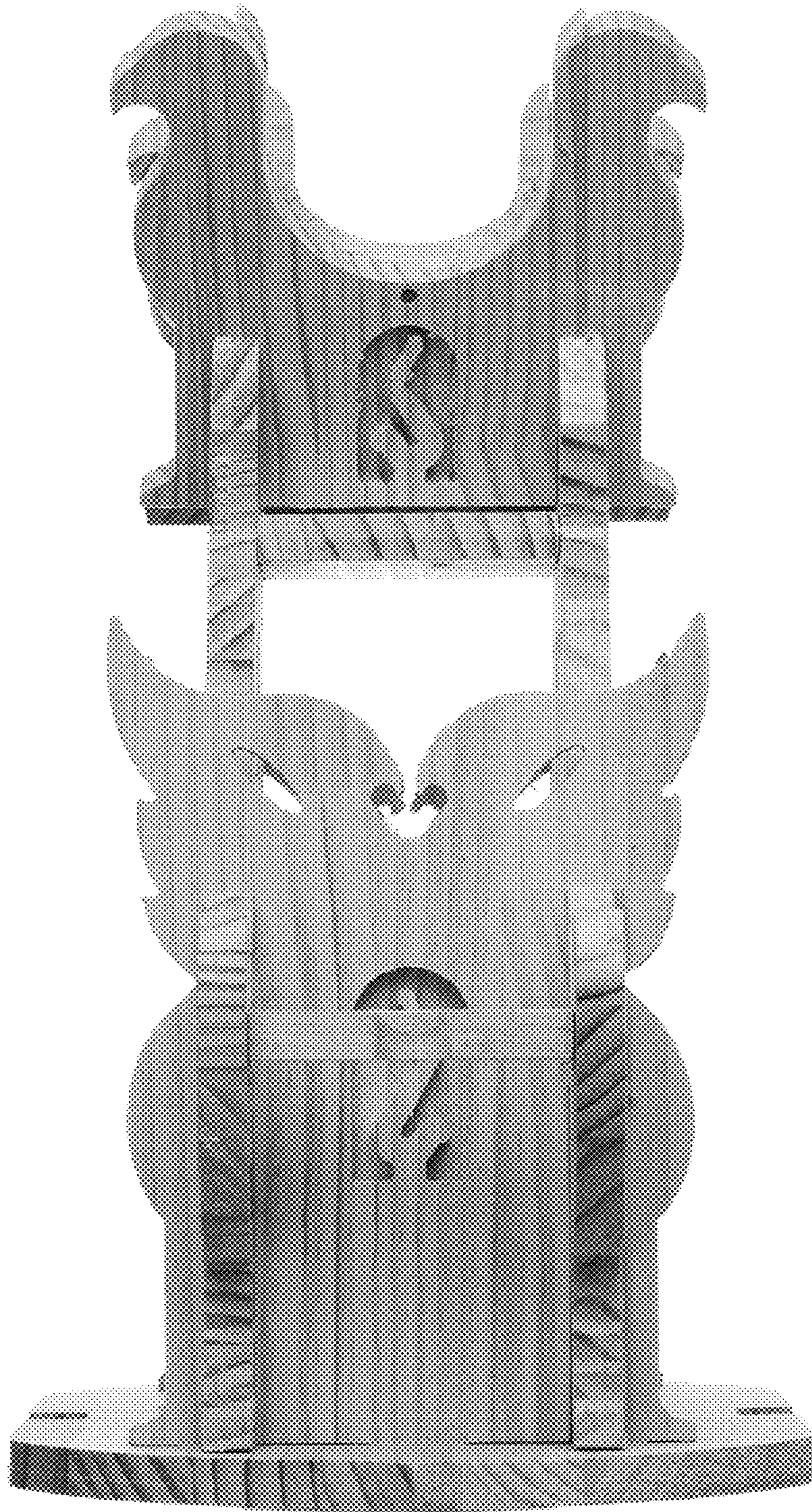

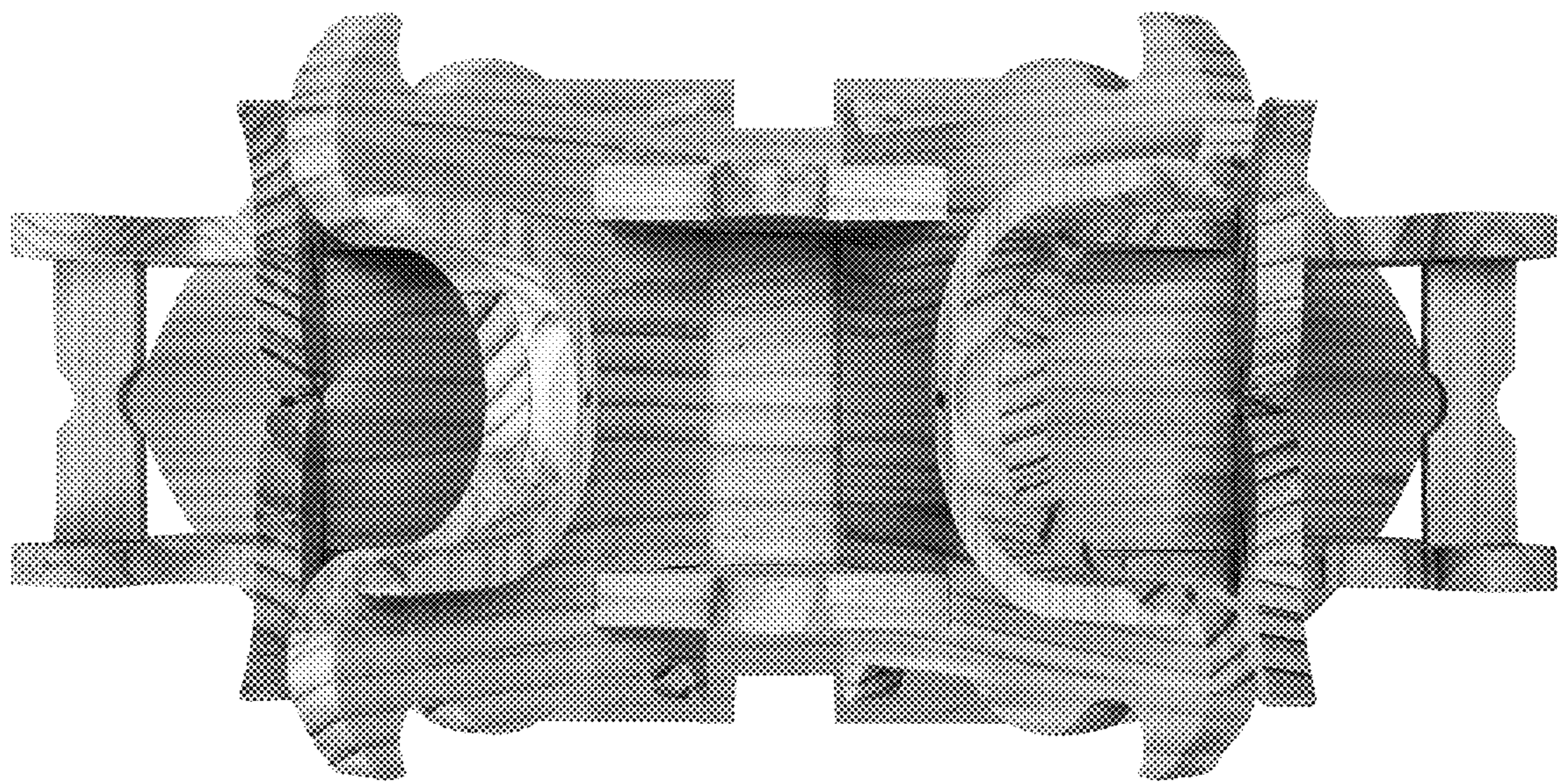
