DESCRIPTION

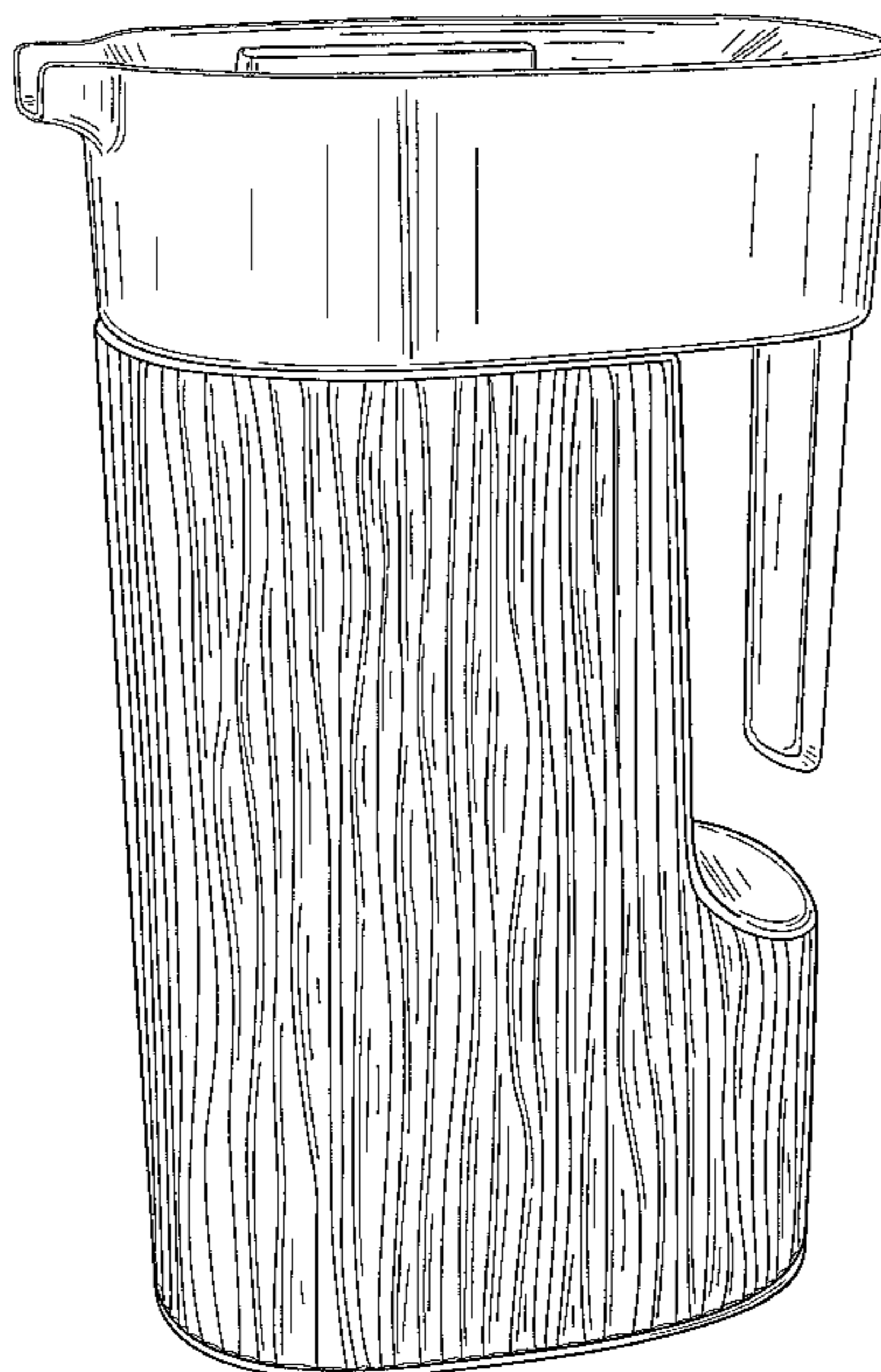
FIG. 1 is a perspective view of the pitcher, showing our new, original and ornamental design;

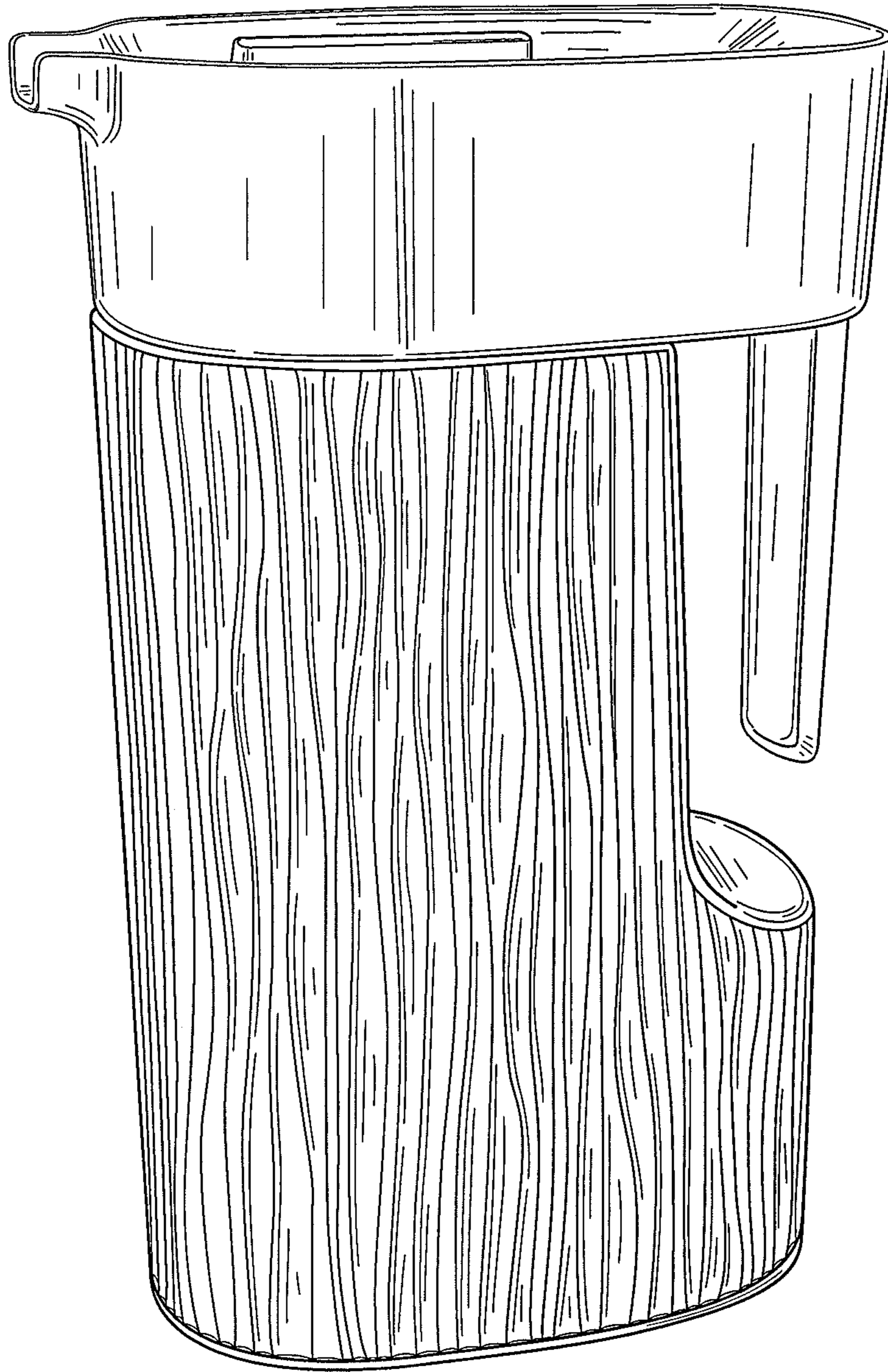

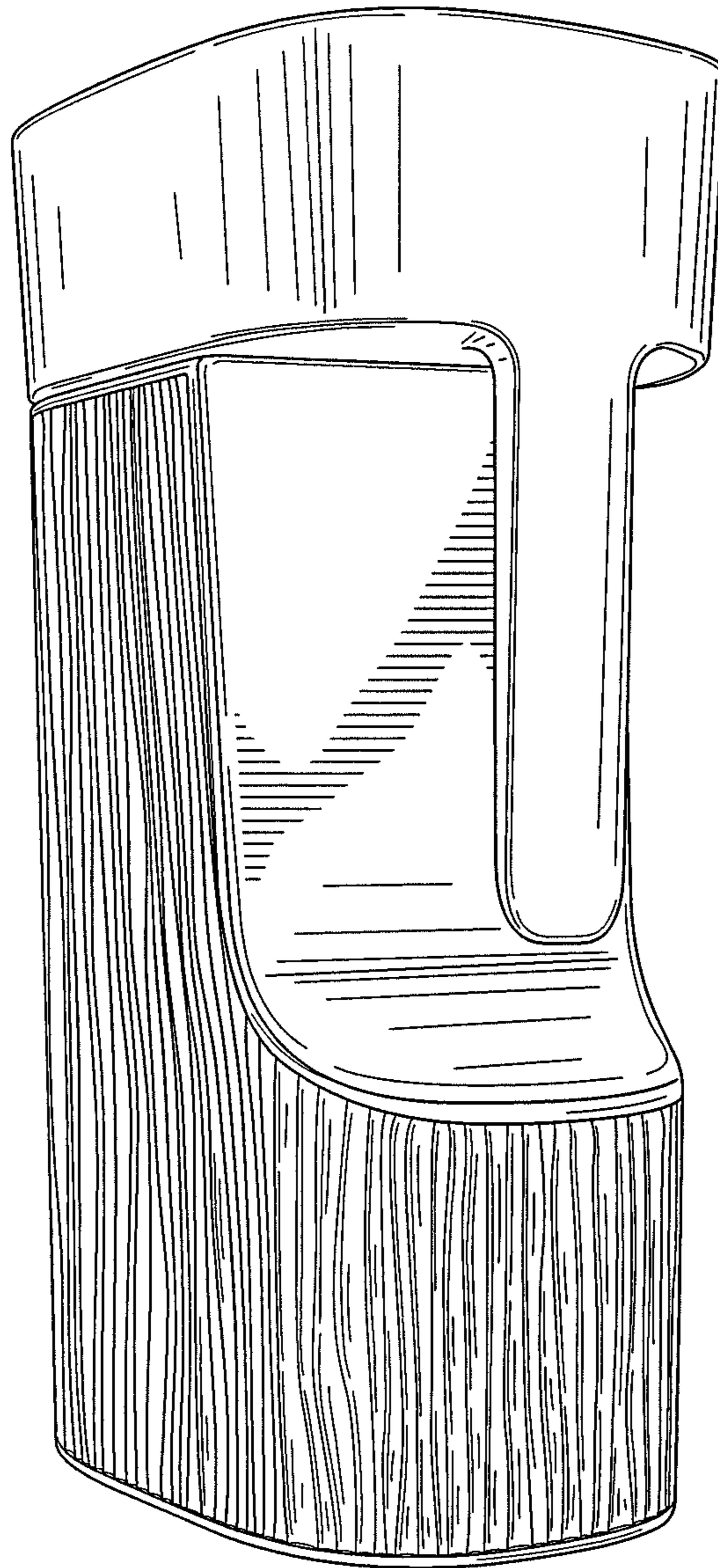

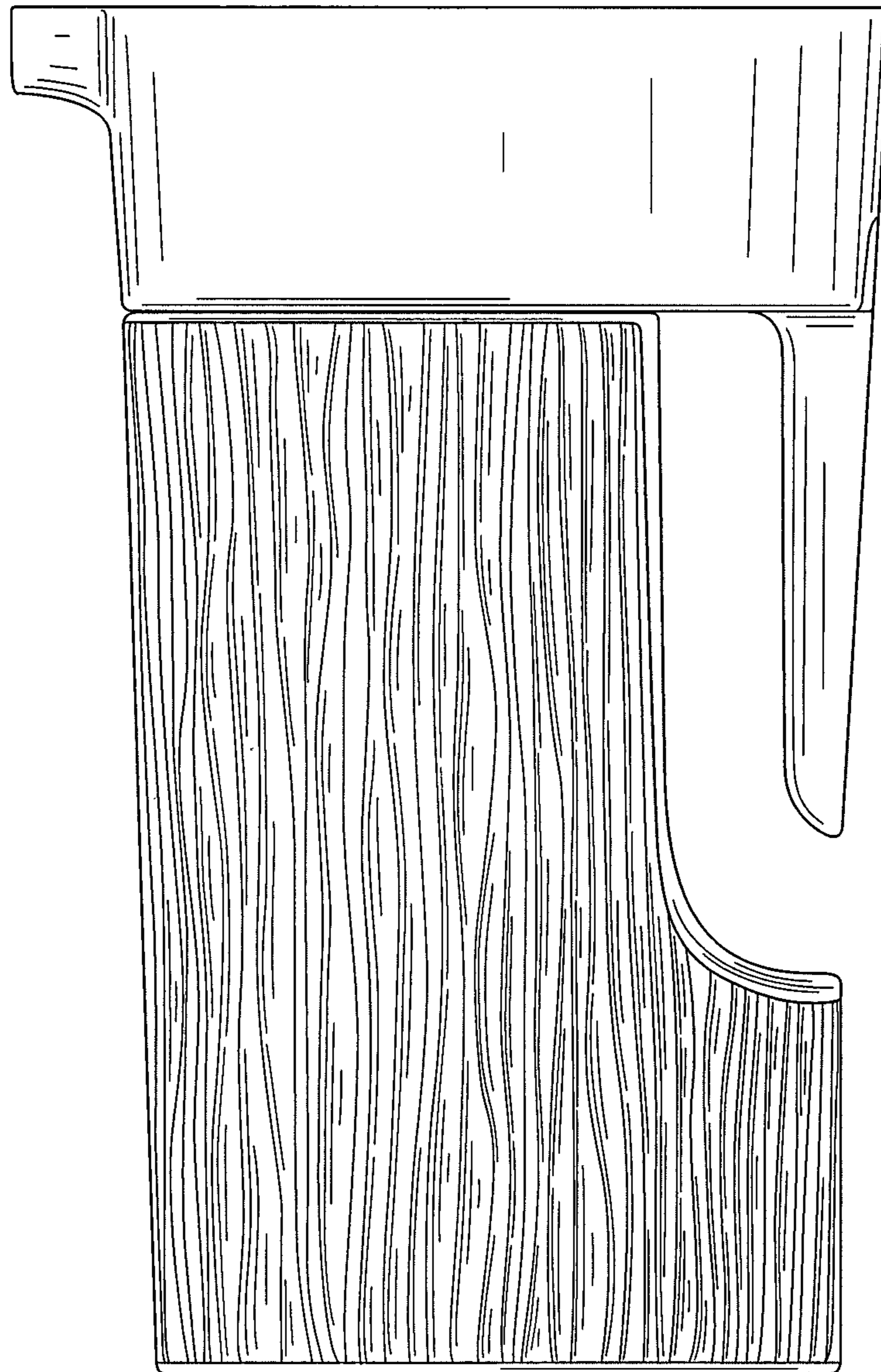

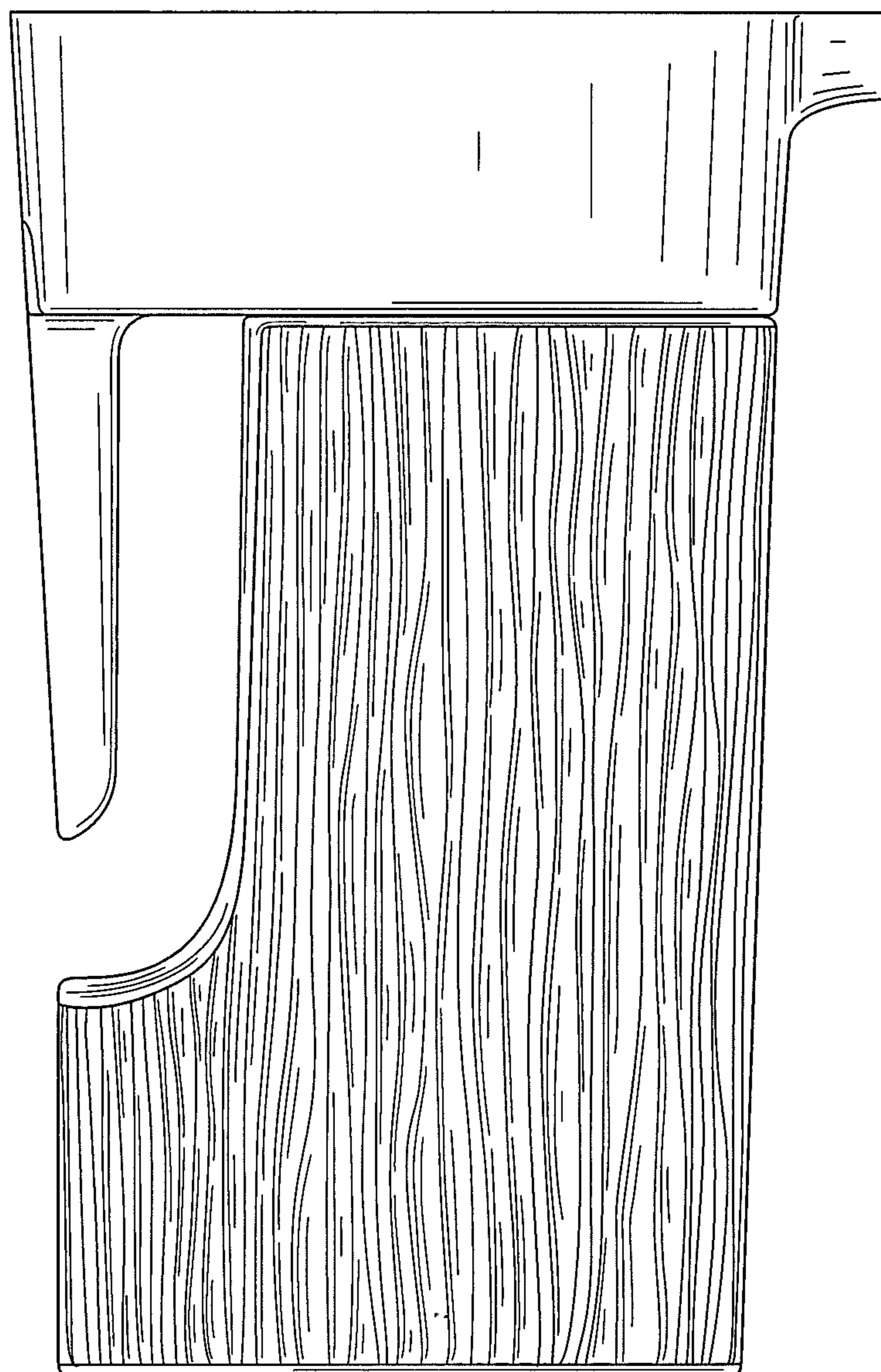

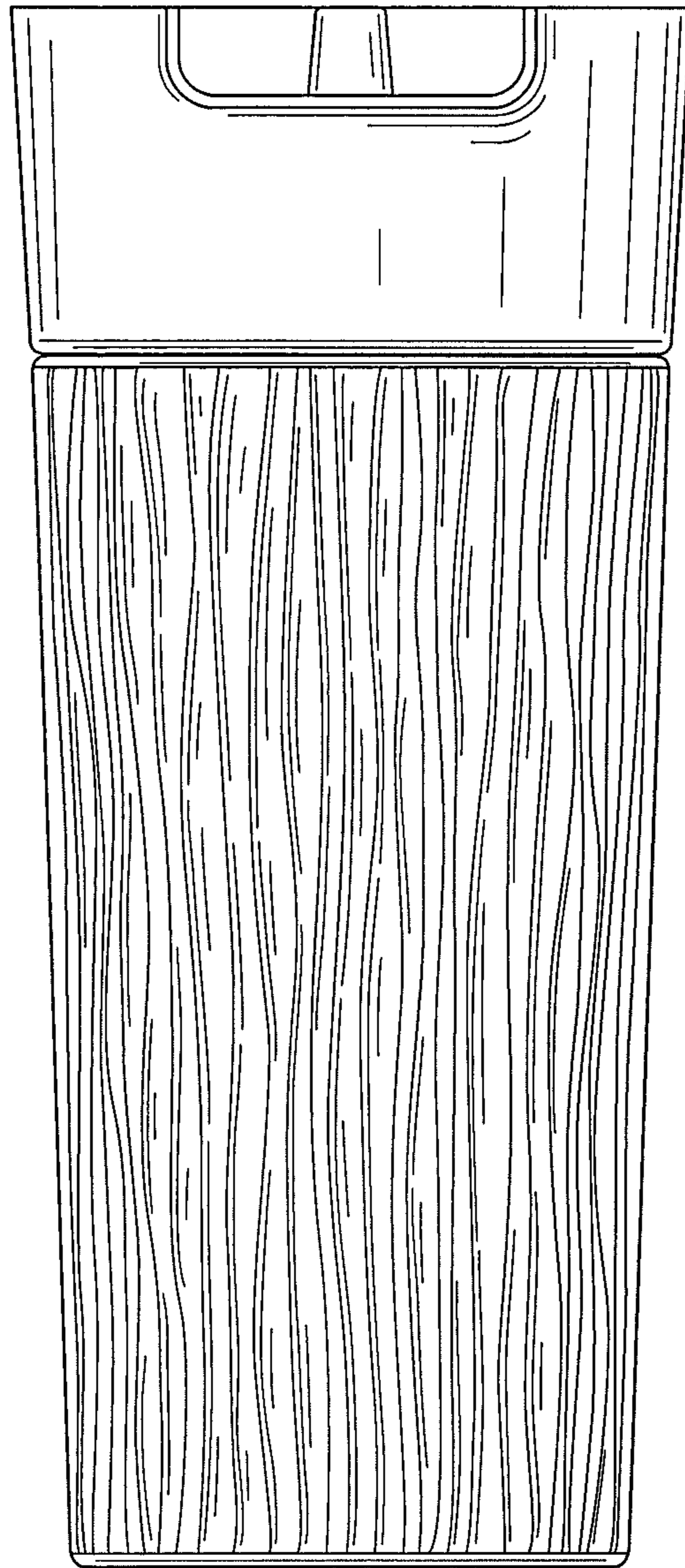

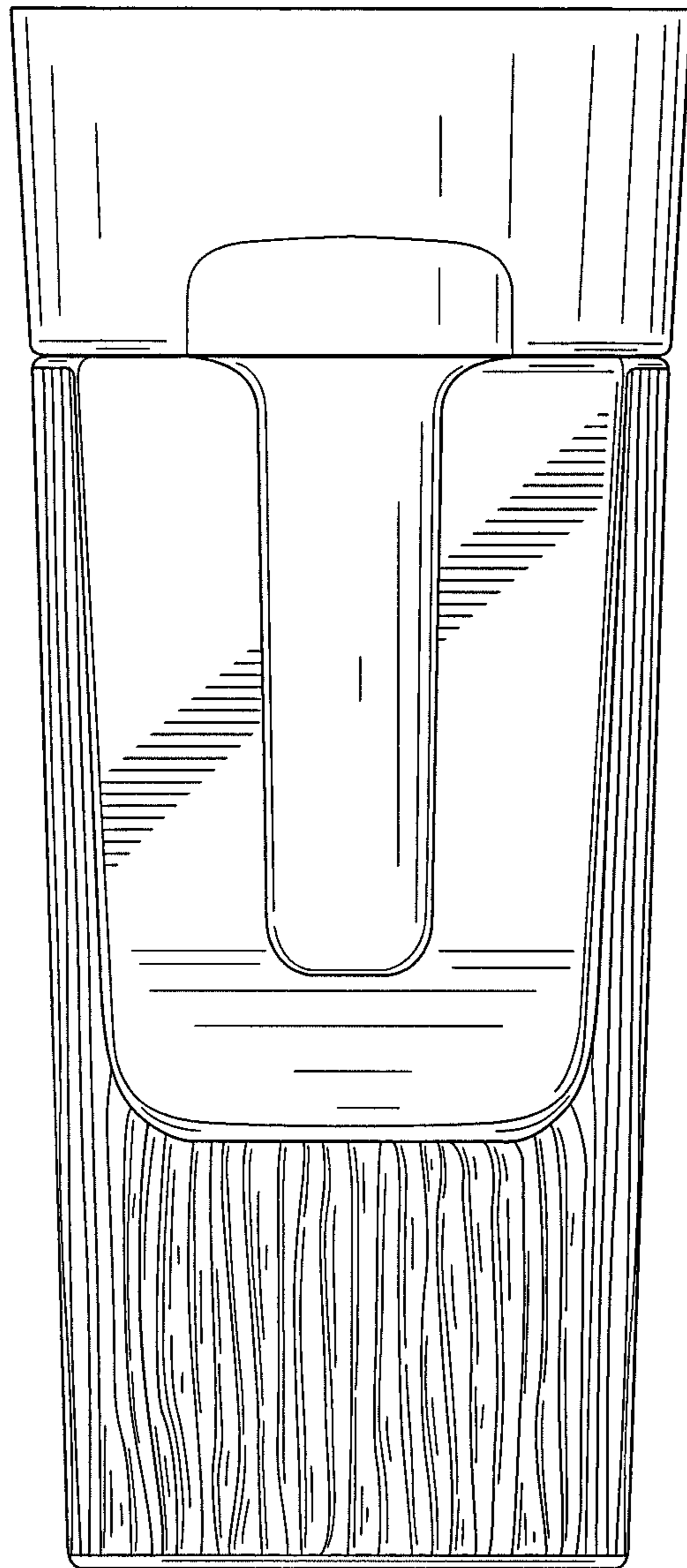

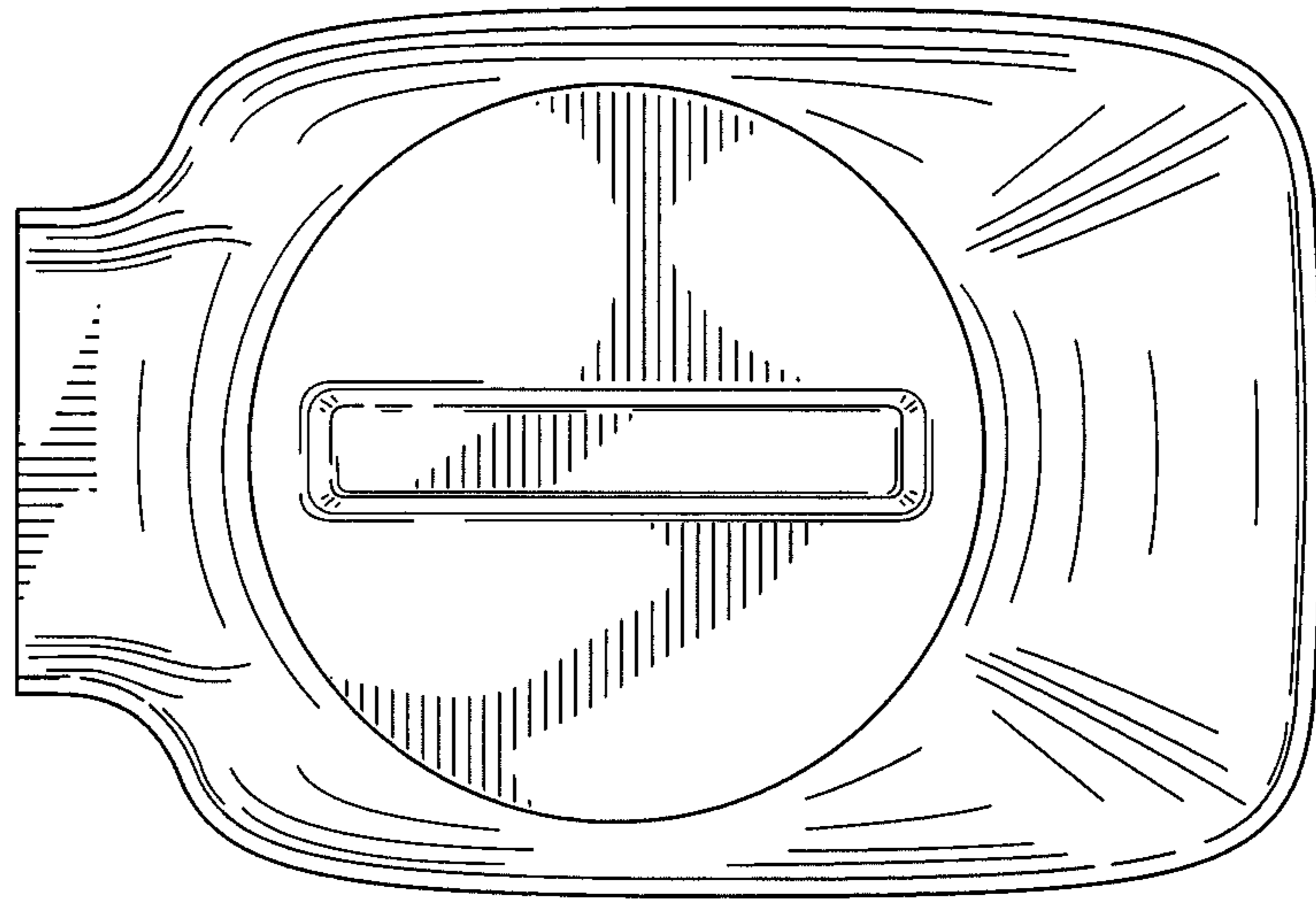

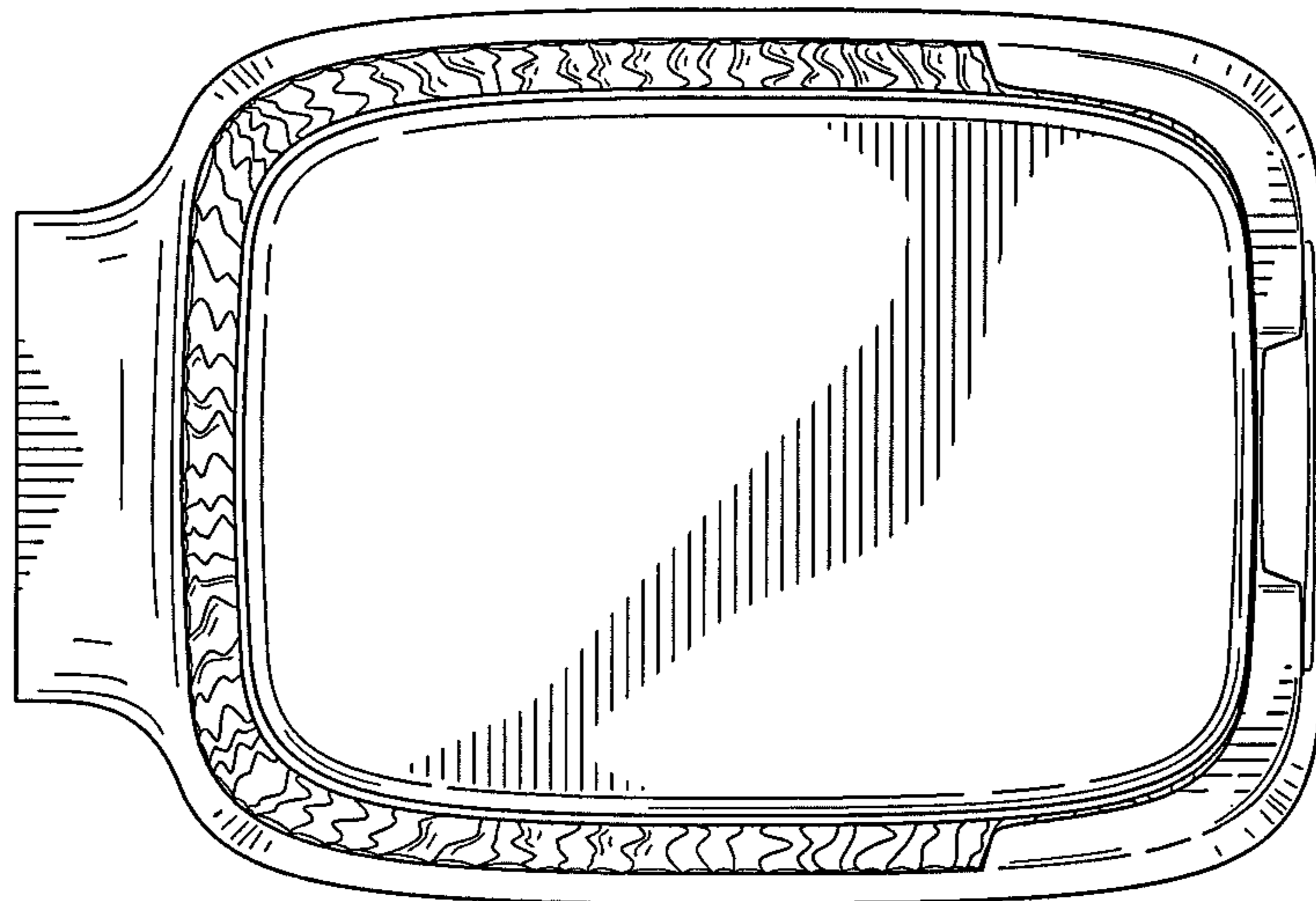
