FIG. 11 is a bottom plan view of the packaging container of FIG. 8.

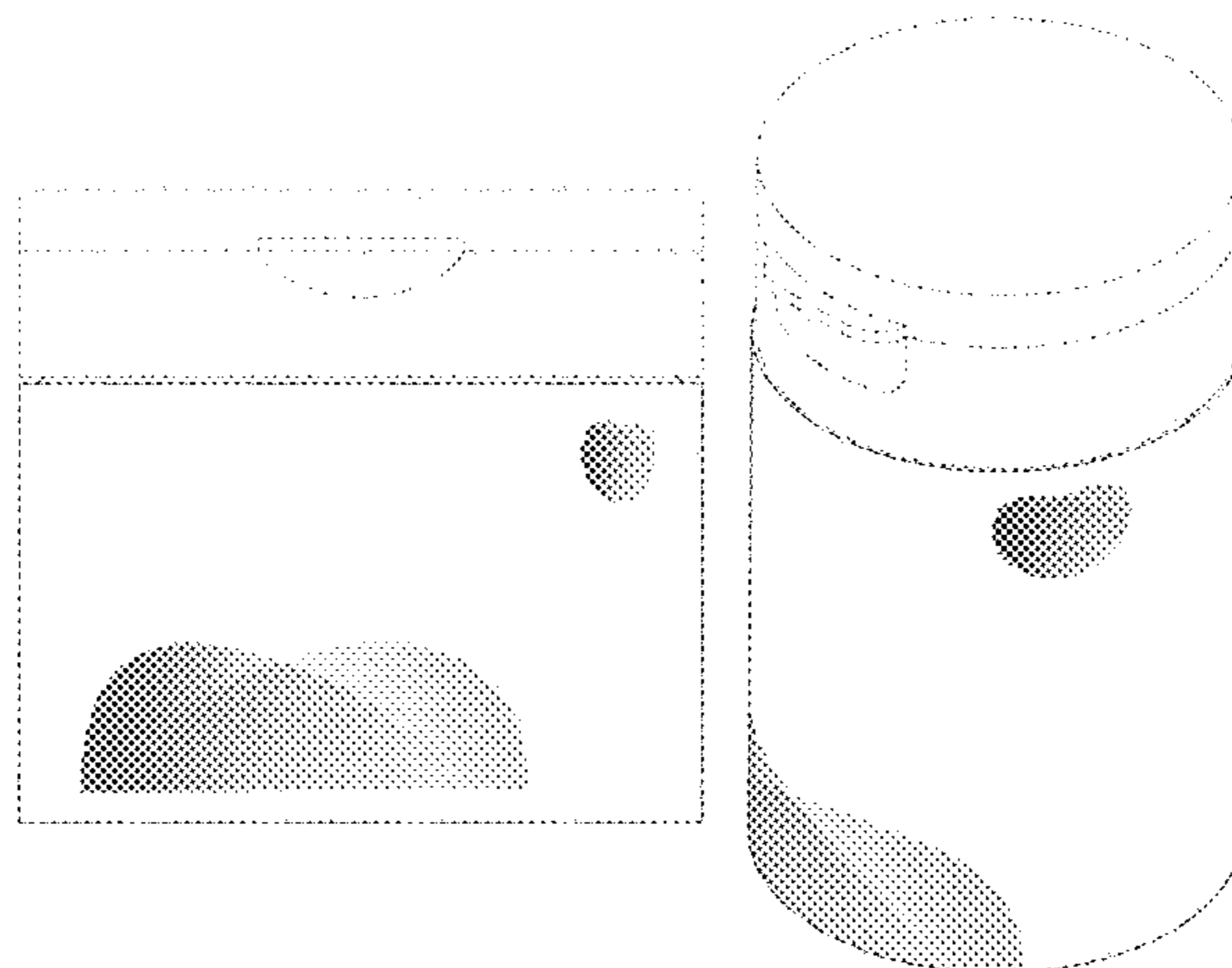
FIG. 12 is a left side elevational view of the packaging container of FIG. 8.

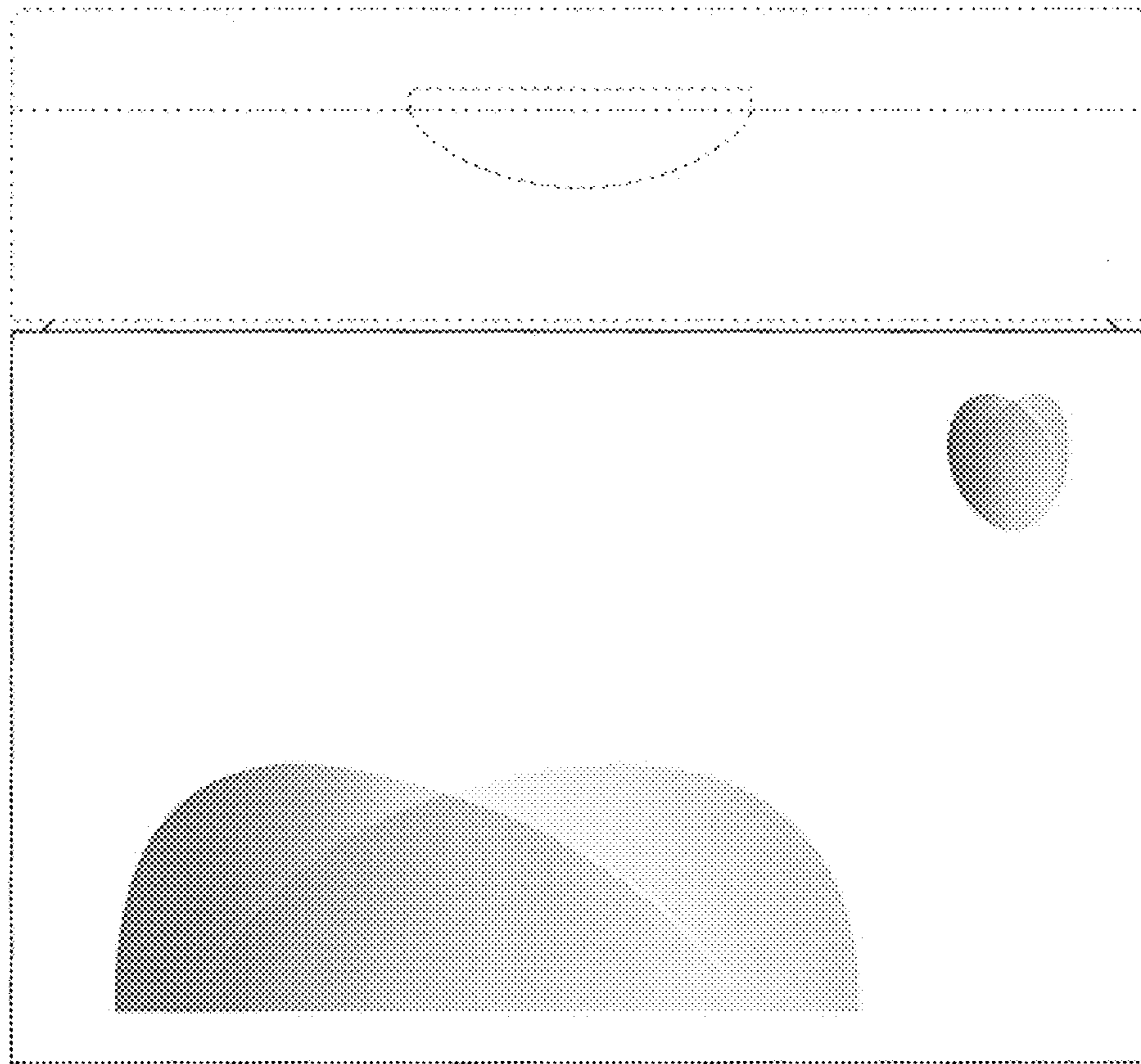

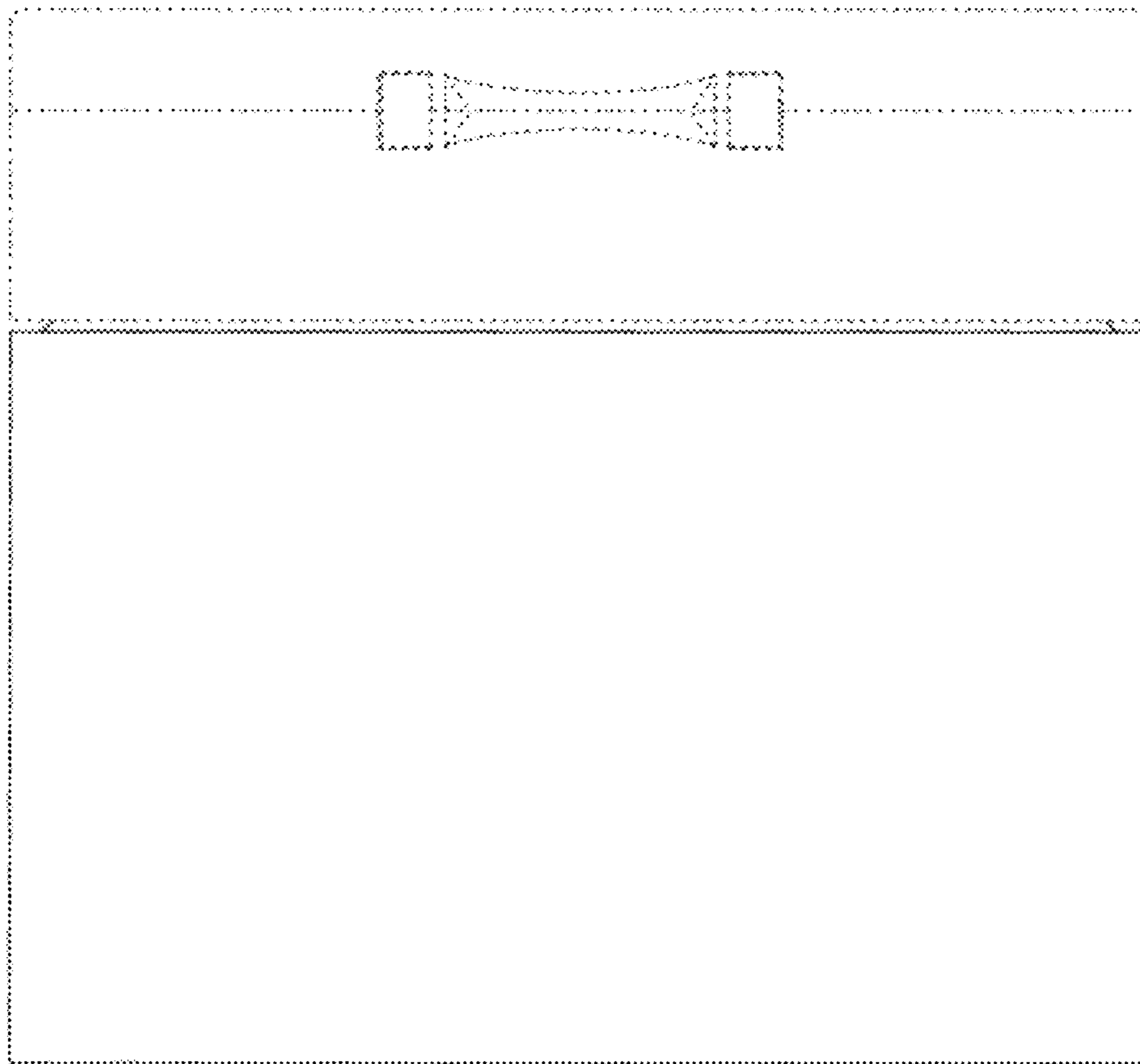

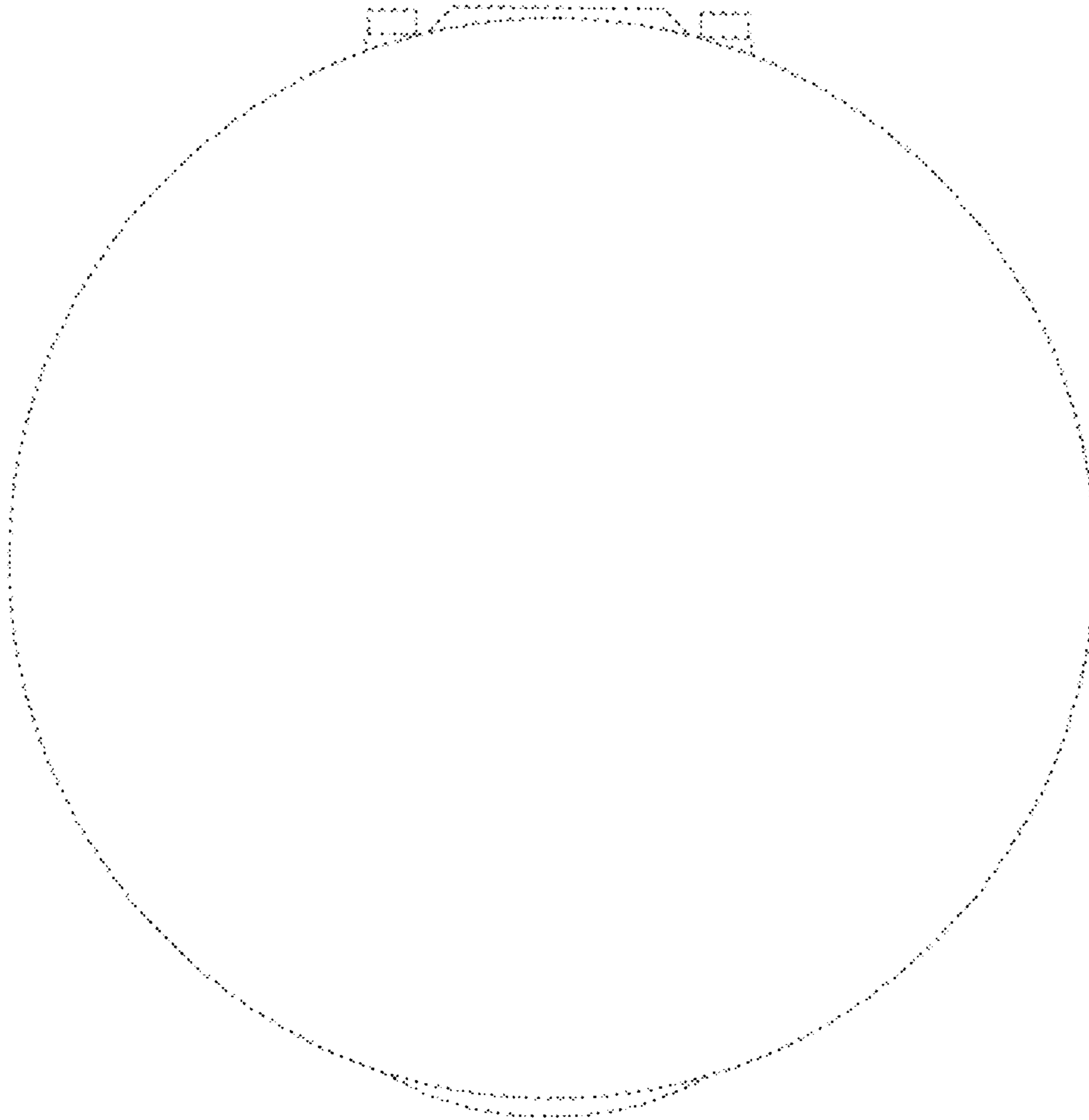

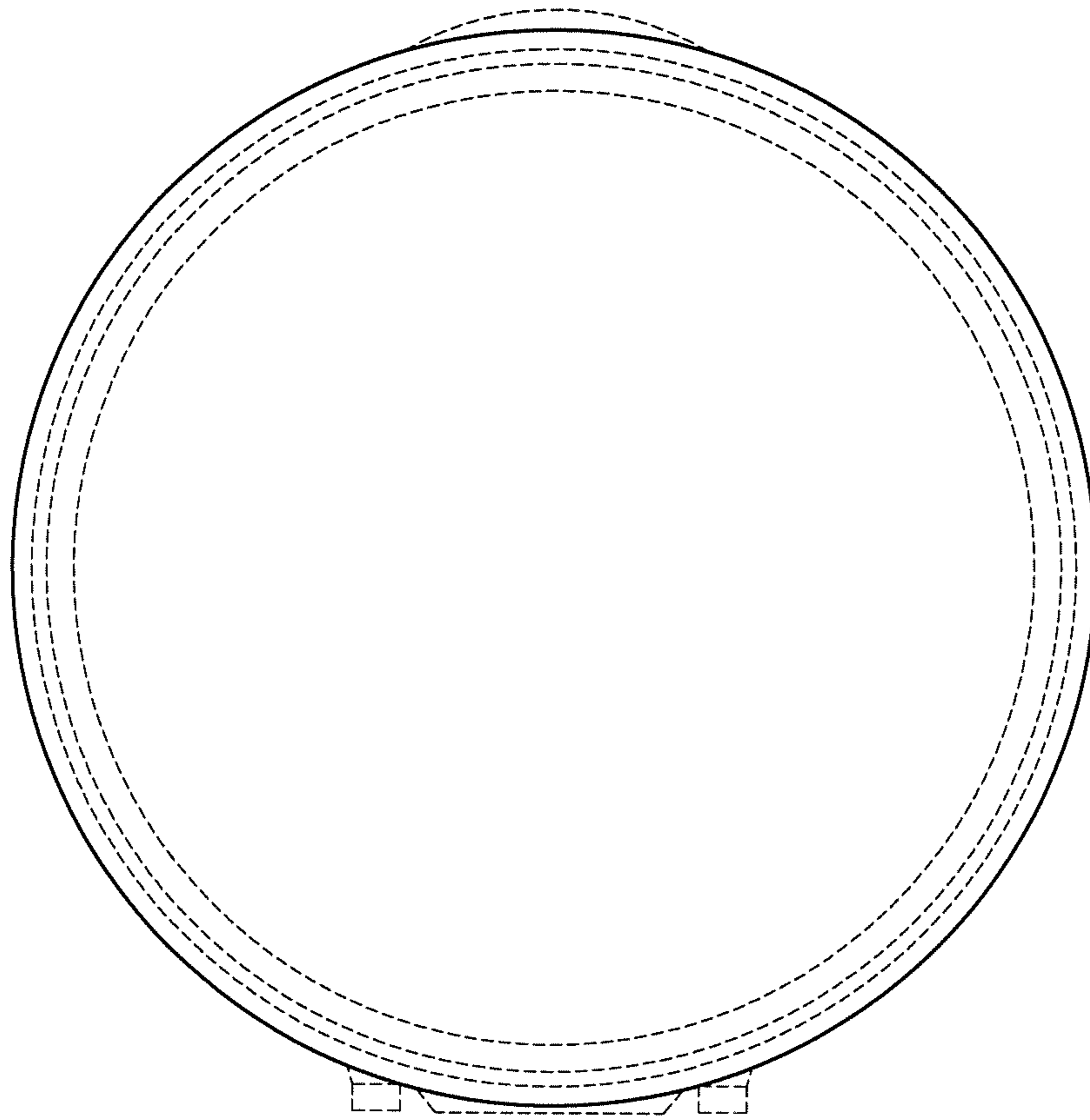

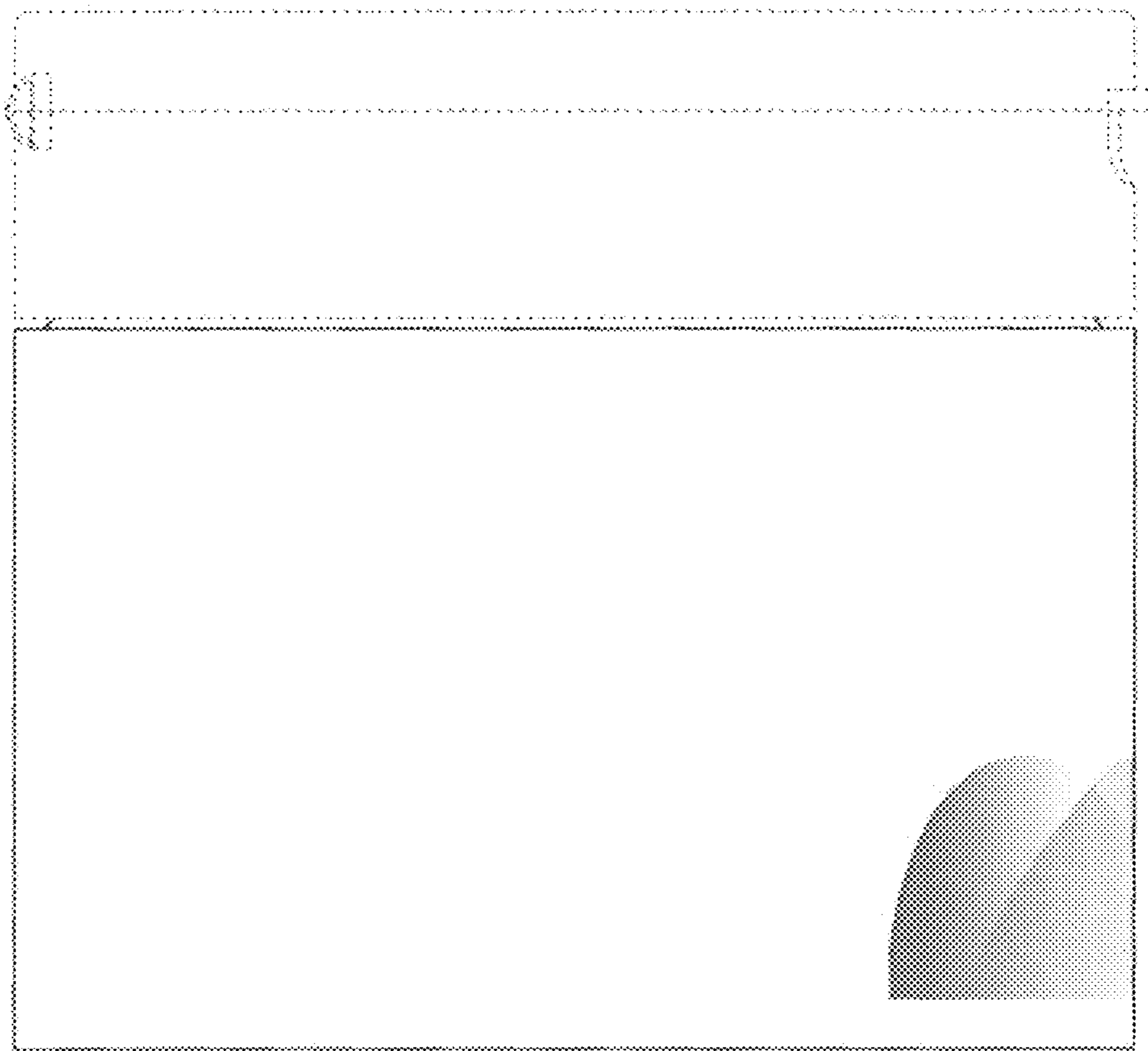

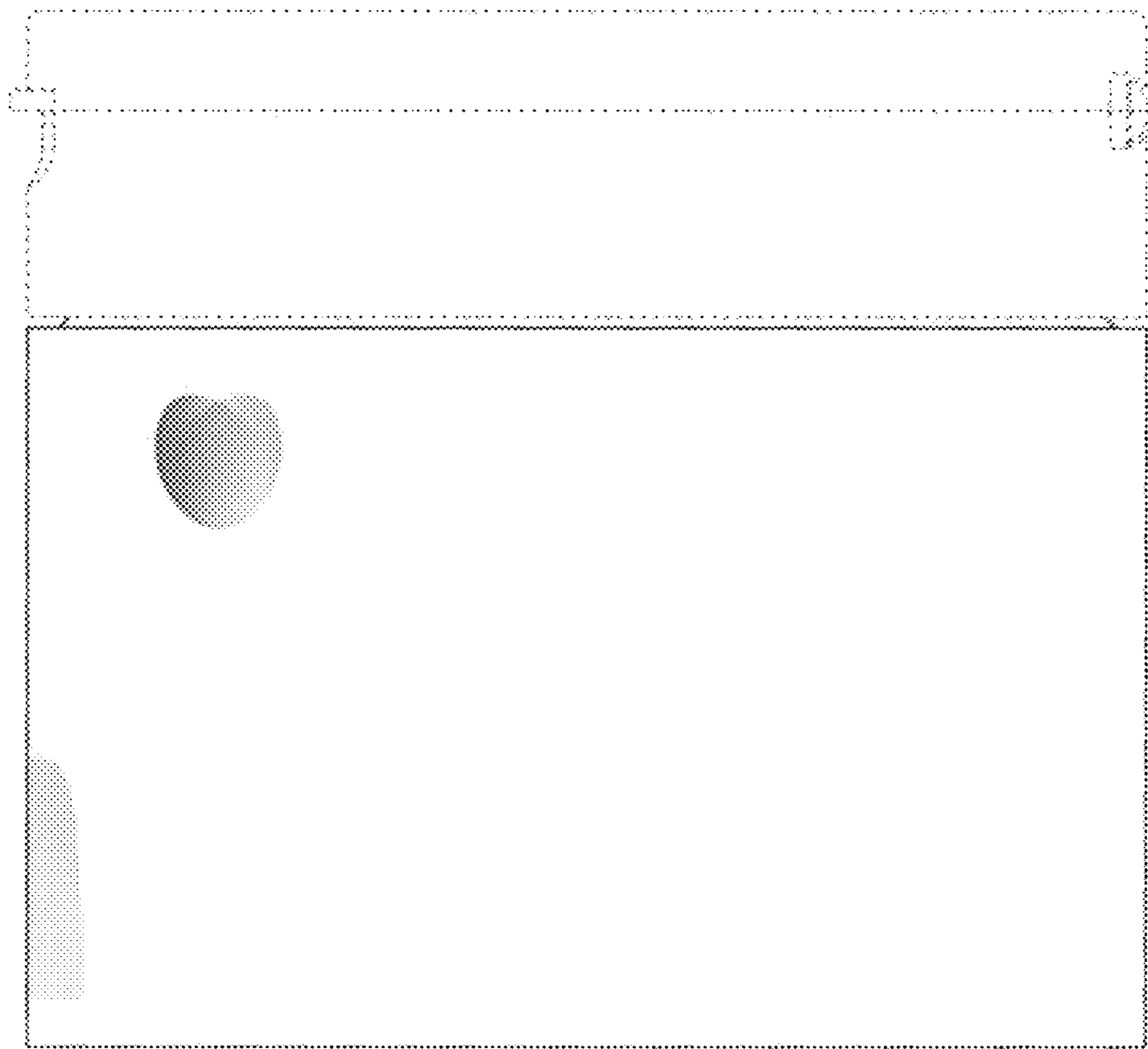

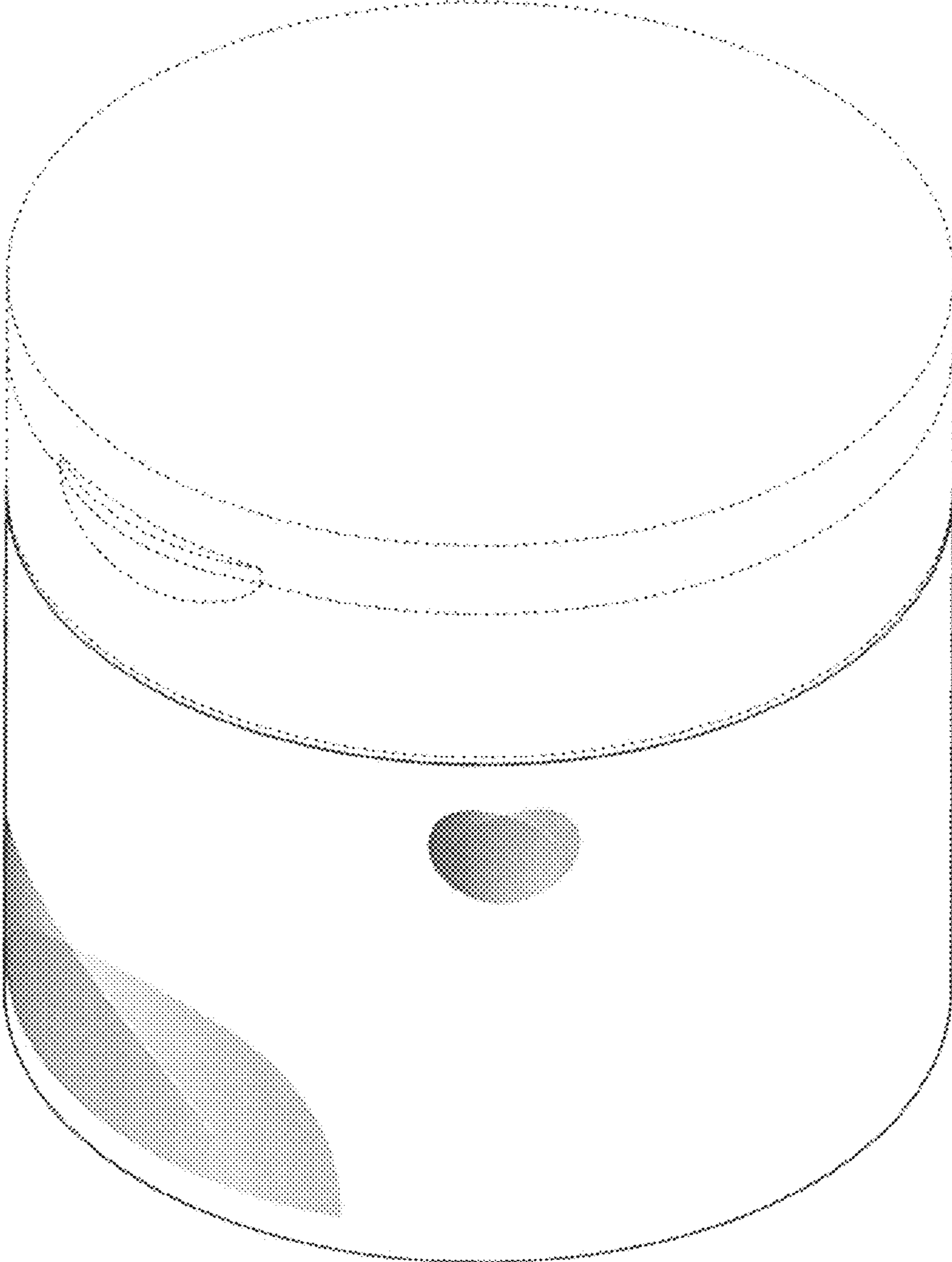

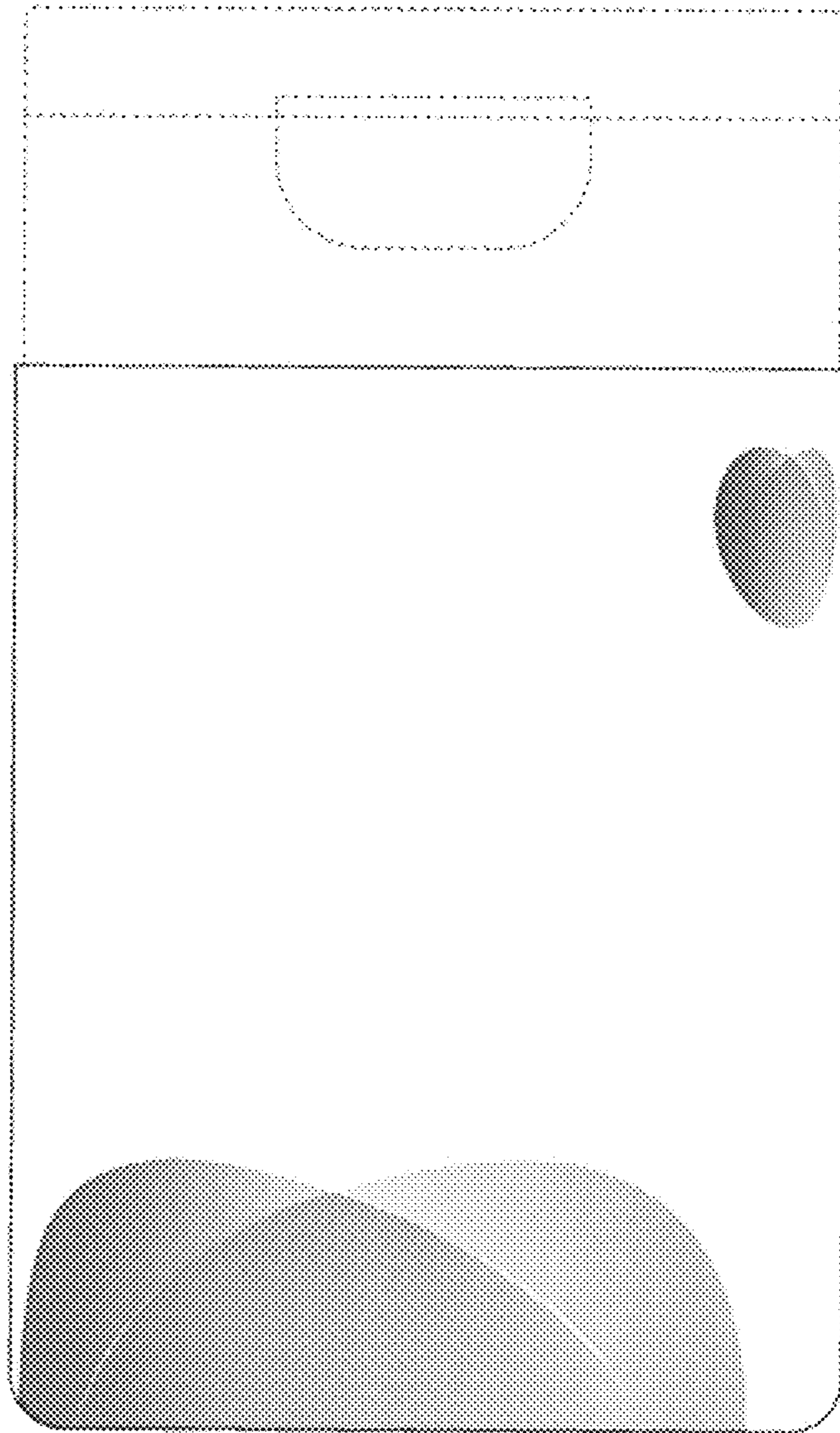

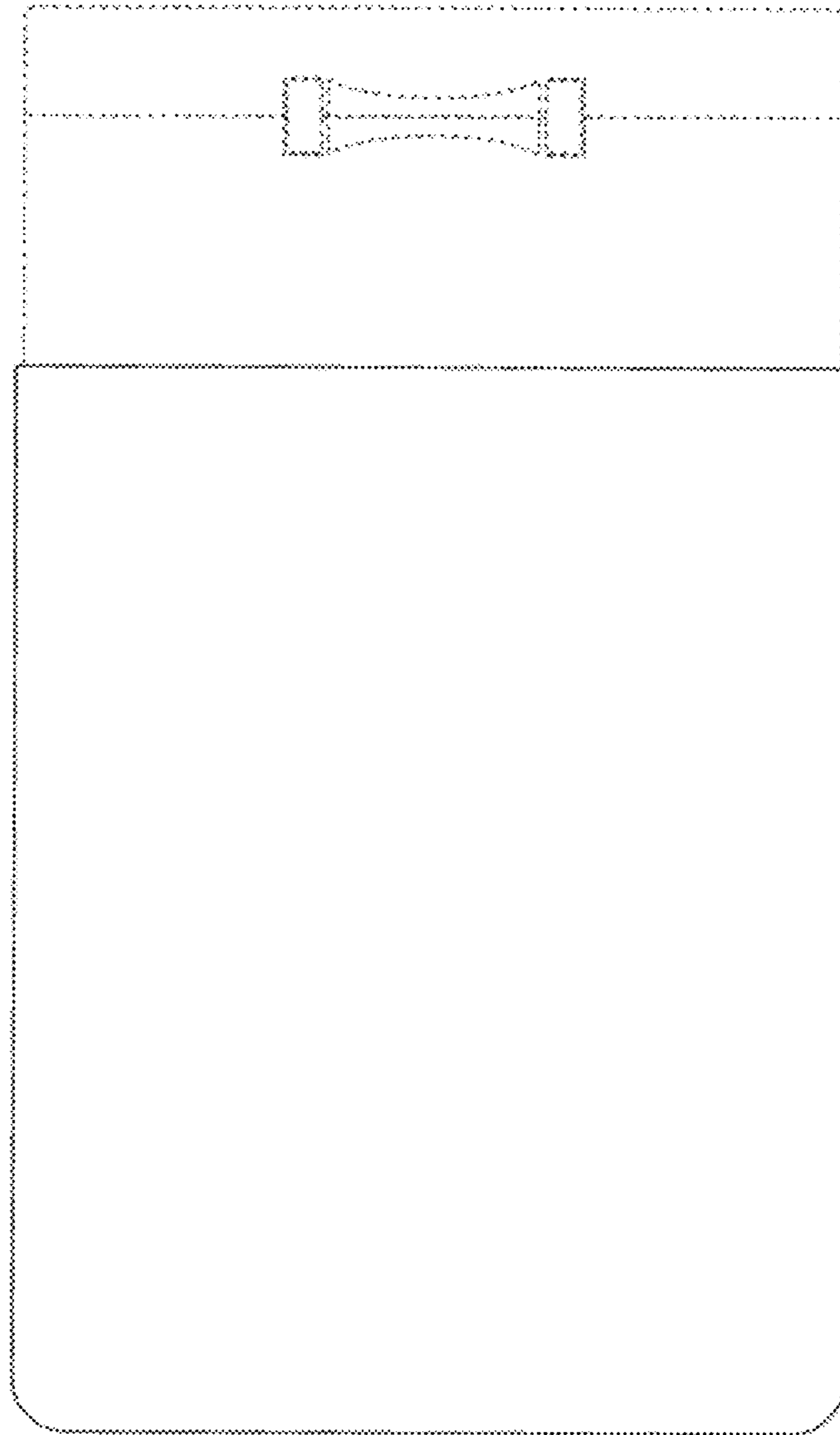

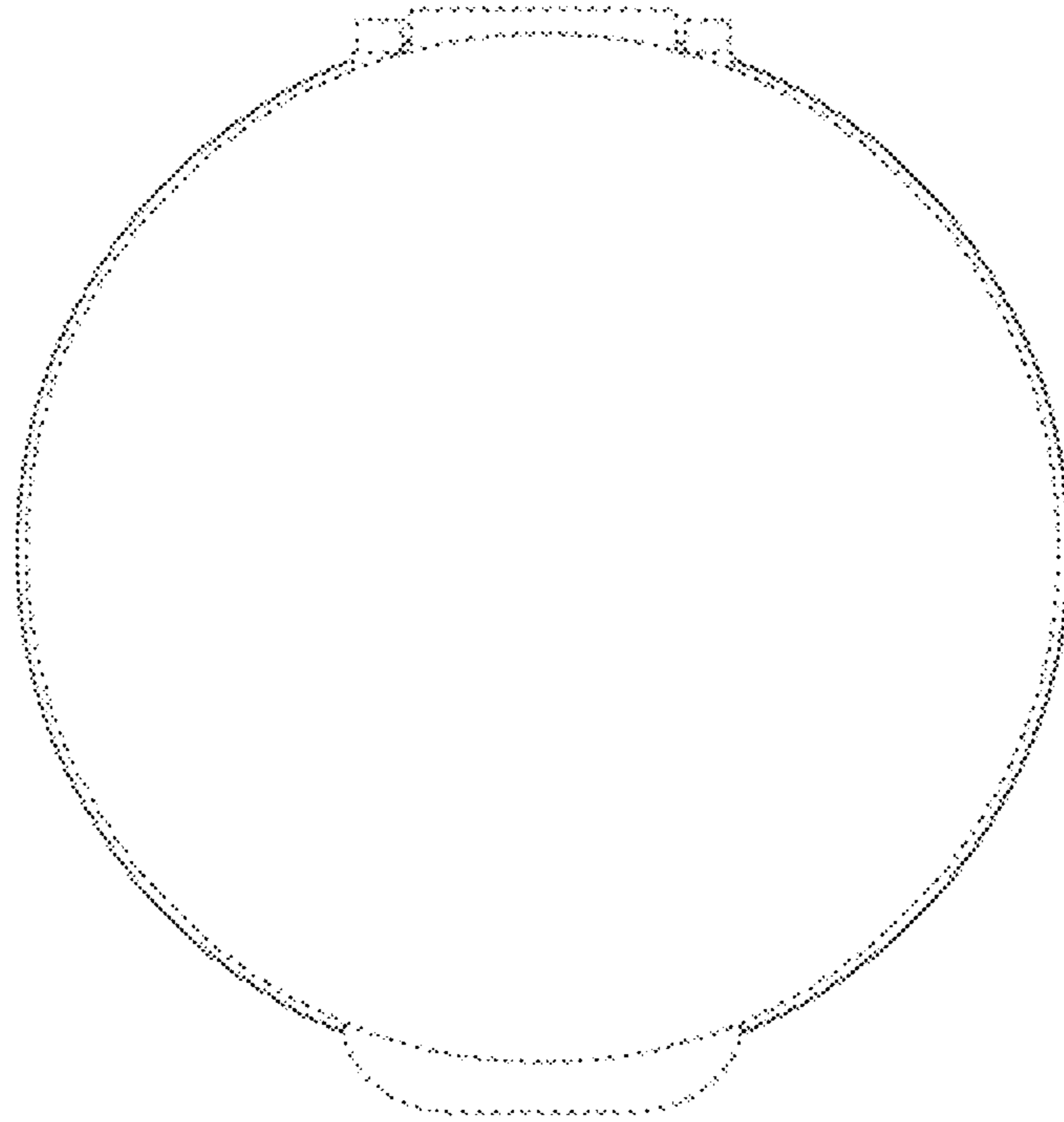

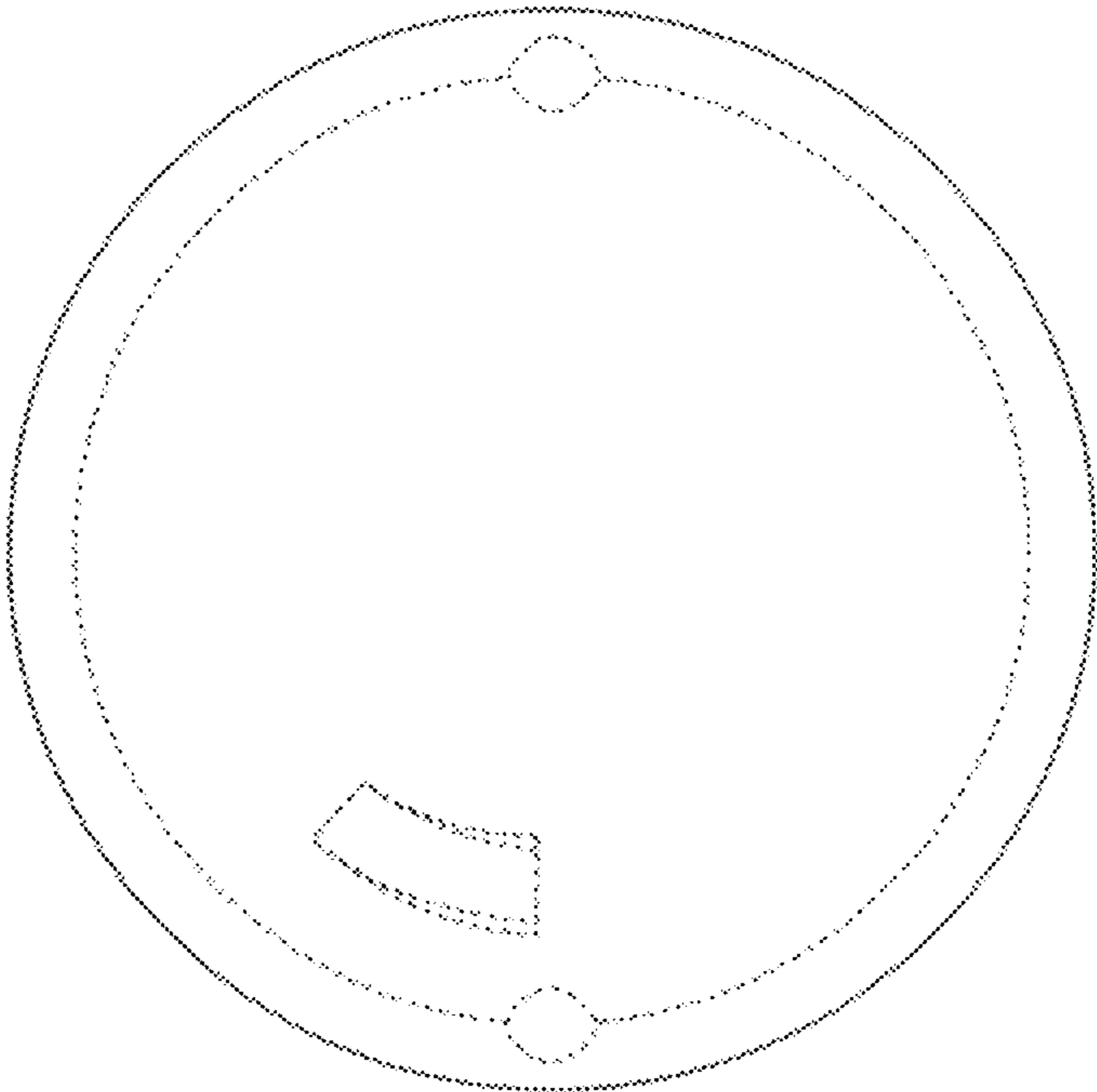

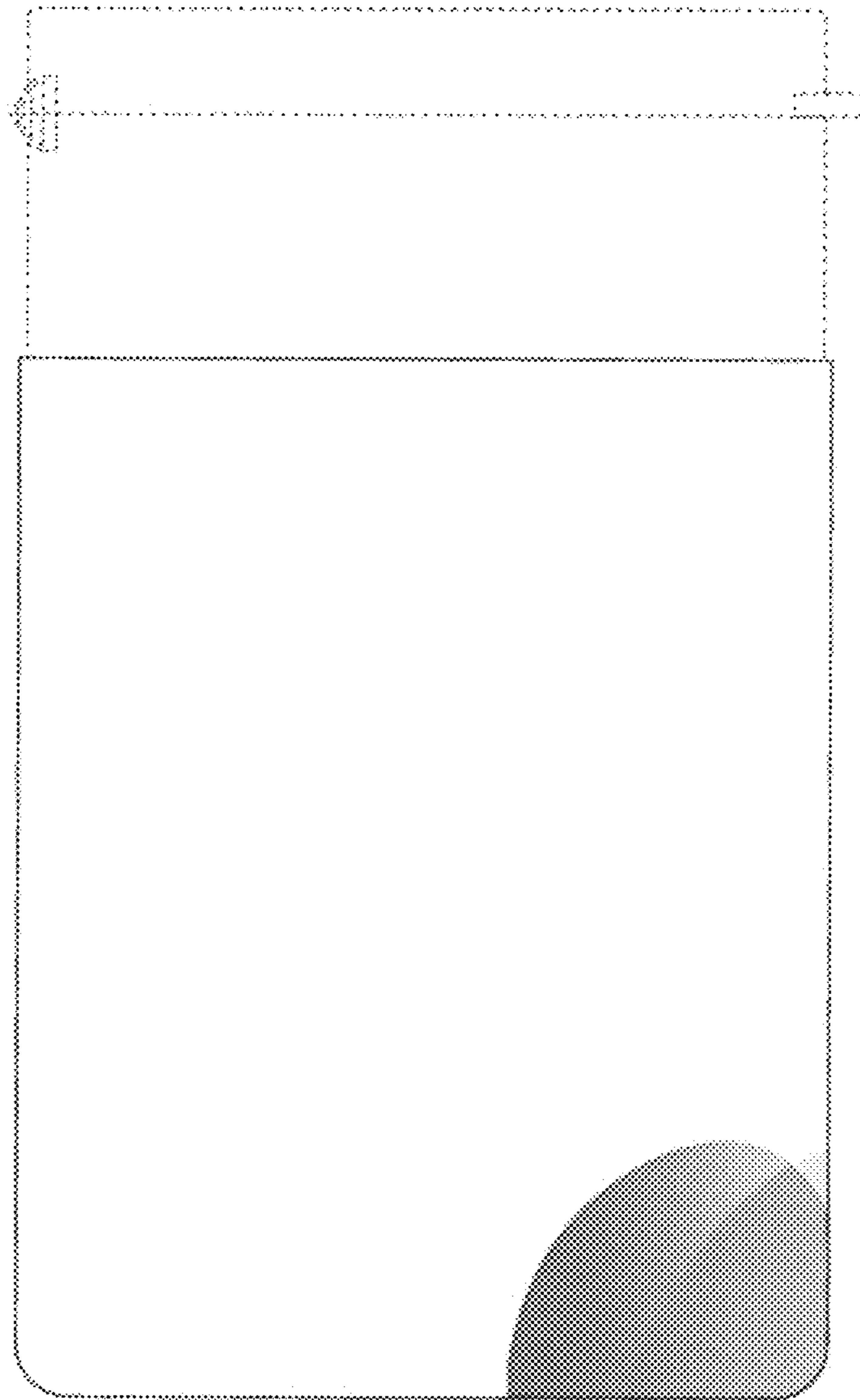

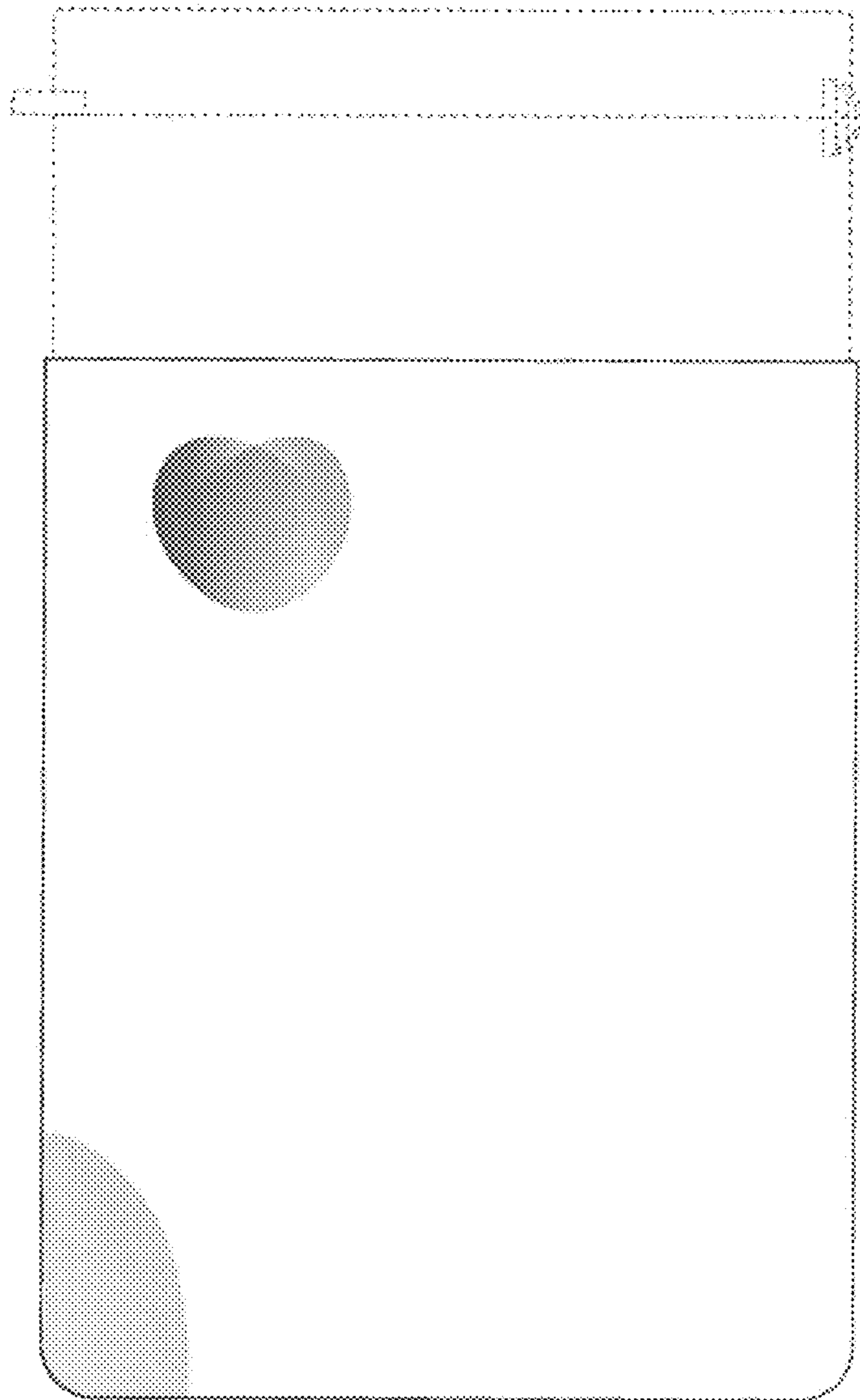

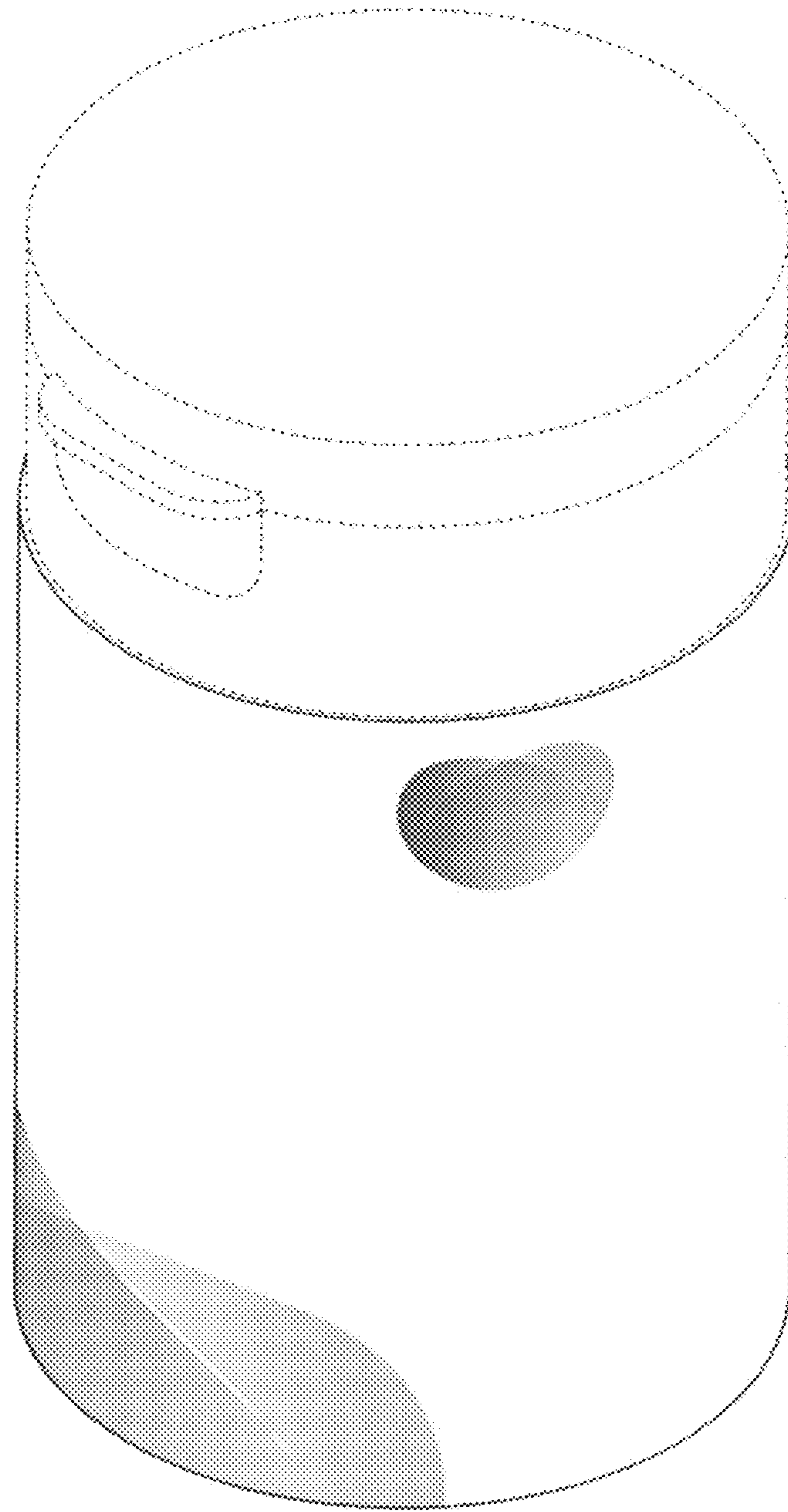
