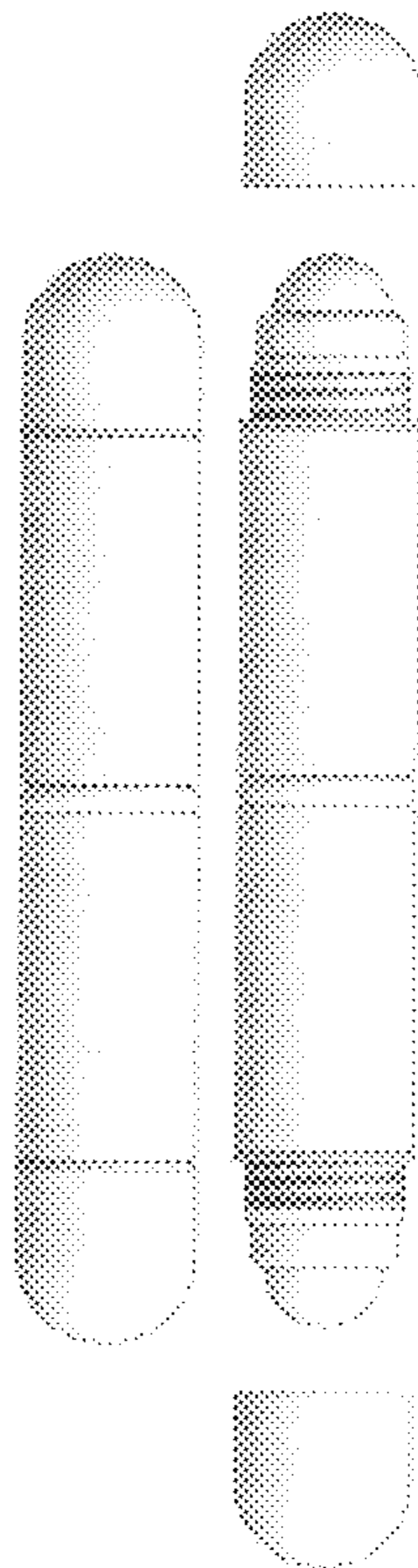
(57) **CLAIM**

The ornamental design for a double-ended roll-on applicator, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the double-ended roll-on applicator, embodying our new design;
FIG. 2 is a front elevational view of thereof, with the screw cap in open position;
FIG. 3 is an end view thereof;
FIG. 4 is a back elevational view of thereof, with the screw cap in open position;
FIG. 5 is a right side elevational view of thereof, with the screw cap in open position; and,
FIG. 6 is a left side elevational view of thereof, with the screw cap in open position.

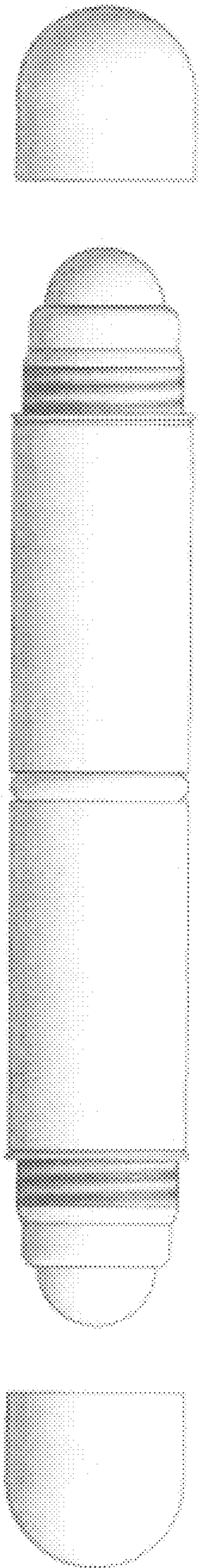

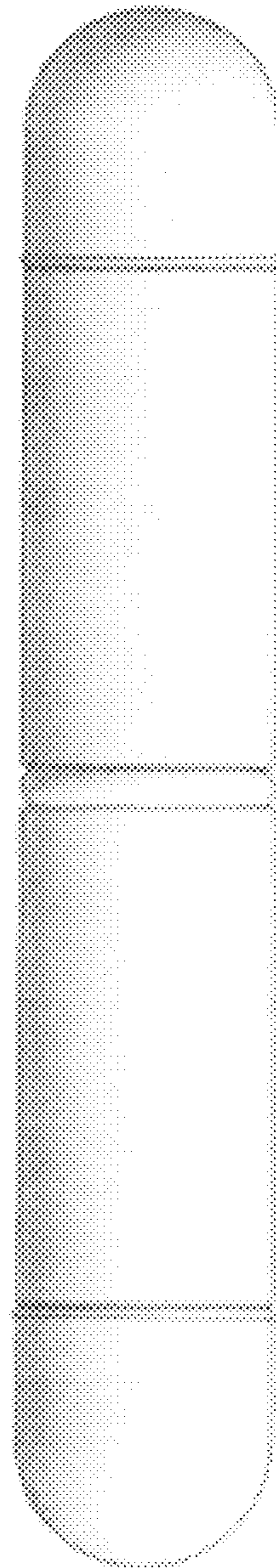

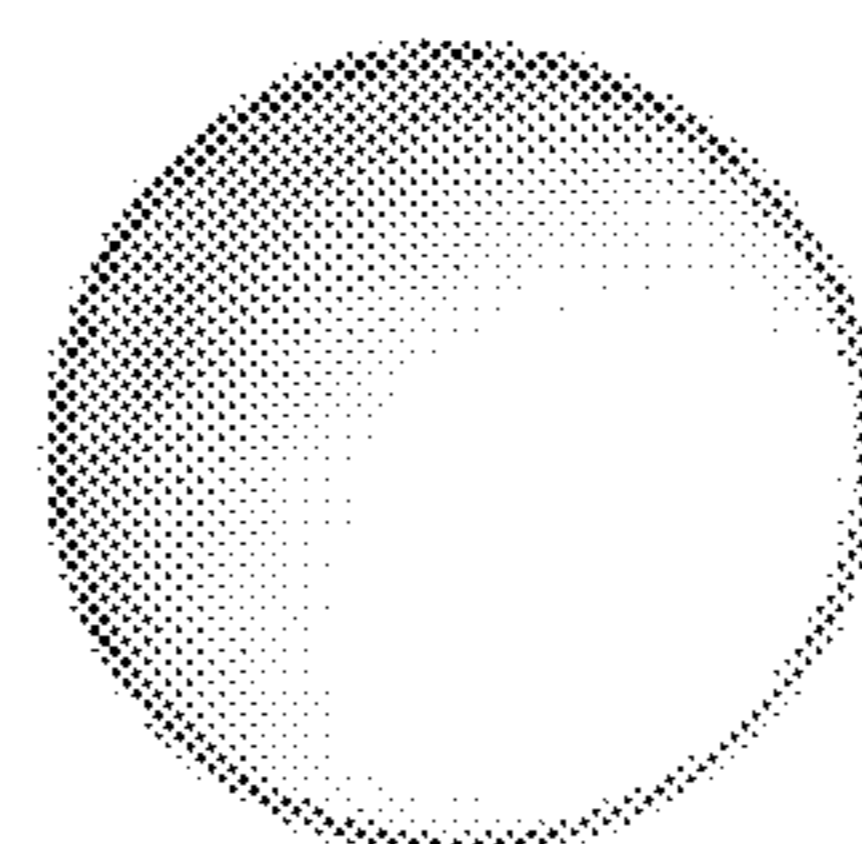
