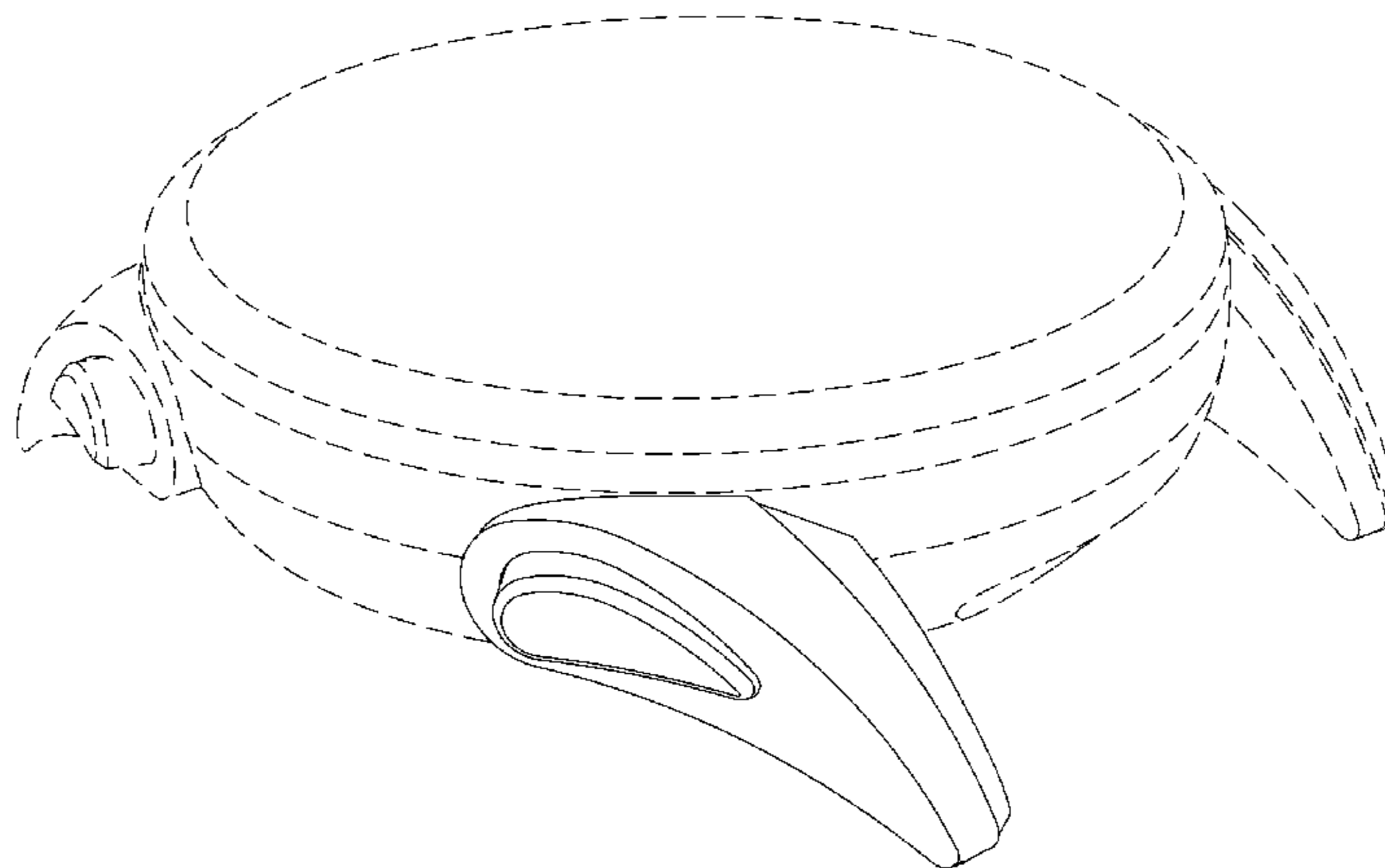

The ornamental design for a lug for a watch, as shown and described.

**DESCRIPTION**

FIG. 9 is a top view of the invention mounted on a watch case;

FIG. 12 is a front view of the invention mounted on a watch case;  
FIG. 13 is a perspective view of the invention mounted on a watch case; and,  
FIG. 14 is another perspective view of the invention mounted on a watch case.

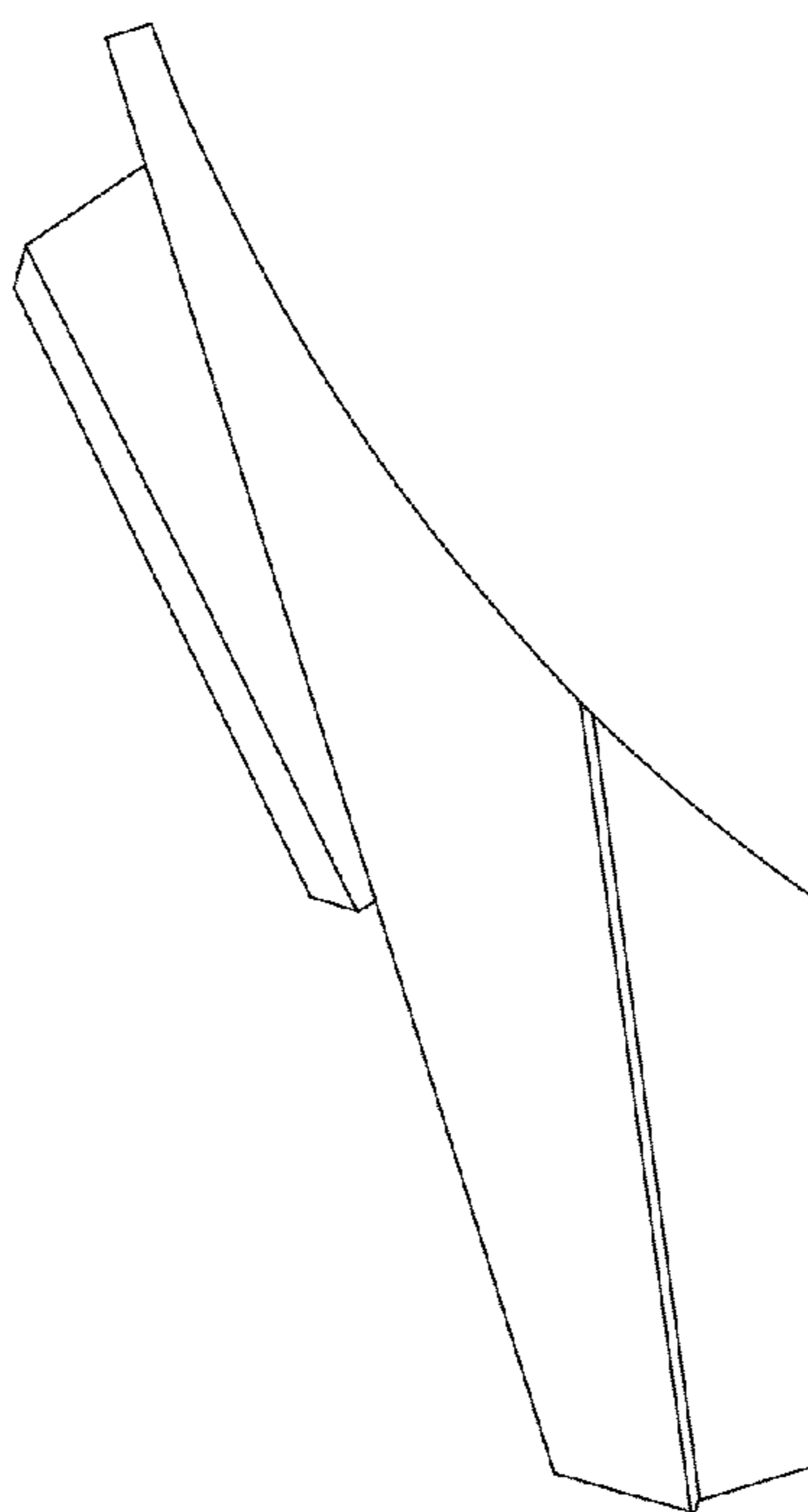

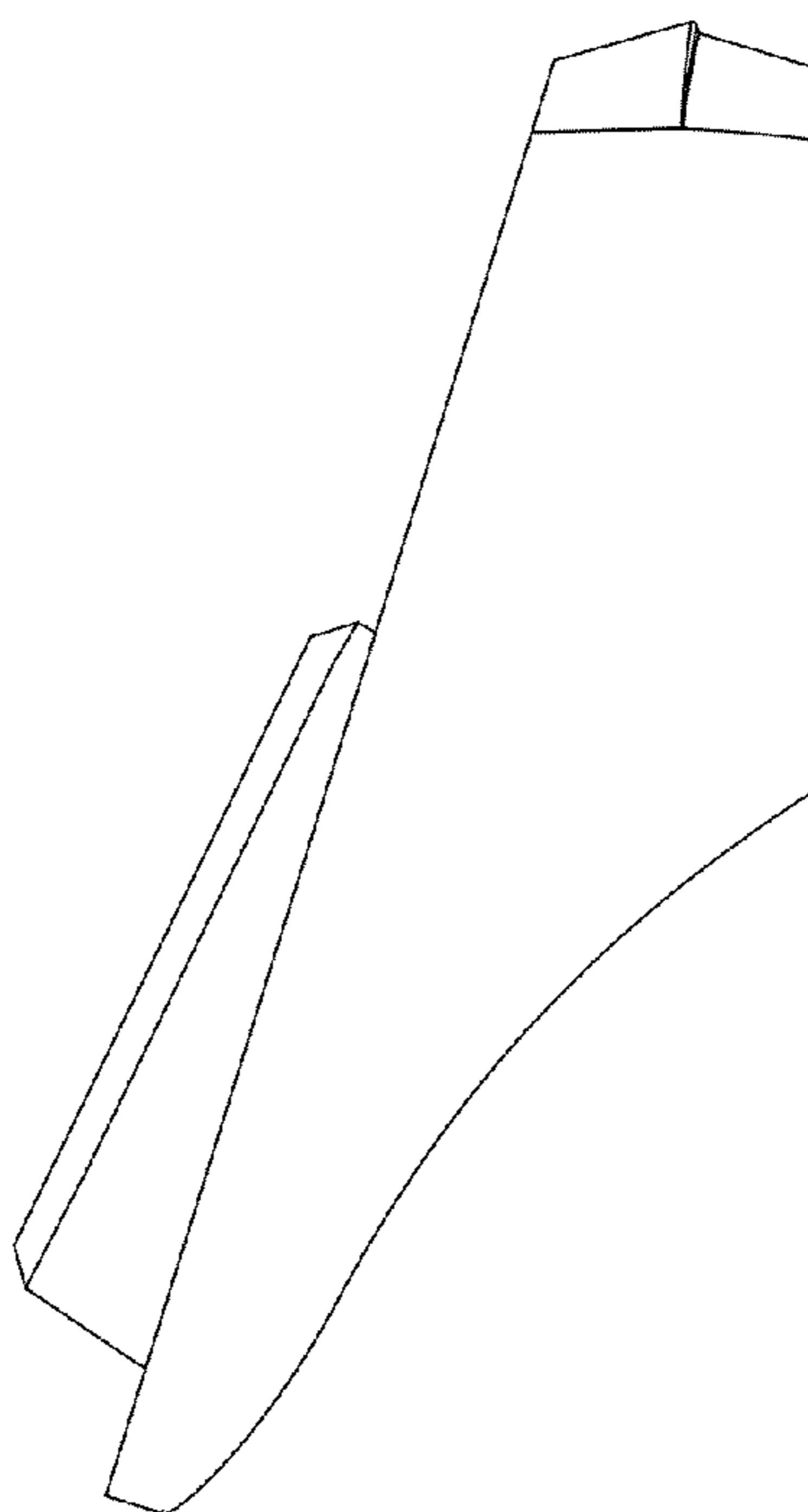

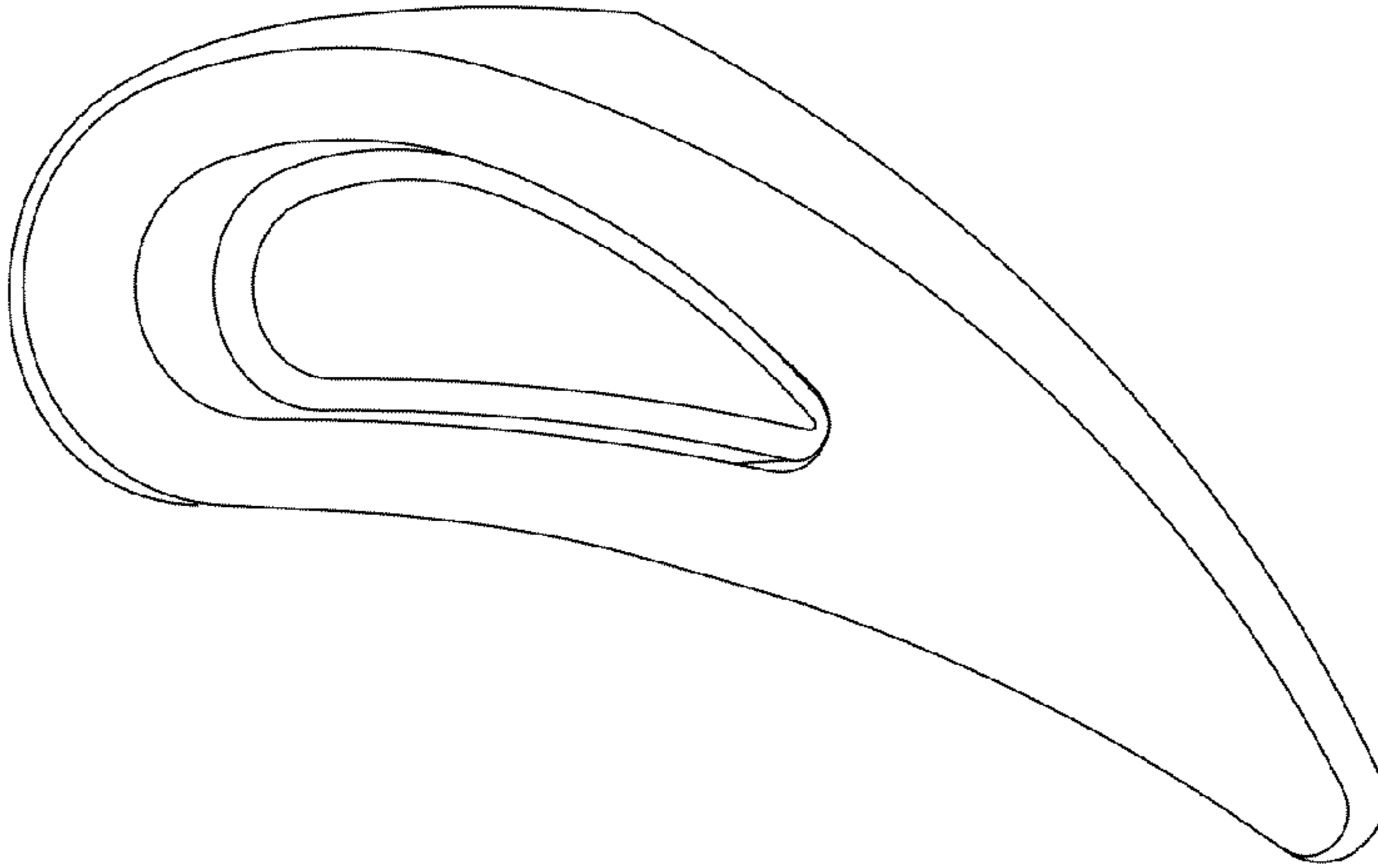

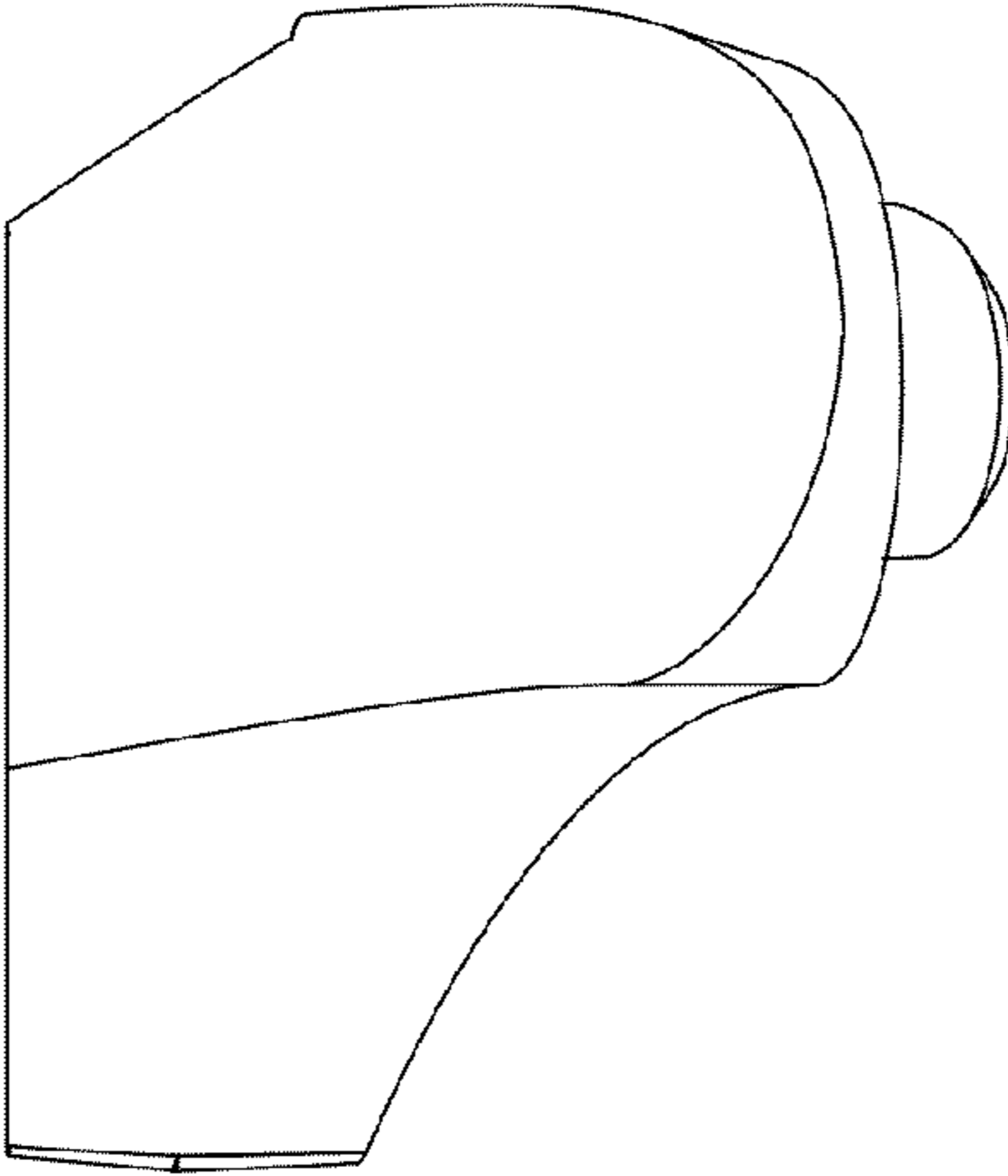

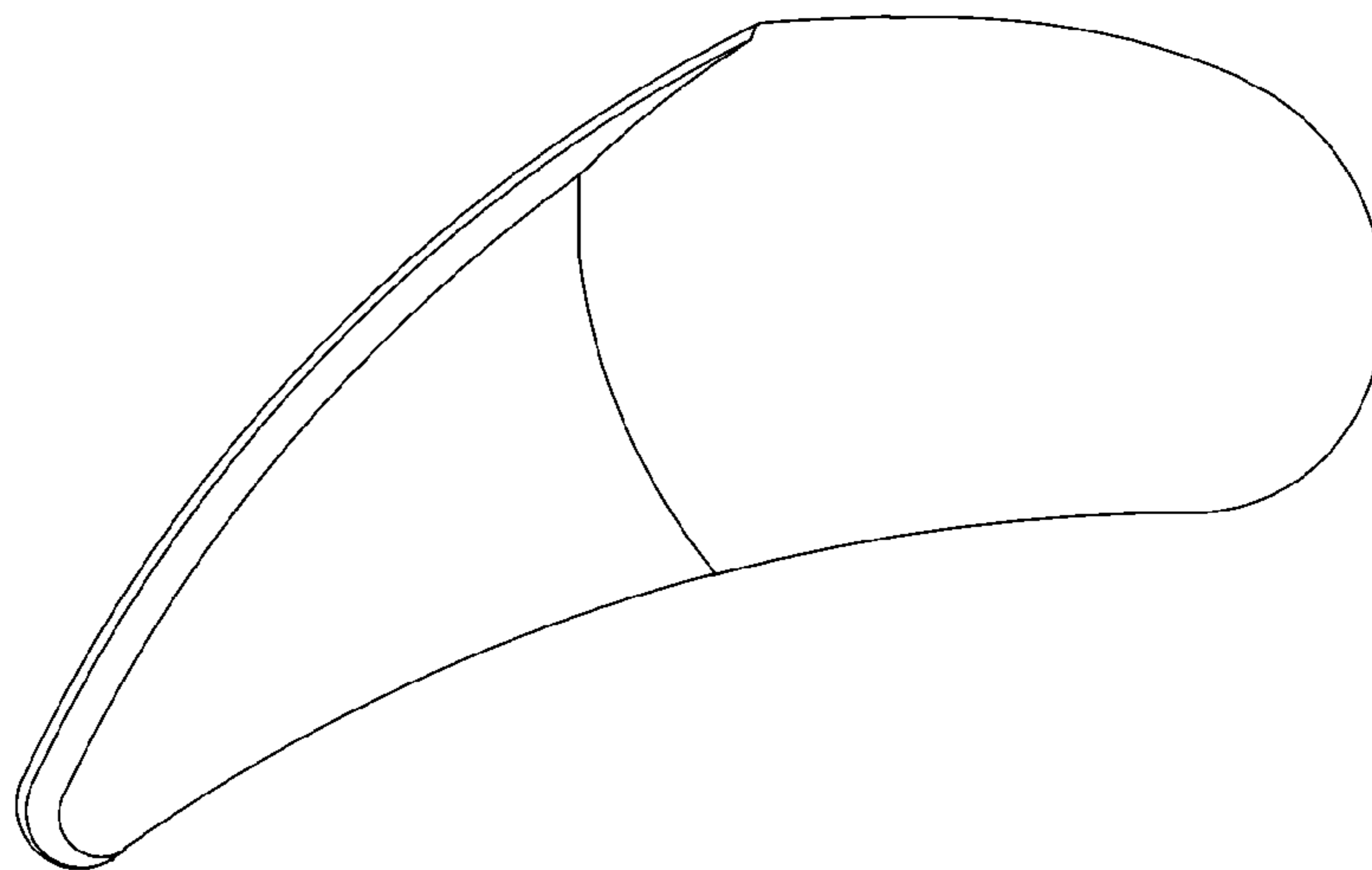

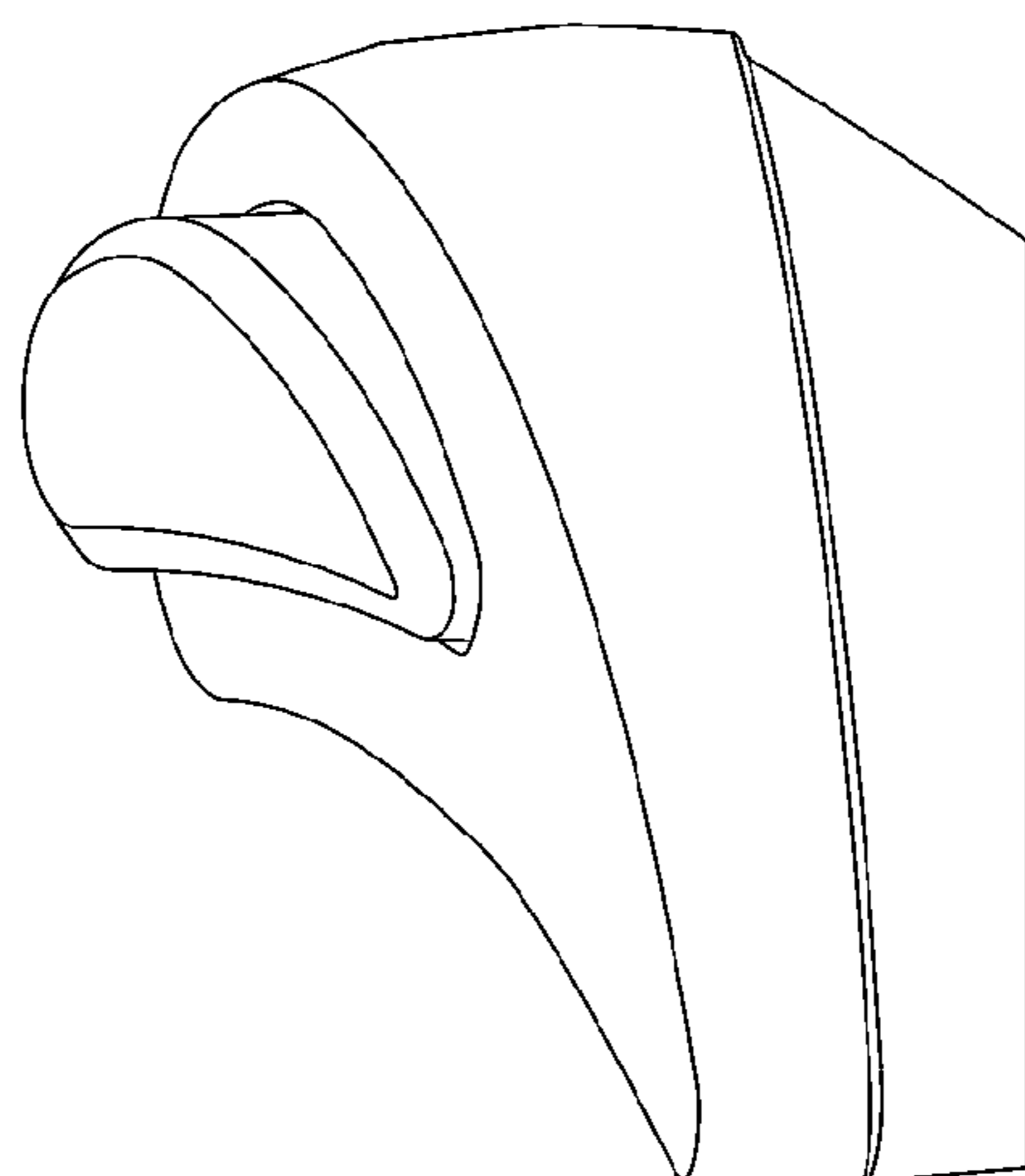

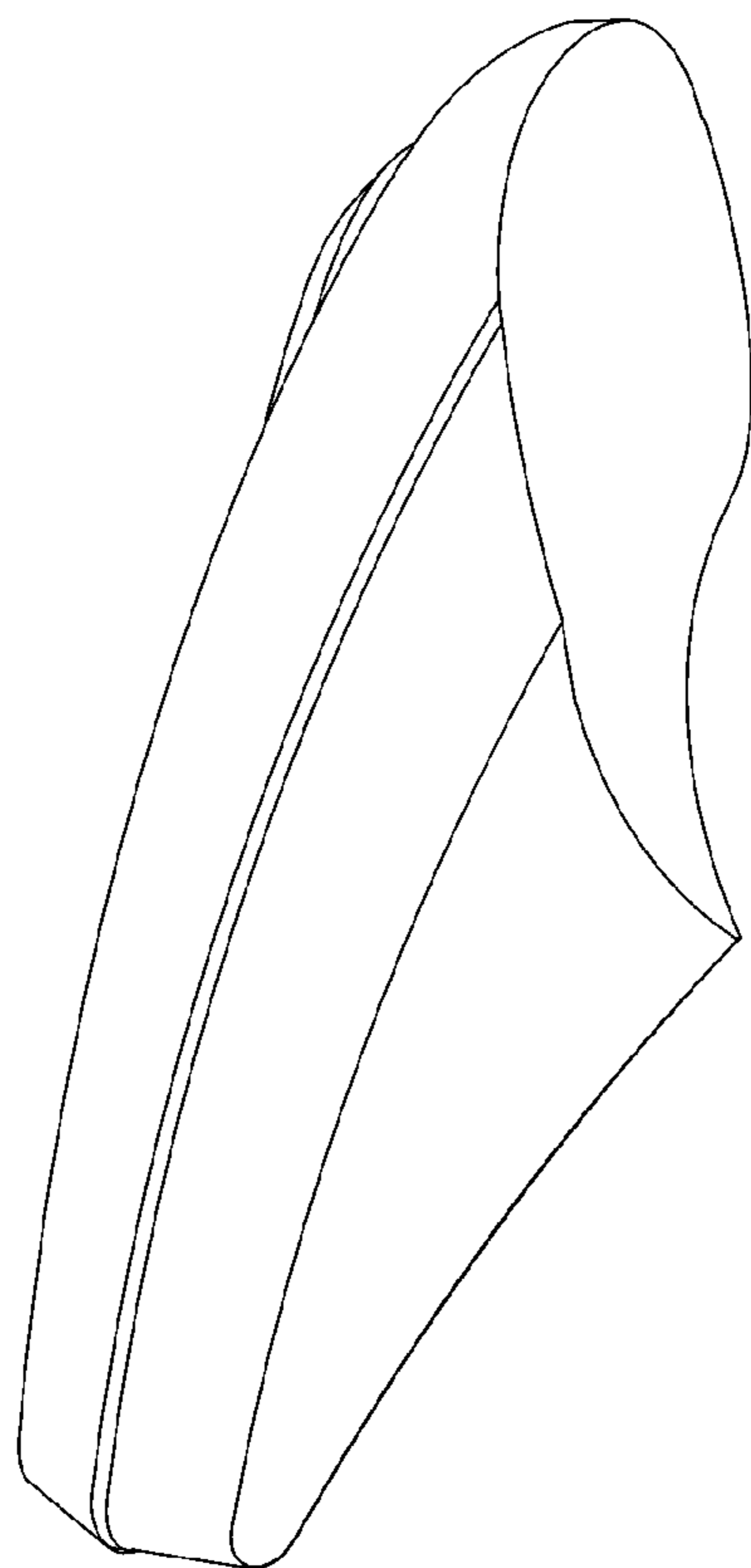

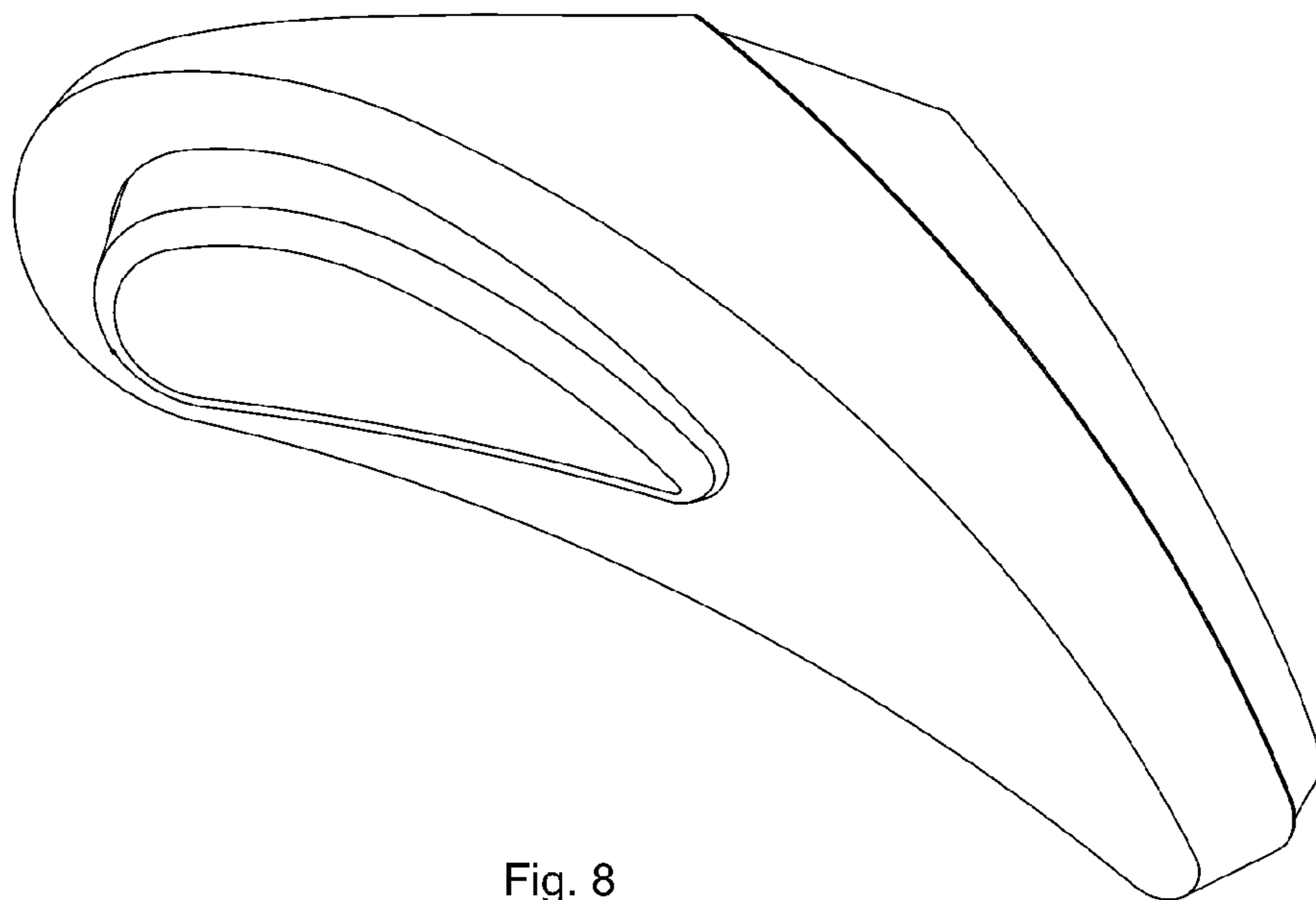

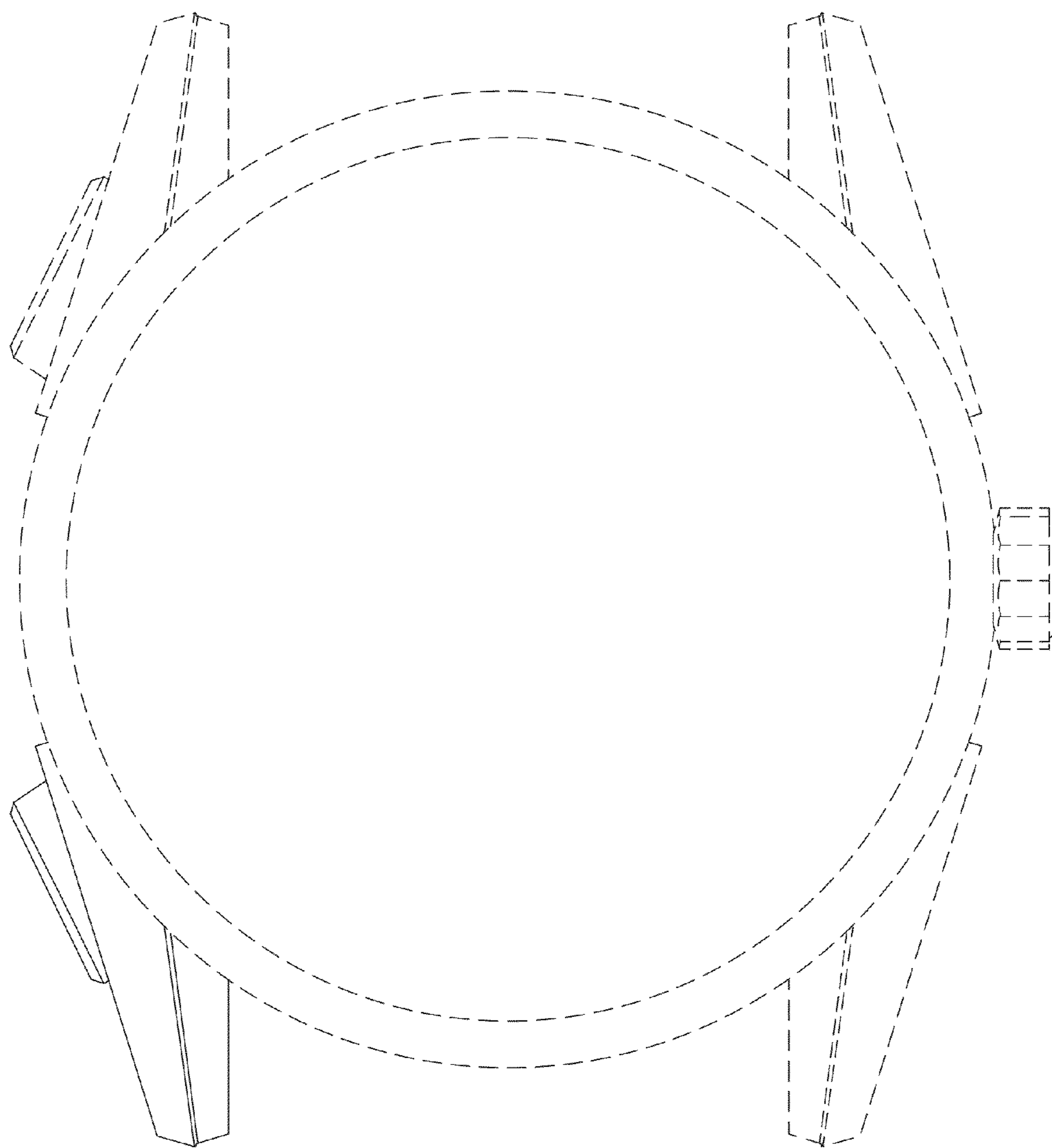

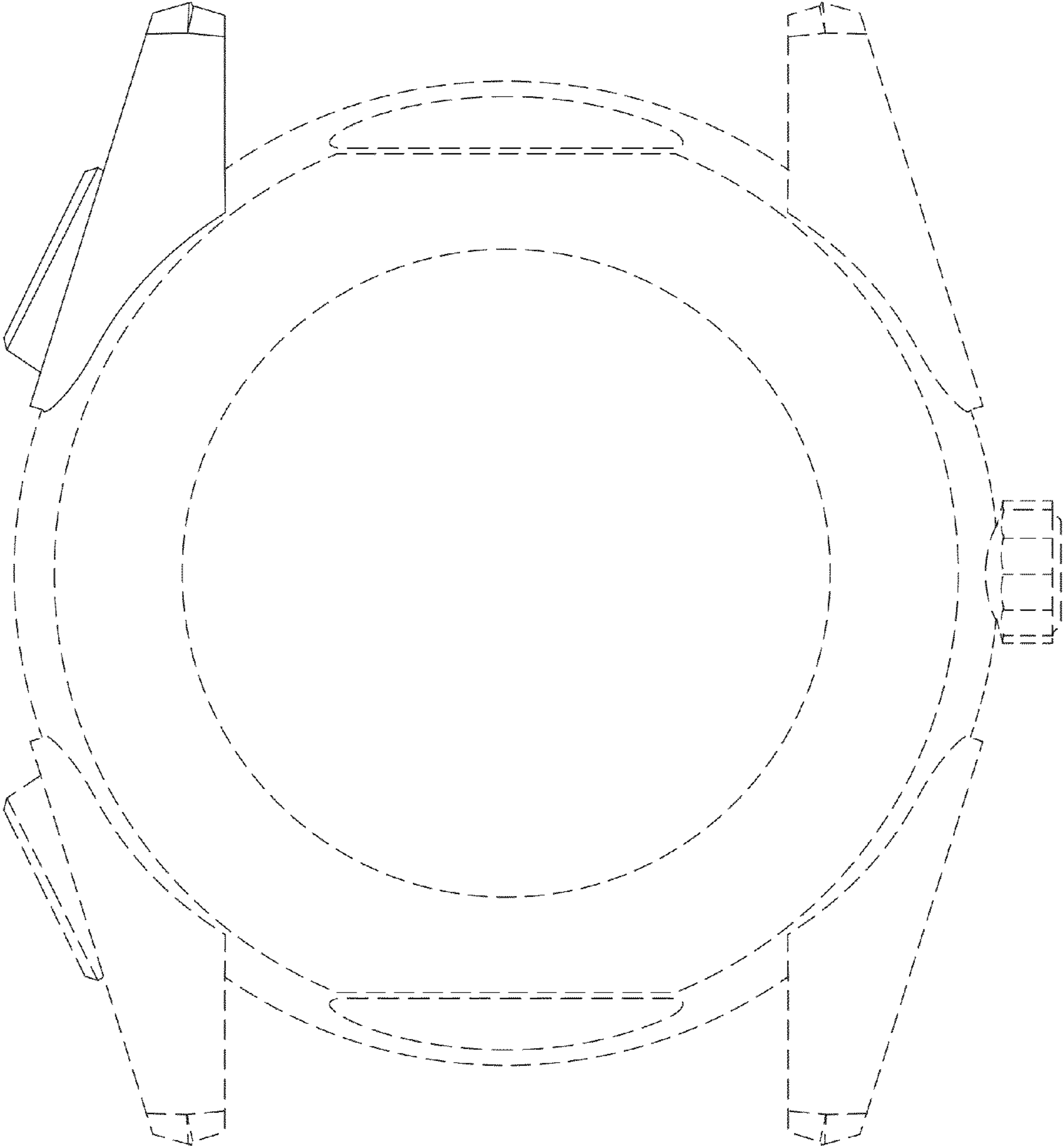

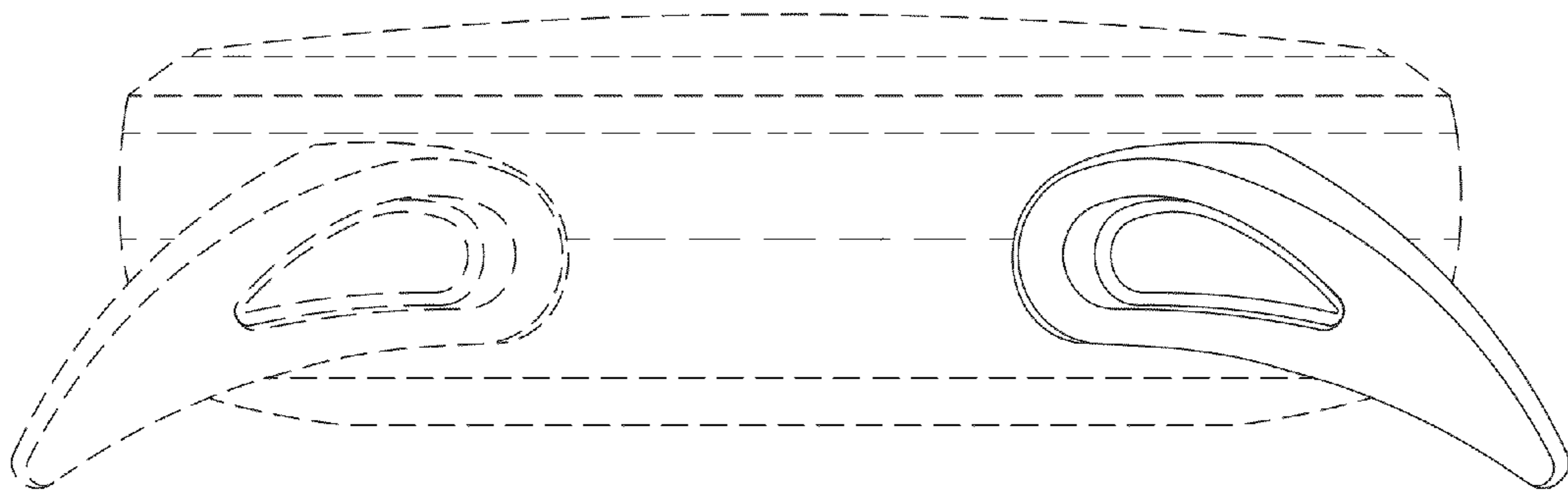

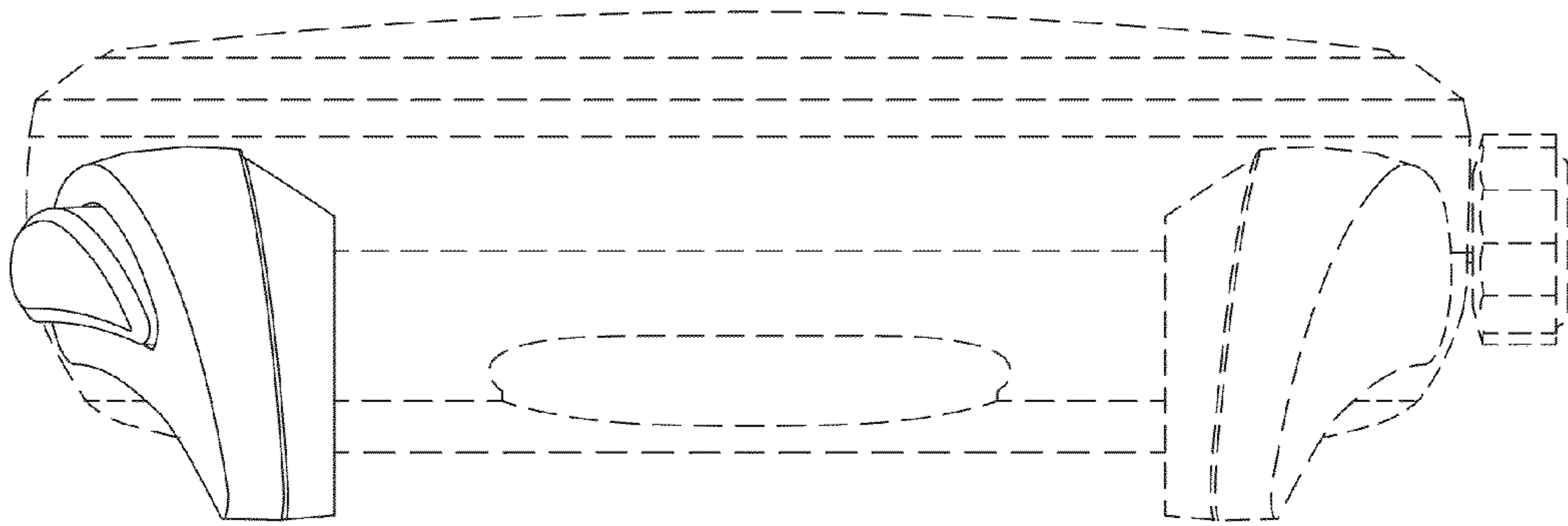

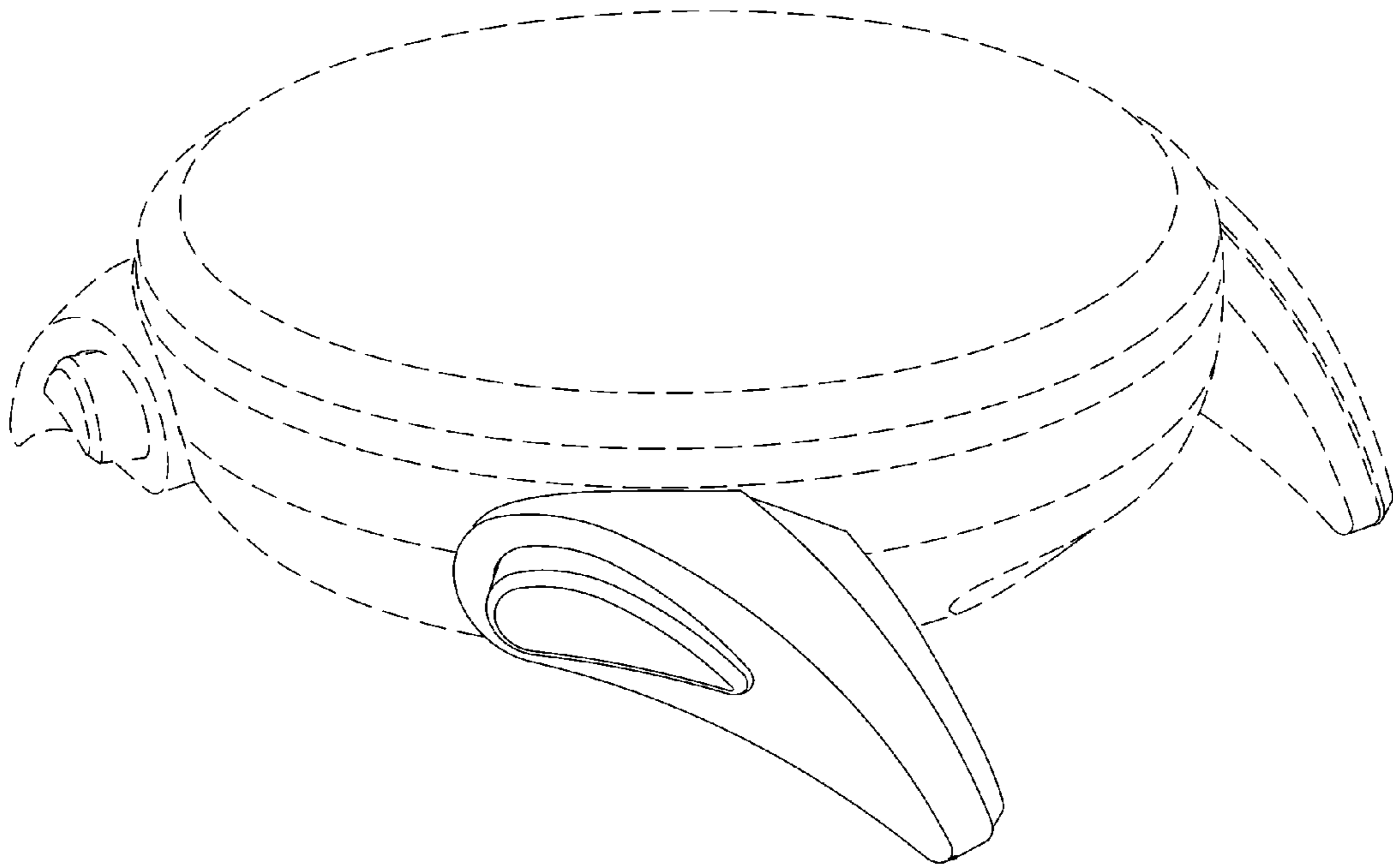

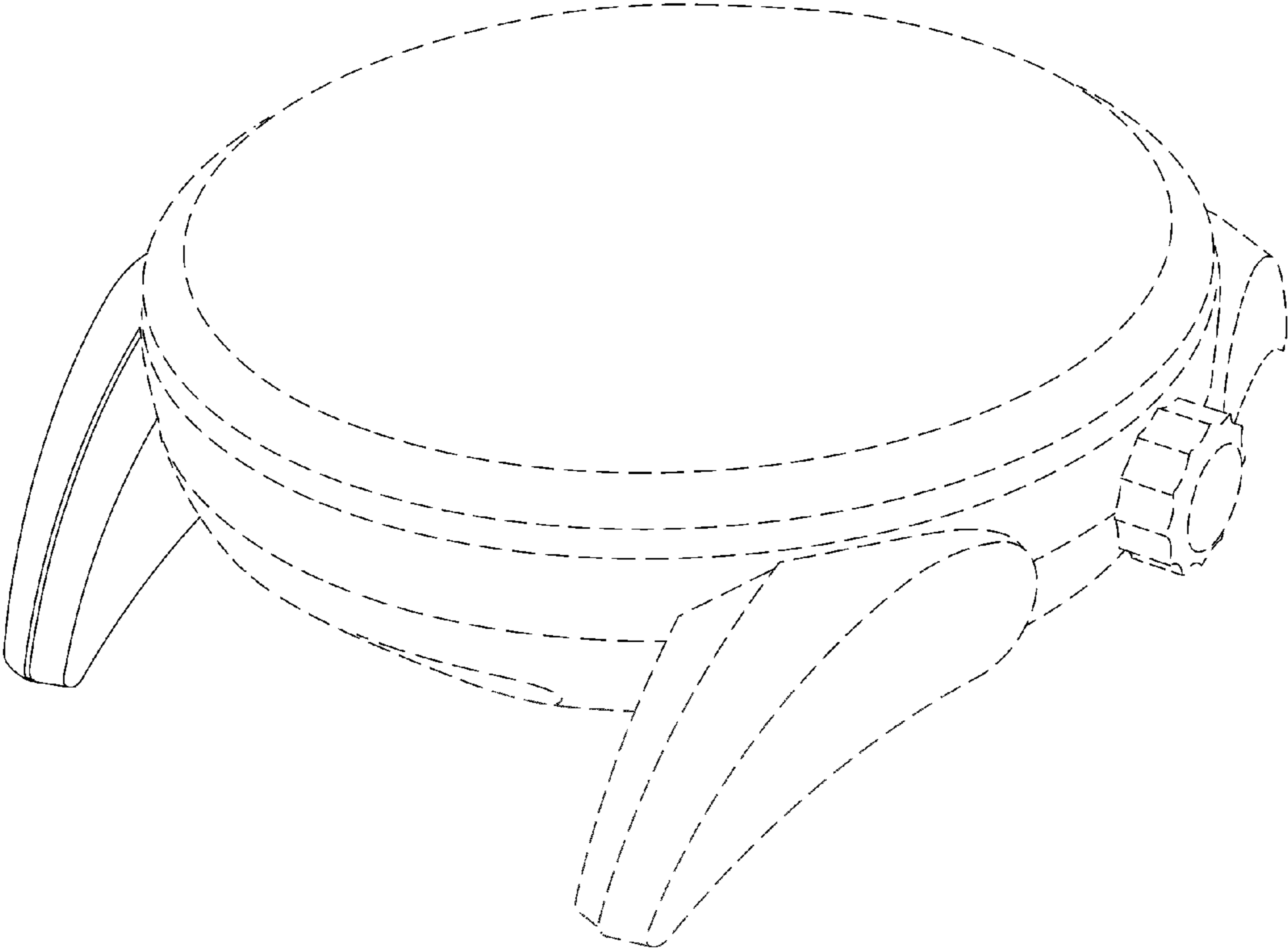
