(57) **CLAIM**

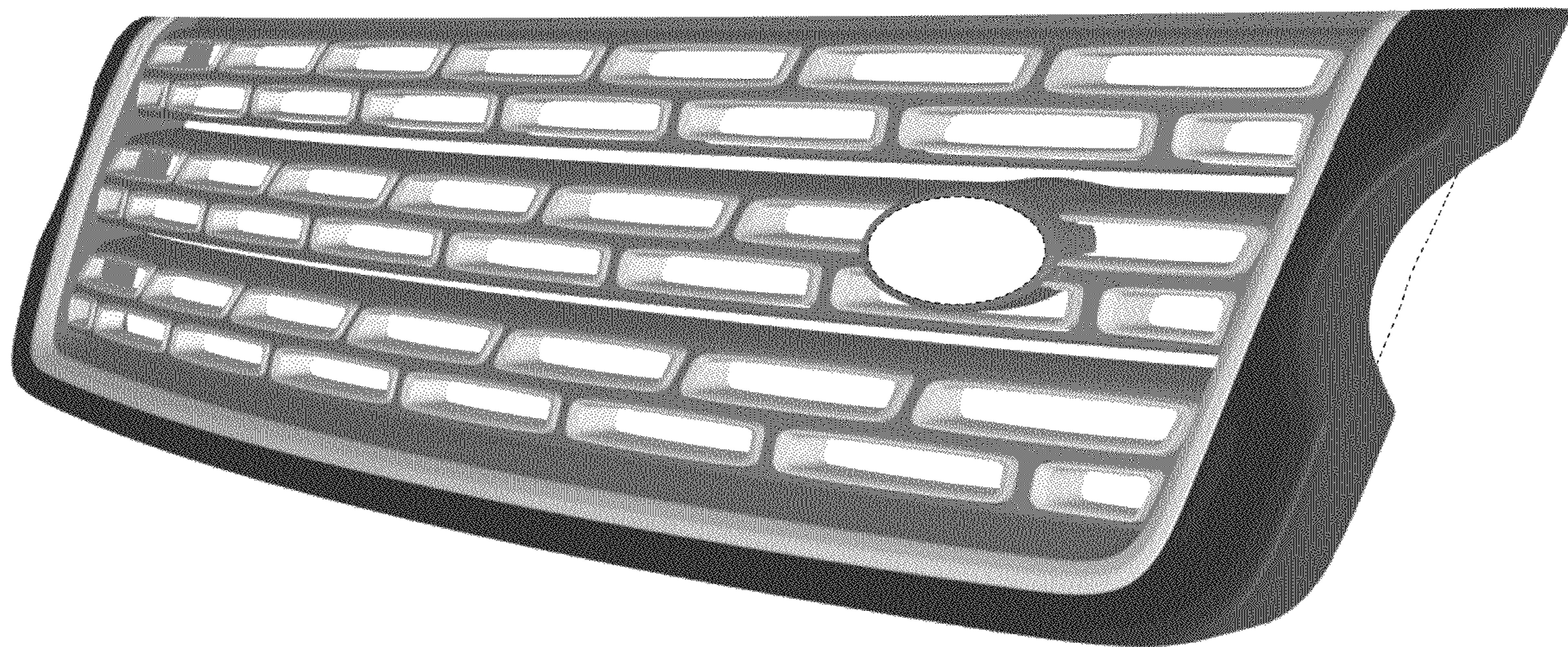
The ornamental design for a vehicle grille, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a vehicle grille; FIG. 2 is a right front perspective view of a vehicle grille; FIG. 3 is a front view of a vehicle grille; FIG. 4 is a rear view of a vehicle grille; FIG. 5 is a left side view of a vehicle grille; FIG. 6 is a right side view of a vehicle grille; FIG. 7 is a top view of a vehicle grille; and, FIG. 8 is a supplemental view of a vehicle grille in the installed position on vehicle.

The broken lines shown illustrate portions of the vehicle grille that form no part of the claimed design. The gray shaded vehicle in FIG. 8 illustrates environmental structure that forms no part of the claimed design.

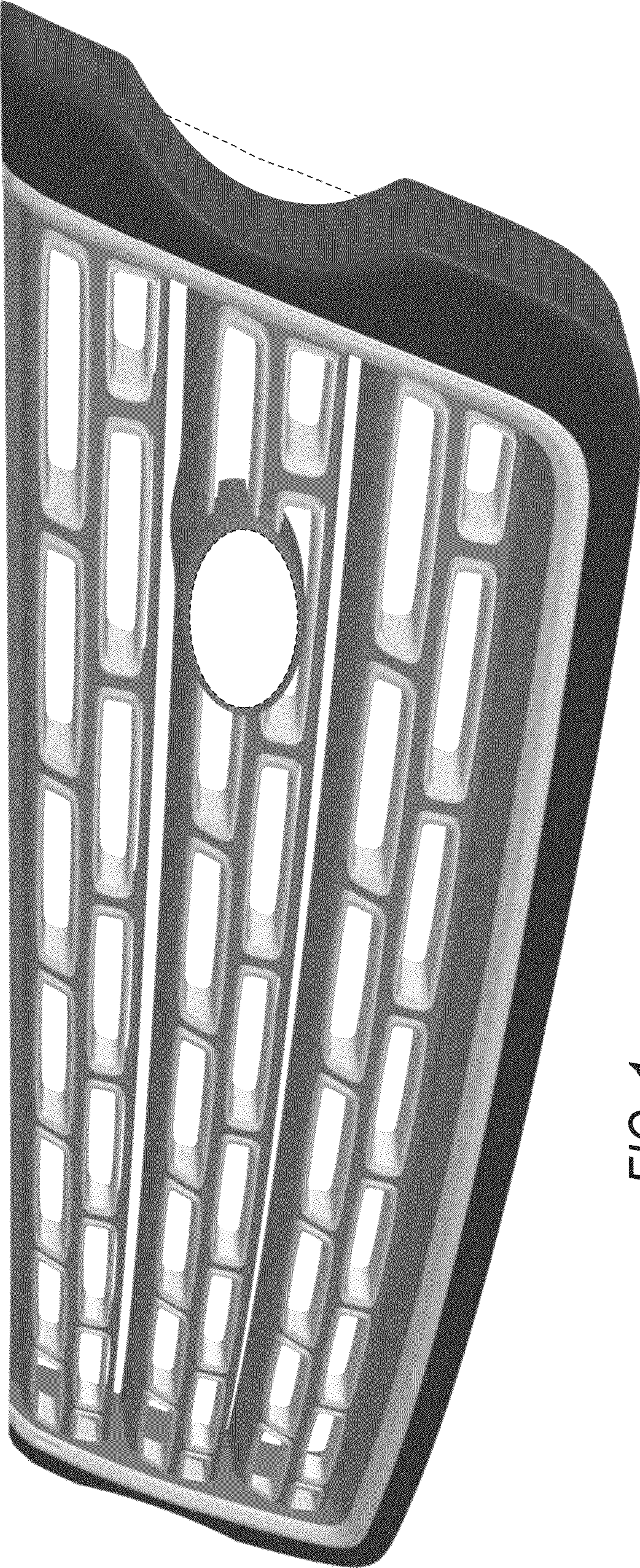

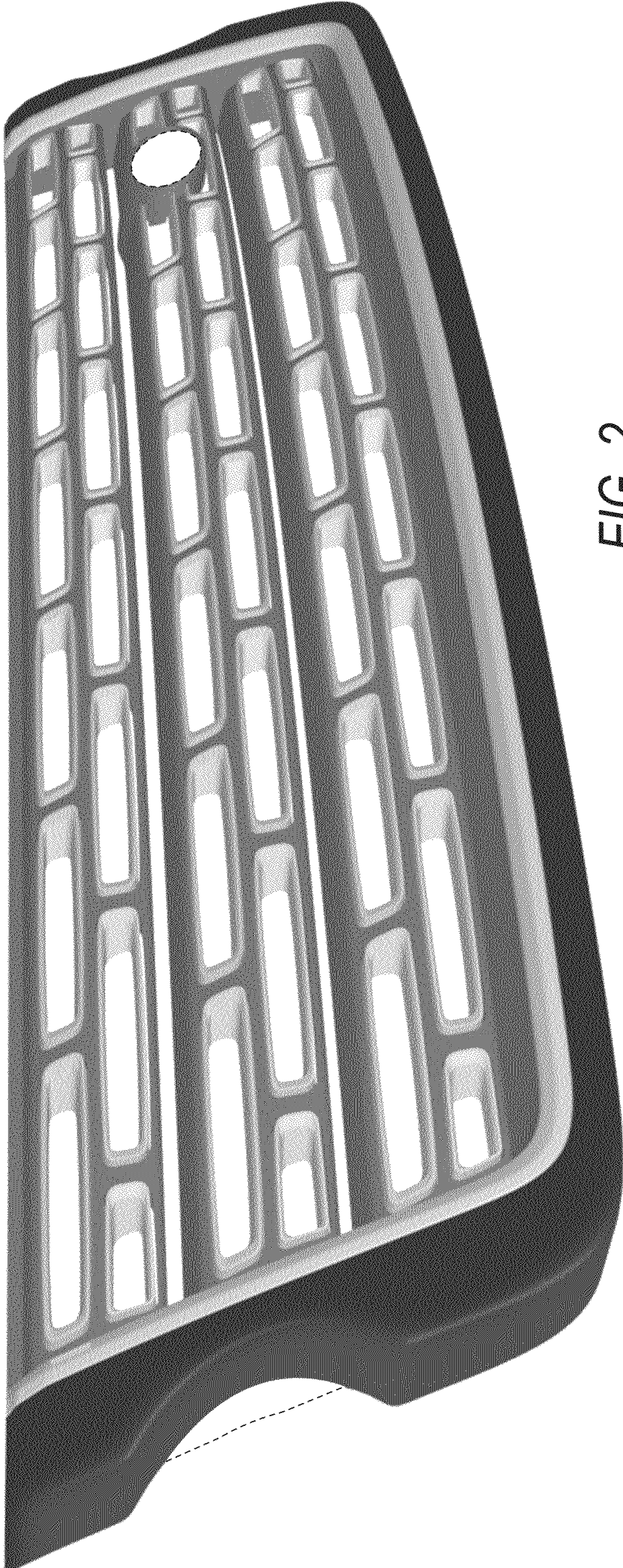

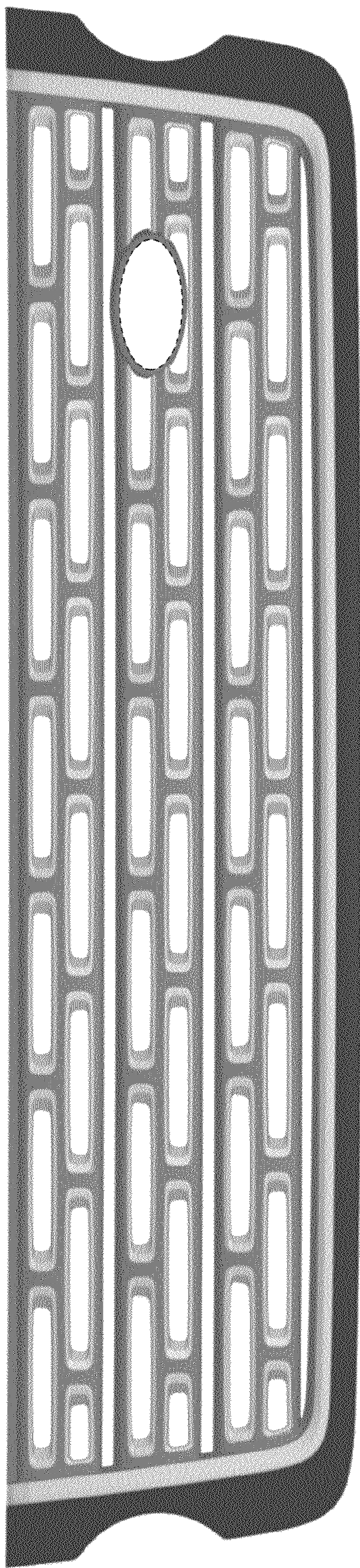

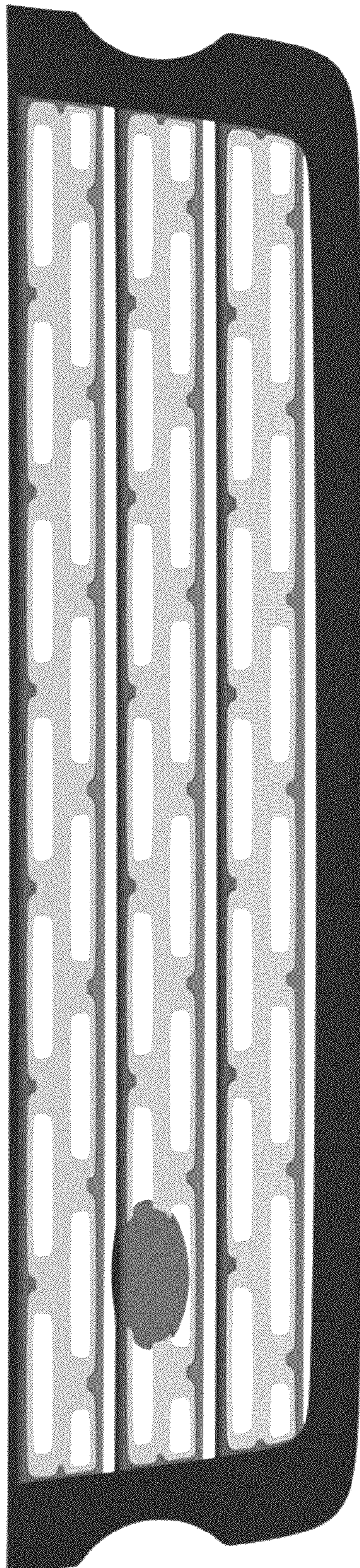

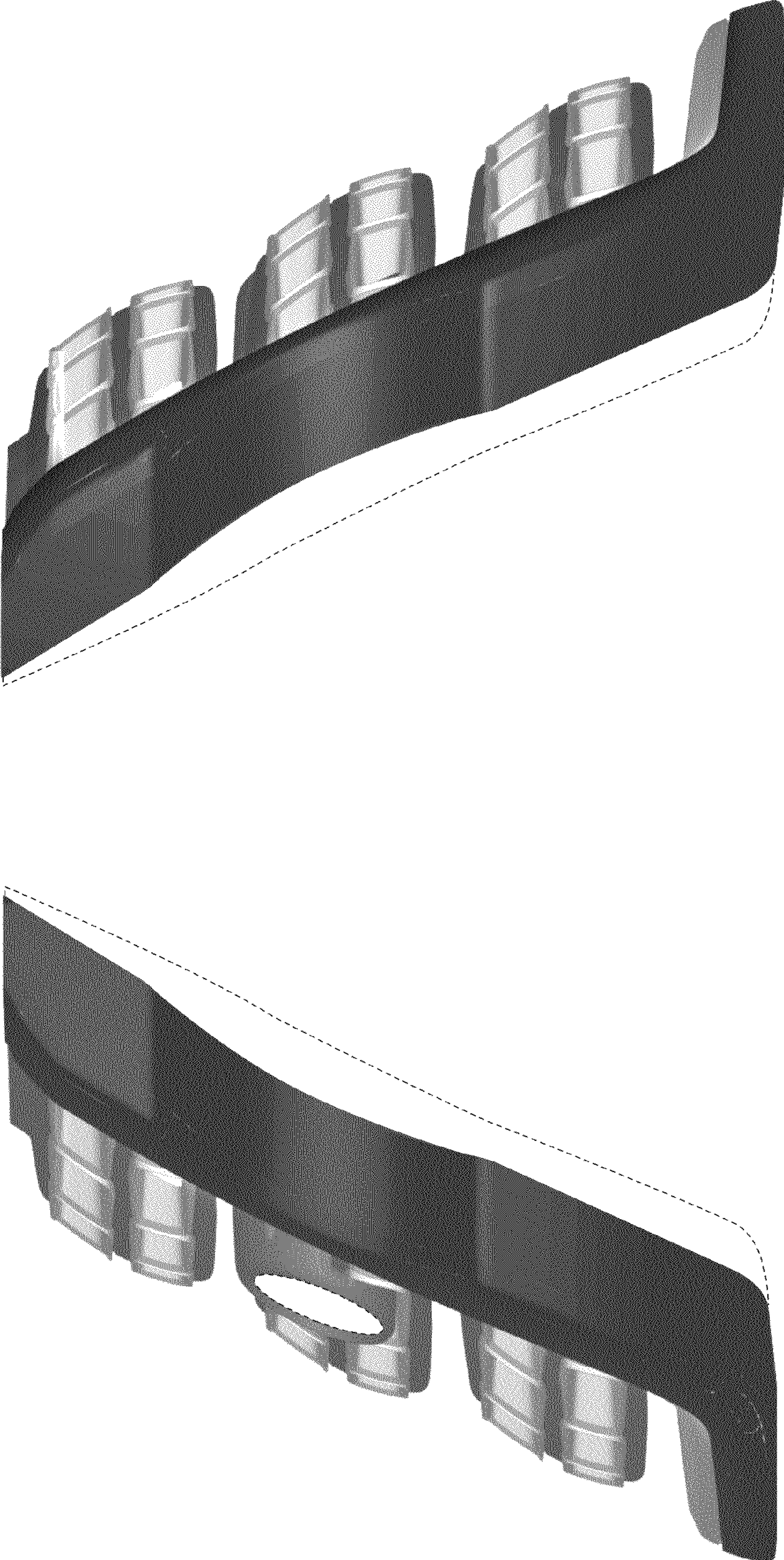

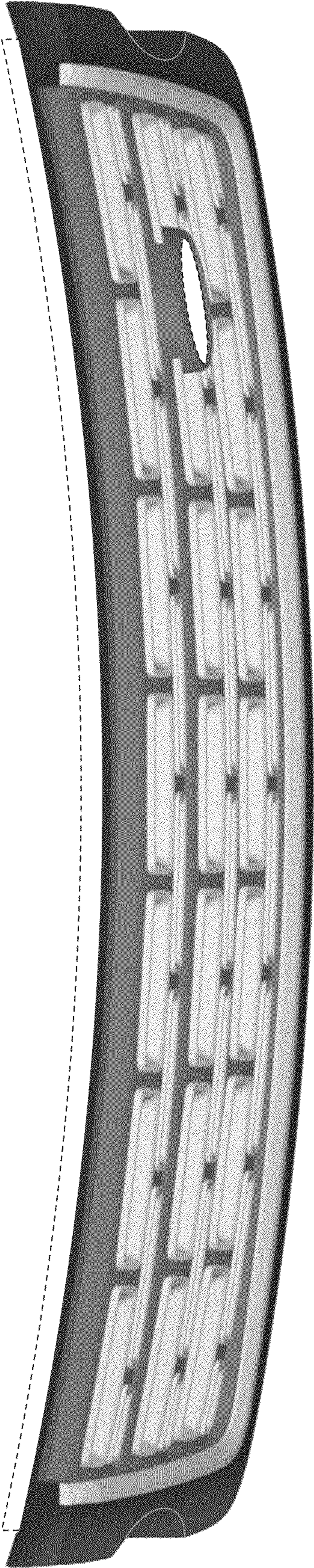
