DESCRIPTION

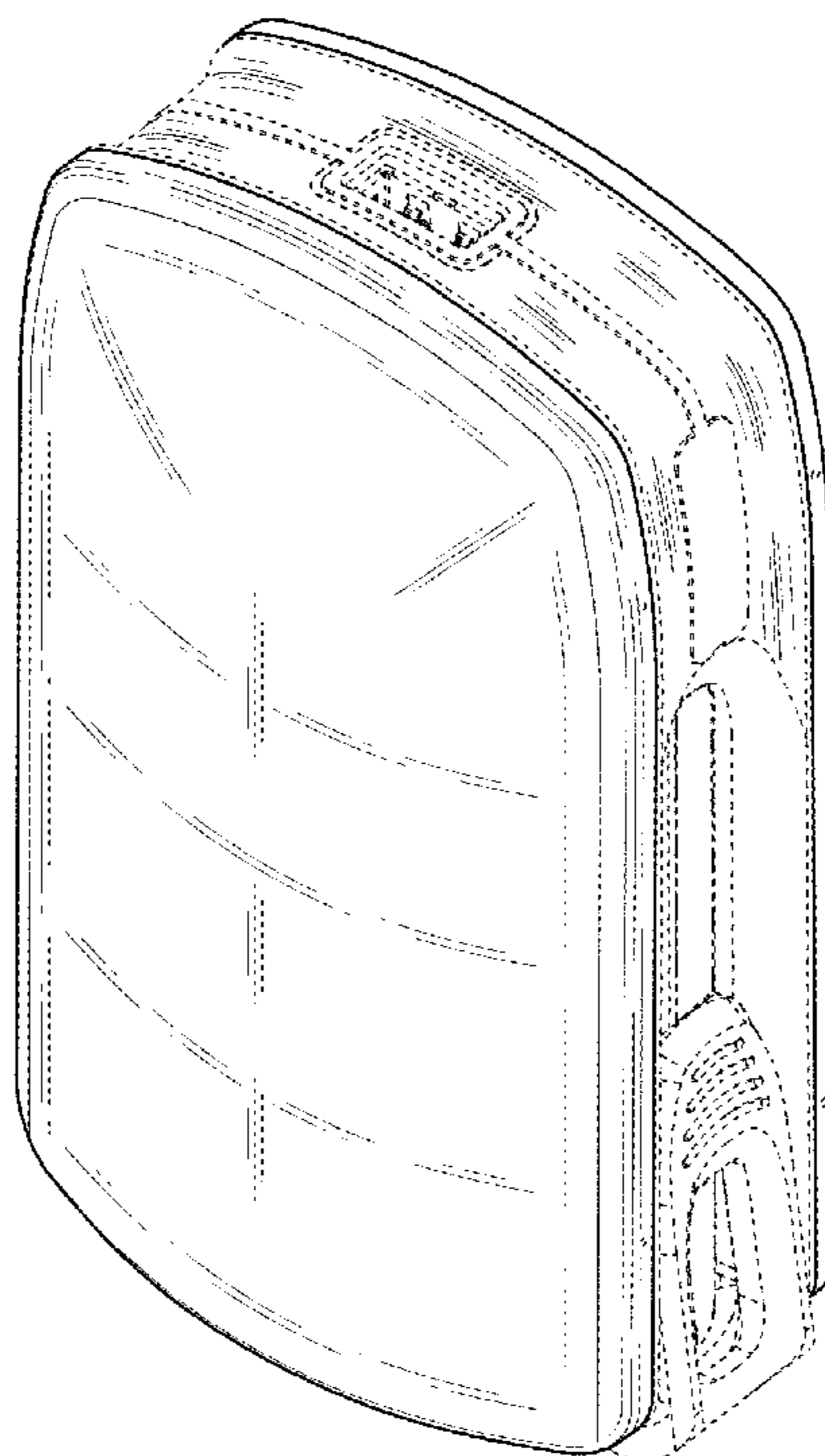
FIG. 1 is a front, top perspective view of the mobile power source;

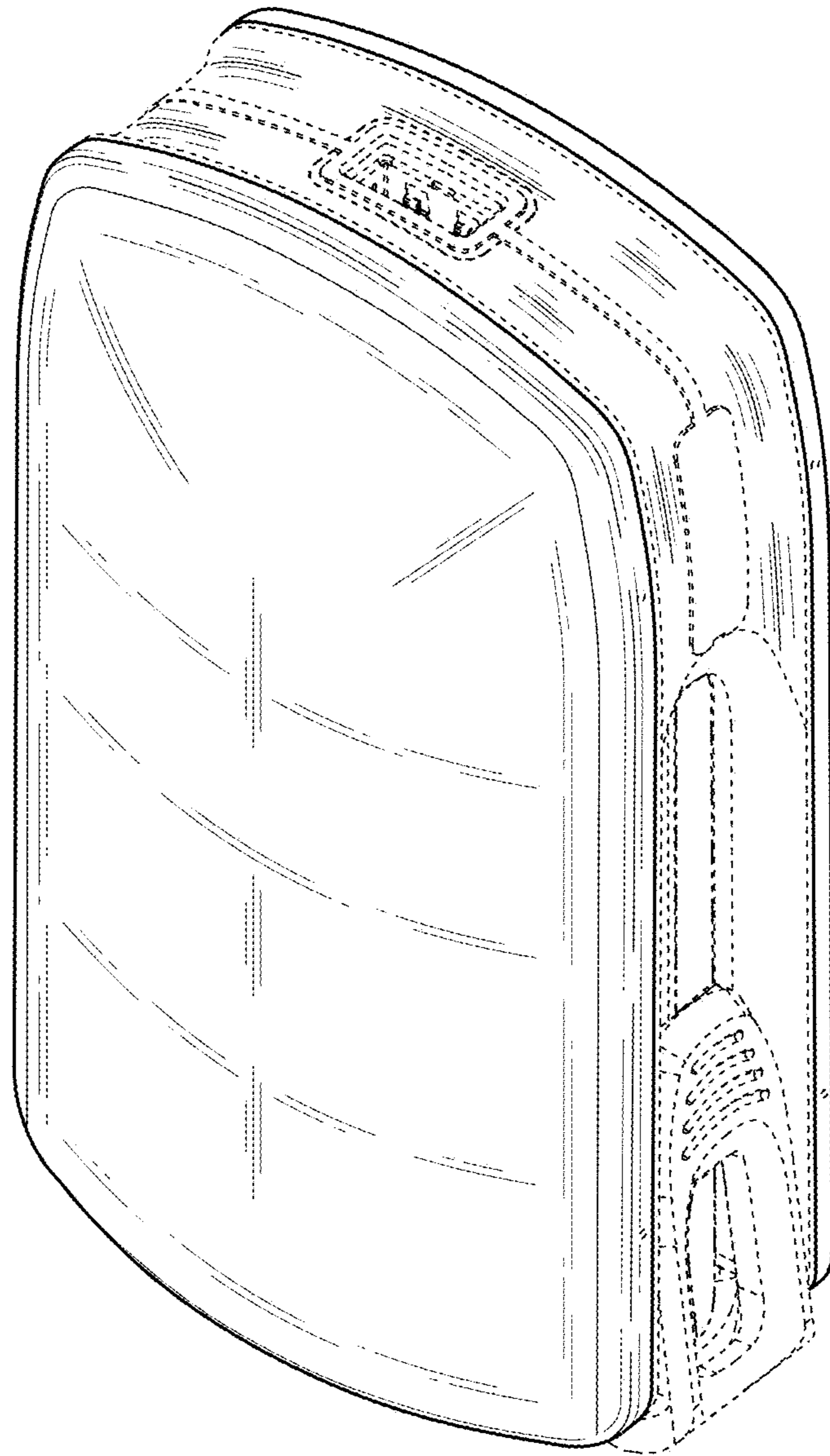

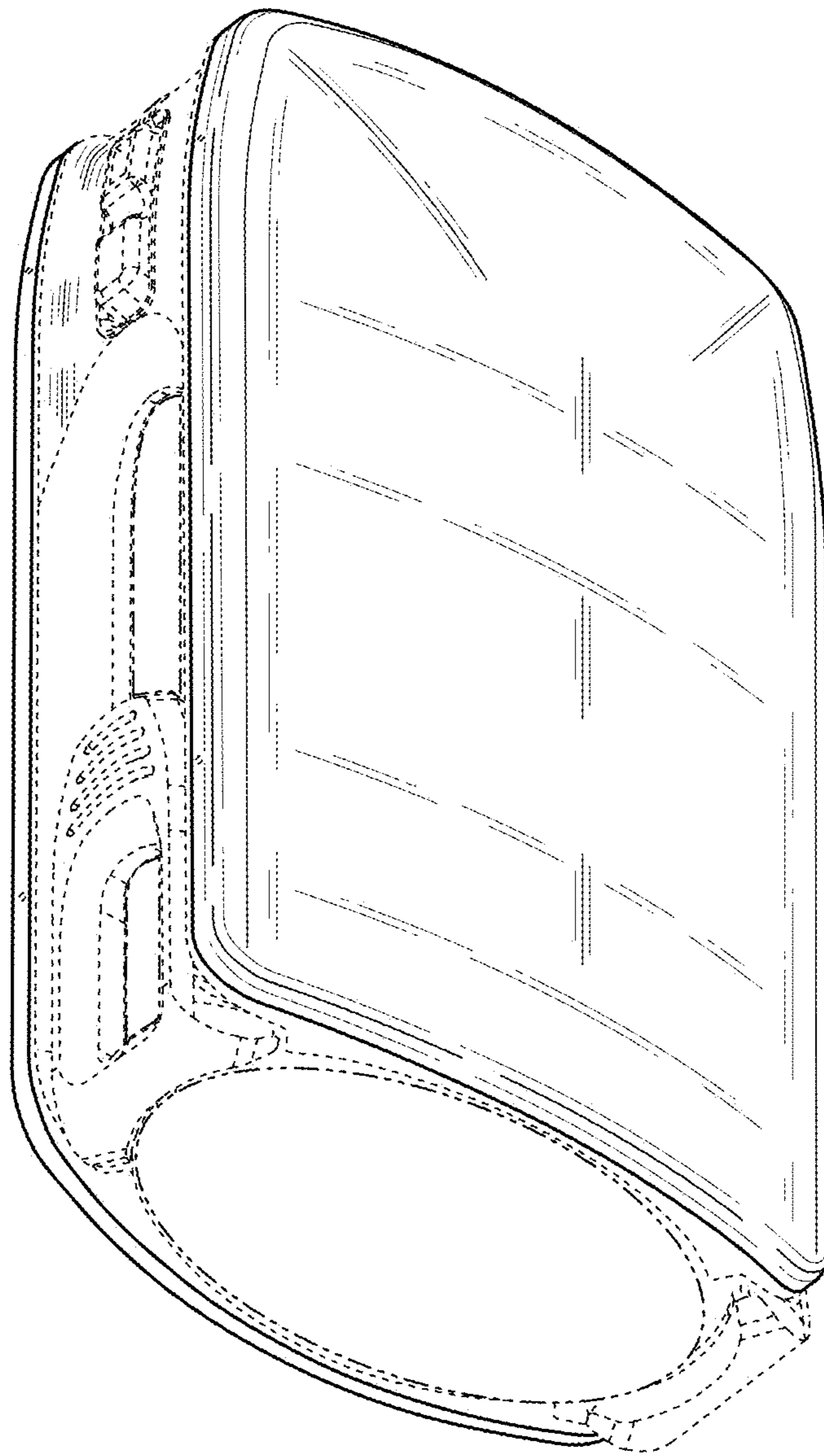

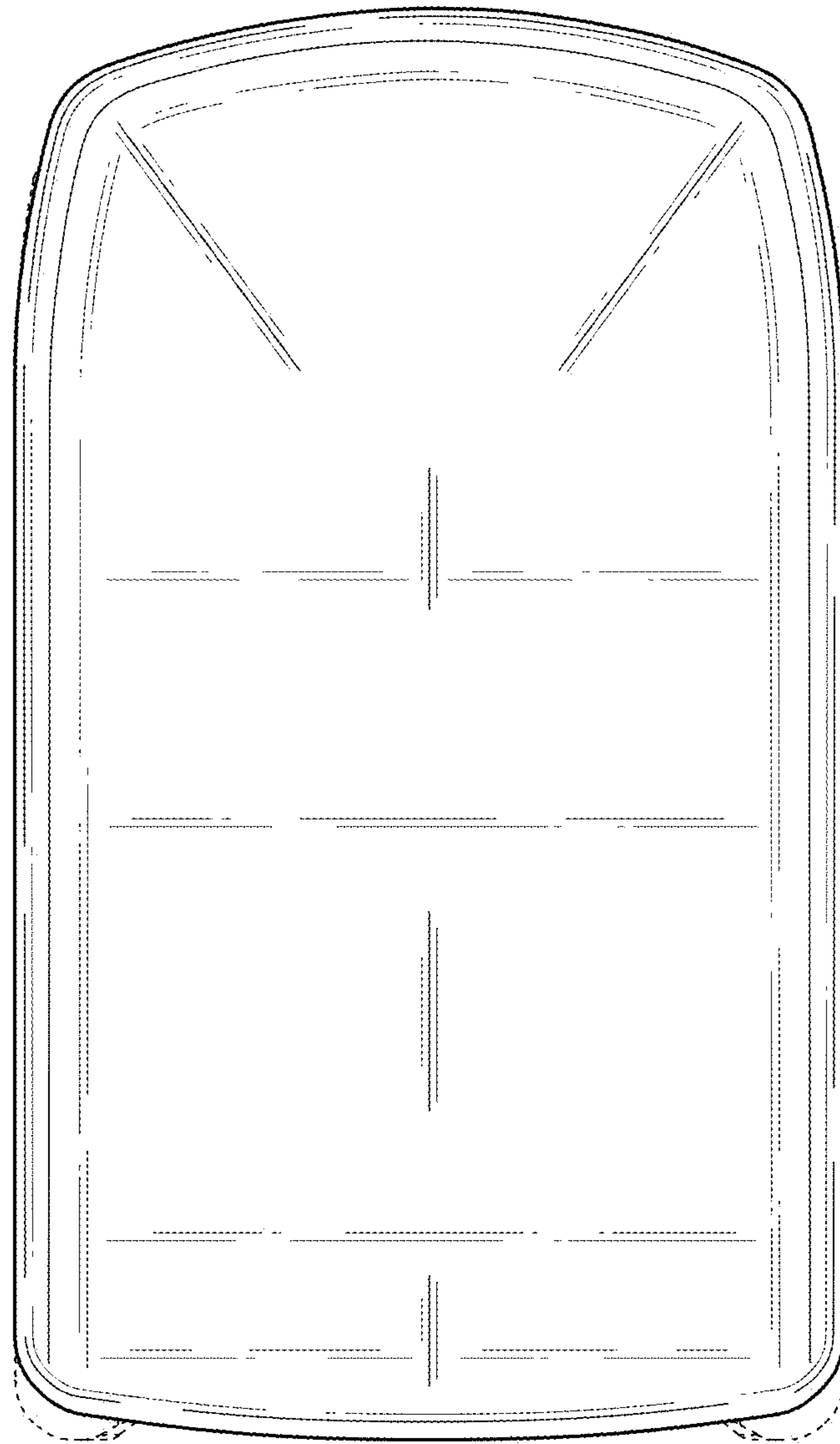

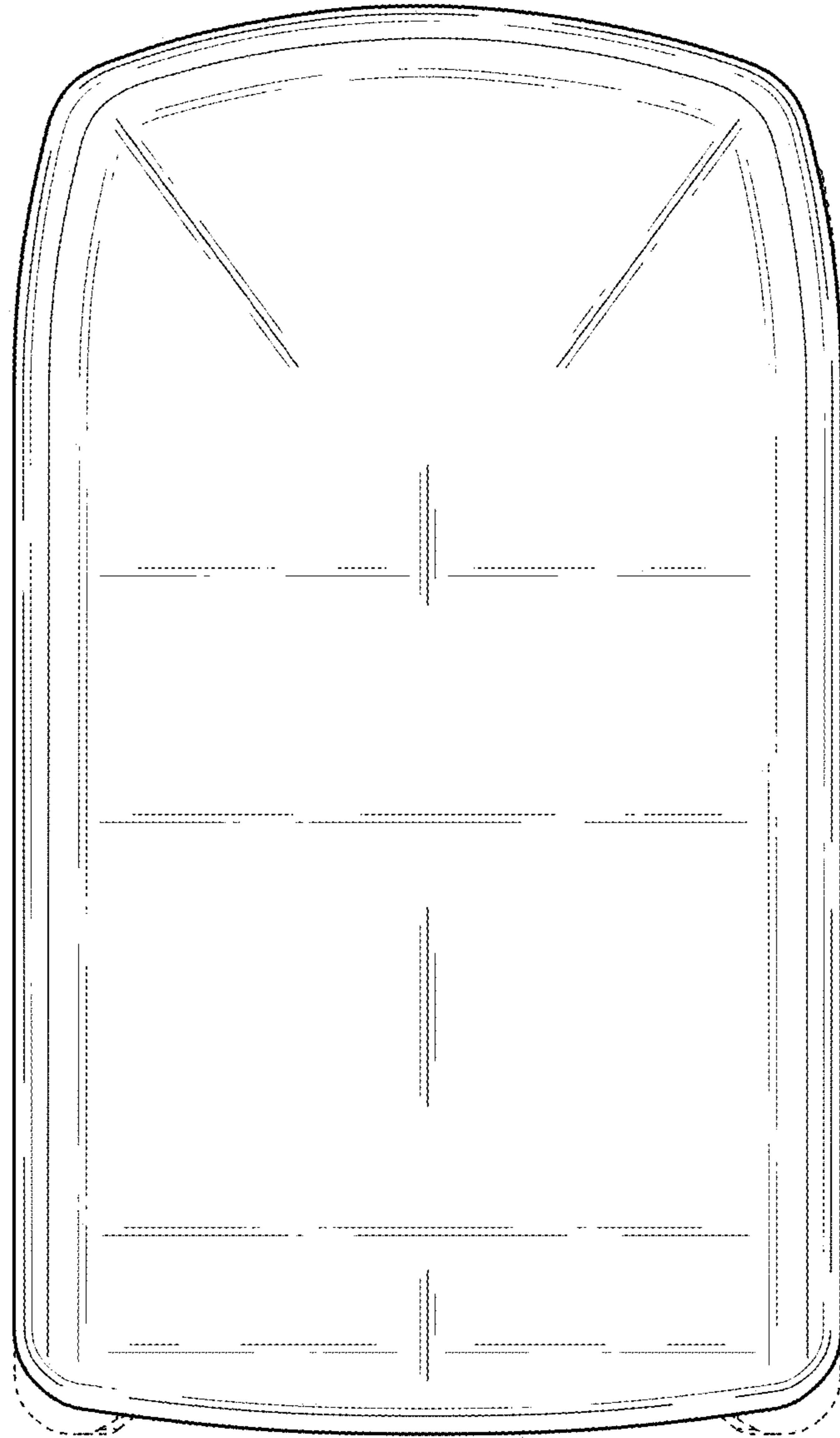

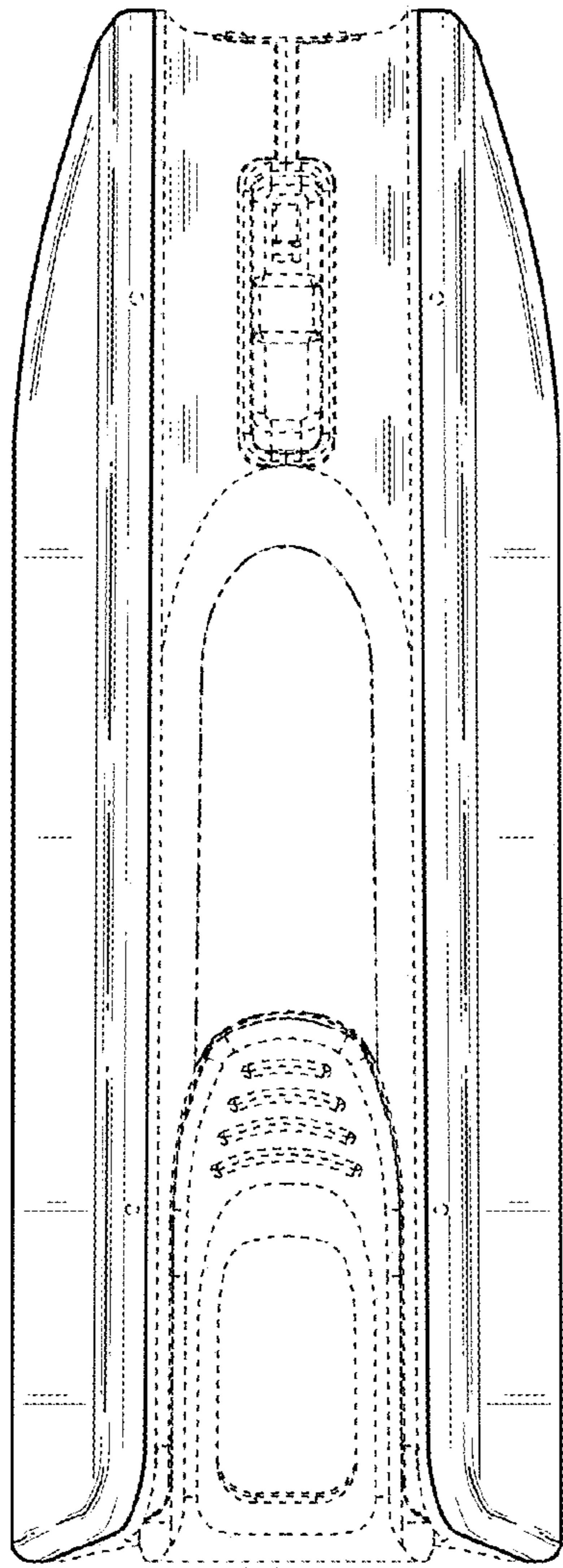

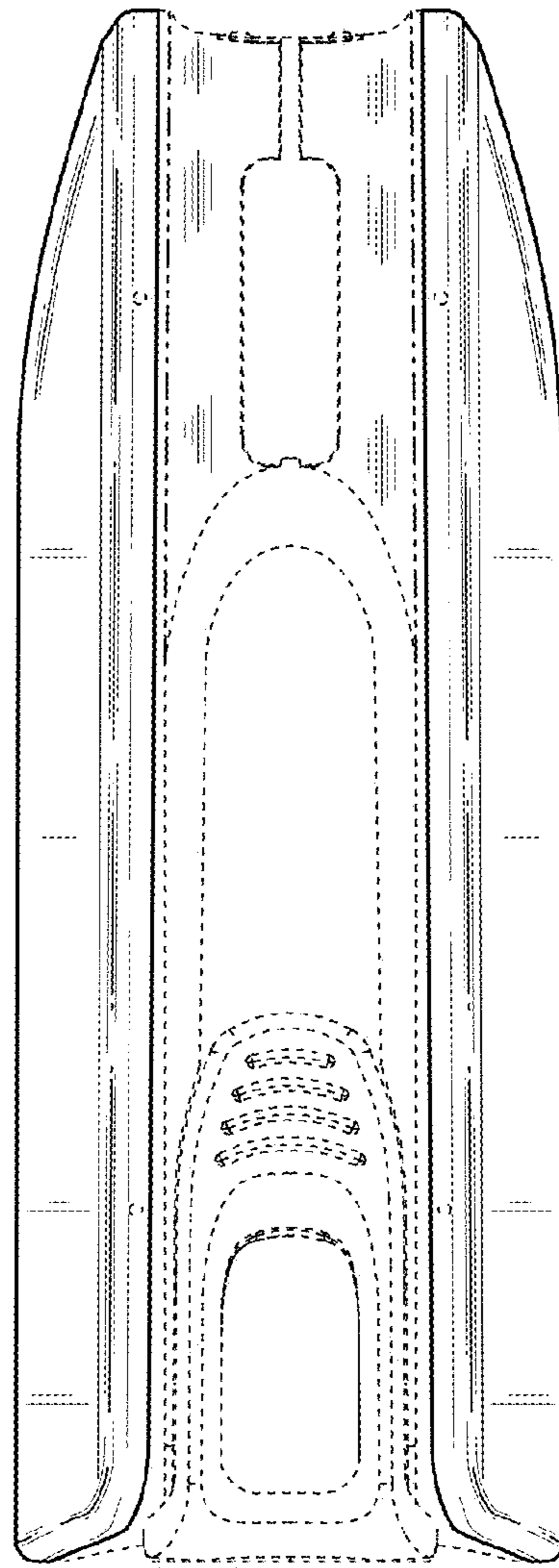

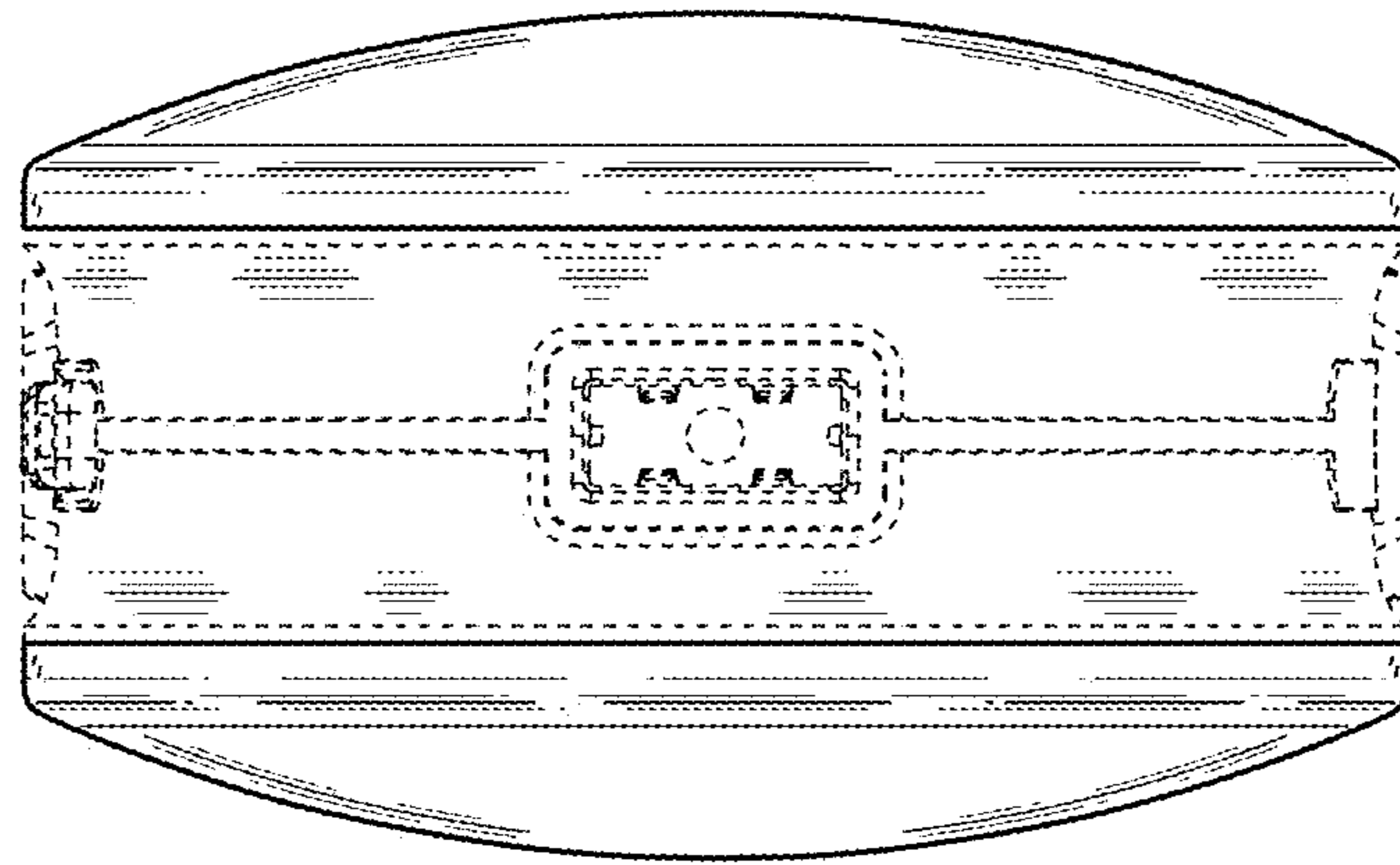

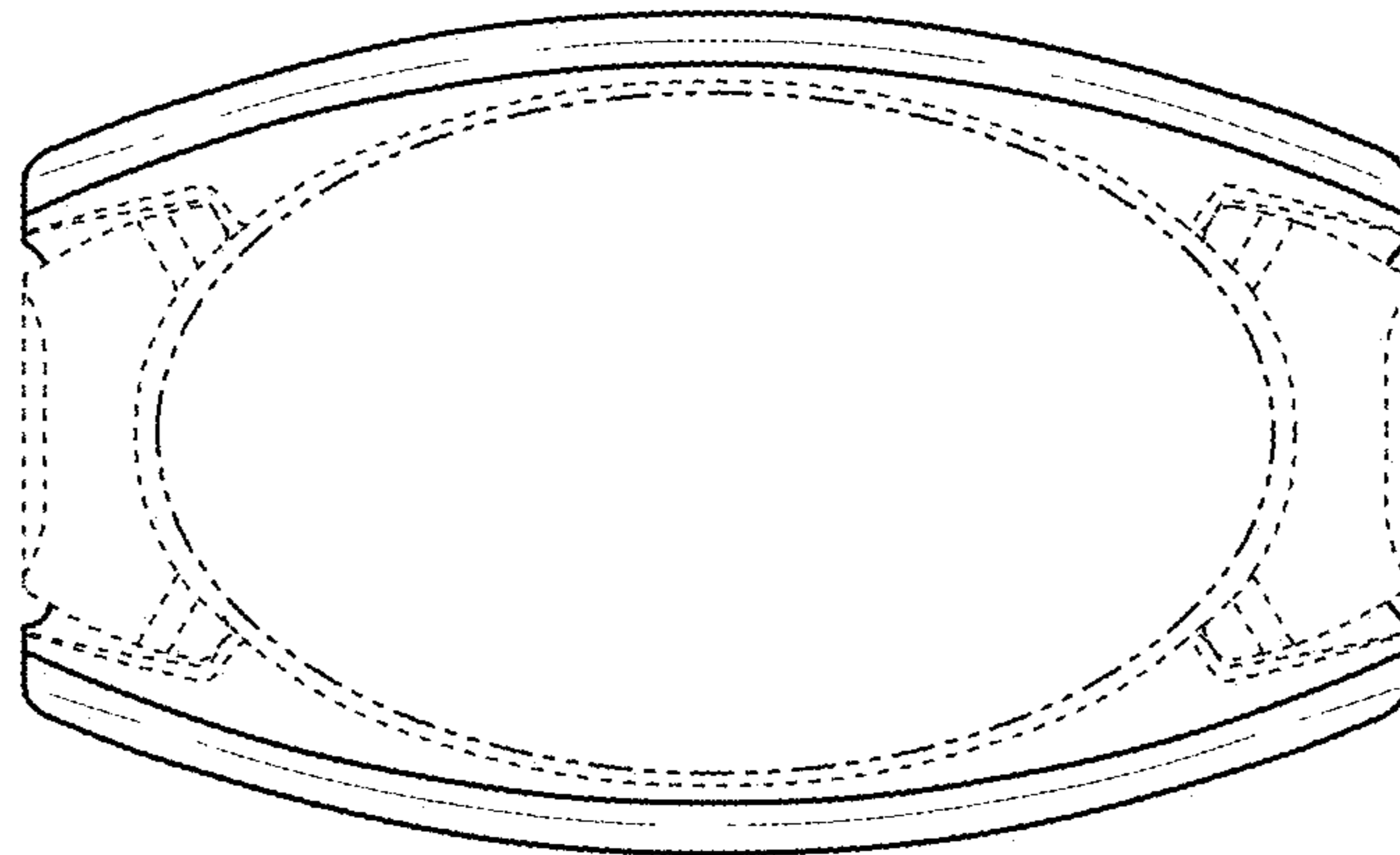
