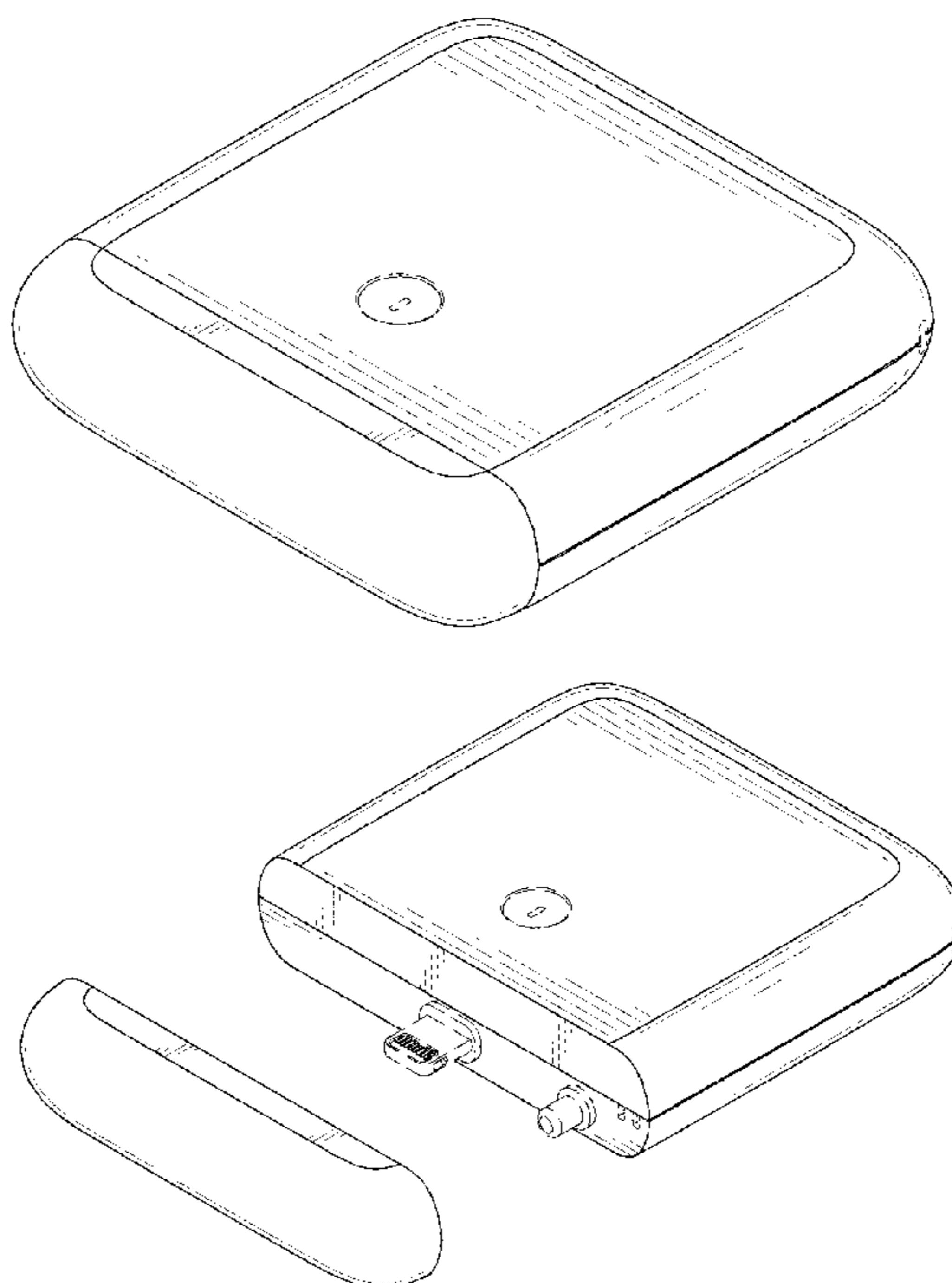
(57) **CLAIM**

The ornamental design for a mobile power pack for electronic device, as shown and described.

**DESCRIPTION**

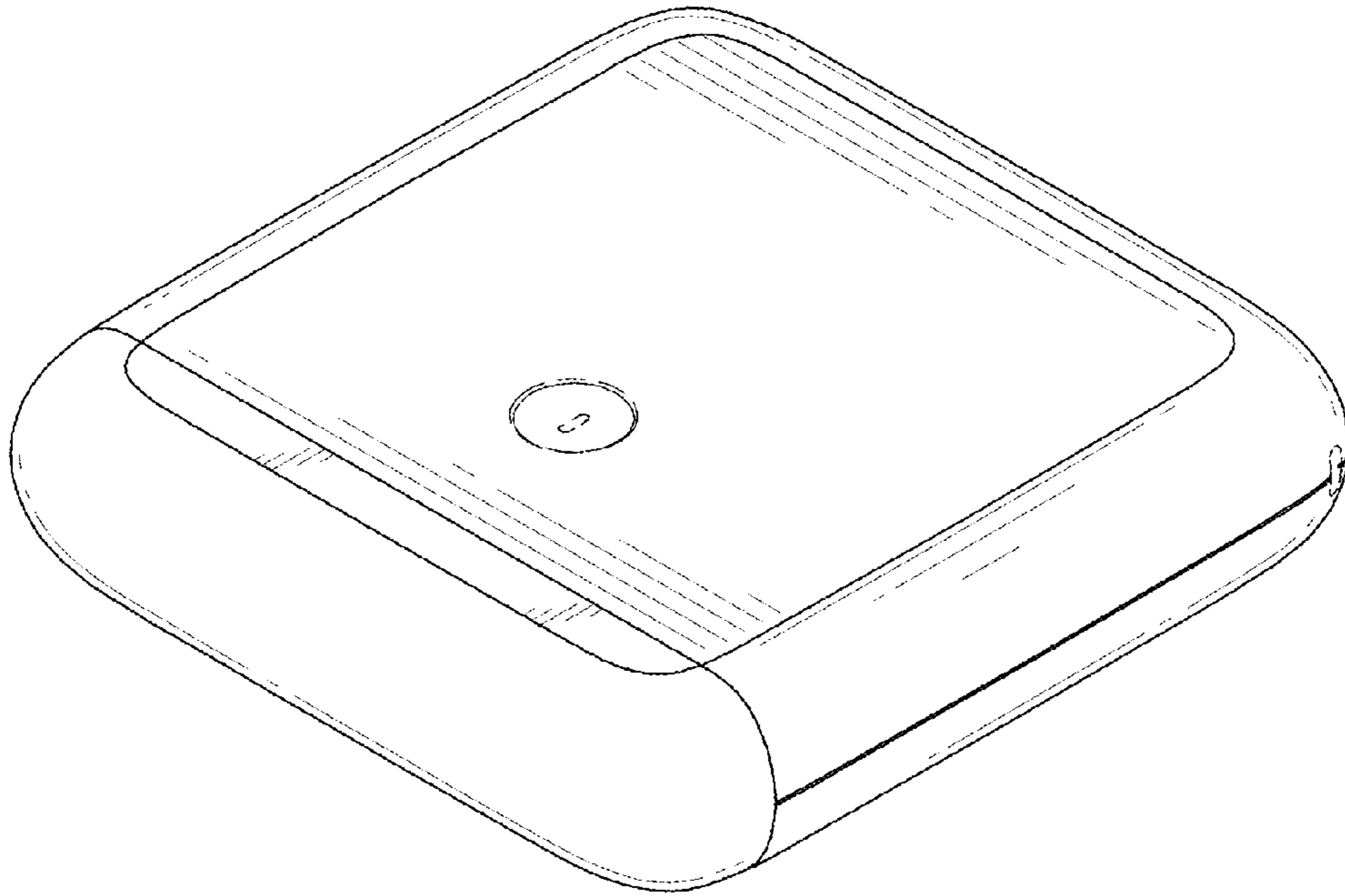

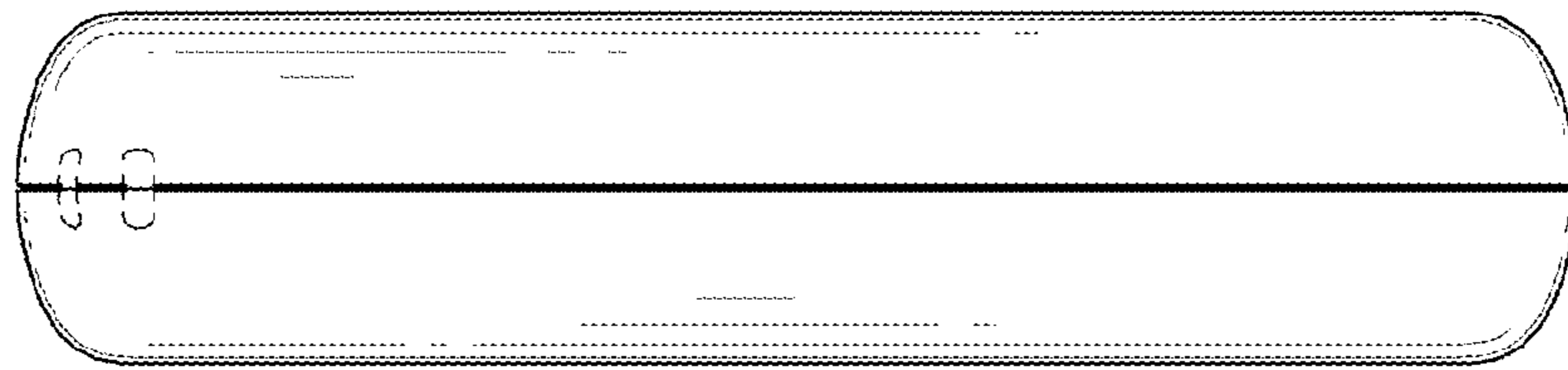

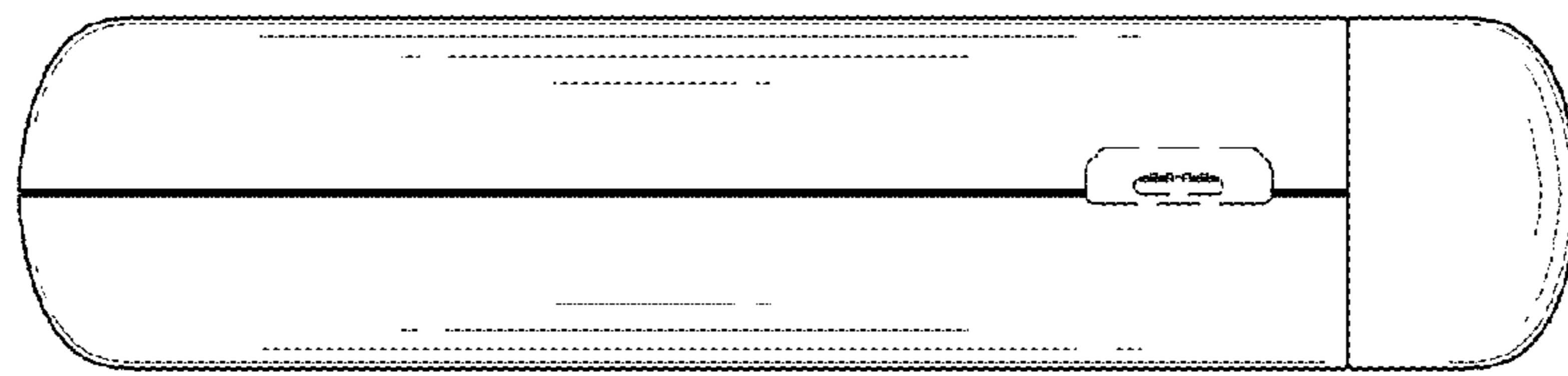

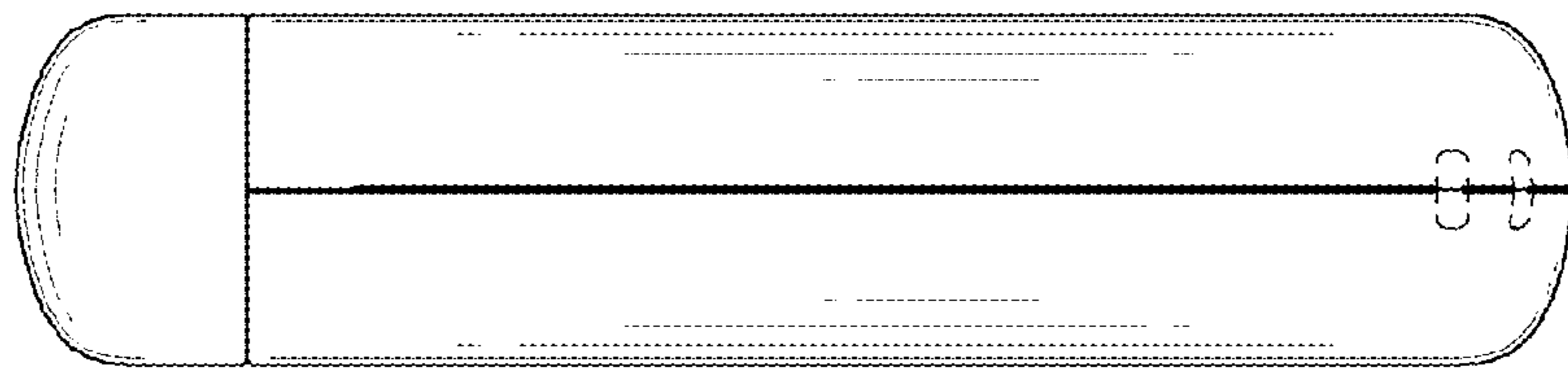

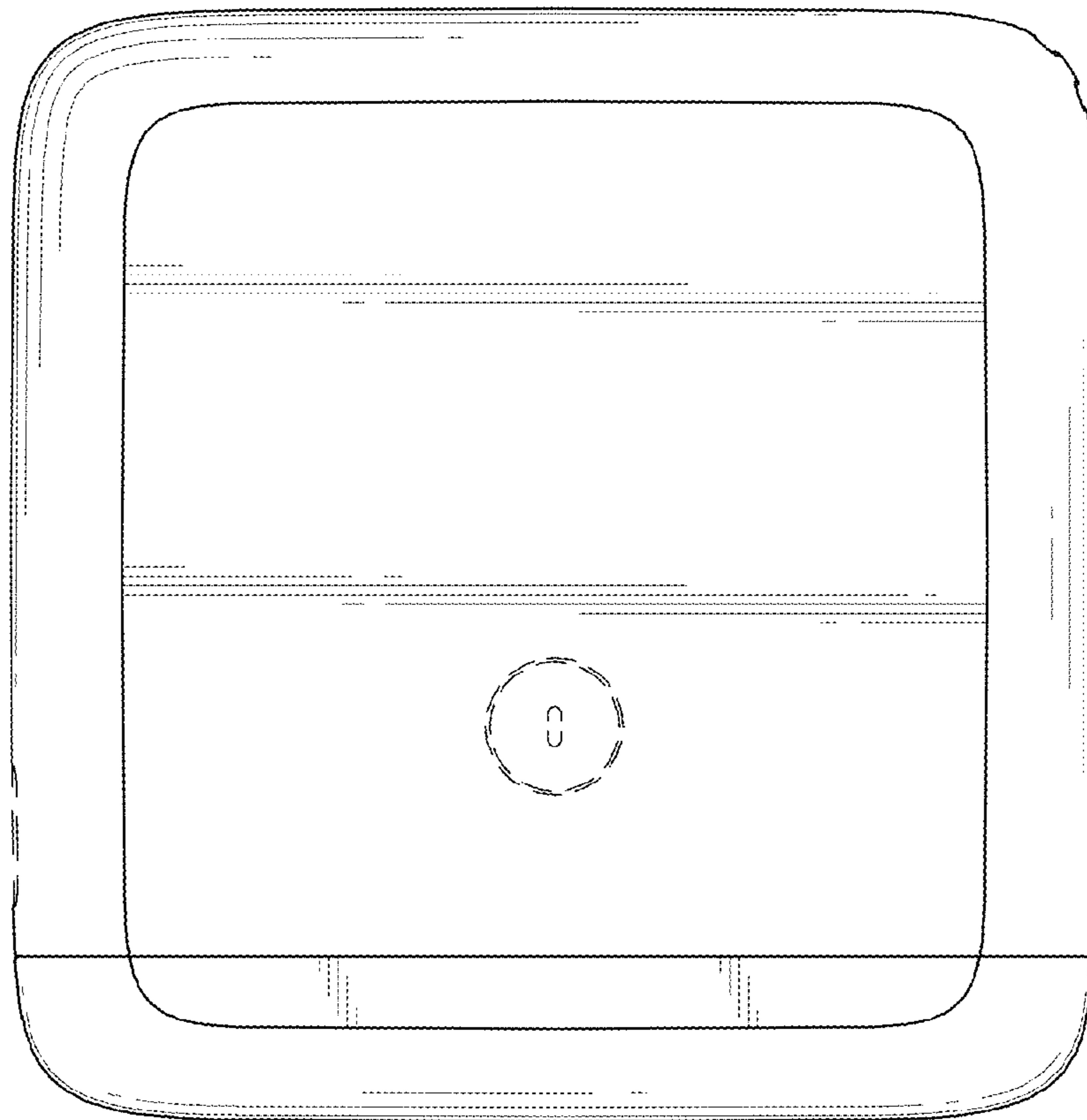

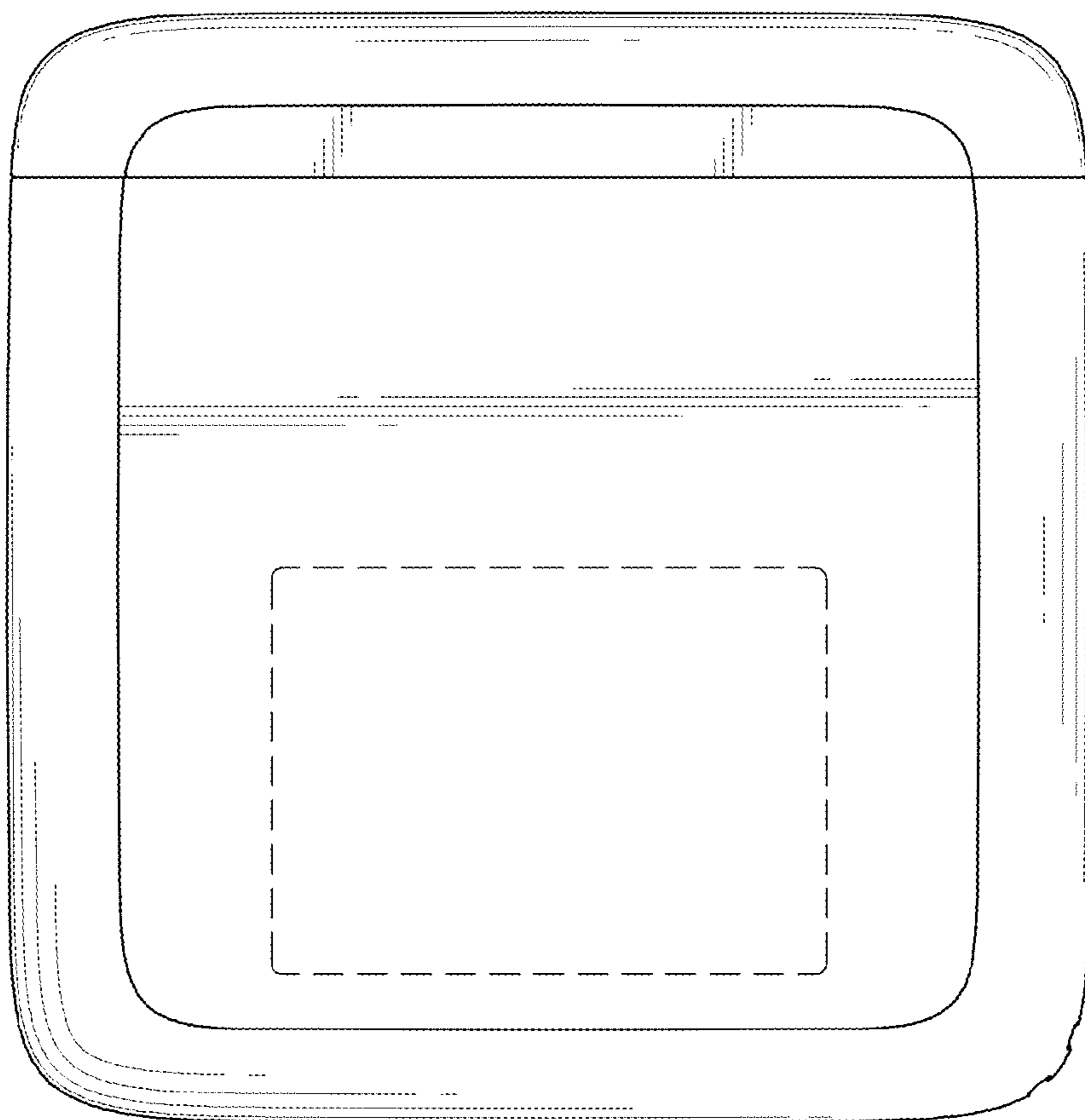

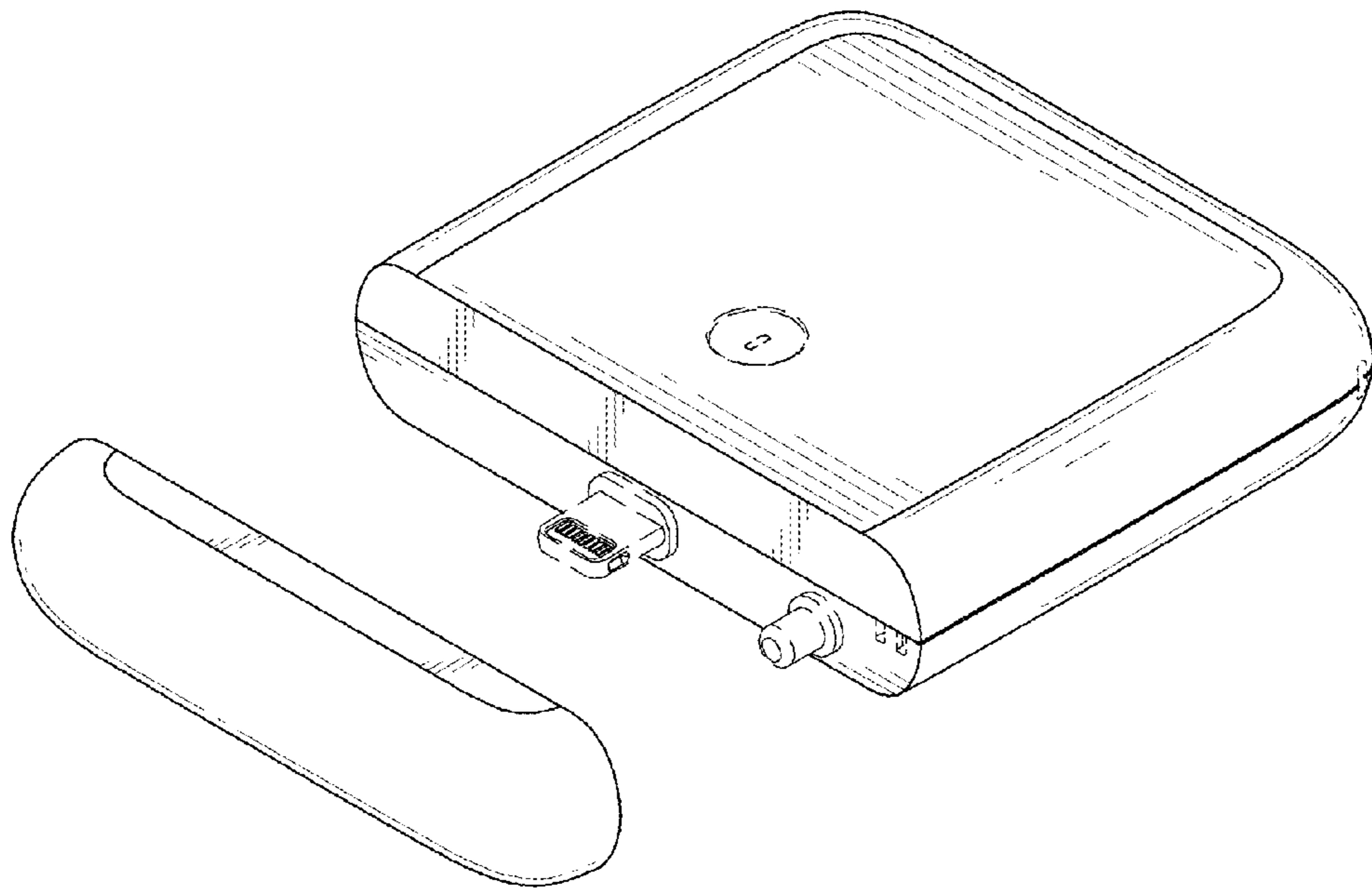
