(57) **CLAIM**

We claim the ornamental design for a TV receiver, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a TV receiver showing our new design;

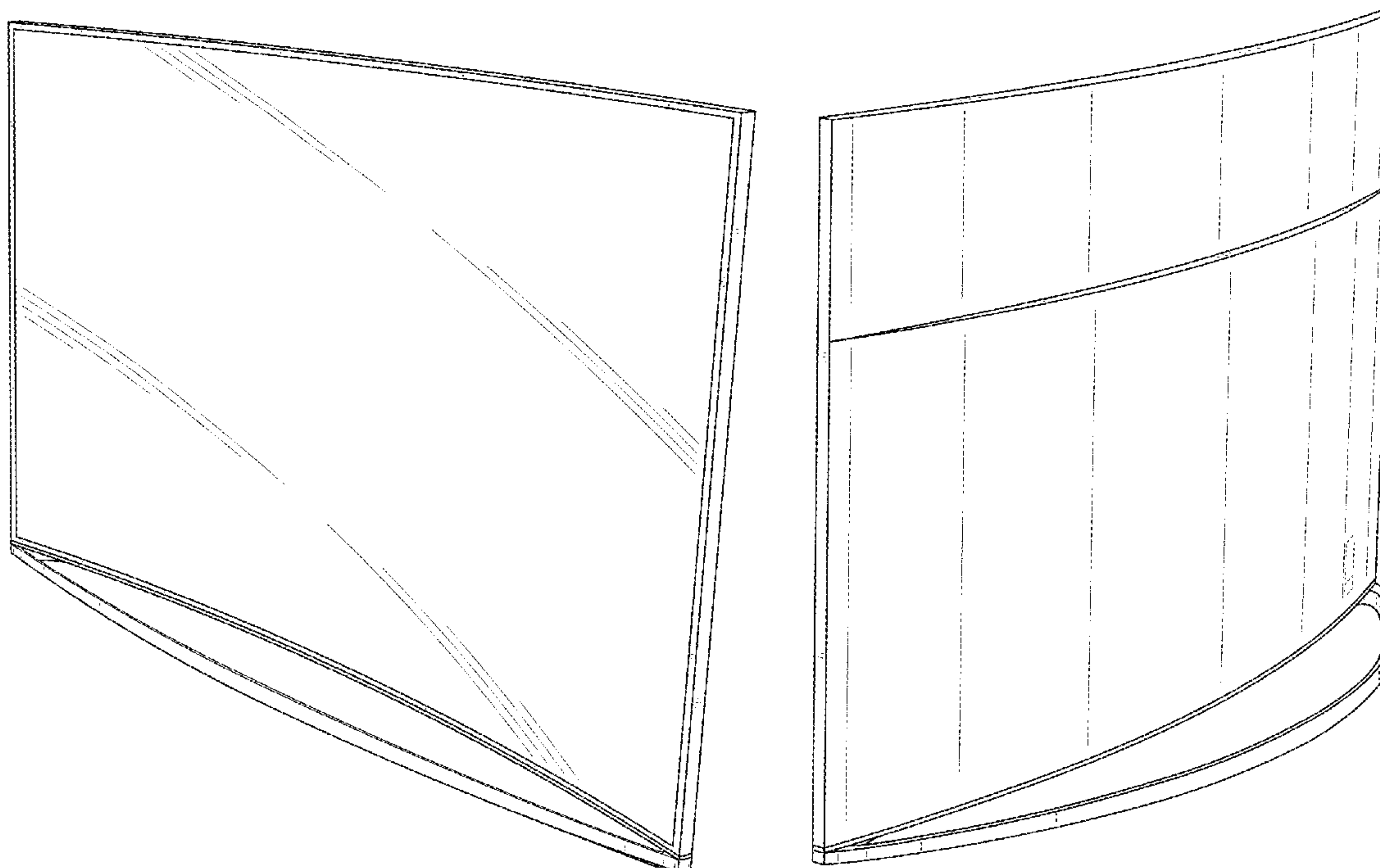

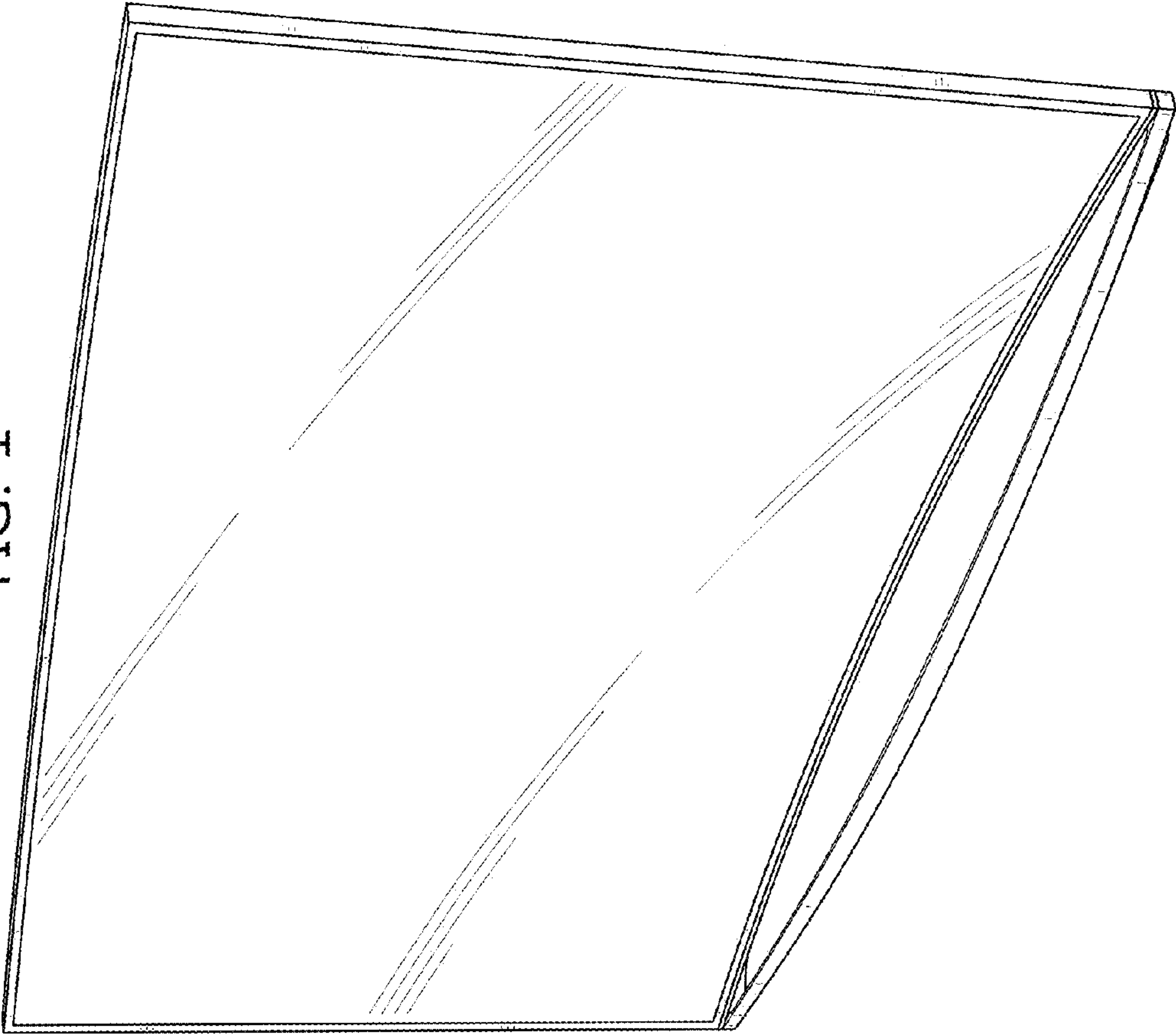

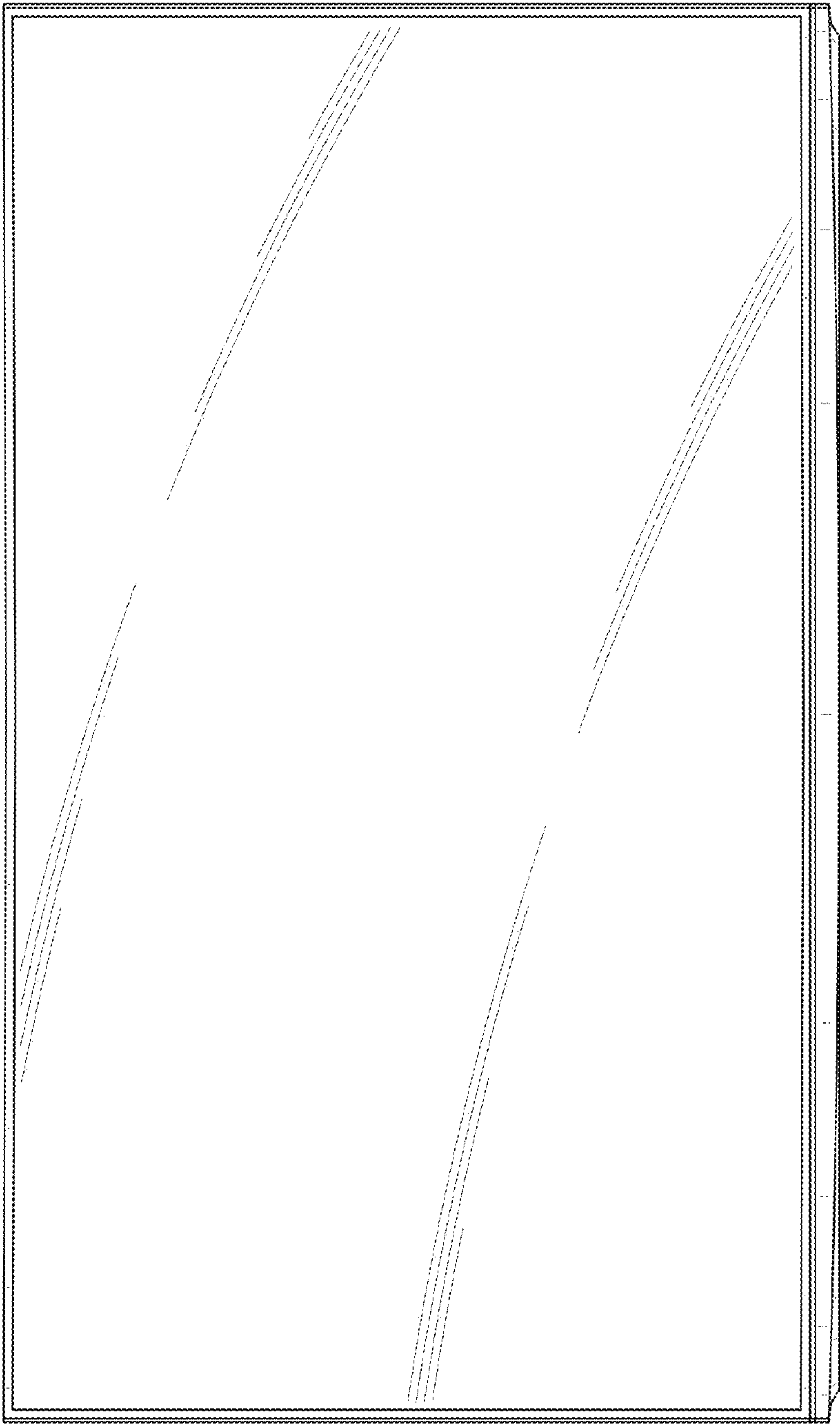

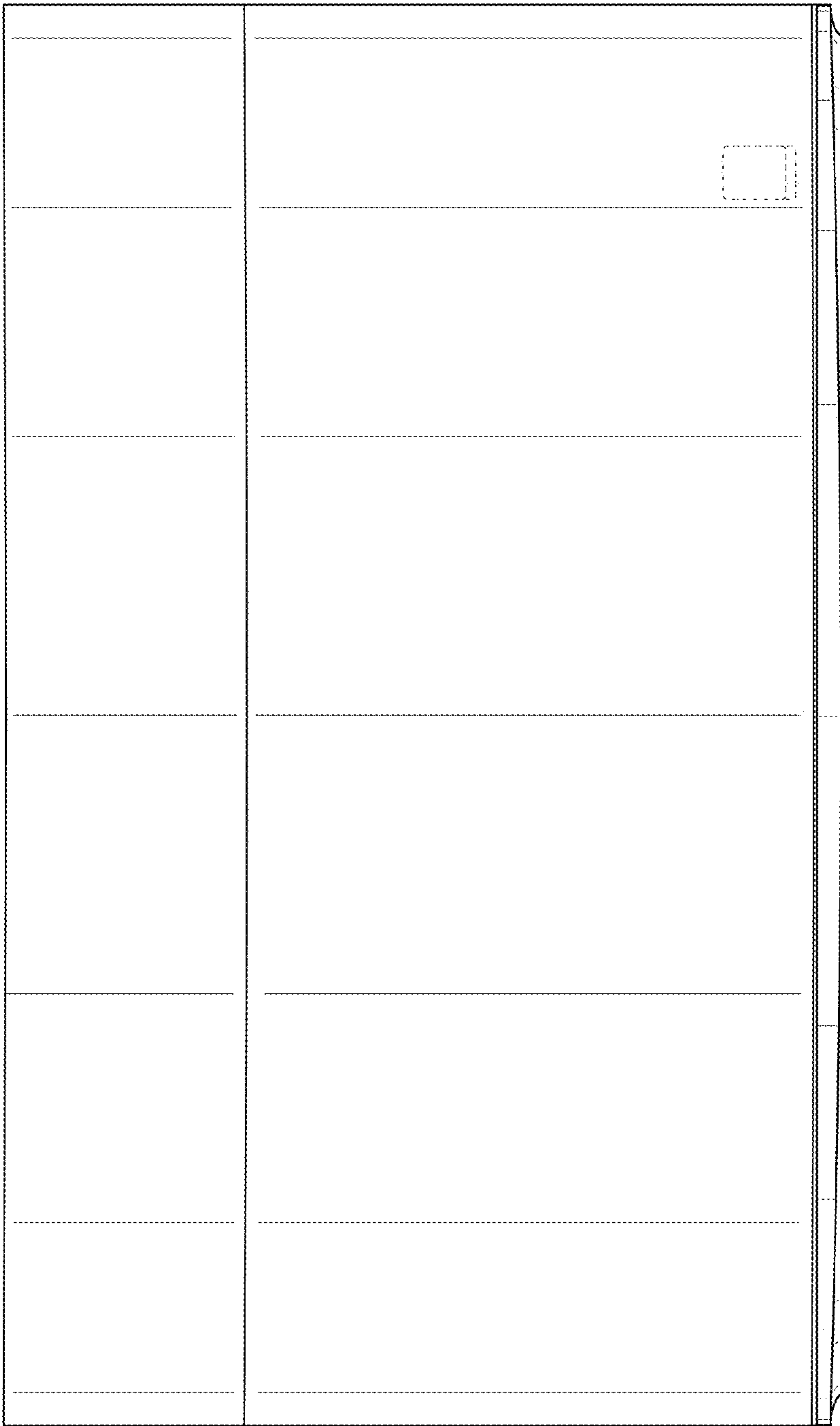

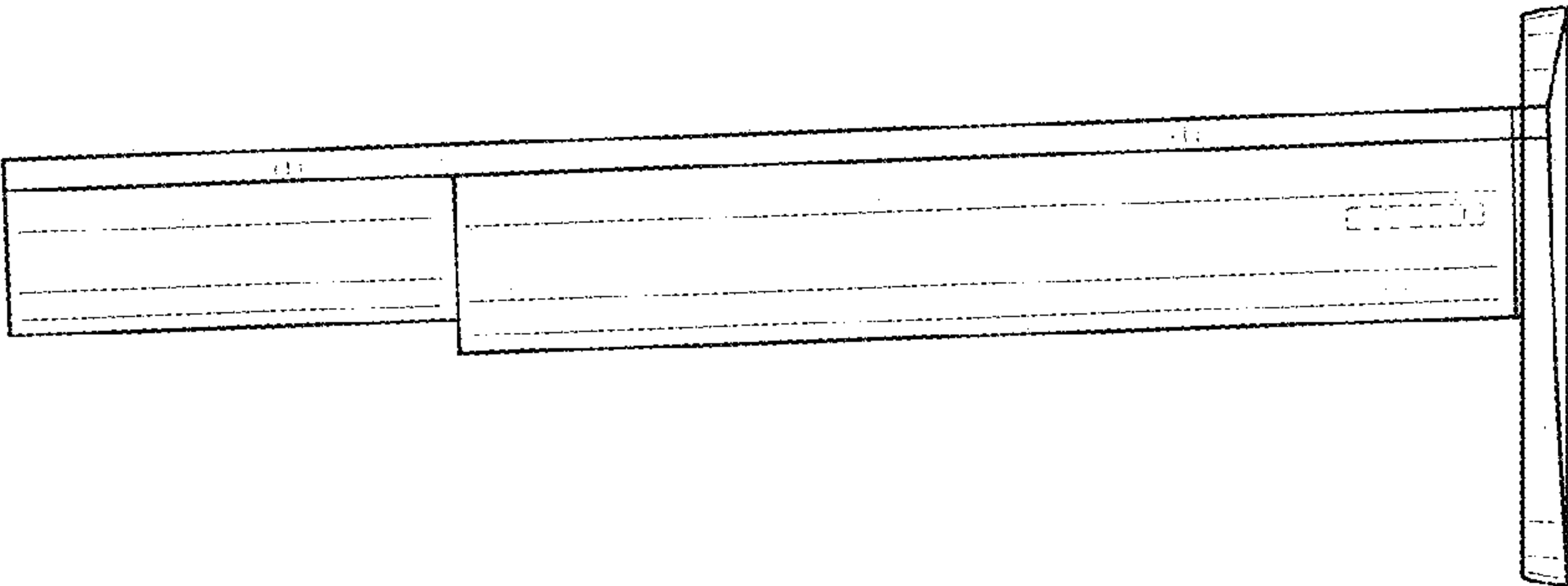

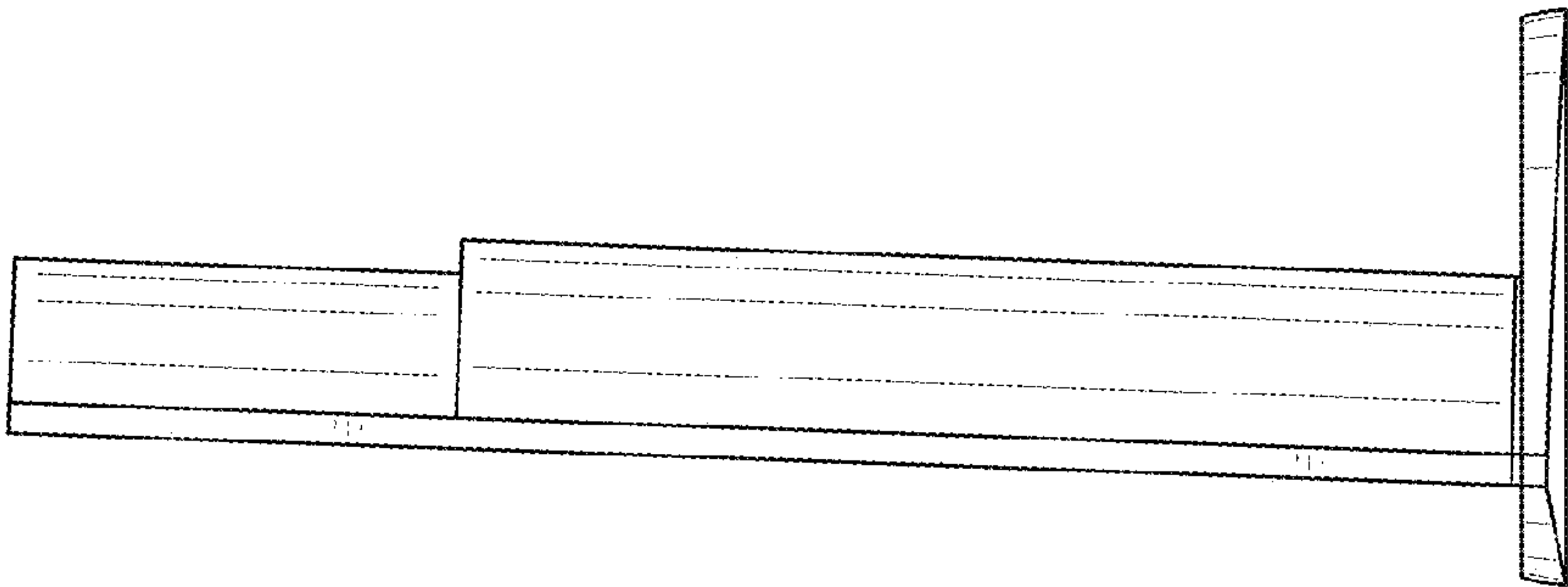

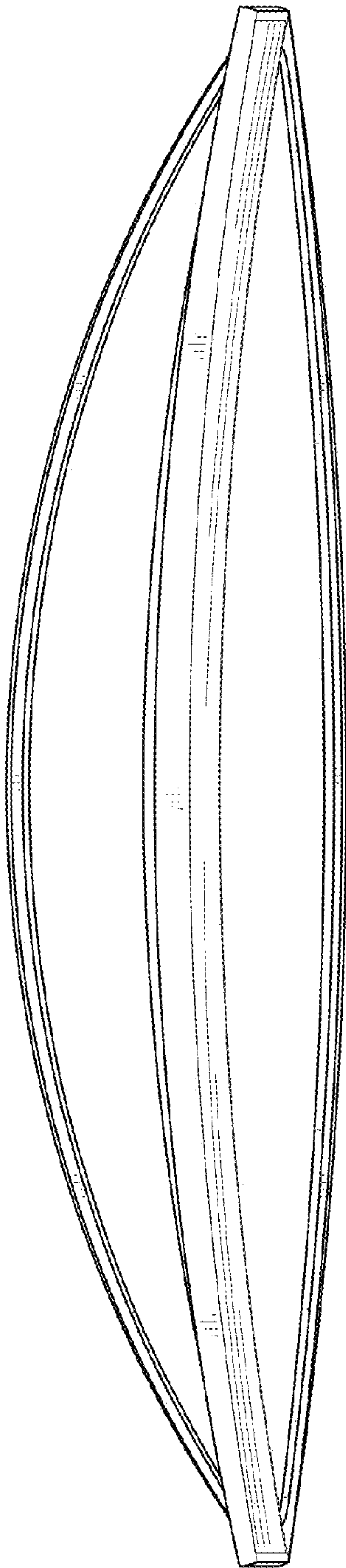
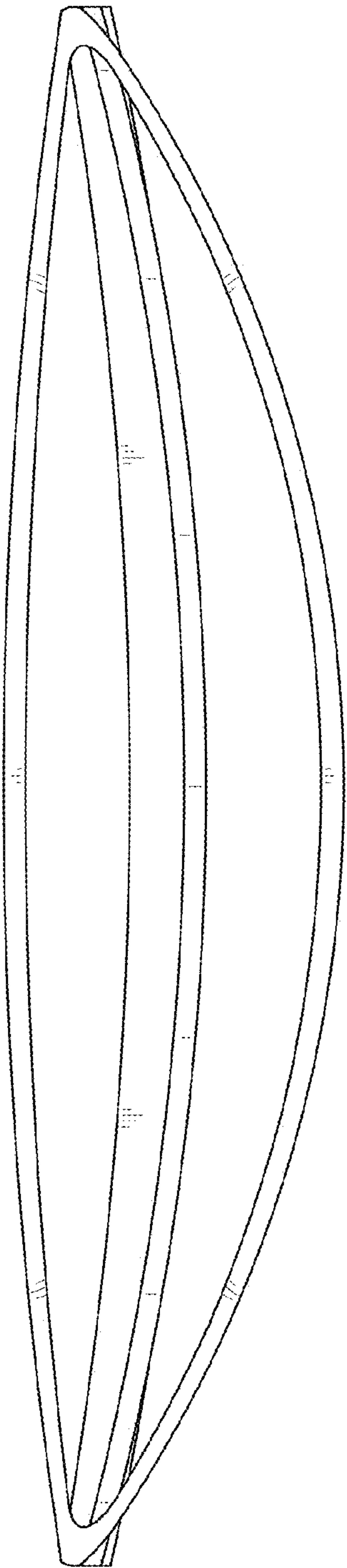

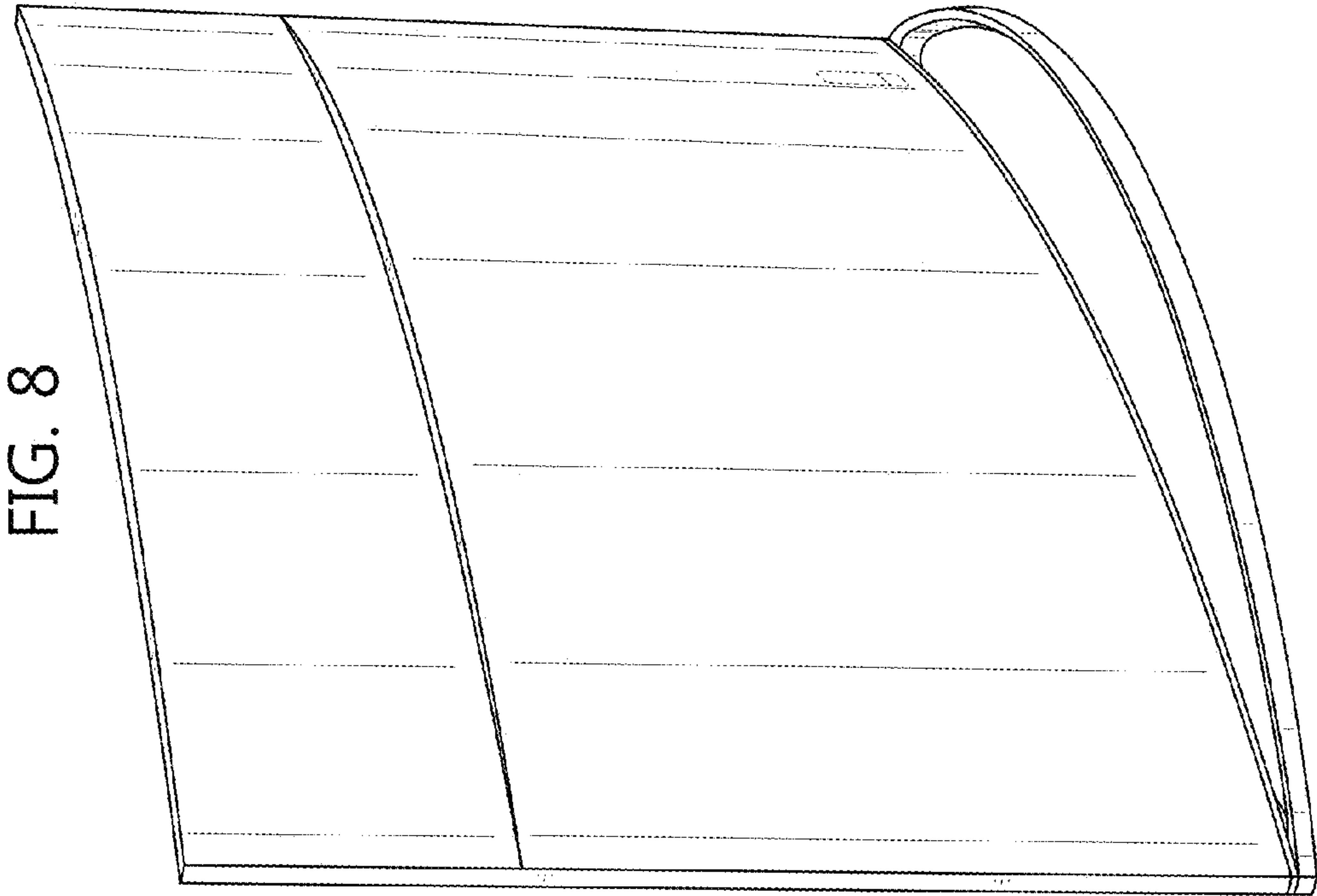
