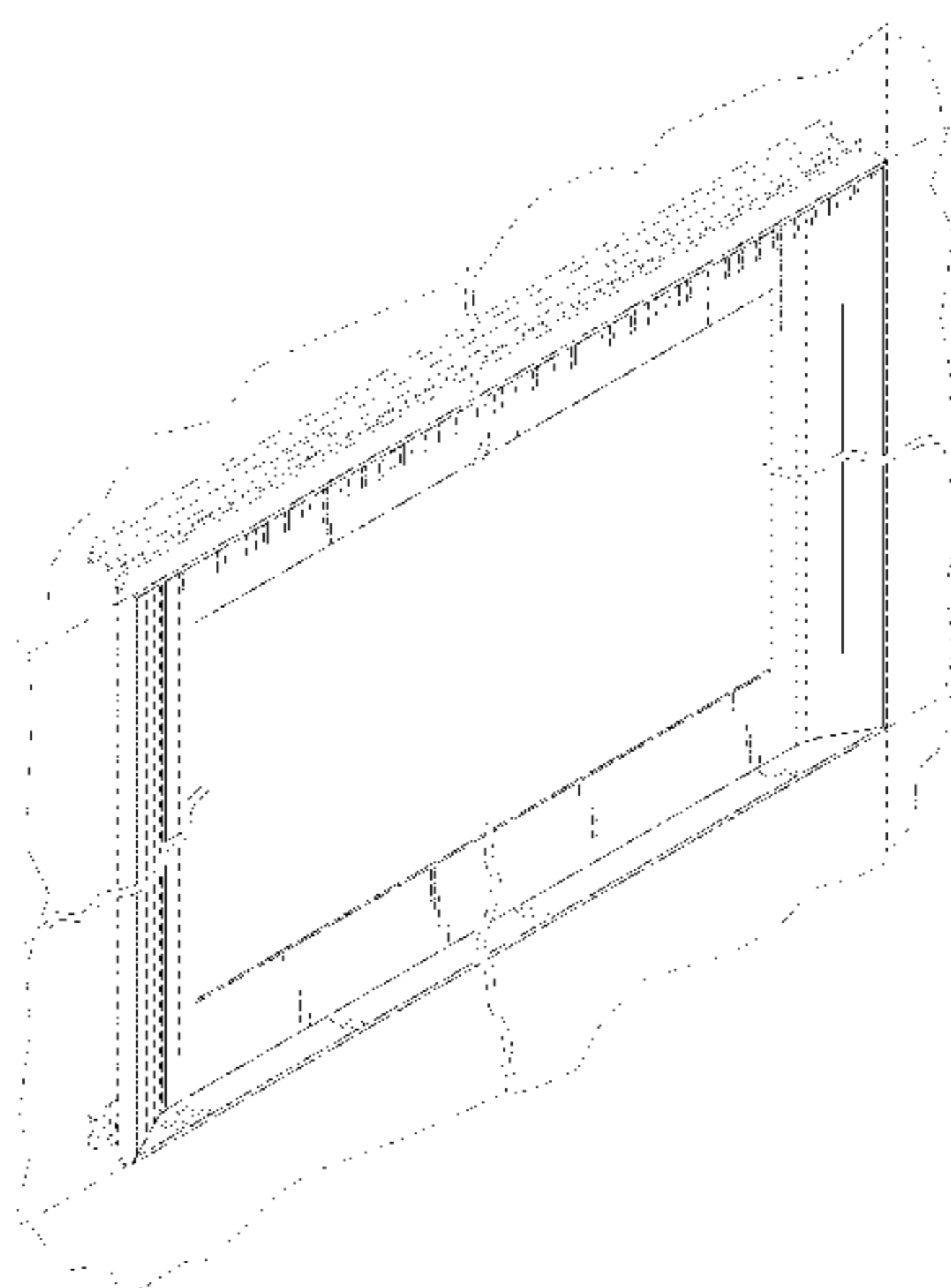
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of a display screen mount, showing our new design;

 FIG. 11 is a front elevational view thereof;

 FIG. 13 is a left side view thereof;
 FIG. 14 is right side view thereof;
 FIG. 15 is a top plan view thereof; and,
 FIG. 16 is a bottom plan view thereof.

 The broken away symbols in the drawings indicate that any portion of the display screen mount beyond what is shown forms no part of the claimed design.

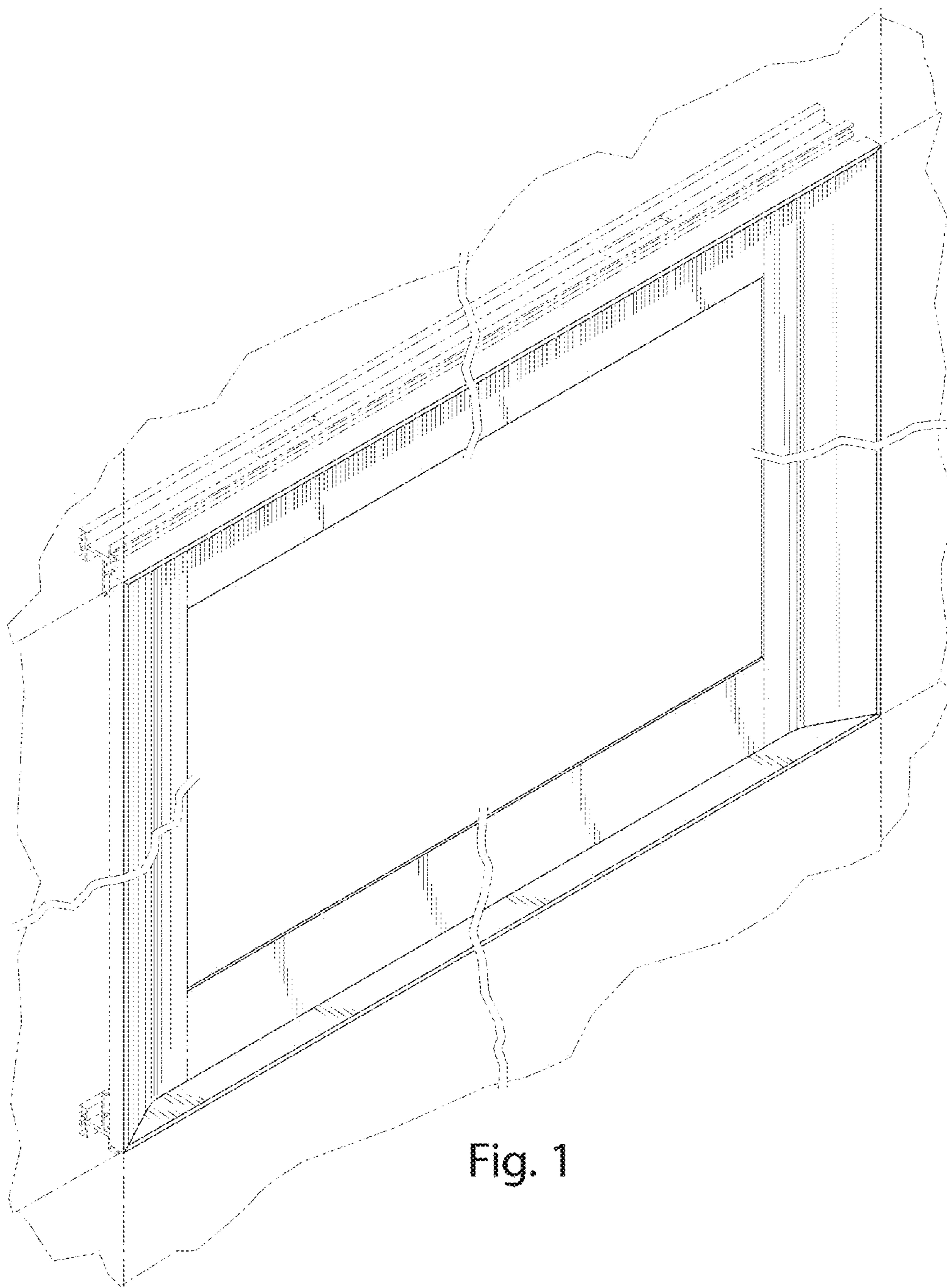

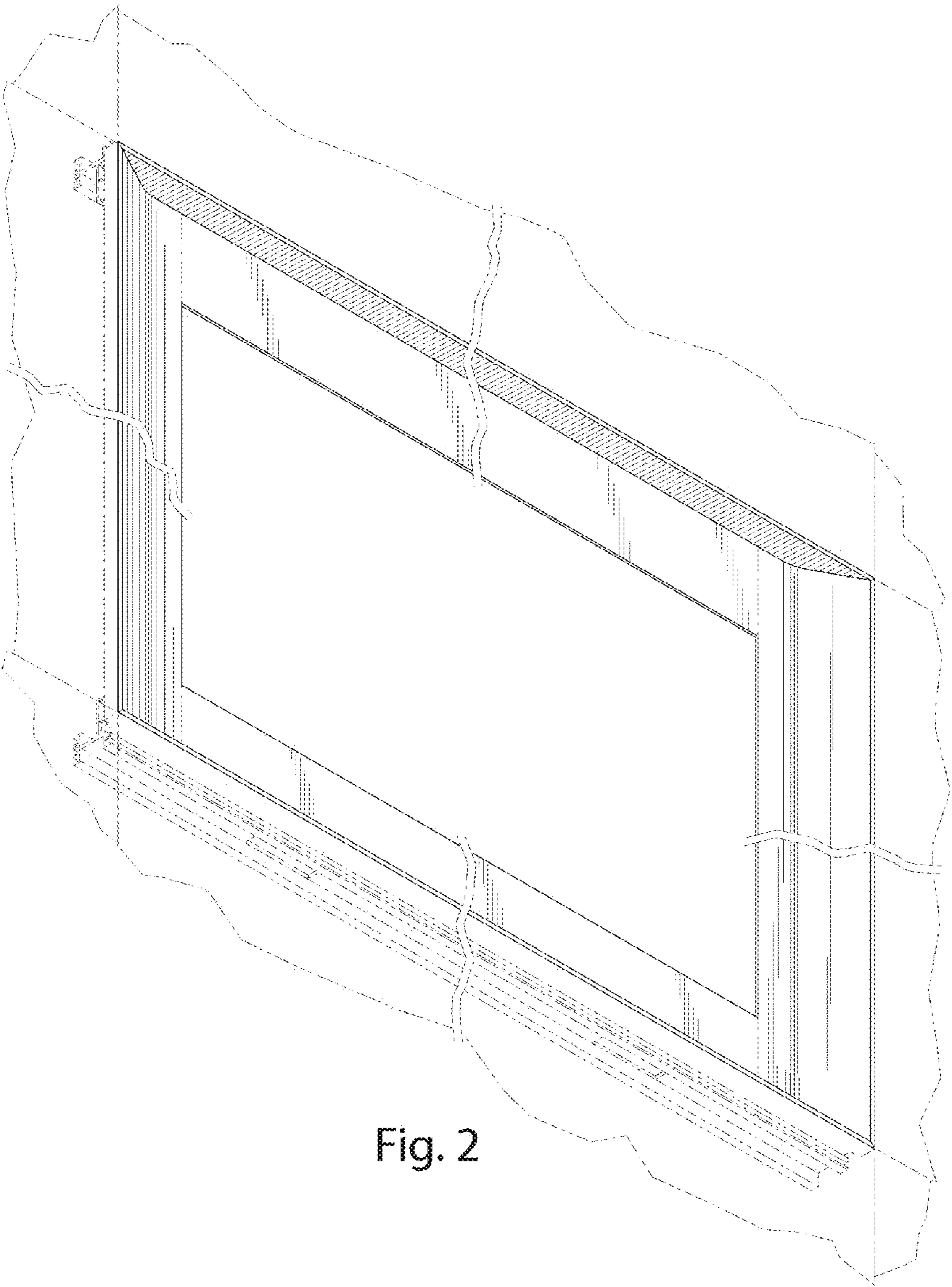

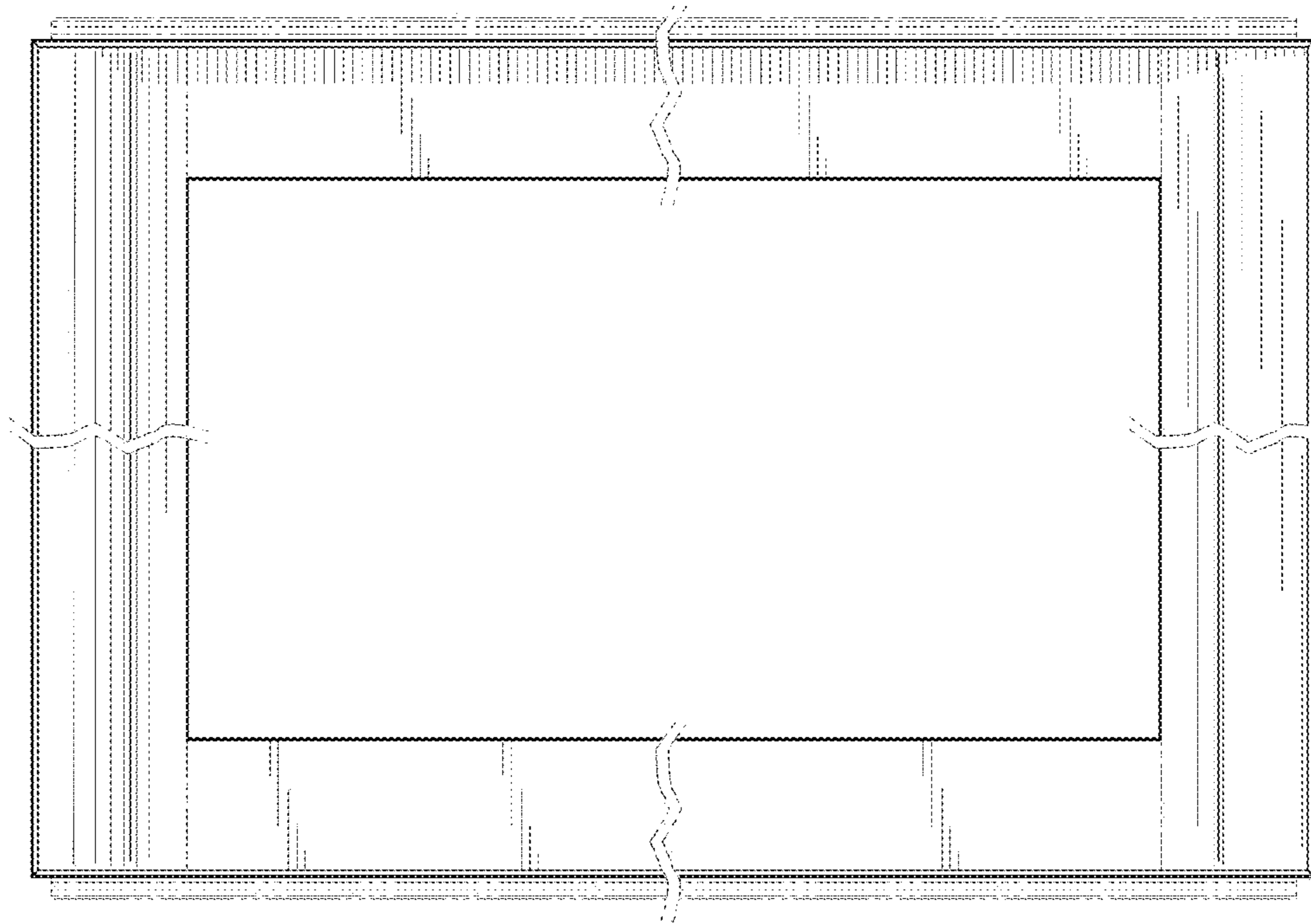

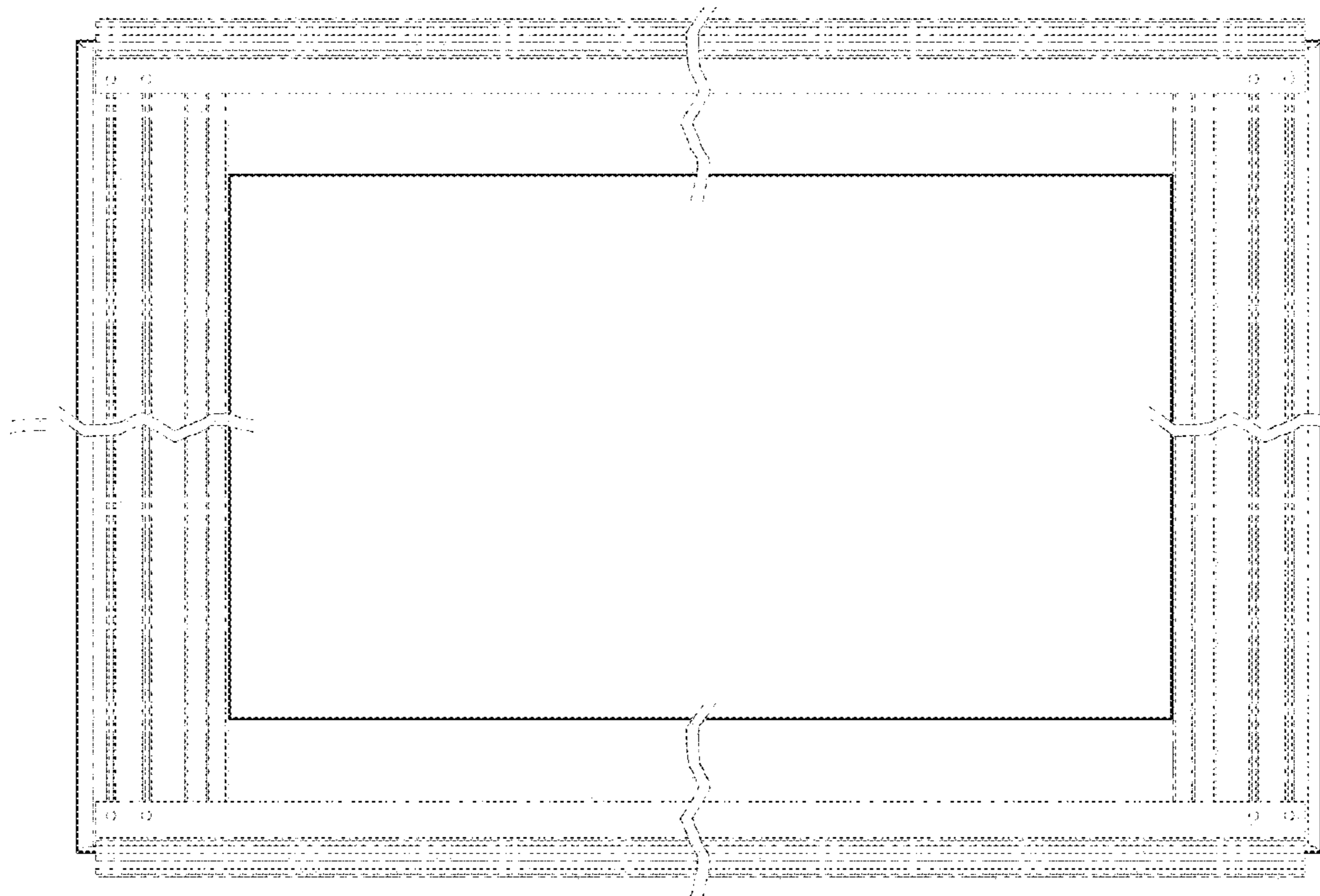

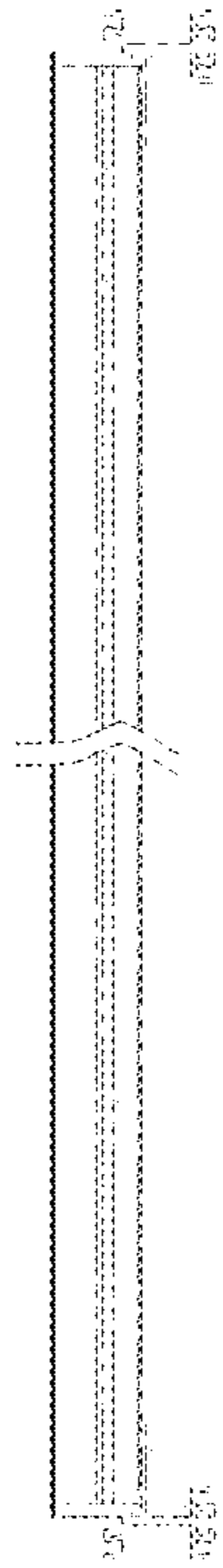

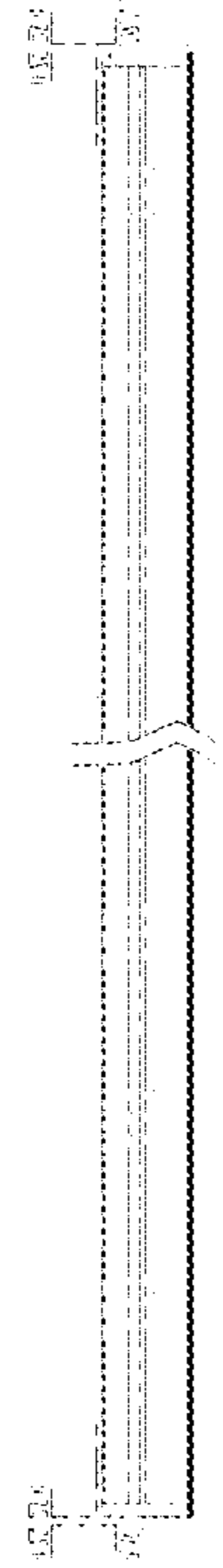

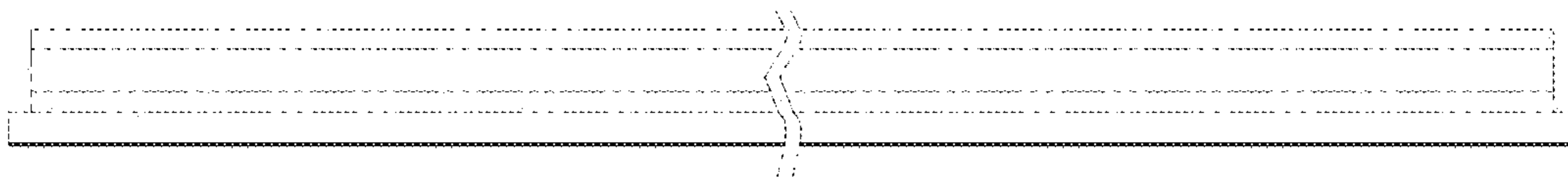

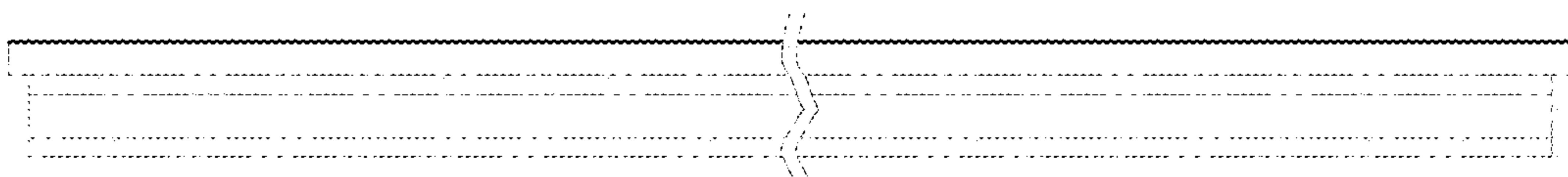

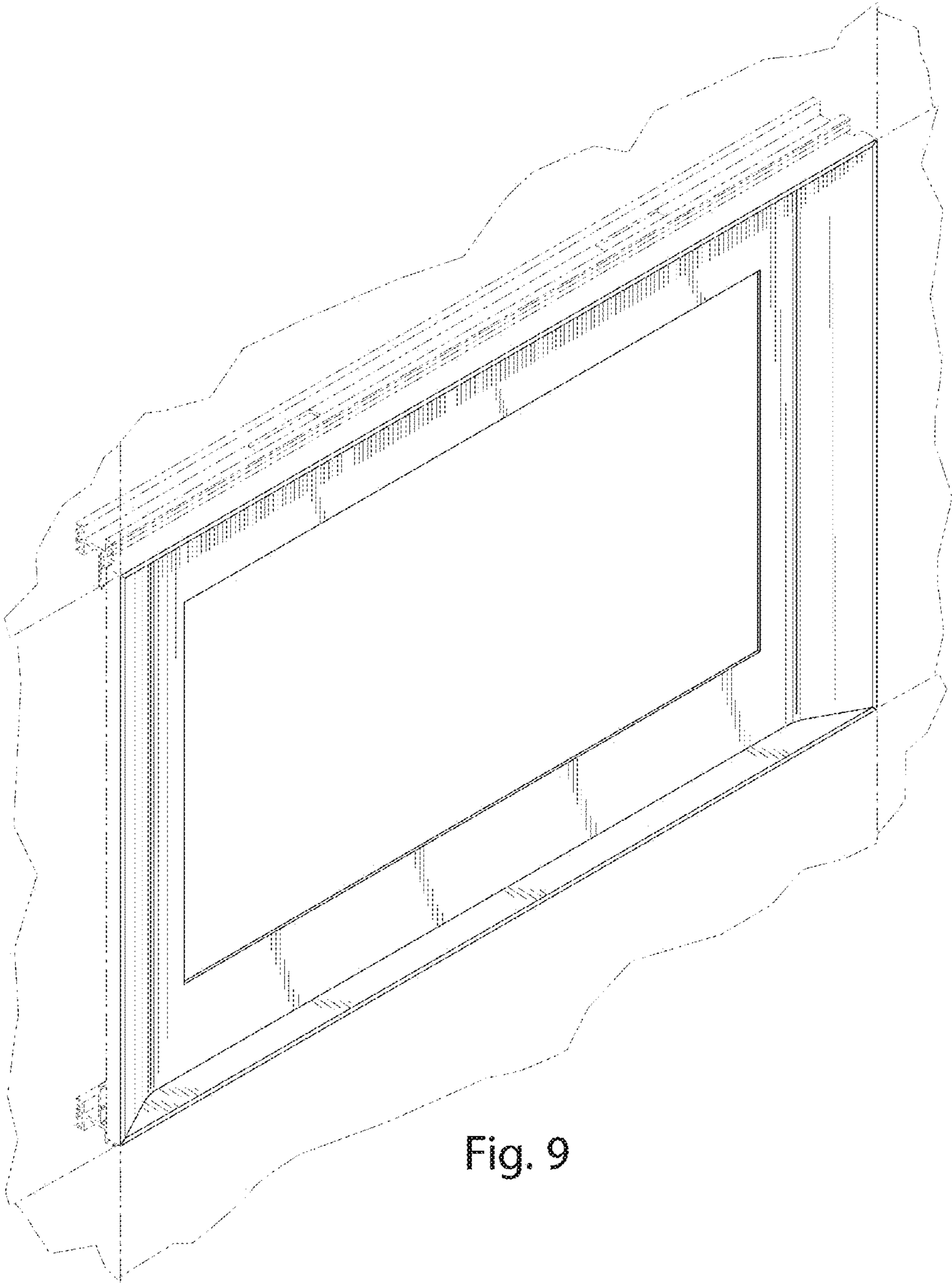

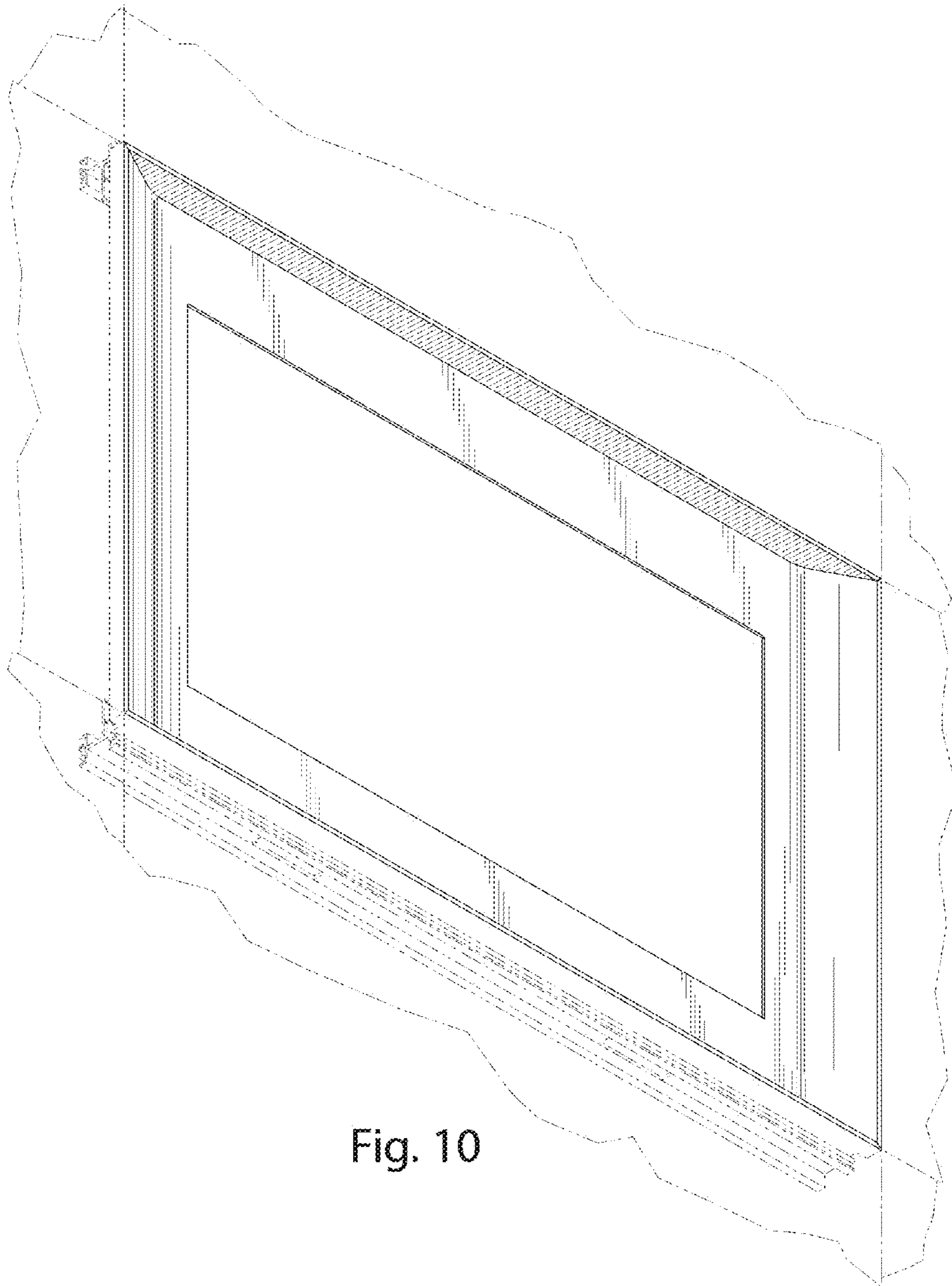

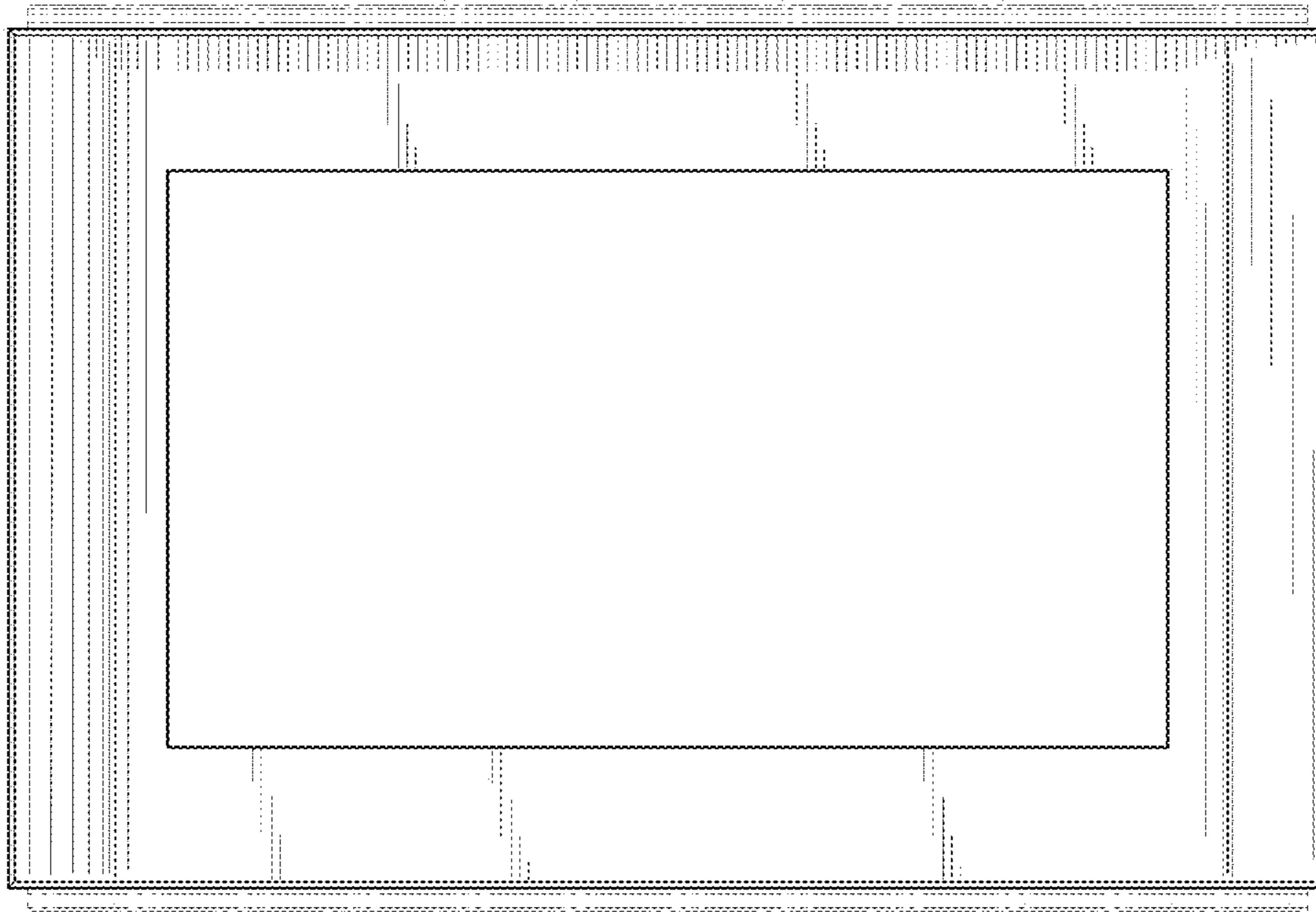

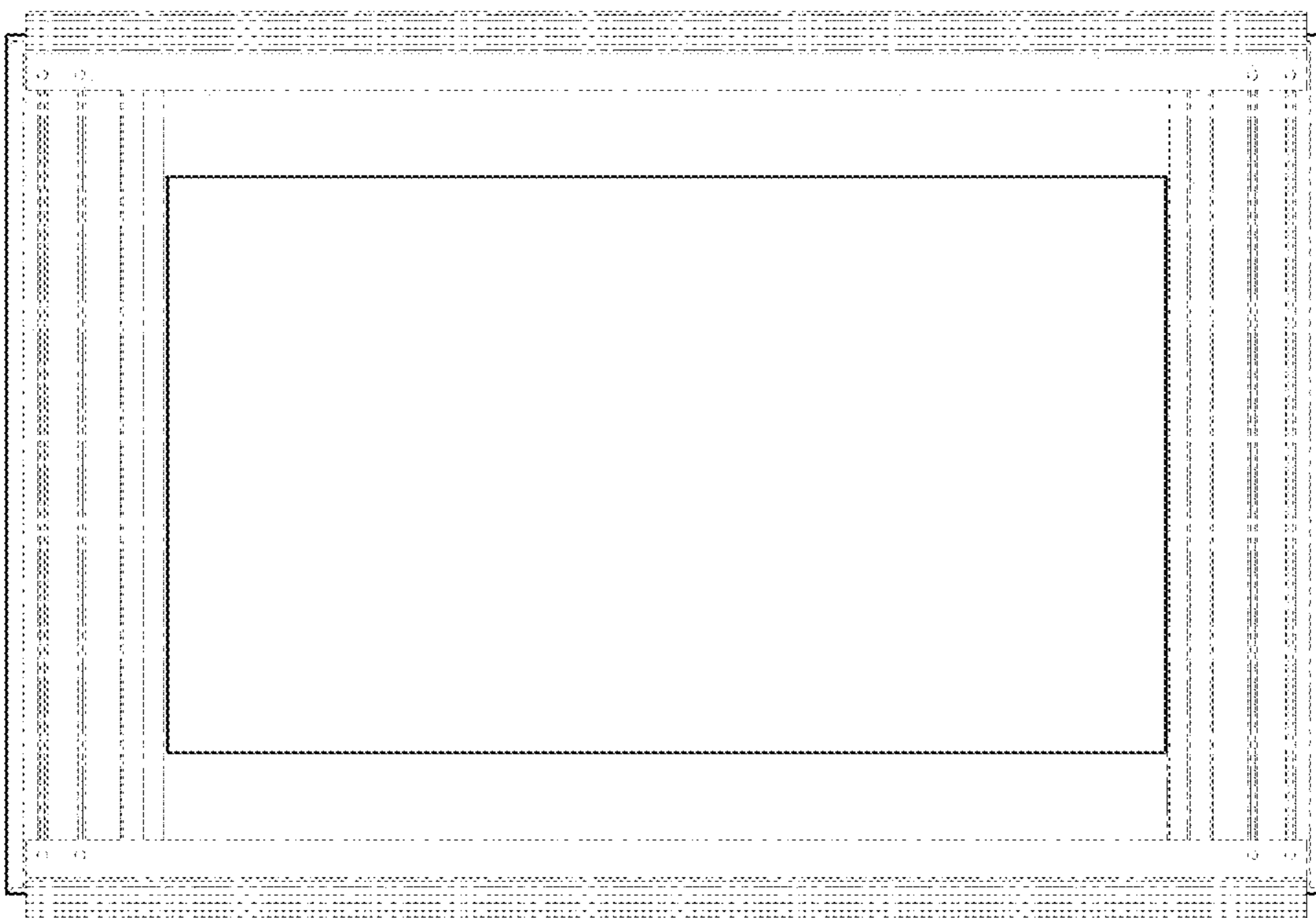

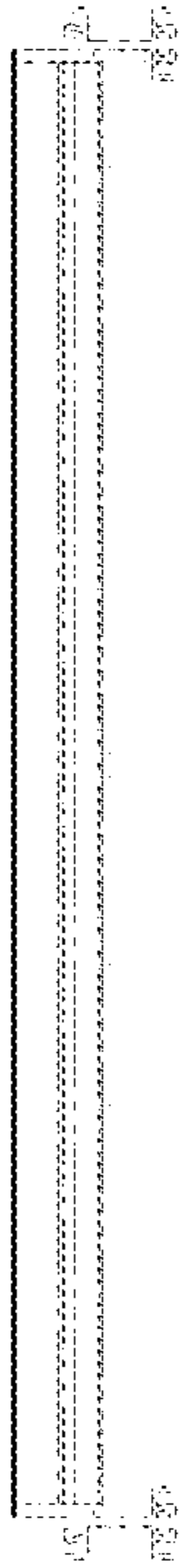

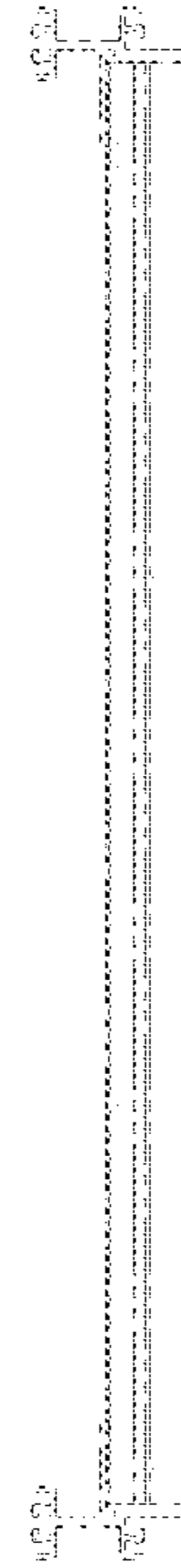

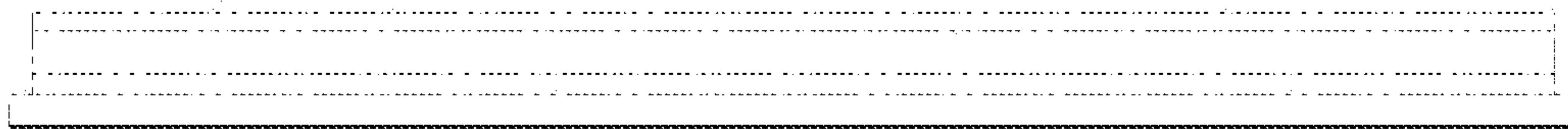

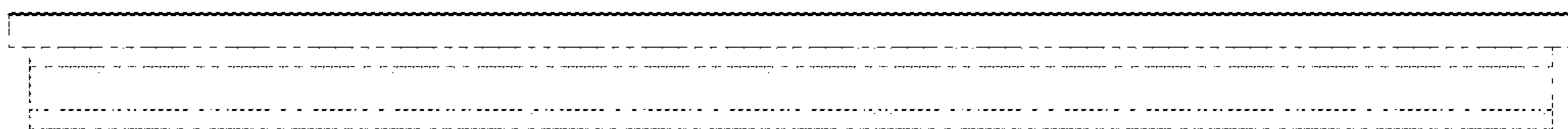
