FIG. 9 is a front perspective view of a fourth embodiment of a case embodying my new design.

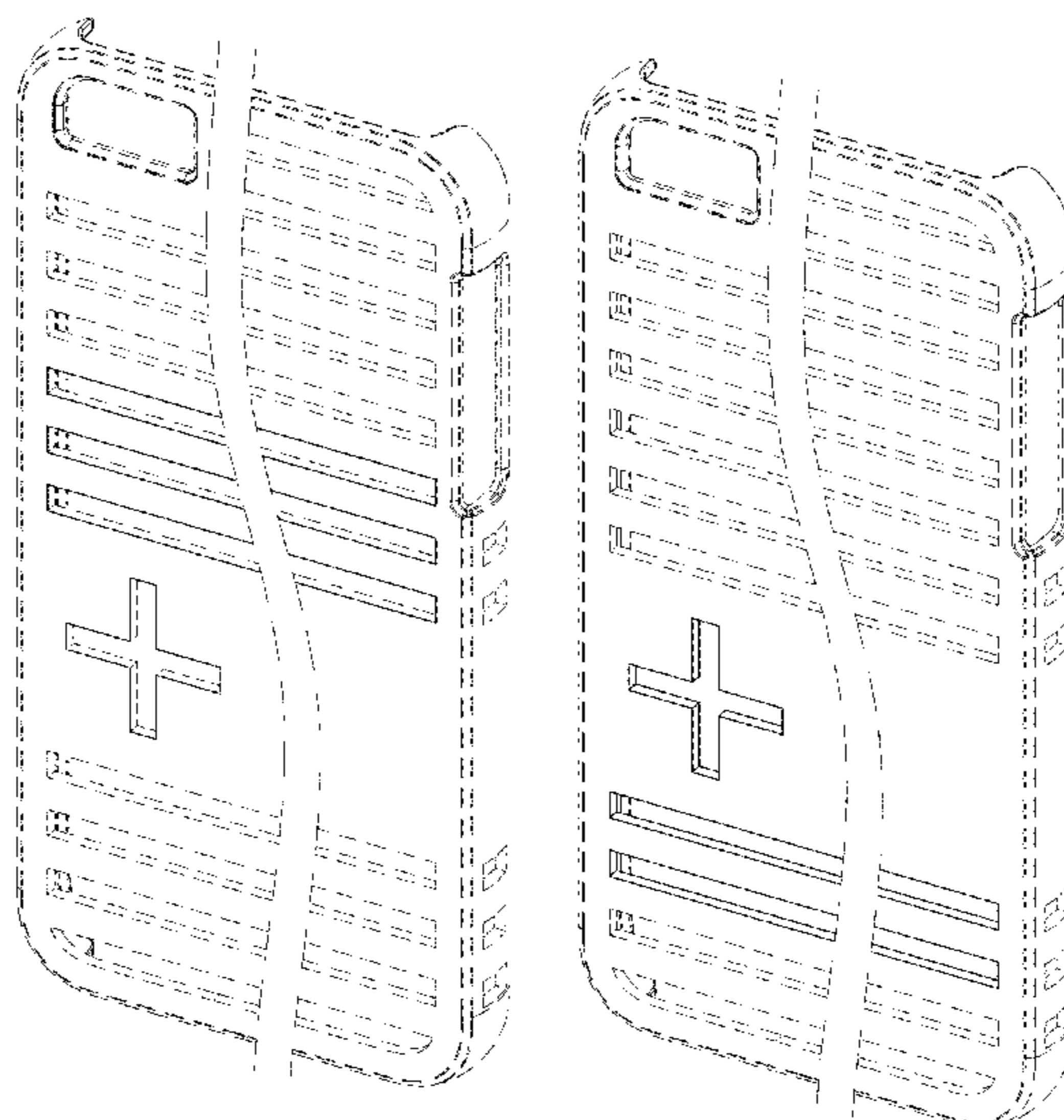
FIG. 10 is a rear perspective view thereof.

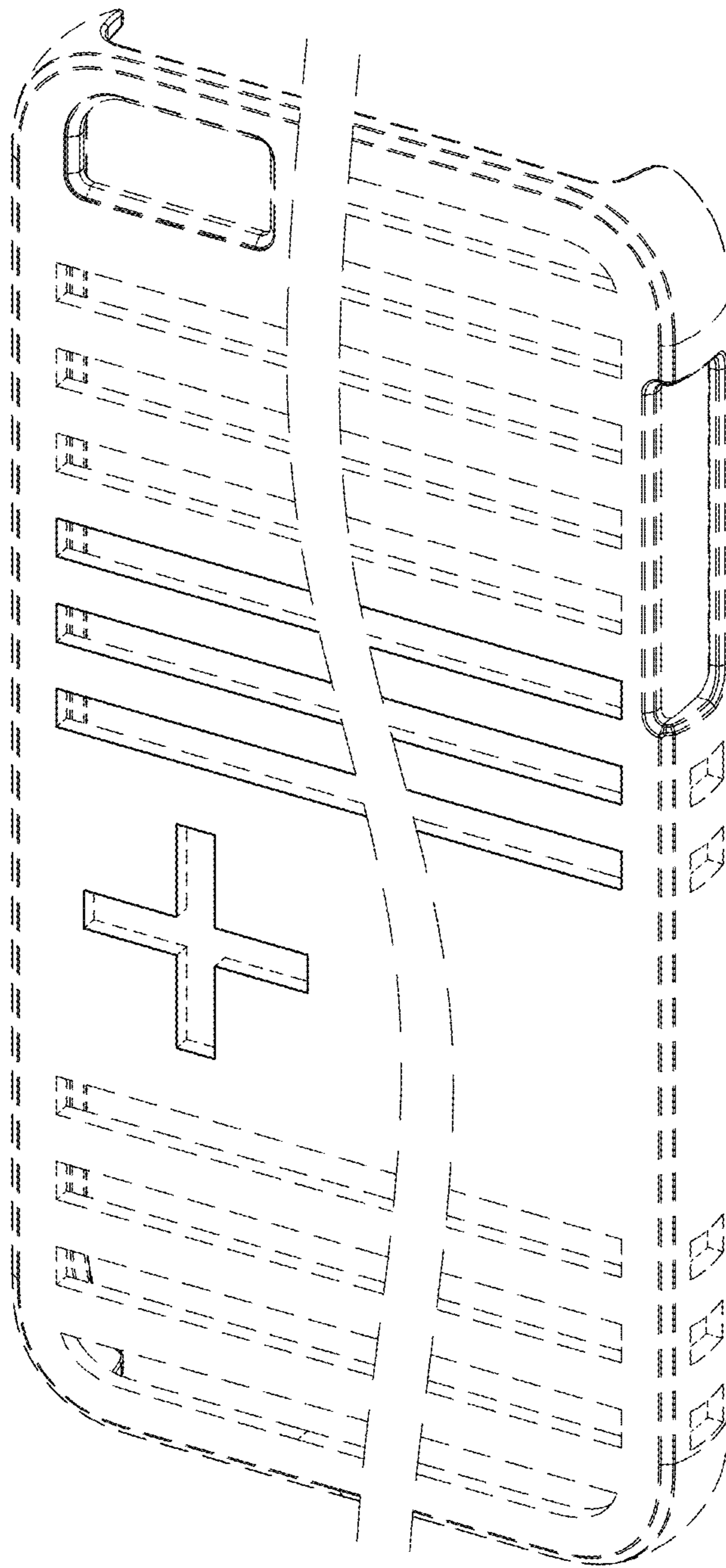

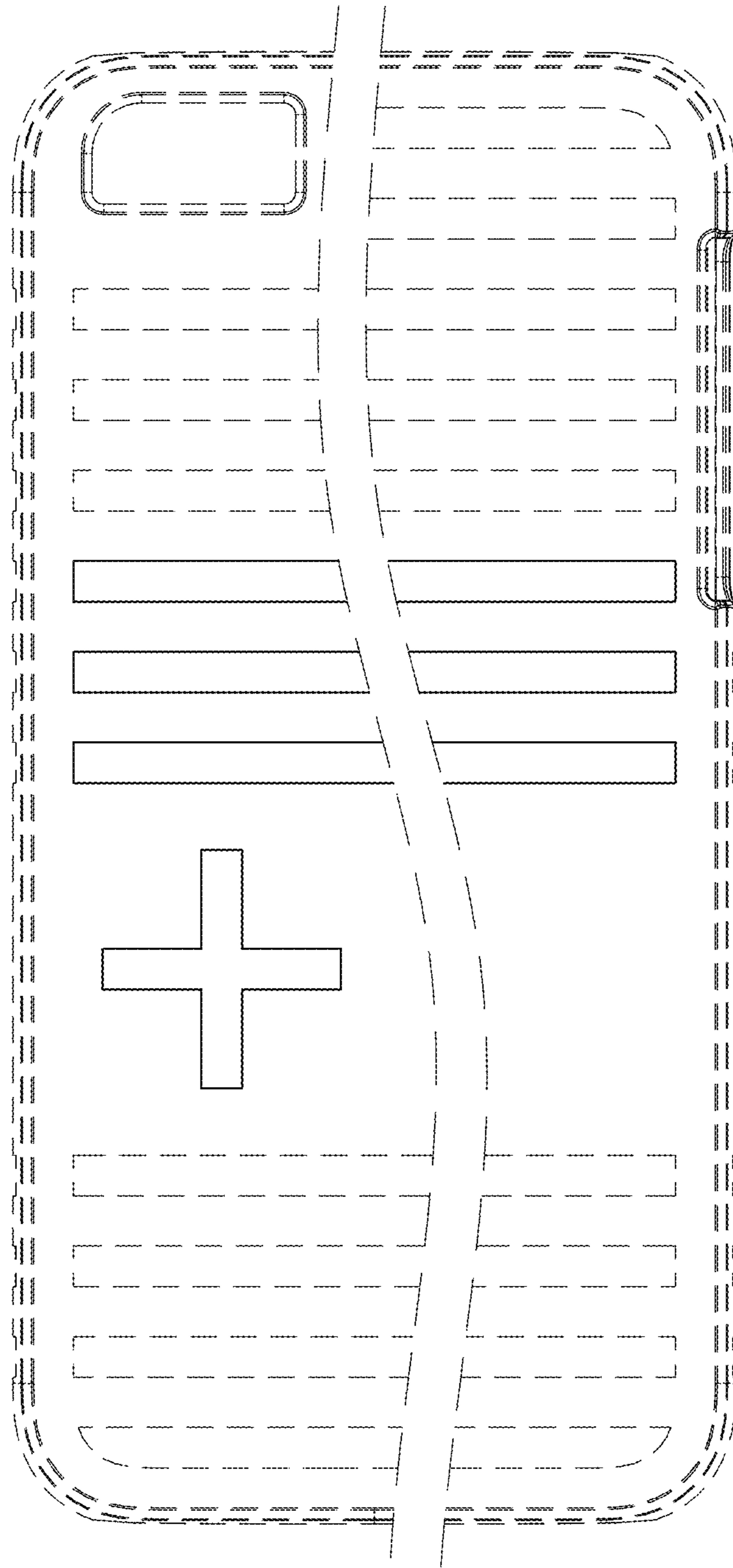

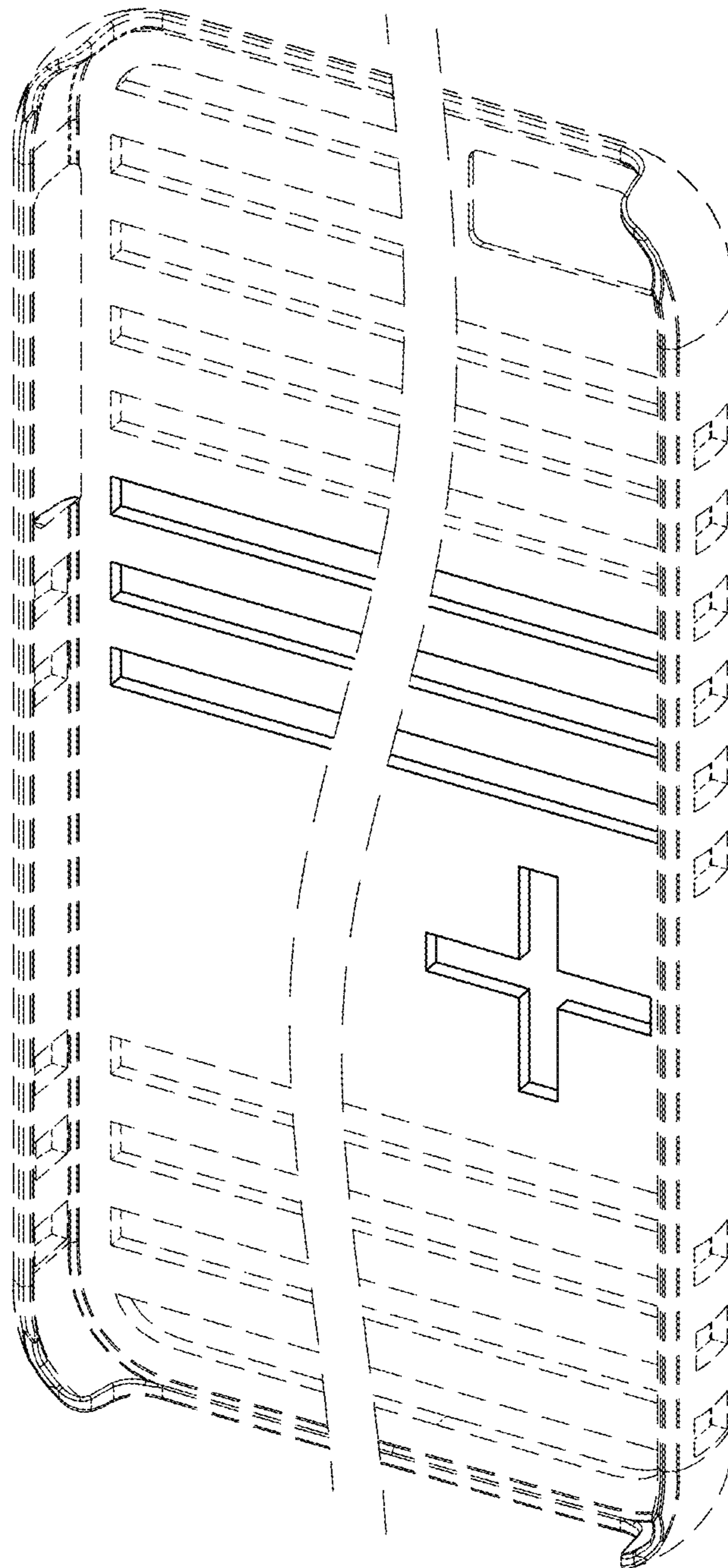

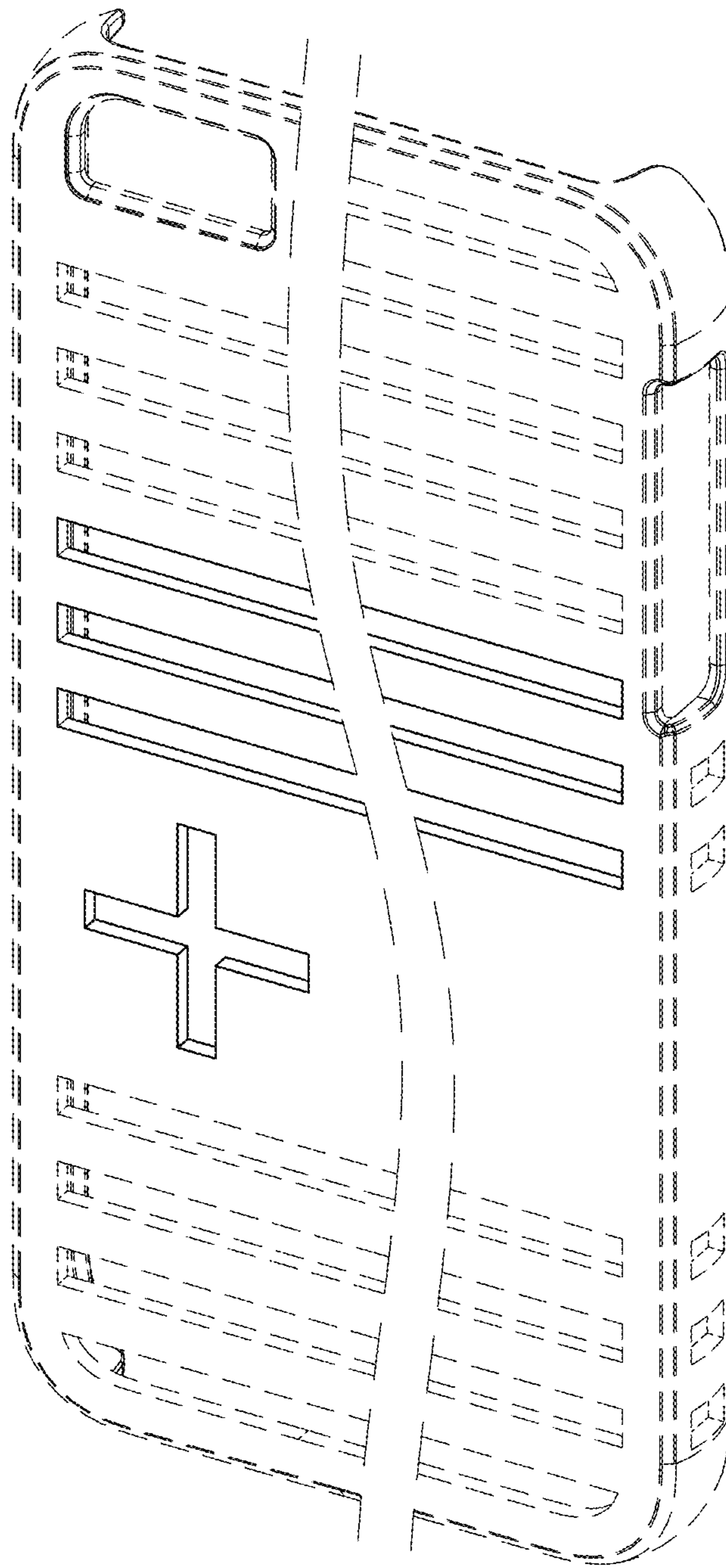

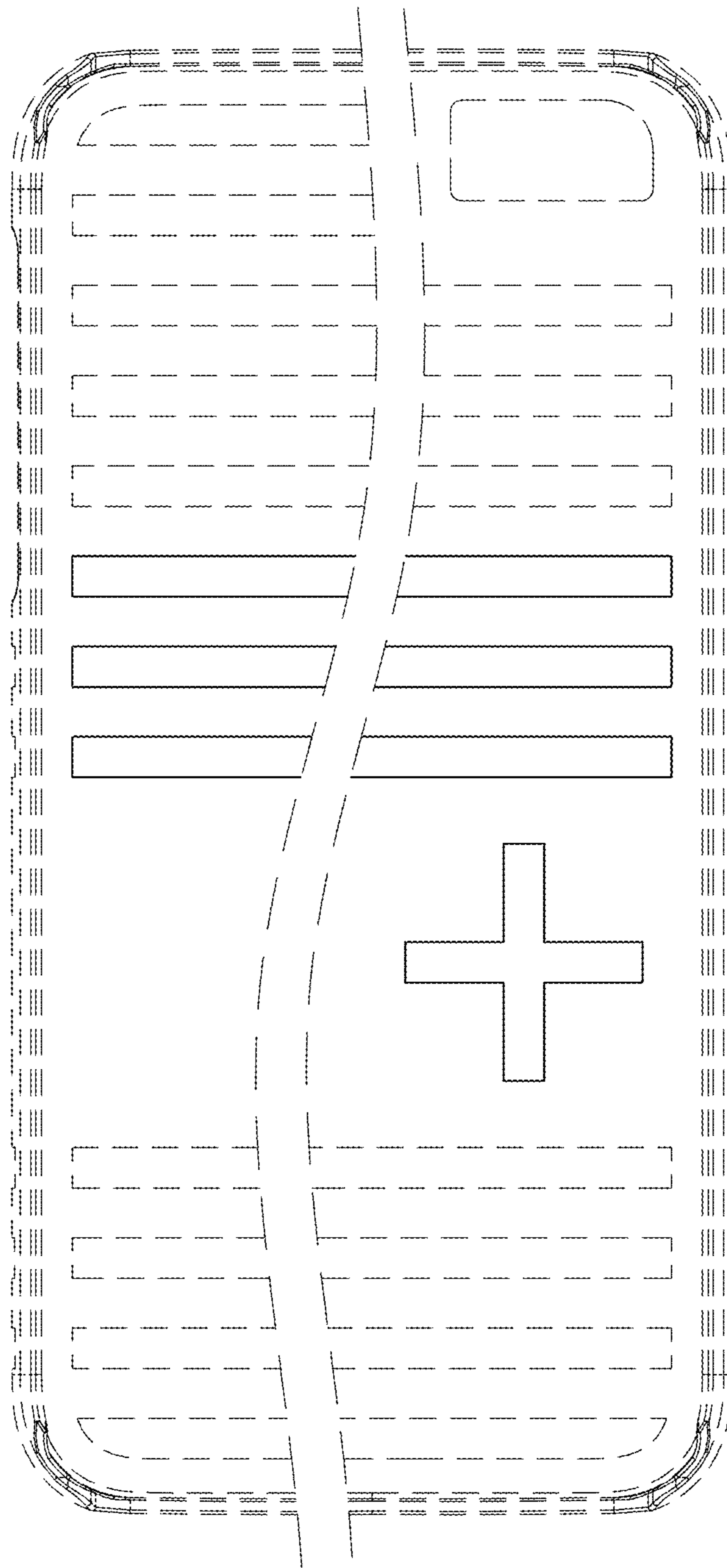

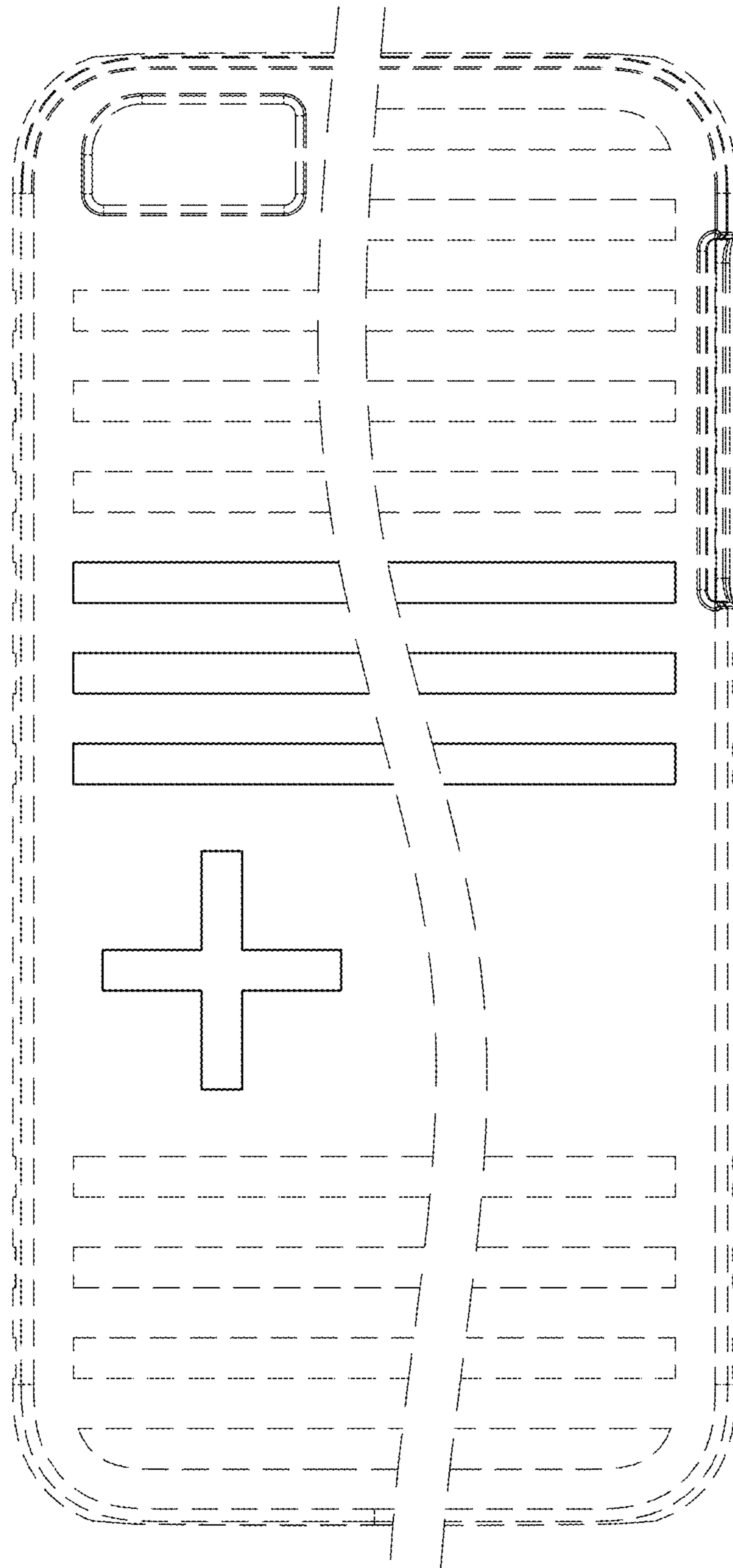

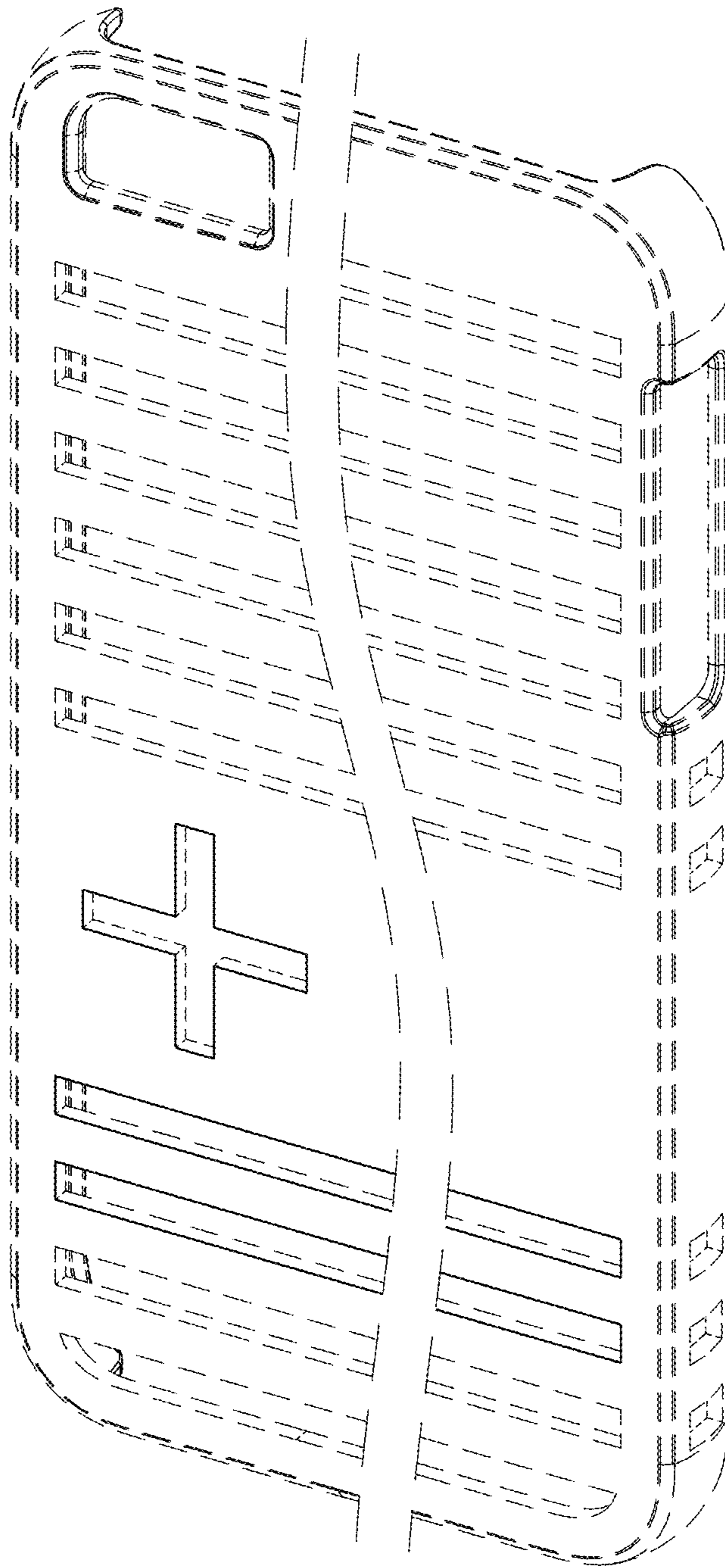

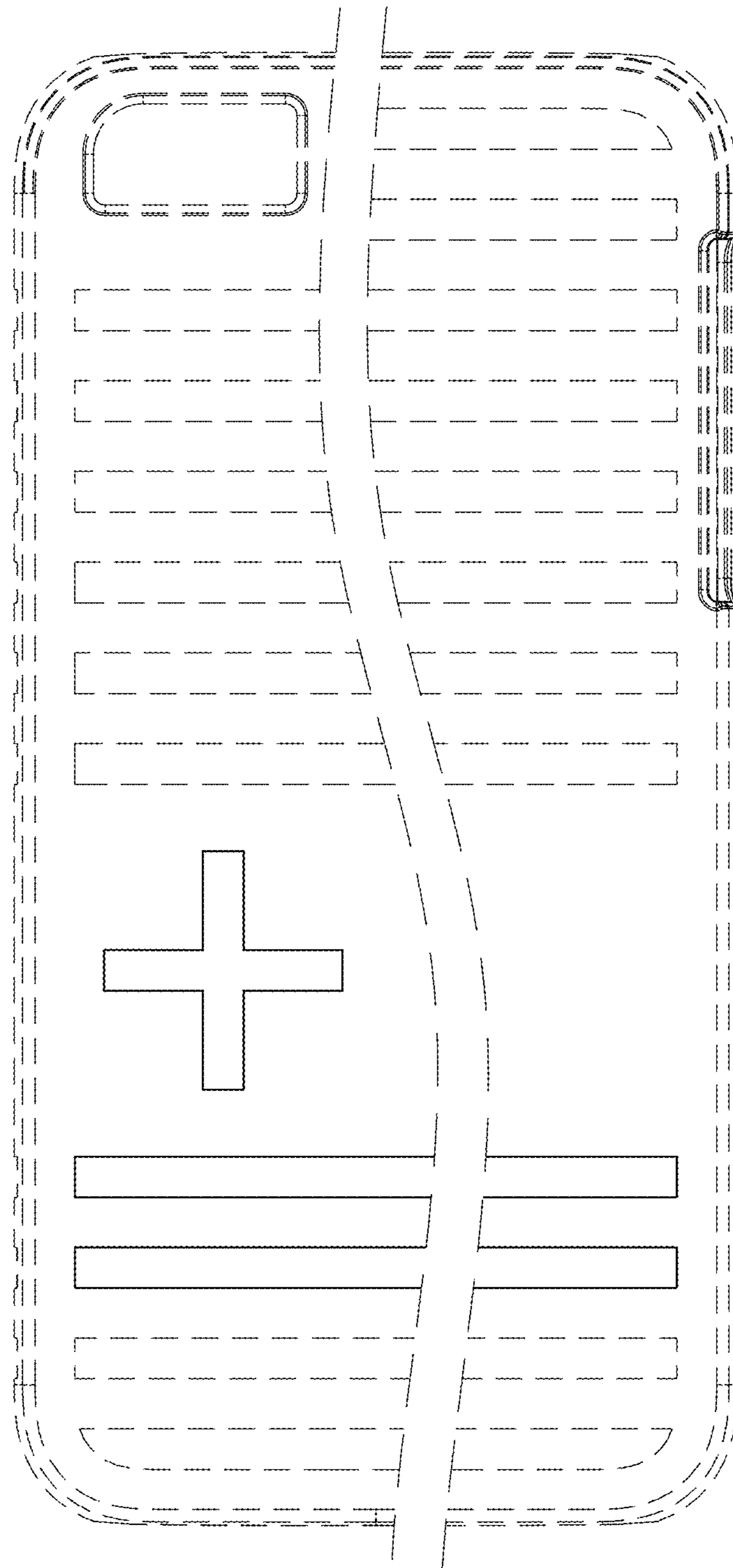

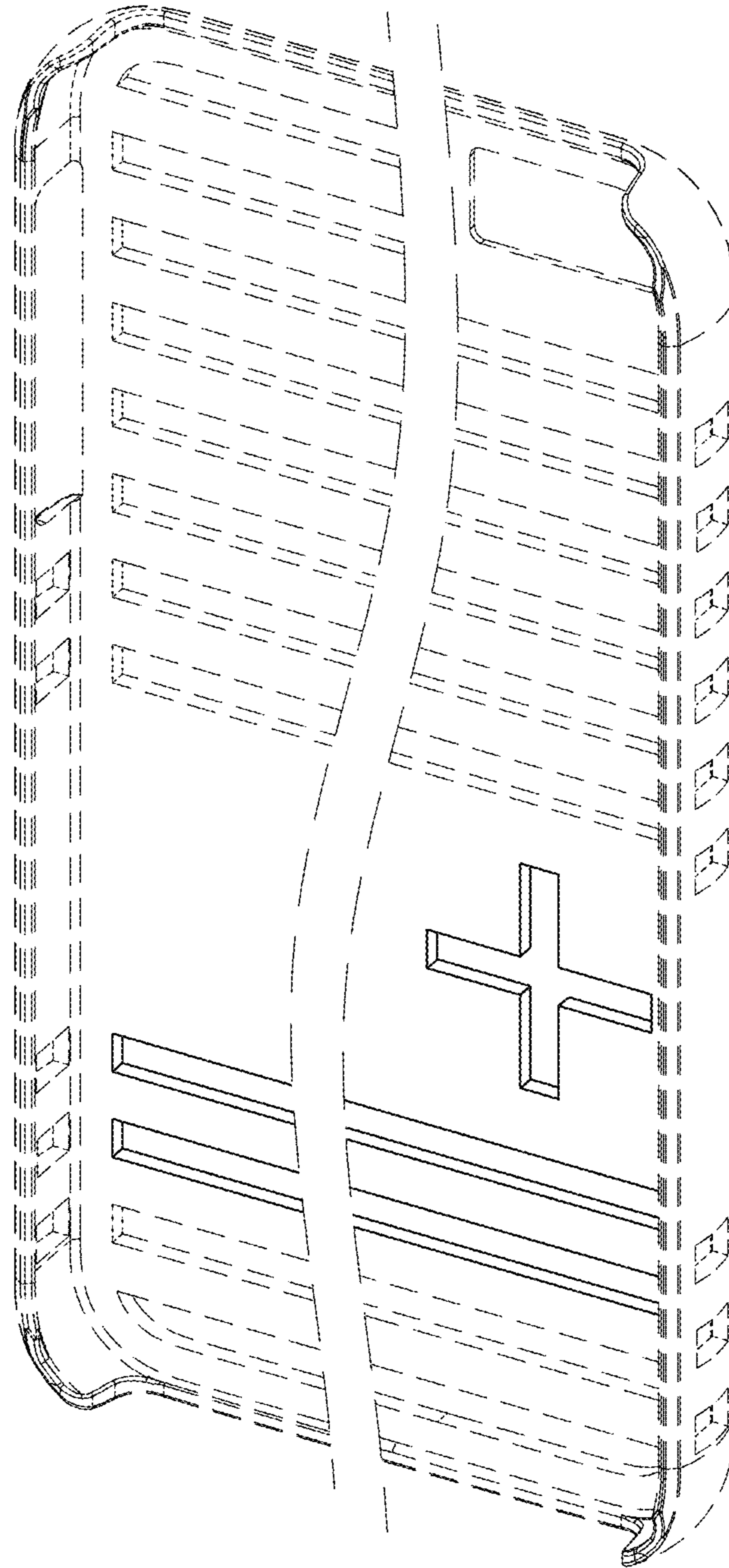

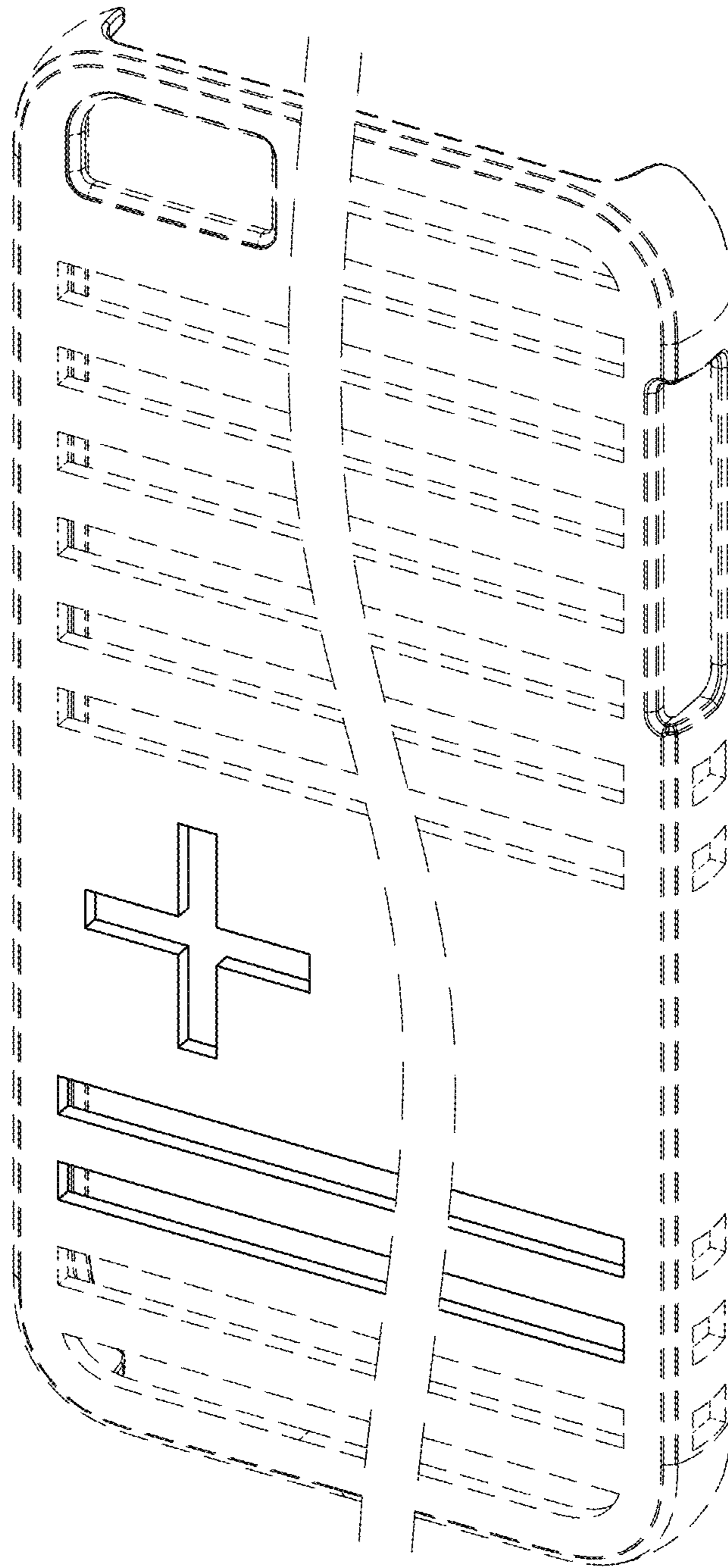

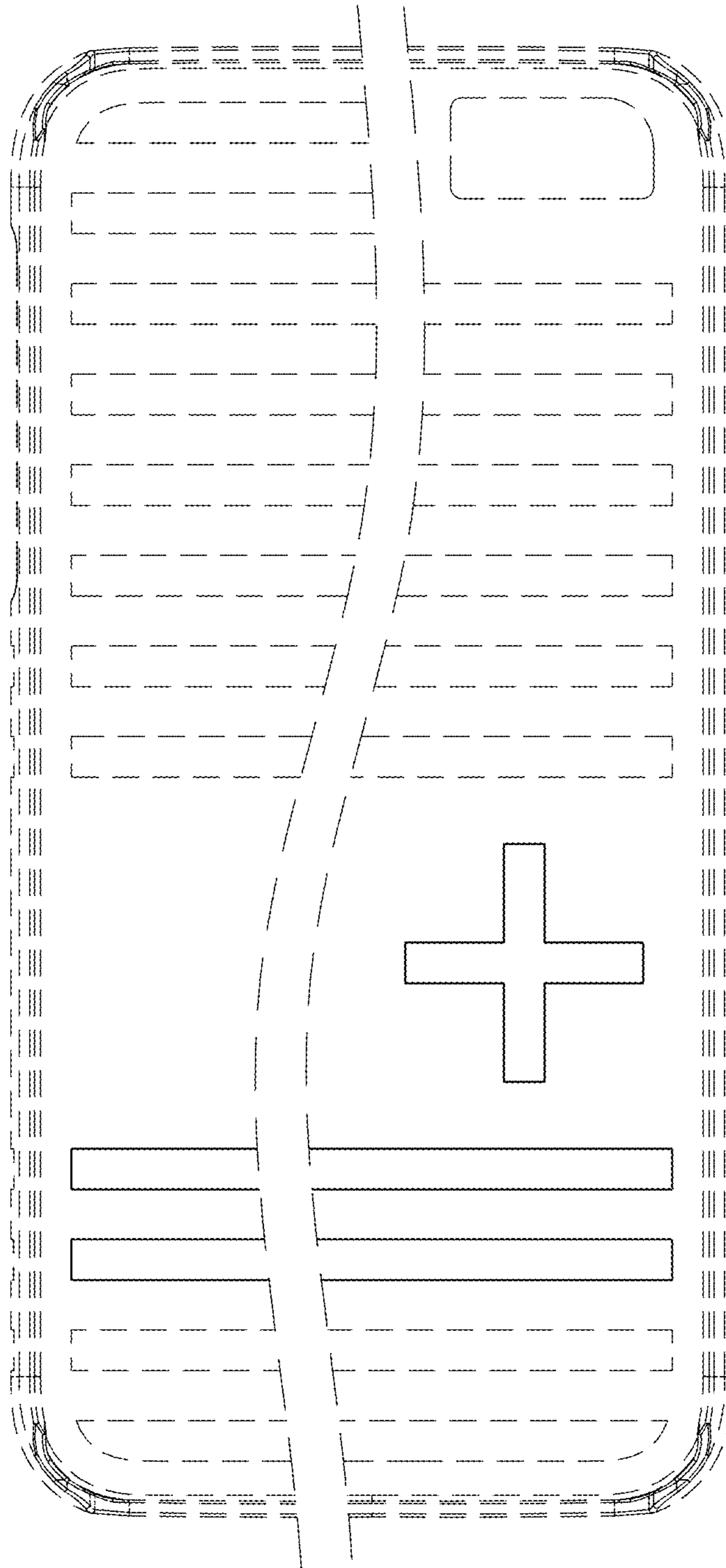

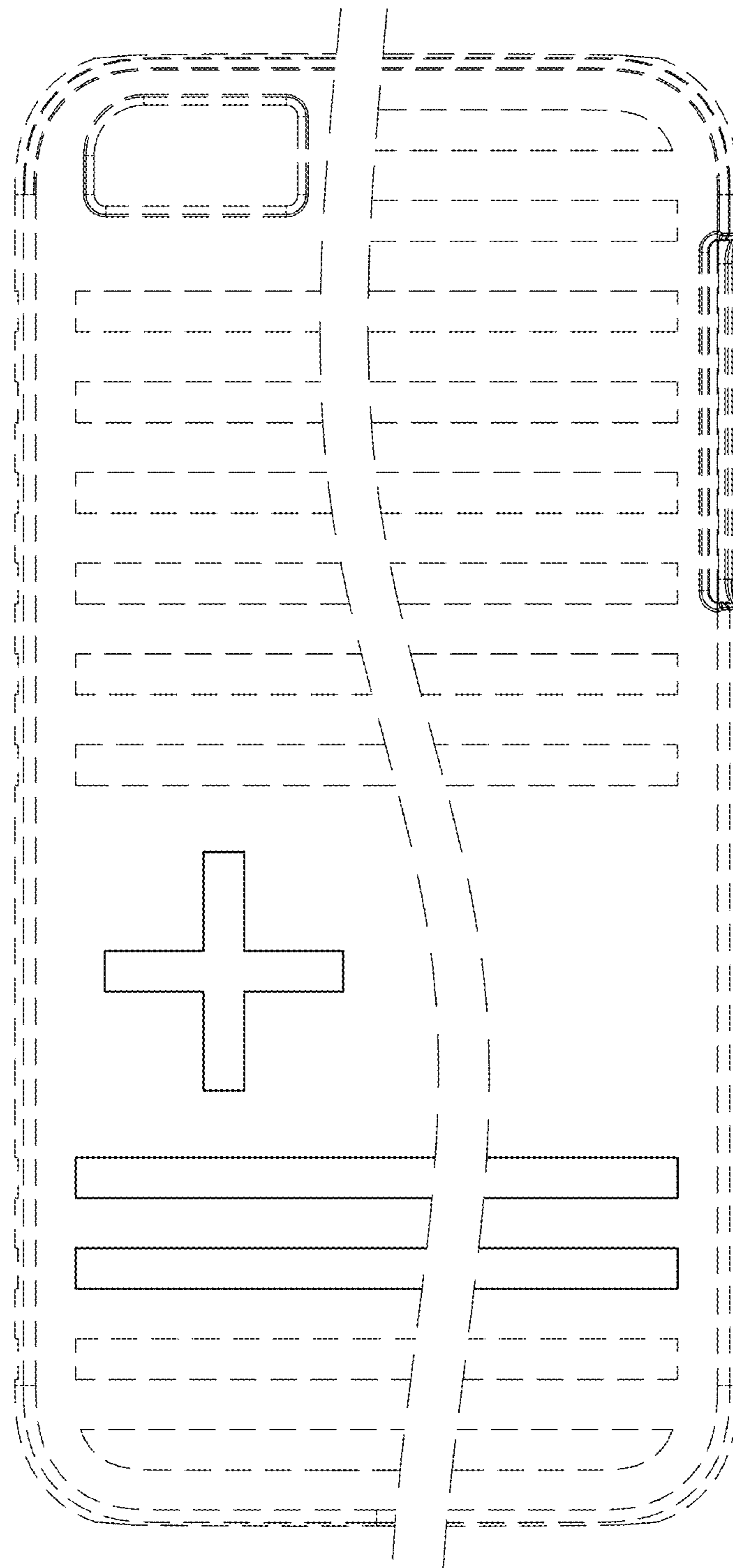
