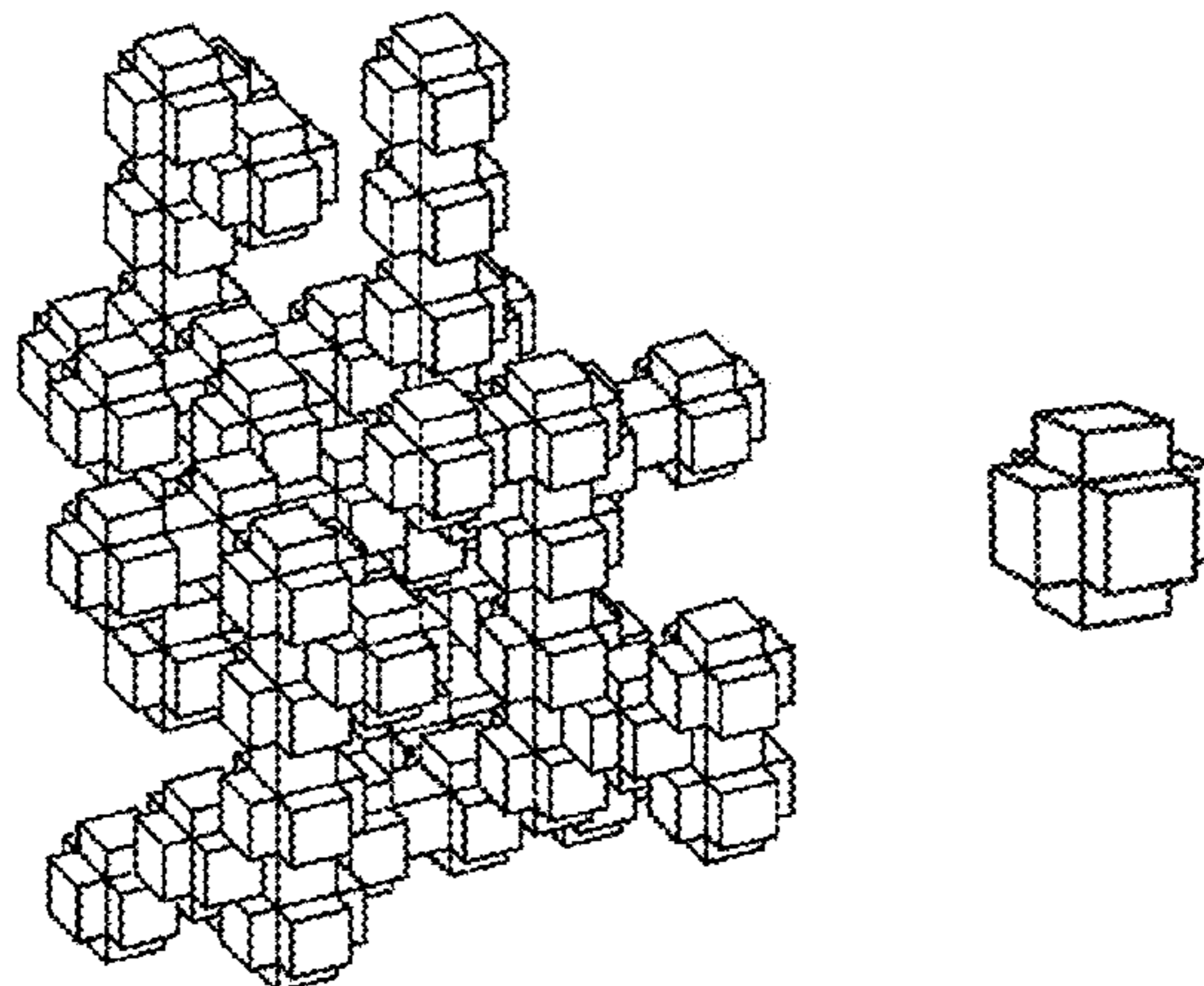
The ornamental design for a set of building blocks, as shown and described.

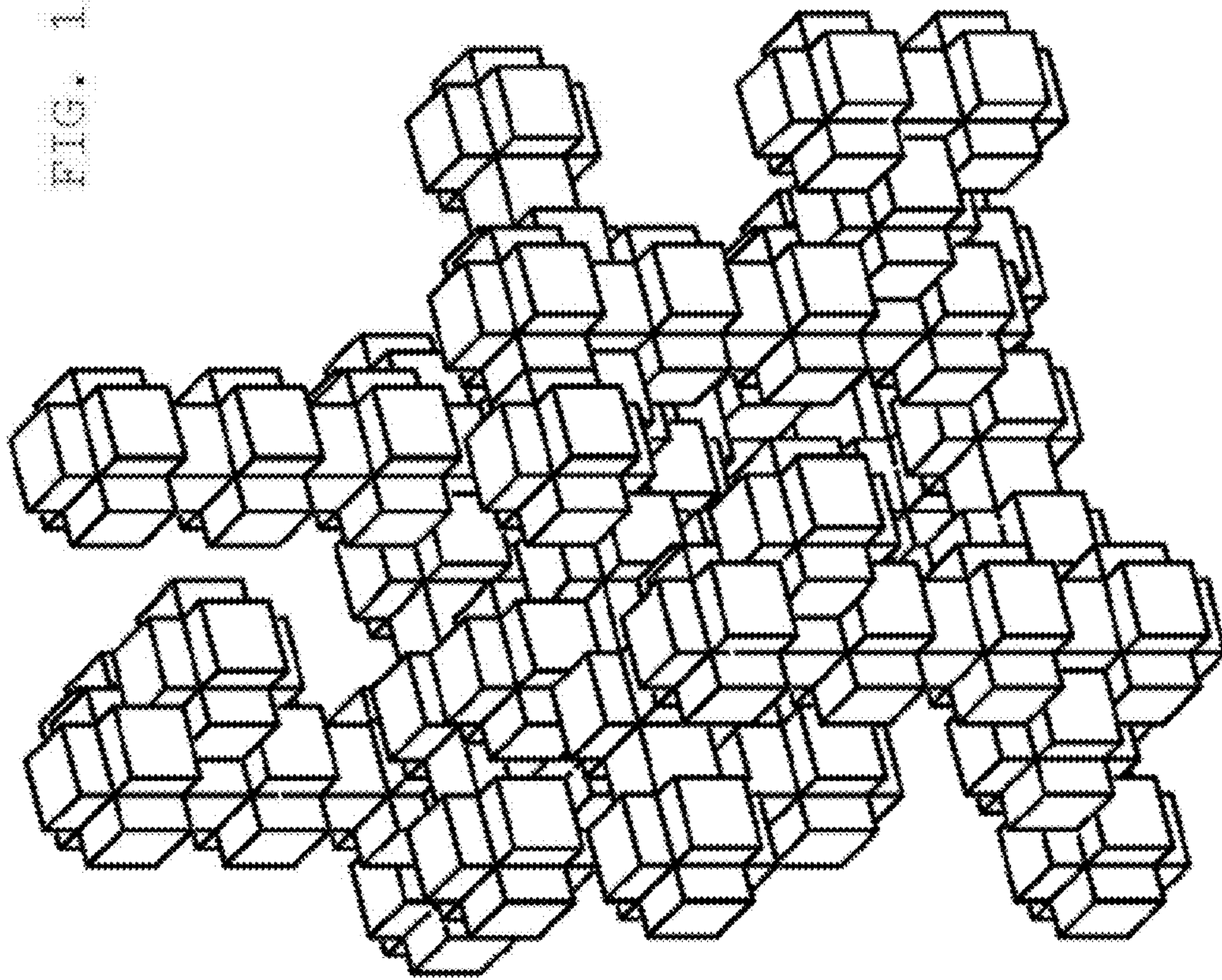
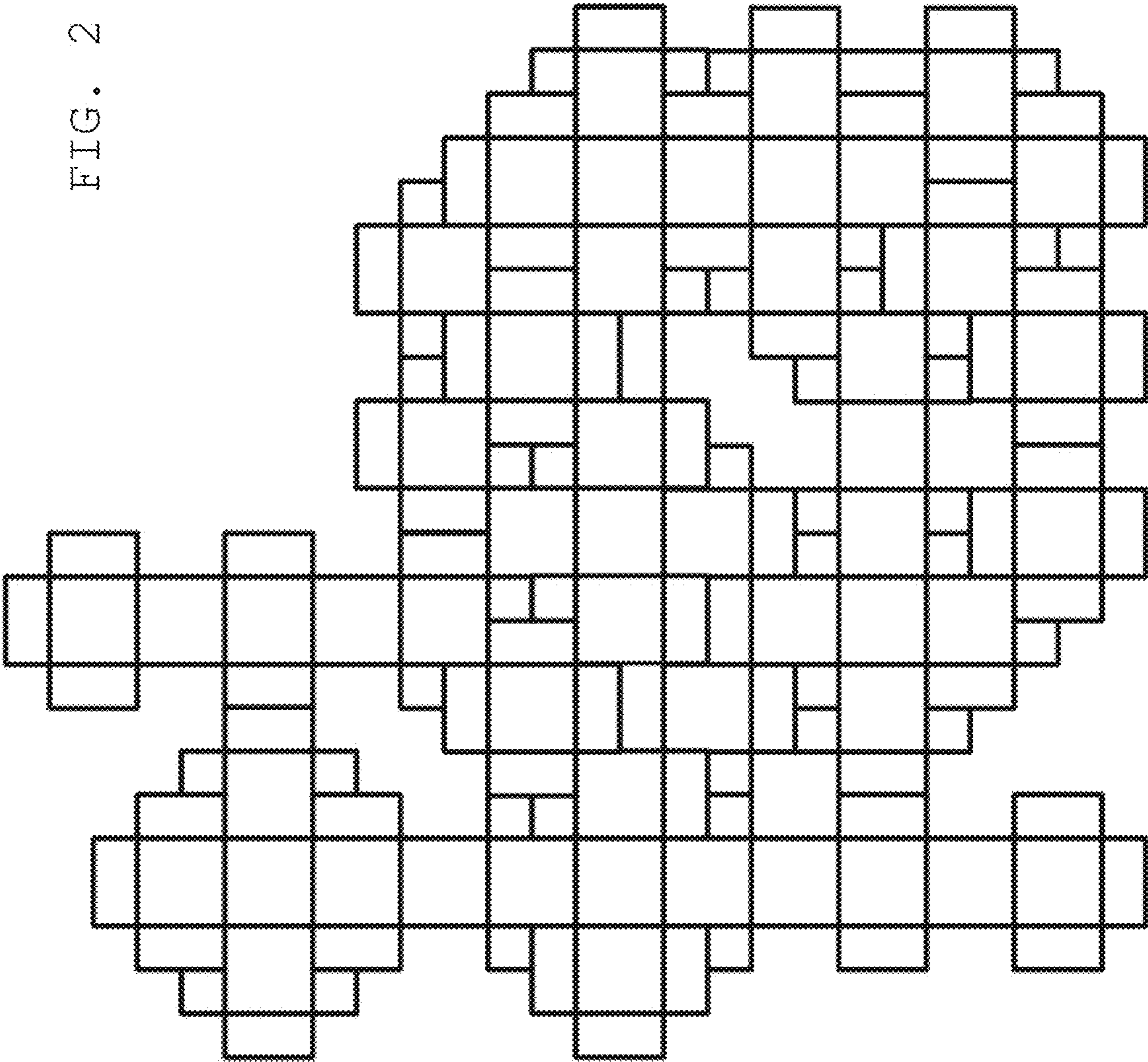

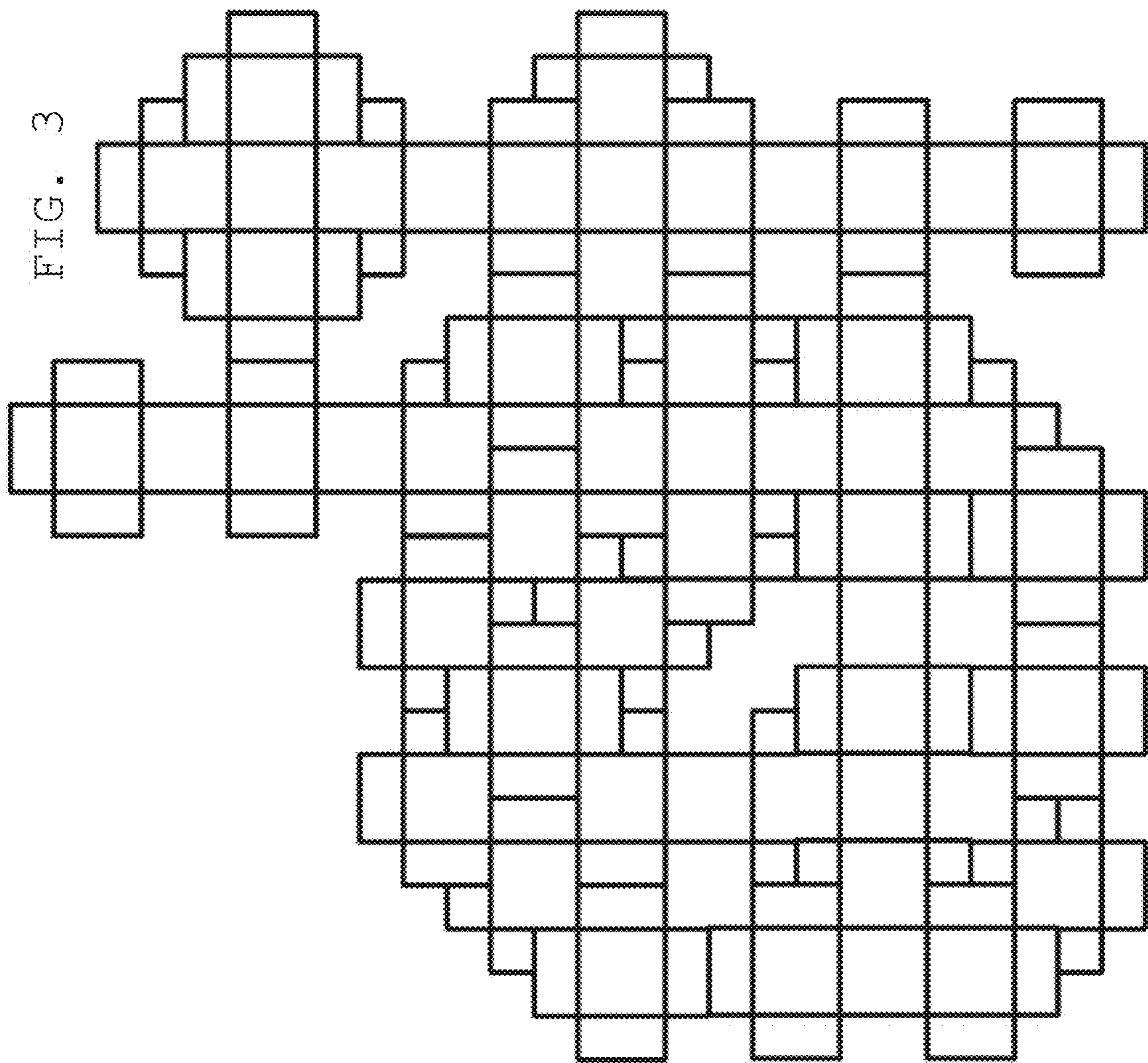

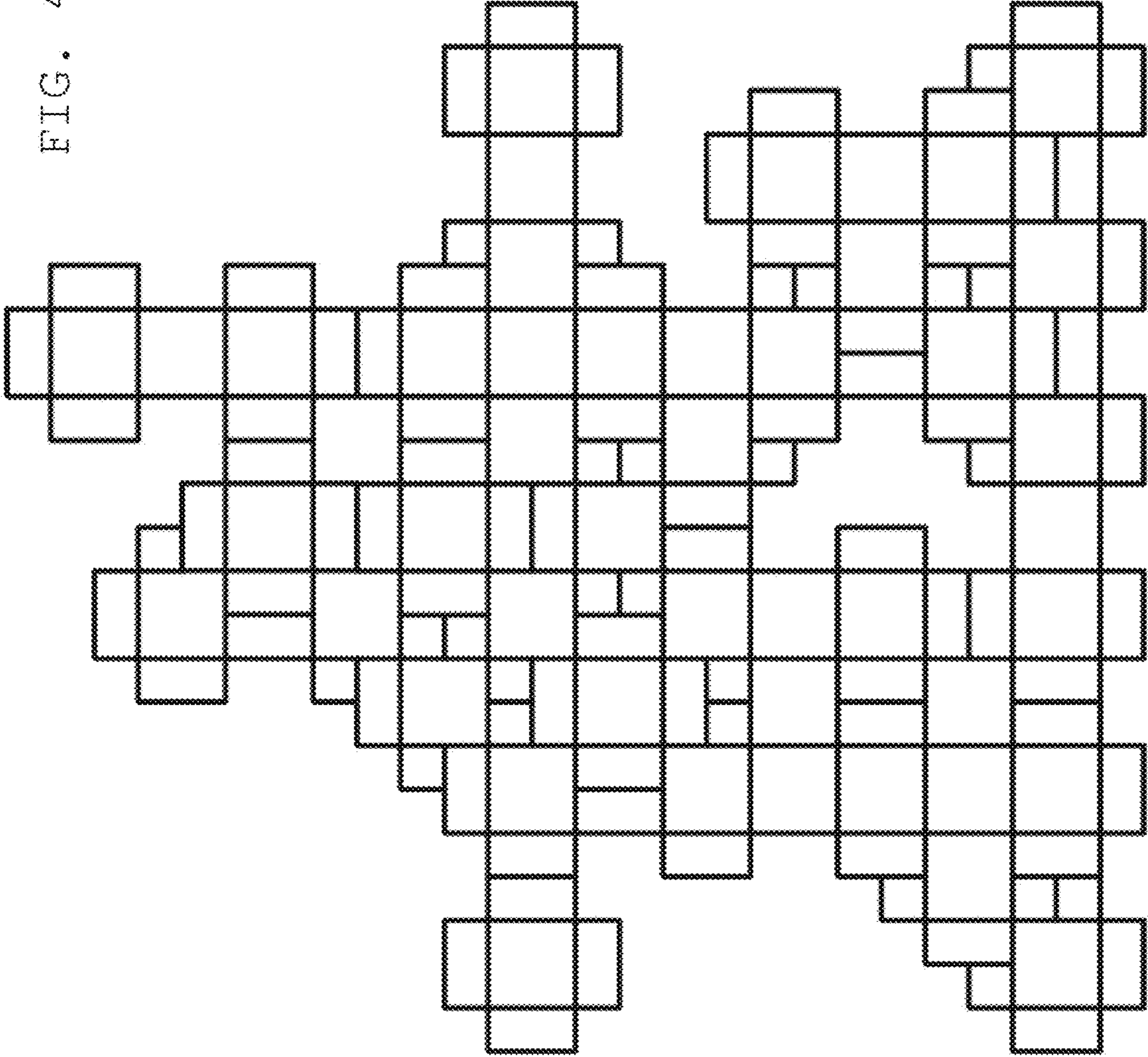

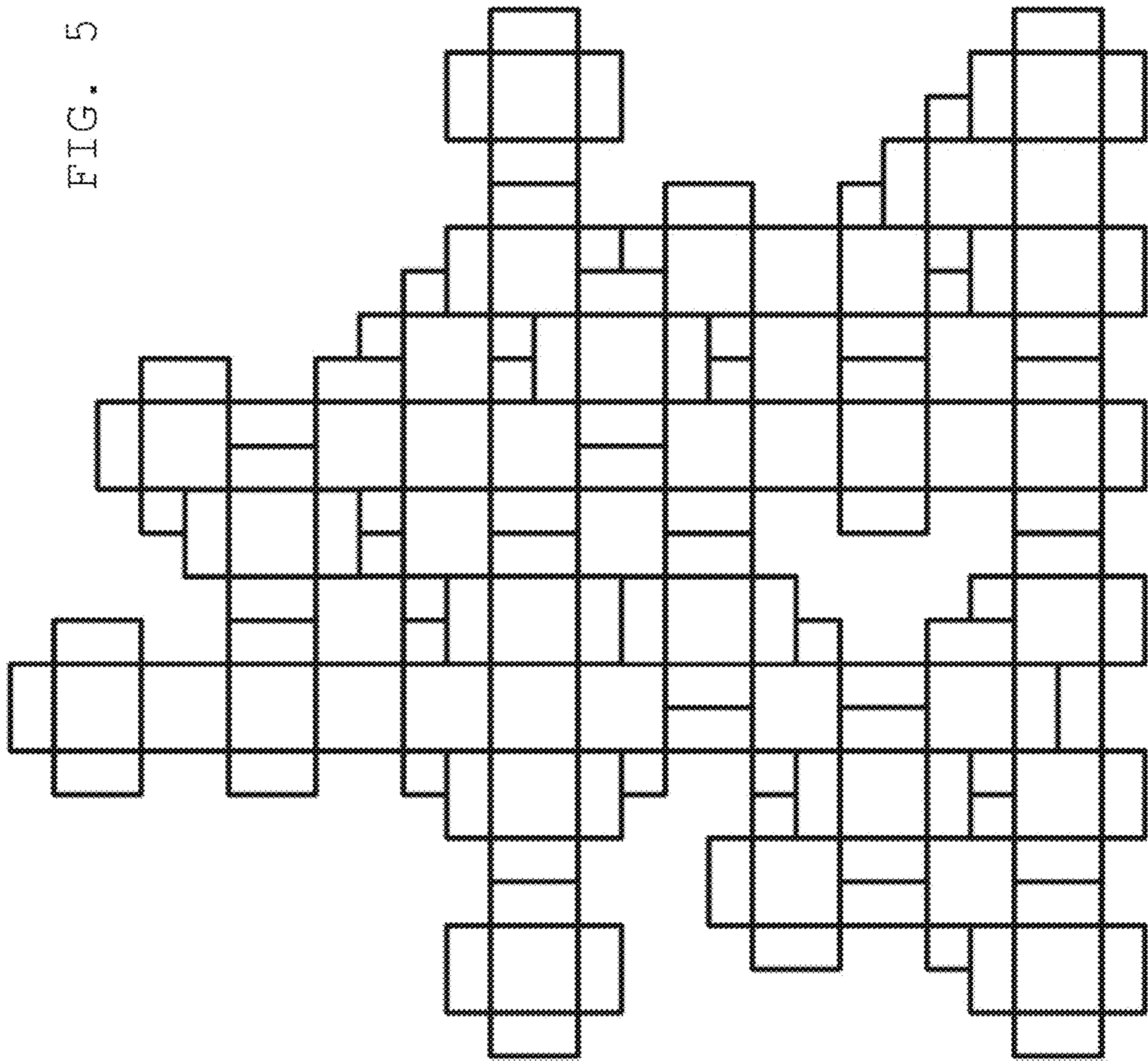

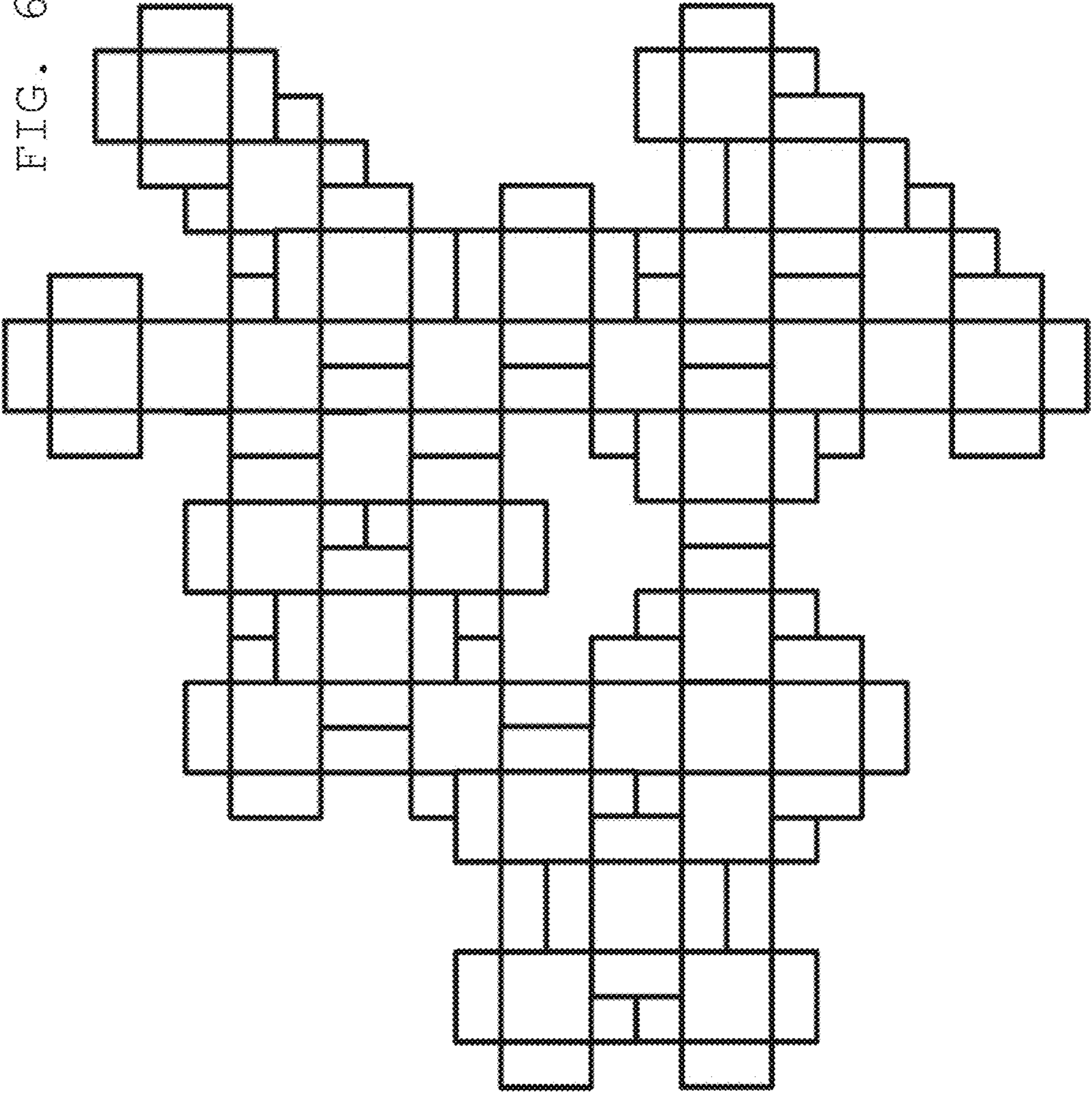

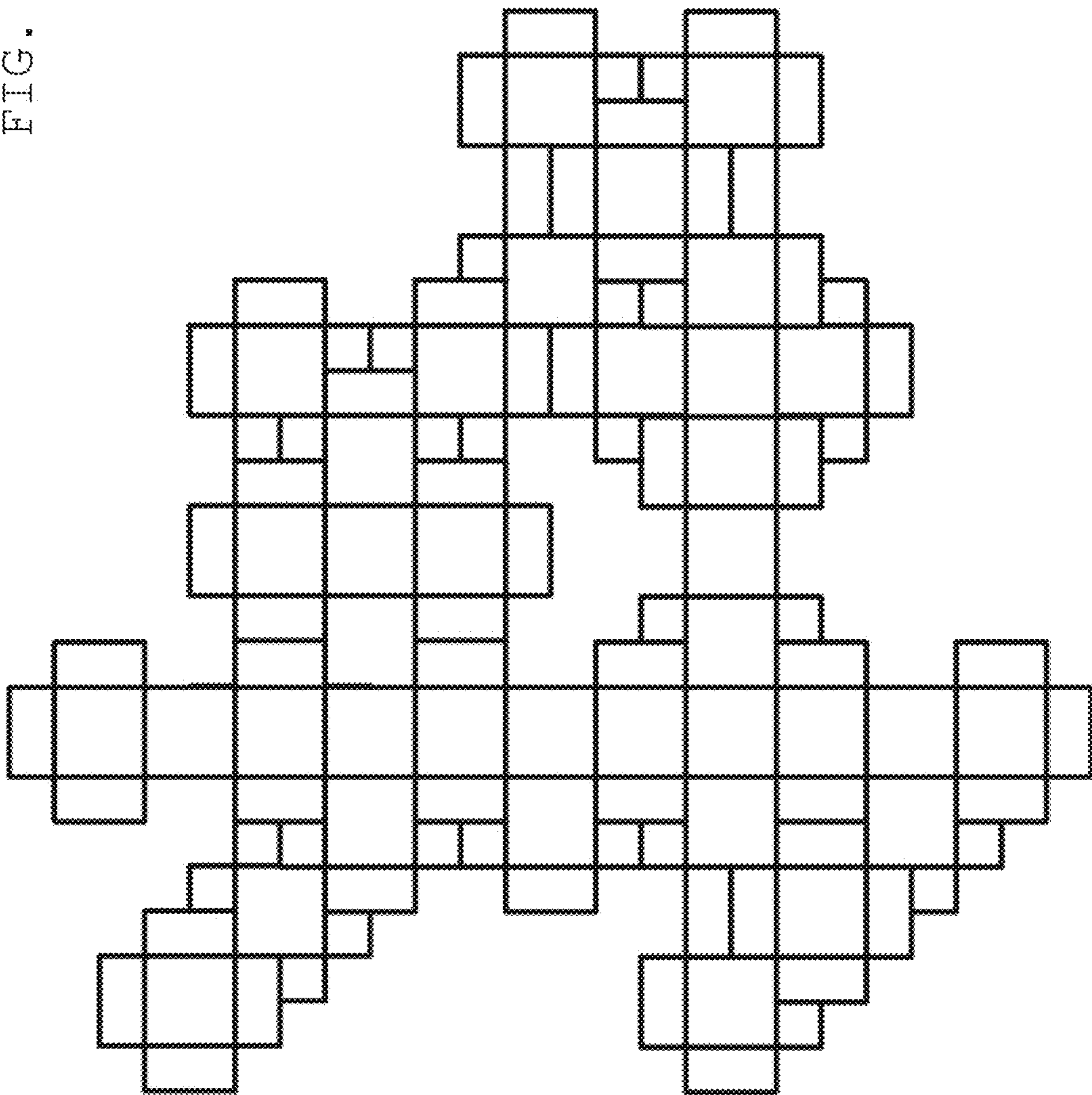

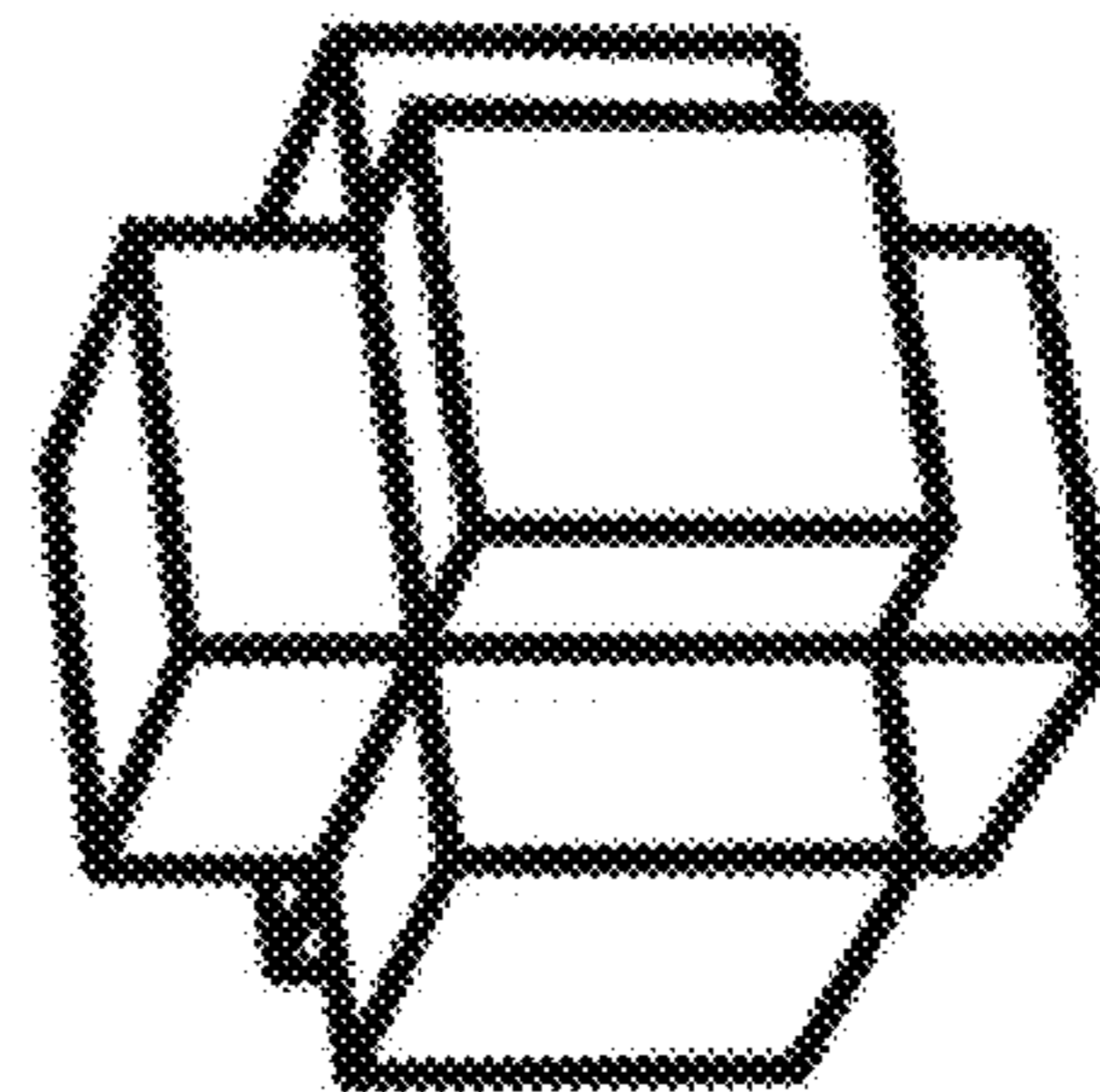

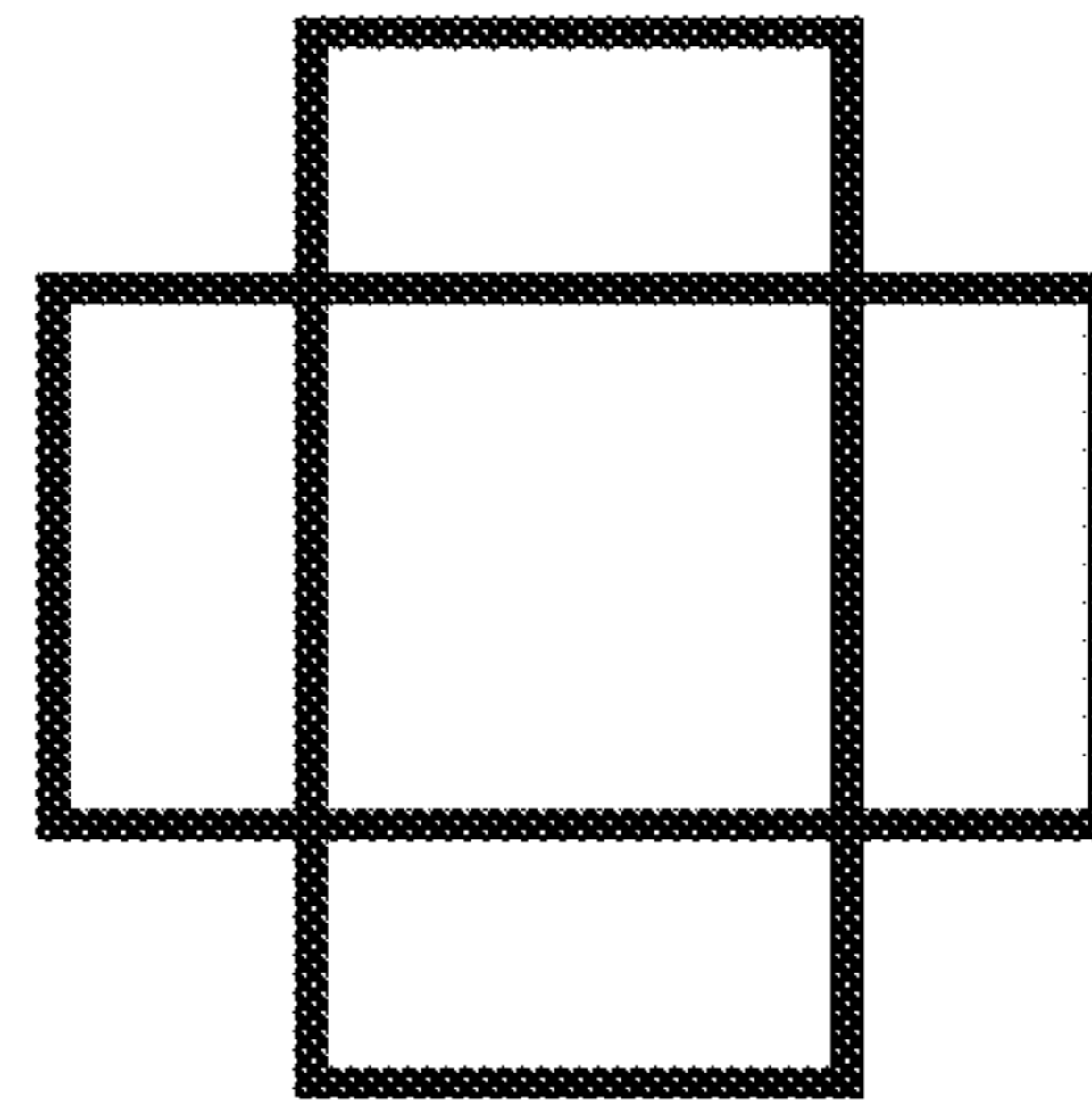

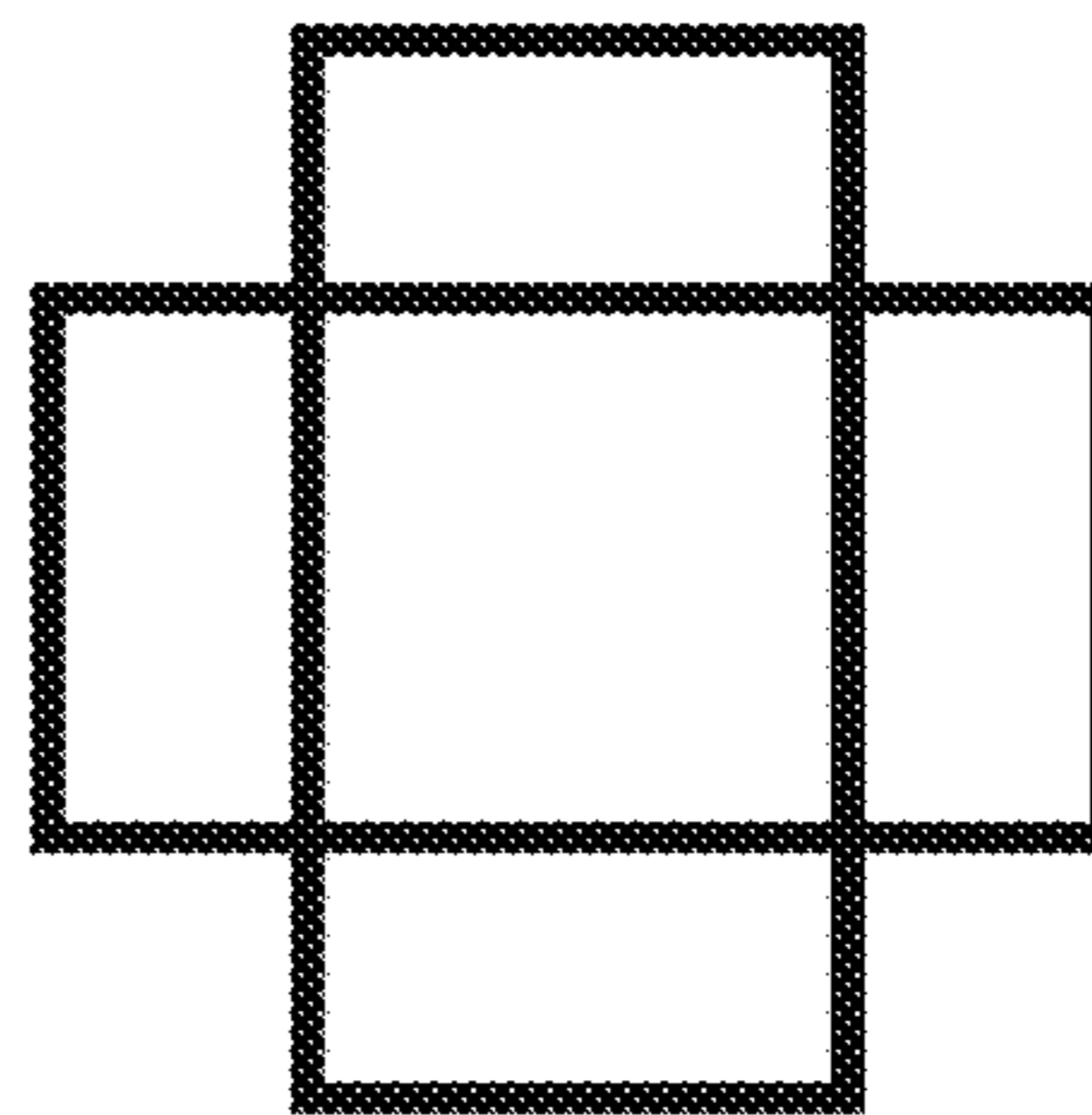

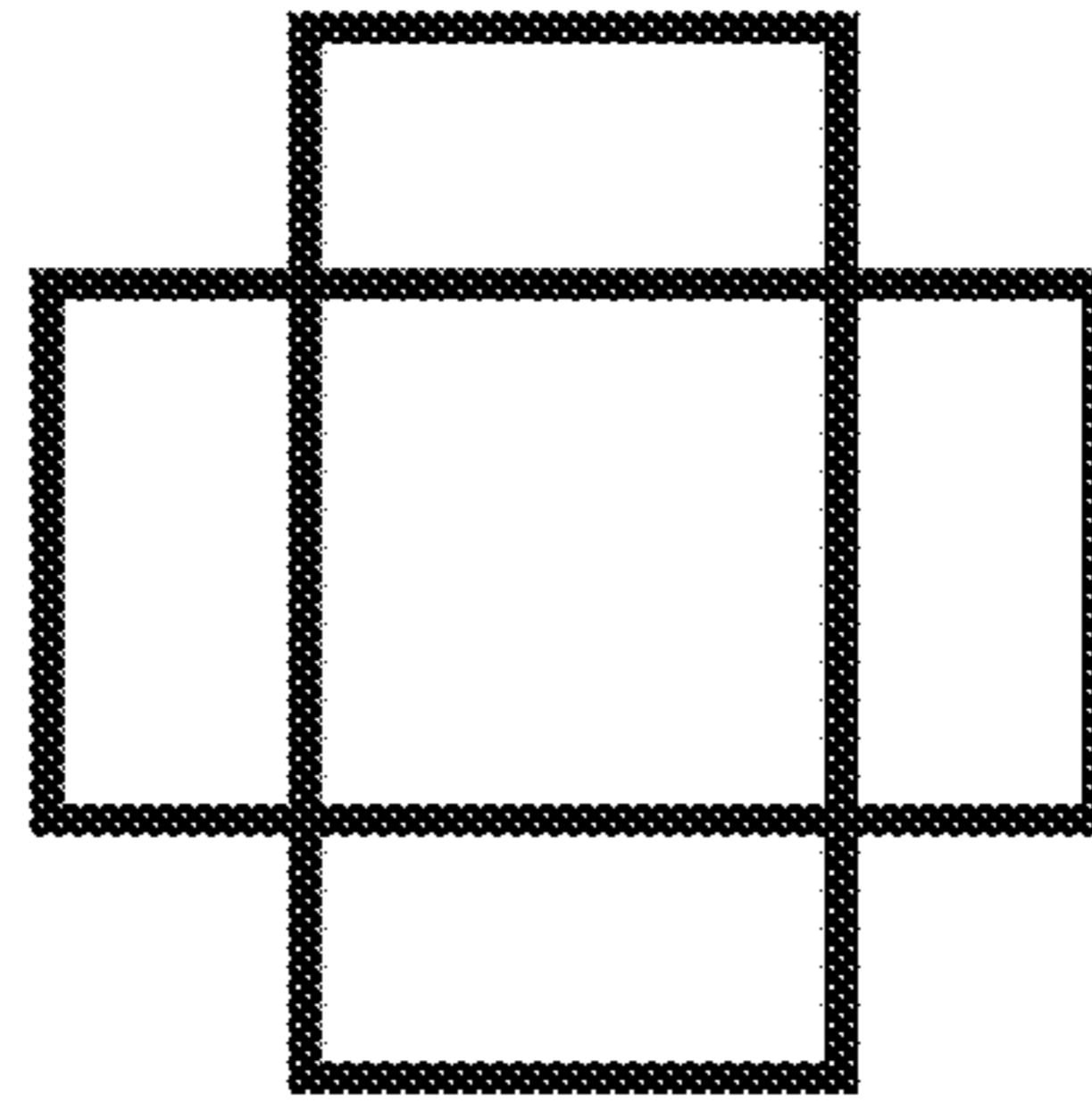

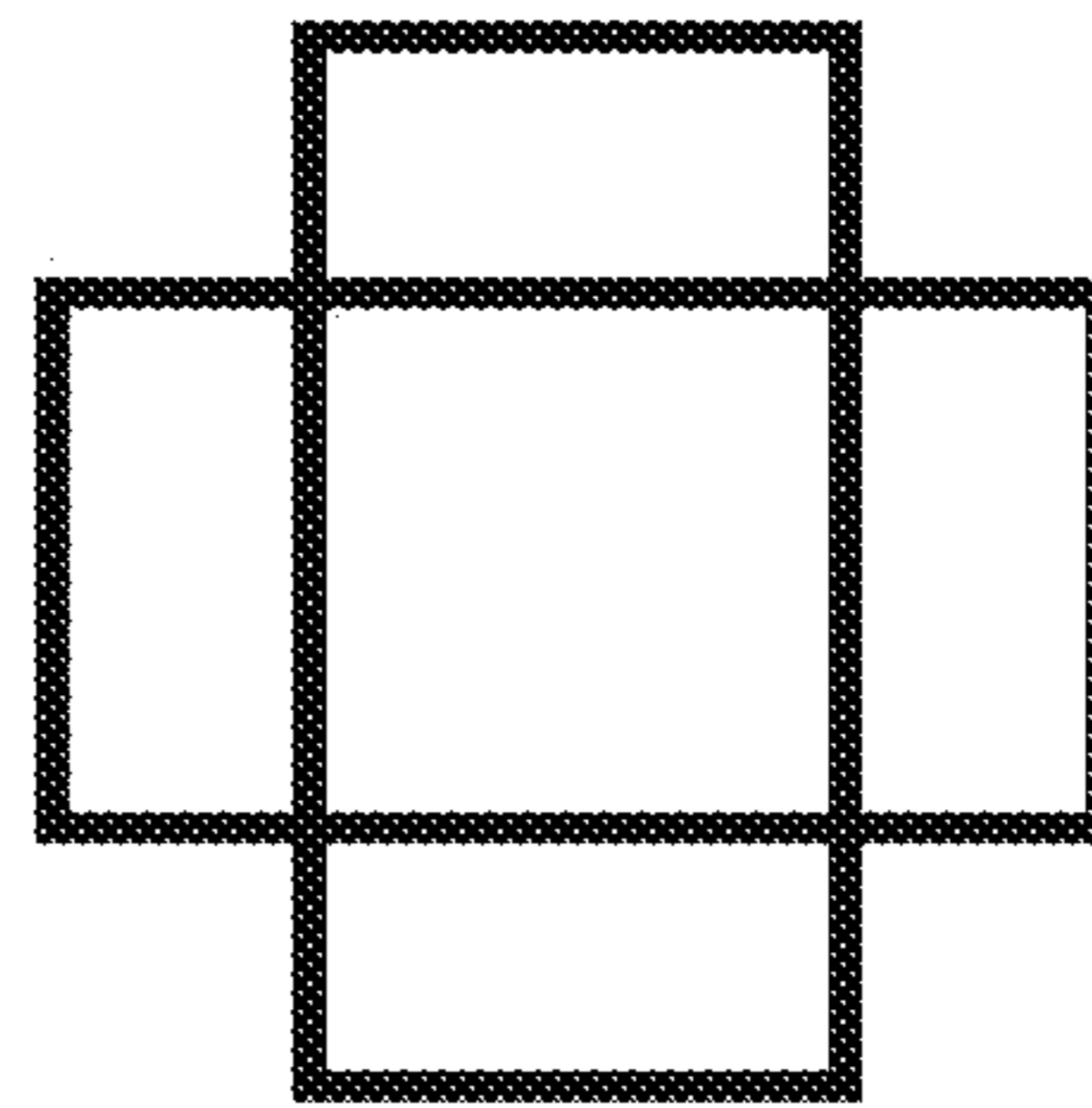

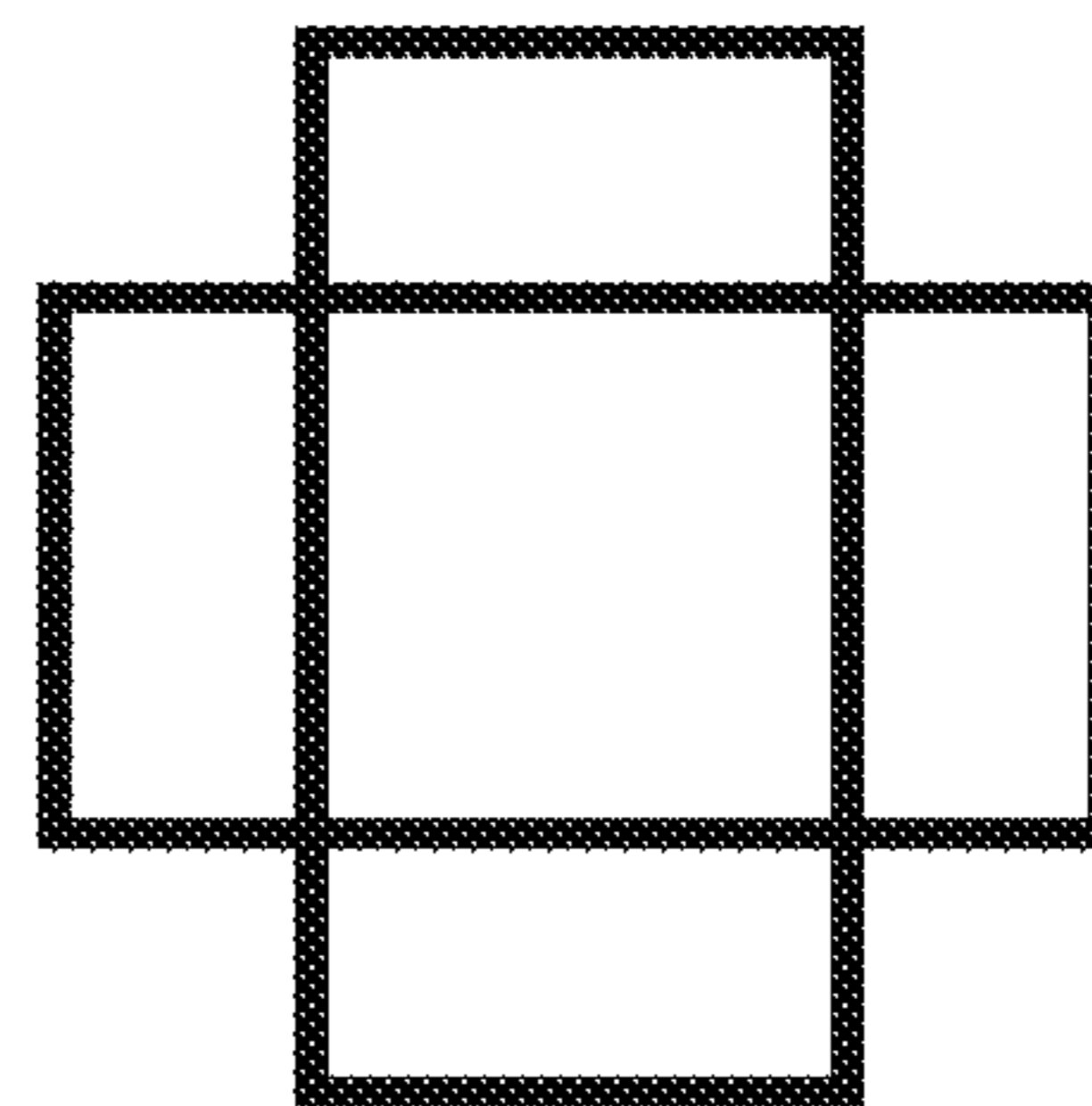

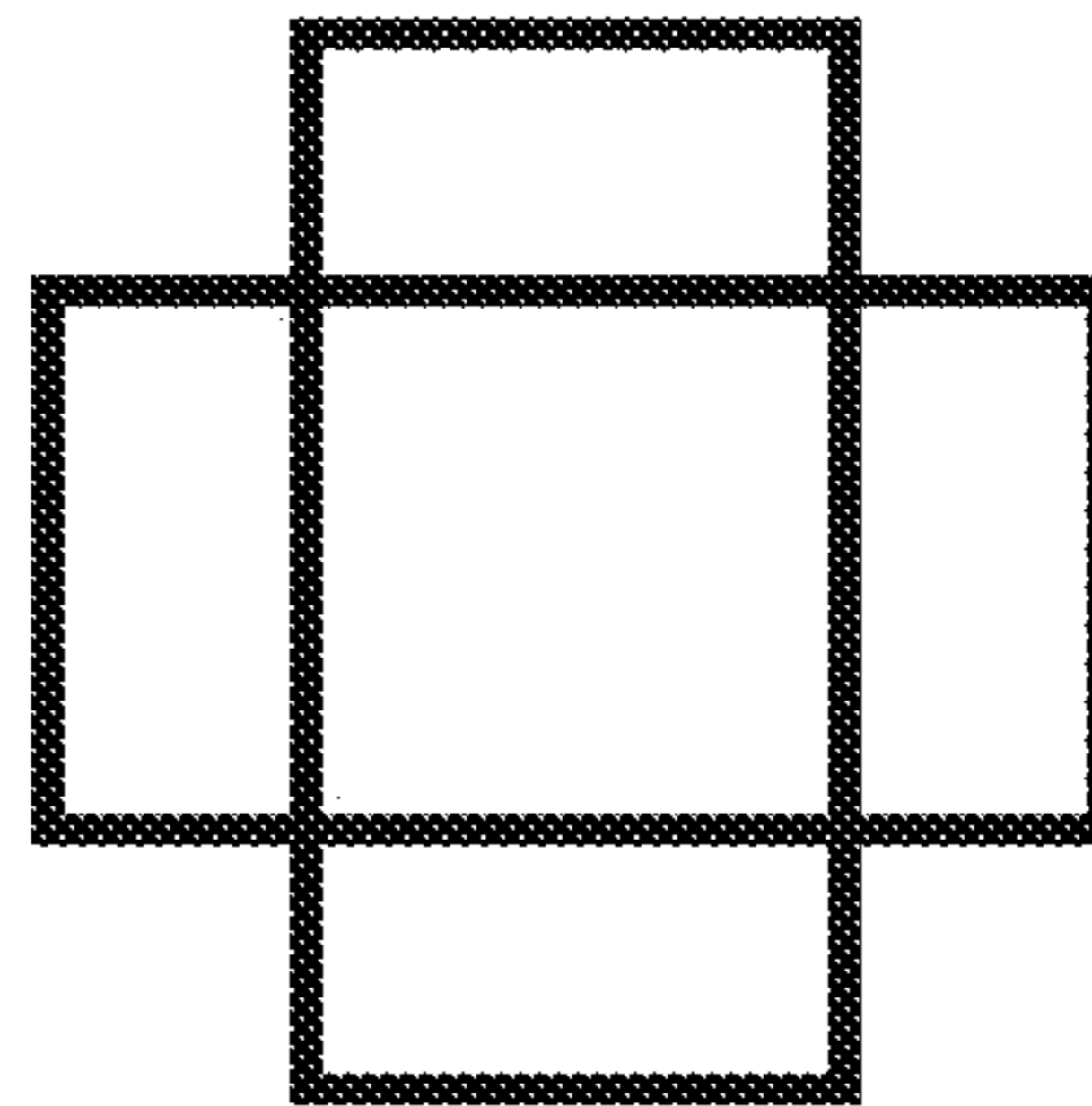

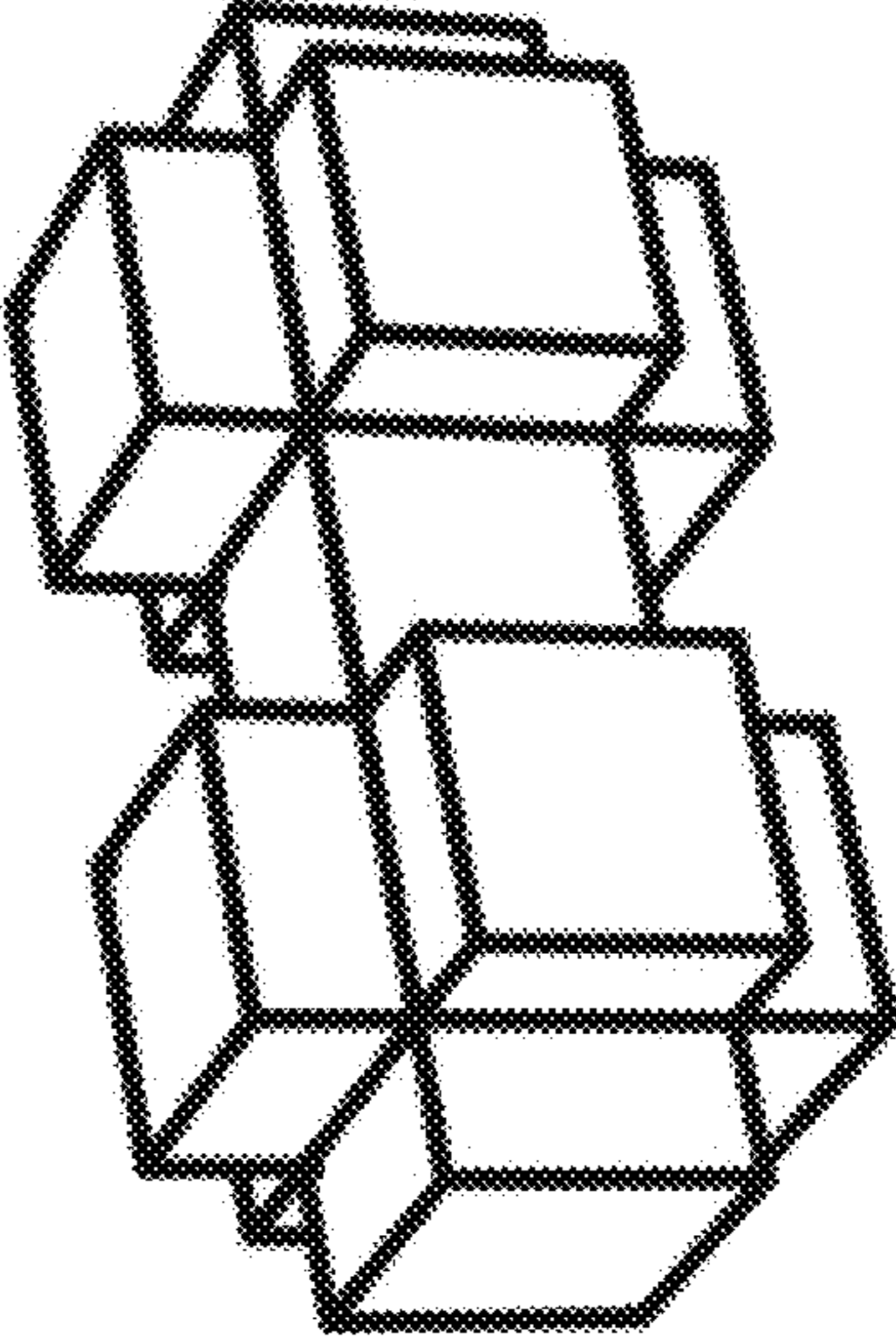

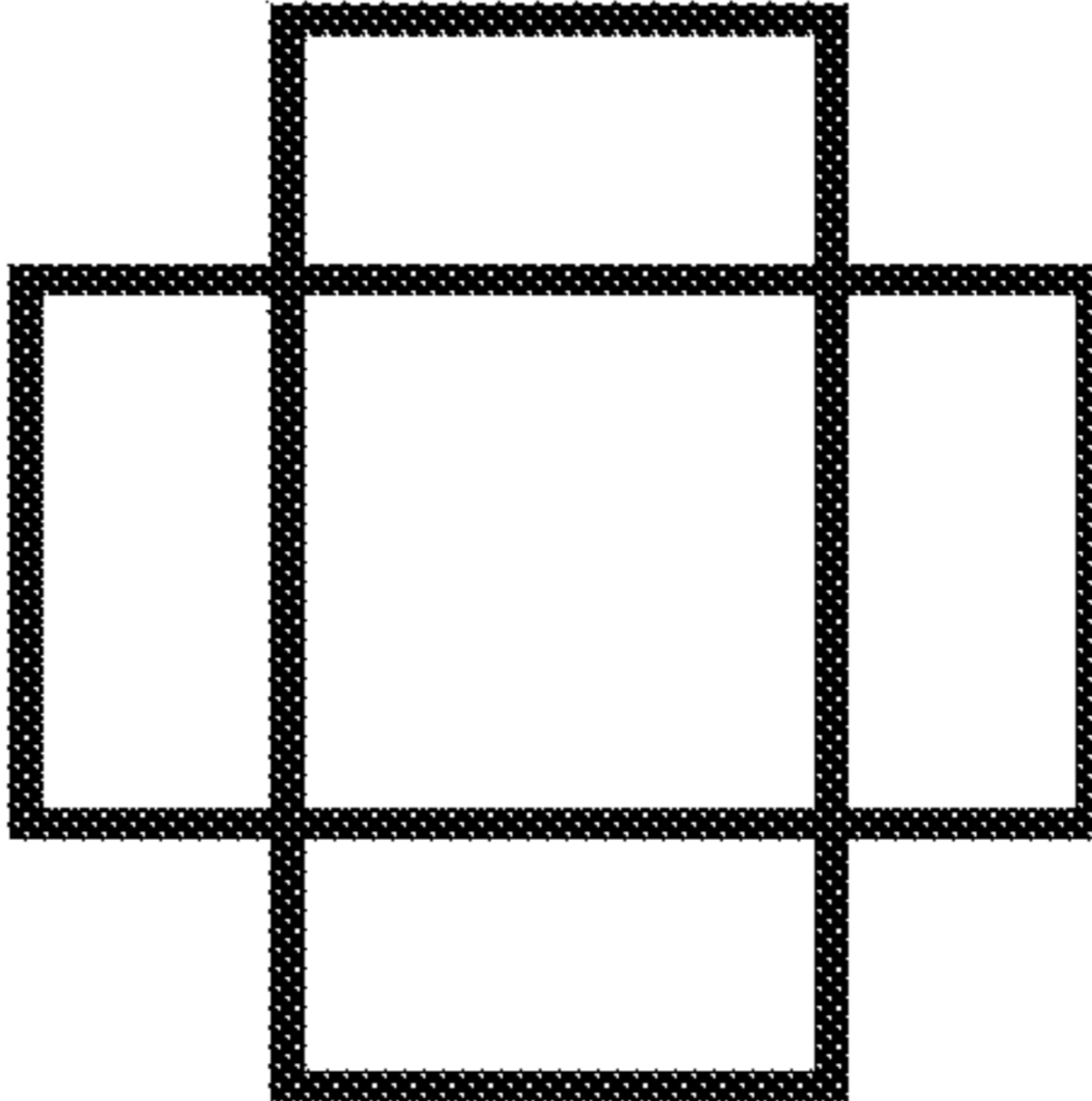

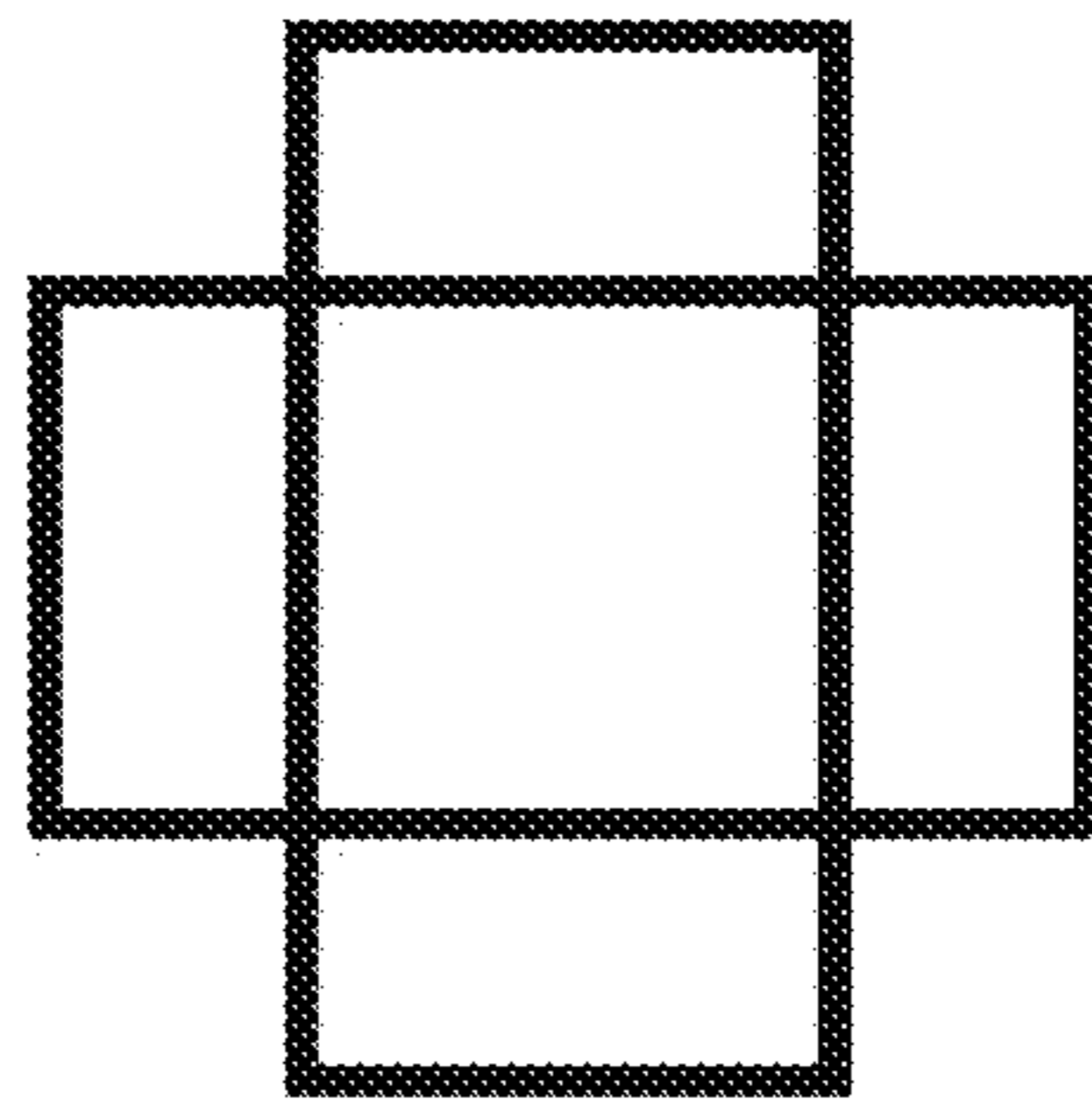

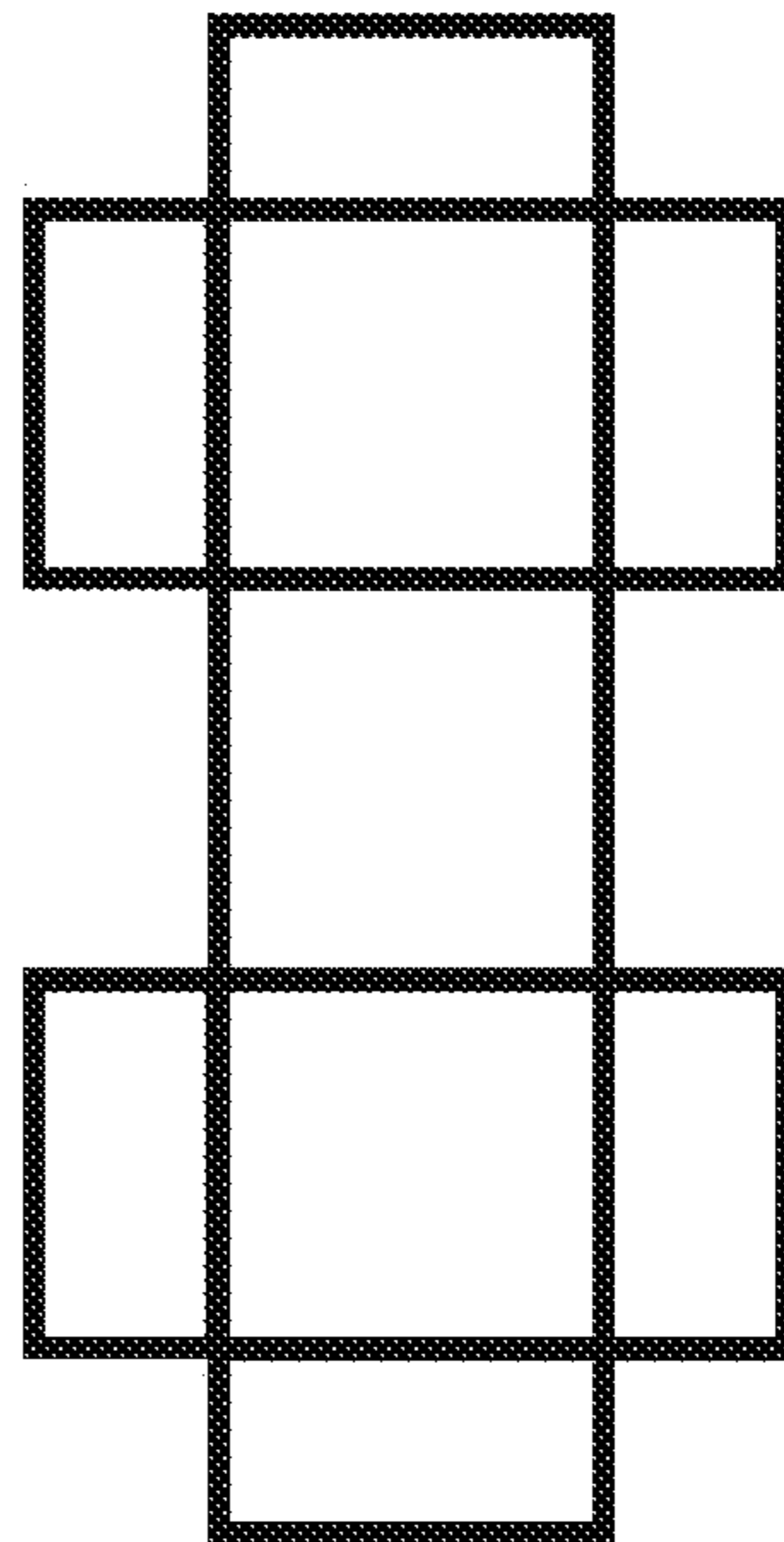

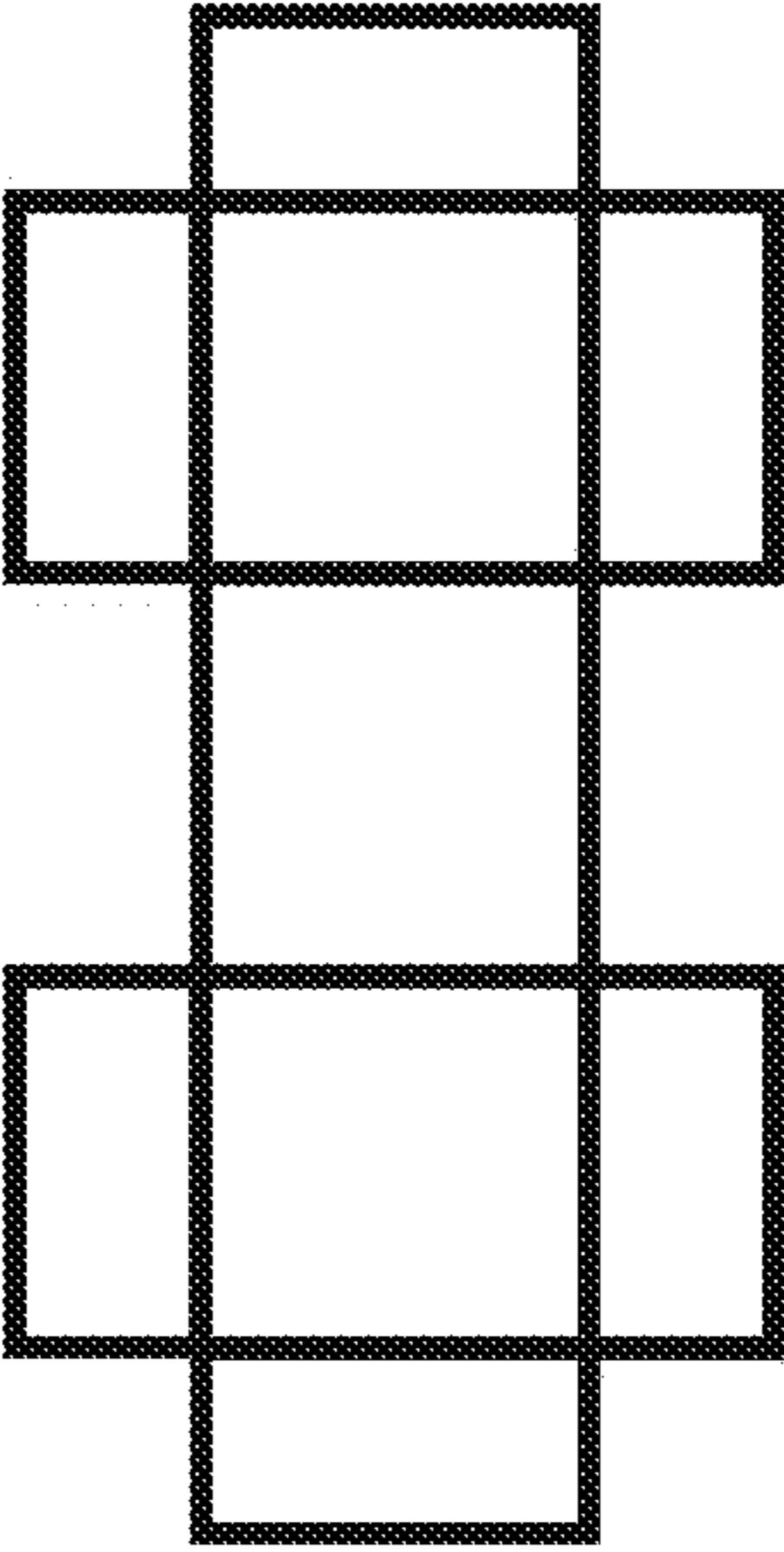

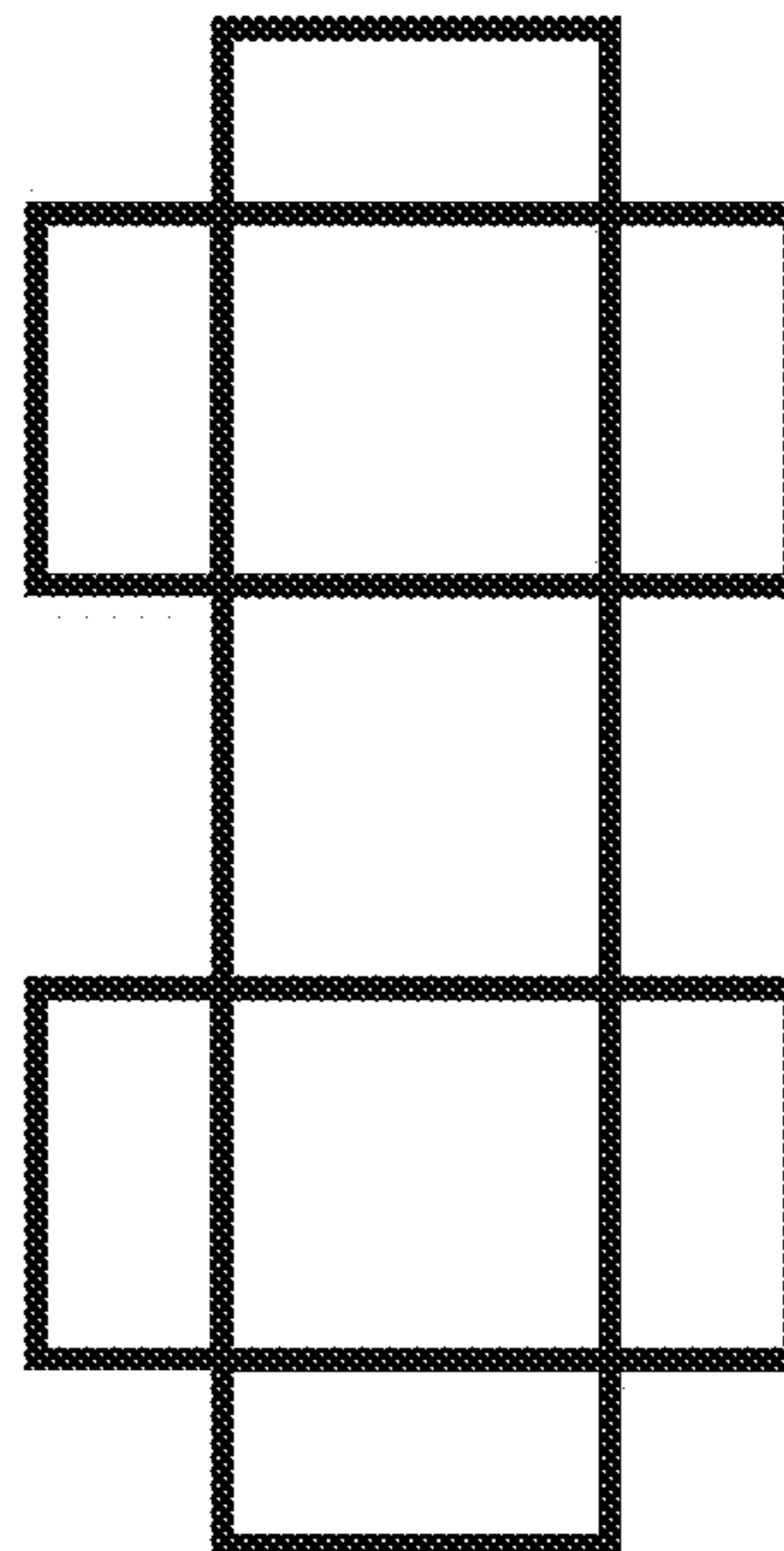

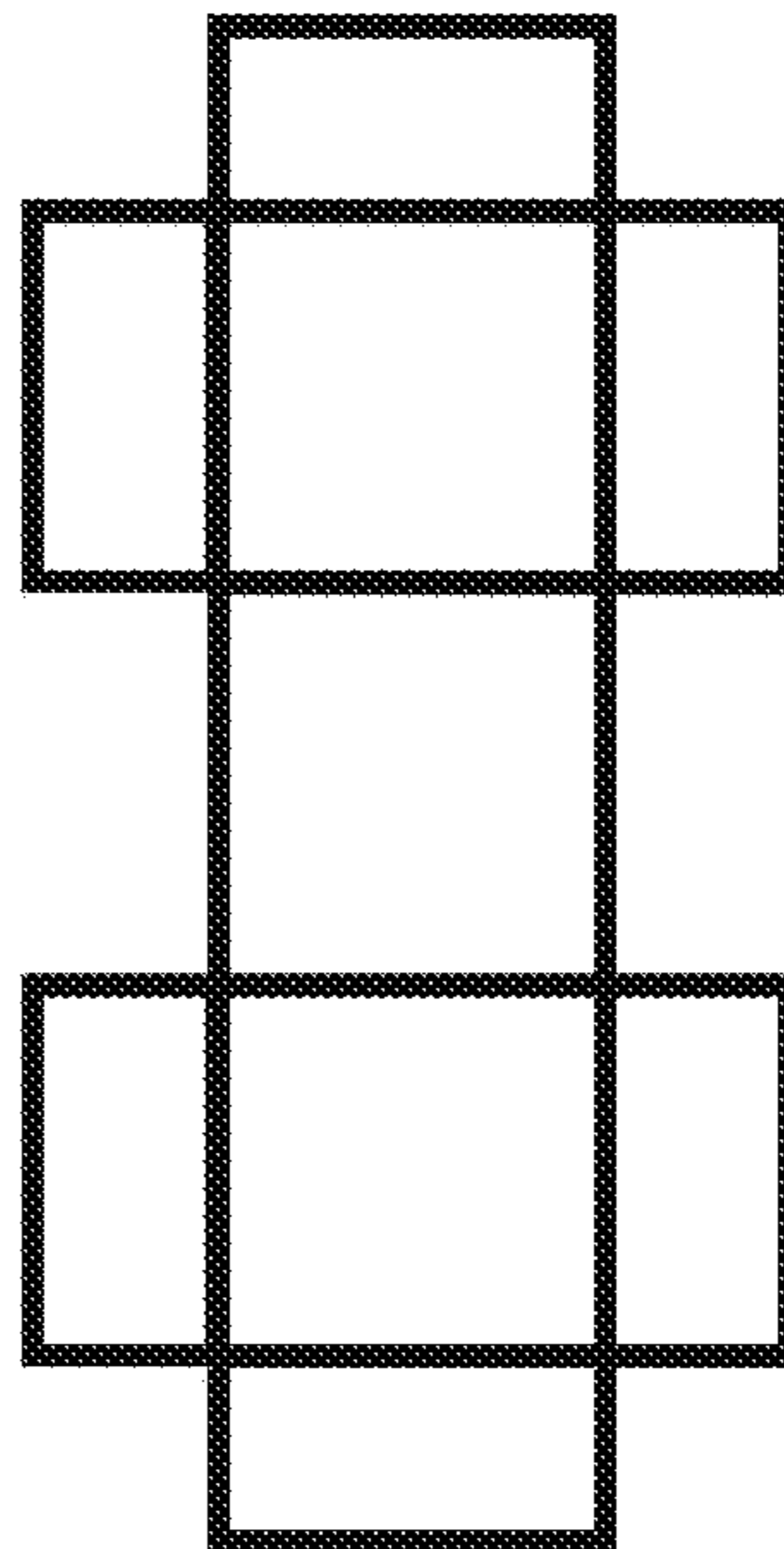

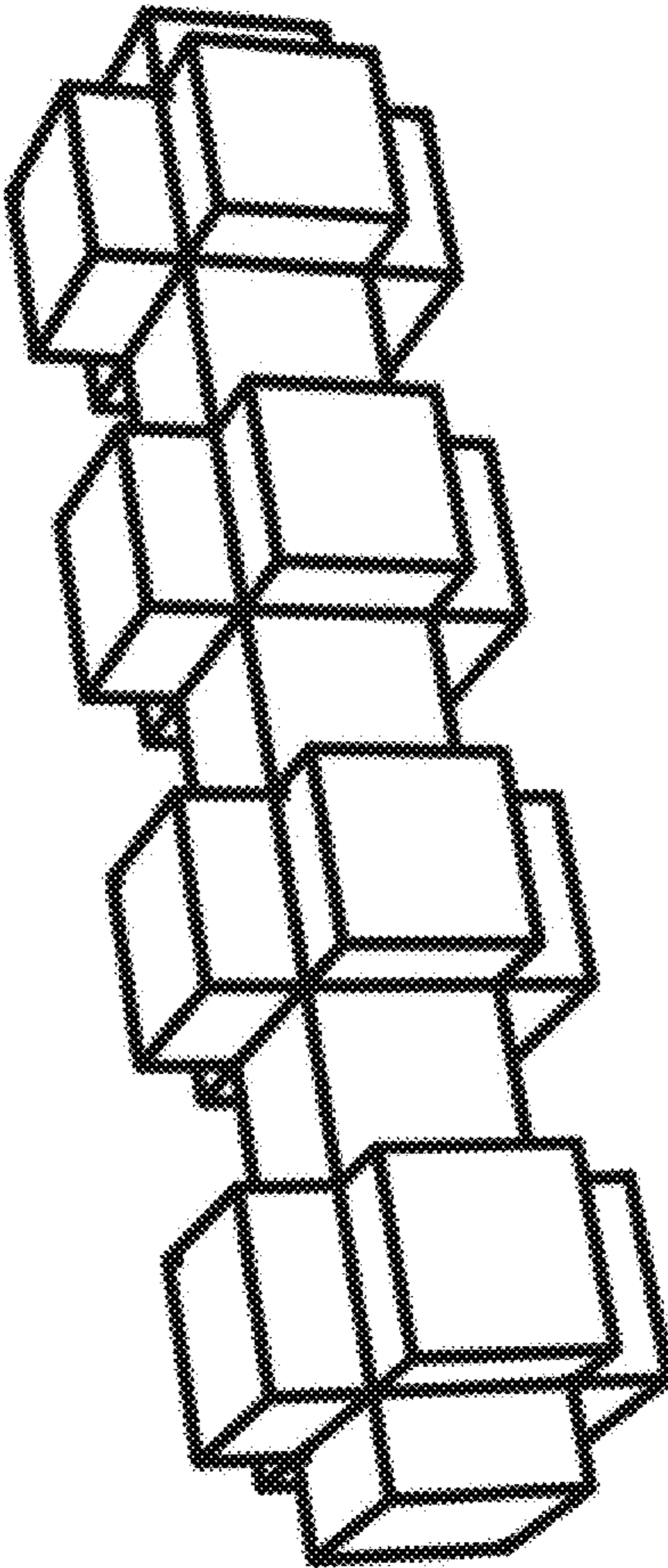

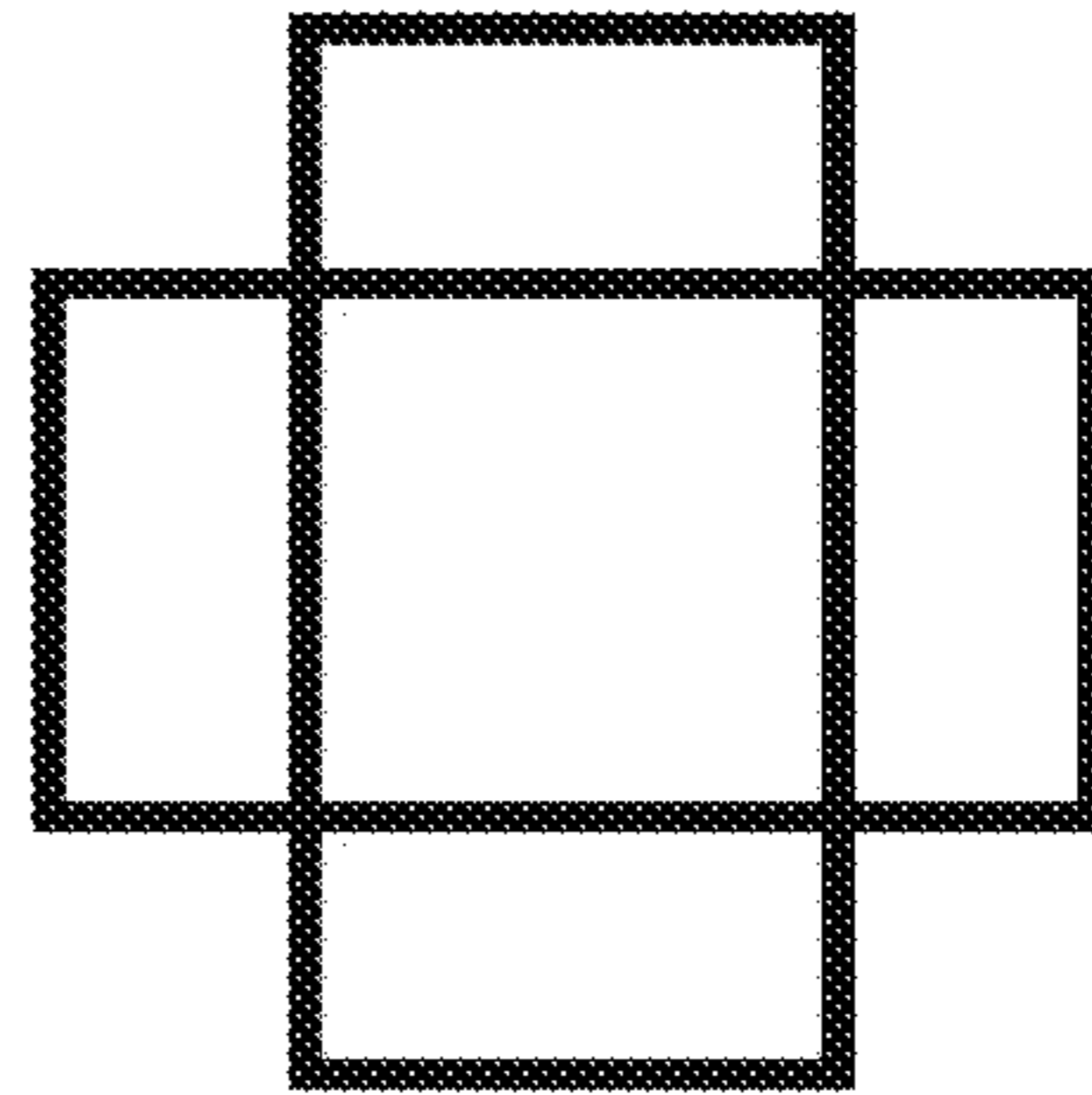

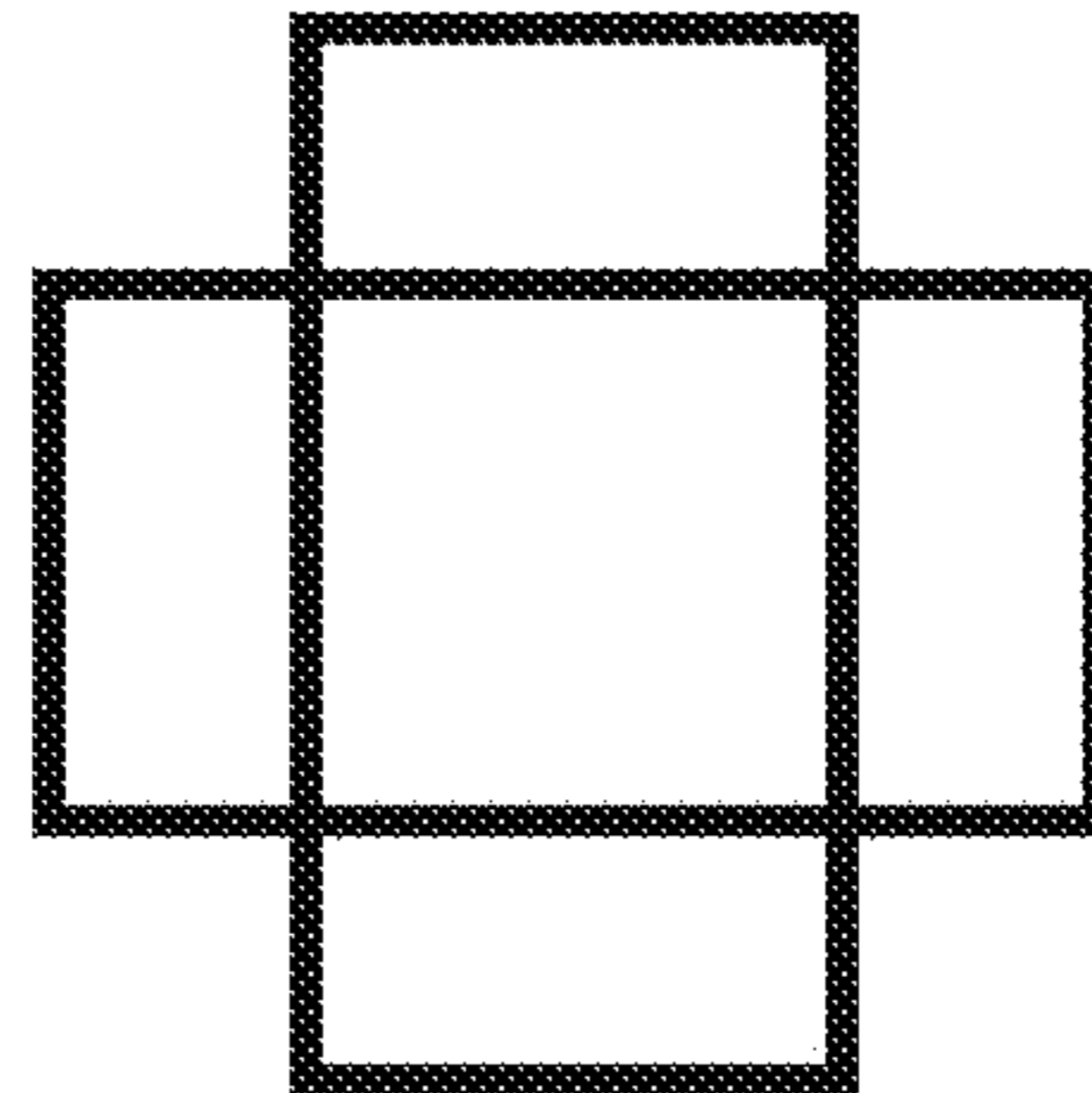

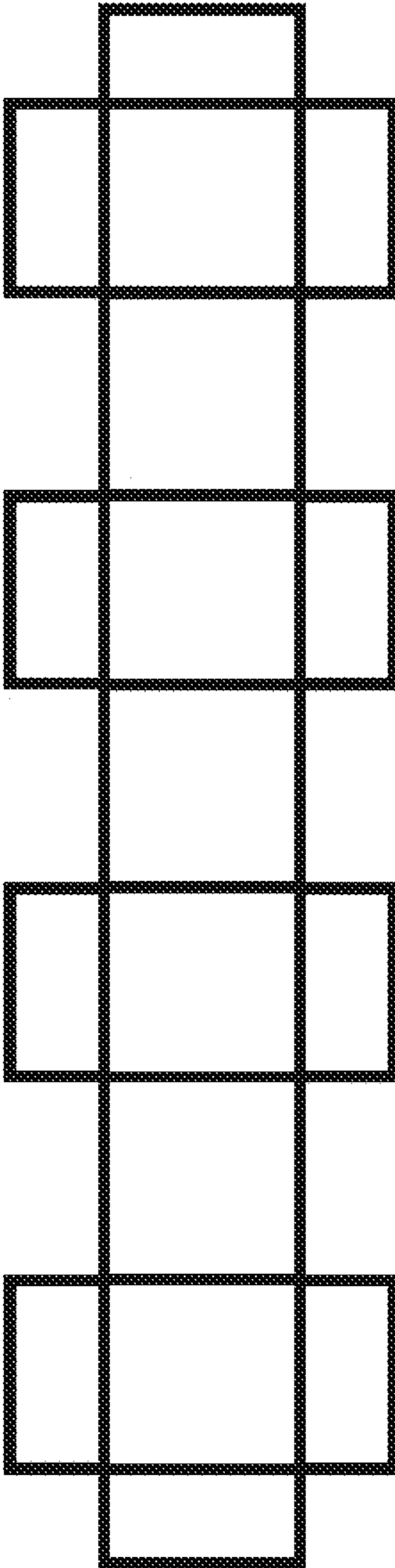

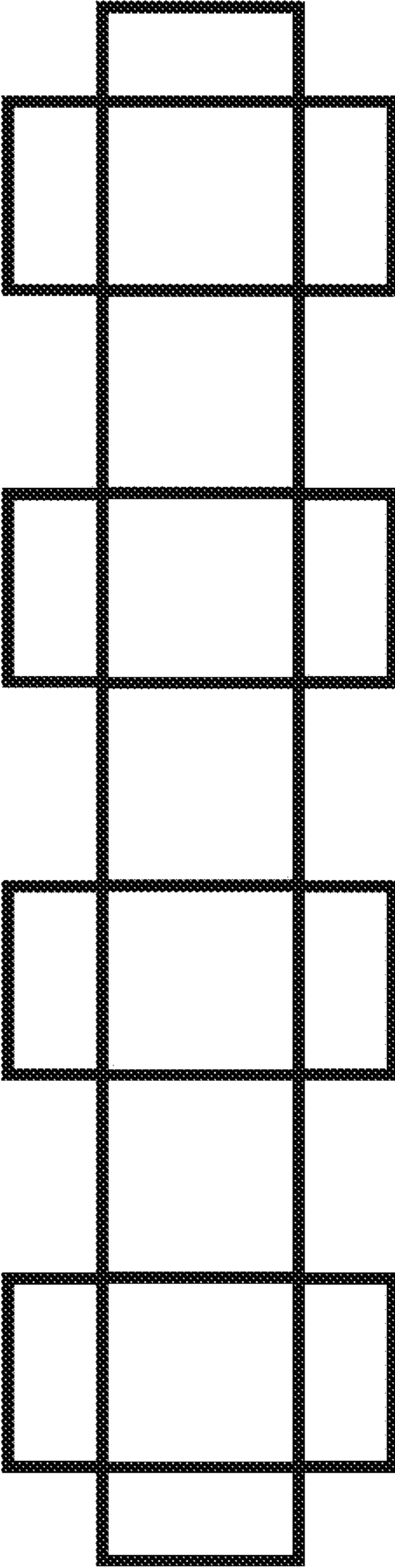

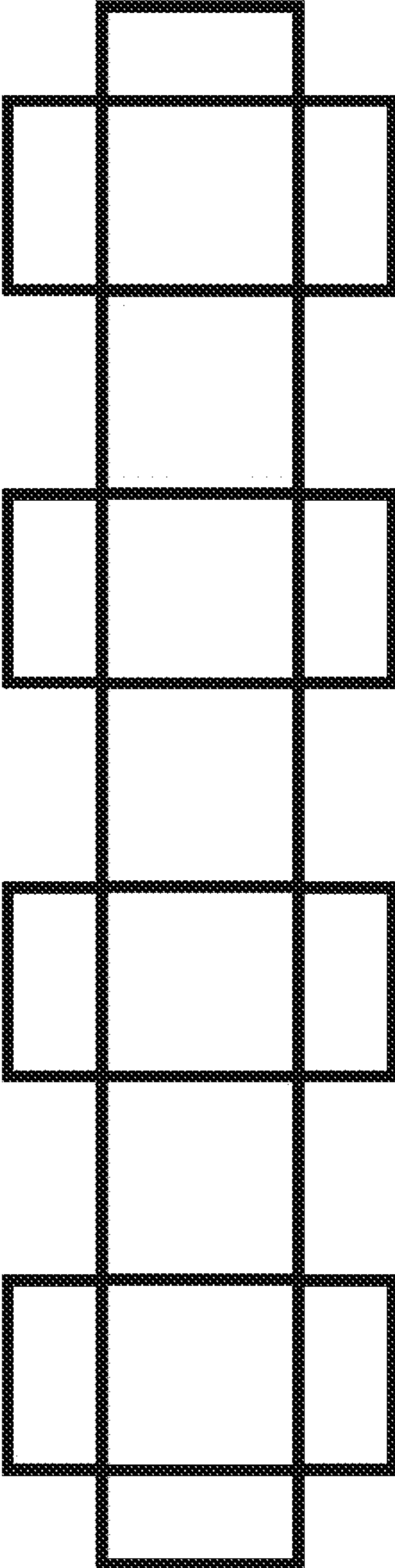

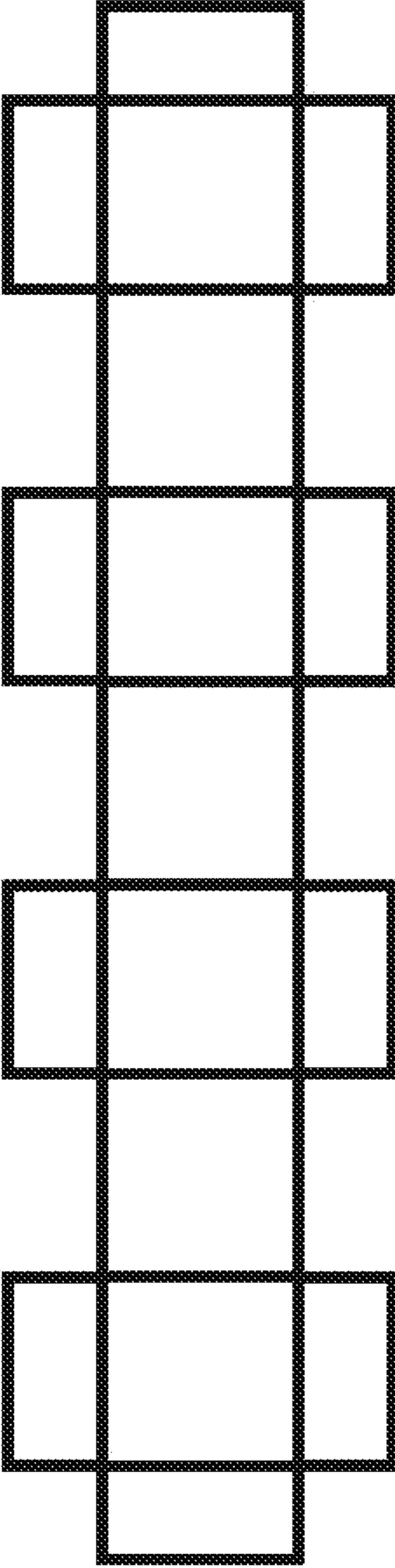

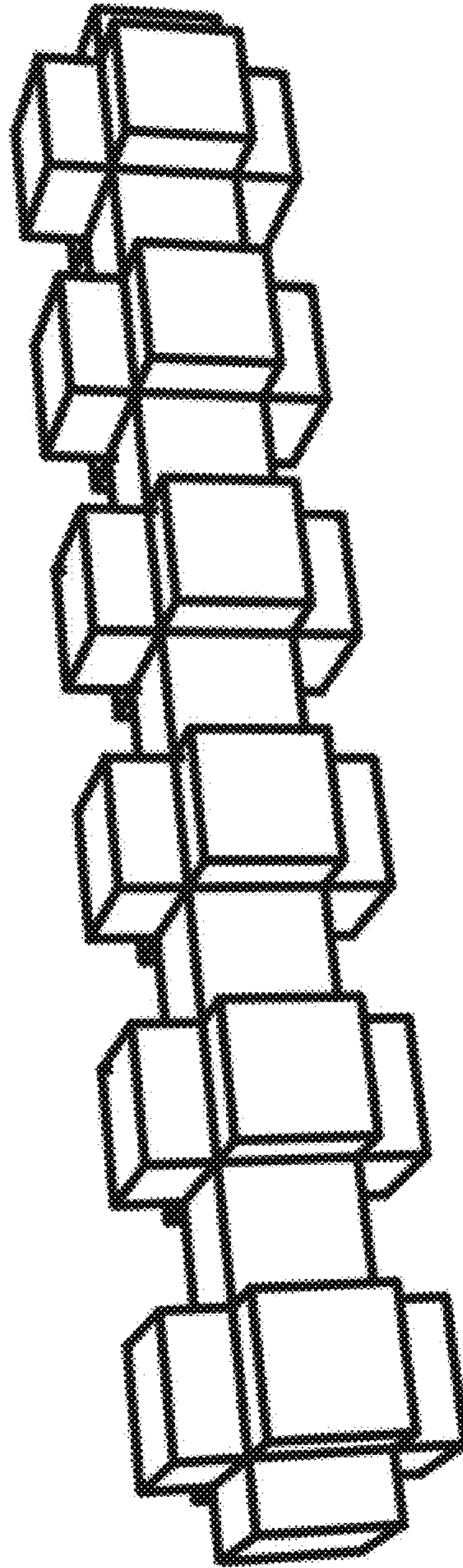

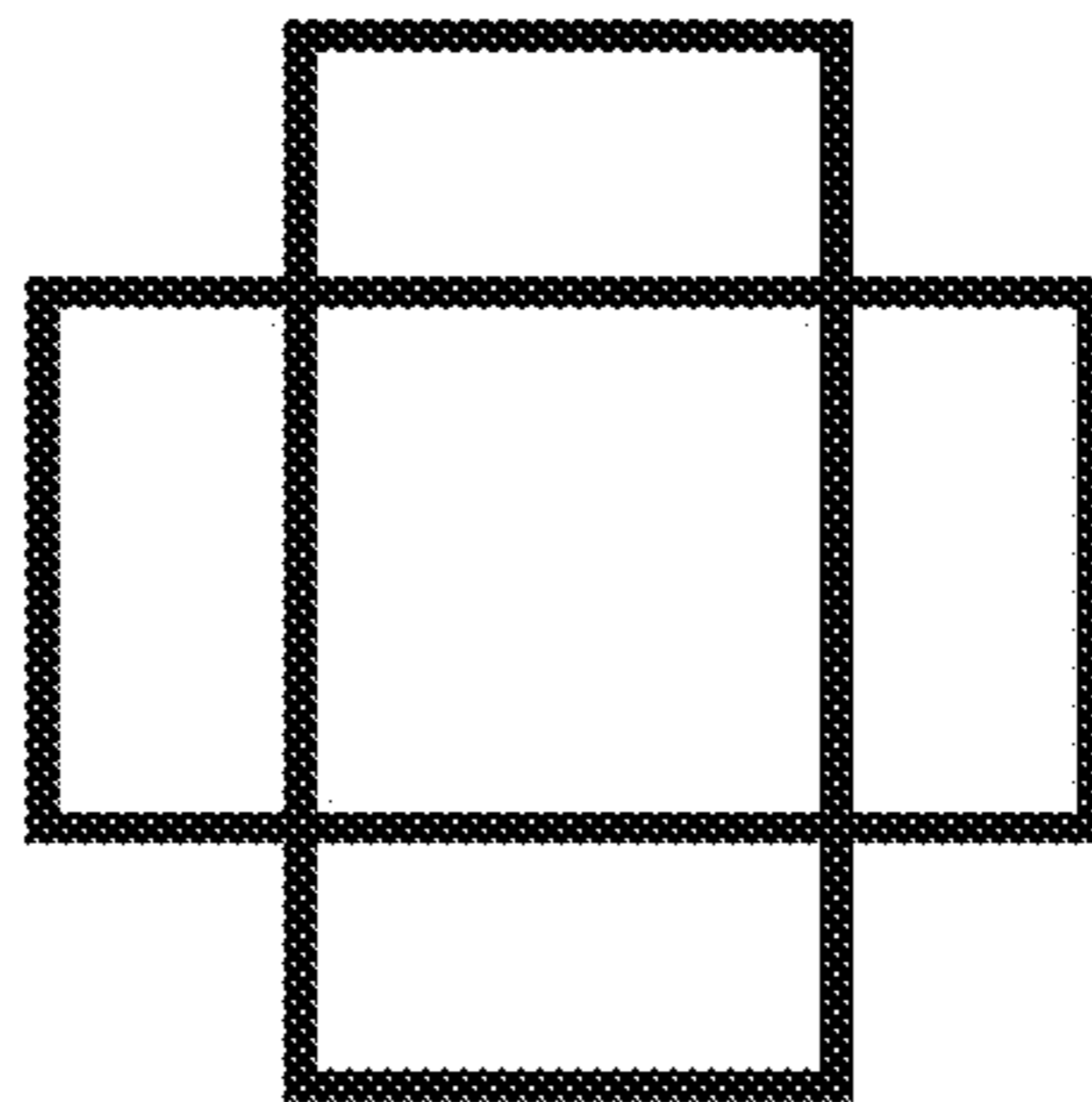

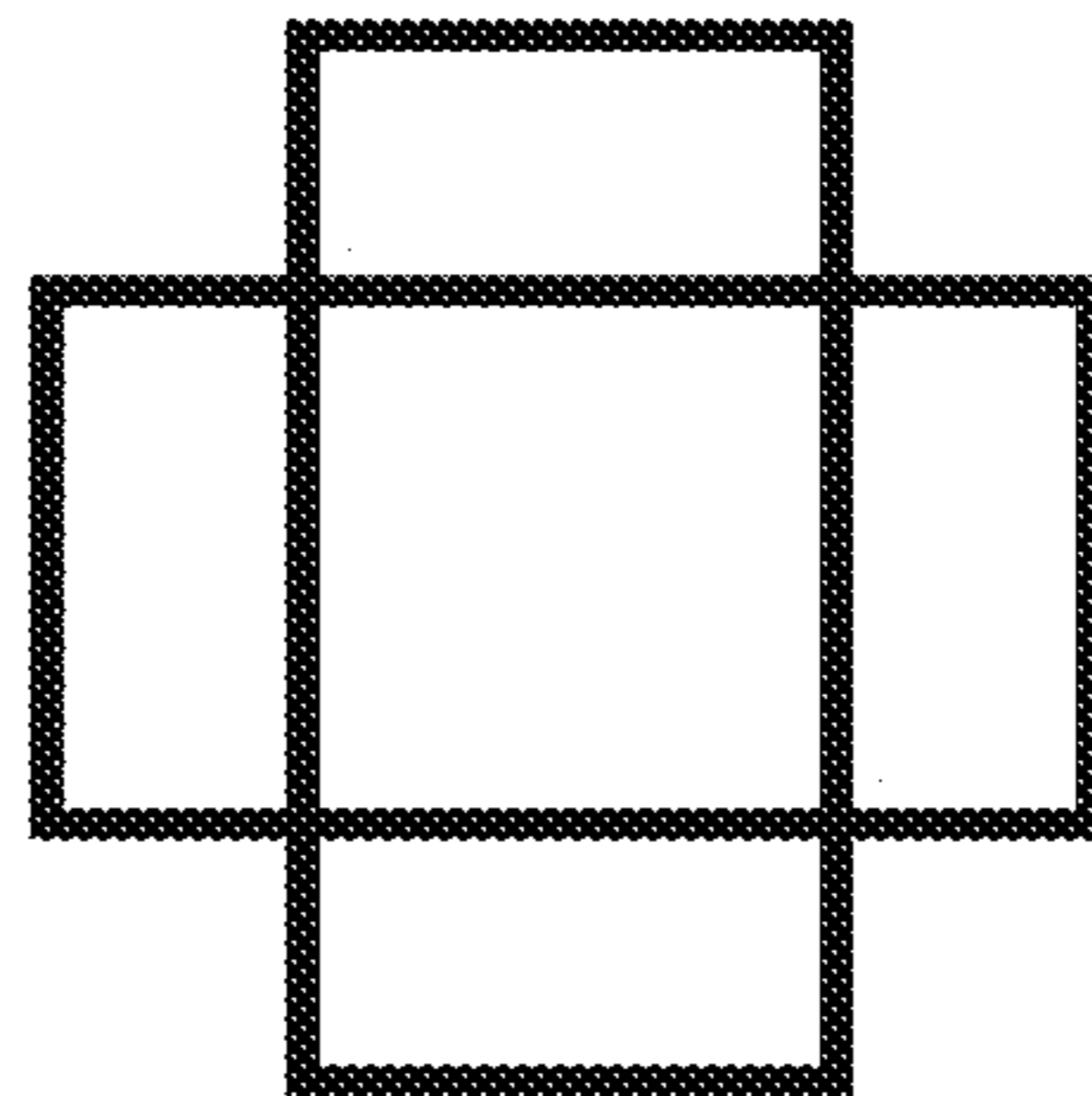

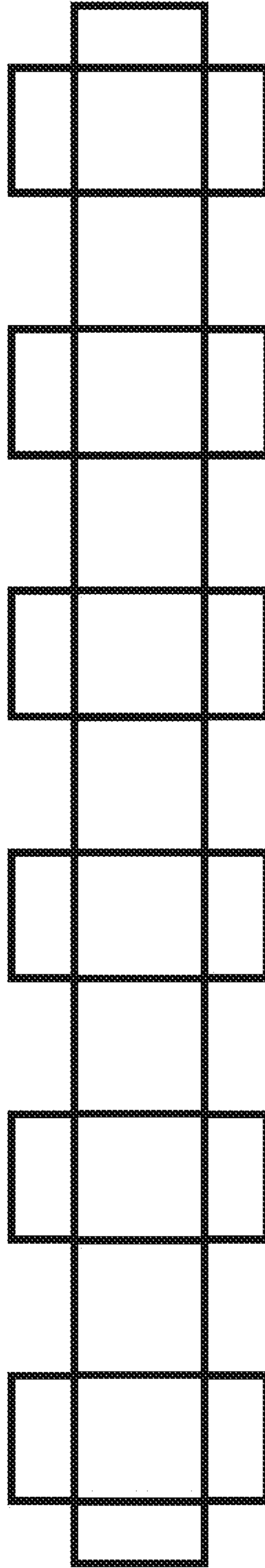

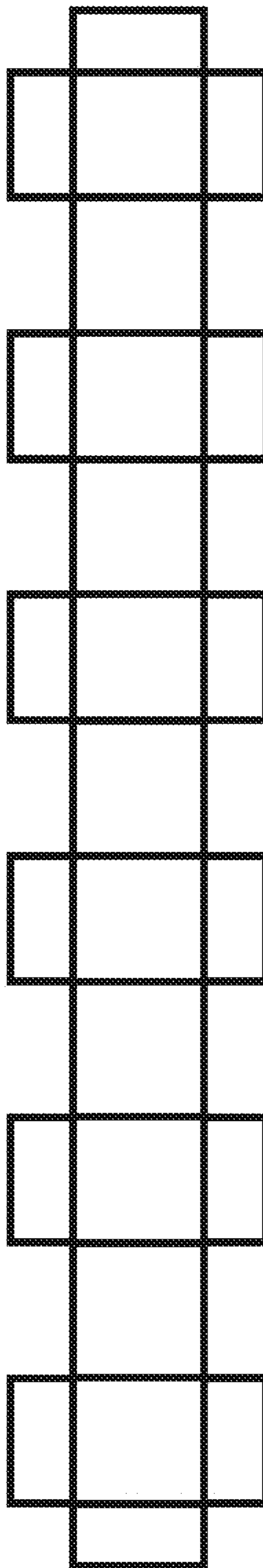

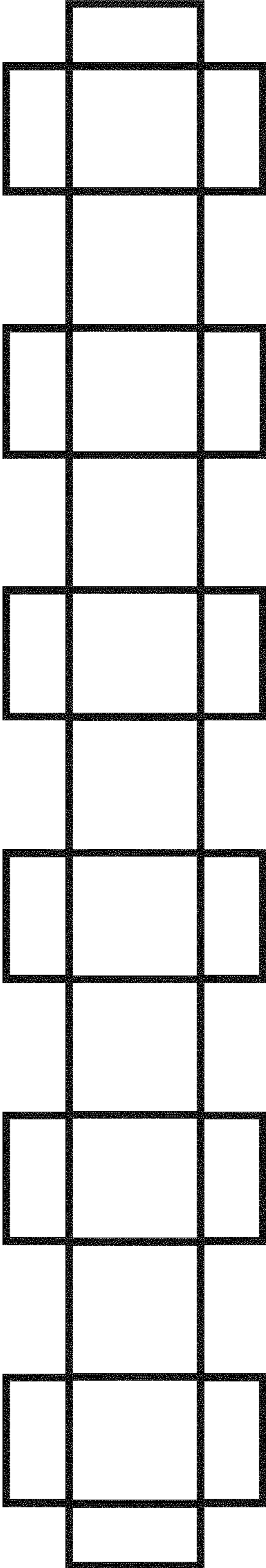
