(57) **CLAIM**

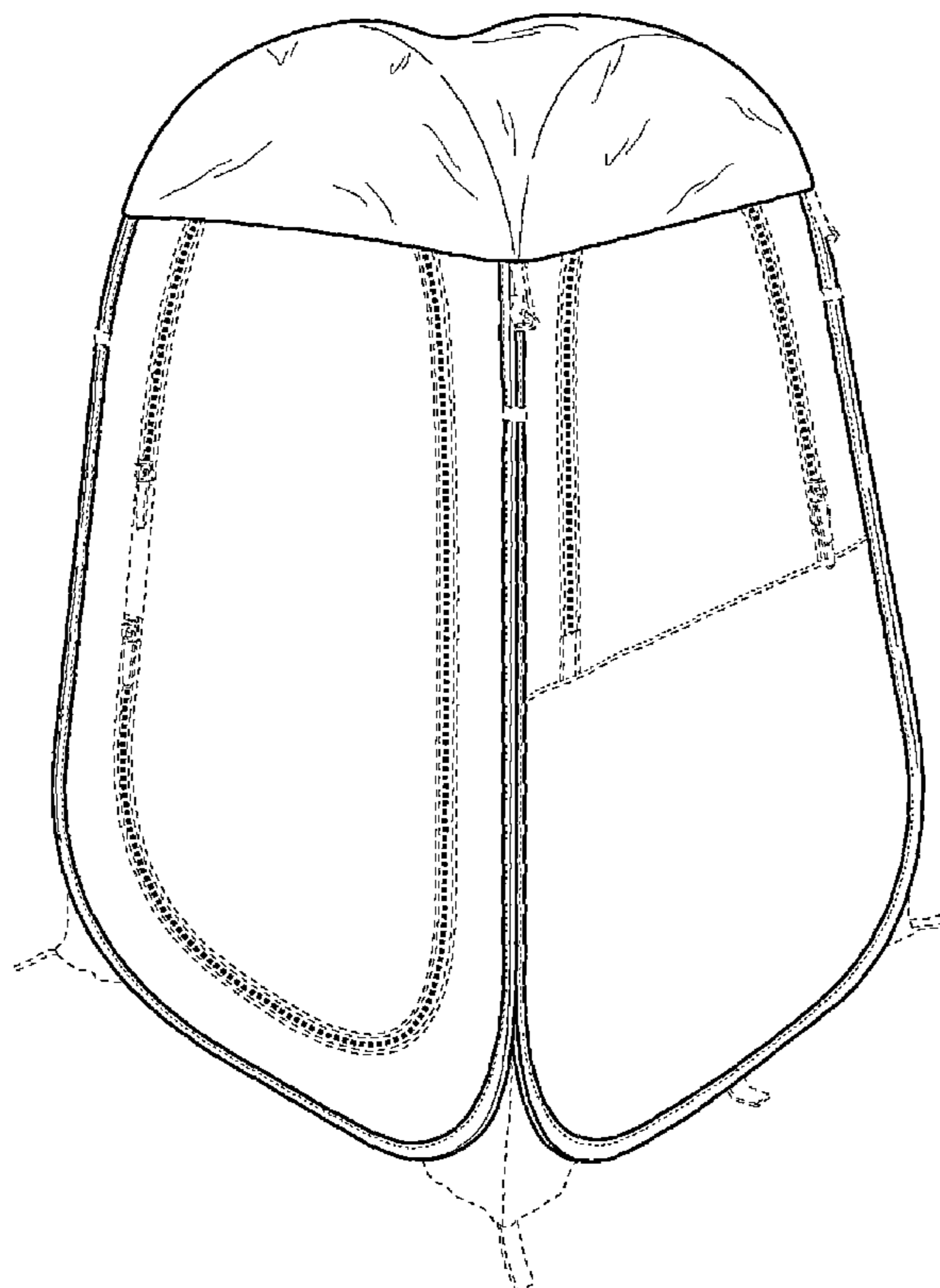
I claim the ornamental design for a personal enclosure, as shown and described.

DESCRIPTION

FIG. 1 is an elevated perspective view of a personal enclosure with a roof, showing my new design, from the left front; FIG. 2 is a frontal view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left profile view thereof; FIG. 5 is a right profile view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

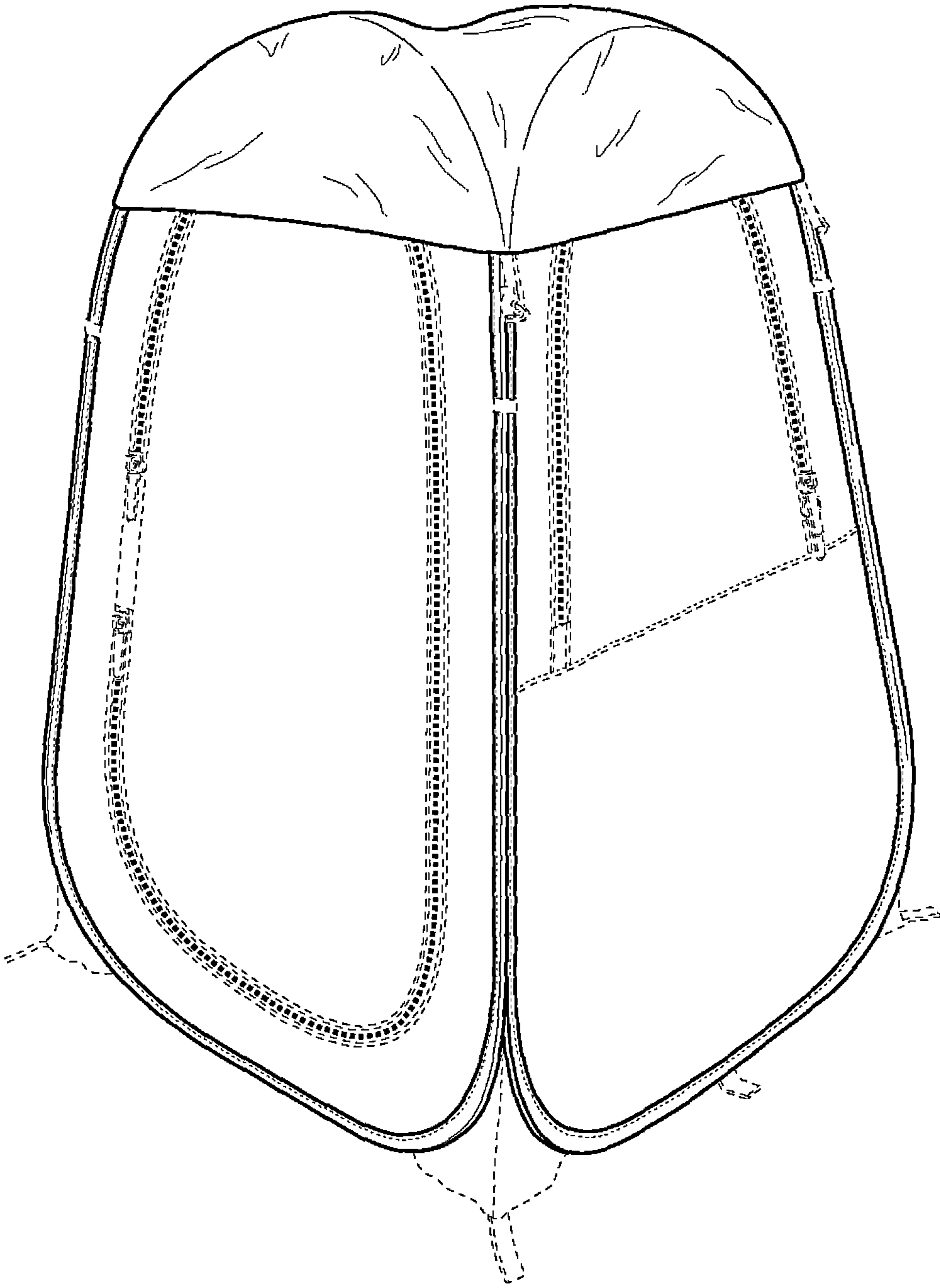

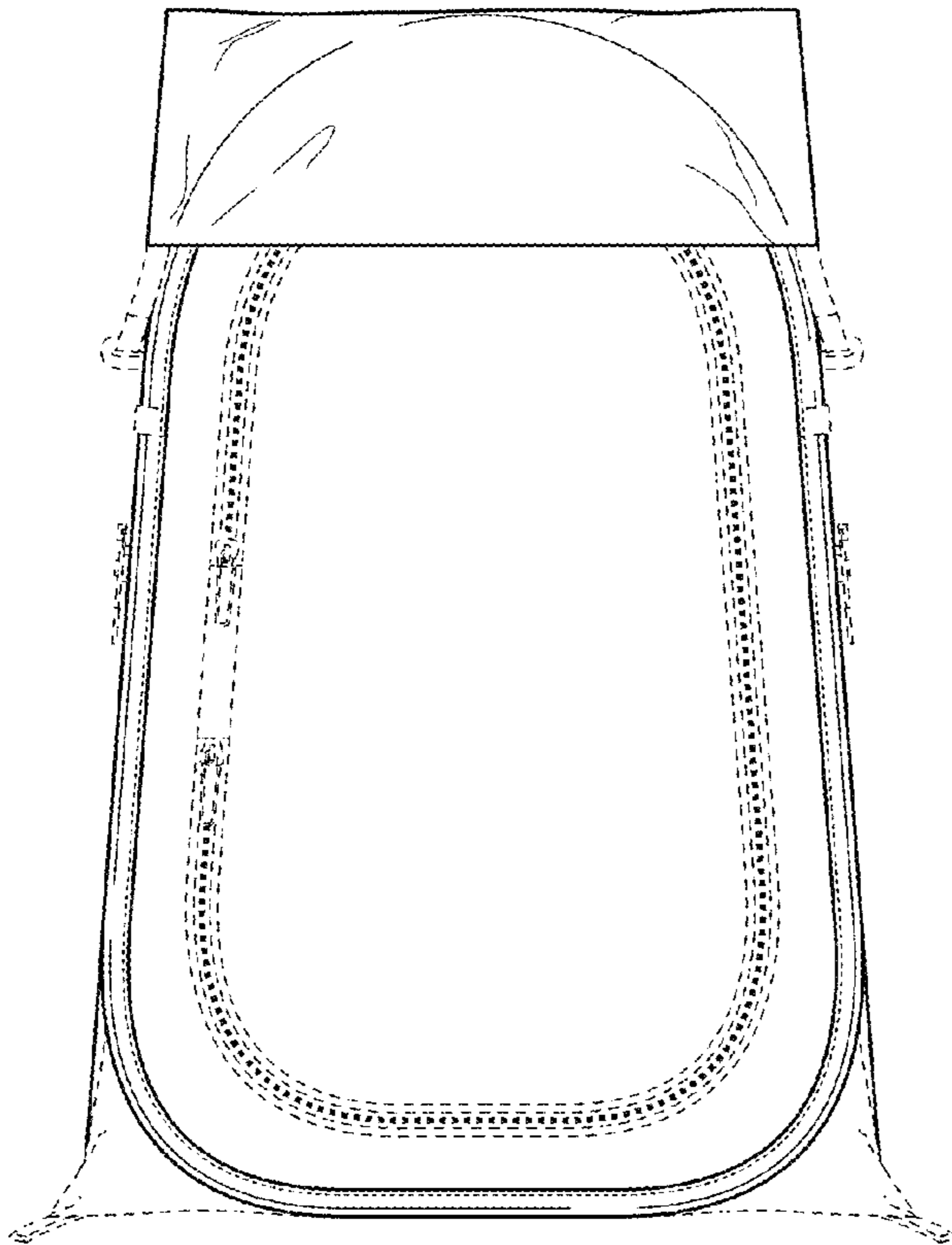

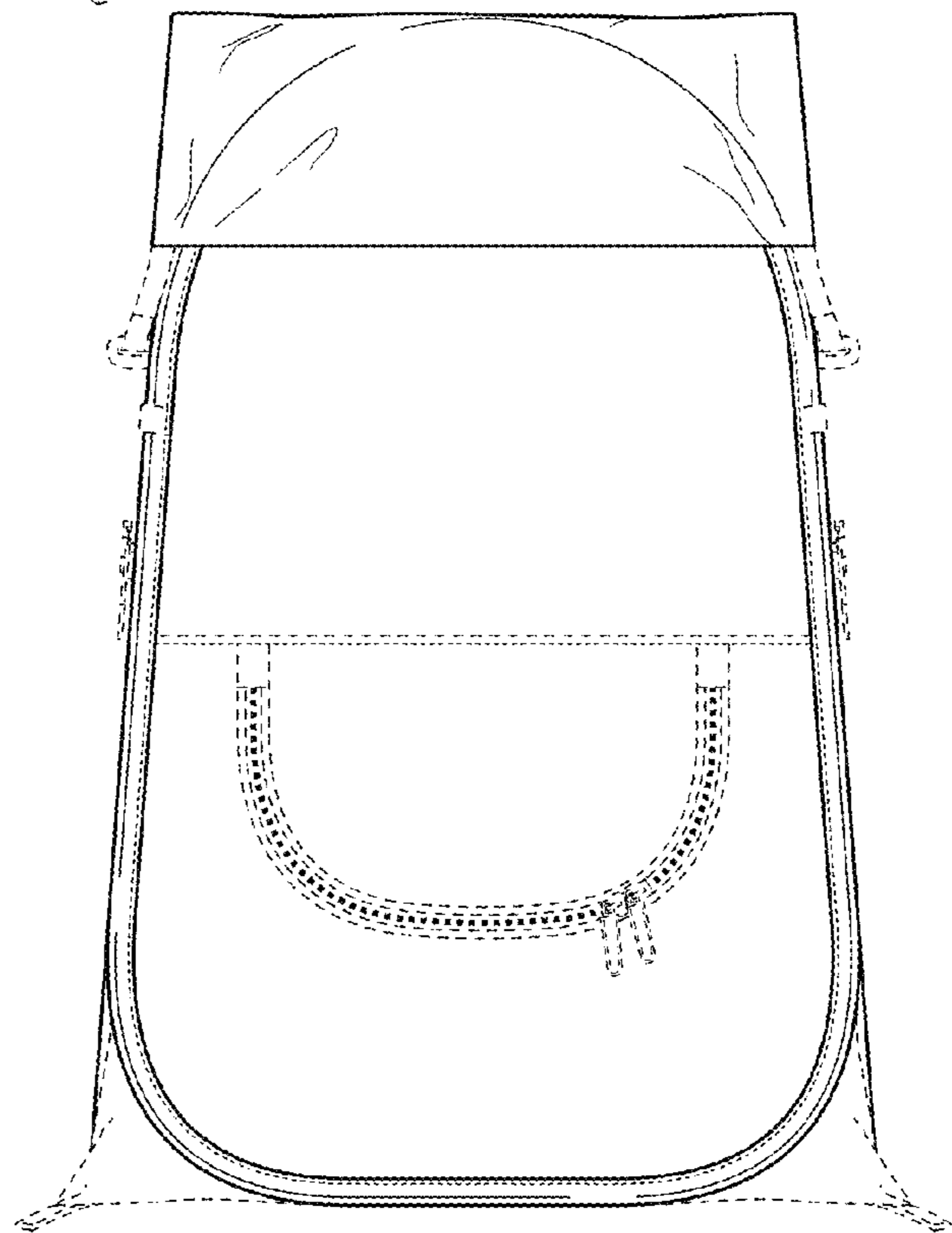

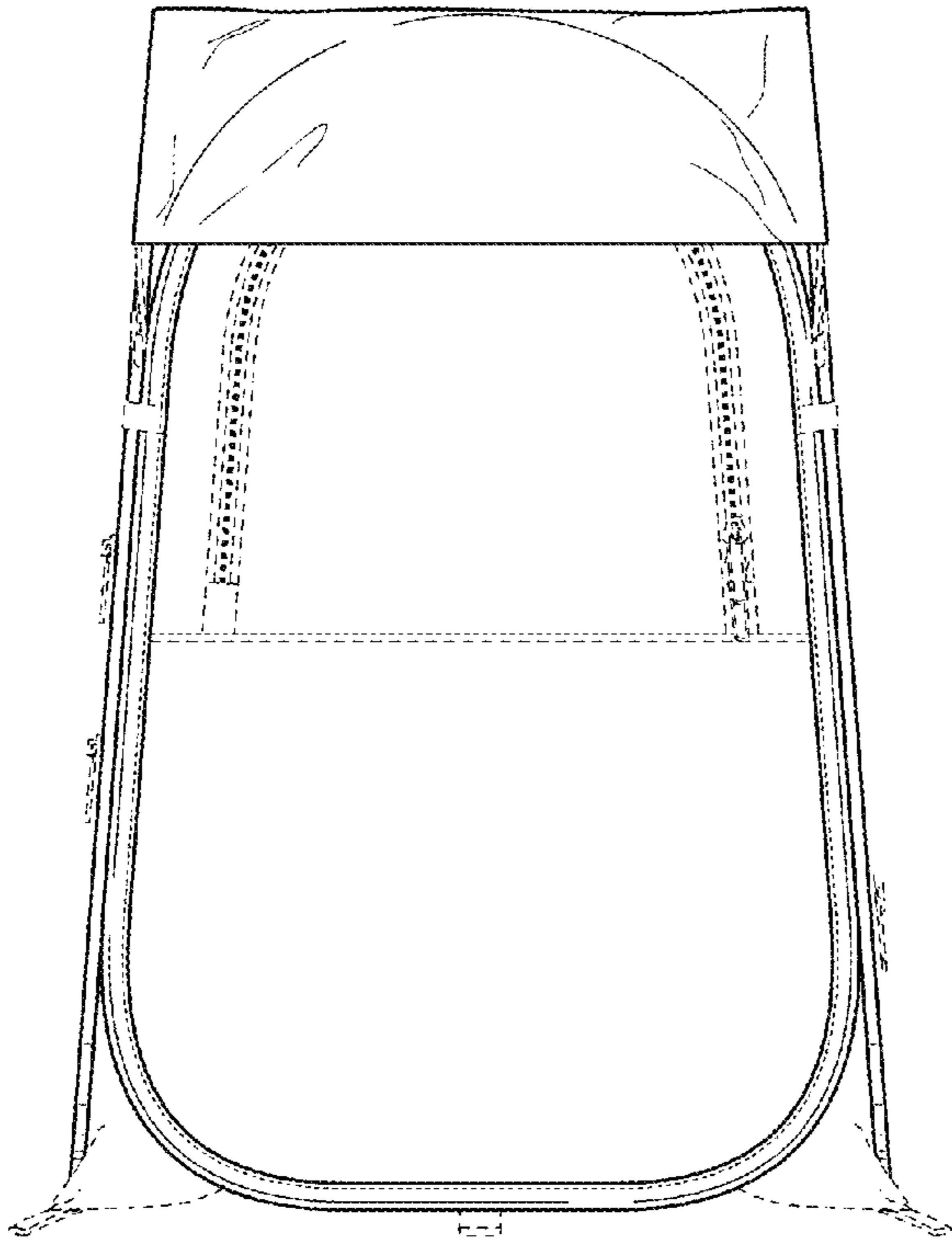

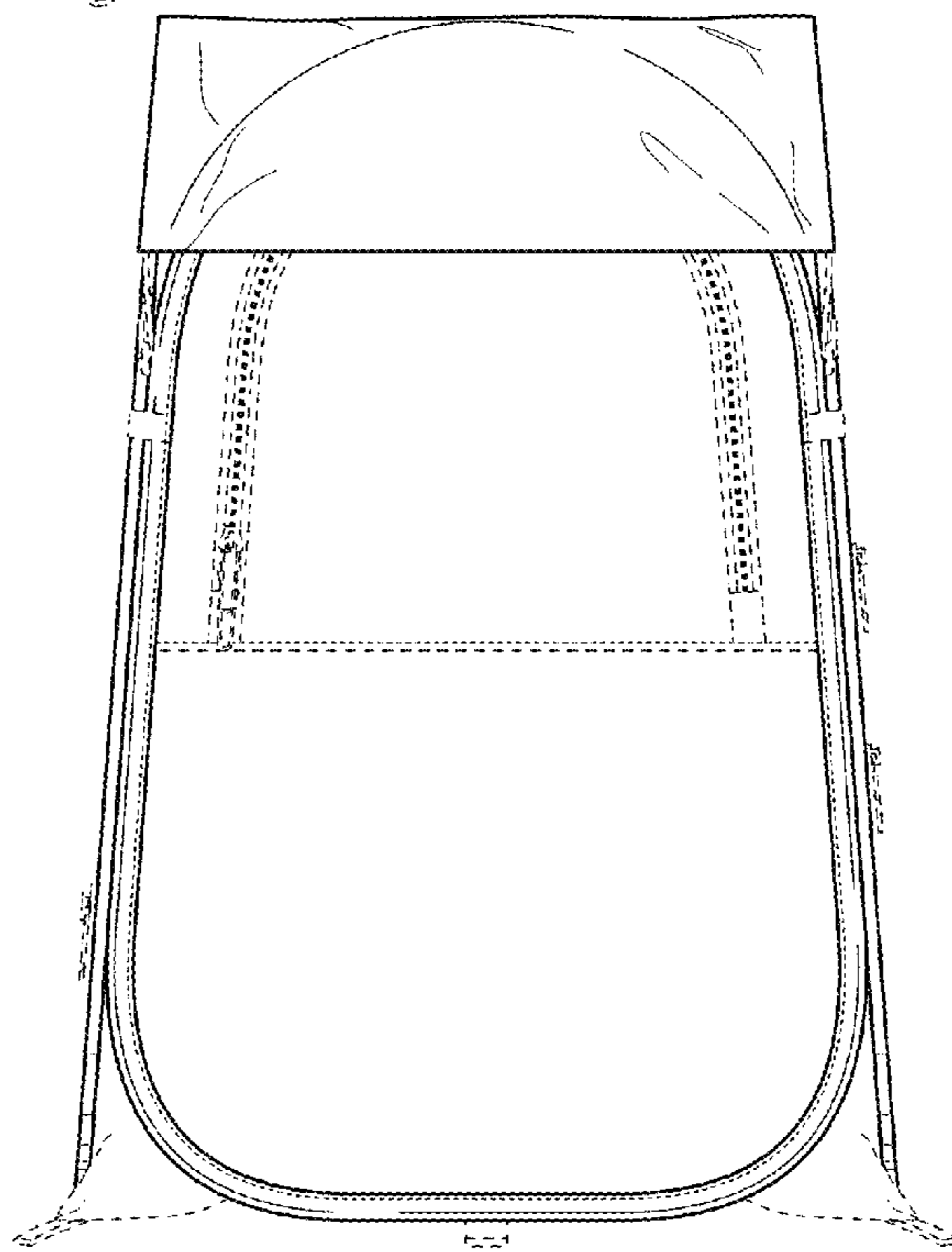

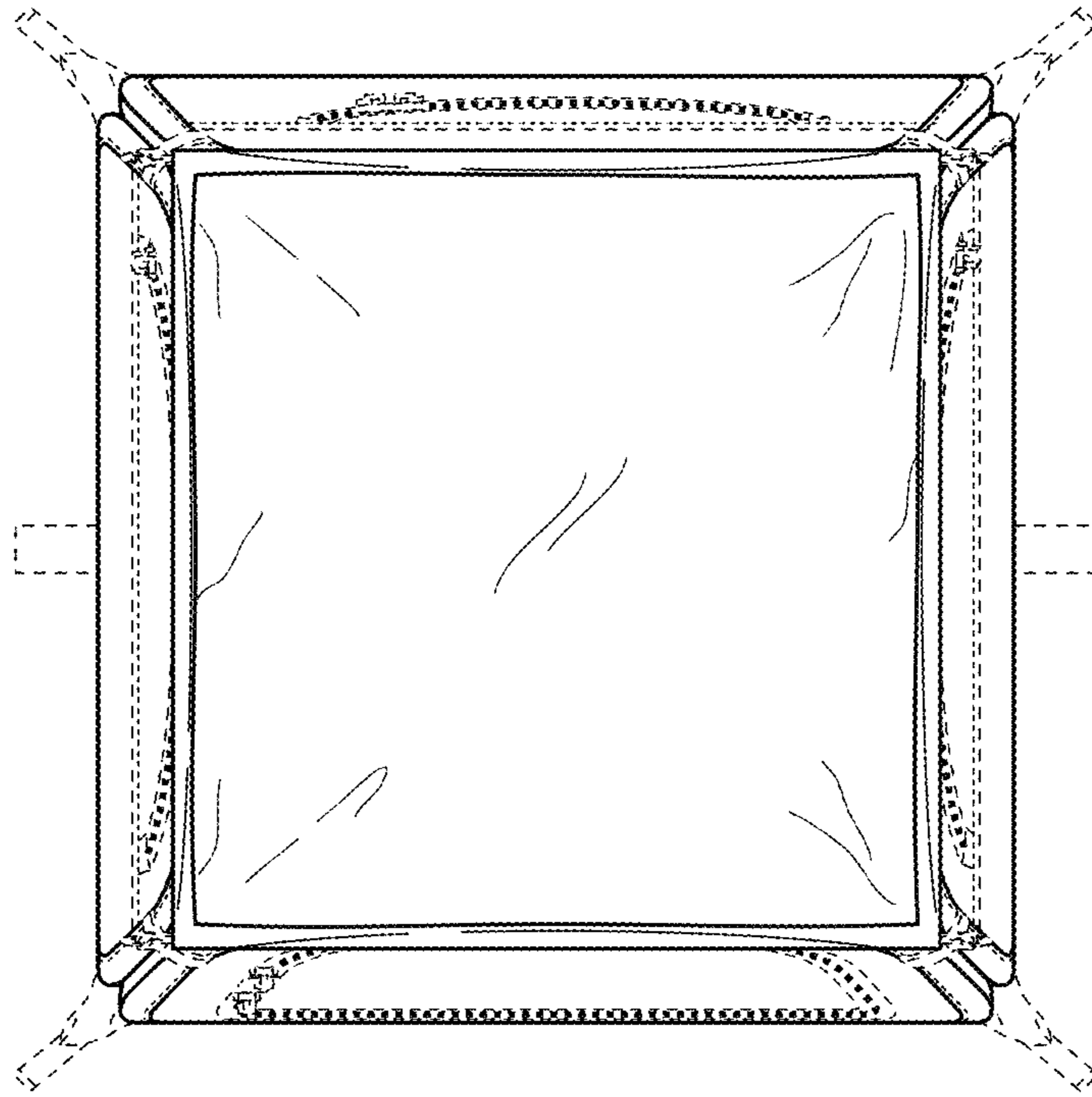

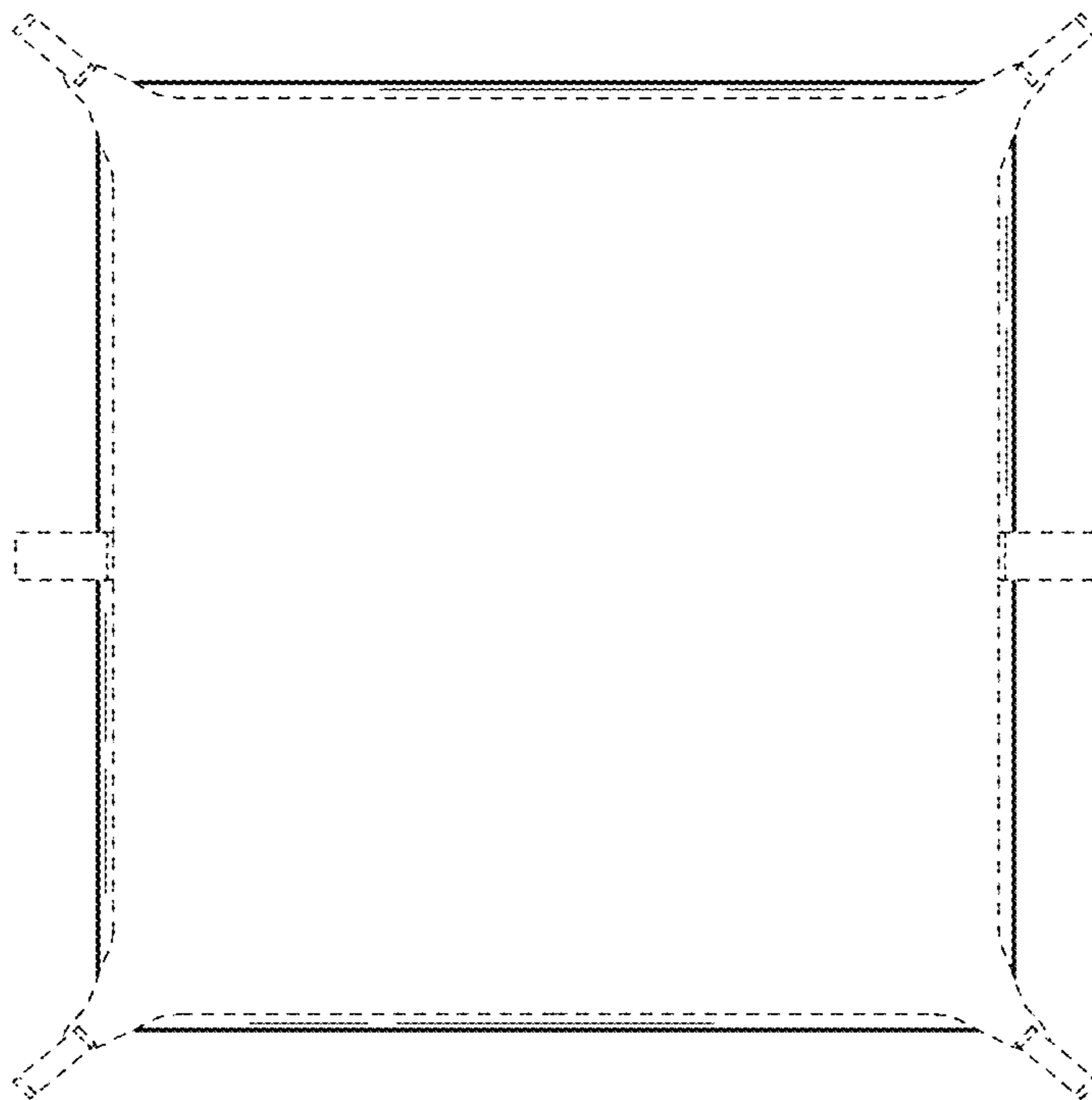
