(57) **CLAIM**

The ornamental design for a roller for cosmetic purposes, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a roller for cosmetic purposes showing my new design;
FIG. 2 is a left side elevation view thereof;
FIG. 3 is a right side elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a top, front perspective view thereof;
FIG. 7 is a bottom, front perspective view thereof;
FIG. 8 is a cross-sectional view taken along line A-A in FIG. 1;
FIG. 9 is an enlarged cross-sectional view taken along line B-B in FIG. 1; and,
FIG. 10 is a top, front perspective view showing the solar panel in the handle and the rollers on the bottom side.

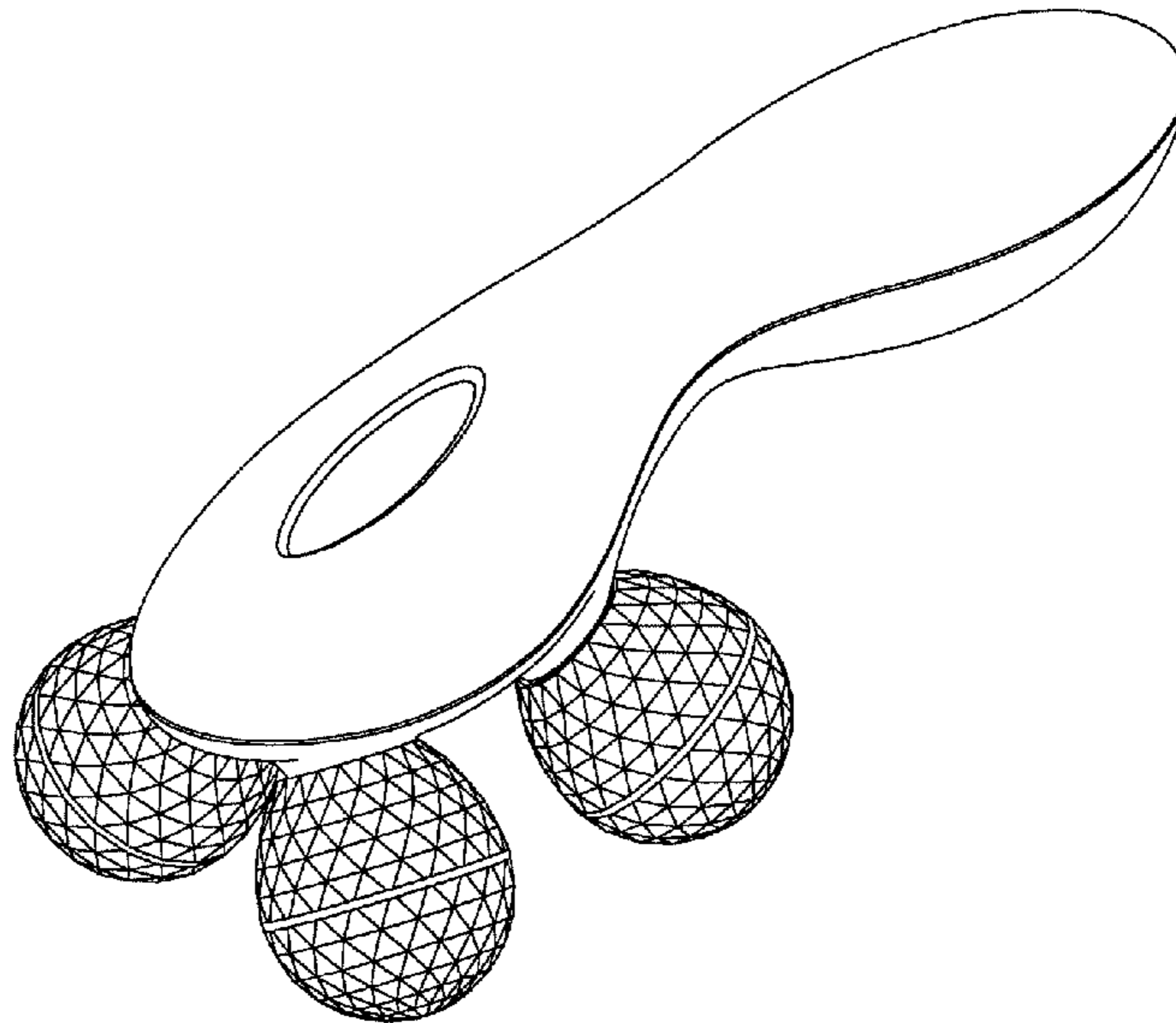

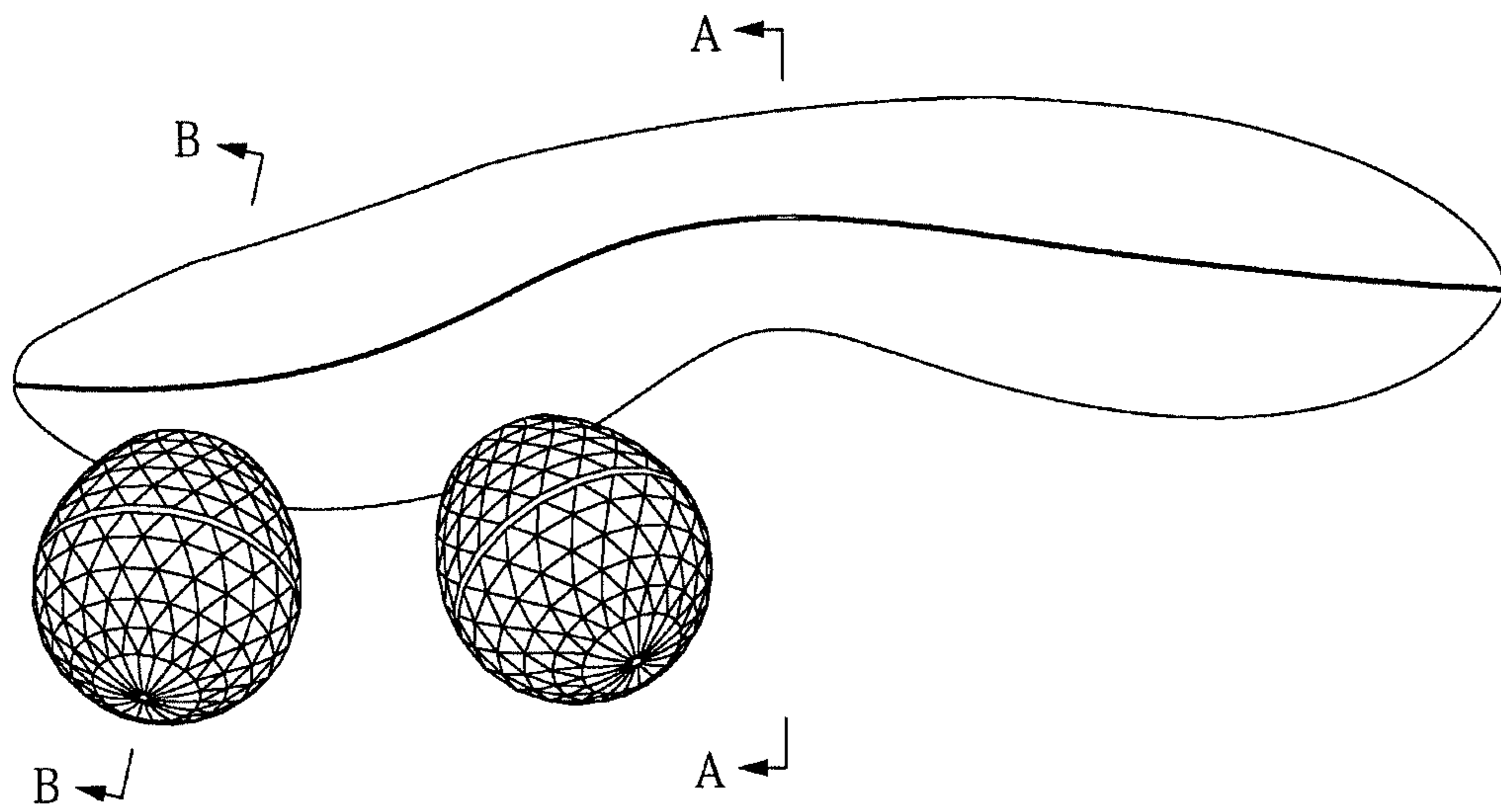

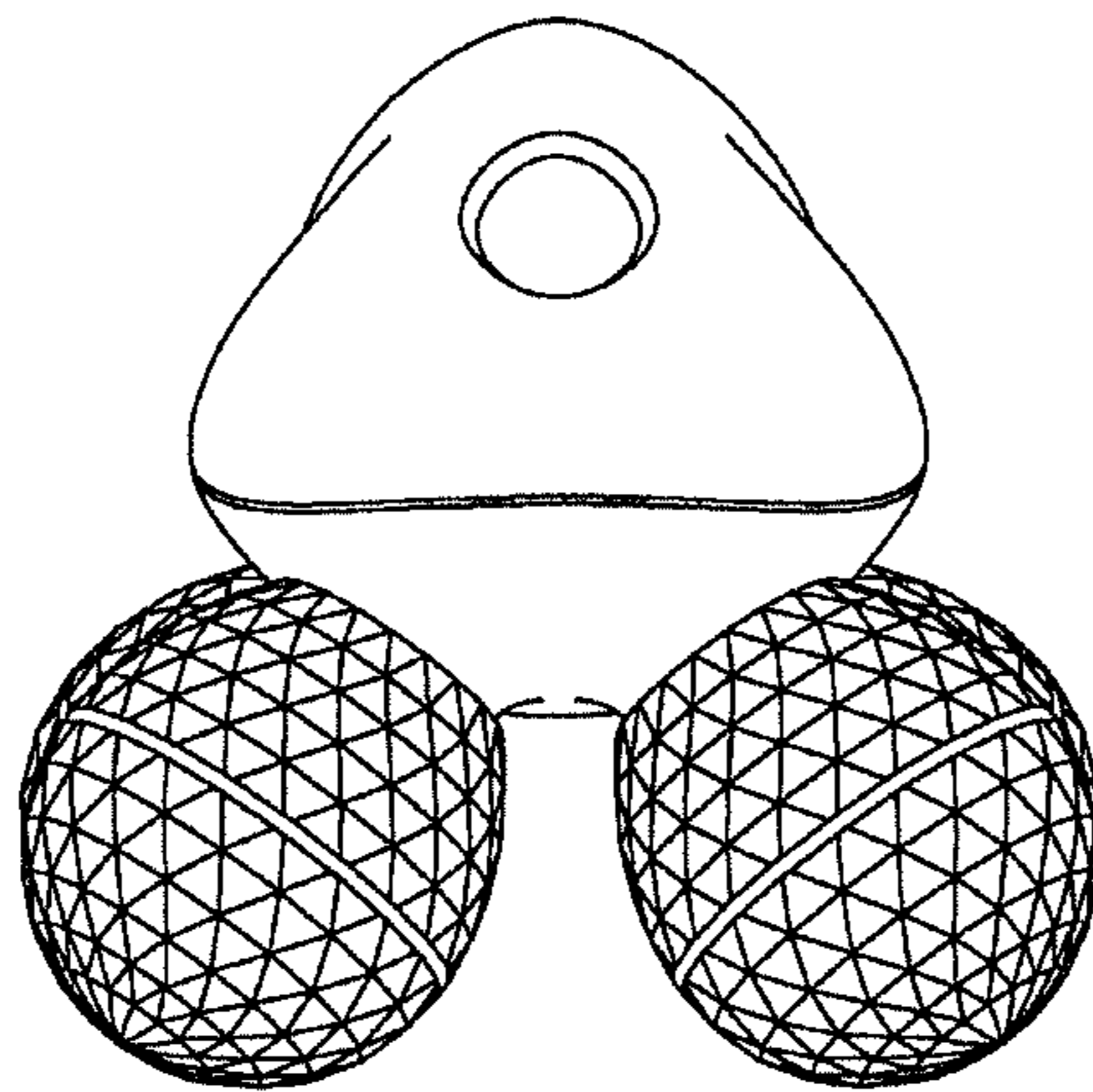

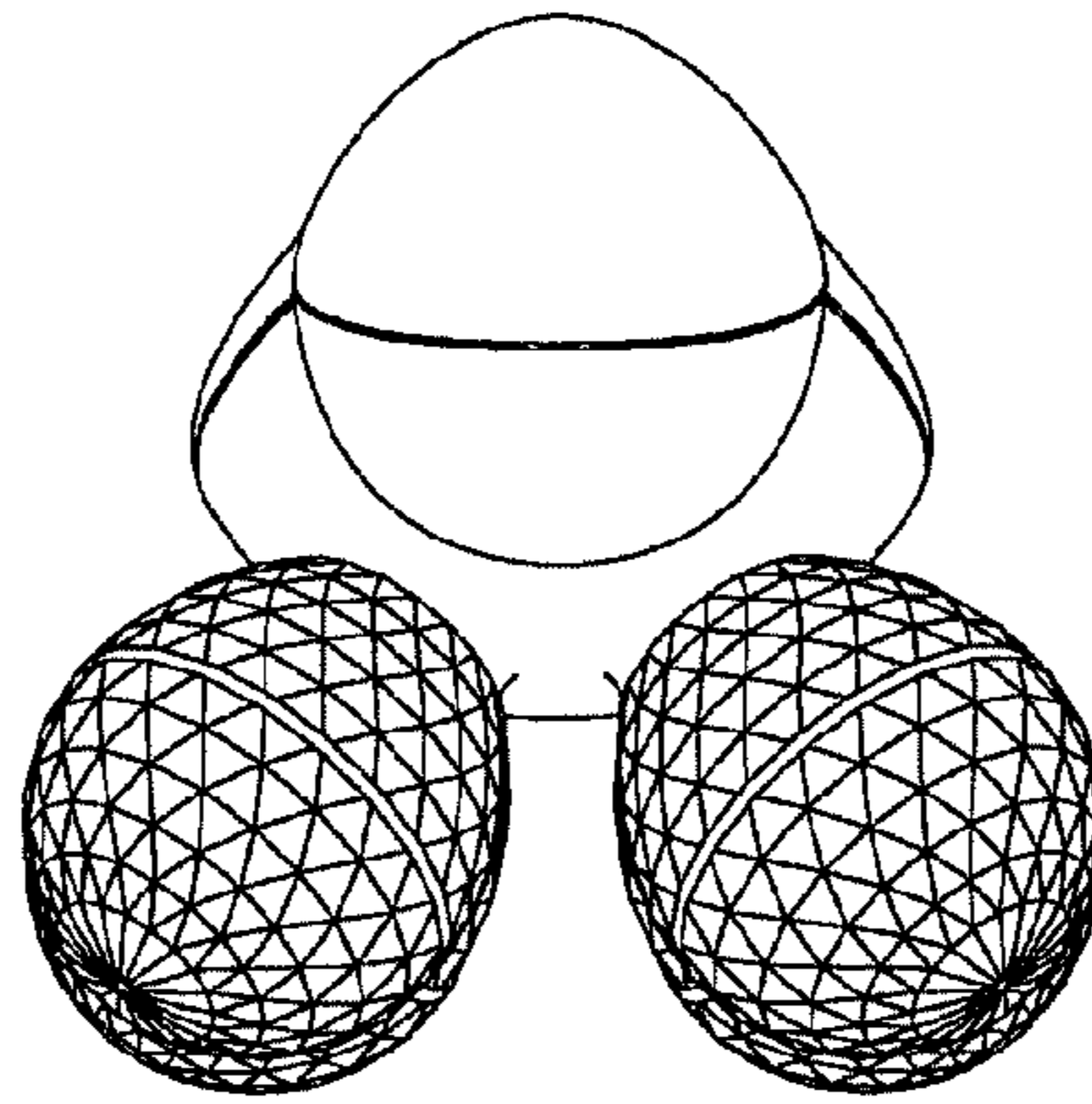

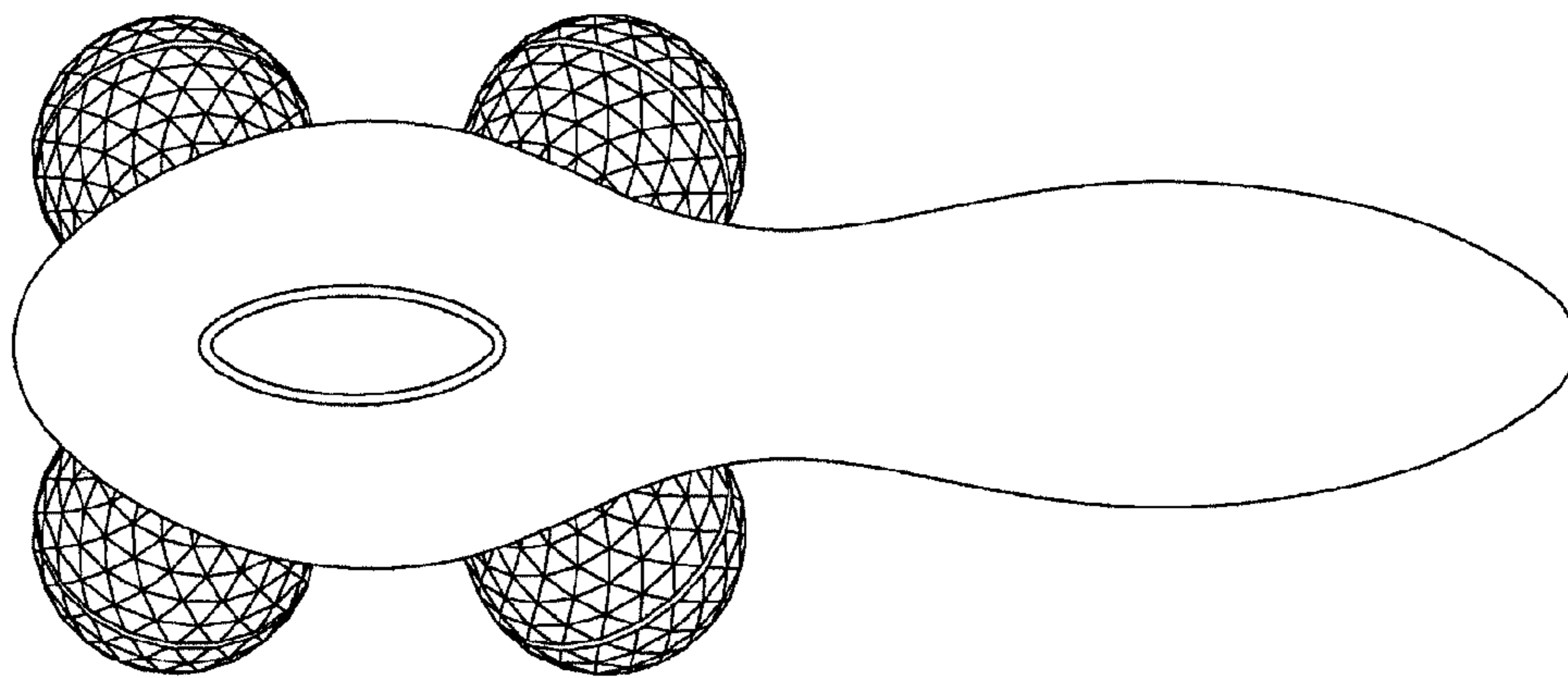

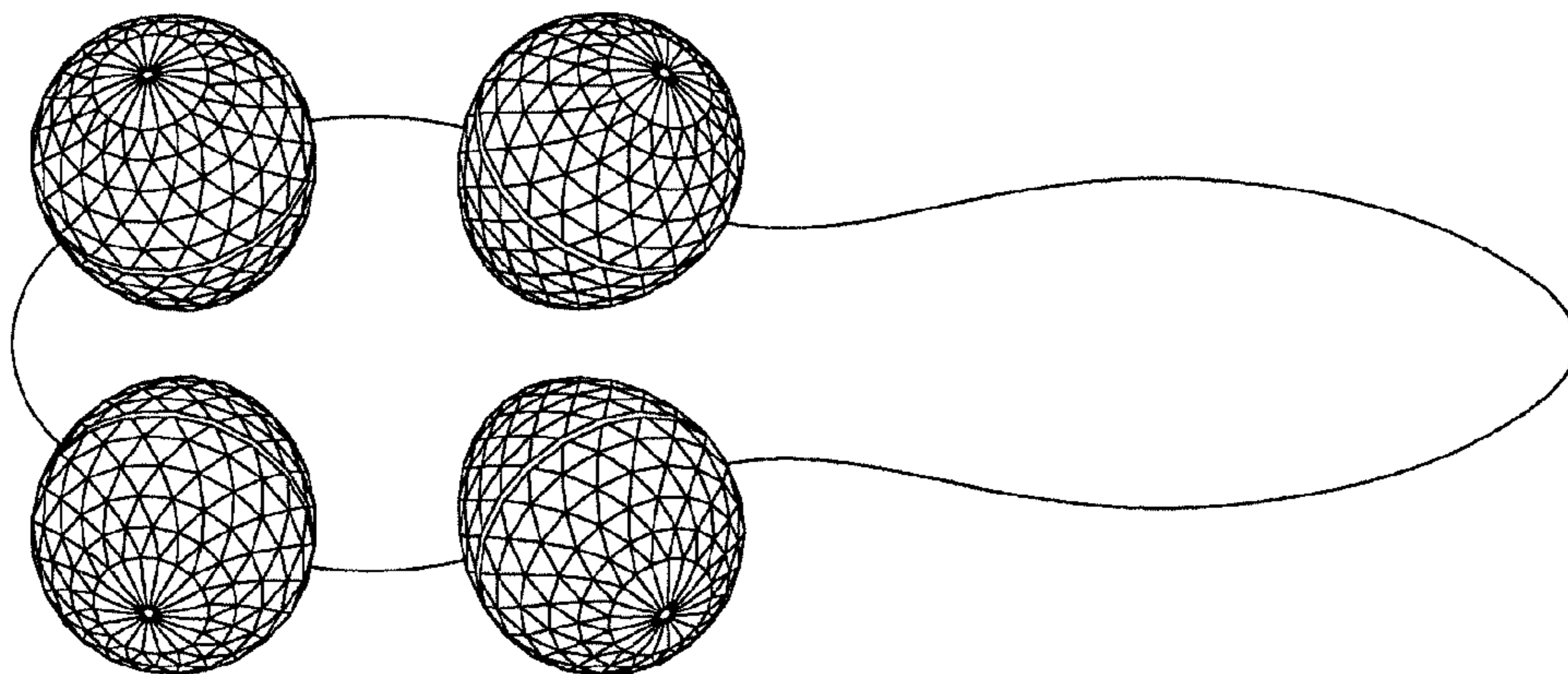

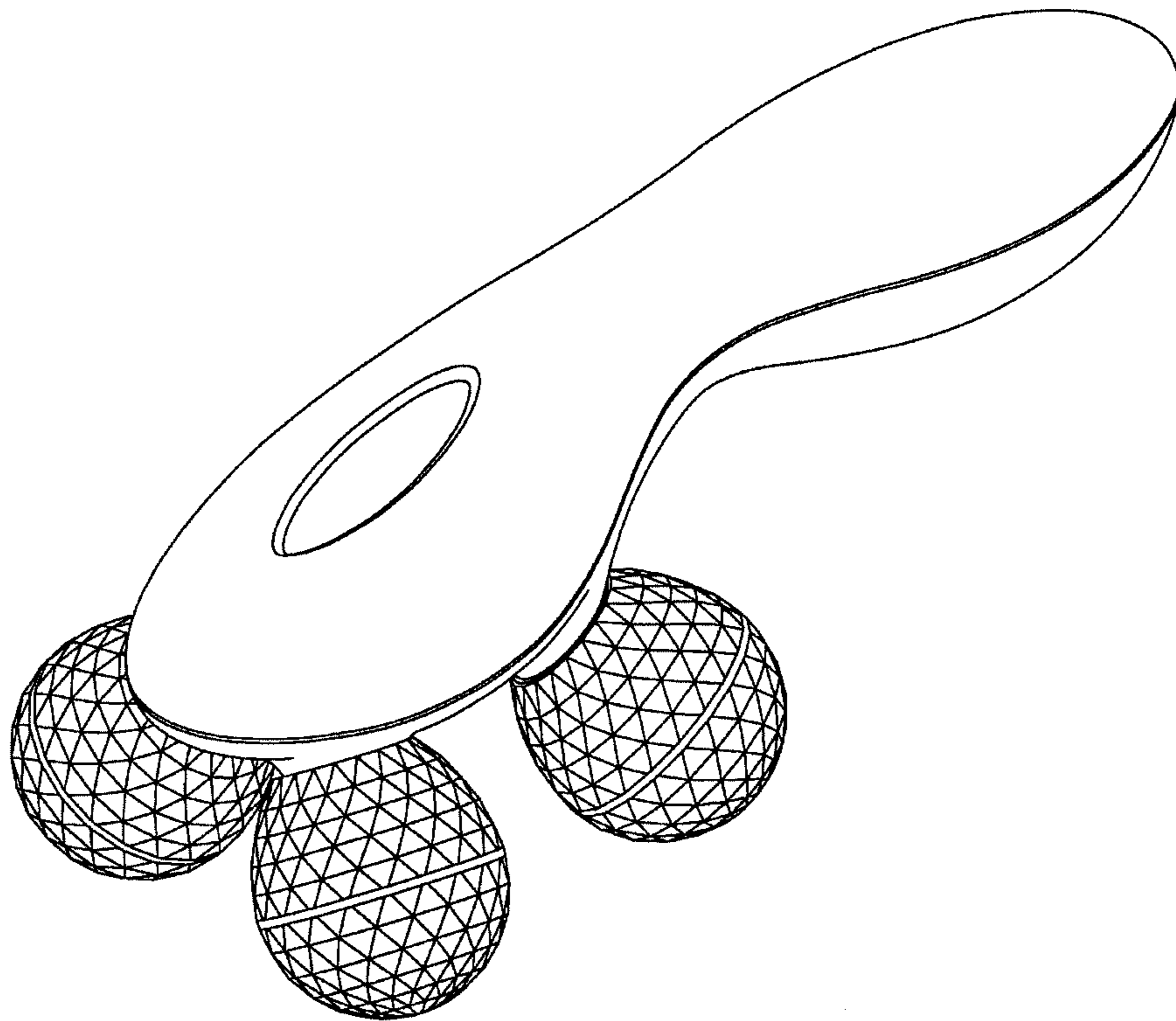

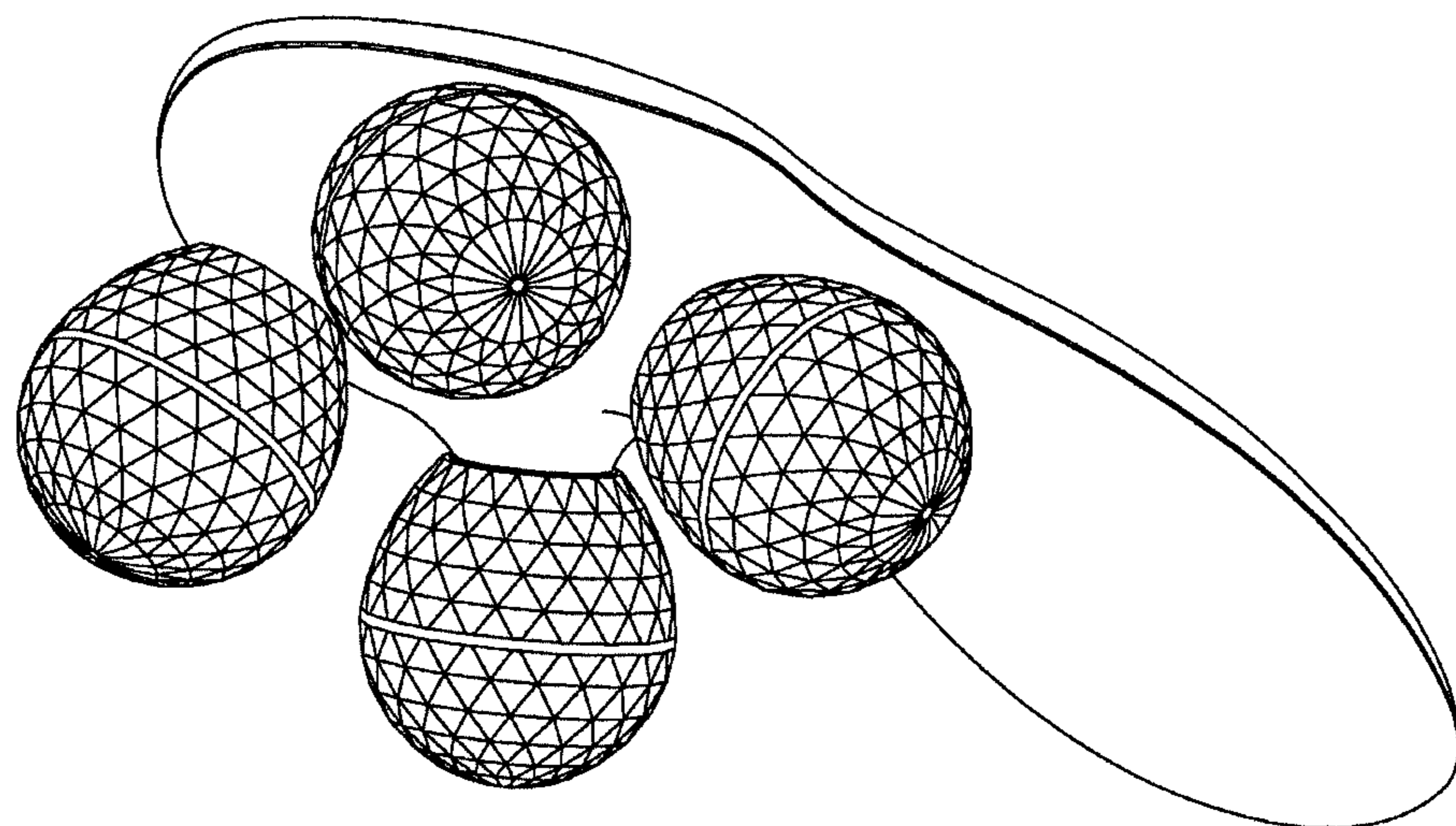

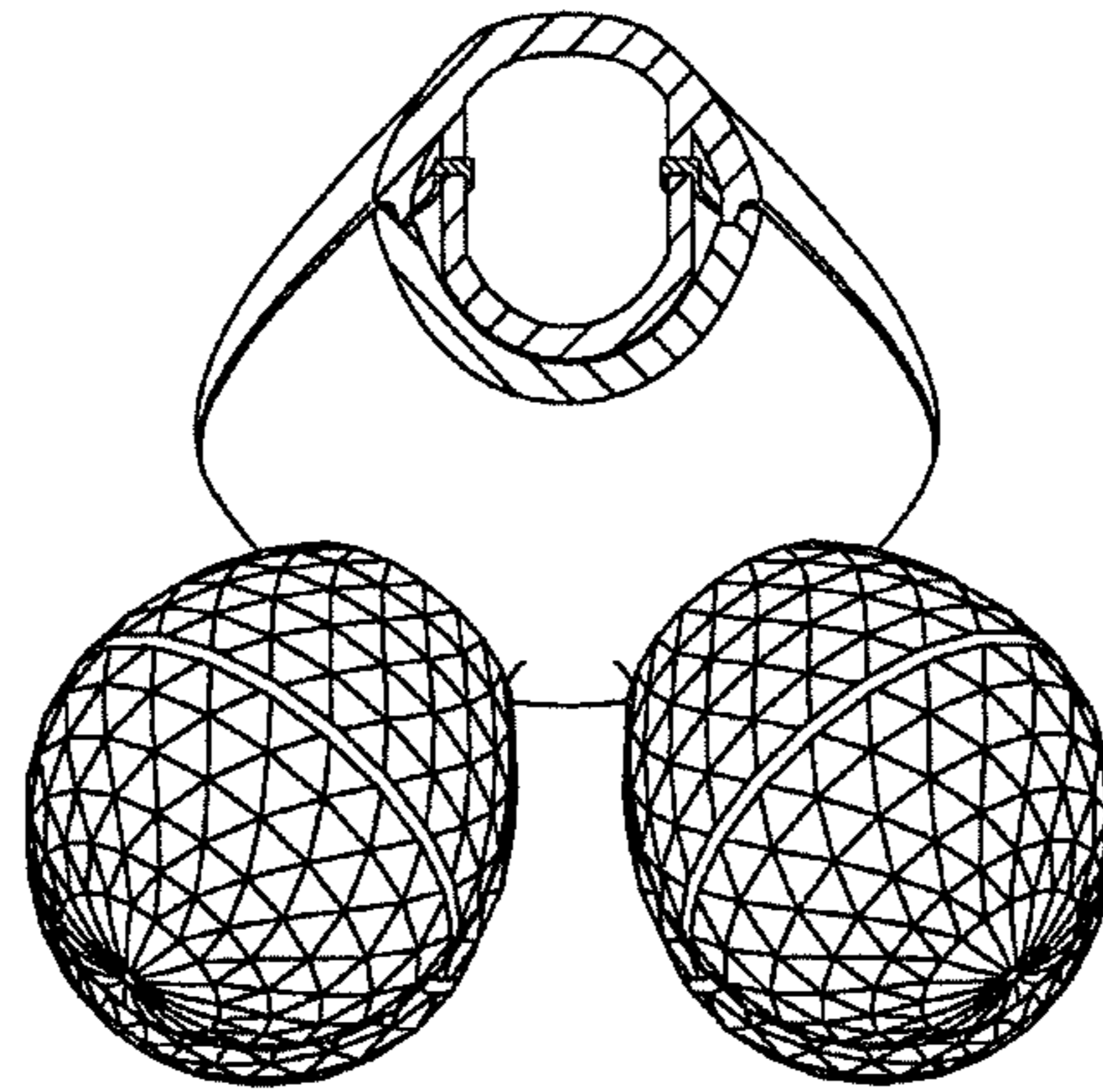

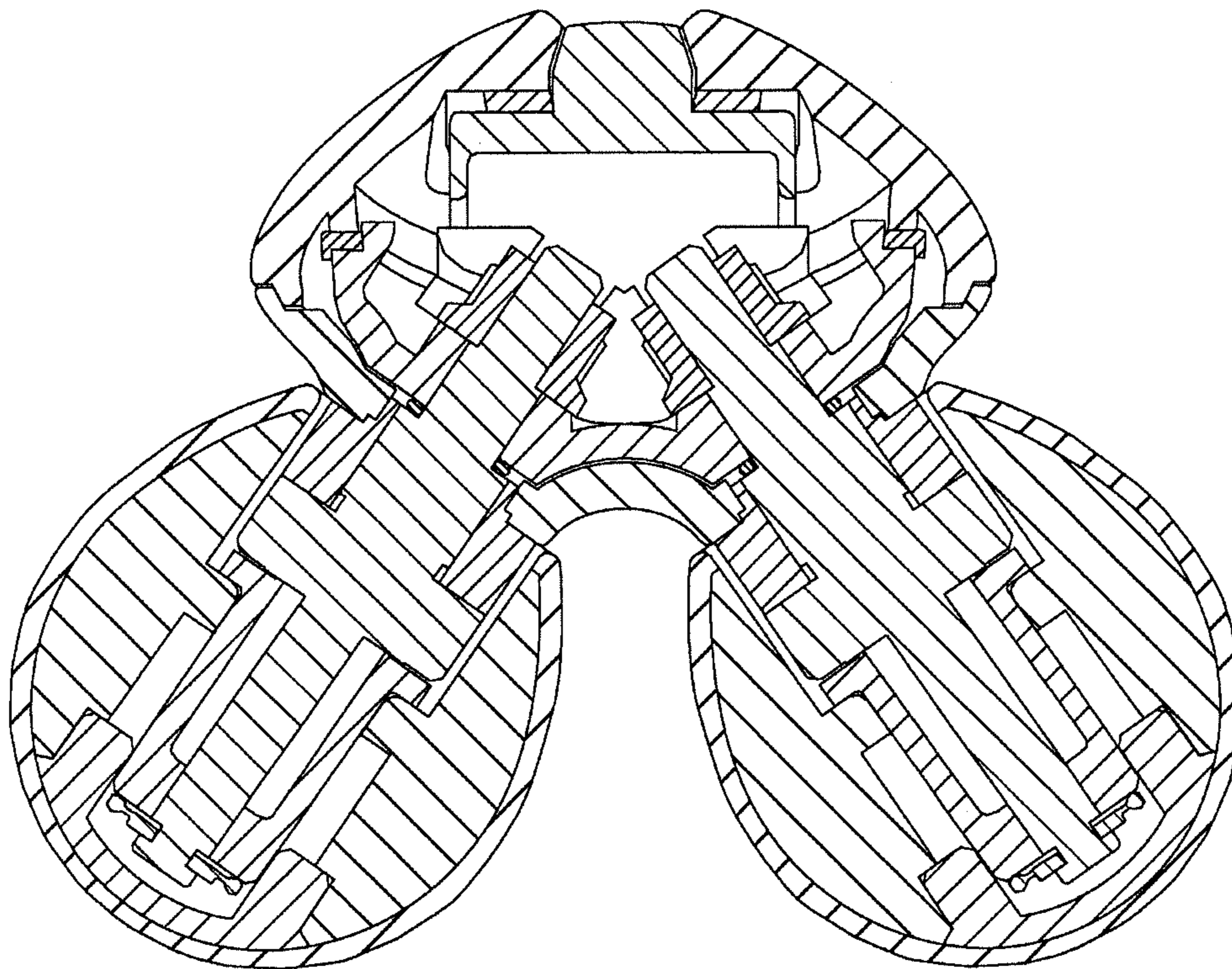
