DESCRIPTION

FIG. 1 is a top-front perspective view of a massage device, showing my new design;
FIG. 2 is a front elevational view thereof, the back elevational view being identical thereto;
FIG. 3 is a left side elevational view thereof, the right side elevational view being identical thereto;

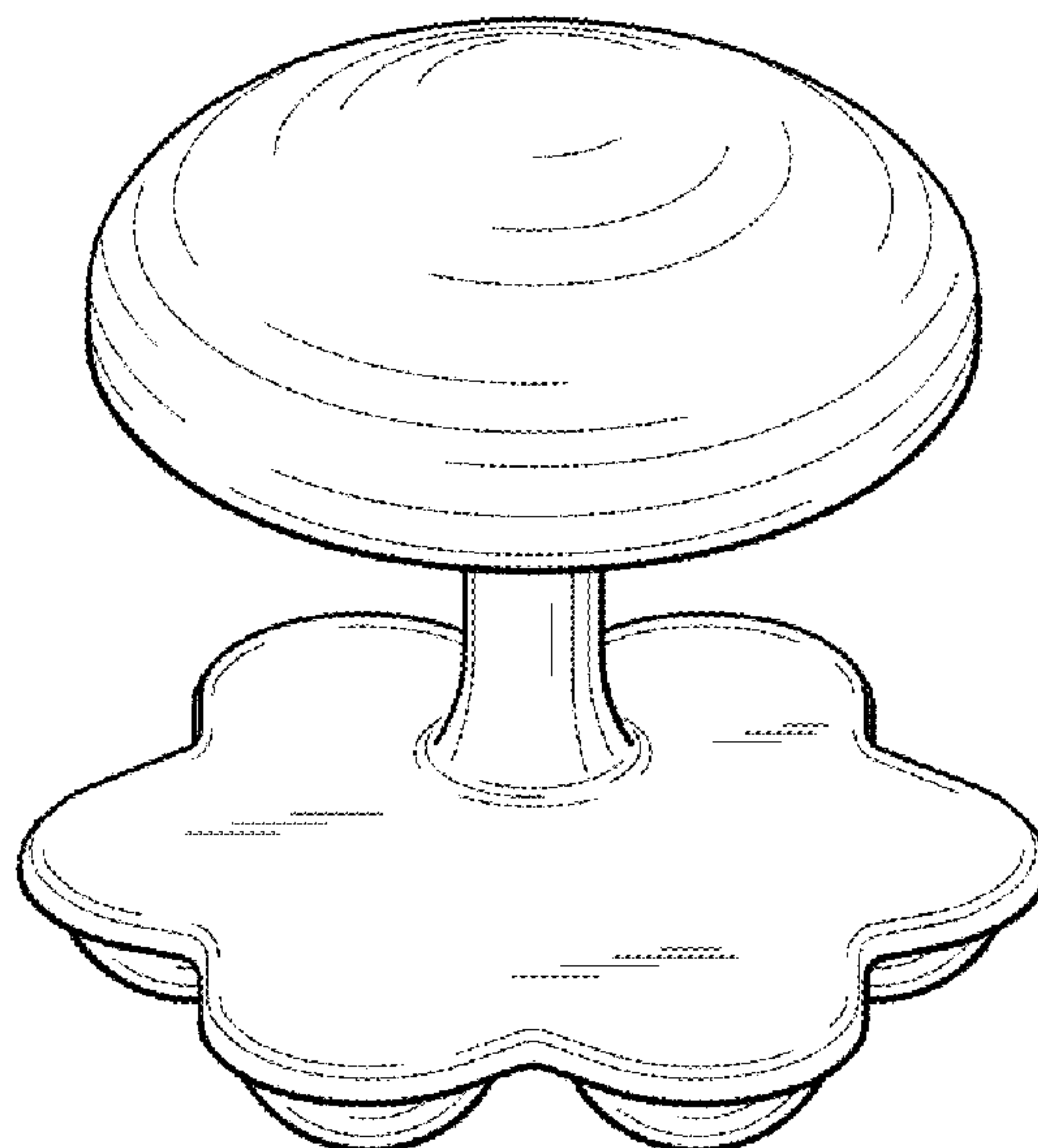

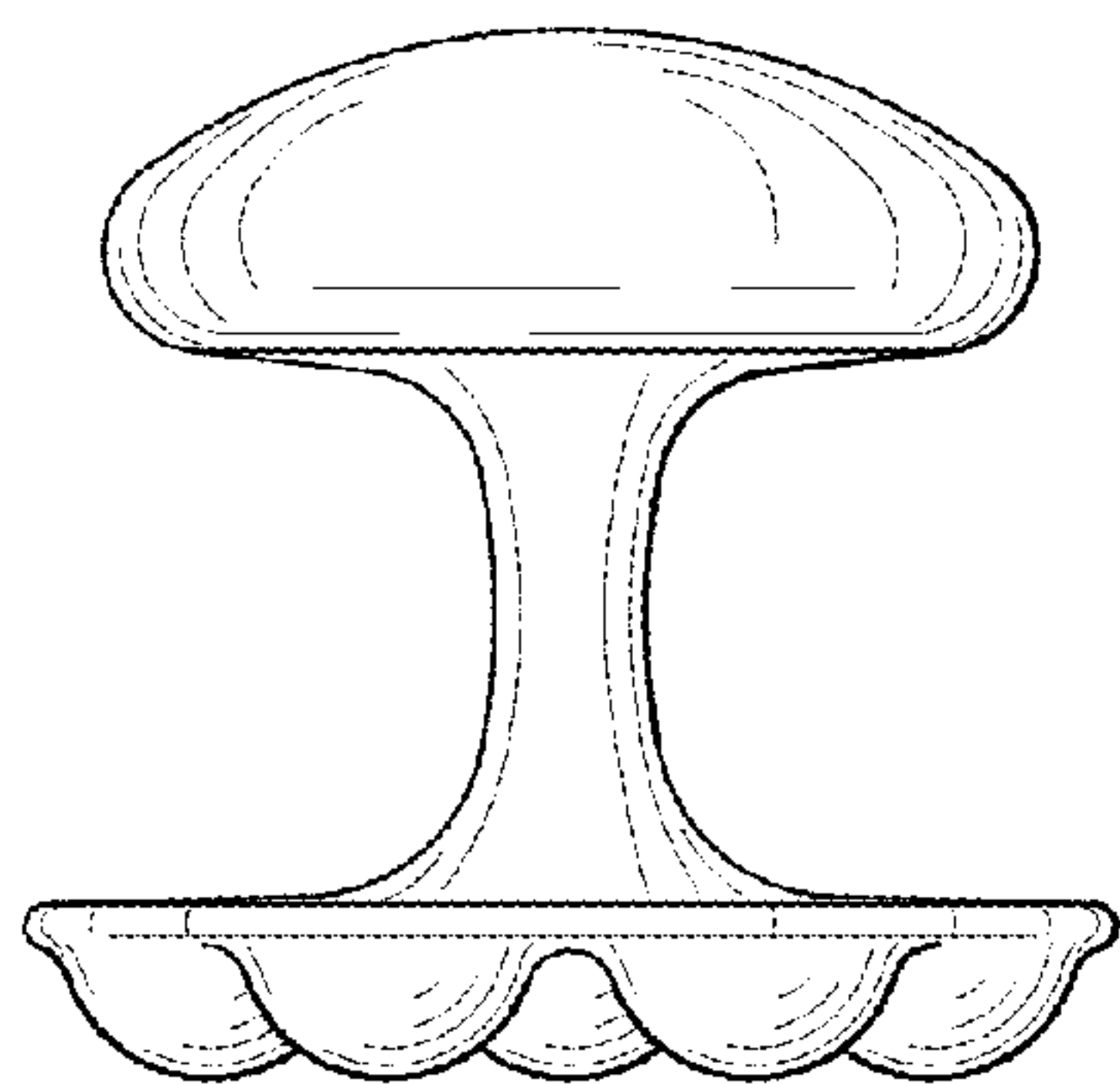
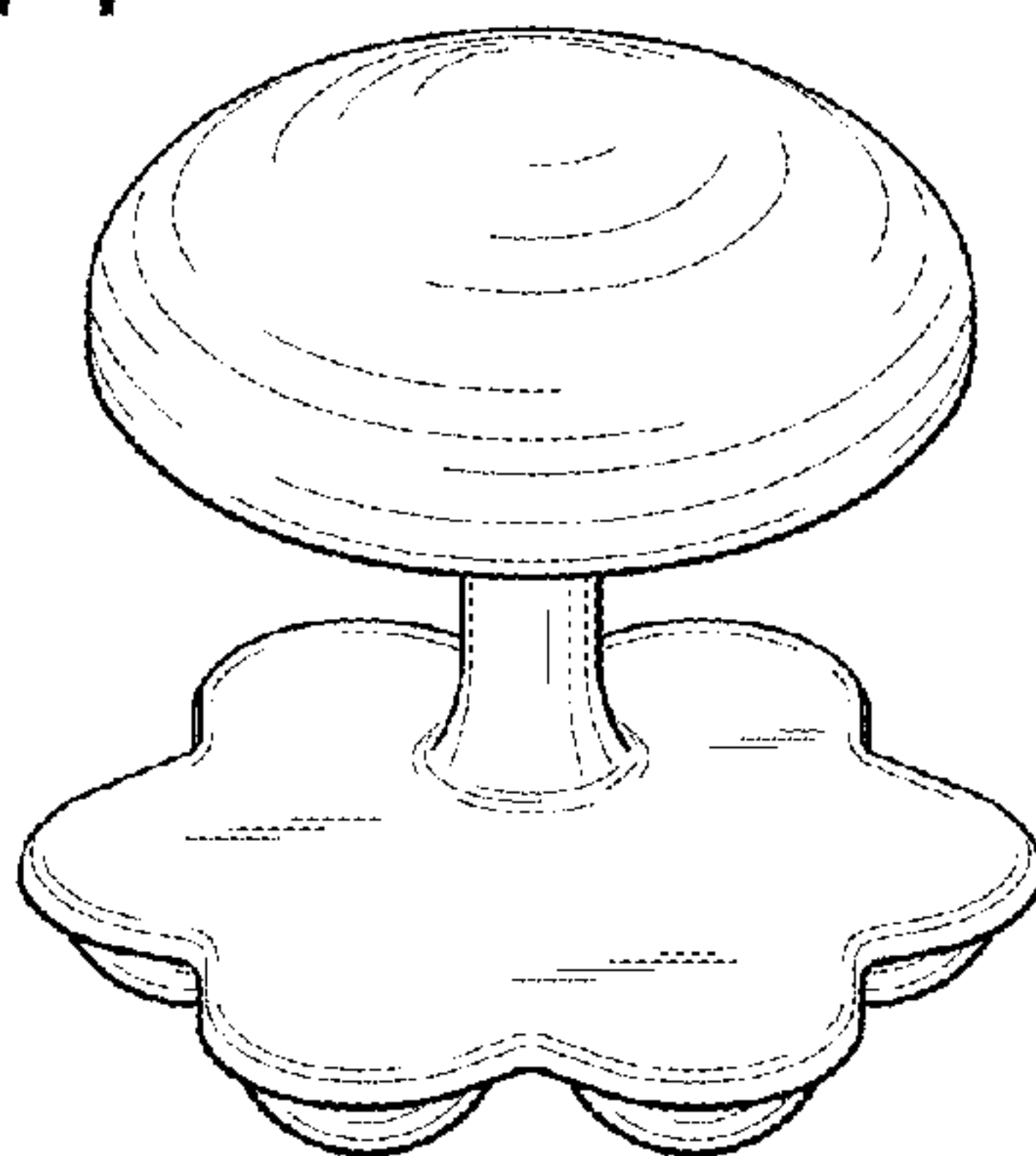

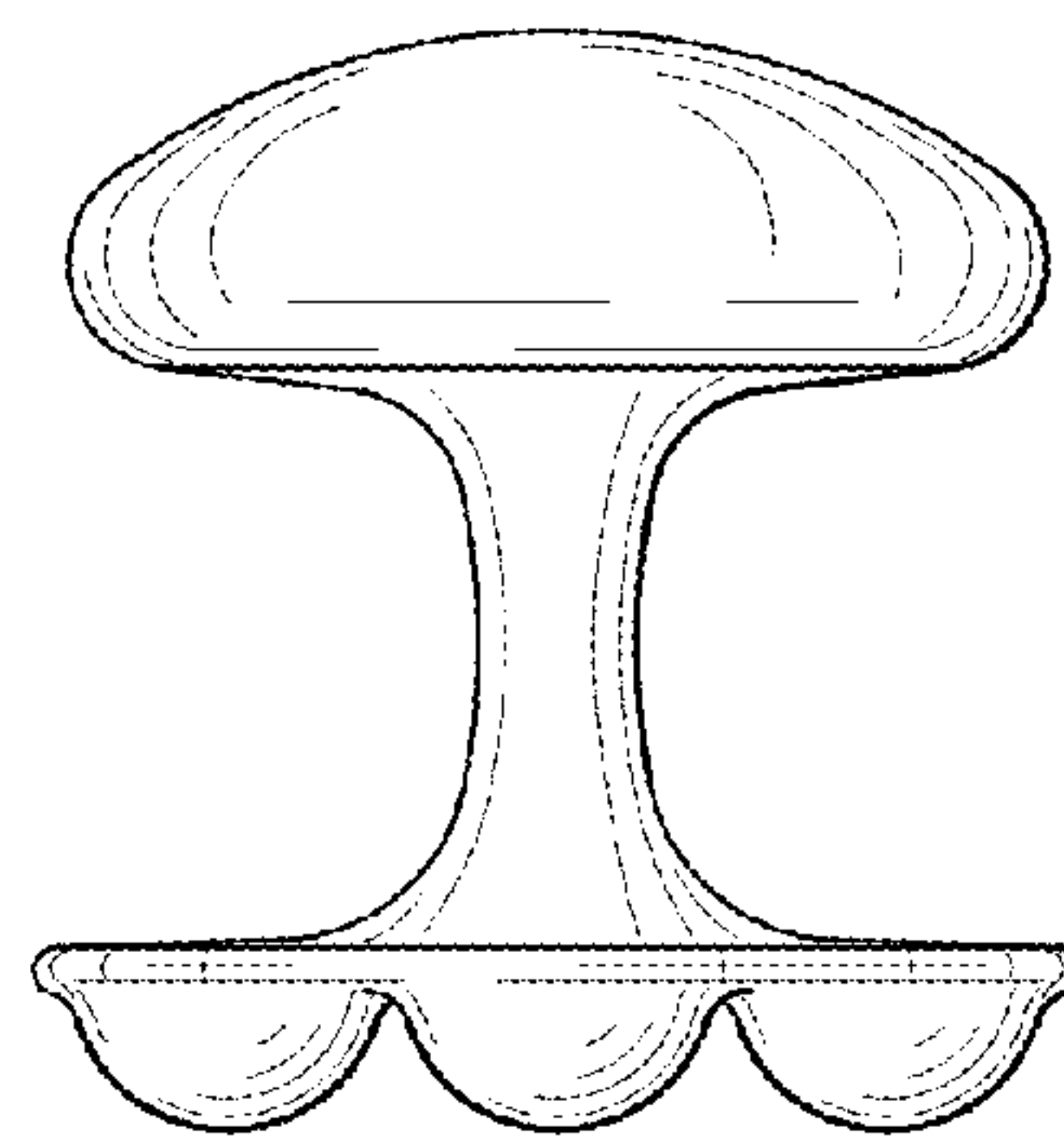

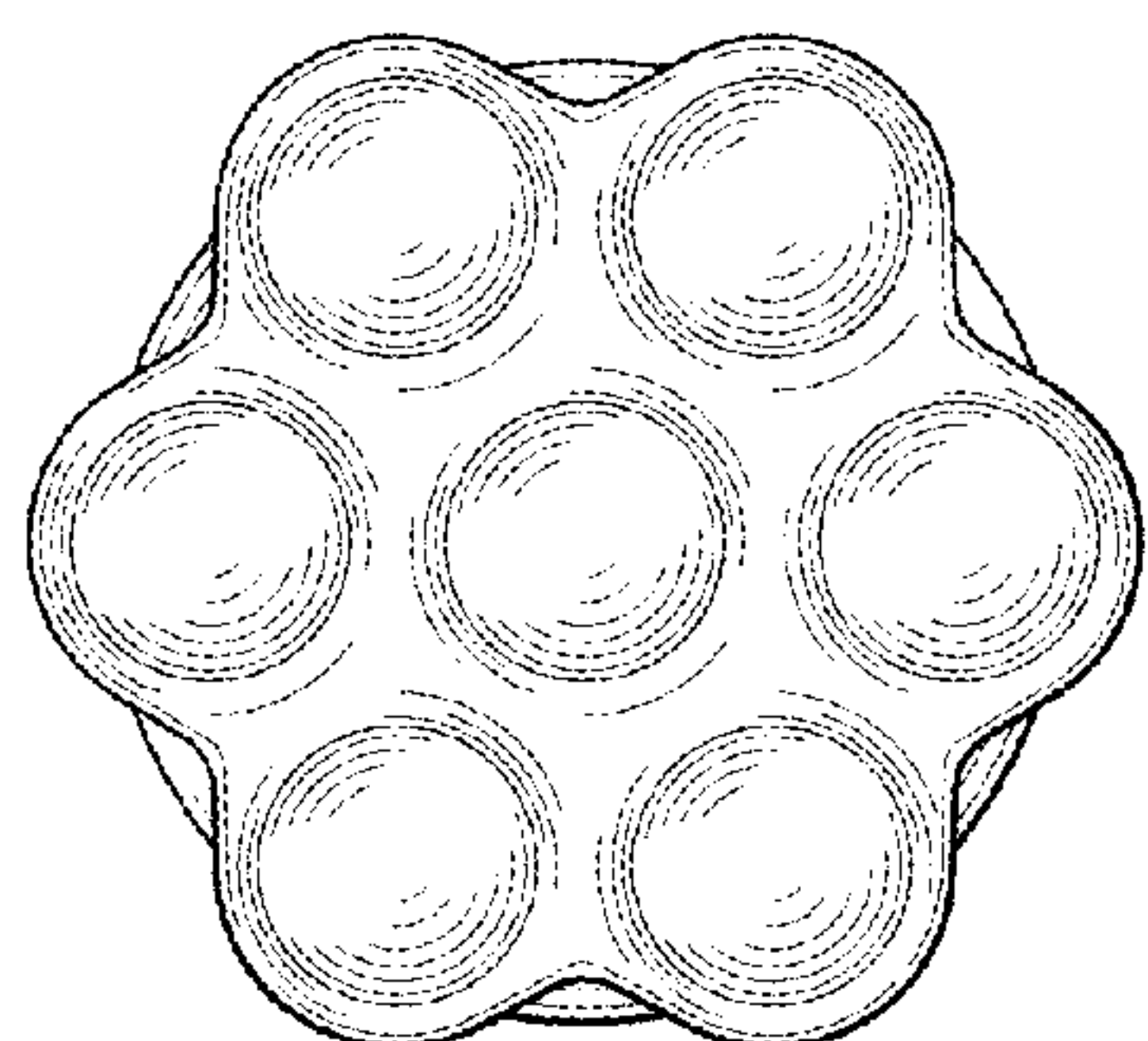

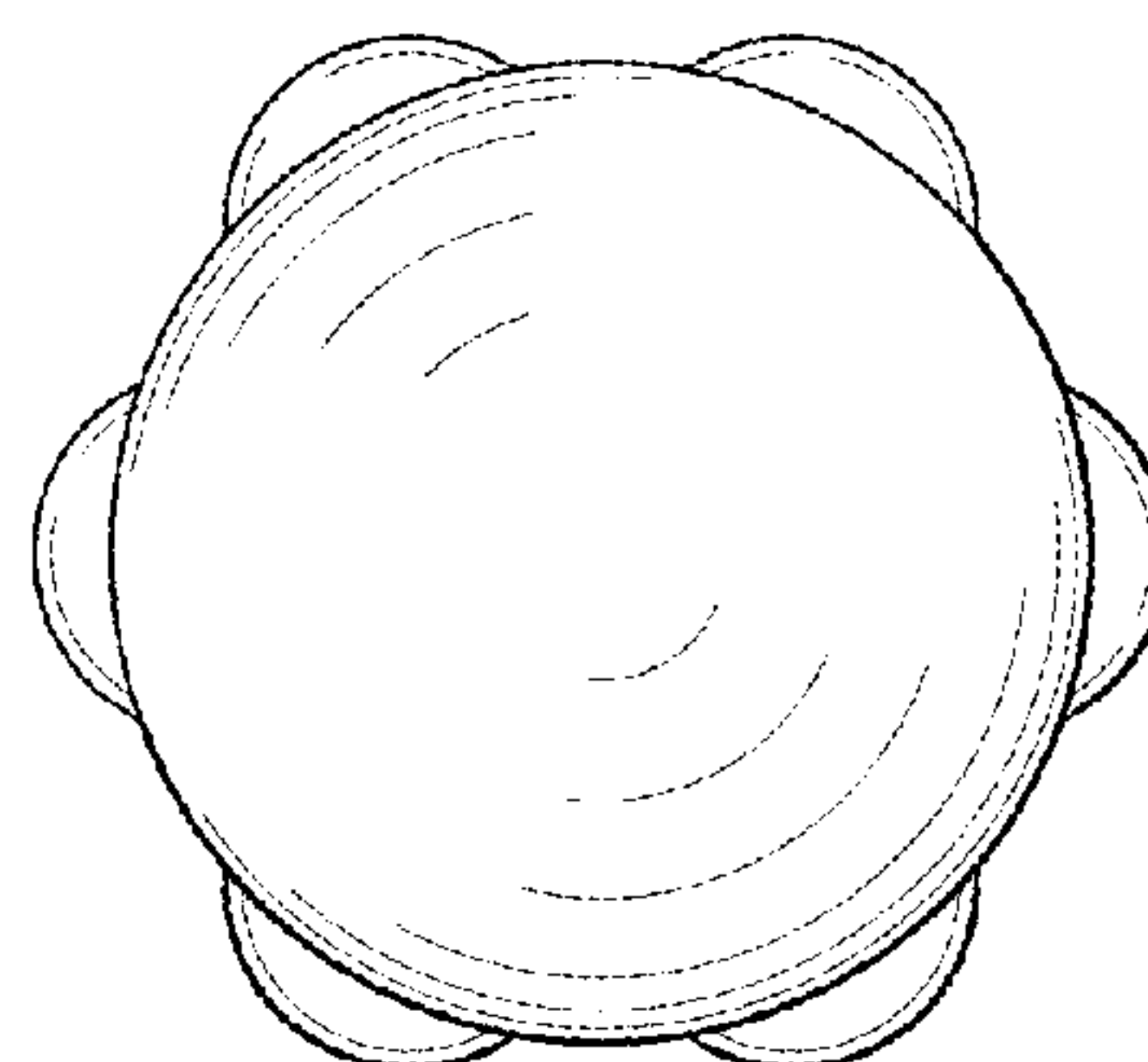
