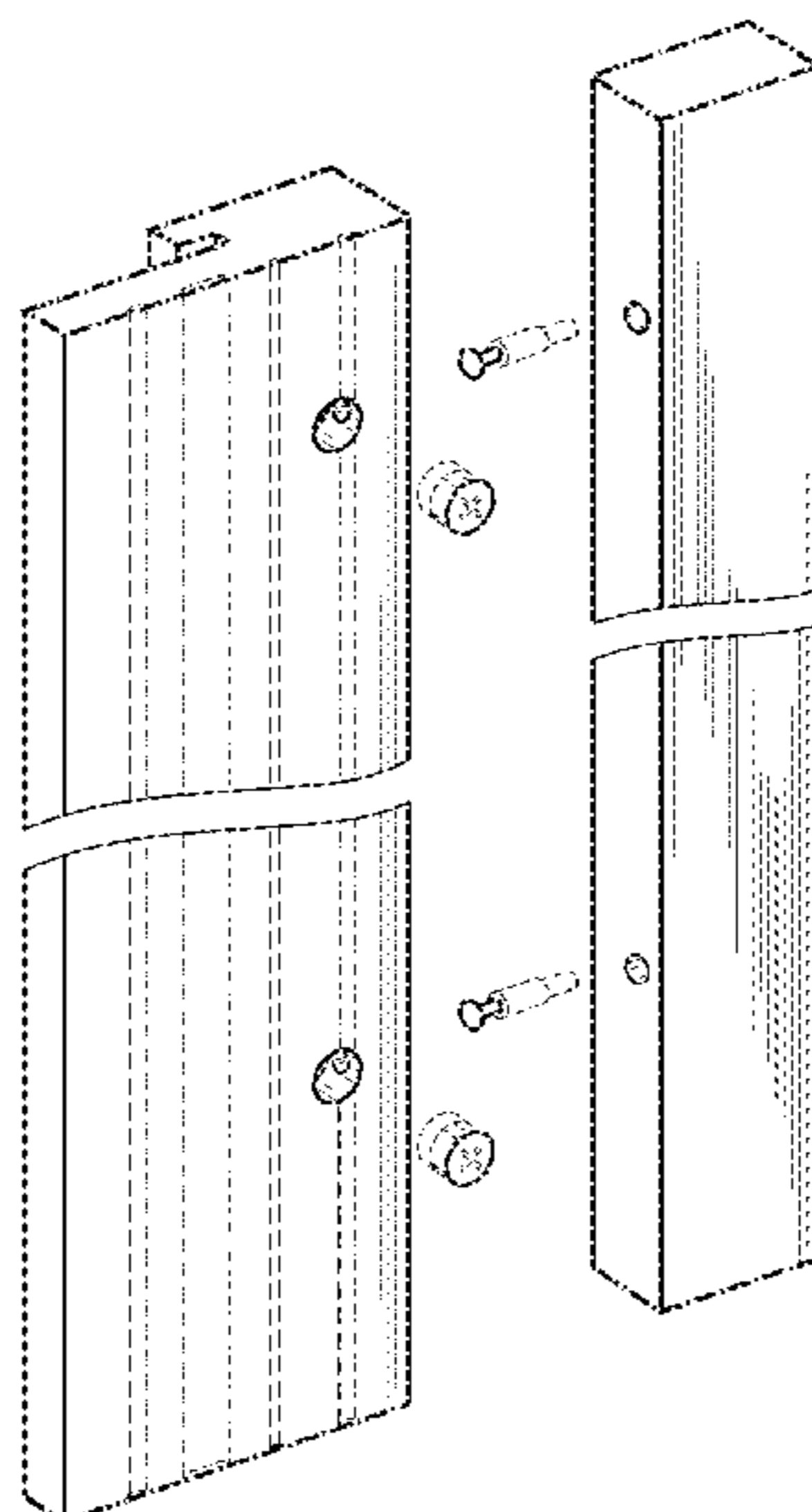

The dash-dot lines in the Figures adjacent to the shaded areas represent unclaimed boundaries of the claimed design. The dash-dash lines in the Figures refer to environmental elements only and form no part of the claimed design. The wavy break lines in FIGS. 1 and 3-6 indicate indefinite length.

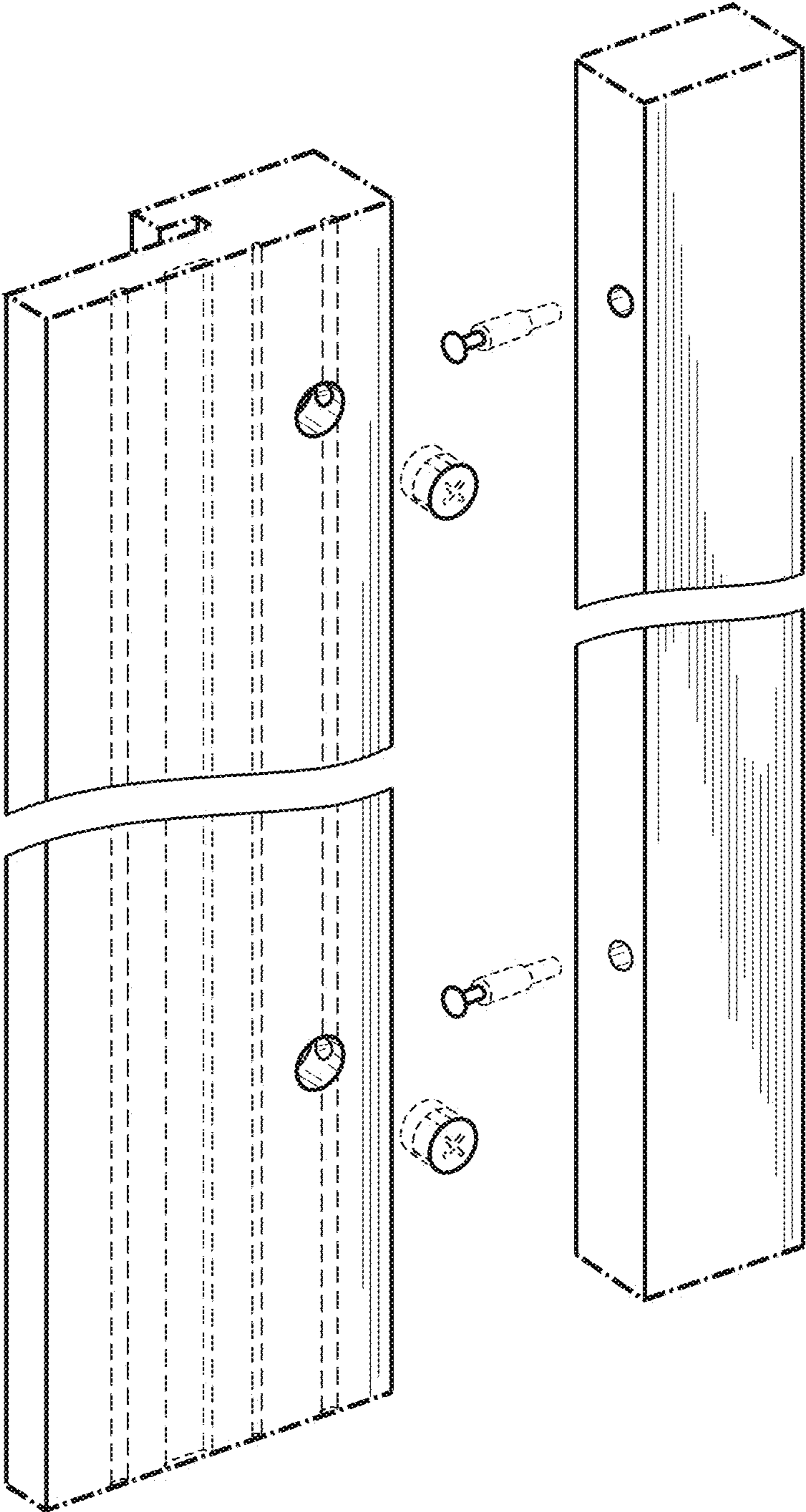
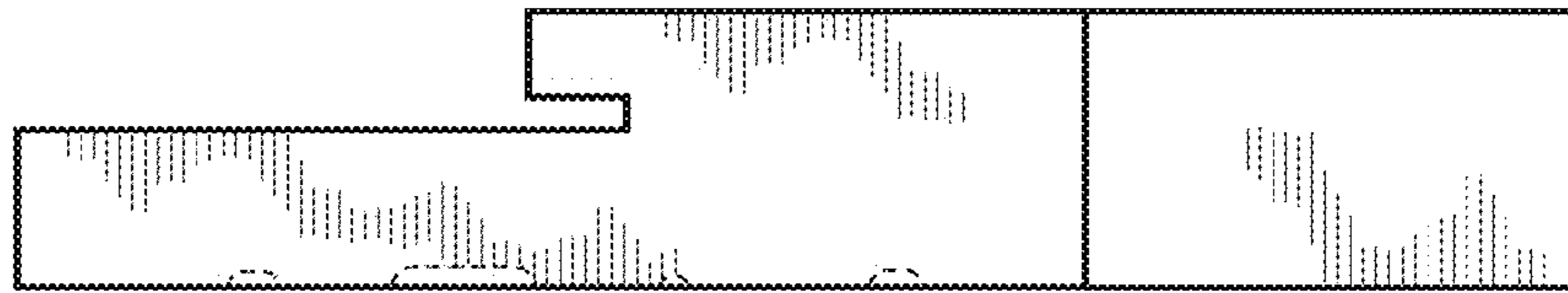

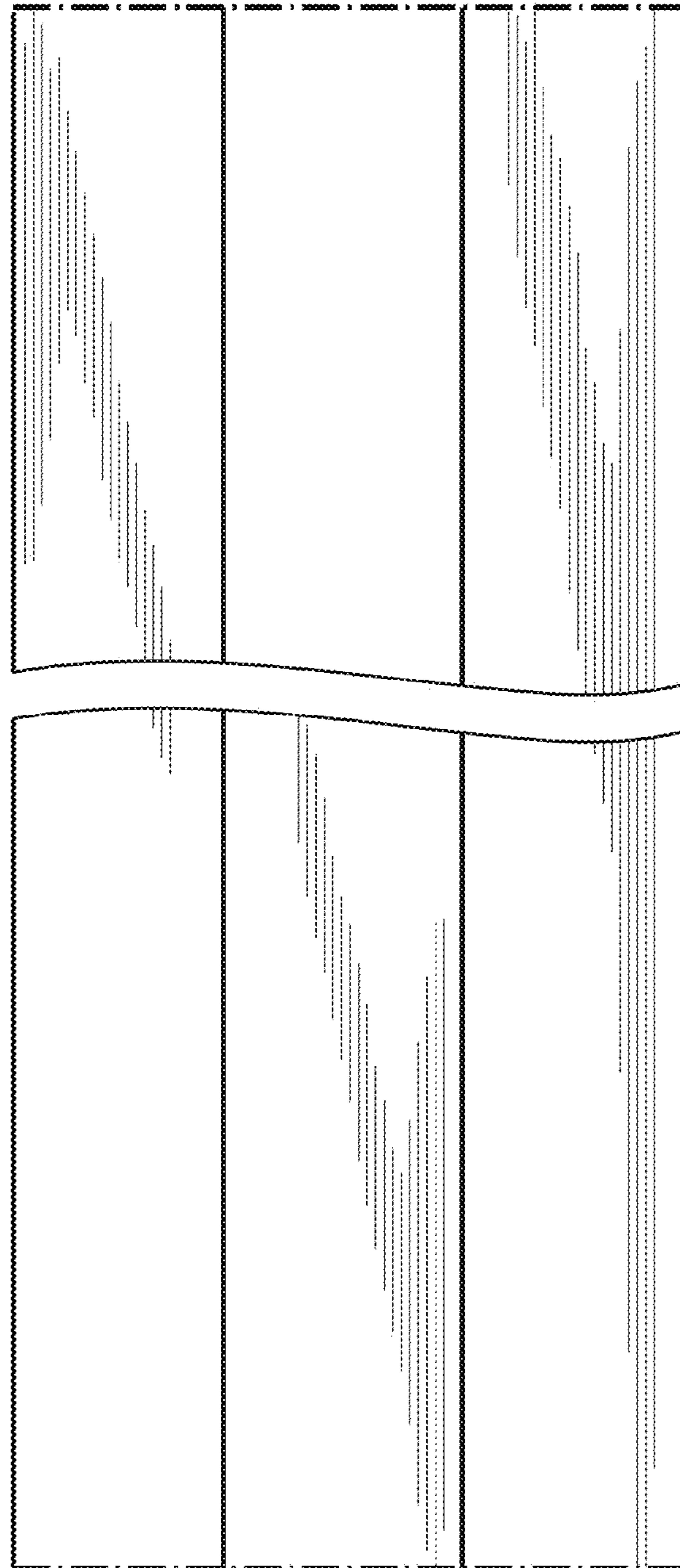

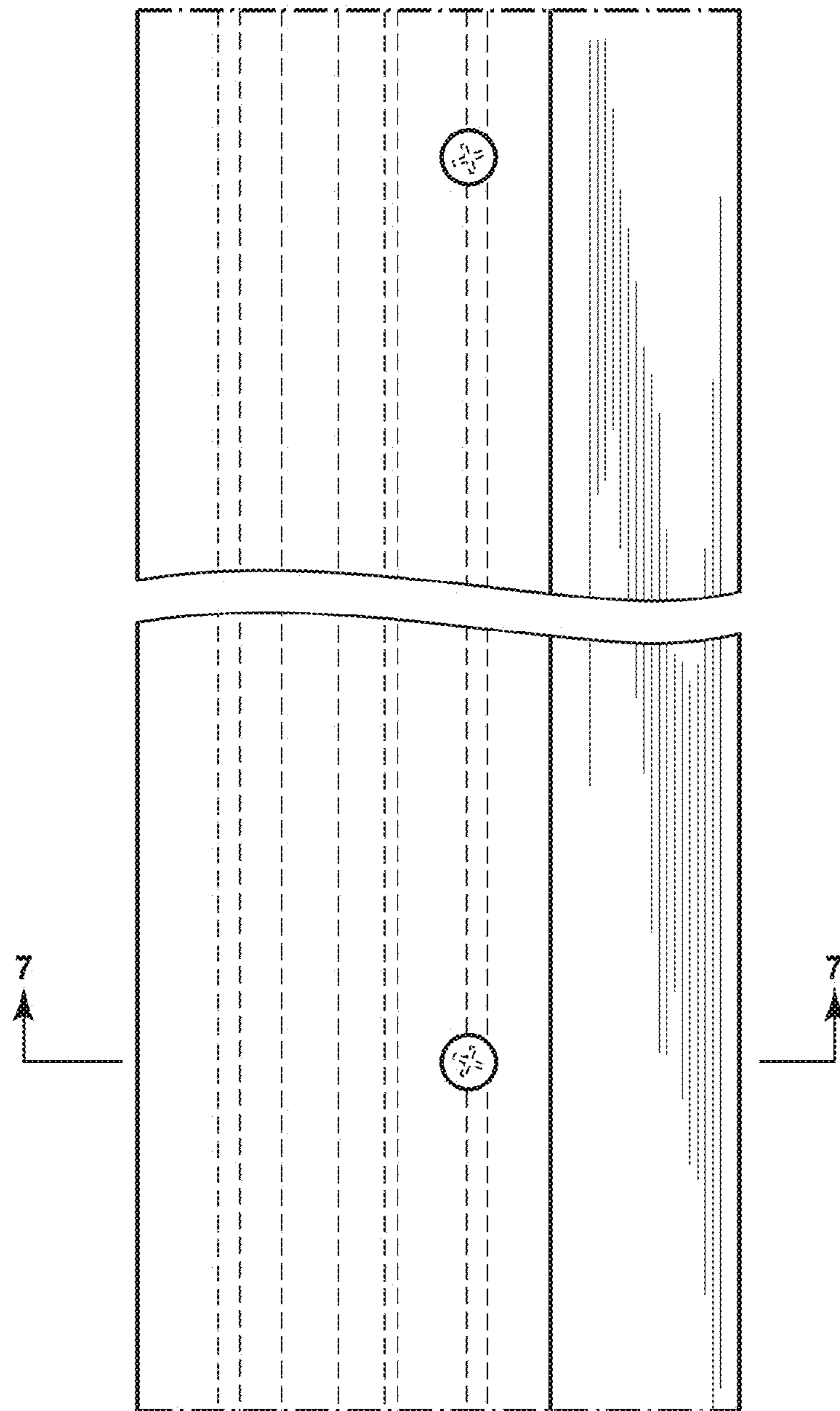

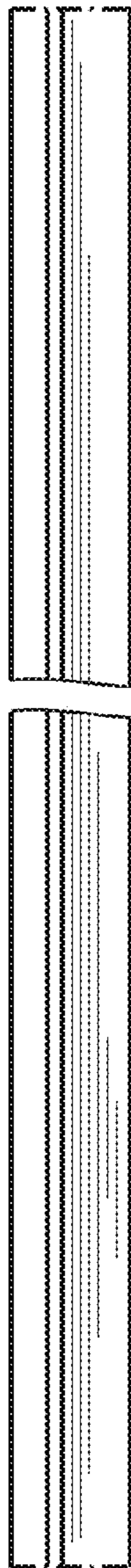

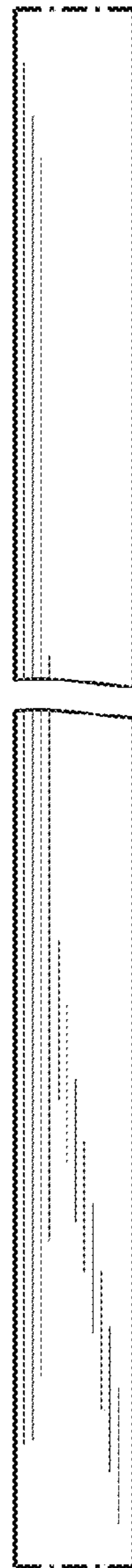
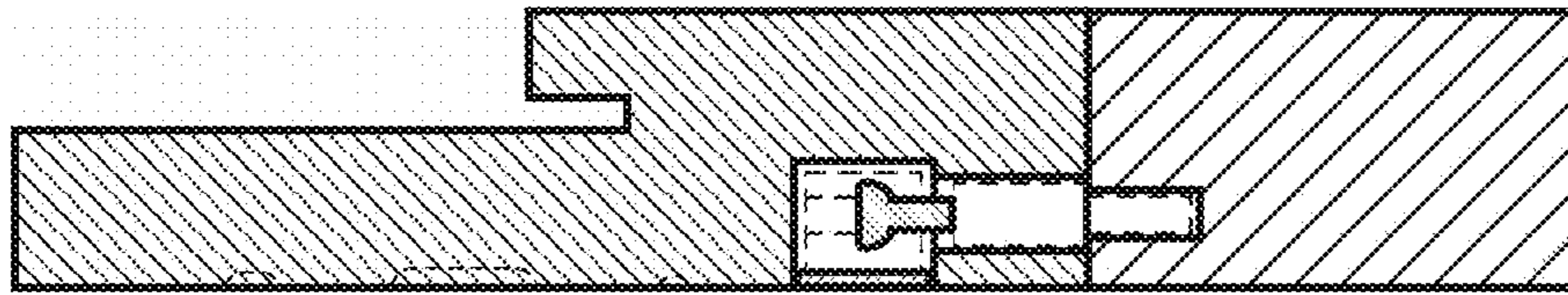
