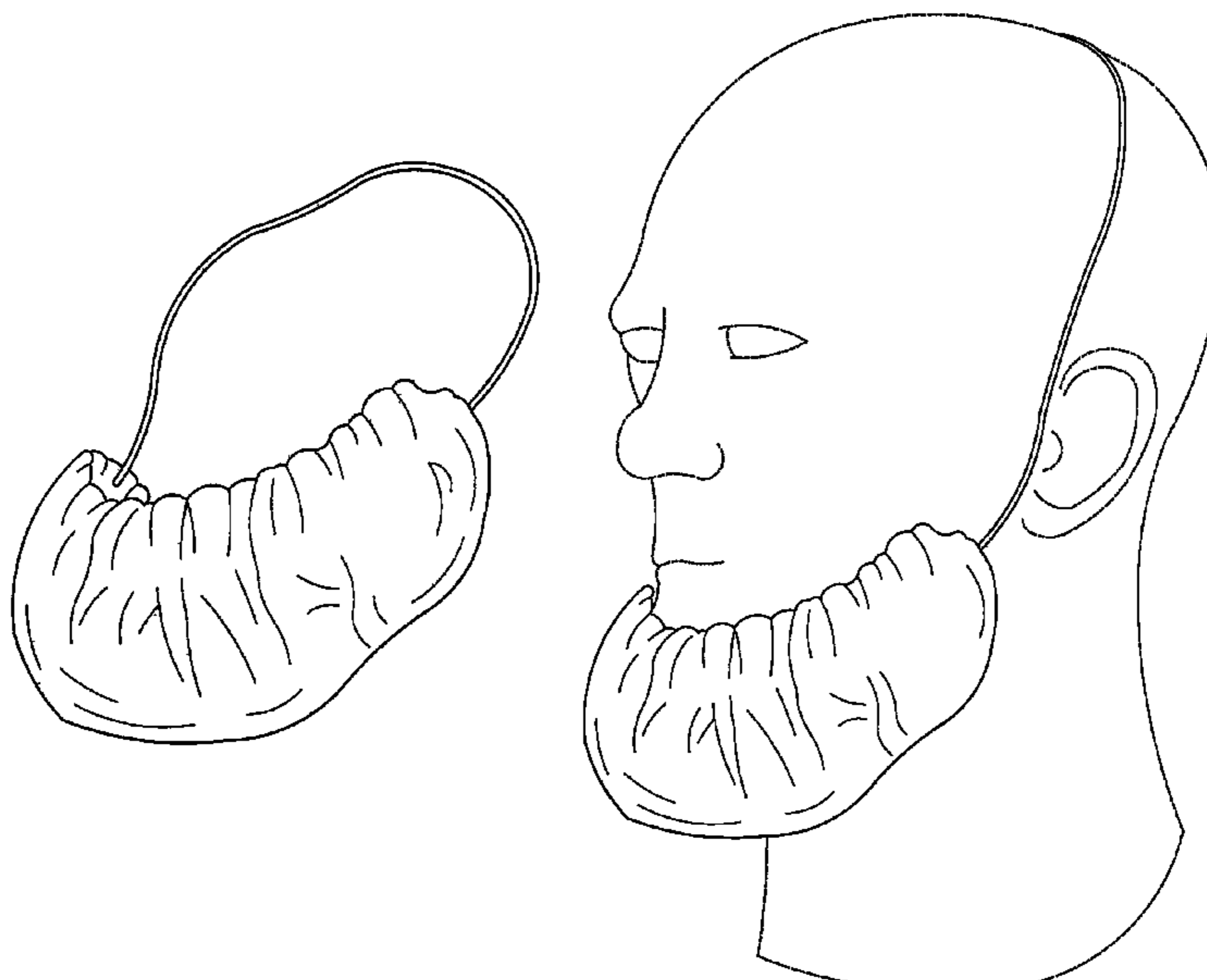
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front view of a beard cover showing my new design;  
FIG. 2 is a right side elevational view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a perspective view thereof; and,  
FIG. 6 is a perspective view of a beard cover shown in a used condition.

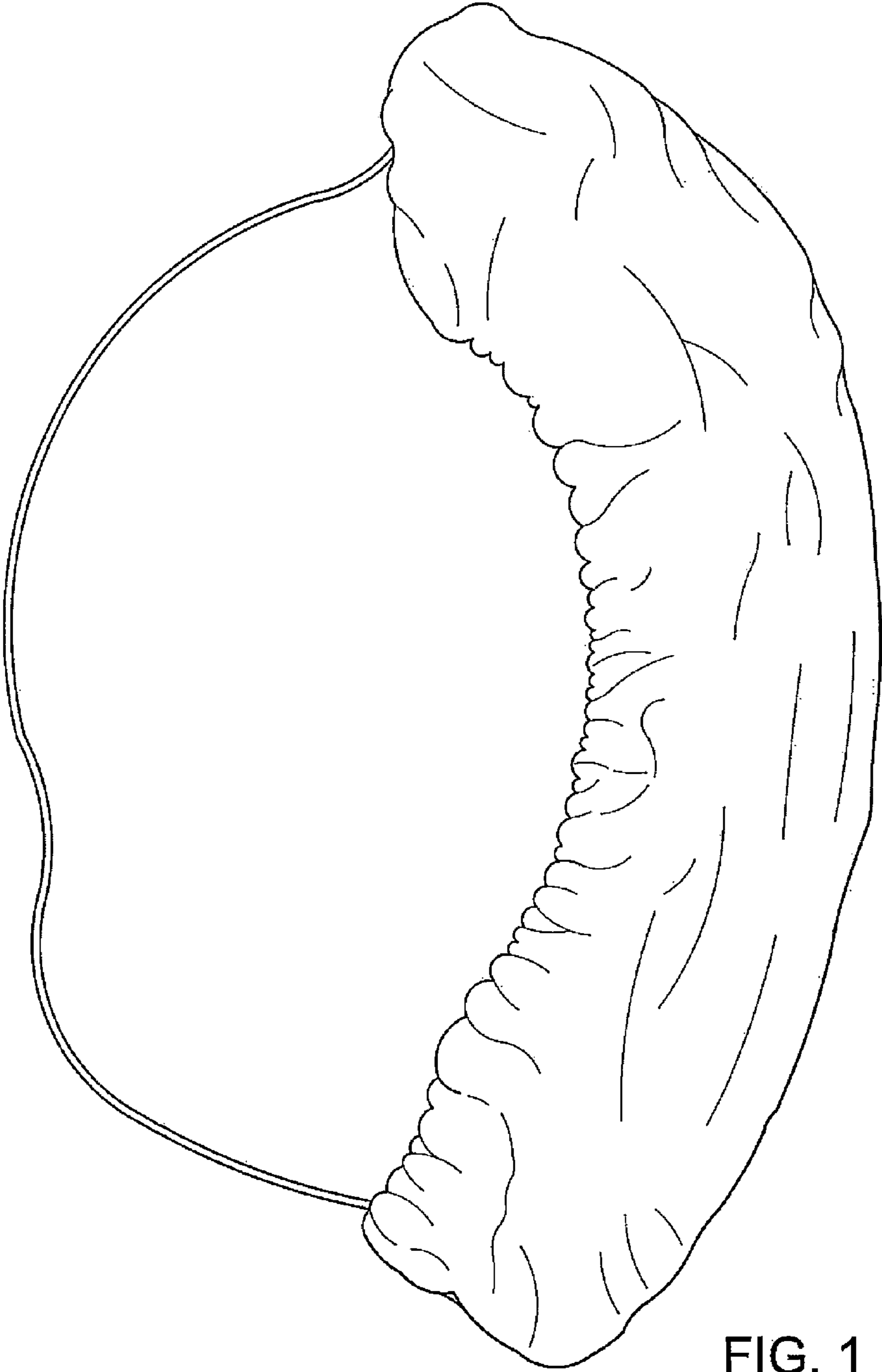

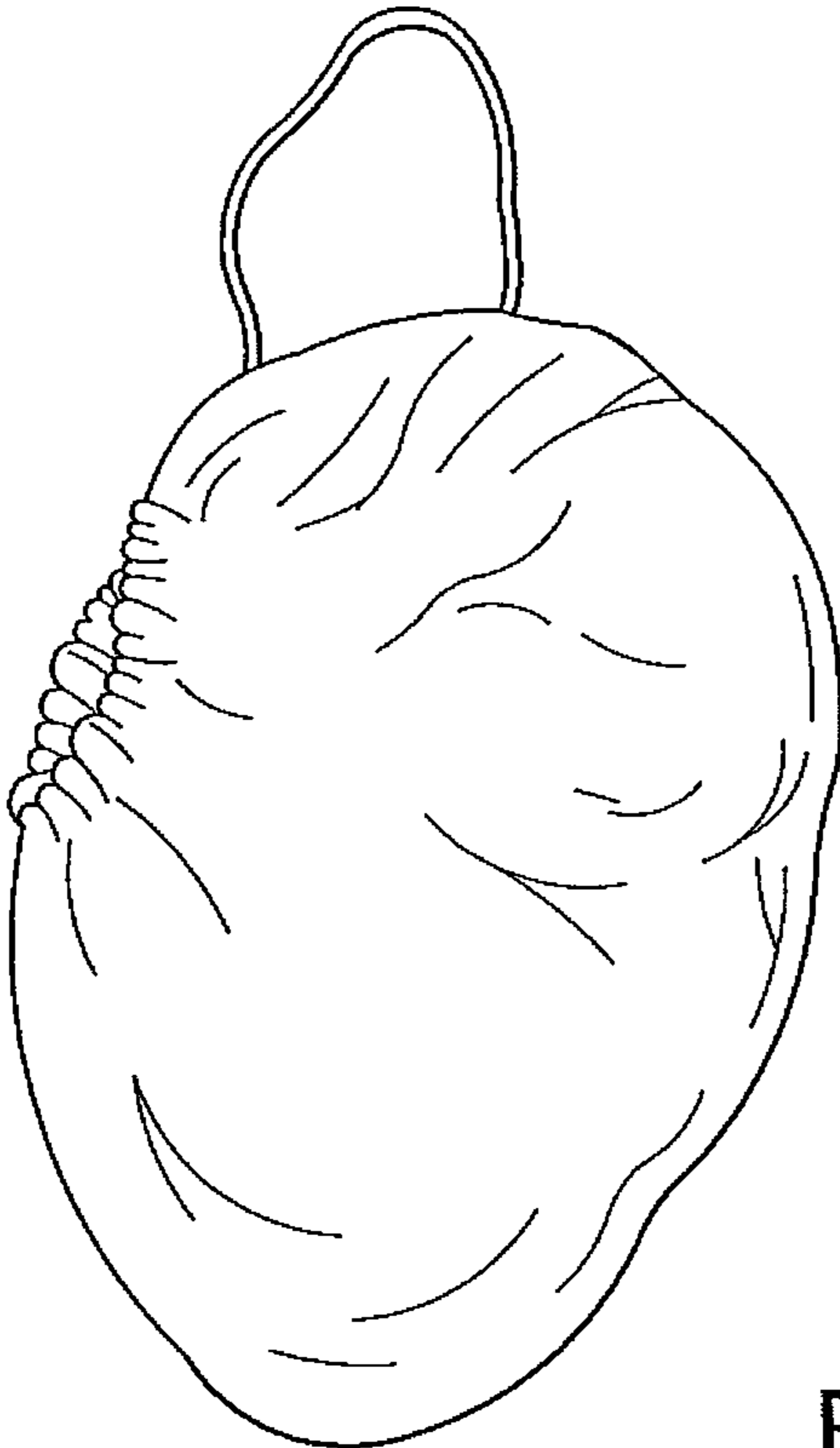

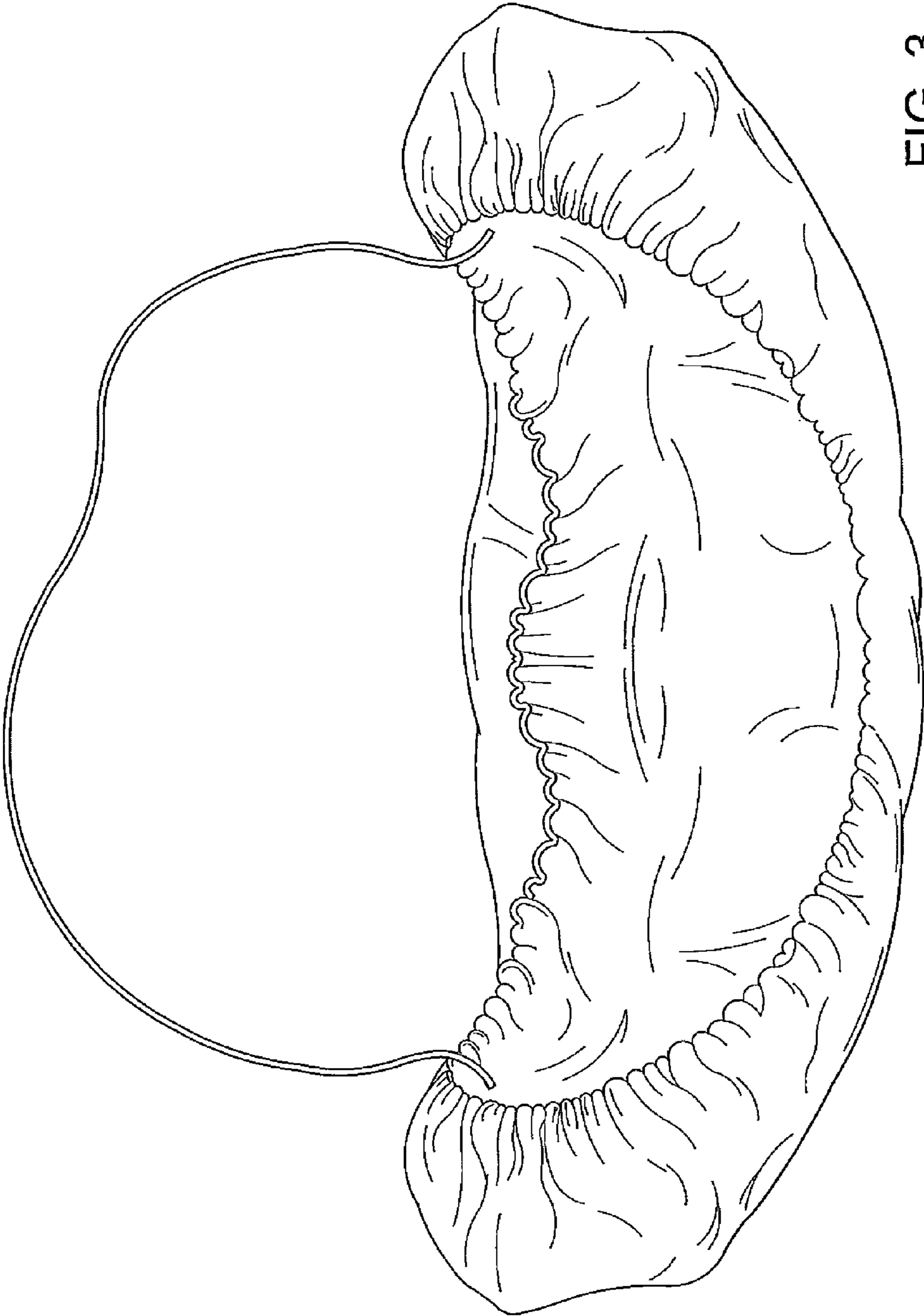

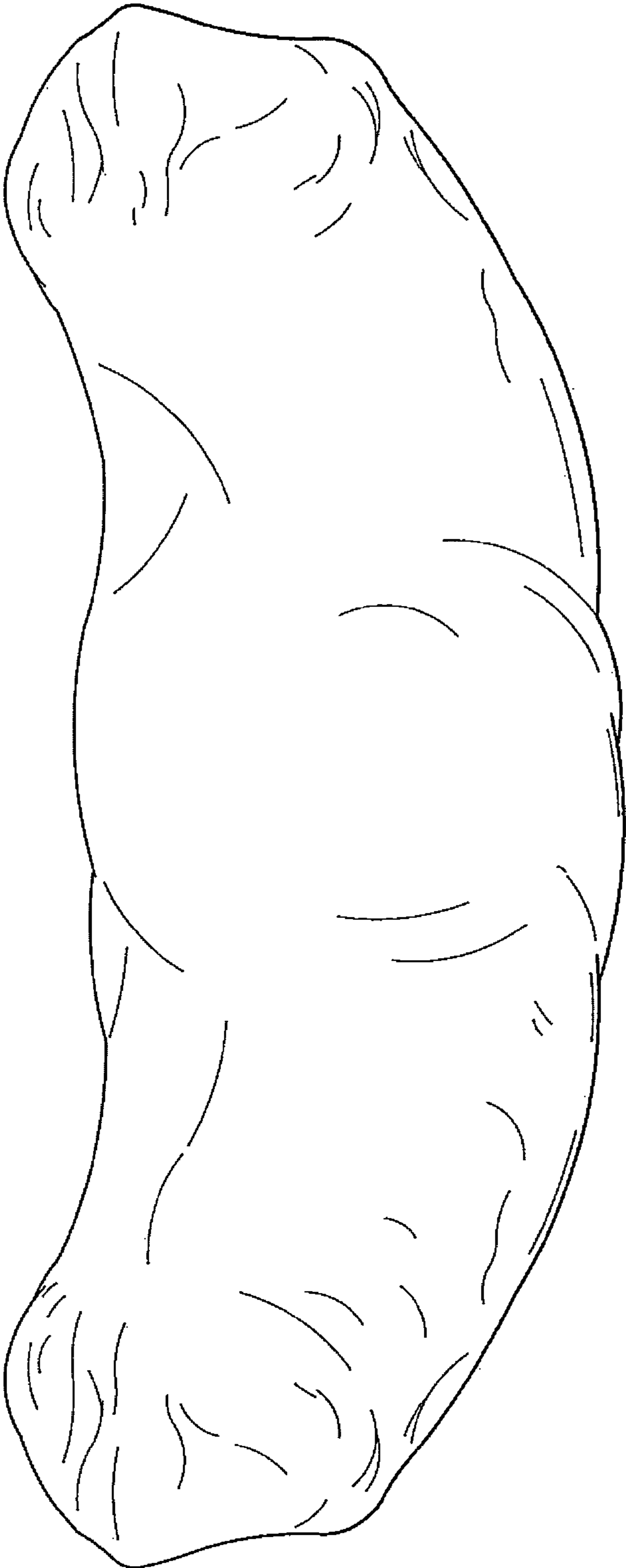

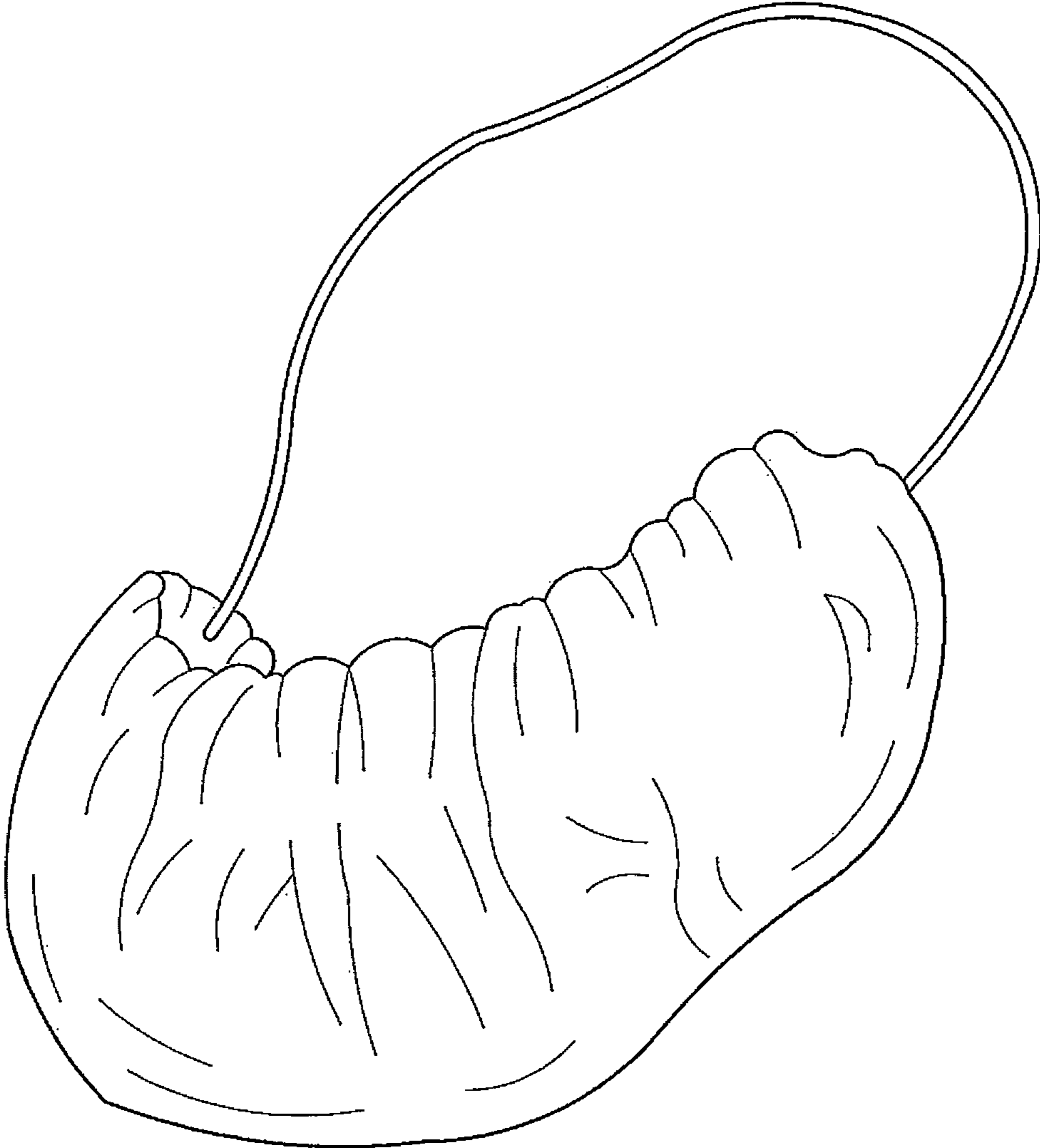

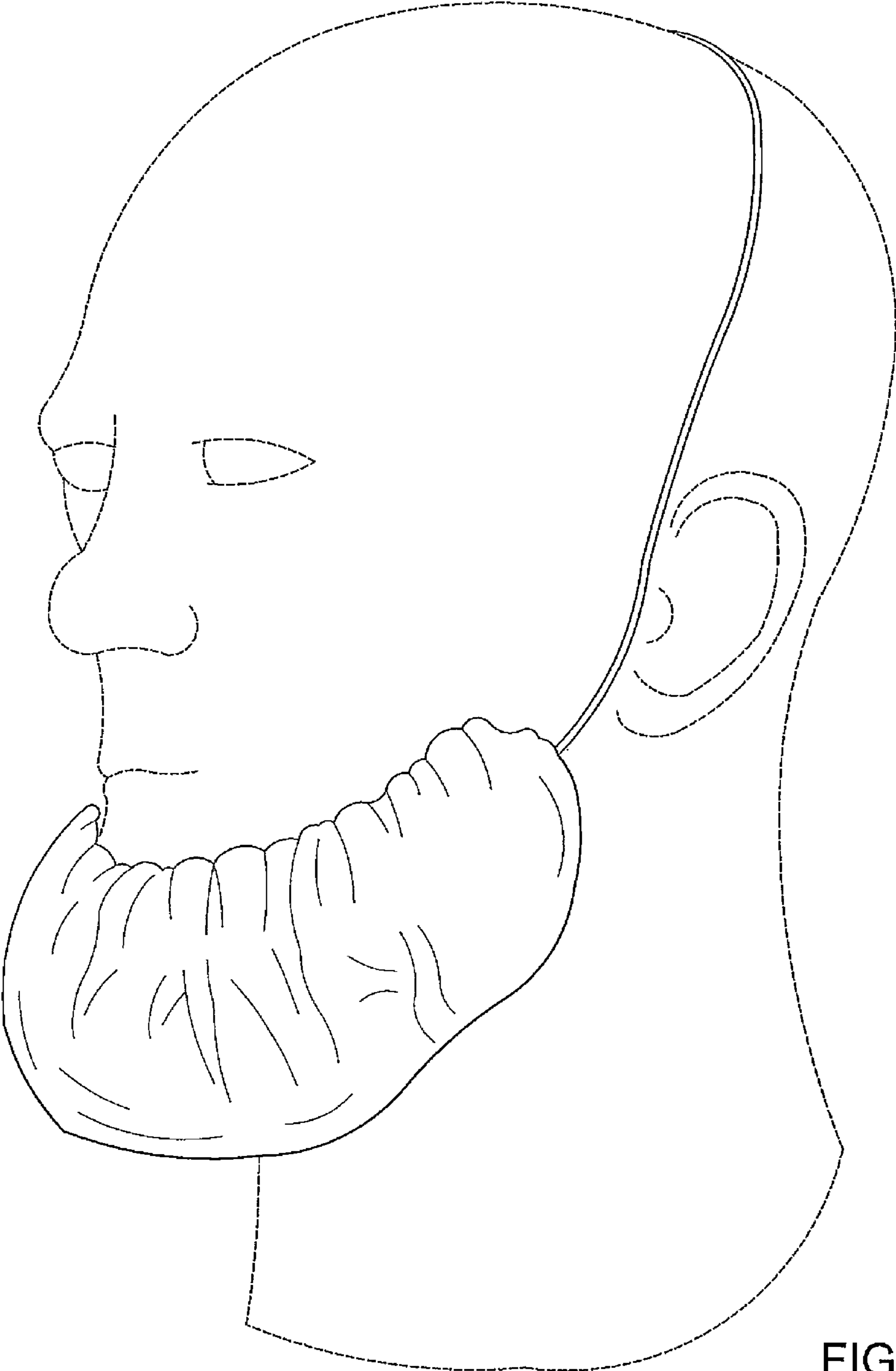
