DESCRIPTION

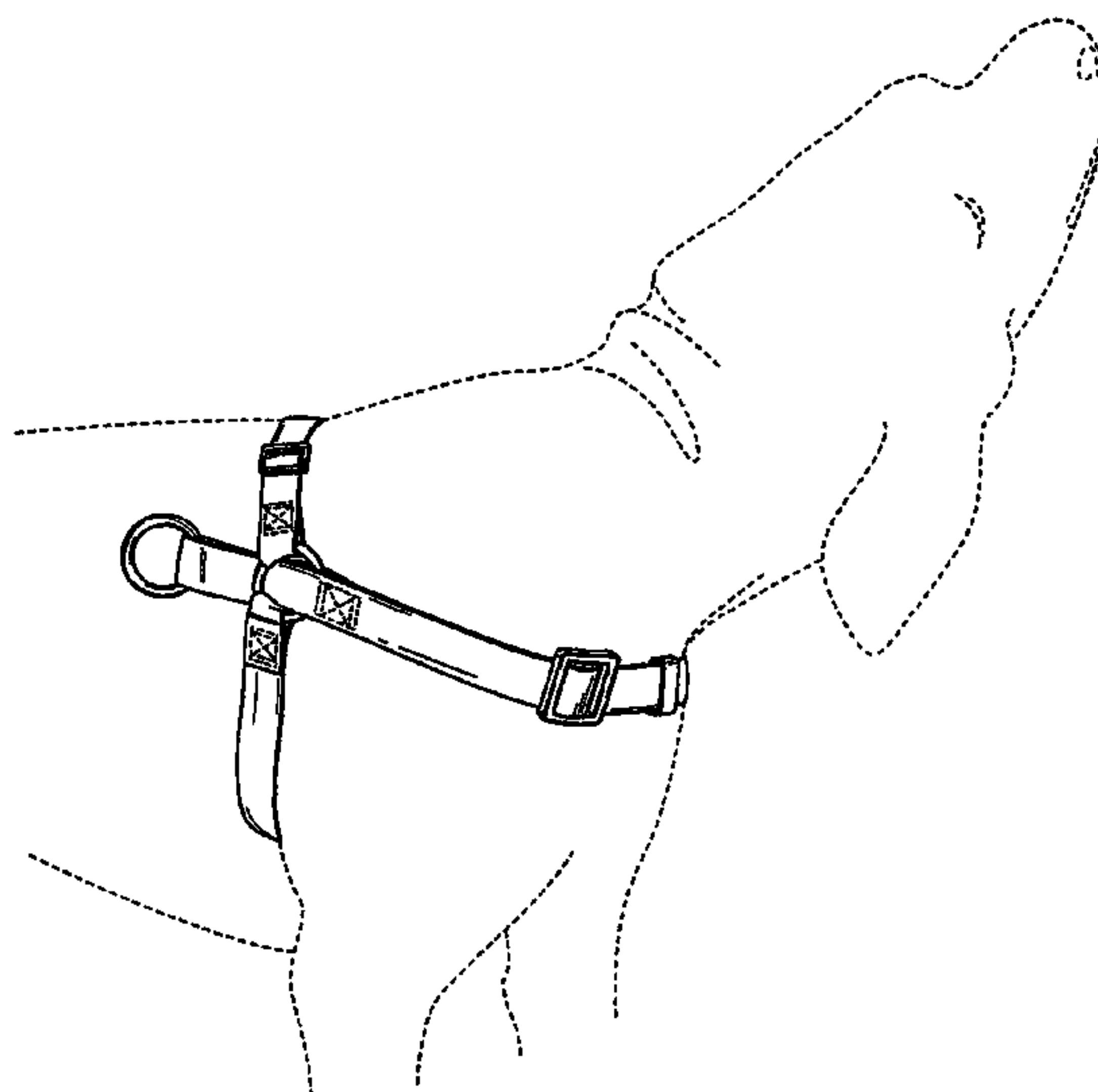
FIG. 1 is a left front perspective view of a dog collar, showing a first embodiment of my new design;

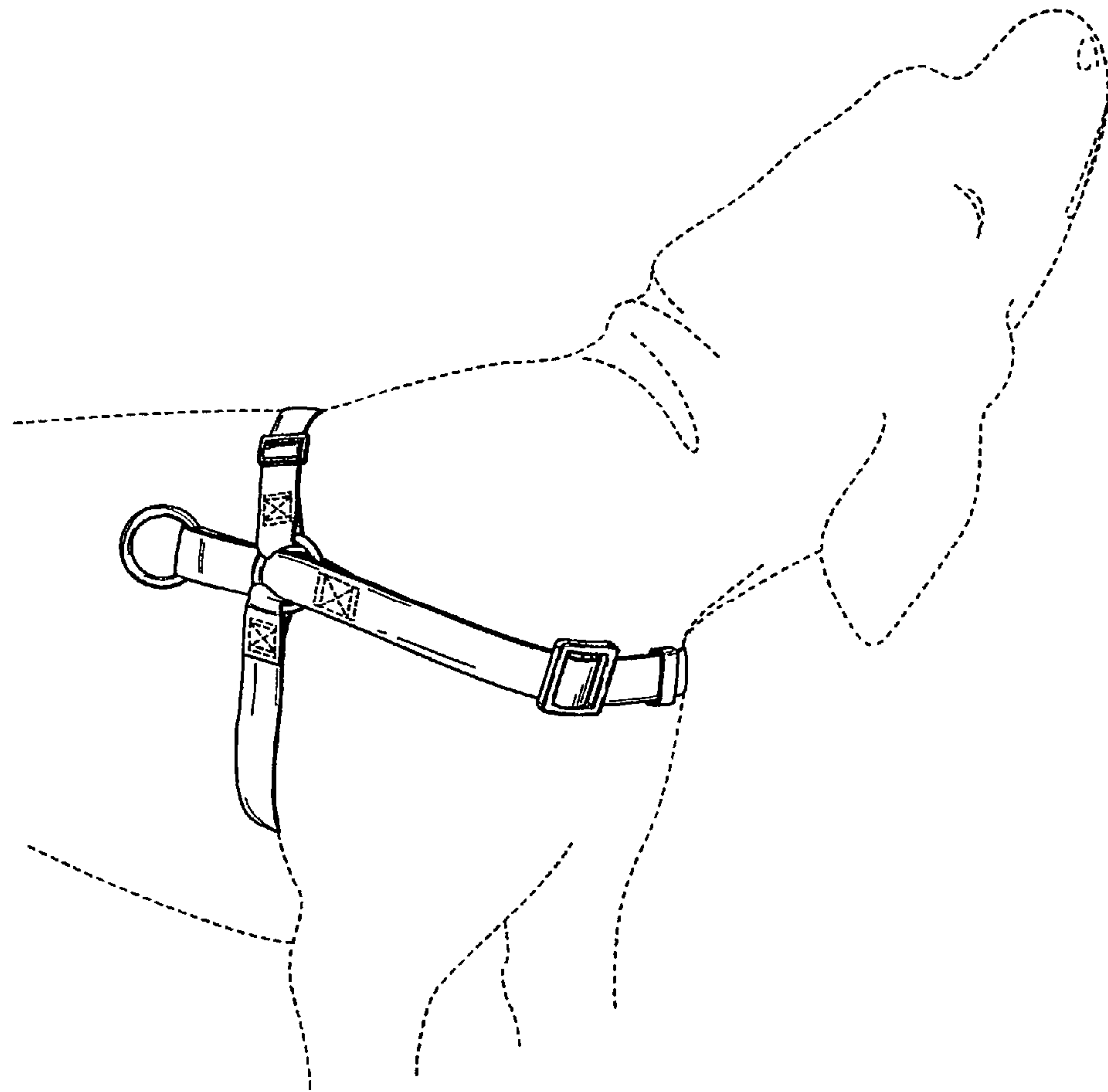

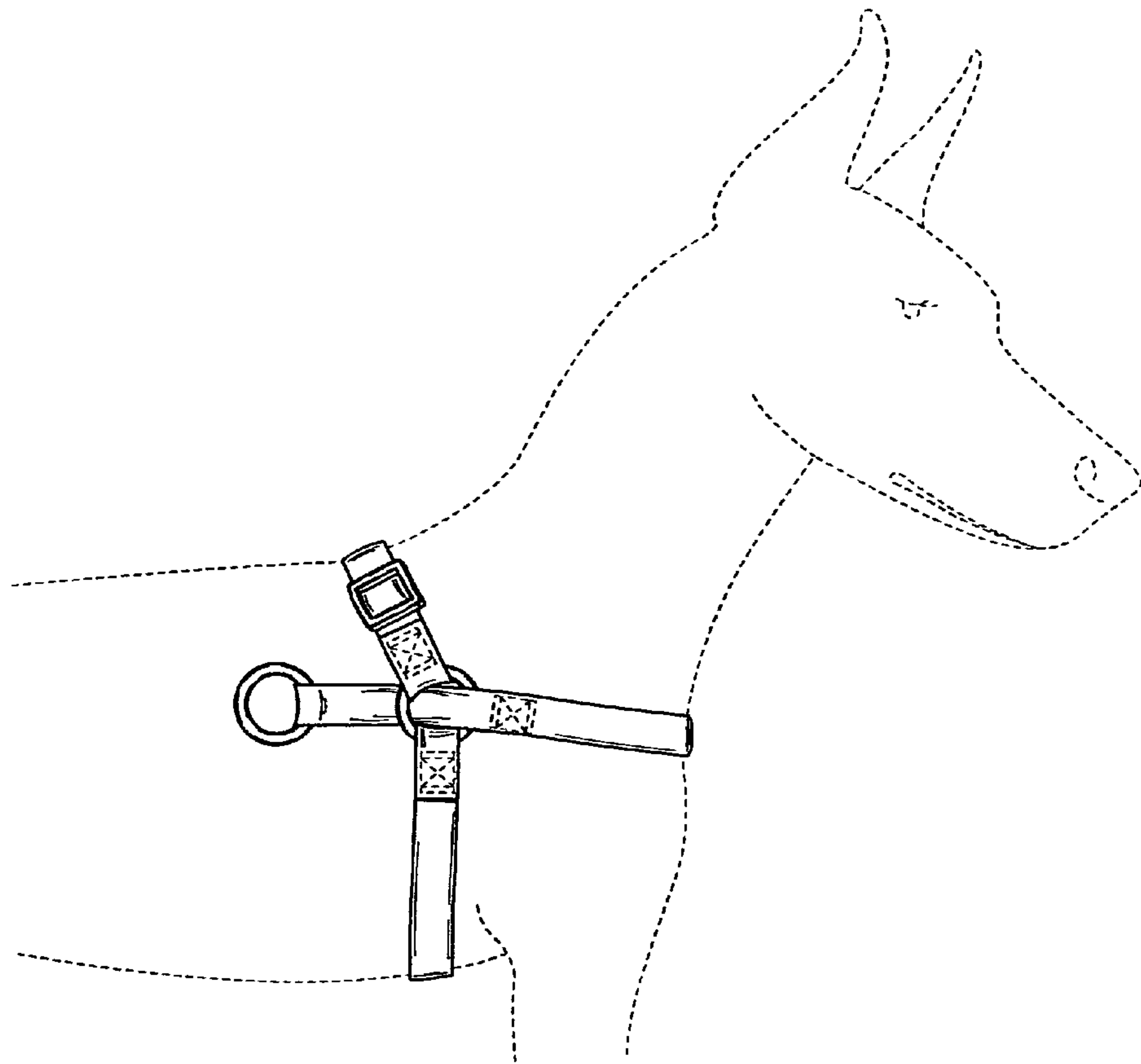

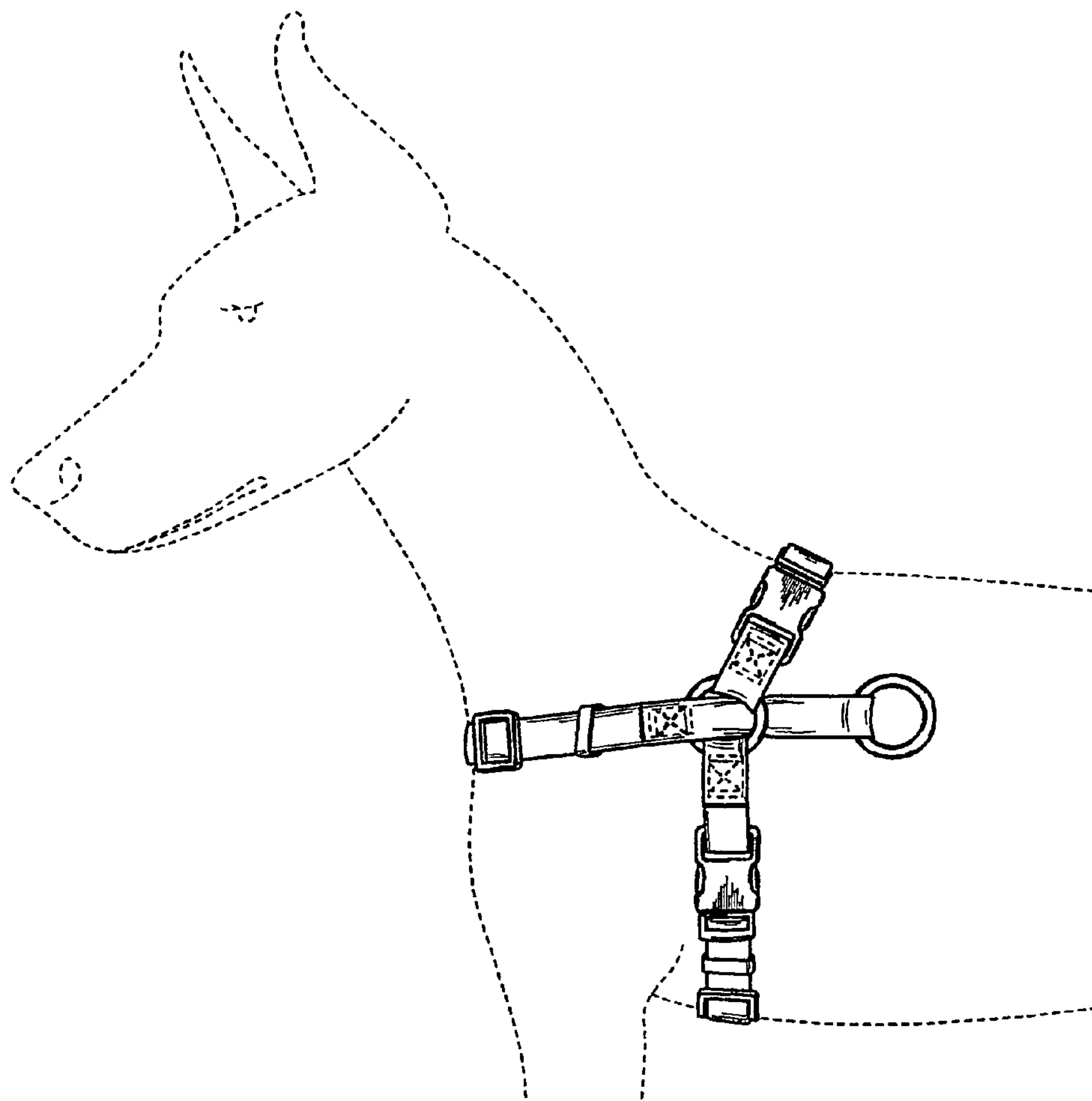

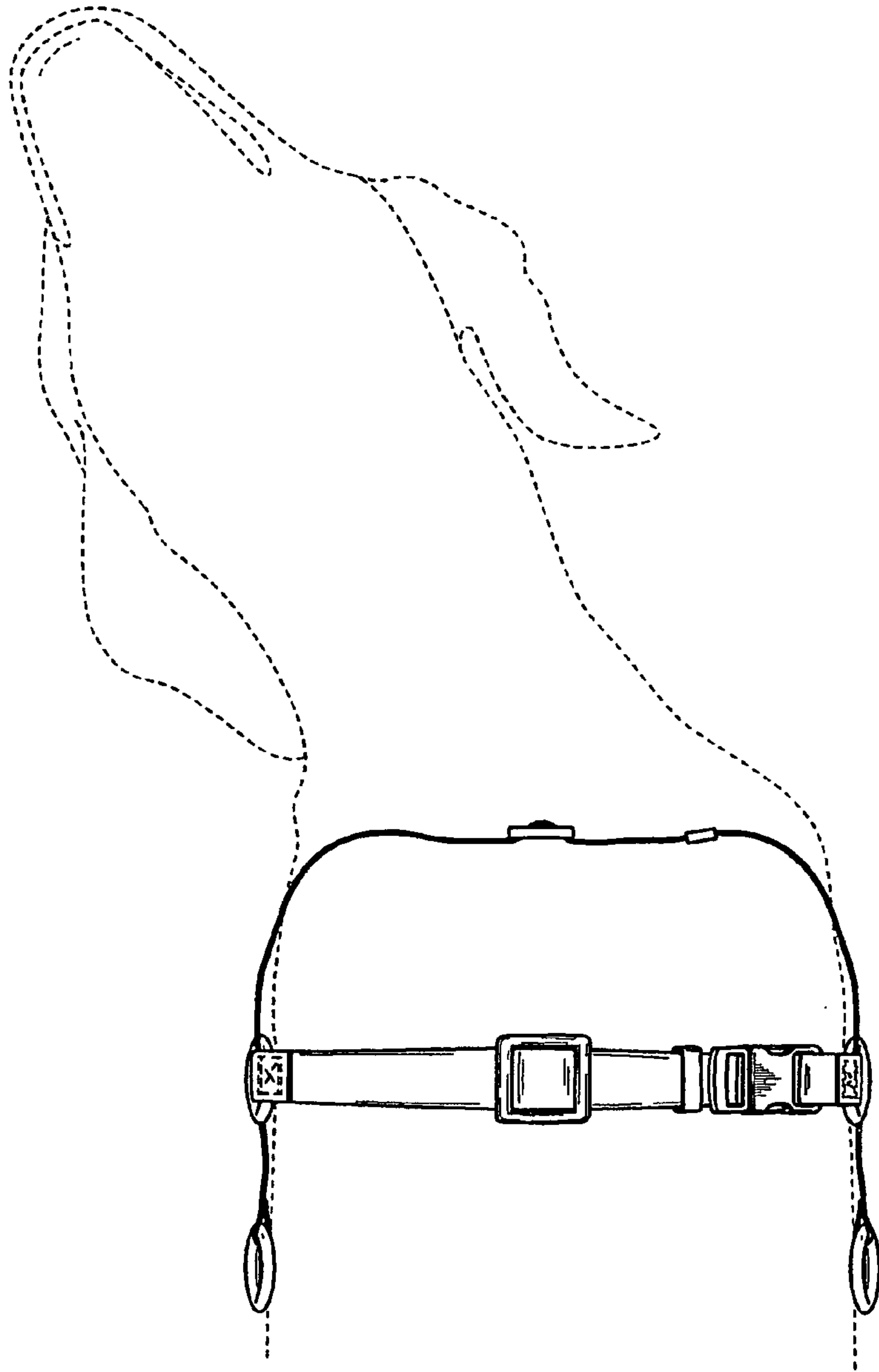

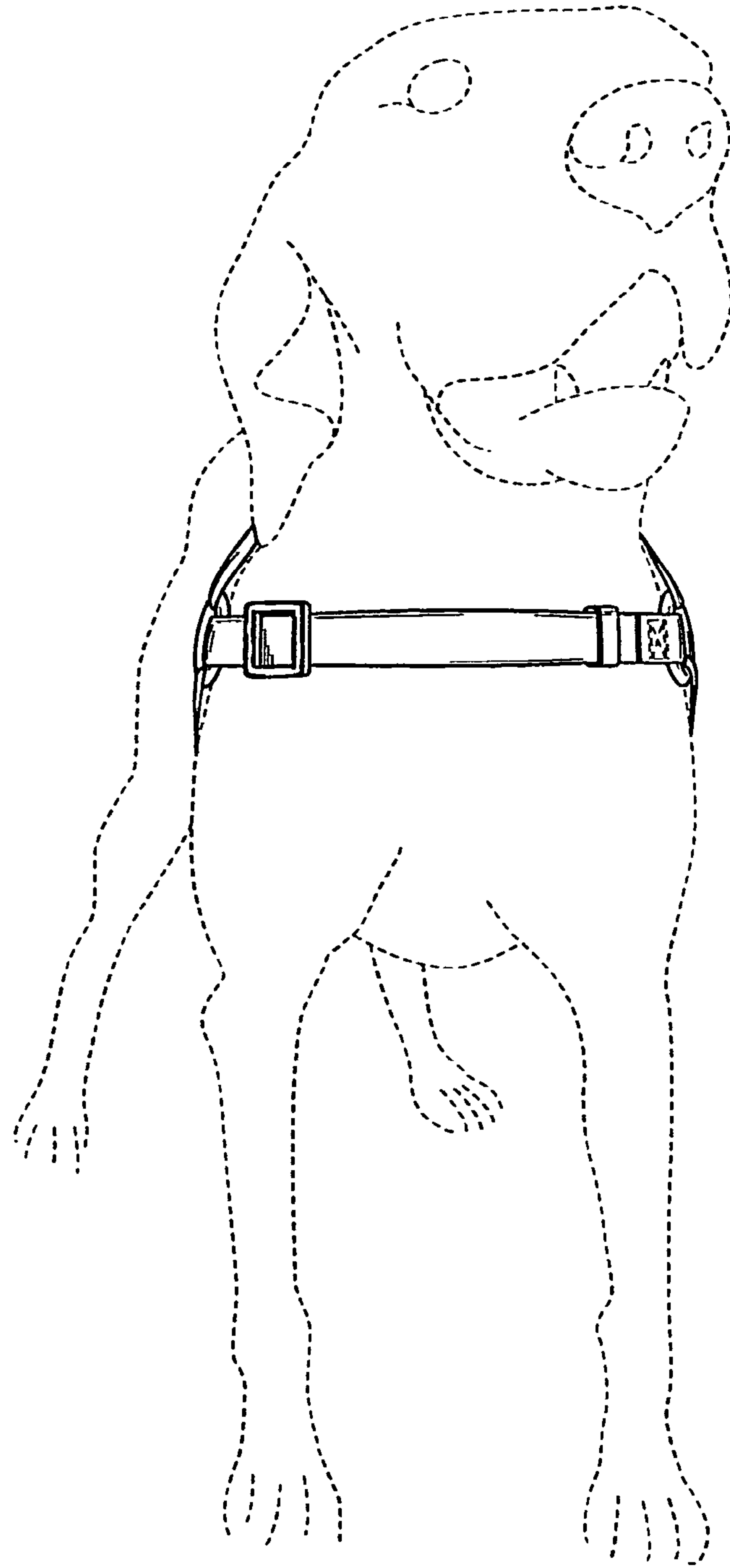

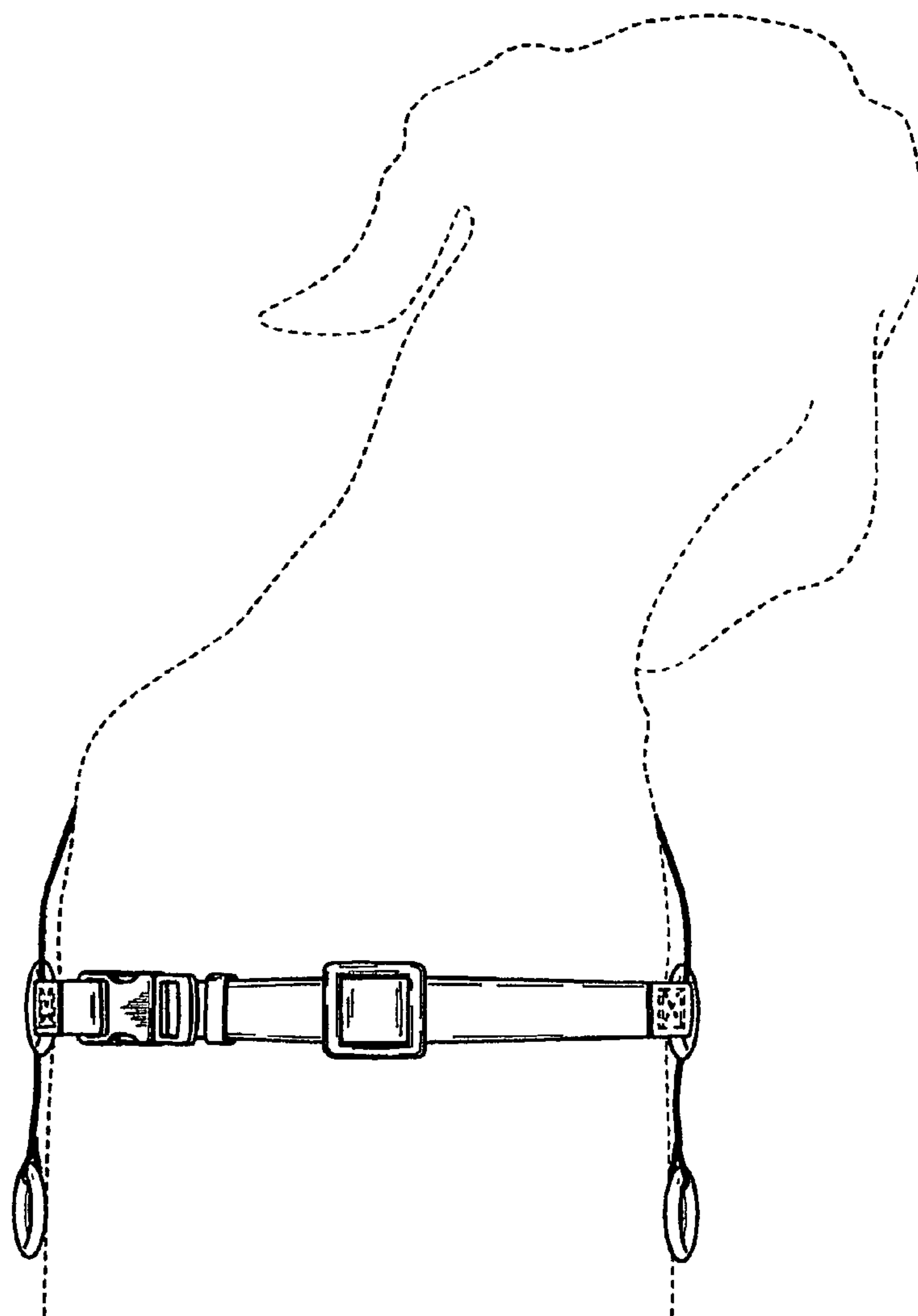

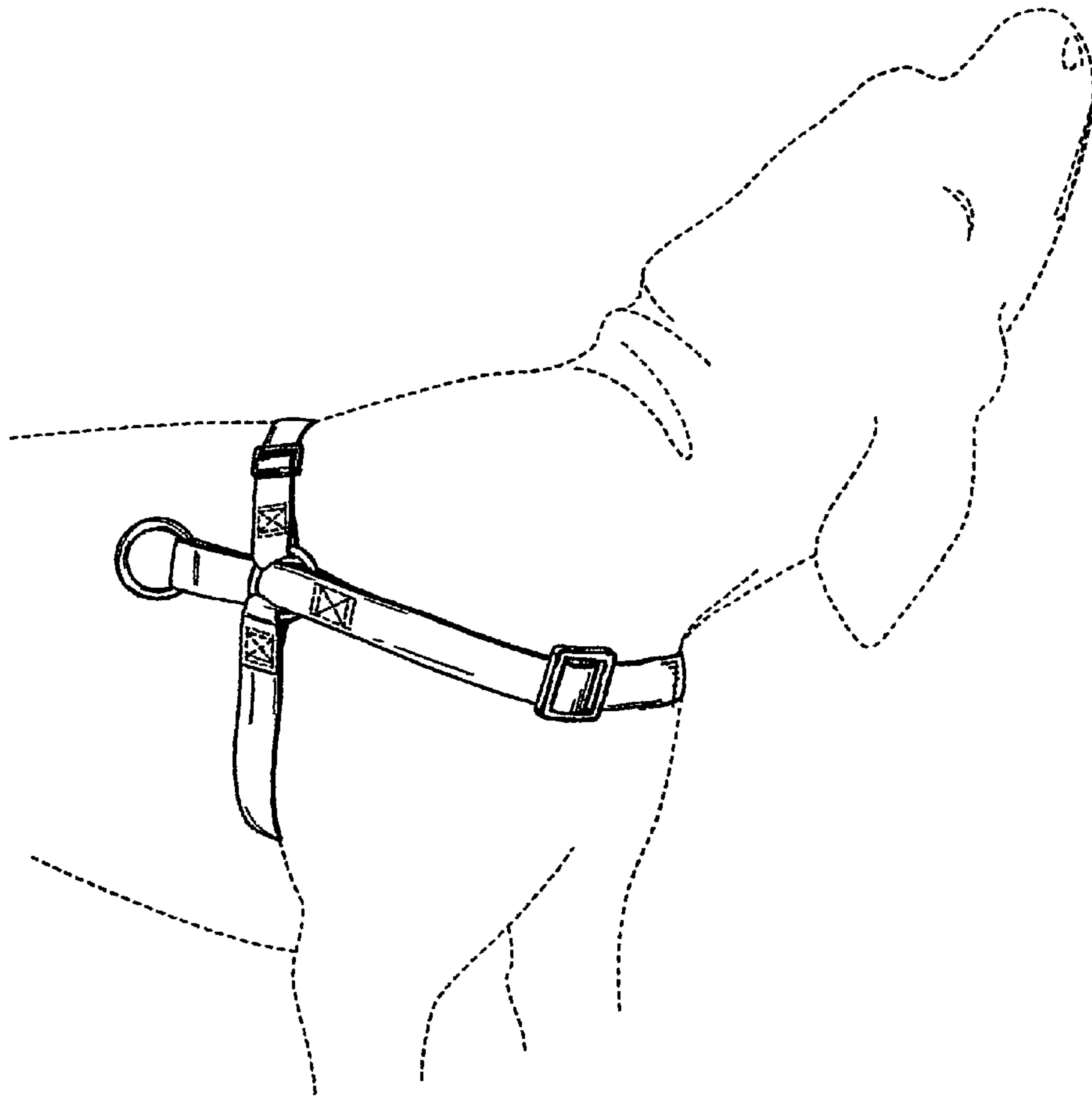

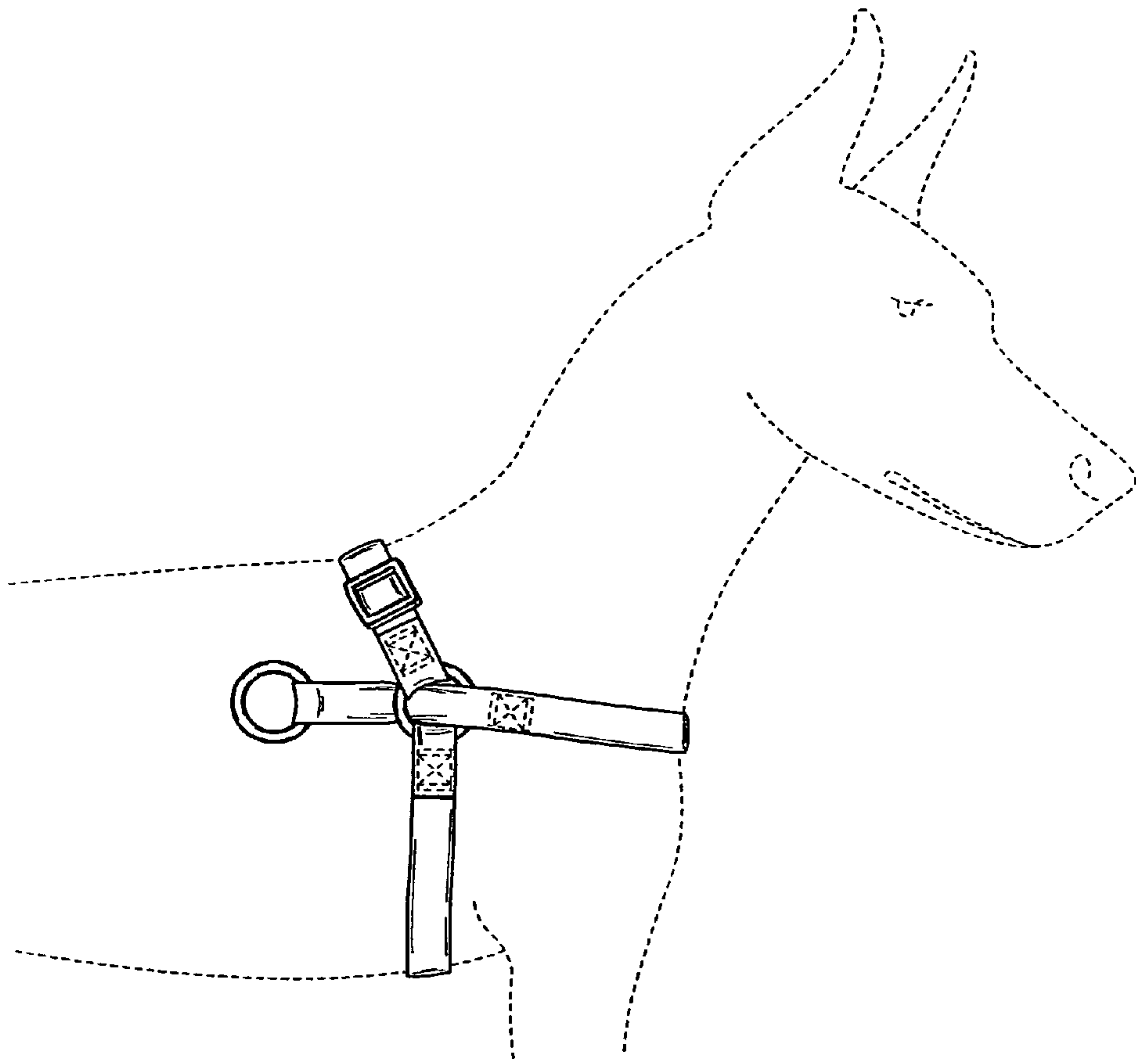

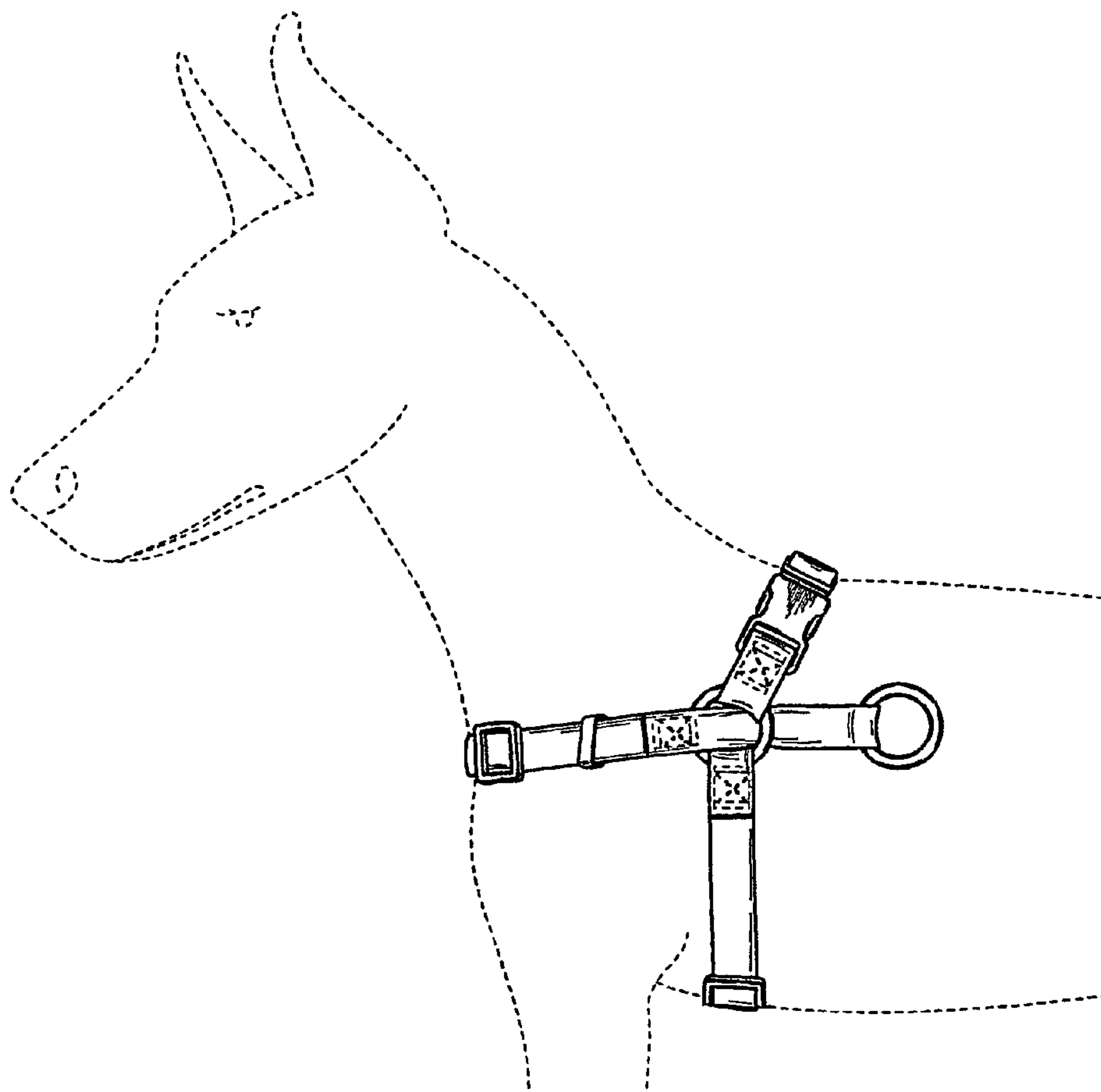

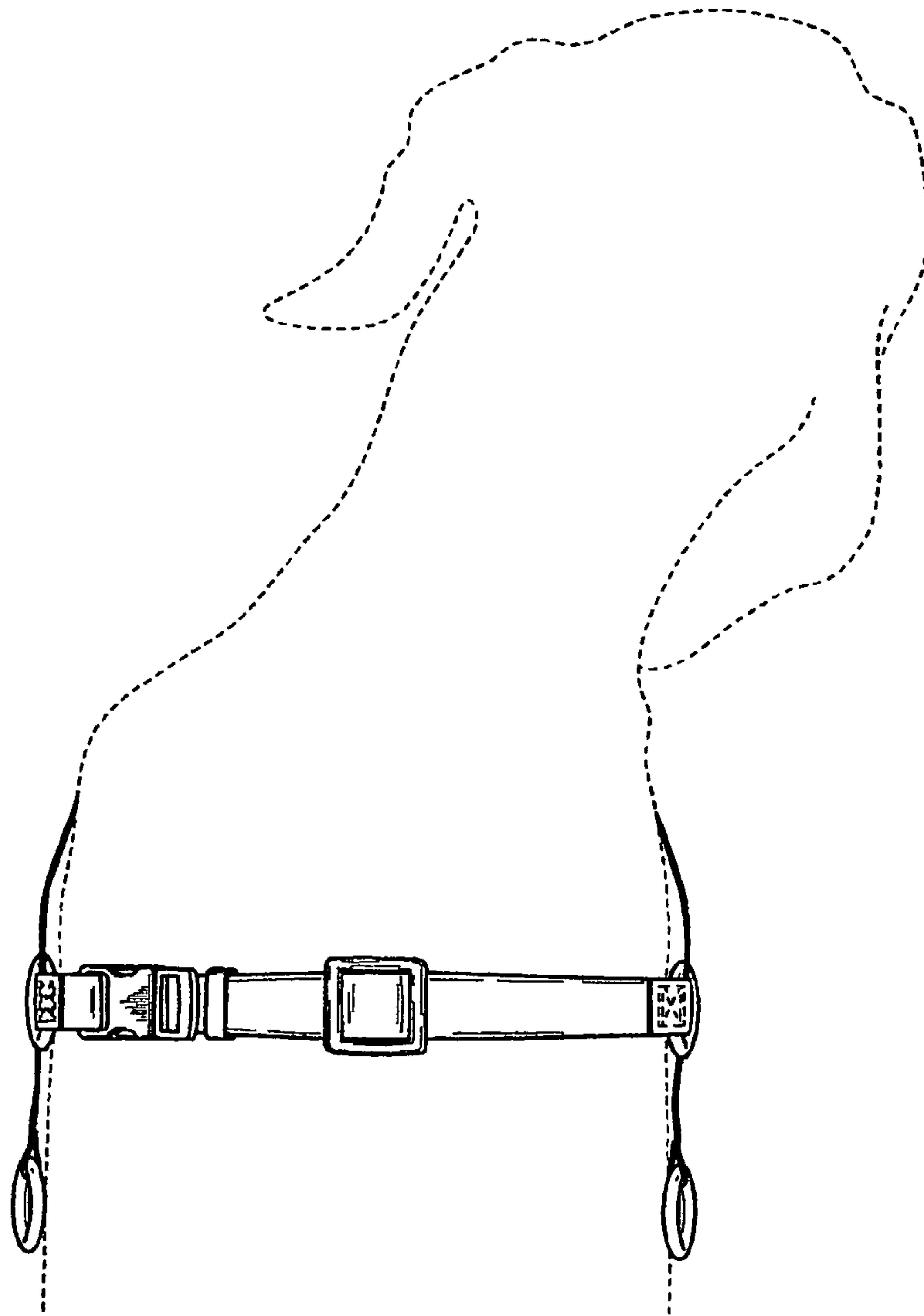

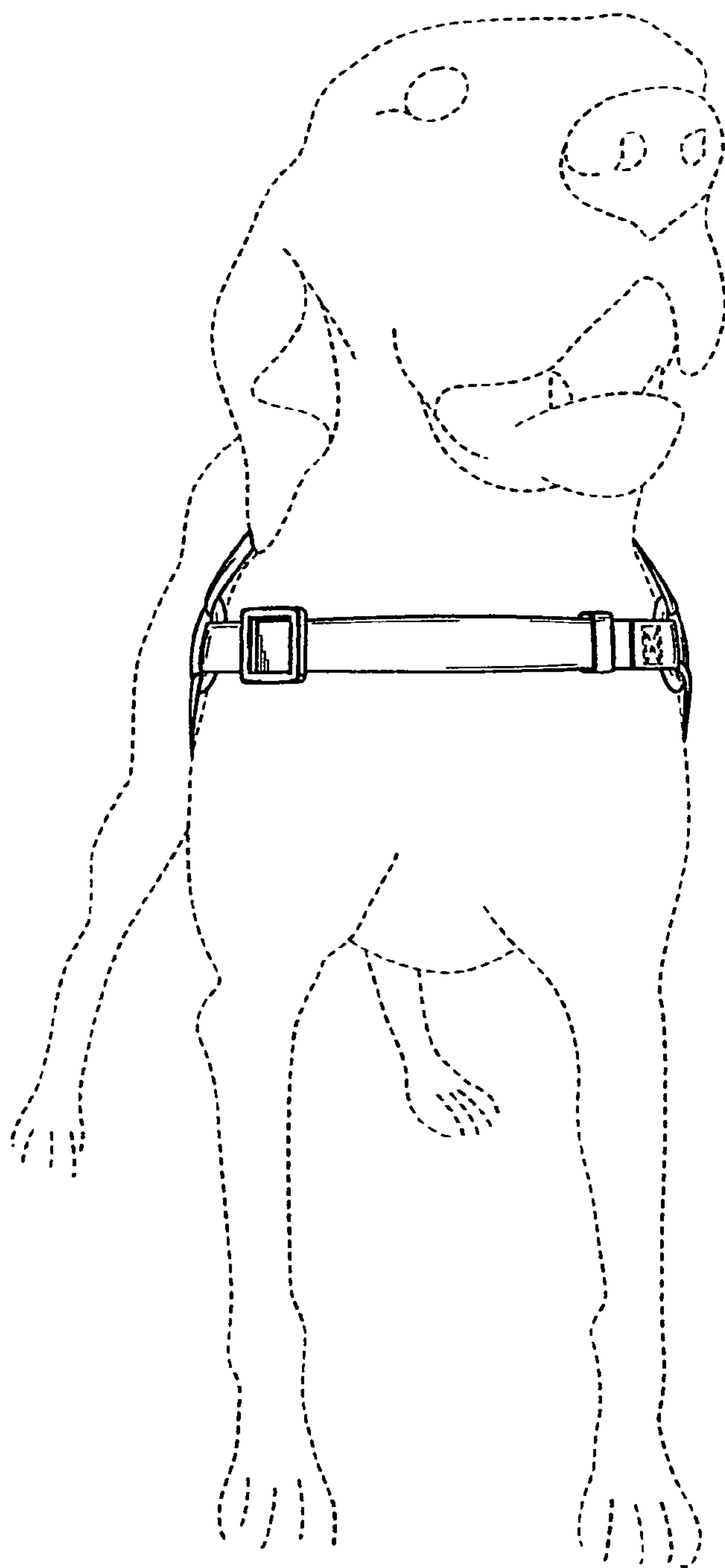

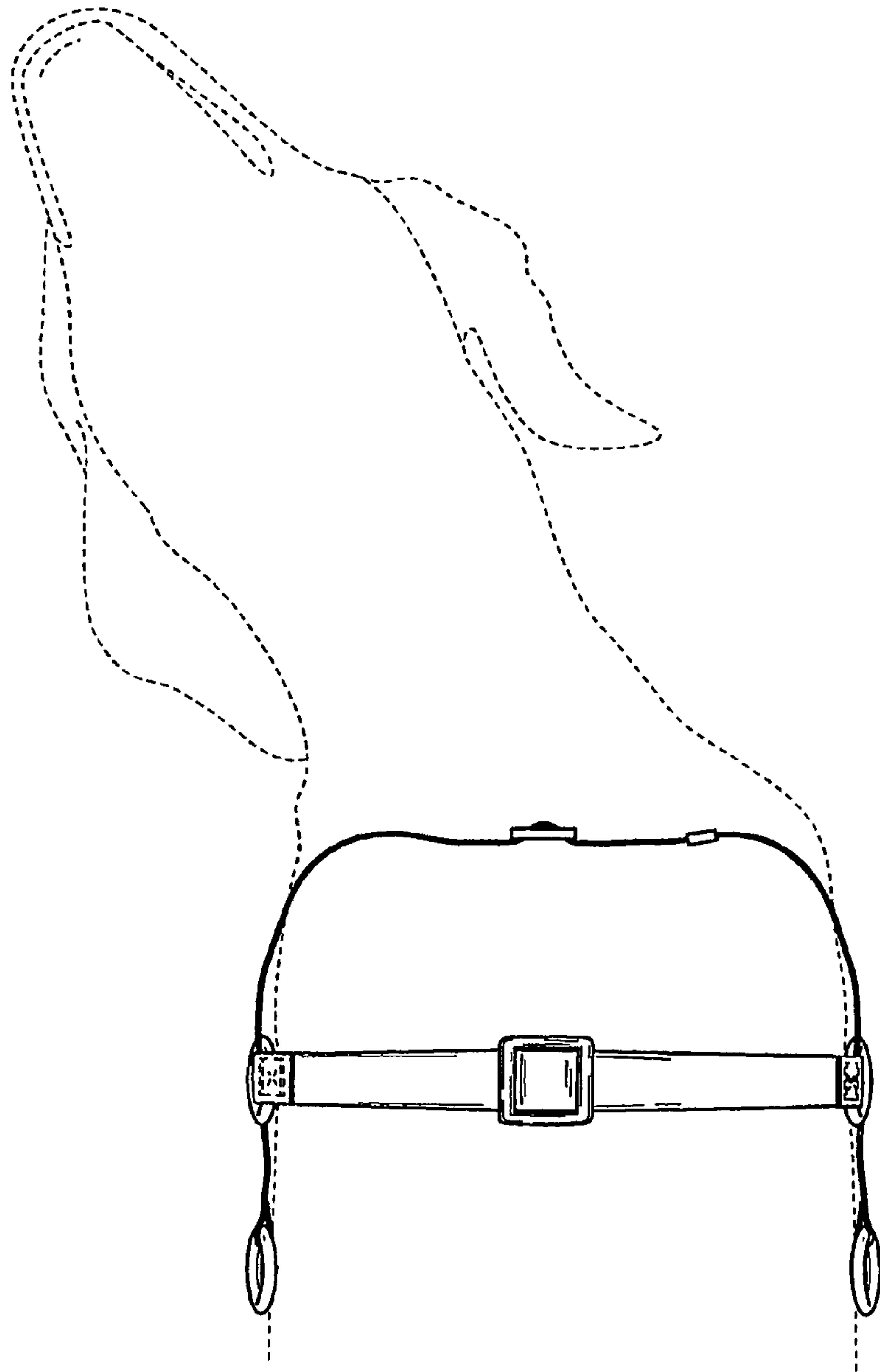
