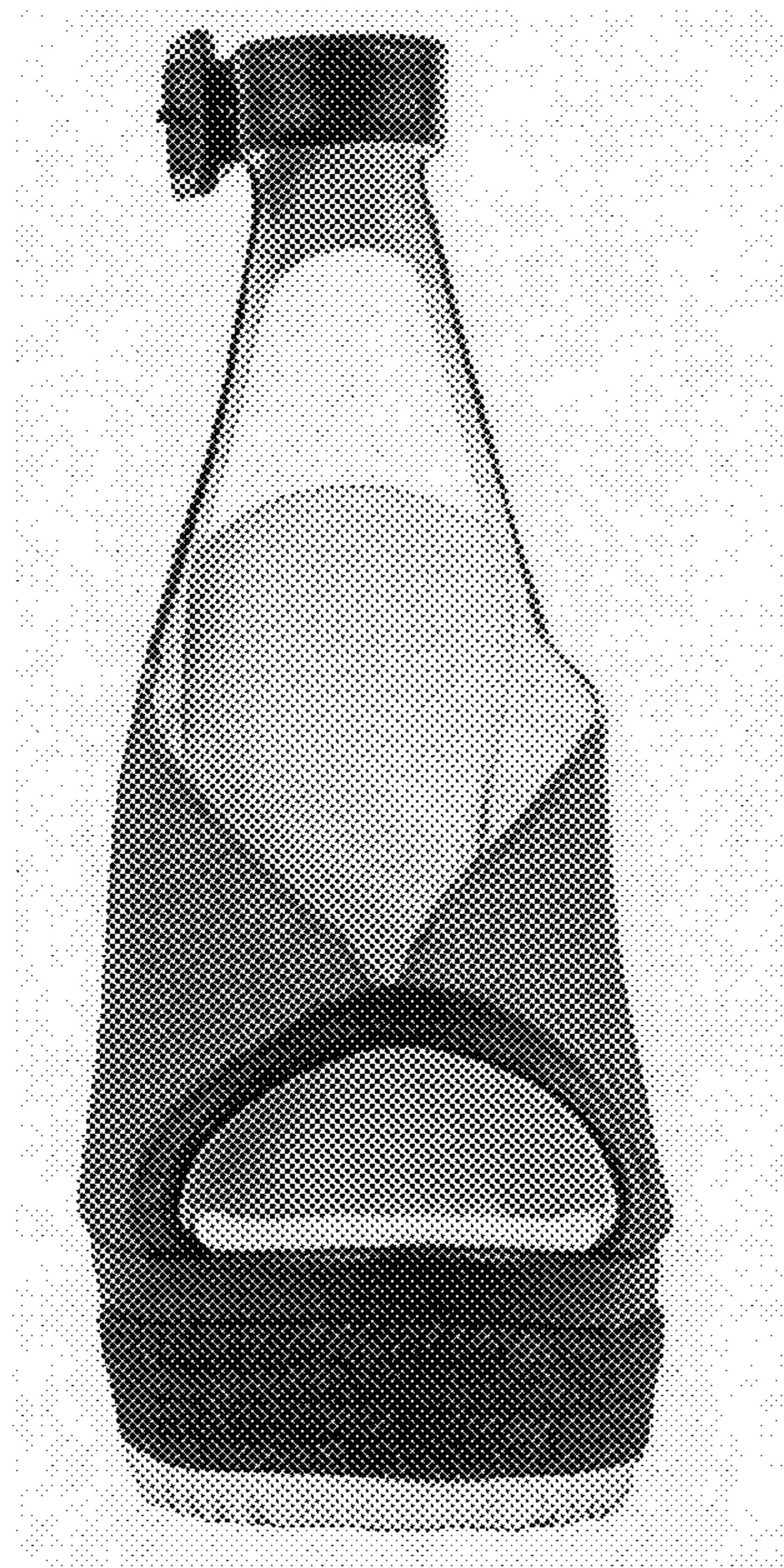
FIG. 1 is a front view of a shoe of the claimed design;

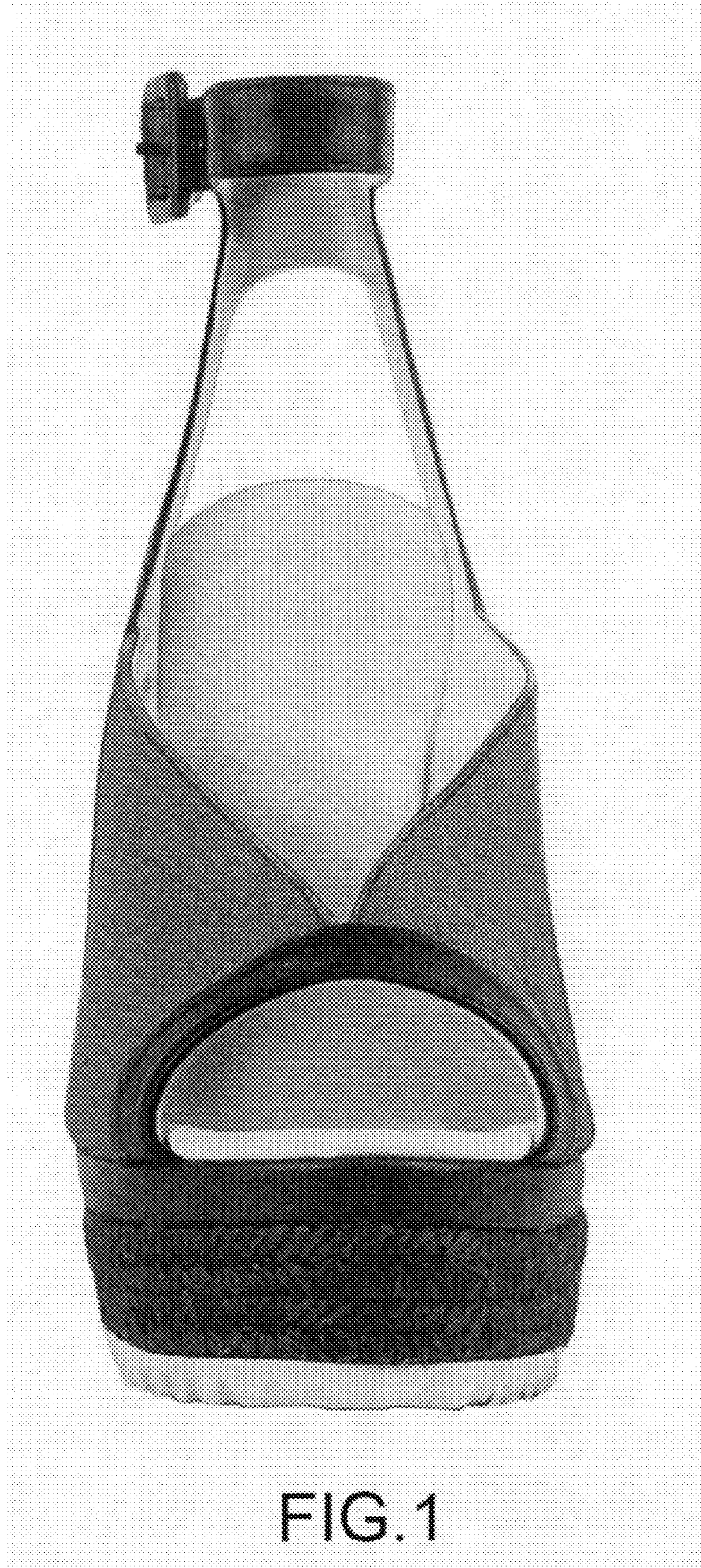

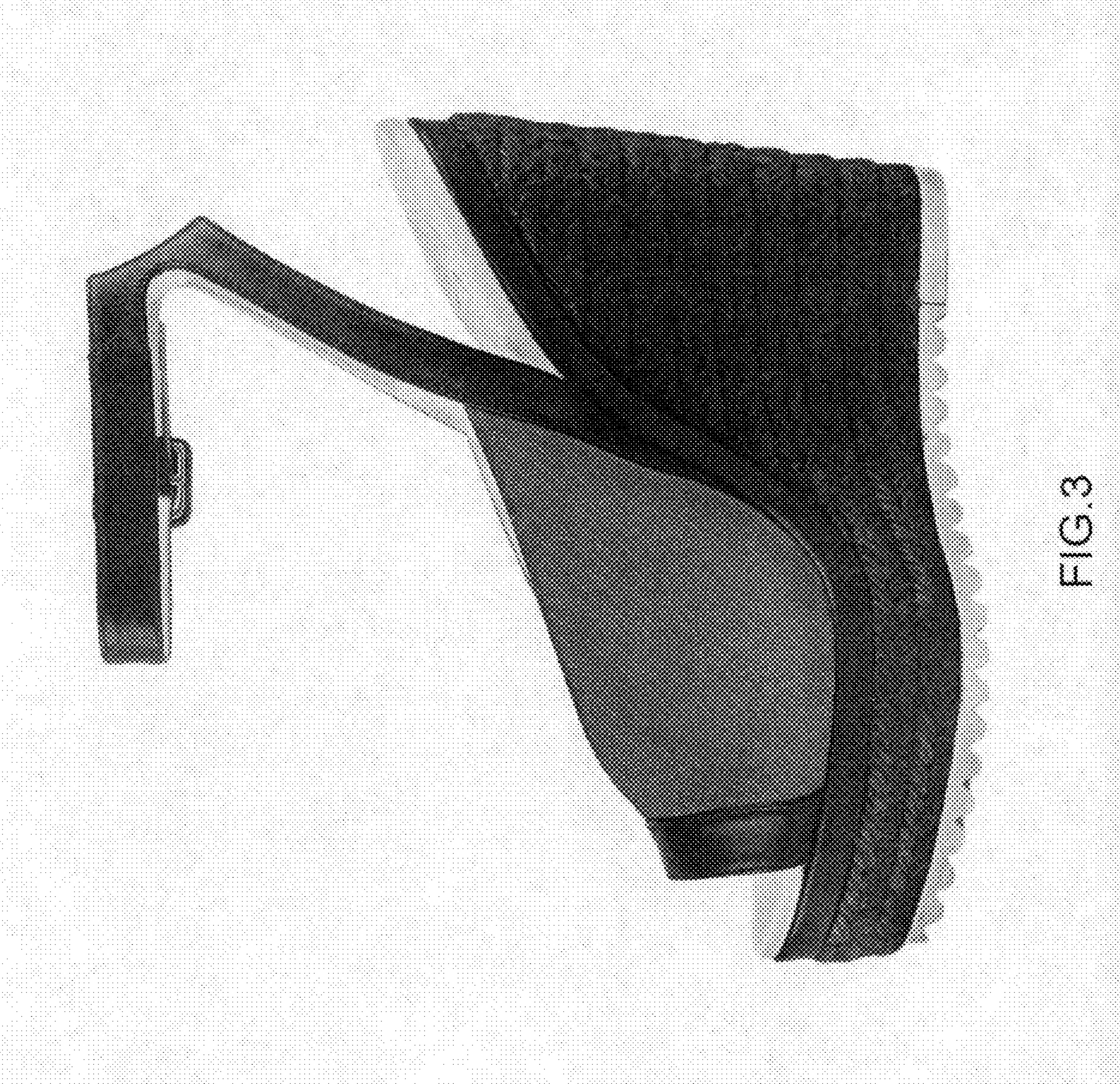

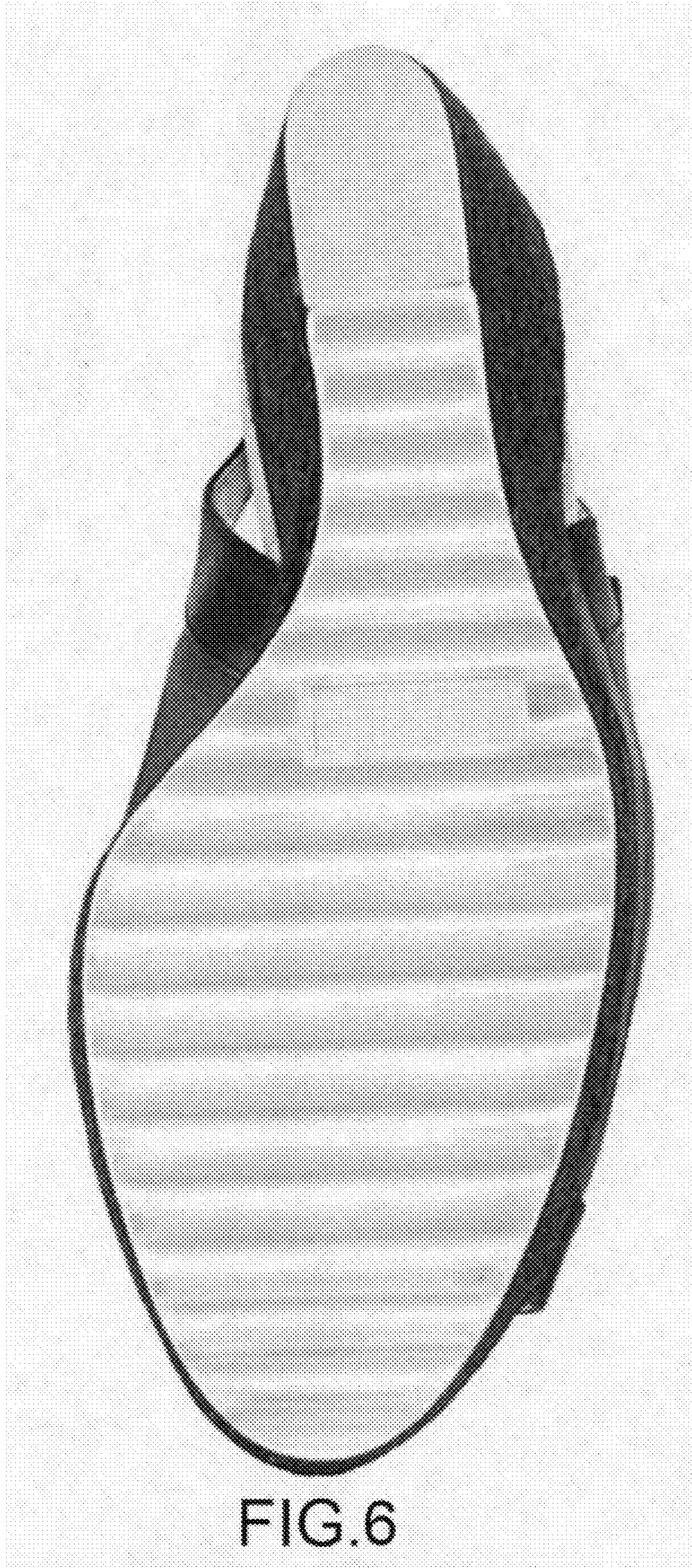
