DESCRIPTION

FIG. 1 is a bottom plan view of the dog walking belt showing my new design;

FIG. 2 is a top plan view of the dog walking belt;

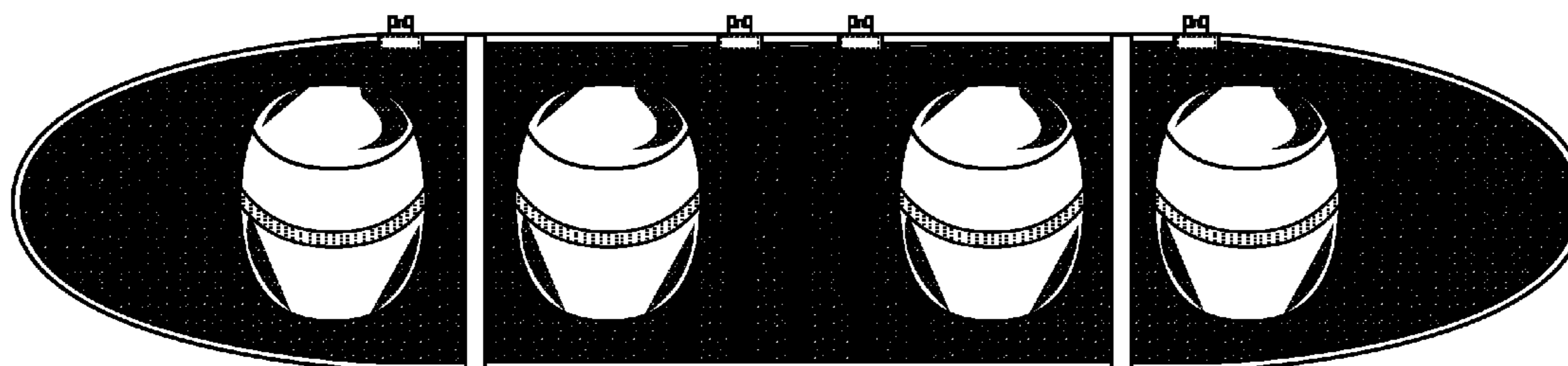
FIG. 3 is a right side view of the dog walking belt;

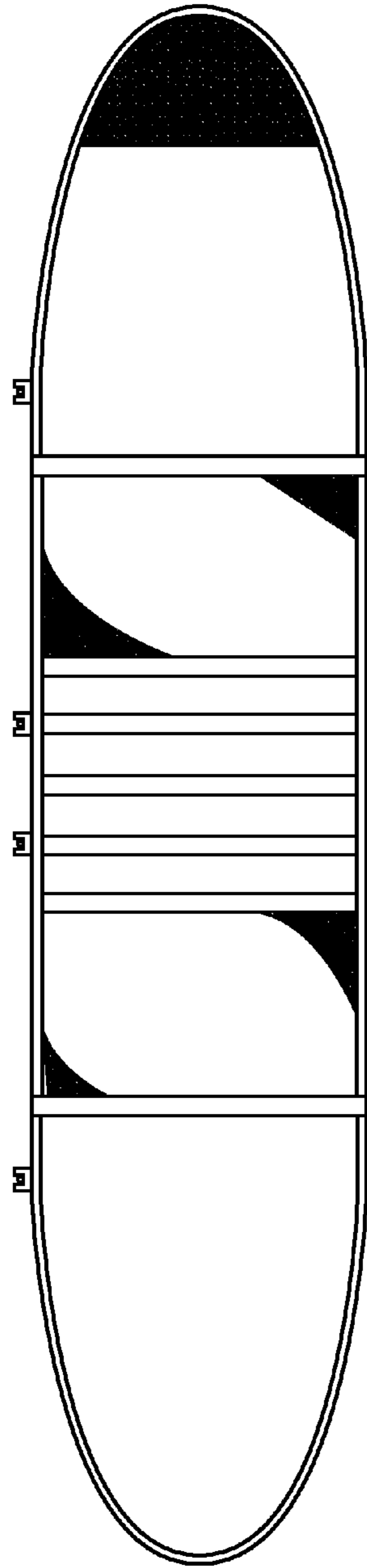

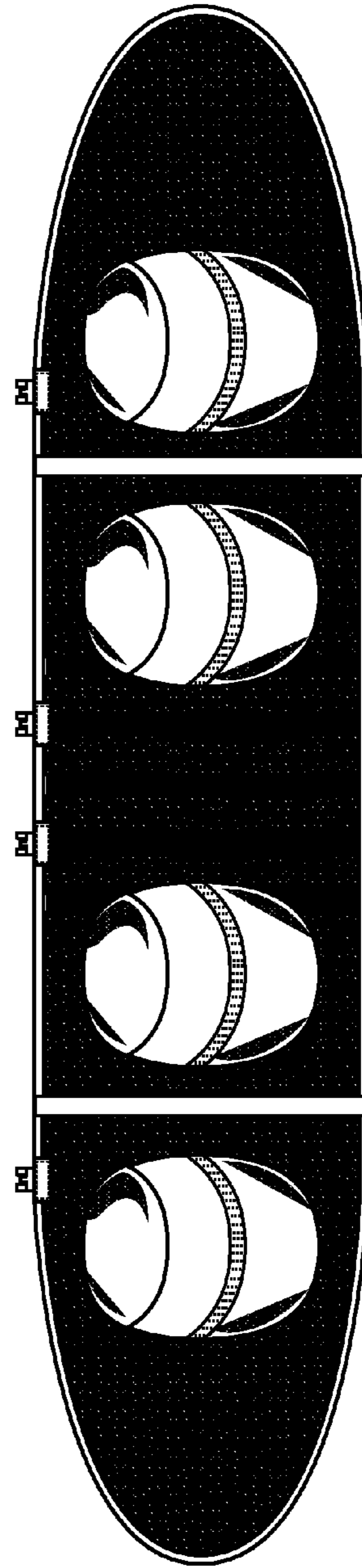

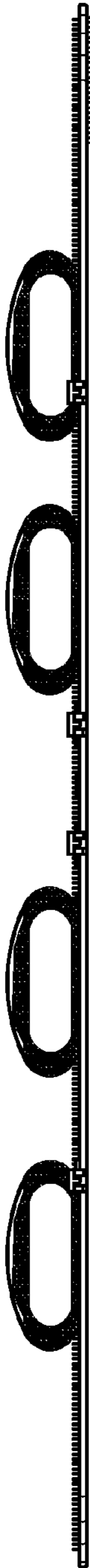

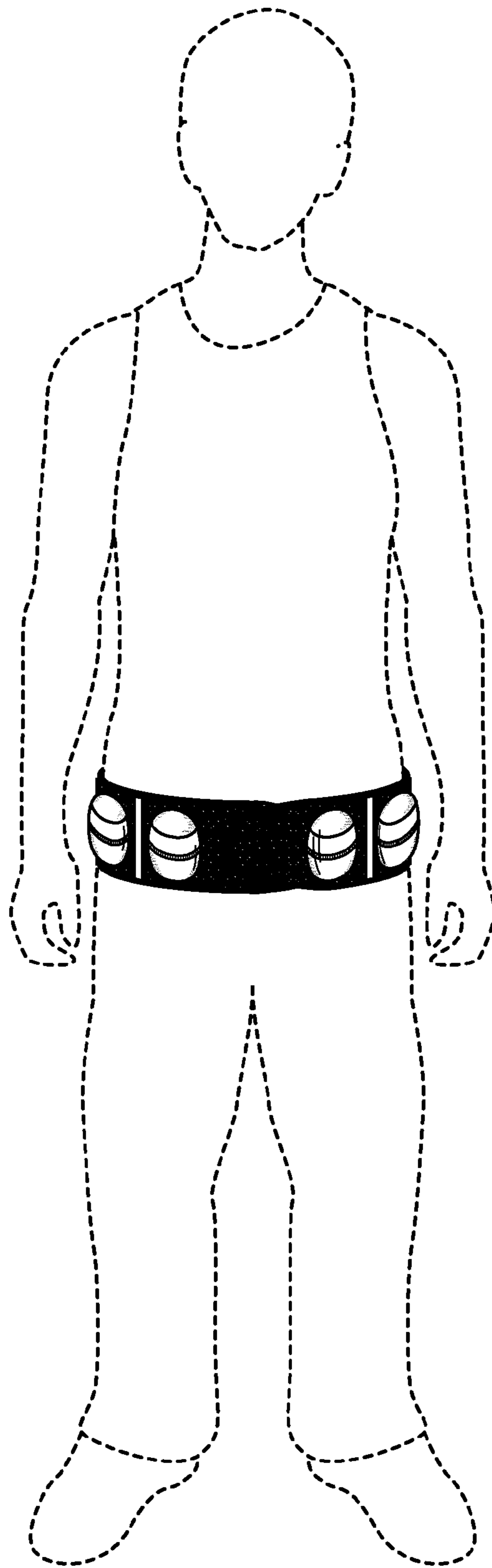
