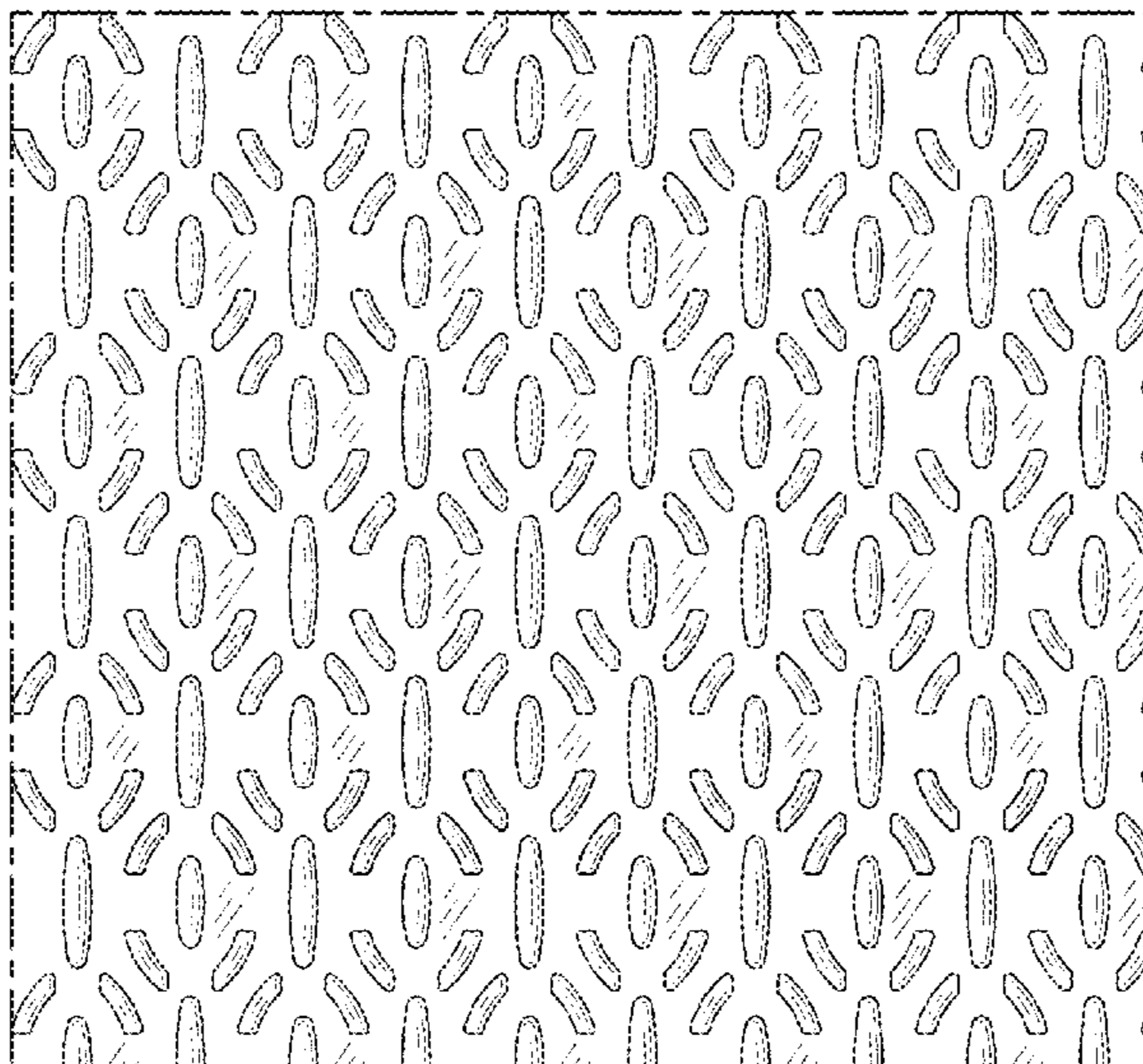
(57) **CLAIM**

The ornamental design for an embossed film with surface pattern, as shown and described.

DESCRIPTION

The sole FIGURE is a top plan view of an embossed film with surface pattern showing the new design. The dot dash dot broken line defines the boundaries of the claim and forms no part thereof. It is understood that the design is intended to be applied uniformly to the embossed film.
