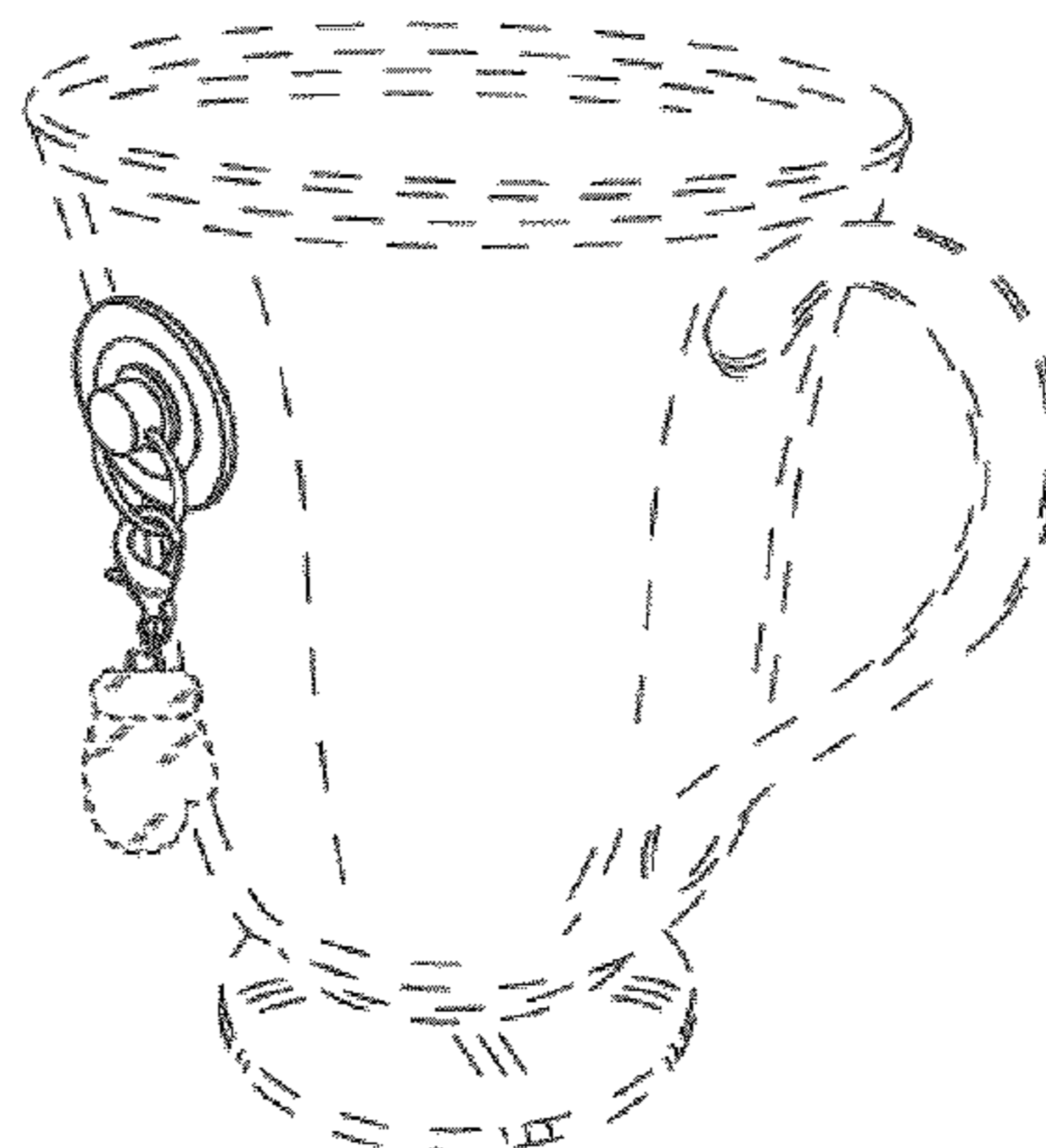
(57) **CLAIM**

The ornamental design for a beverage identification device, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a first embodiment of a beverage identification device showing the new design; FIG. 2 is another front elevation view thereof; FIG. 3 is another front elevation view thereof; FIG. 4 is a right front perspective view thereof; FIG. 5 is another front elevation view thereof; FIG. 6 is a front elevation view of an alternative embodiment of a beverage identification device showing the new design; FIG. 7 is a front elevation view of yet another alternative embodiment of a beverage identification device showing the new design; and, FIG. 8 is a front elevation view of yet another alternative embodiment of a beverage identification device showing the new design. The views of the beverage identification device not shown form no part of the claimed design. The broken lines depicting beverage vessels and optional ornamental identification charms represent environmental elements only and form no part of the claimed design.

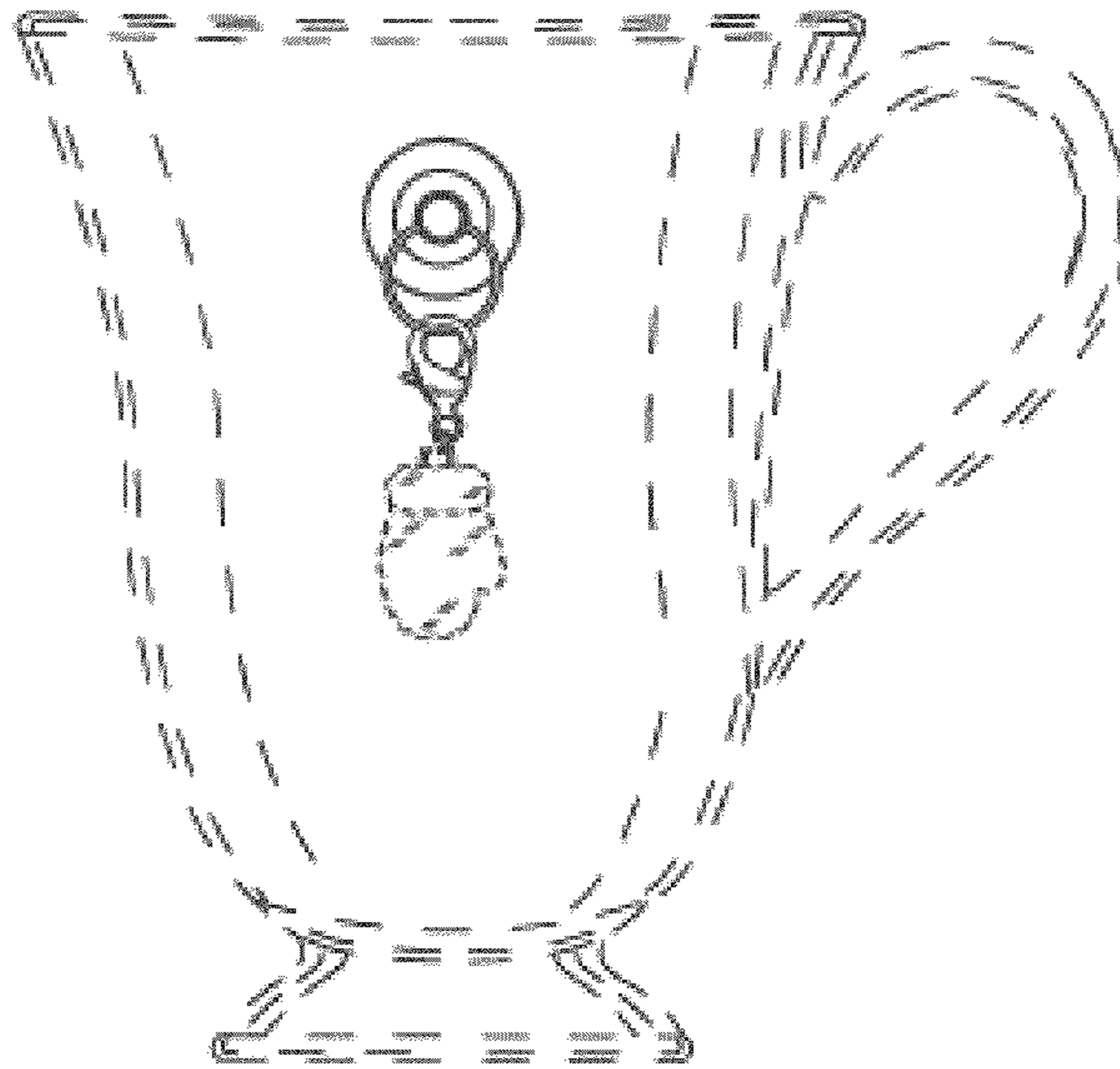

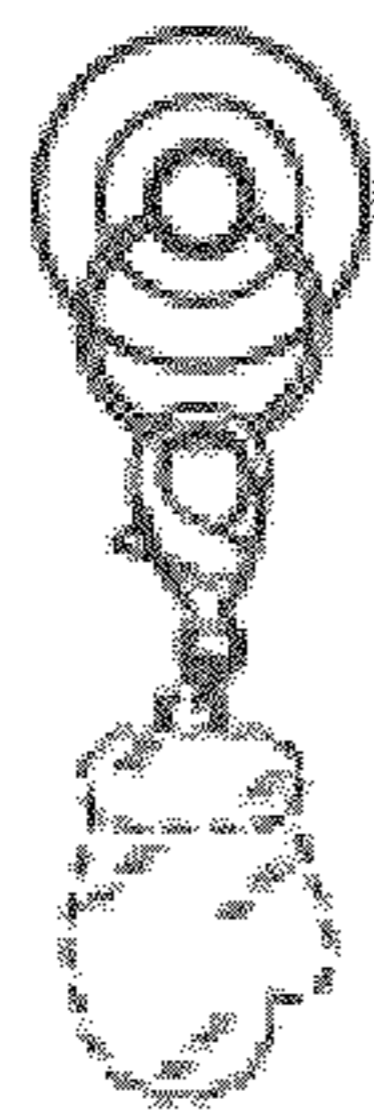

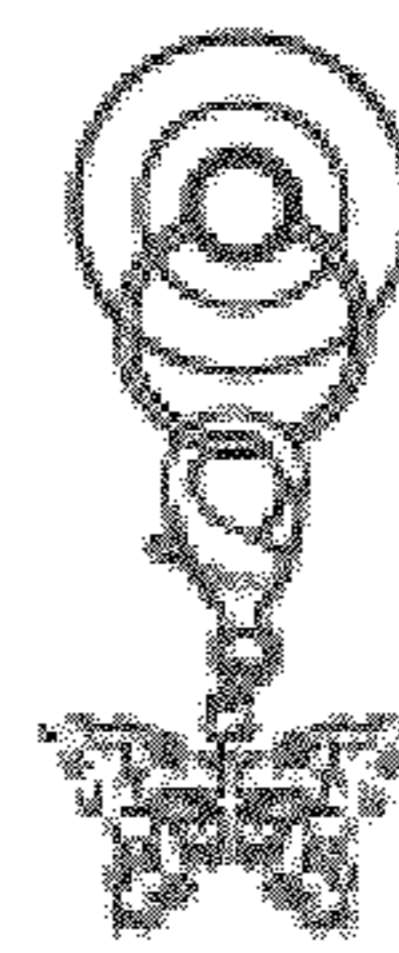

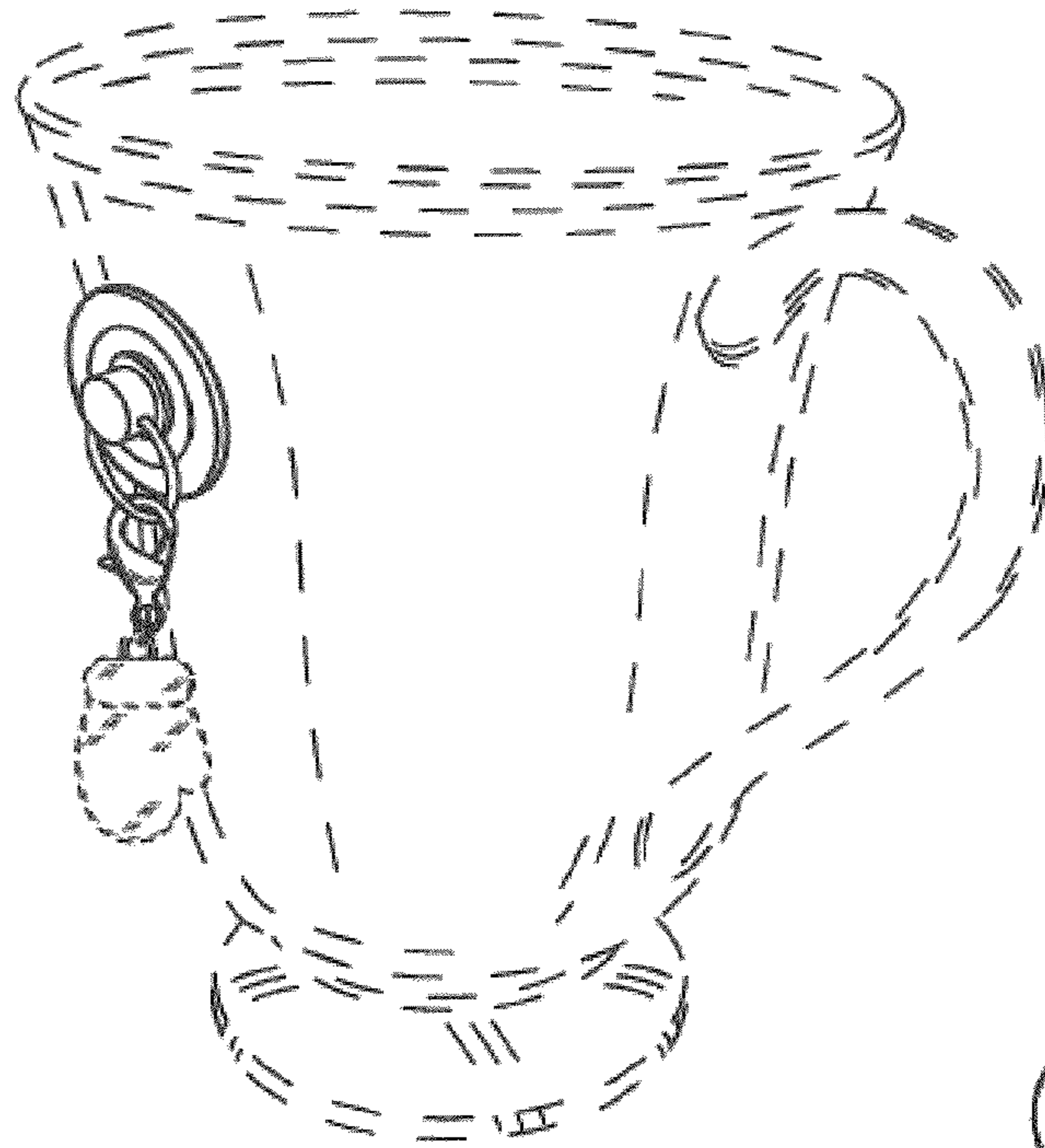

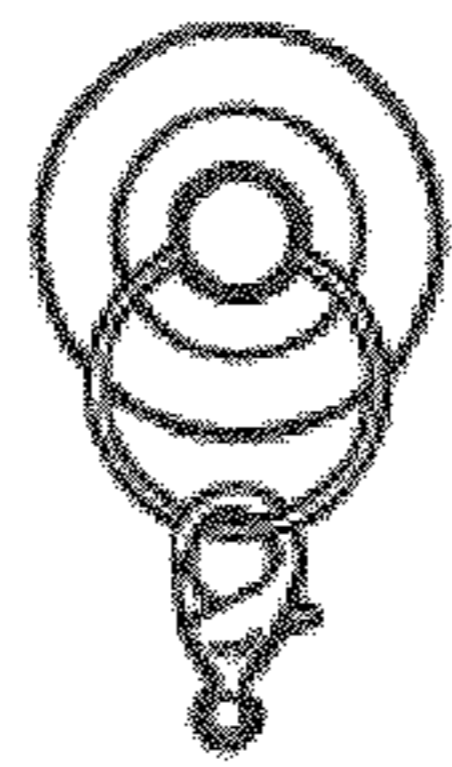
