The ornamental design for a sealing washer, as shown and described.

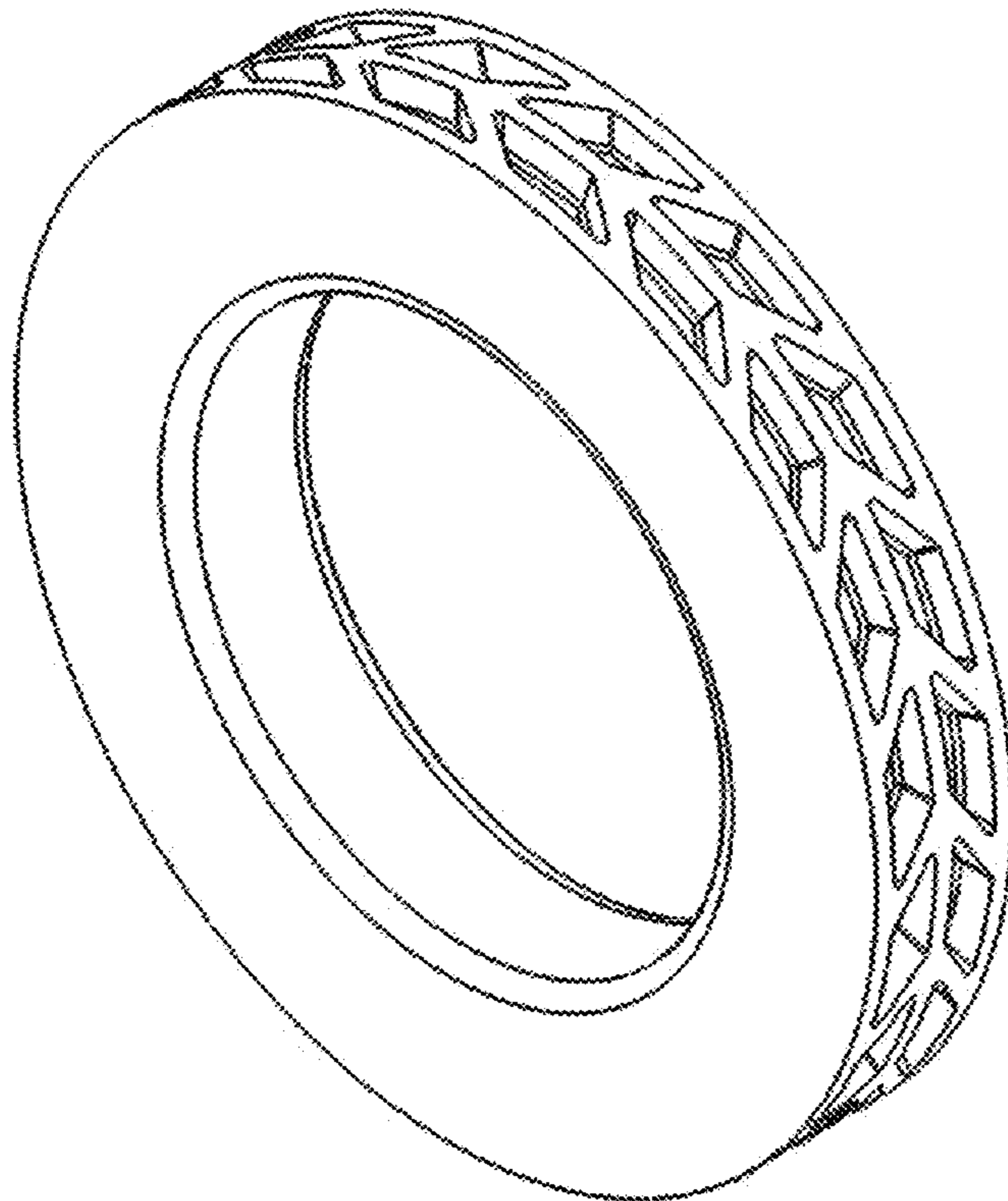
**DESCRIPTION**

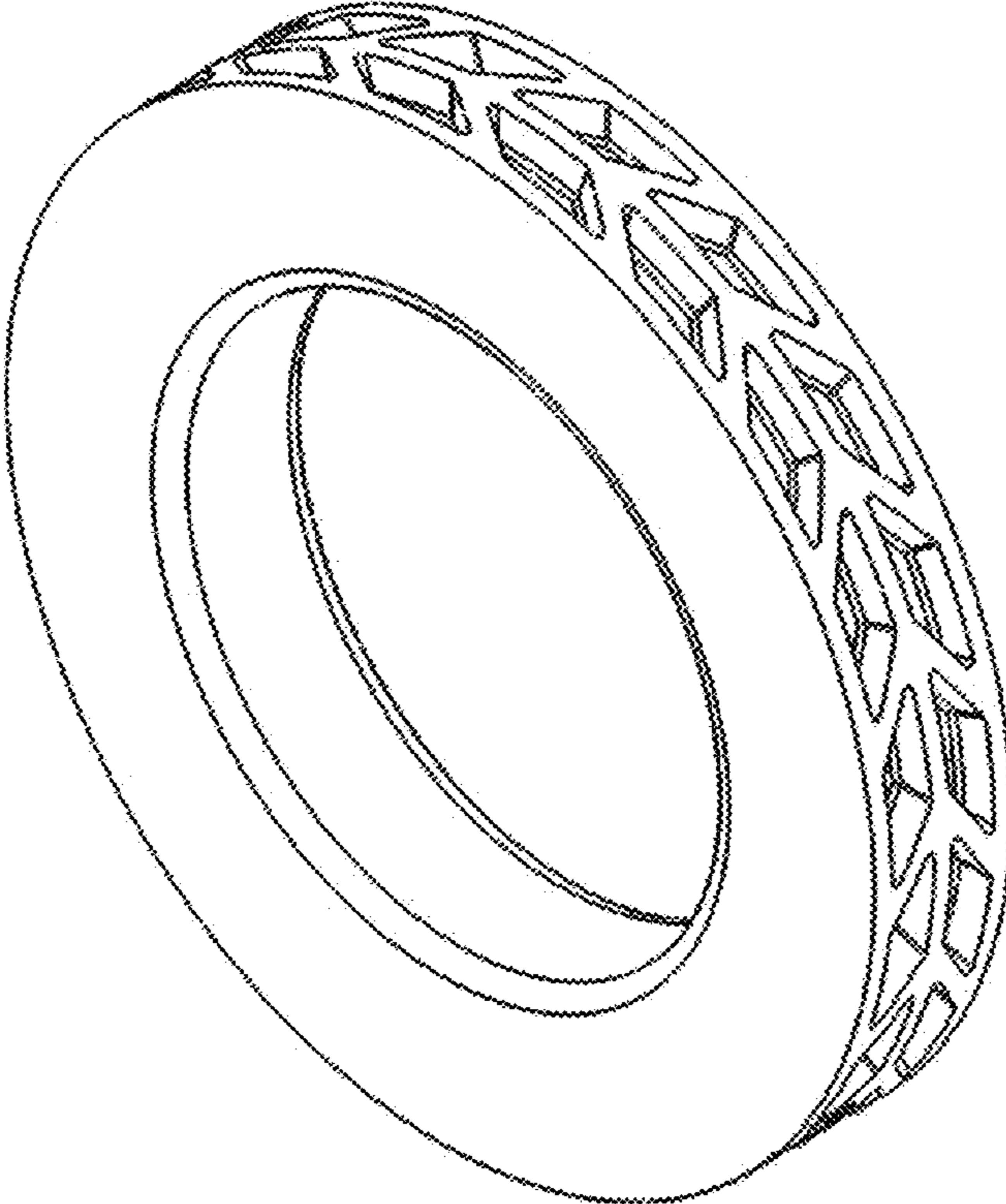

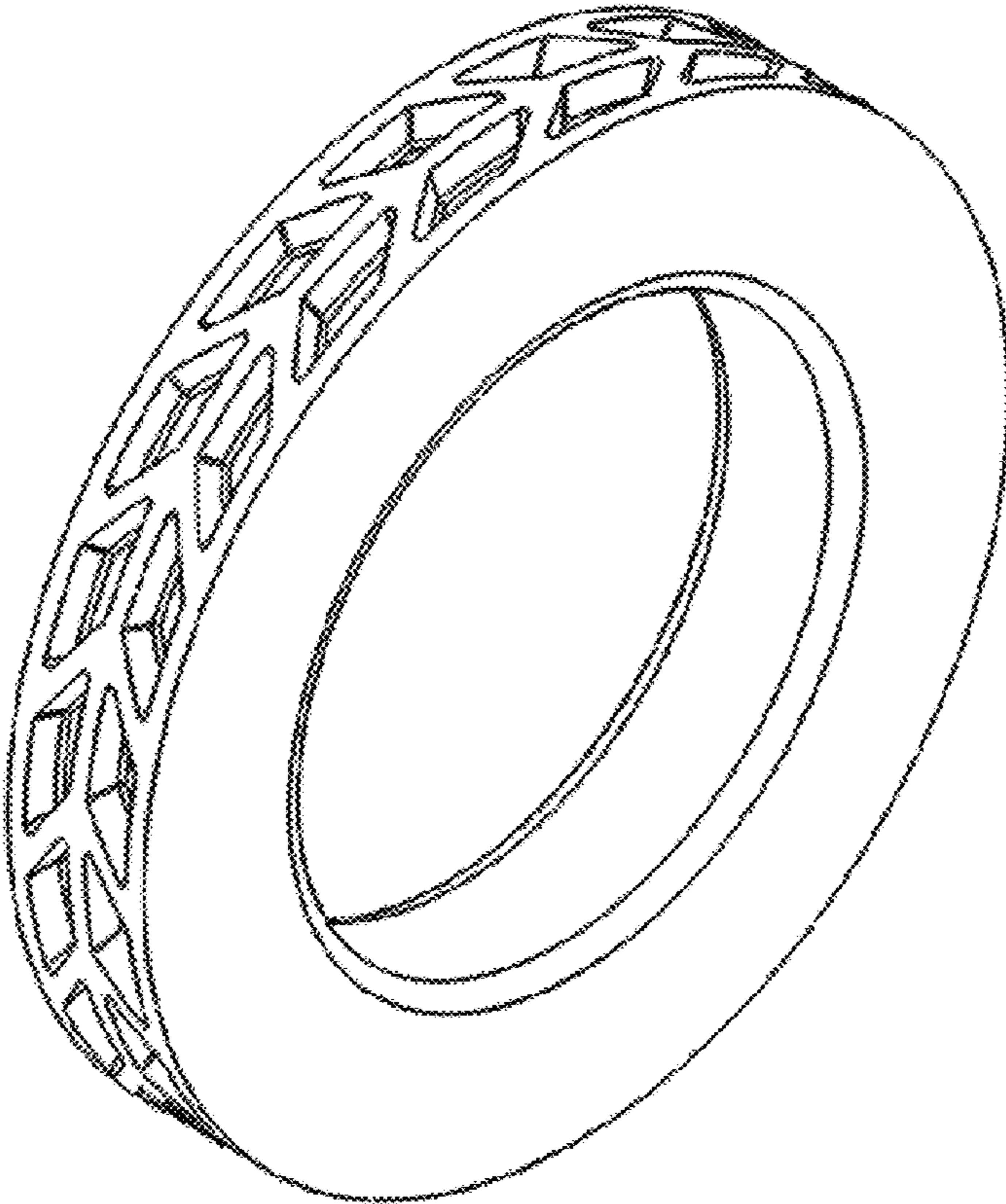

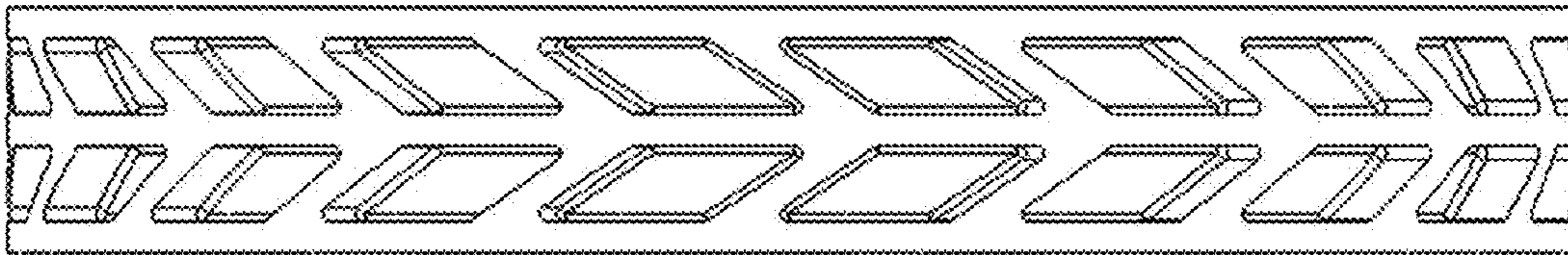
