(57) **CLAIM**

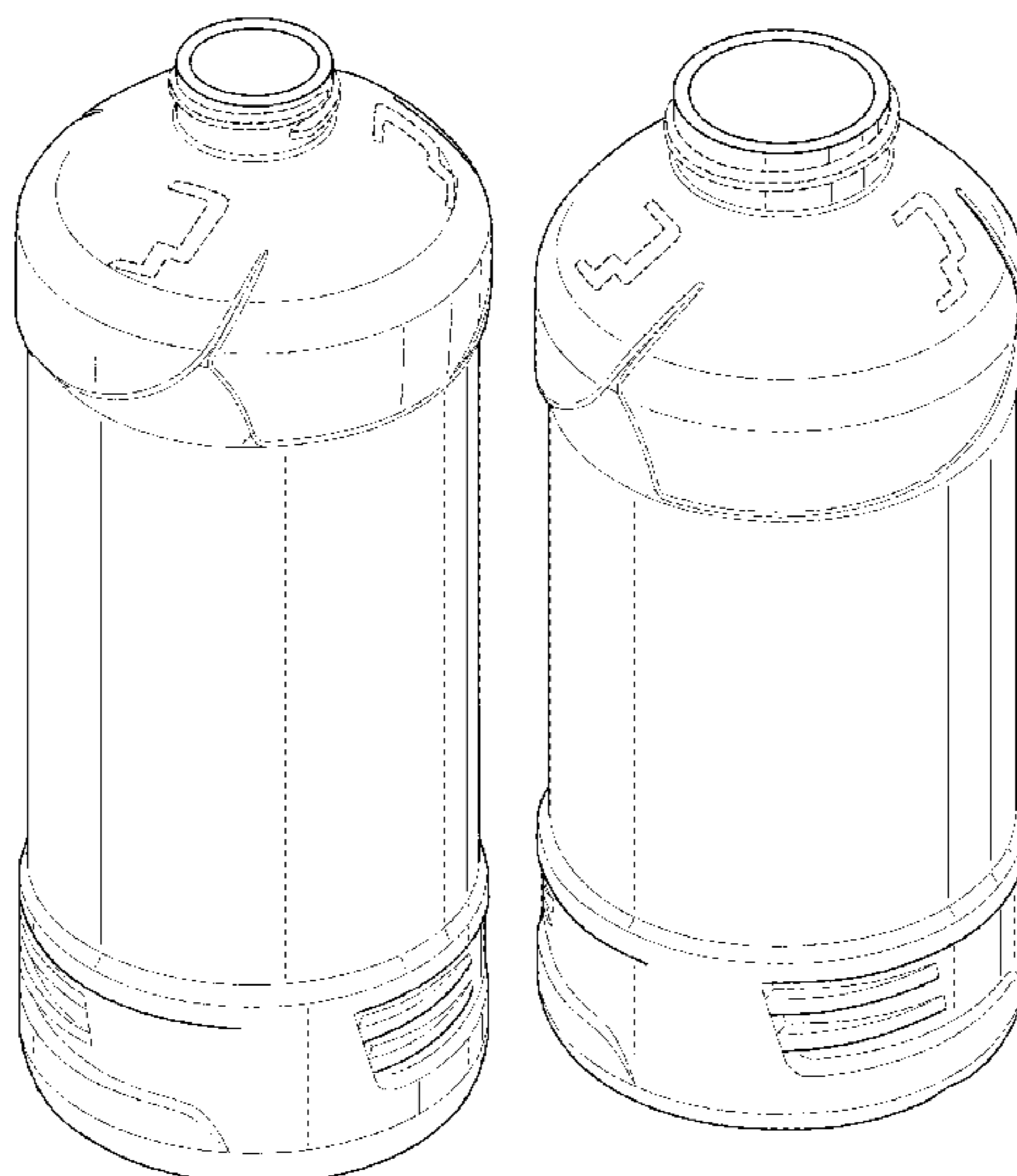
We claim, the ornamental design for a container, as shown and described.

DESCRIPTION

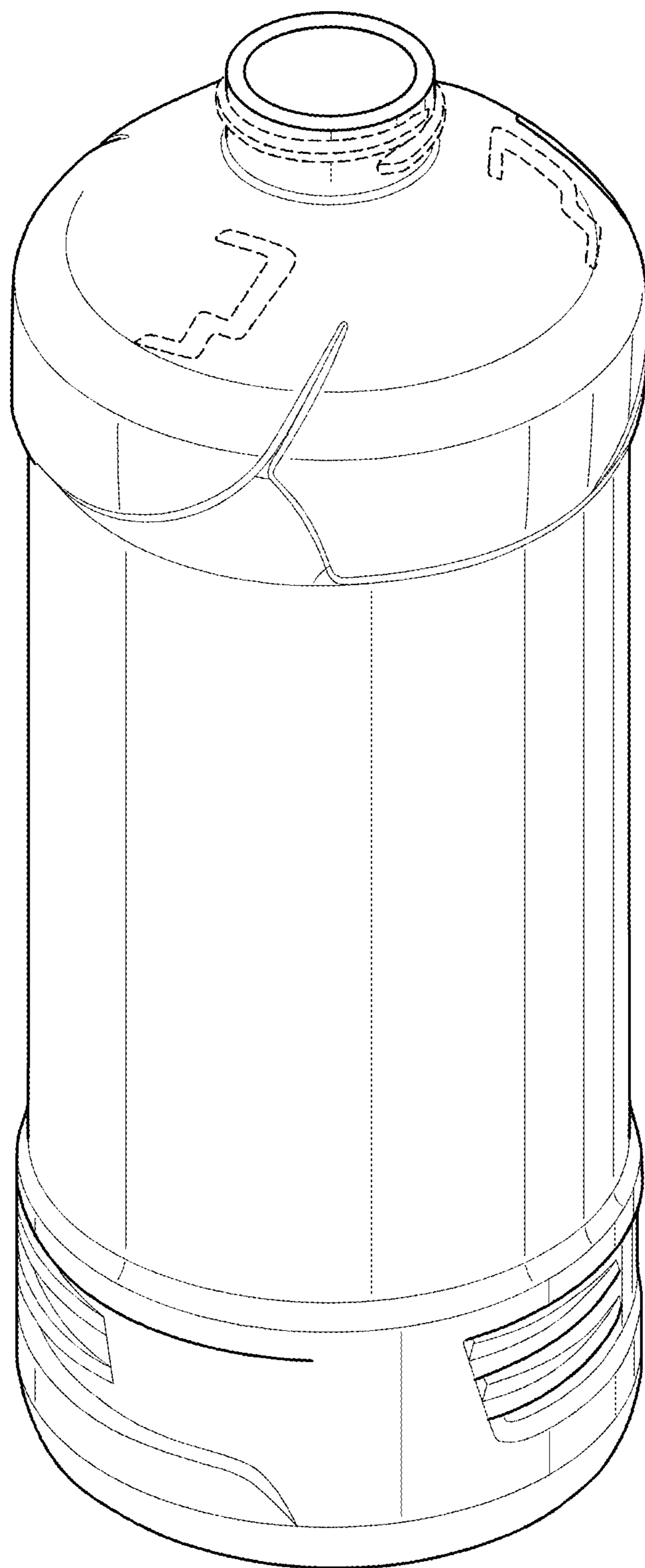

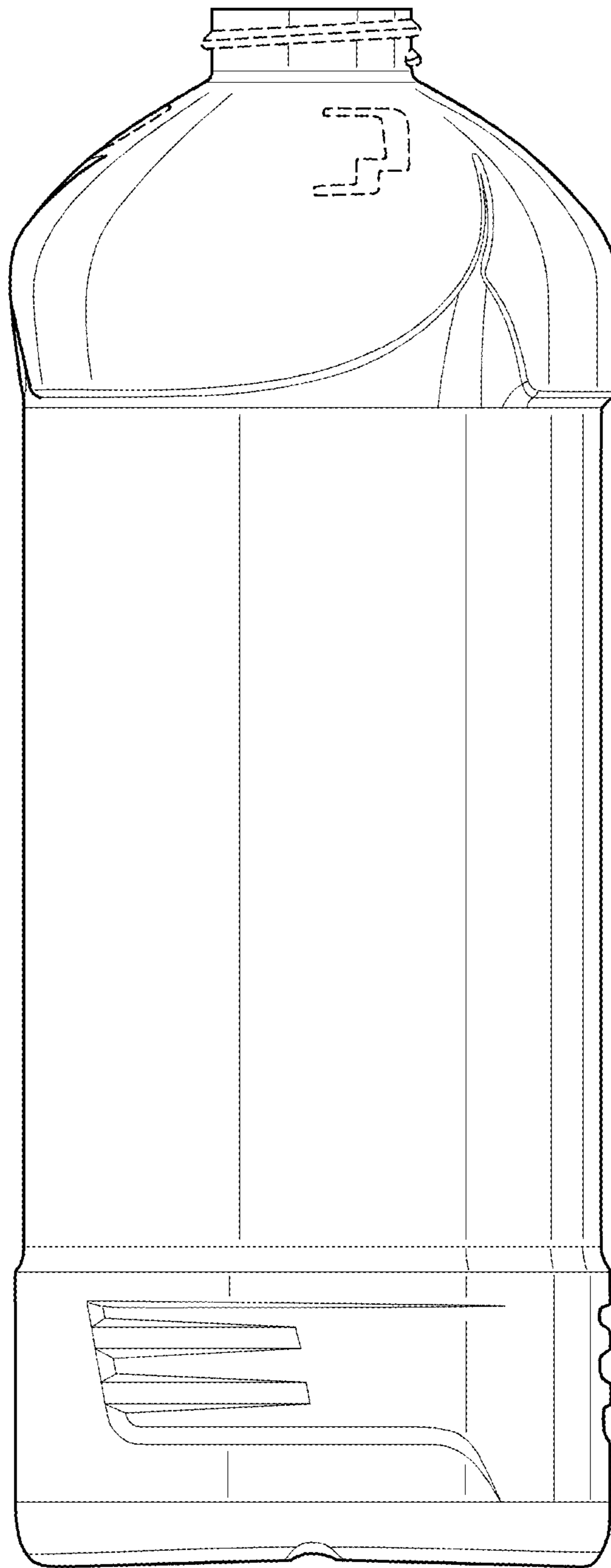

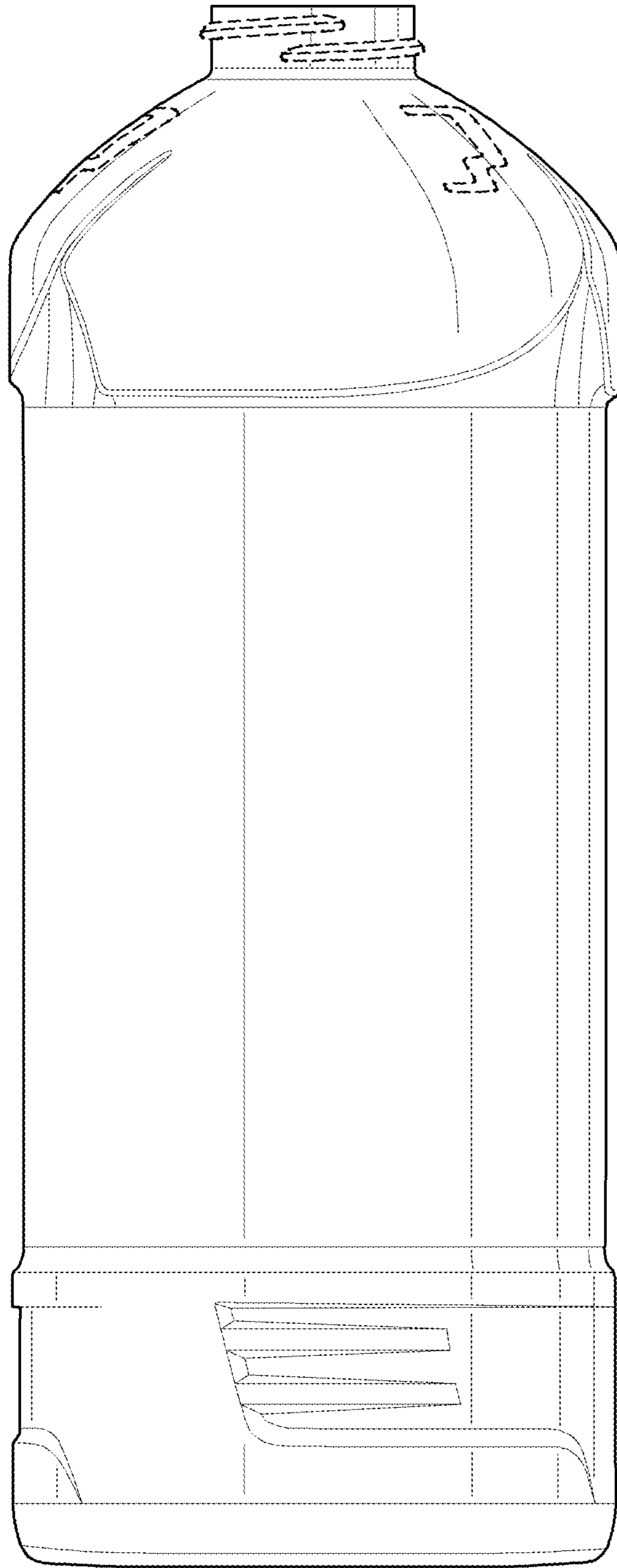

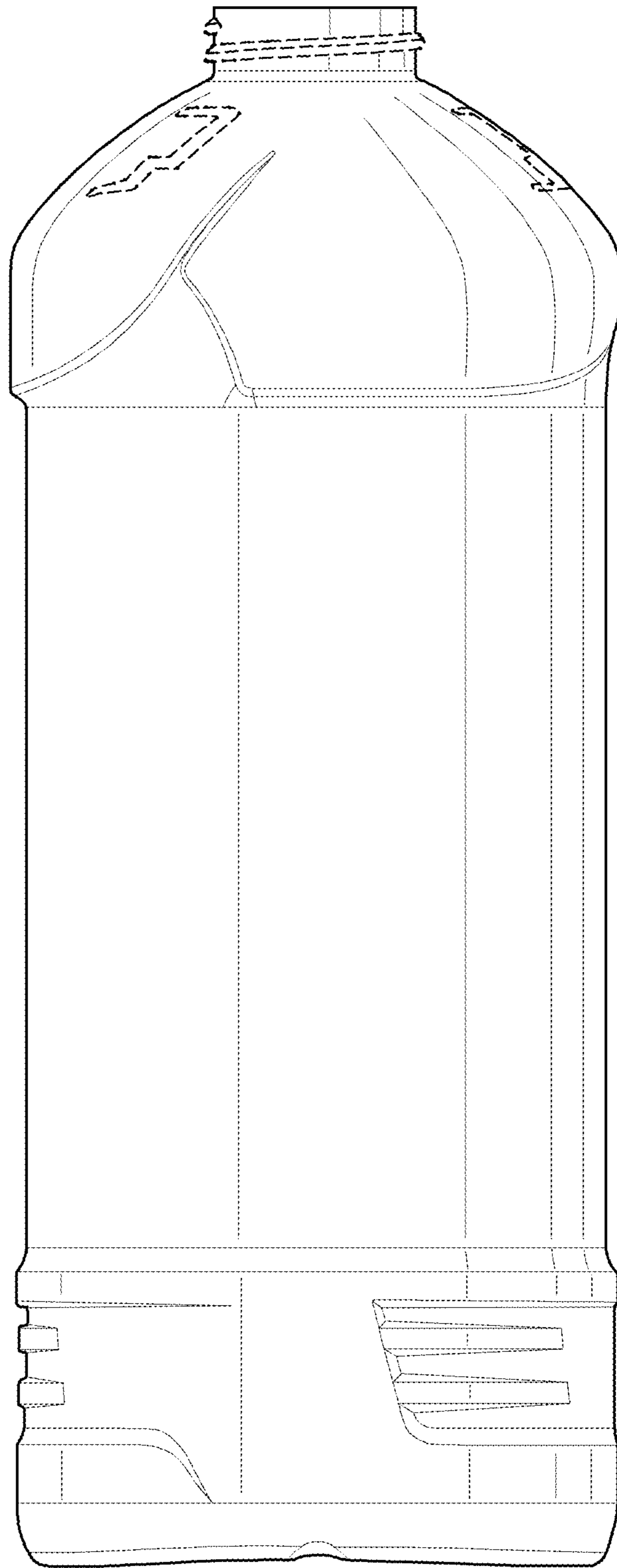

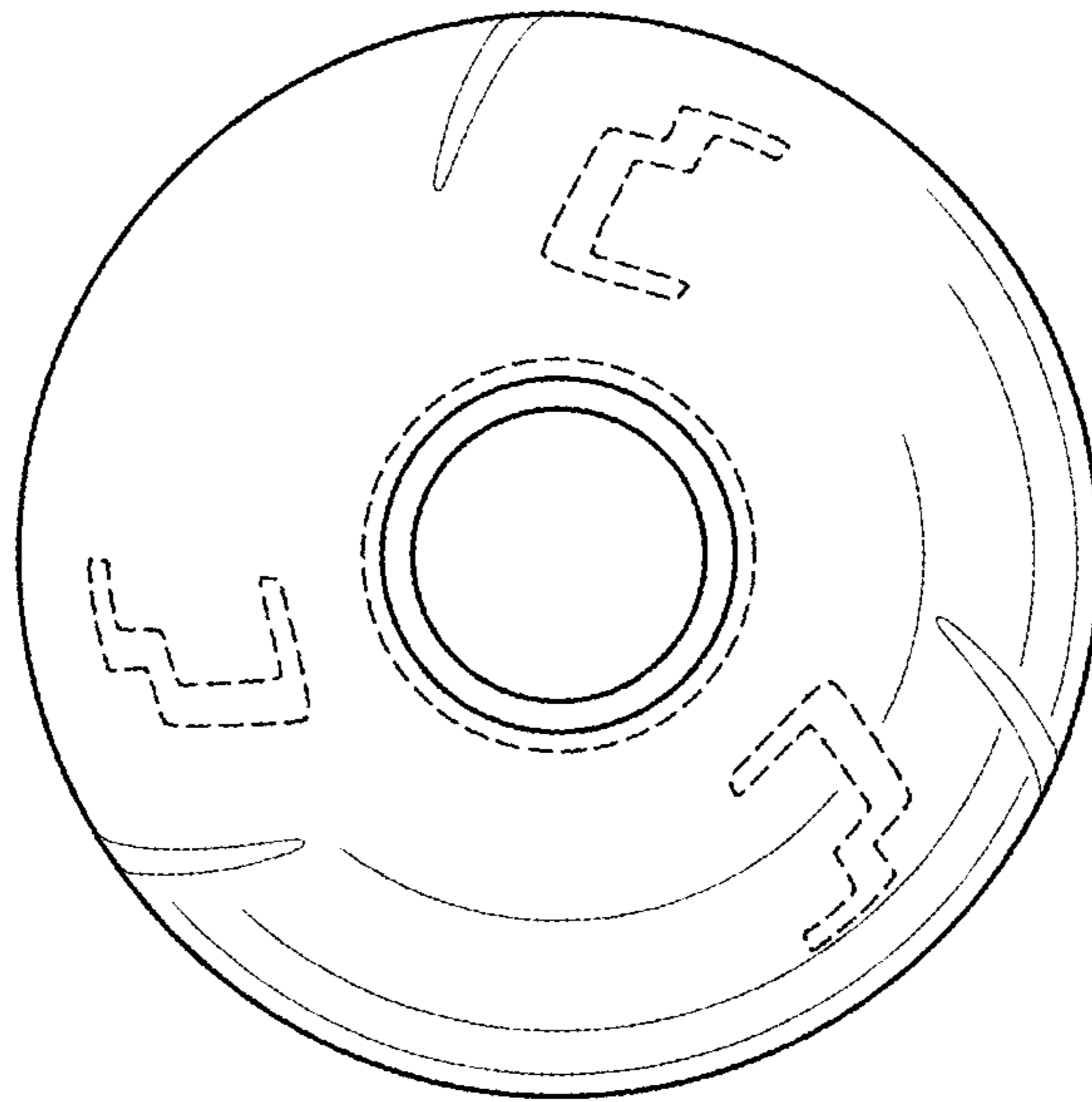

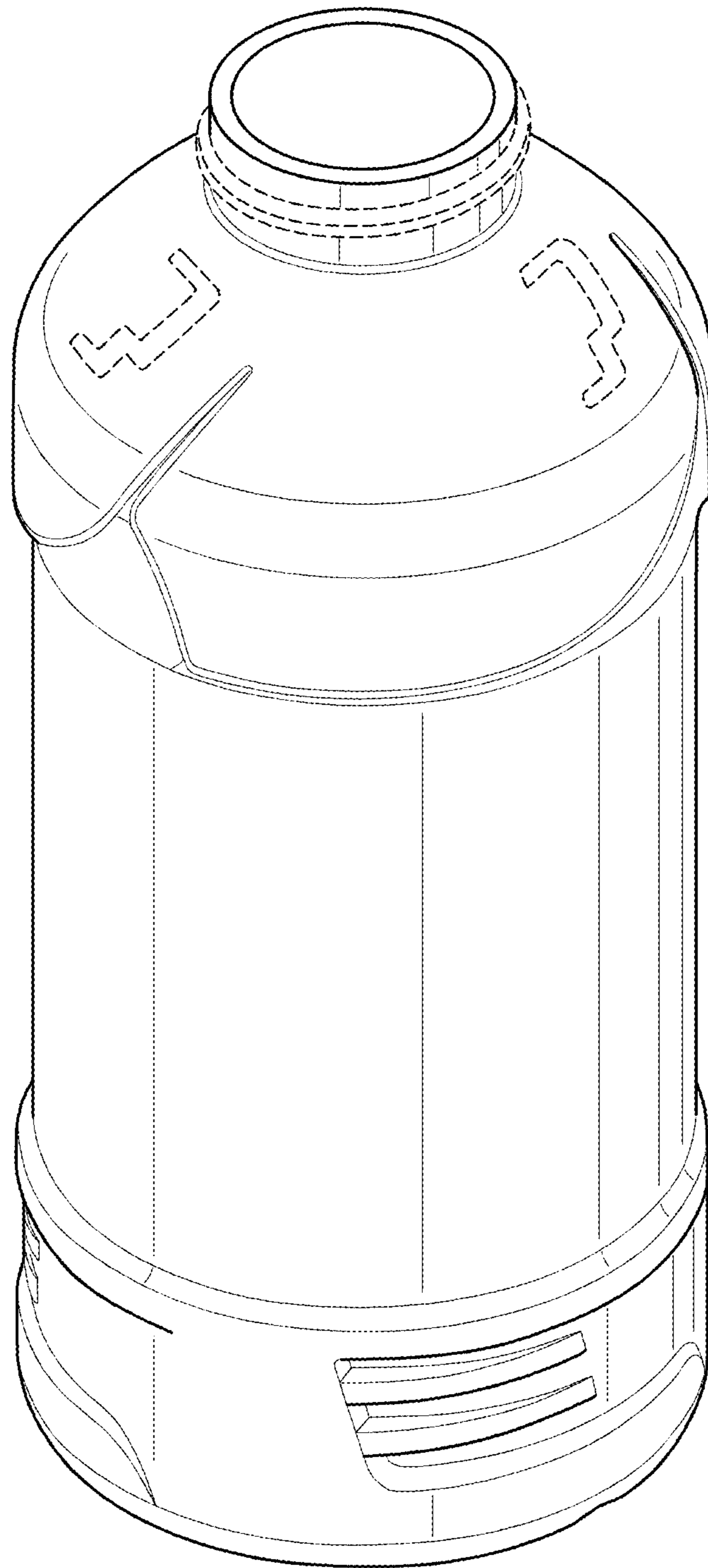

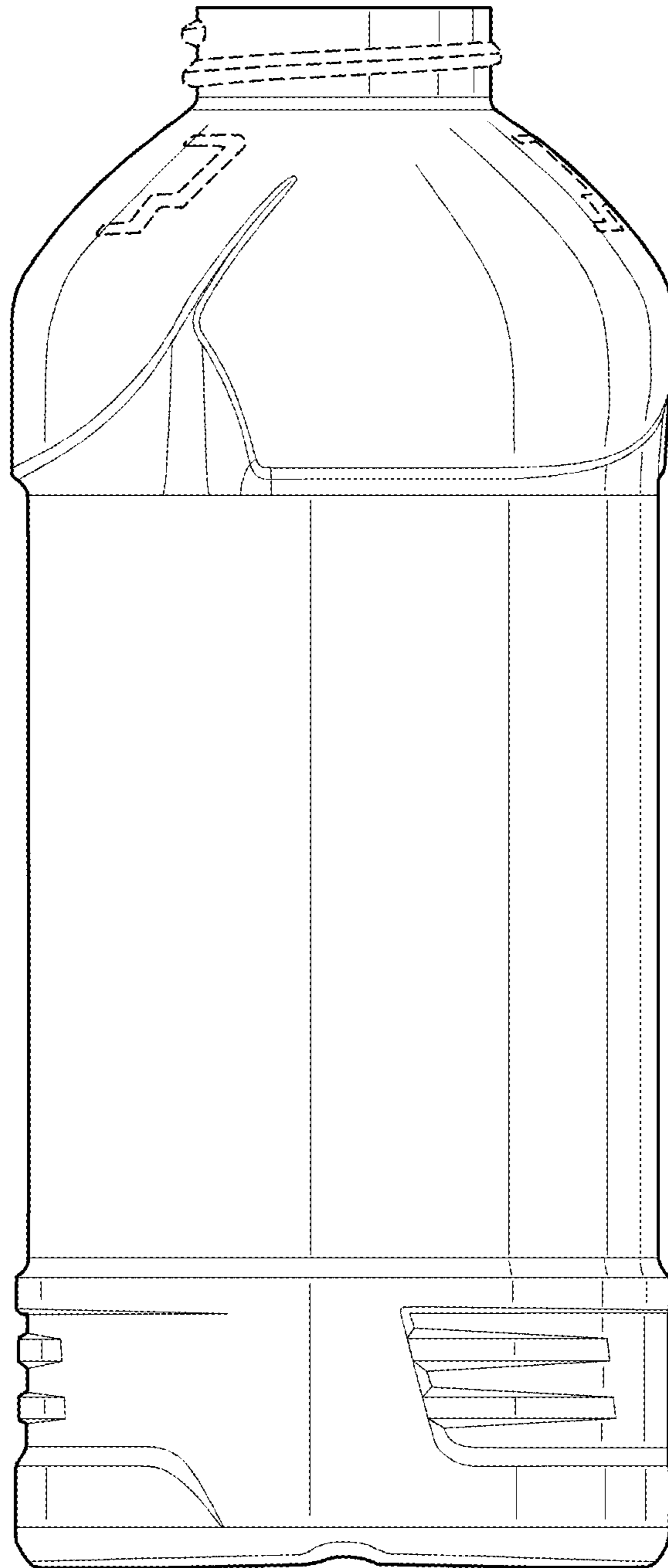

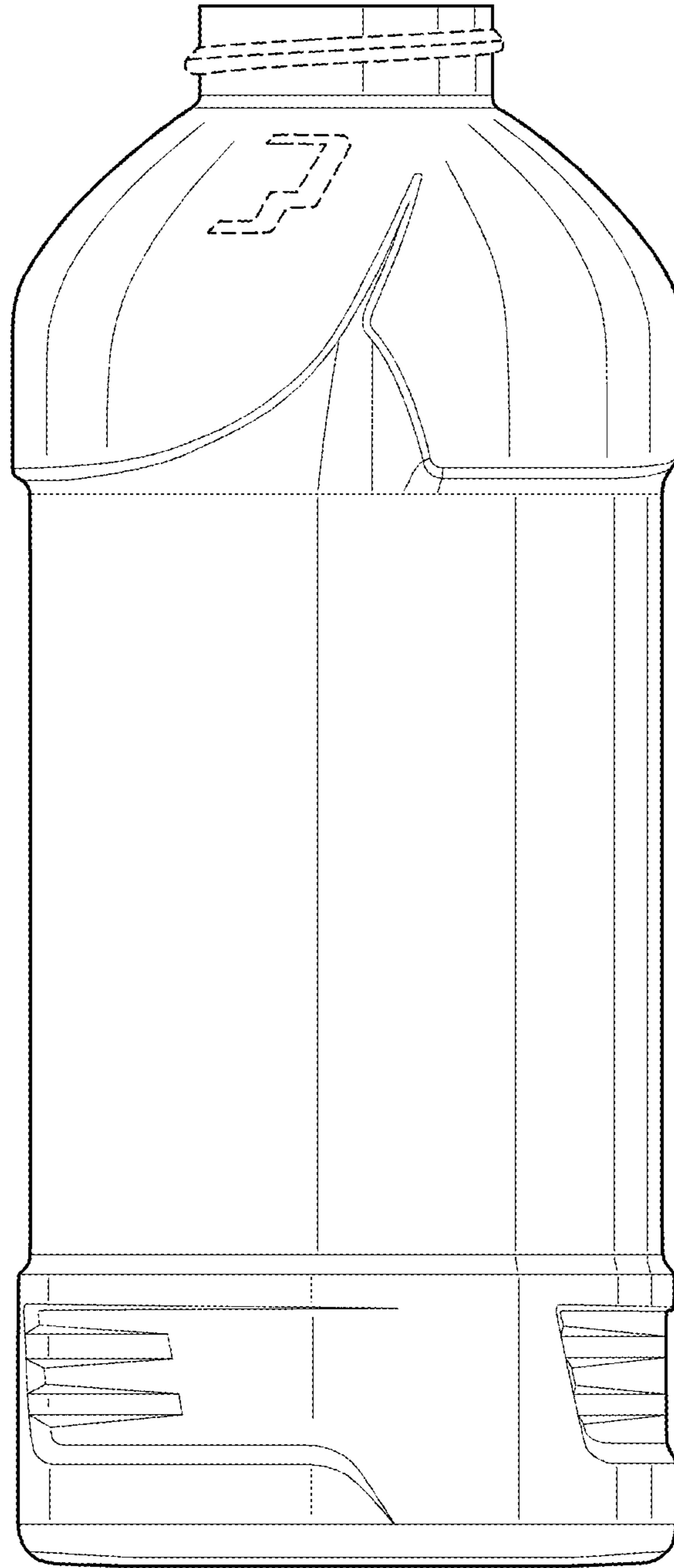

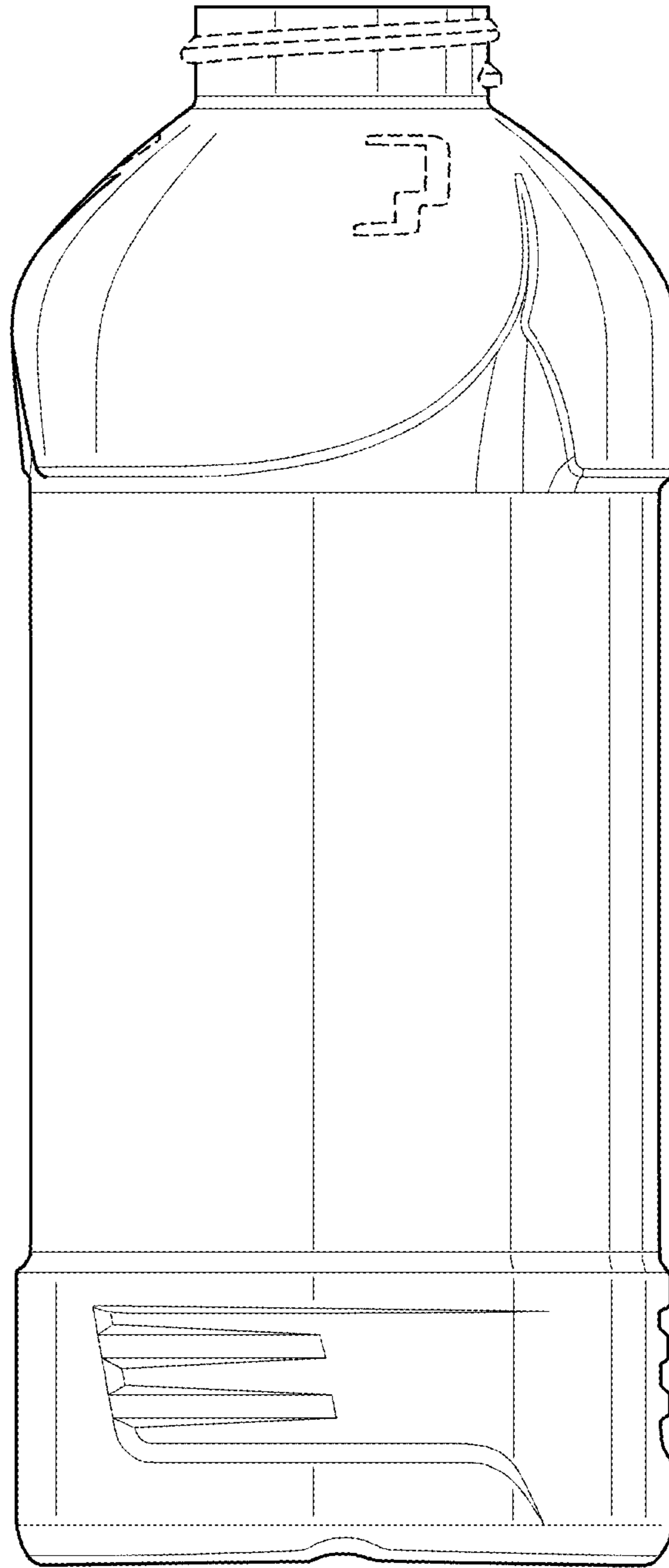

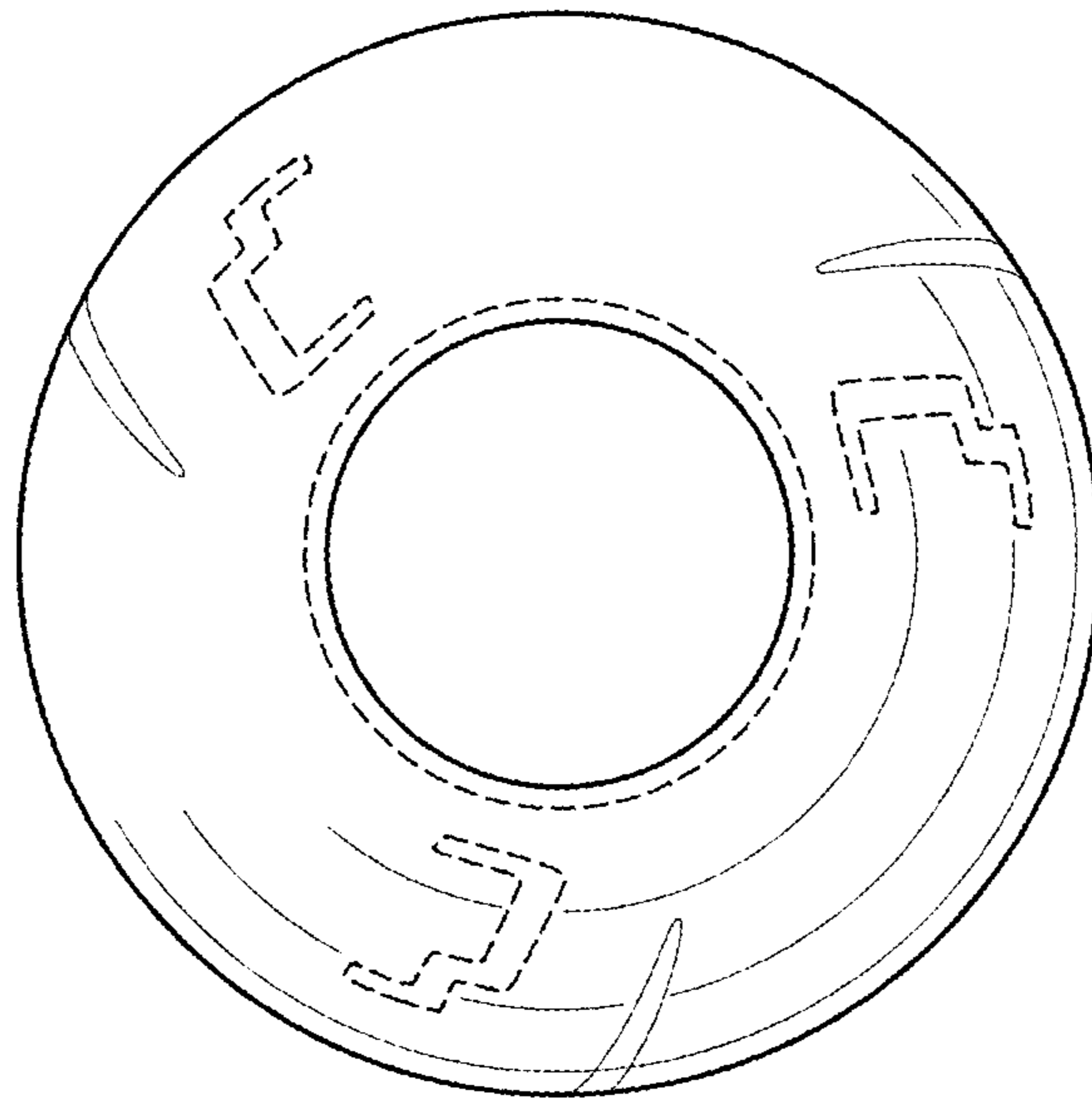
