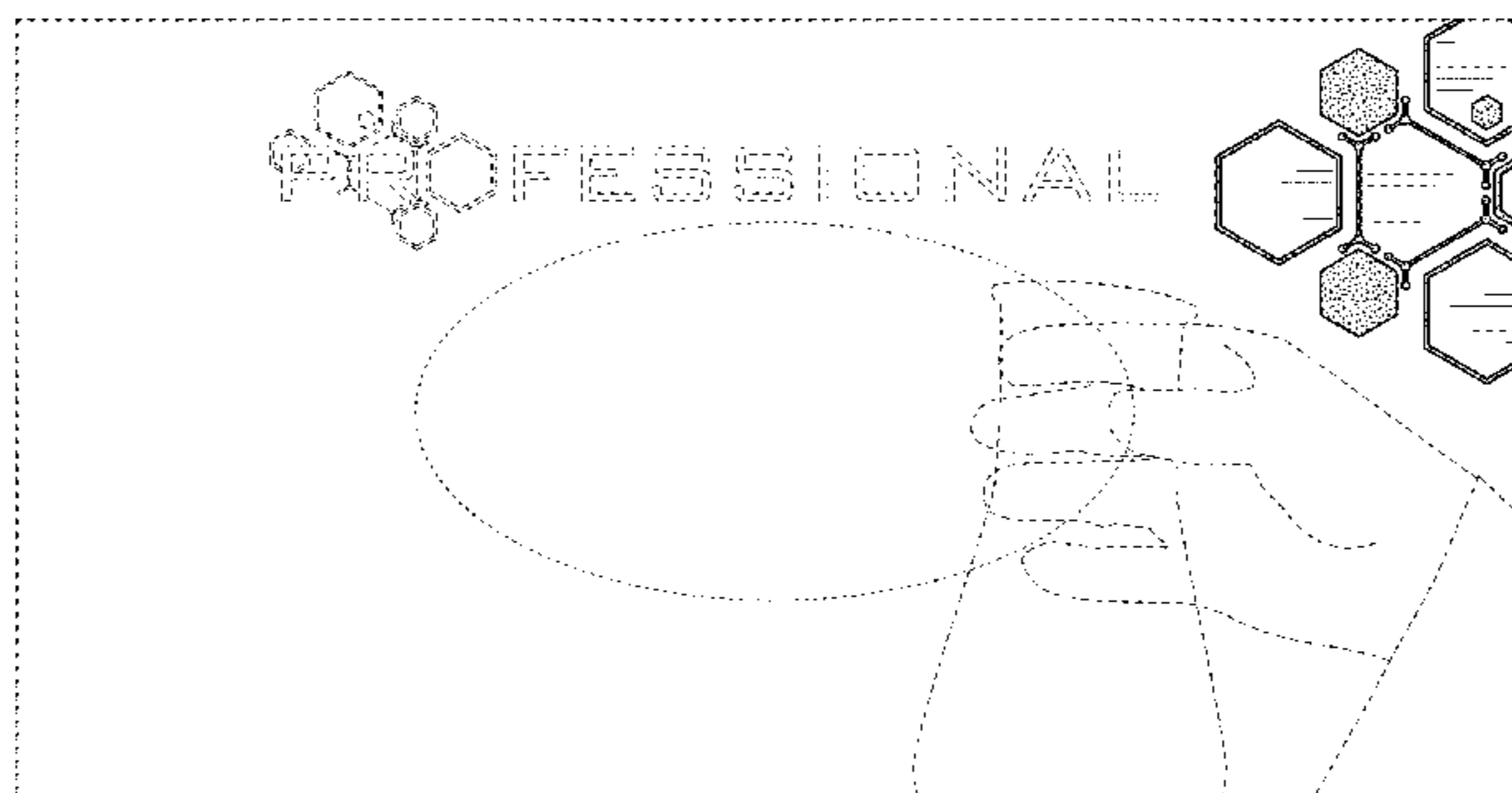
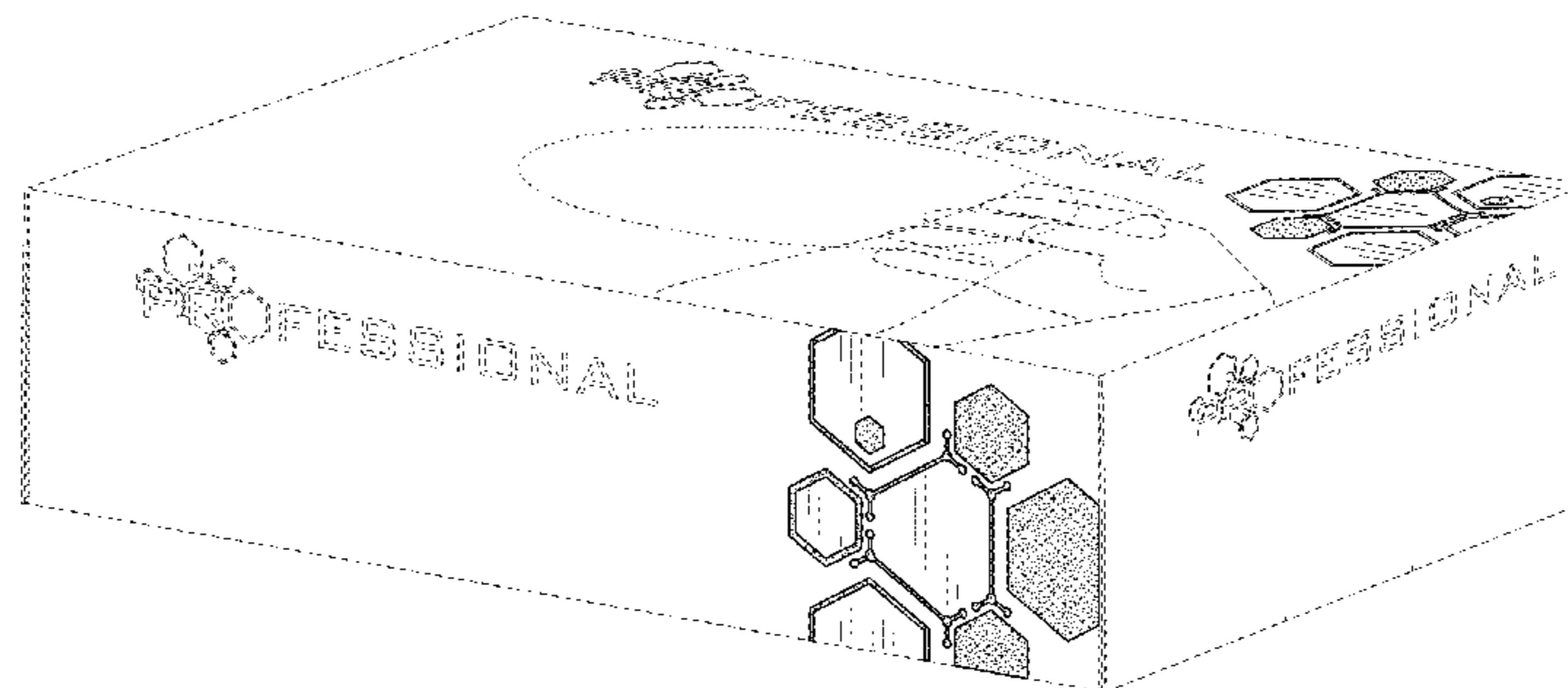
FIG. 1 is a front right perspective view of packaging for sanitation gloves showing our design;

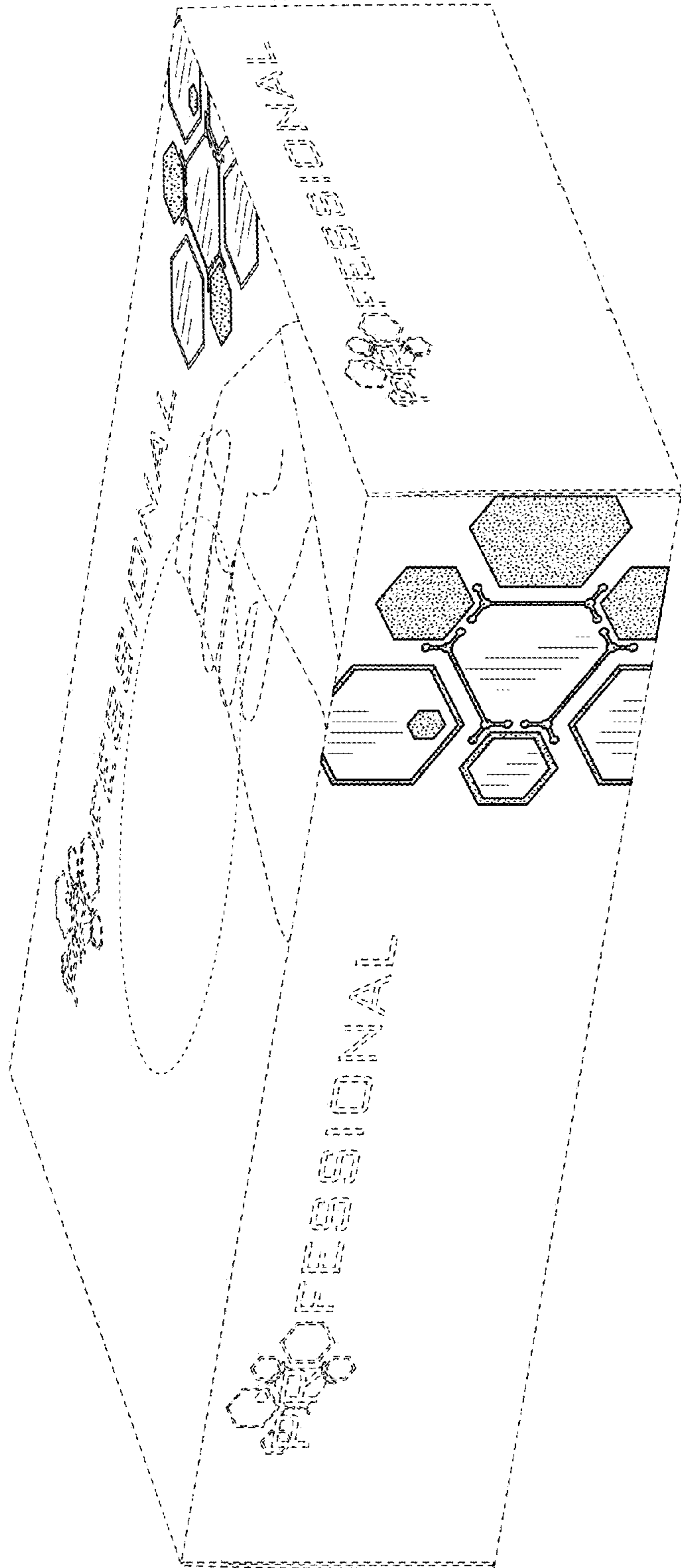

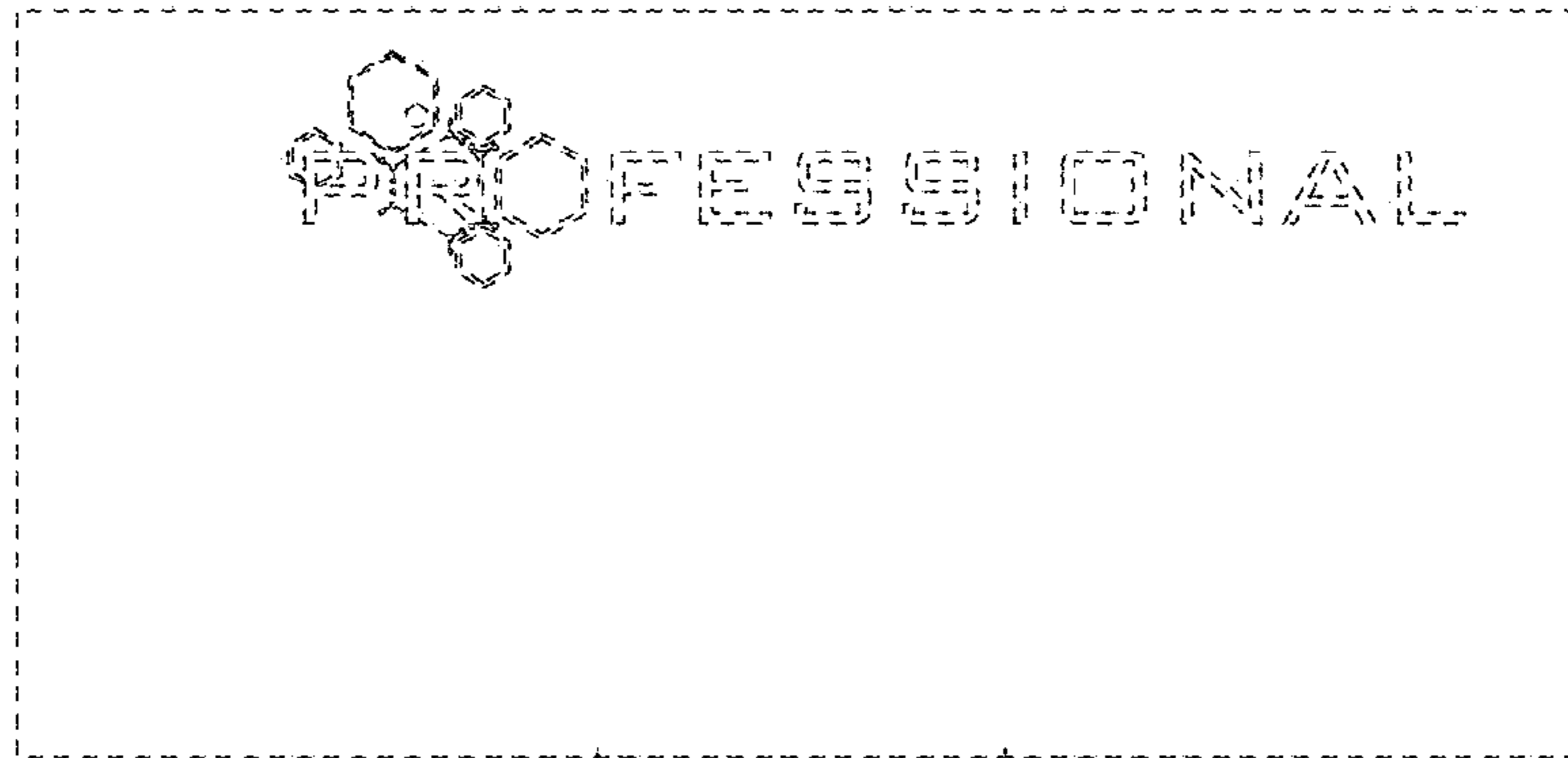

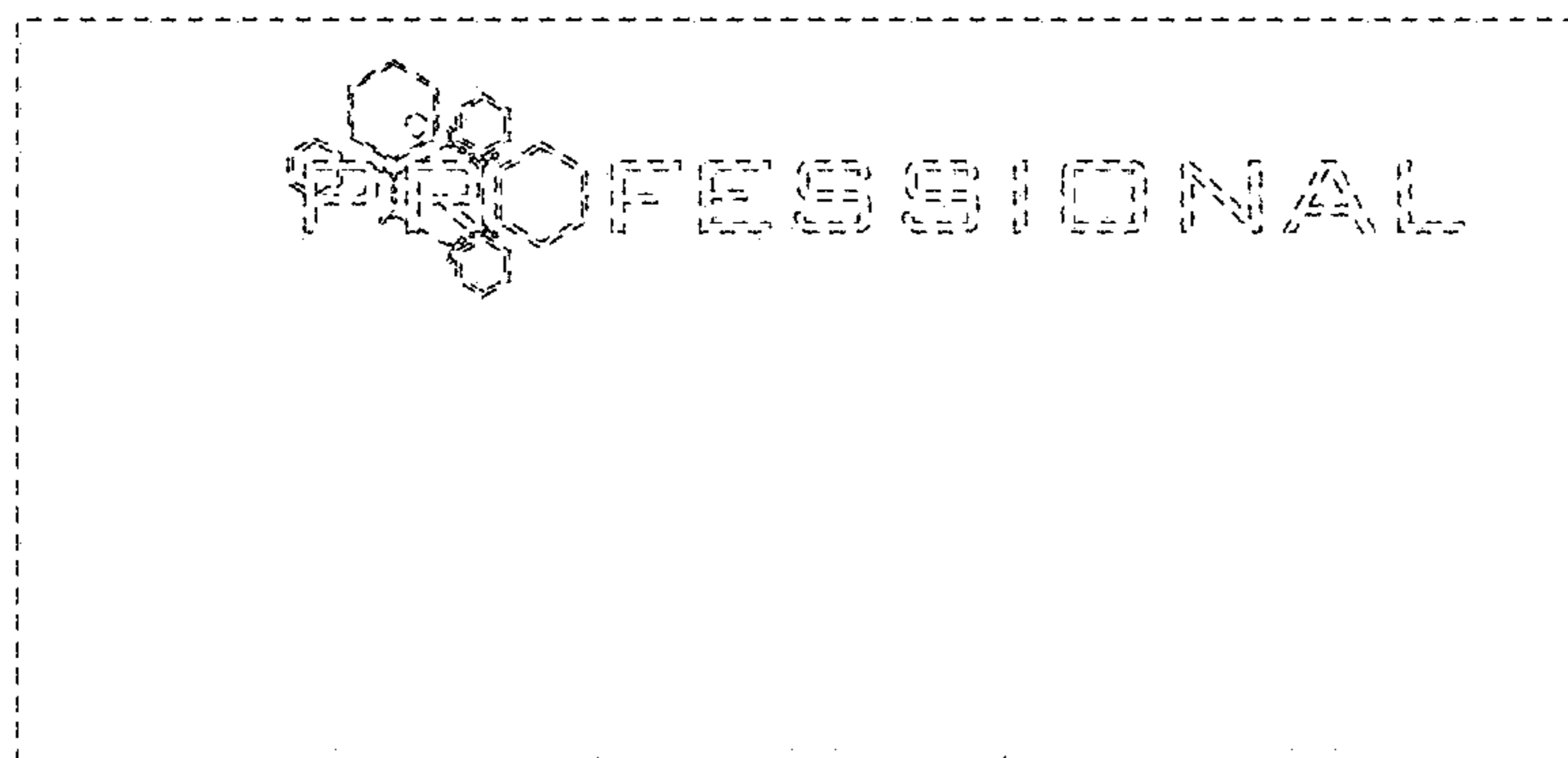

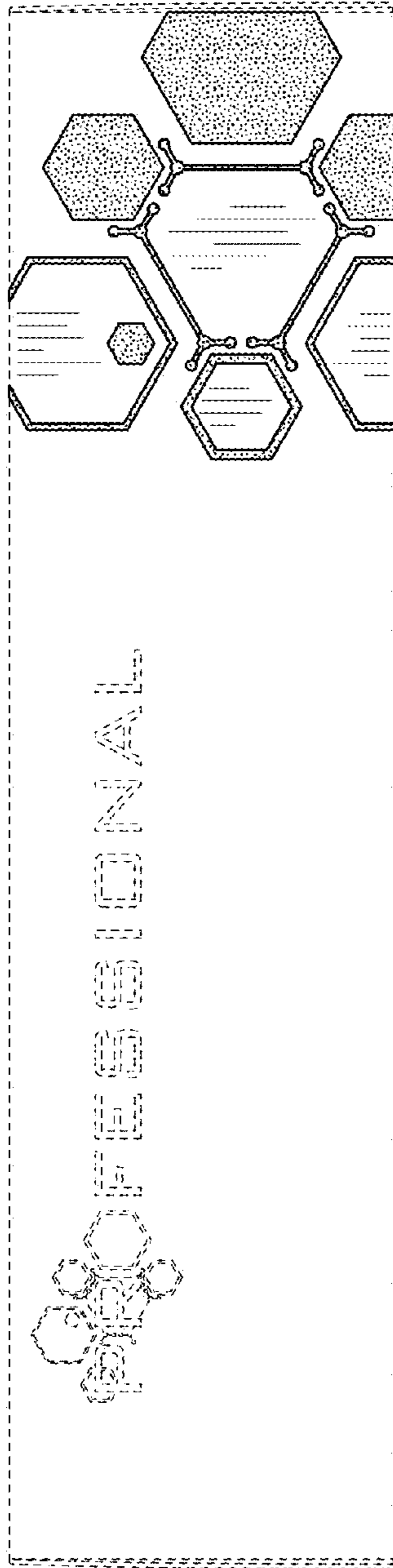

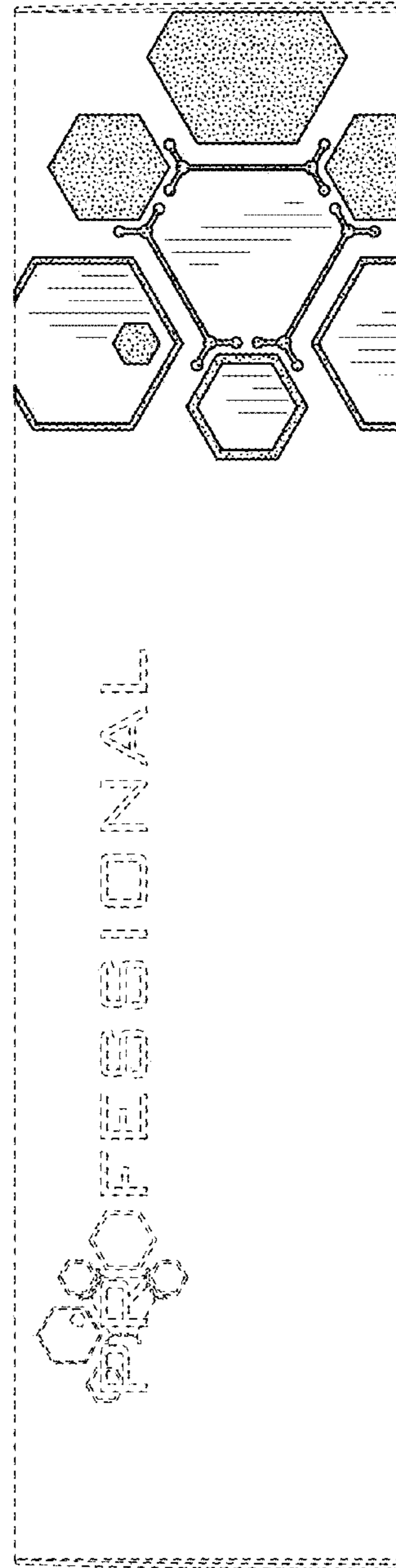

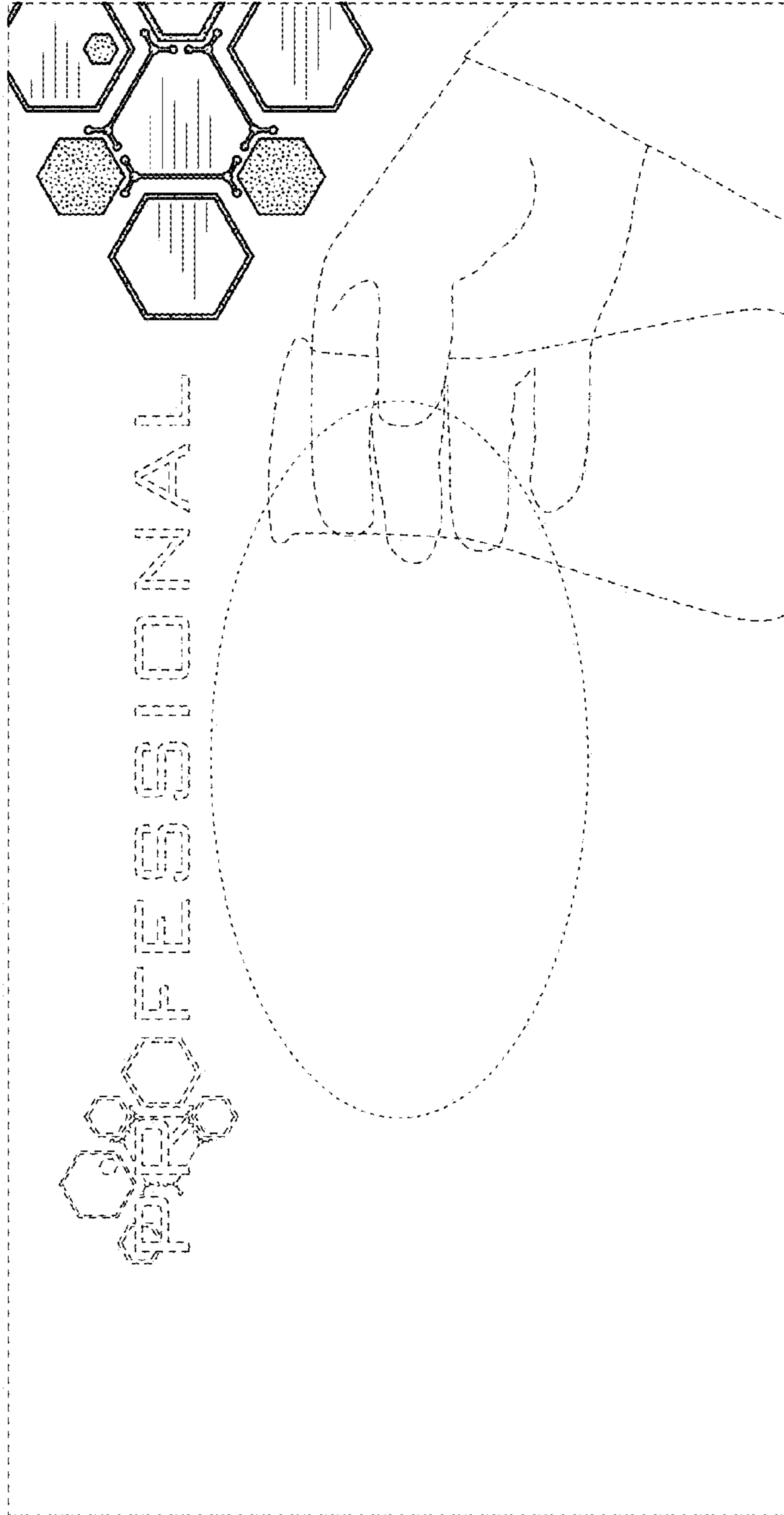
