The ornamental design for a watch dial, as shown and described.

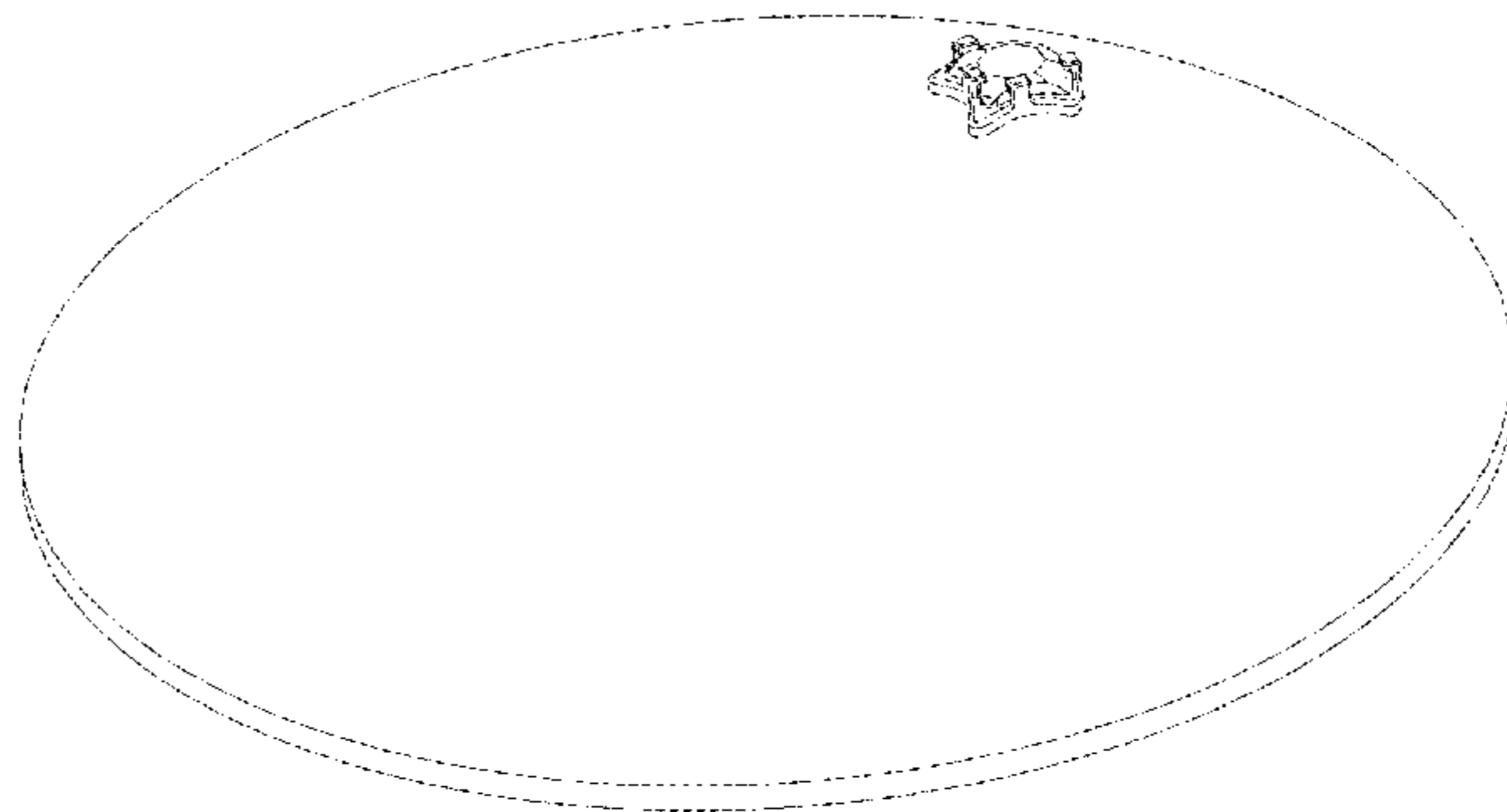
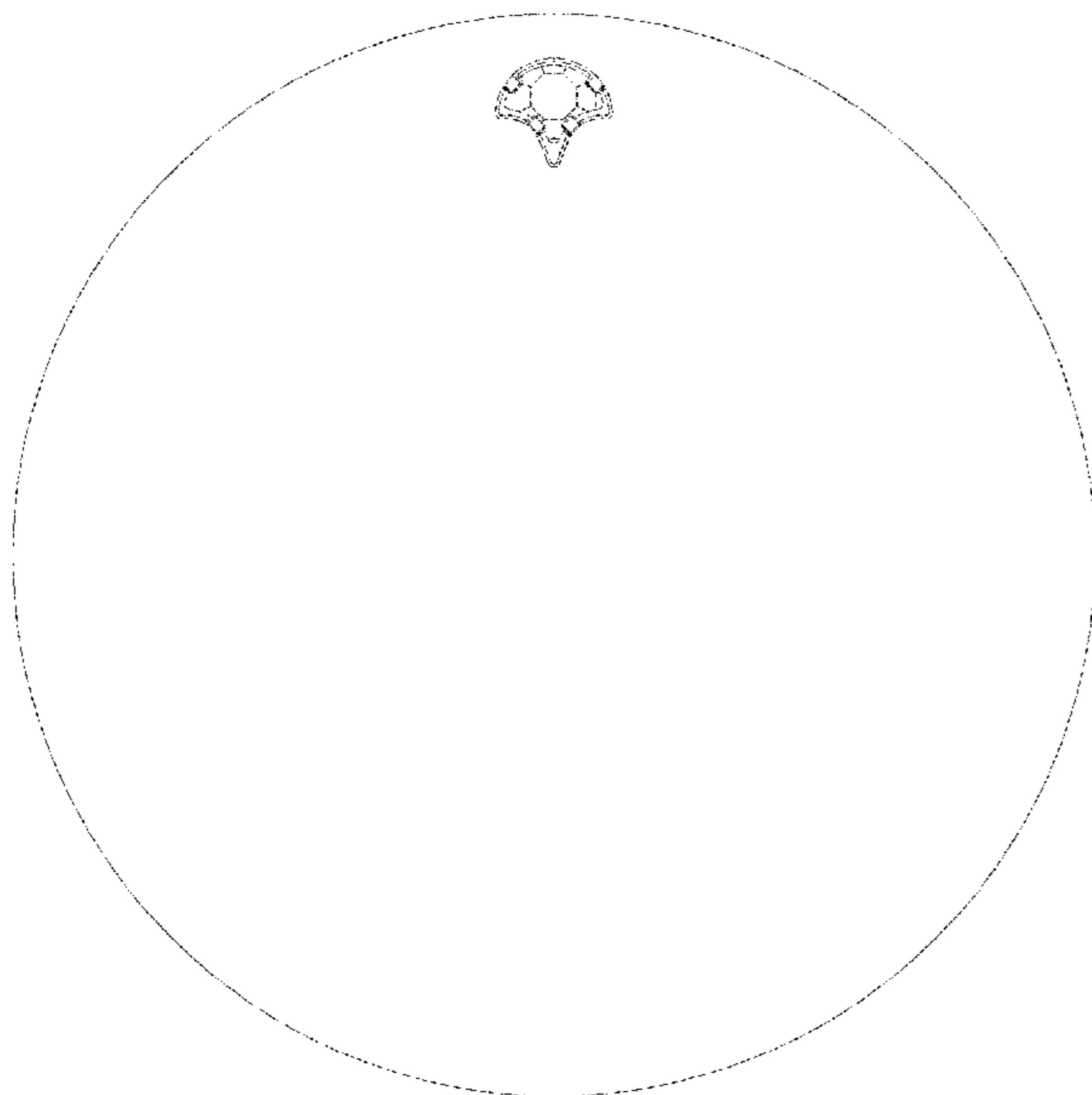
**DESCRIPTION**

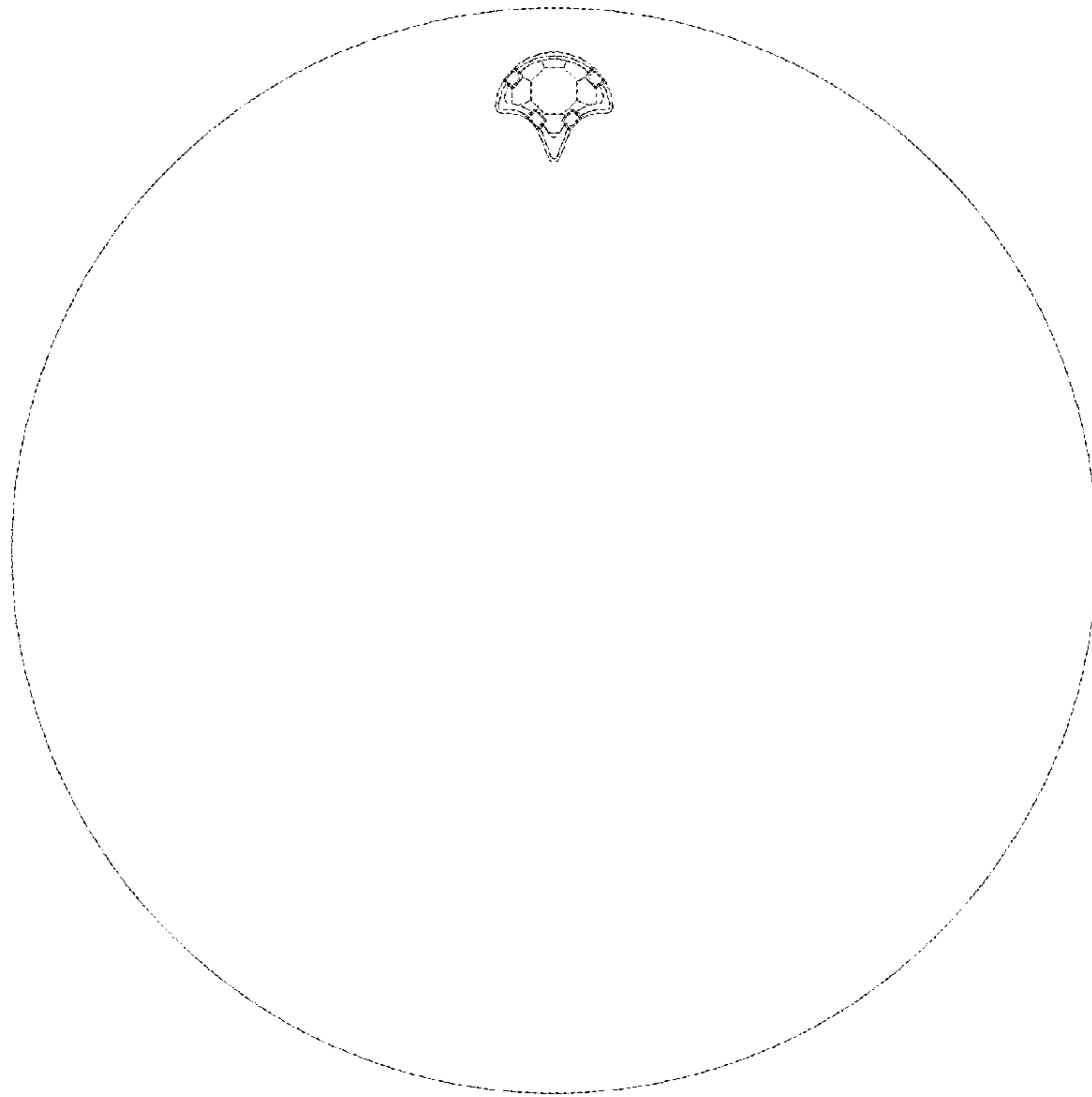

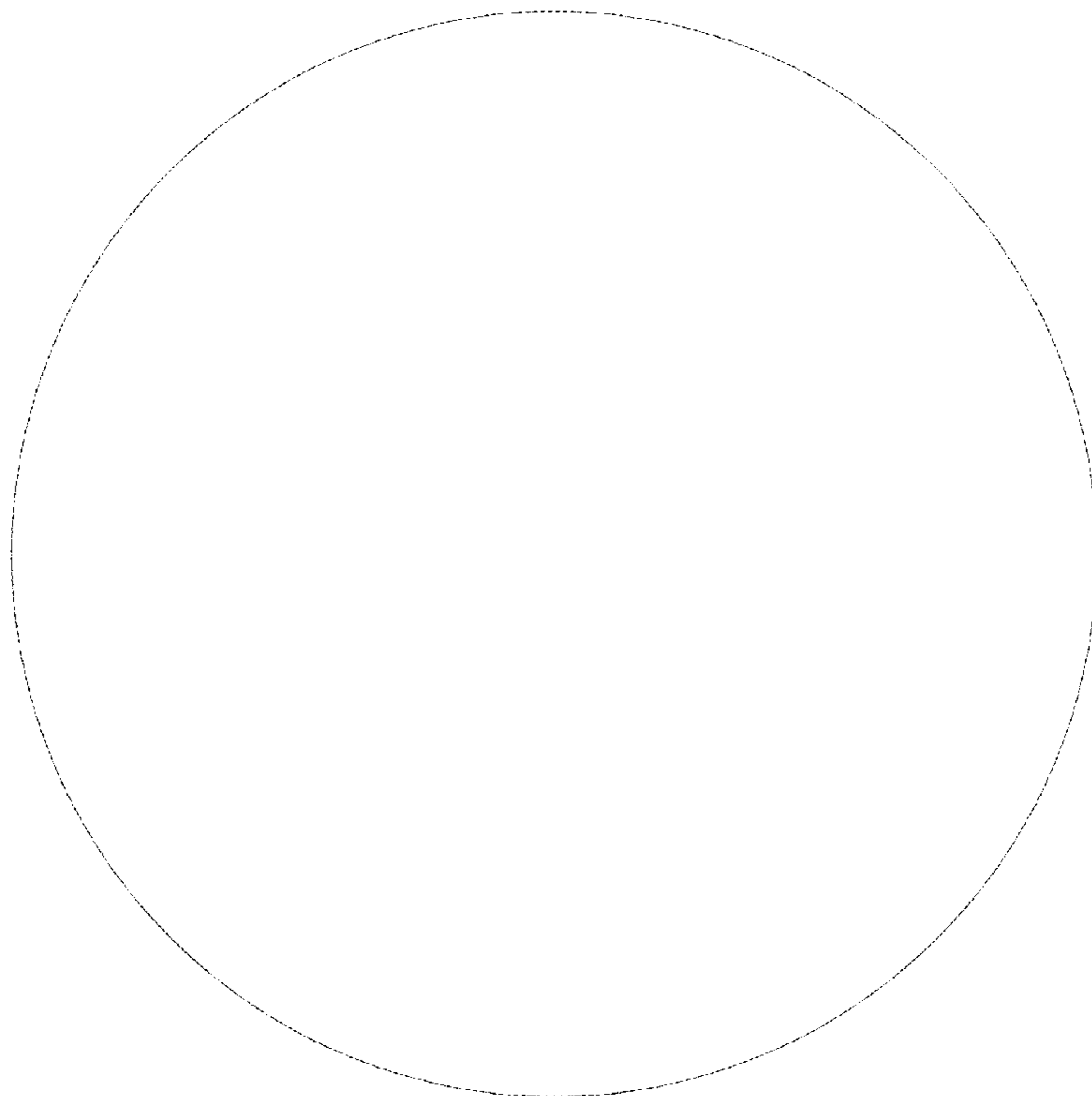

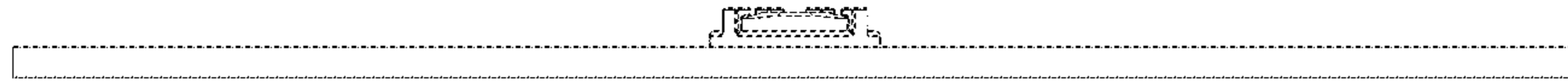

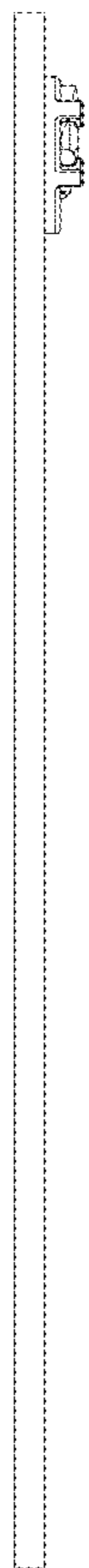

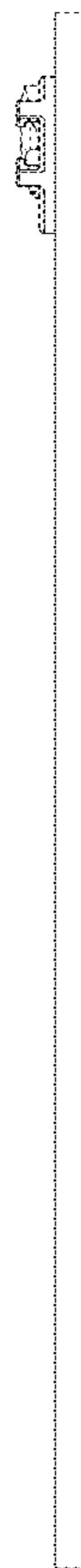

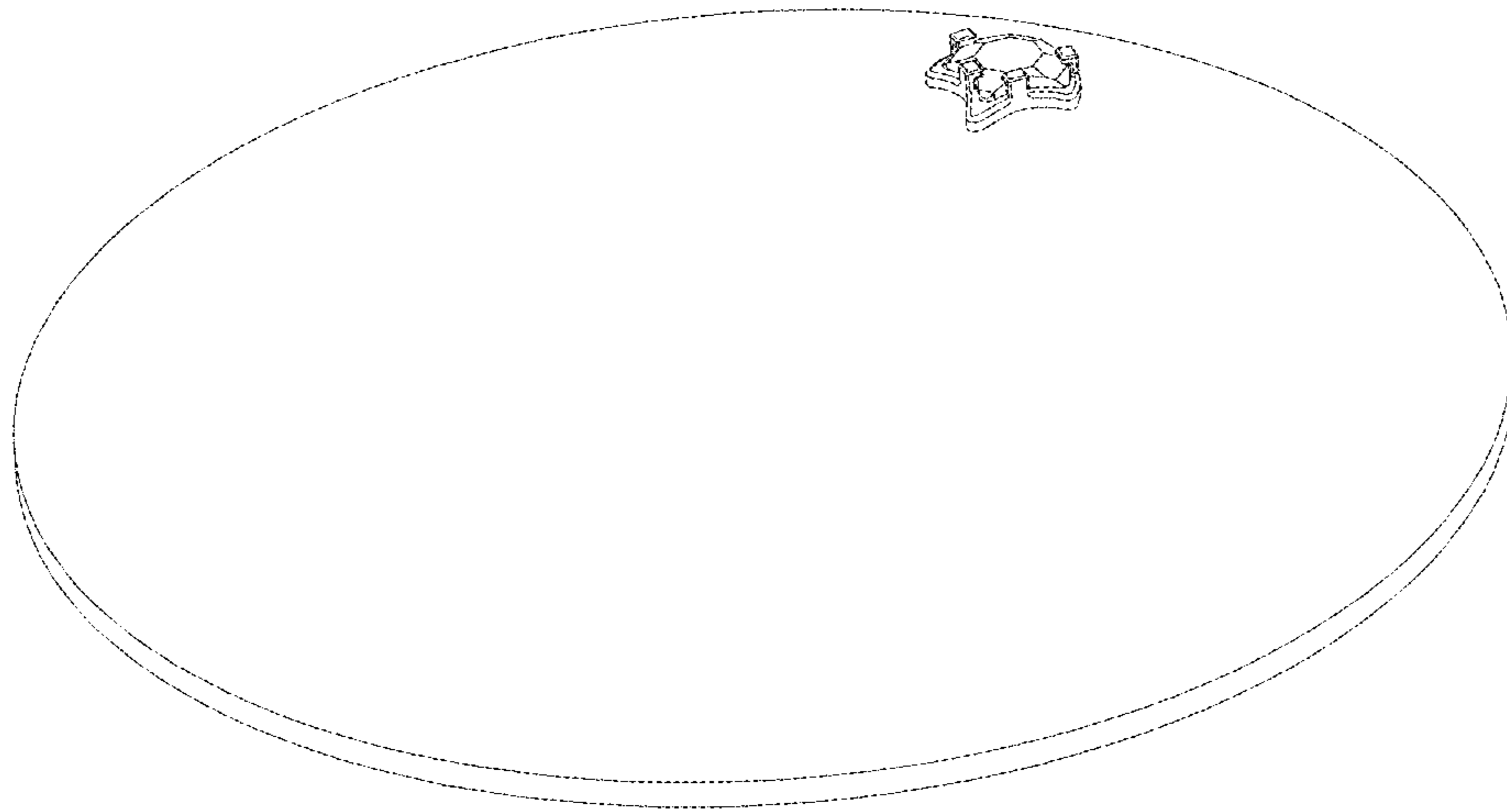
