(57) **CLAIM**

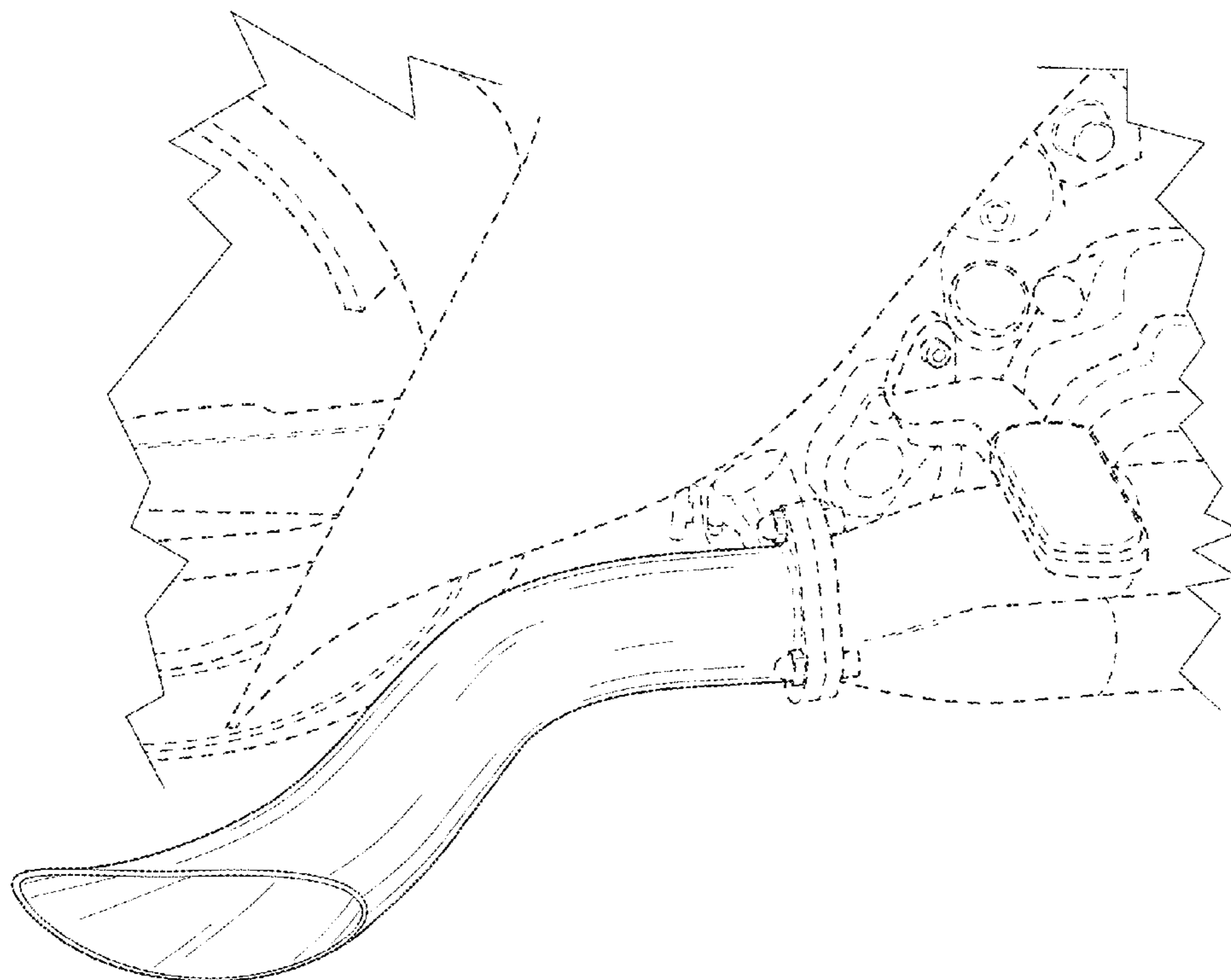
The ornamental design for an engine exhaust tip, as shown and described.

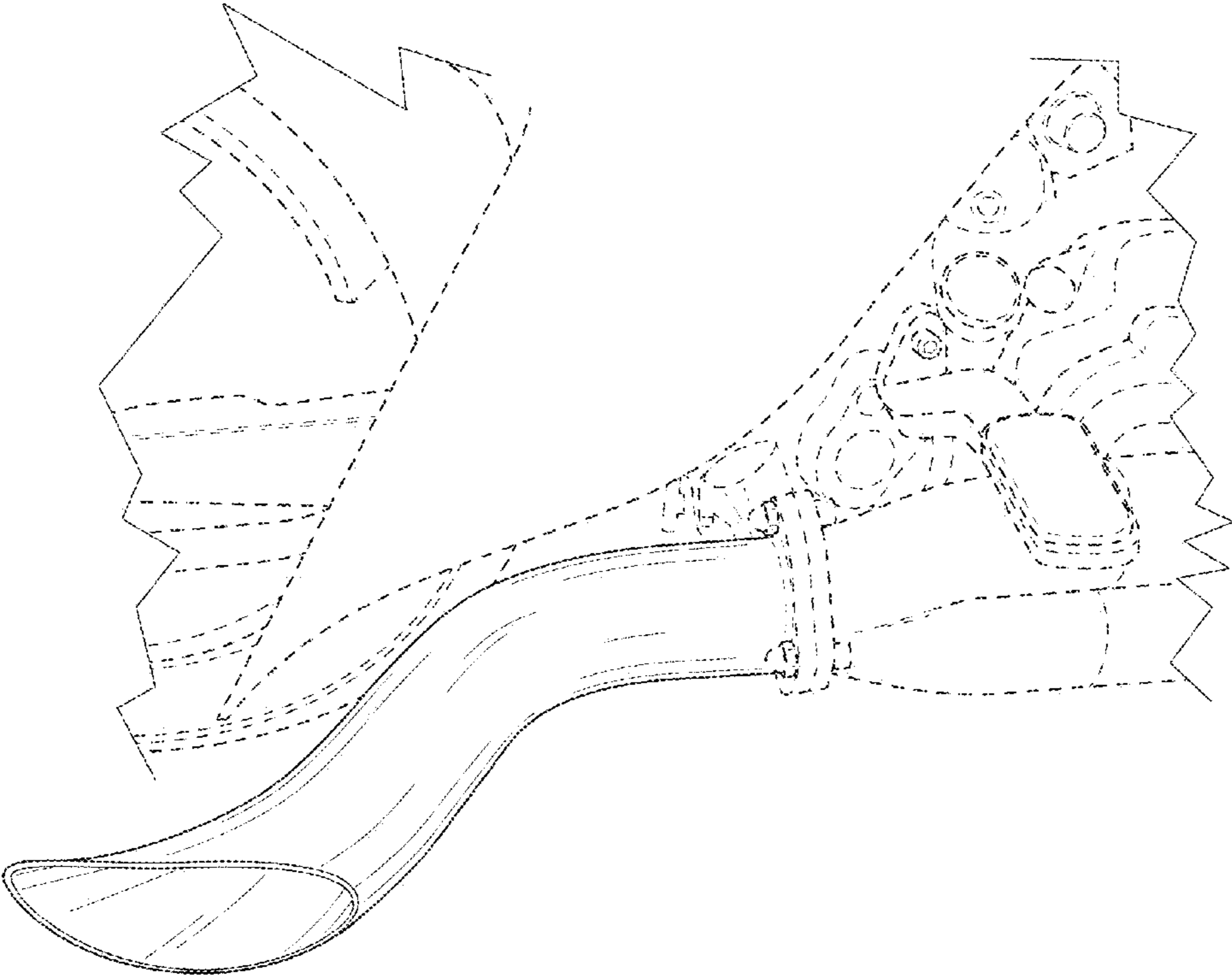

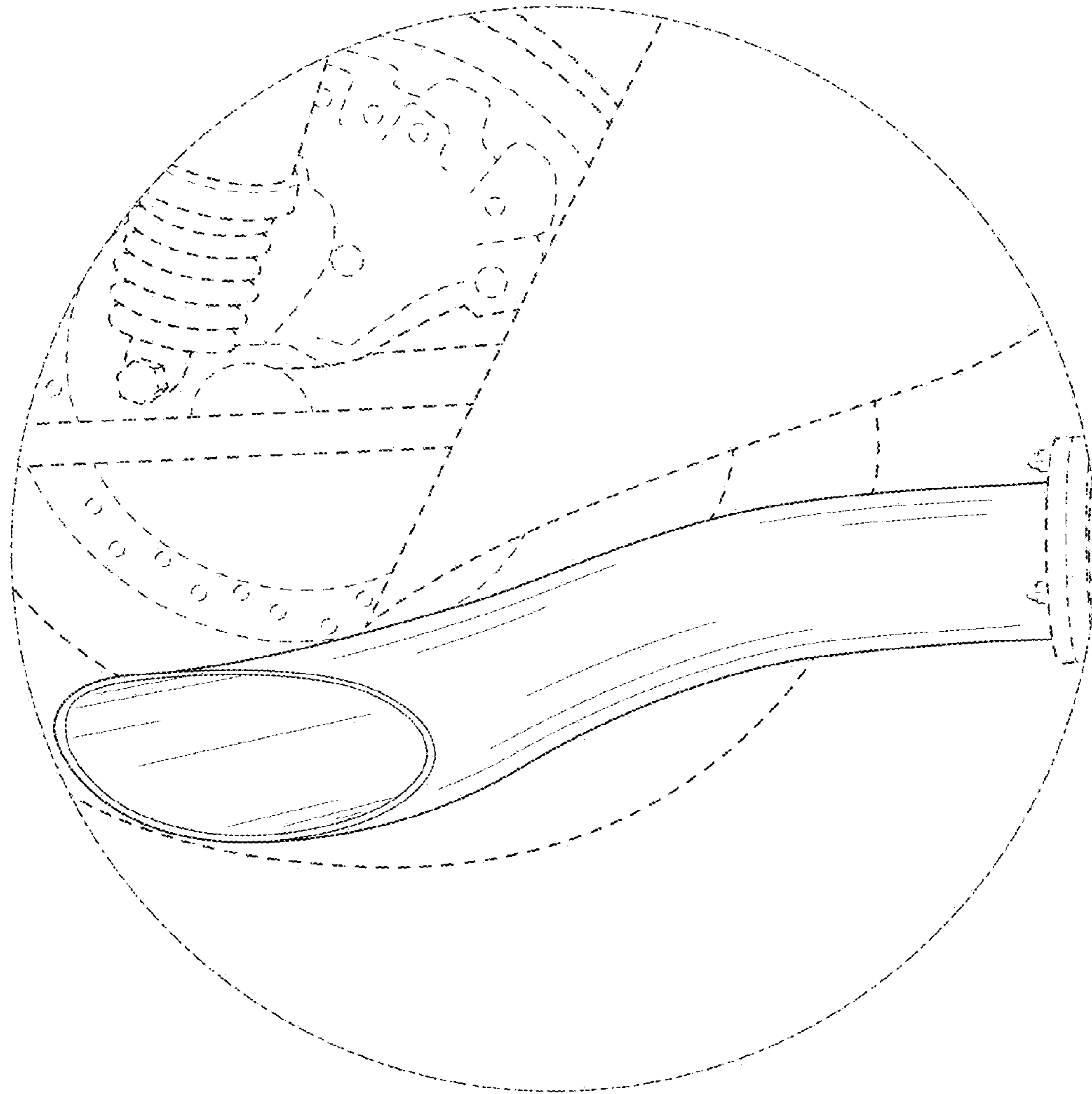

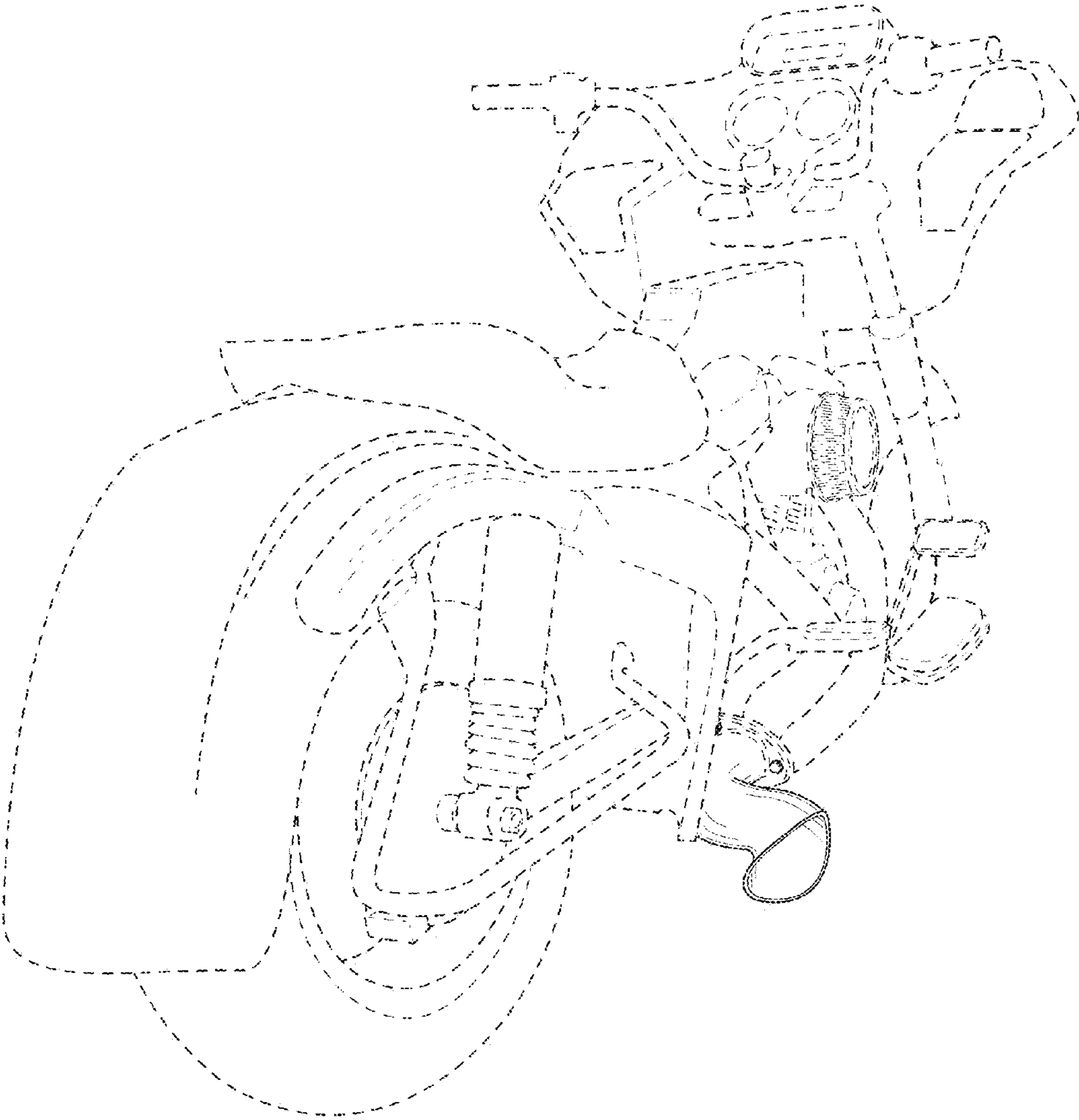

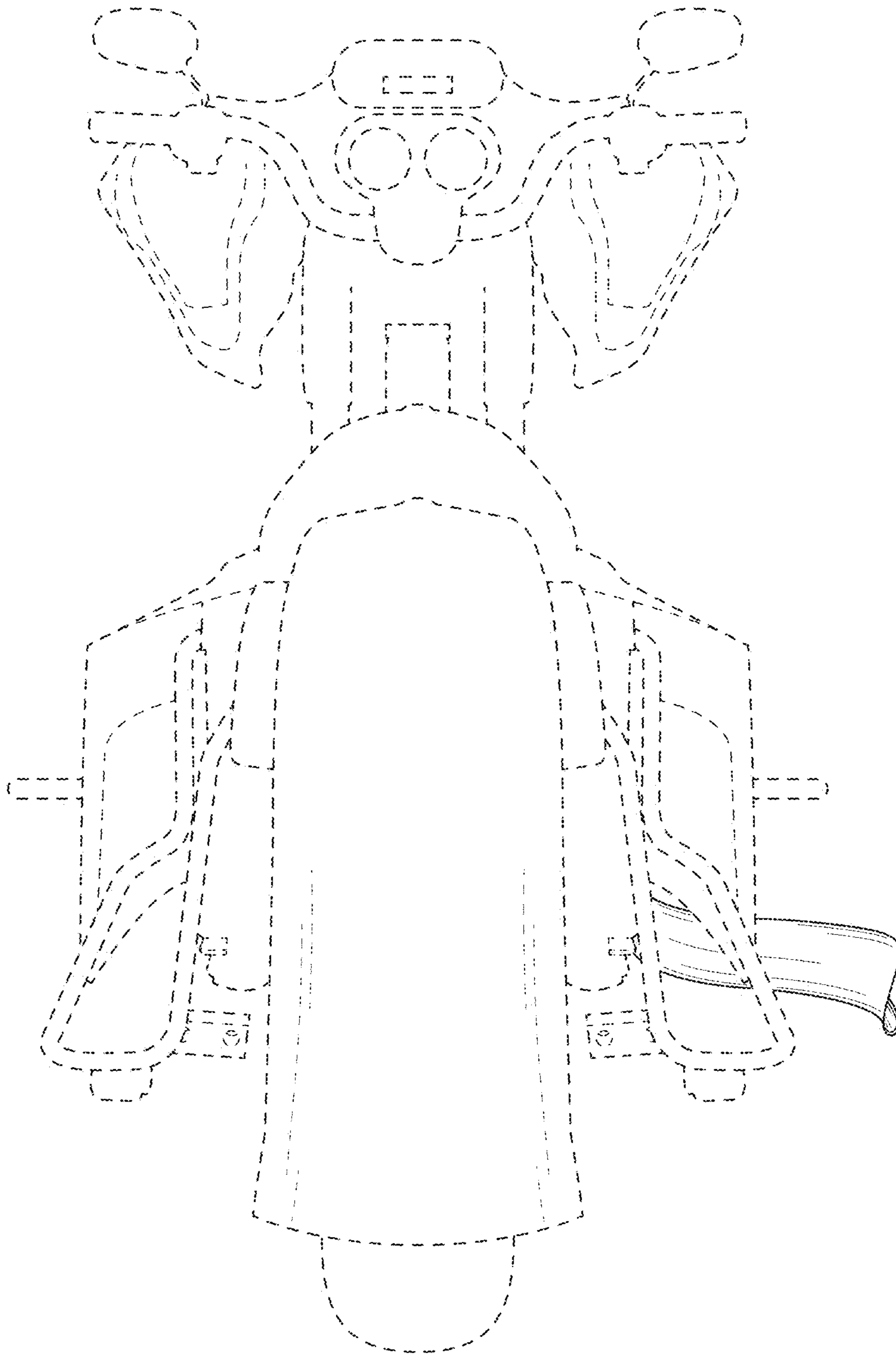

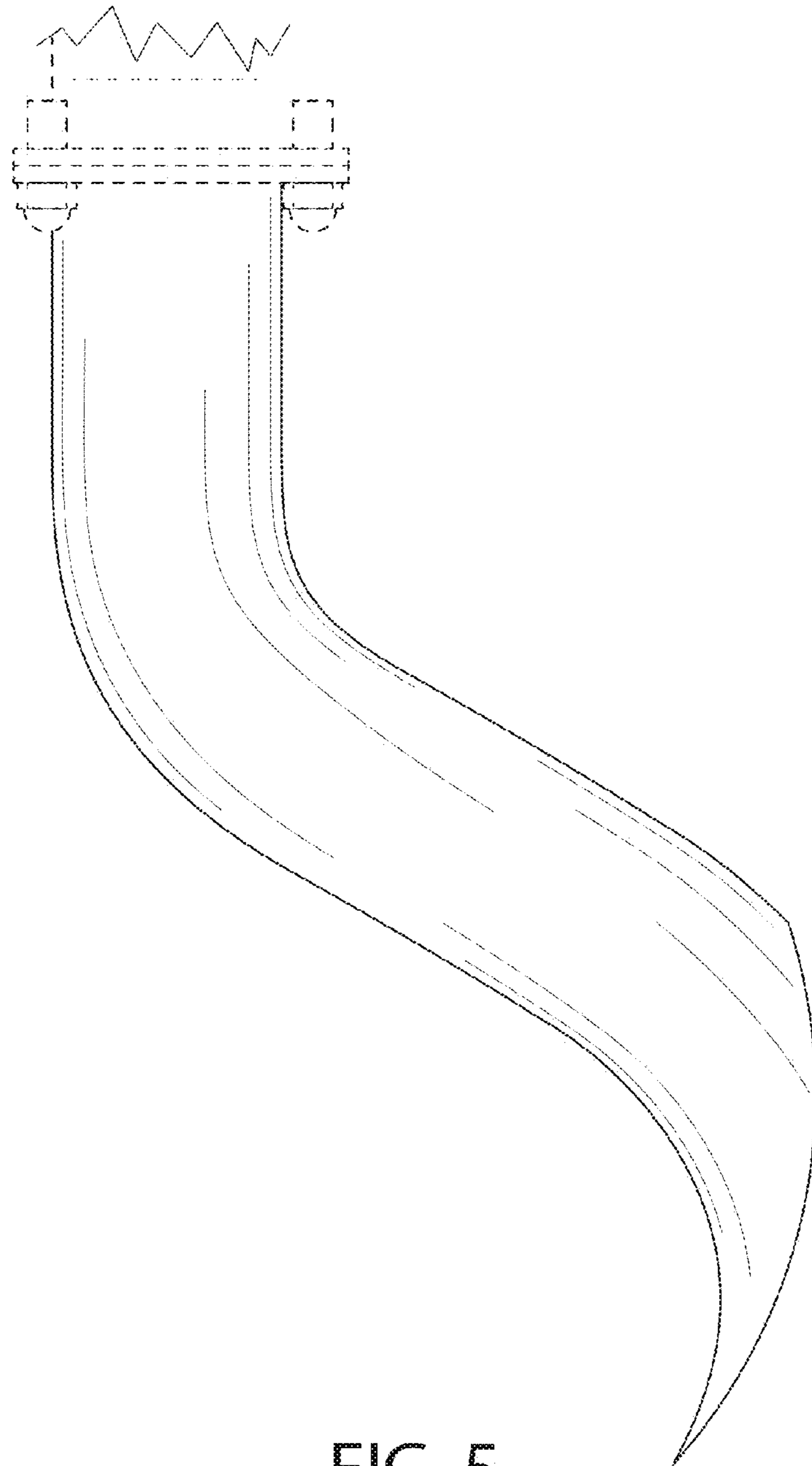
