FIG. 4 shows a right side view thereof;

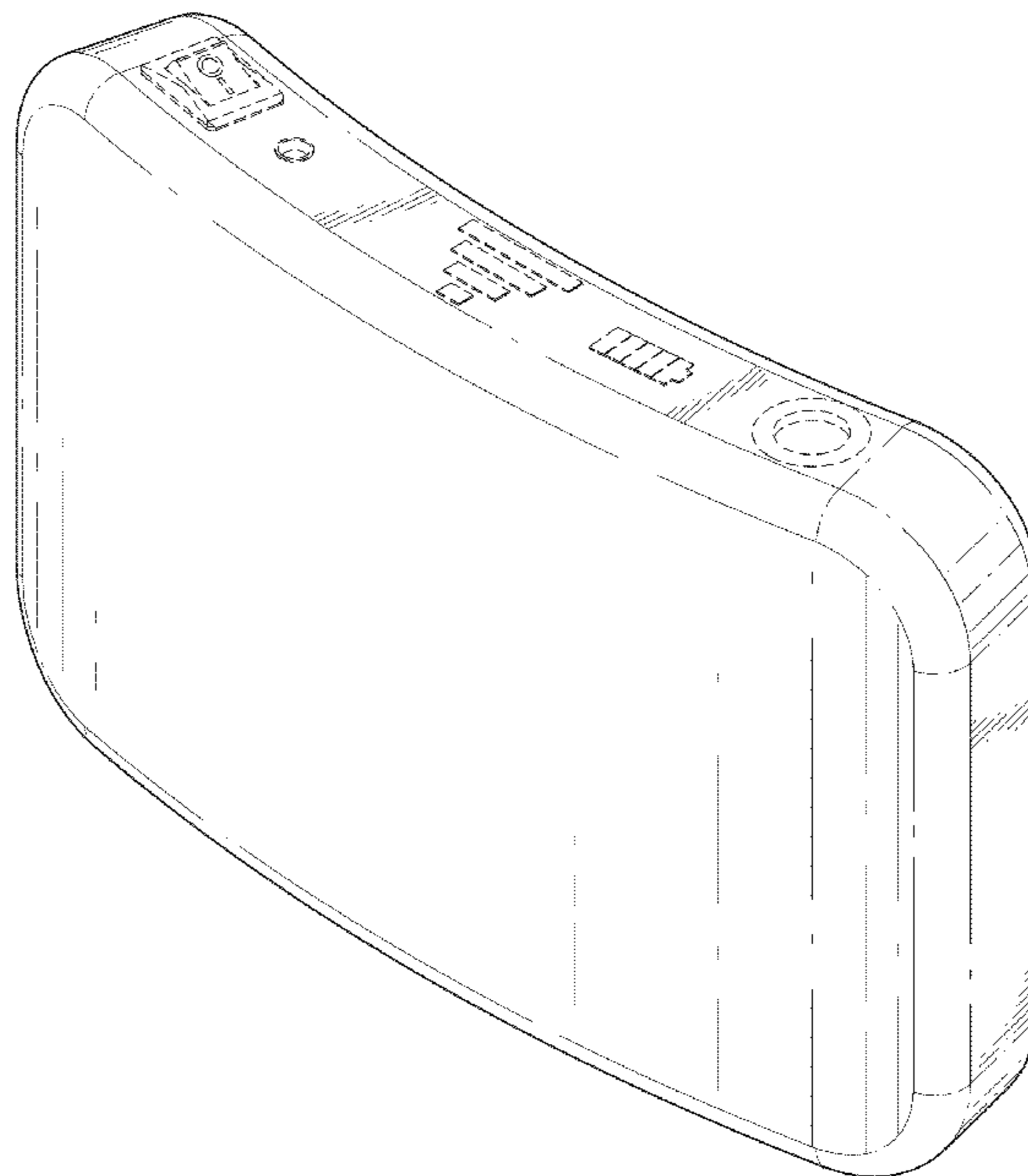
FIG. 5 shows a left side view thereof;

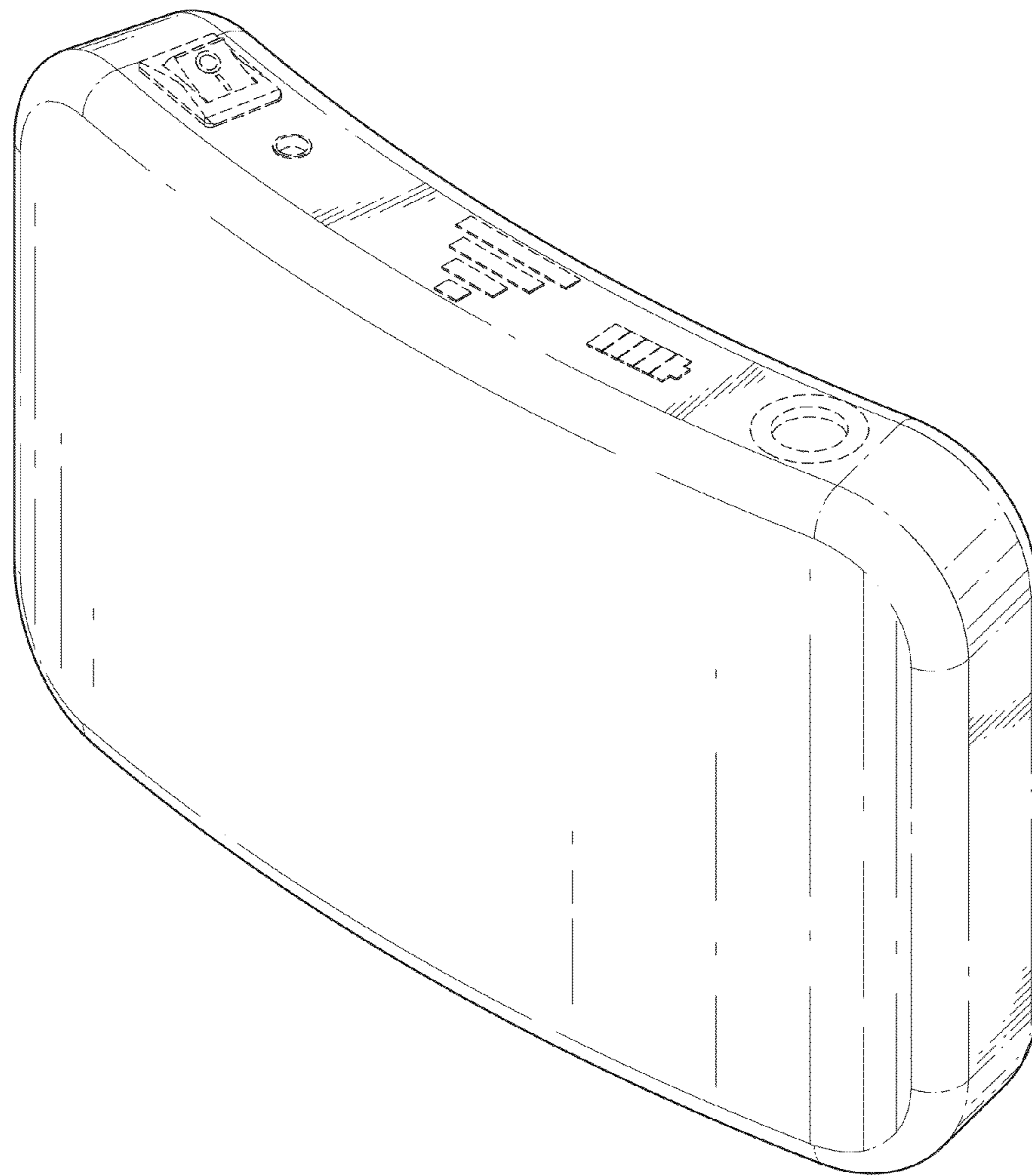

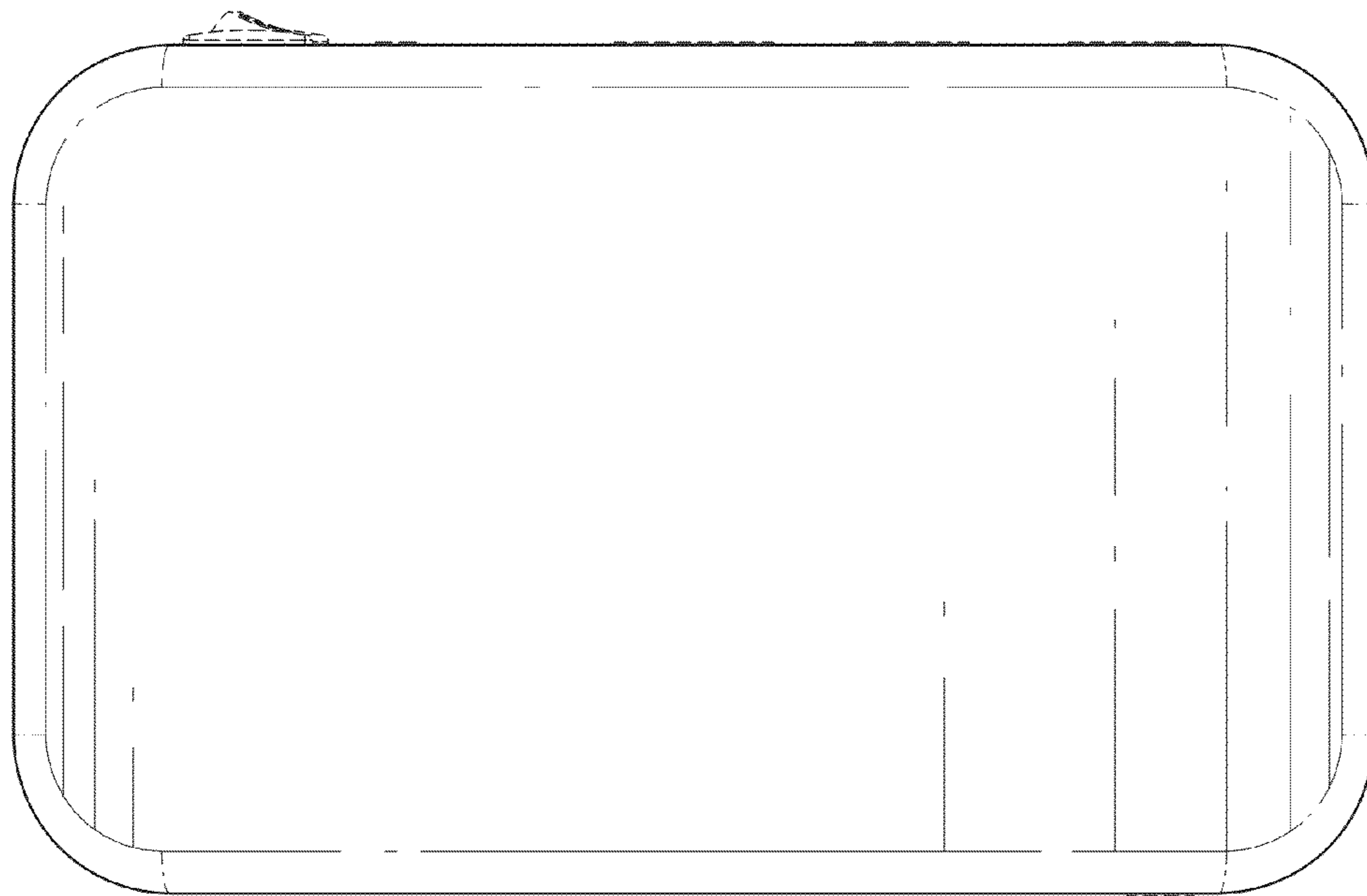

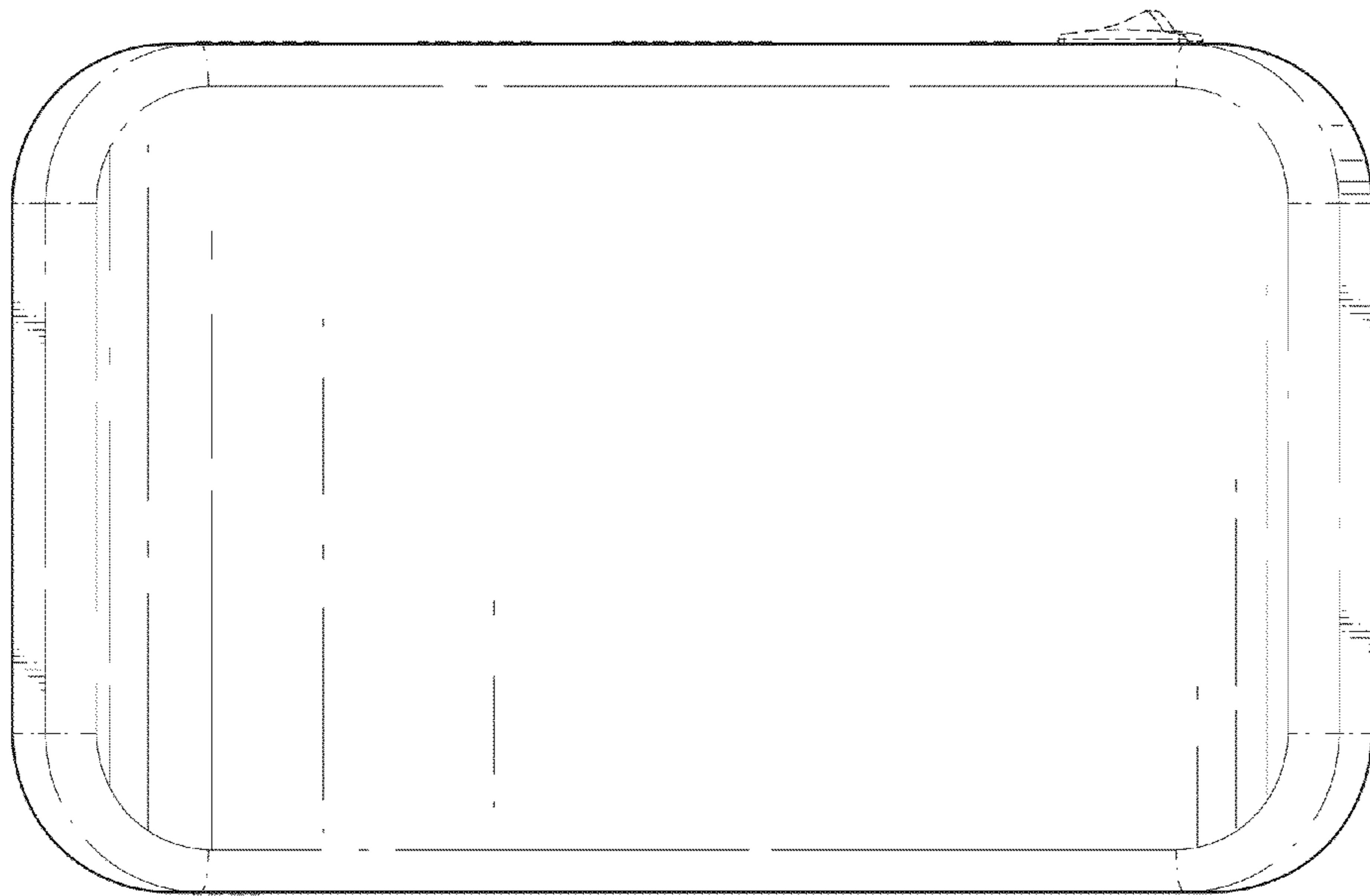

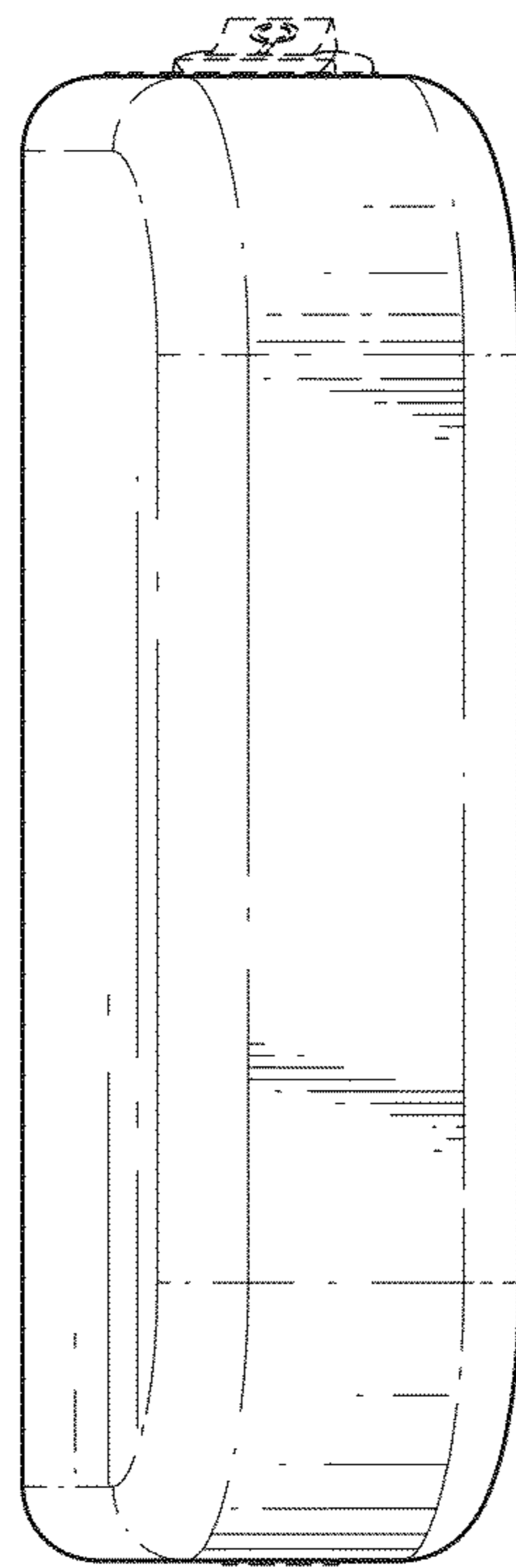

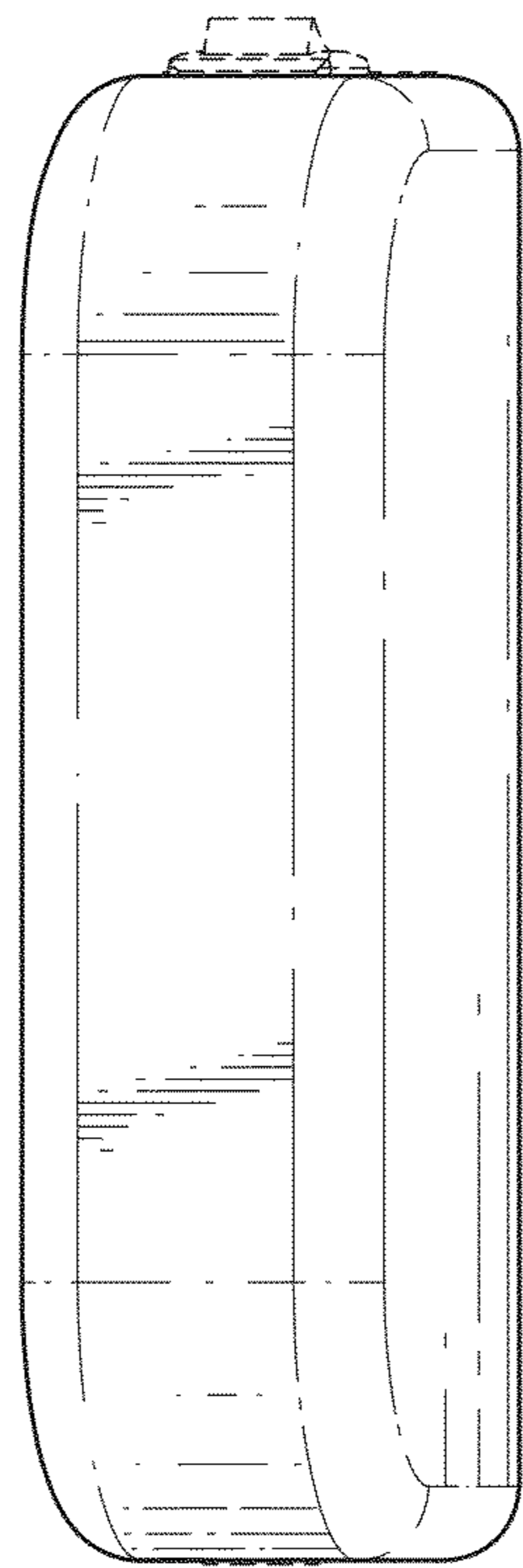

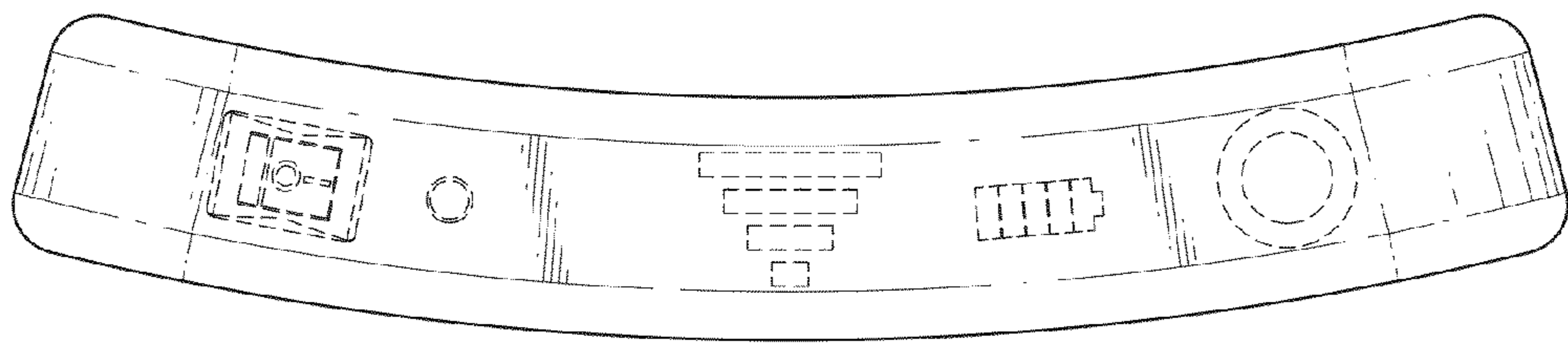

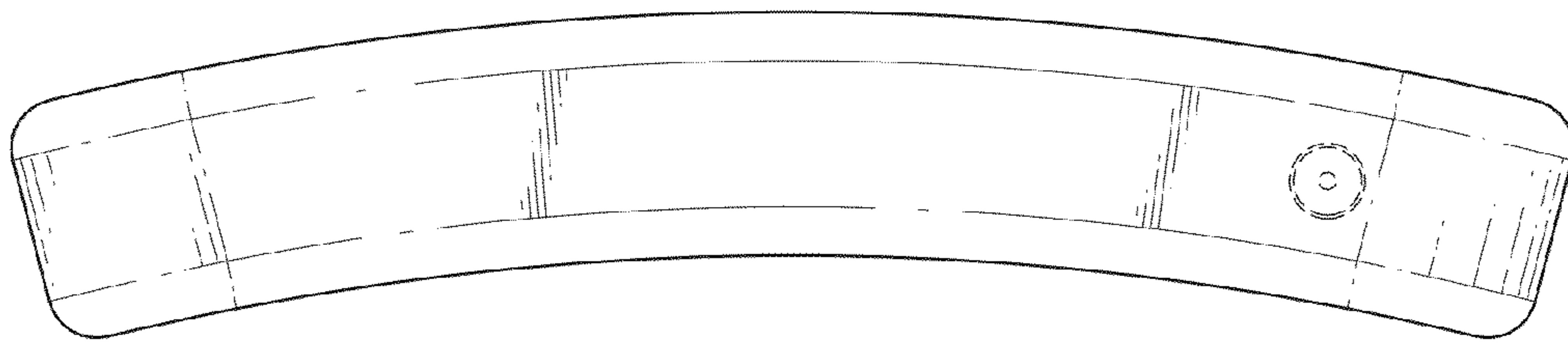
