The ornamental design for an electronic device, as shown and described.

DESCRIPTION

FIG. 1 is the front/right-side/top perspective view of an electronic device showing our new design;
FIG. 2 is the front elevational view thereof;
FIG. 3 is the rear elevational view thereof;
FIG. 4 is the left-side elevational view thereof;
FIG. 5 is the right-side elevational view thereof;
FIG. 6 is the top plan view thereof;

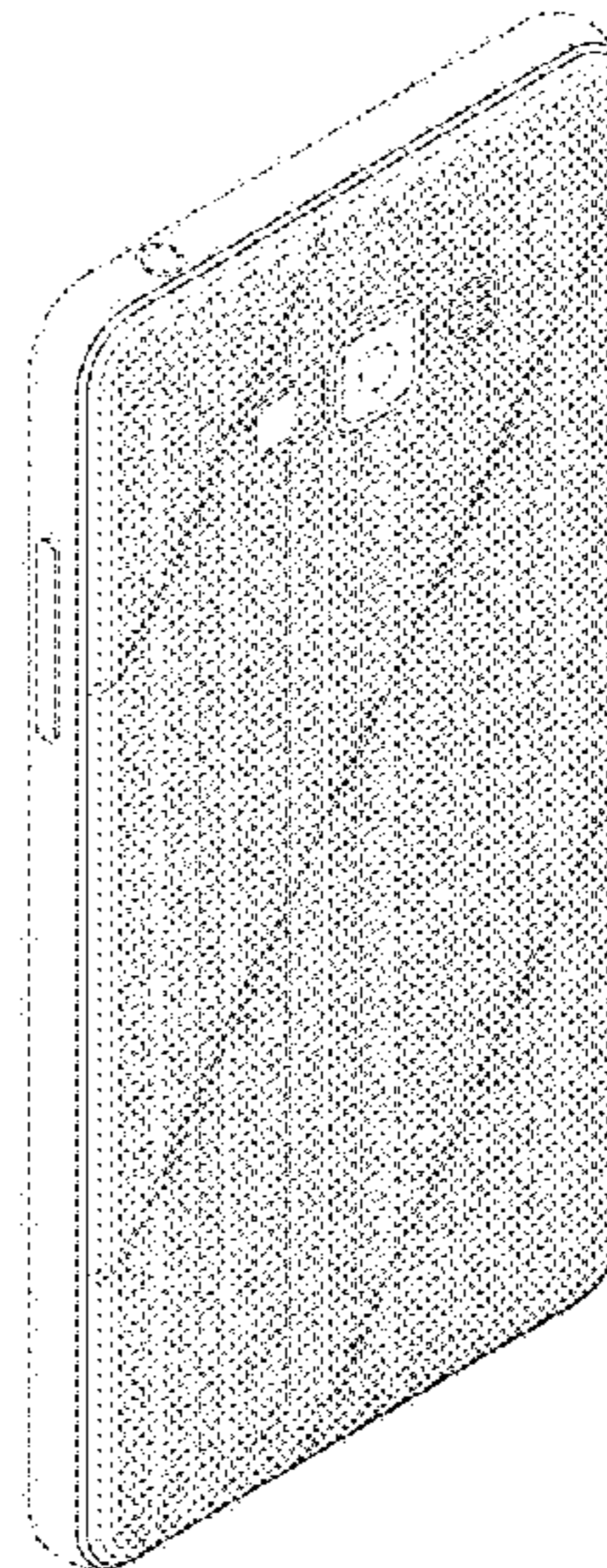
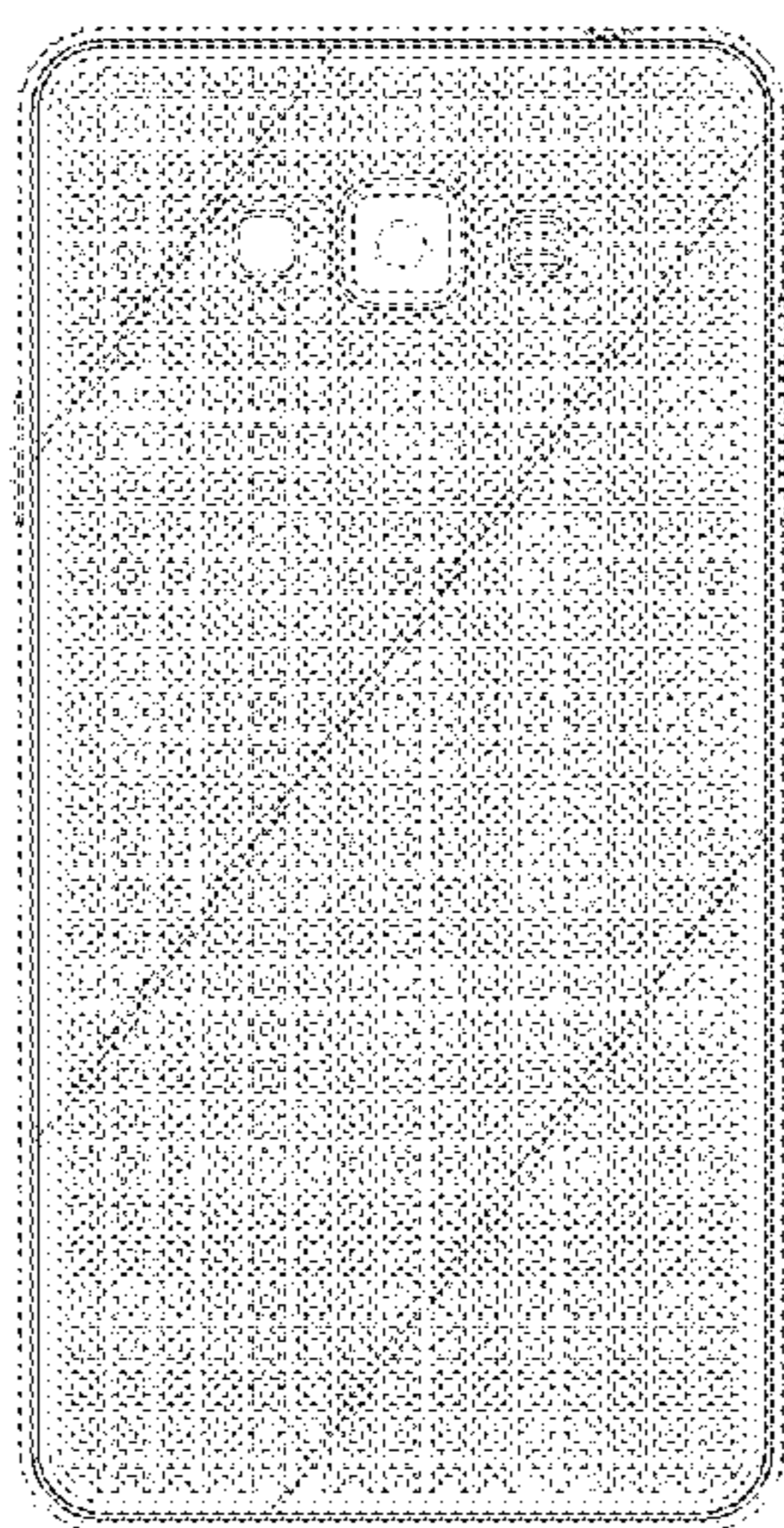

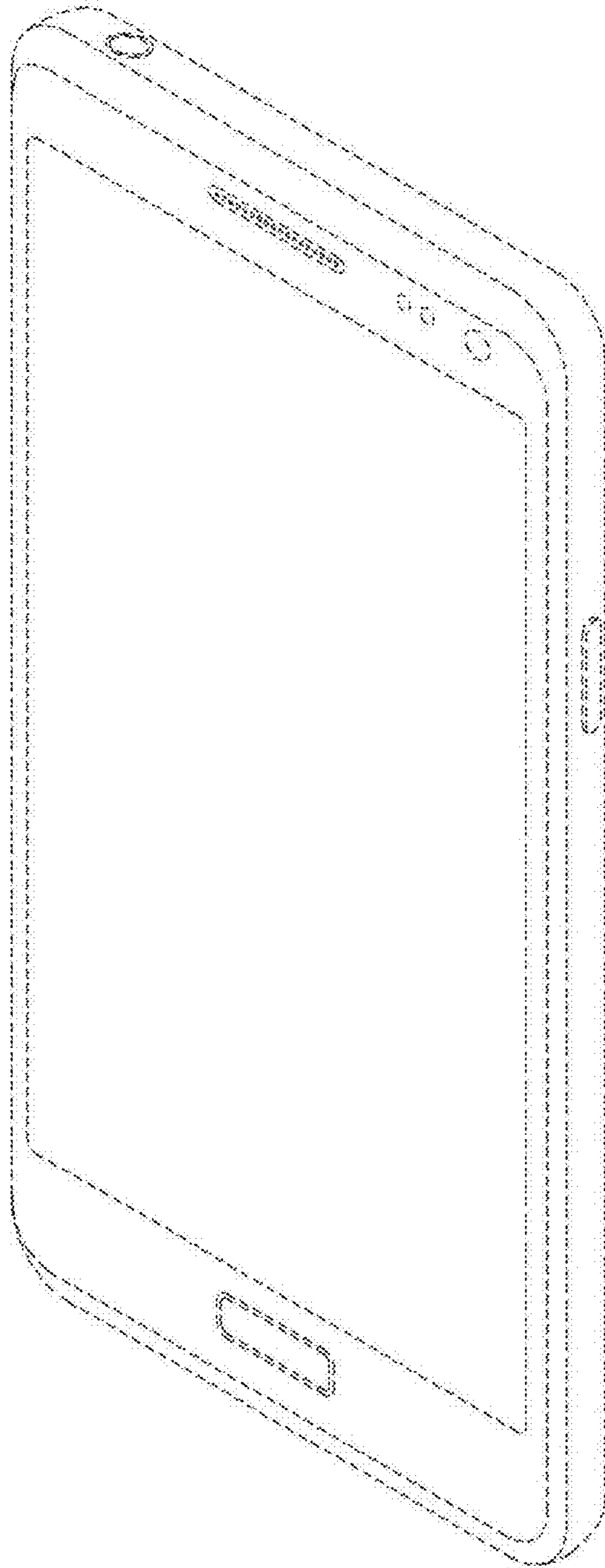

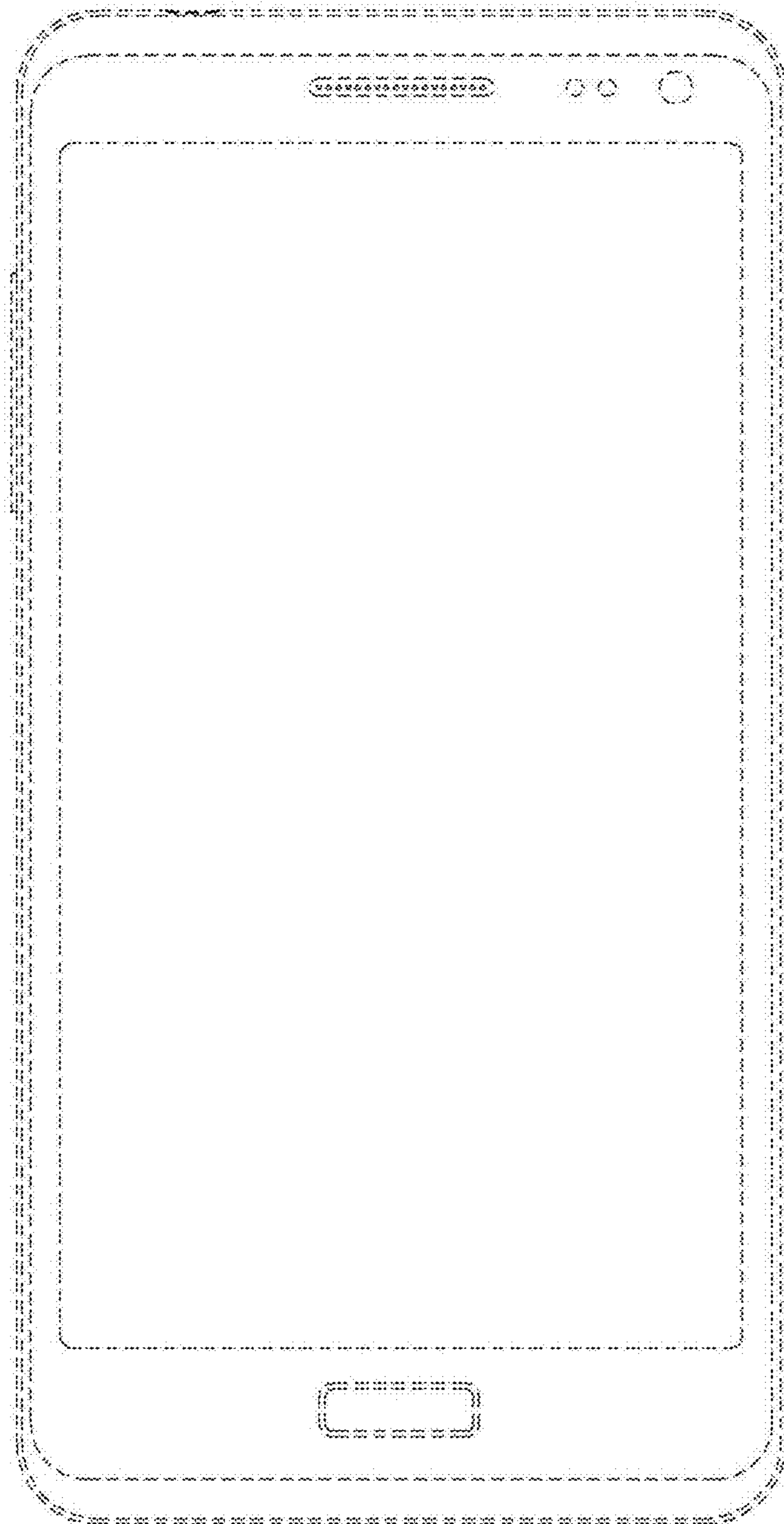

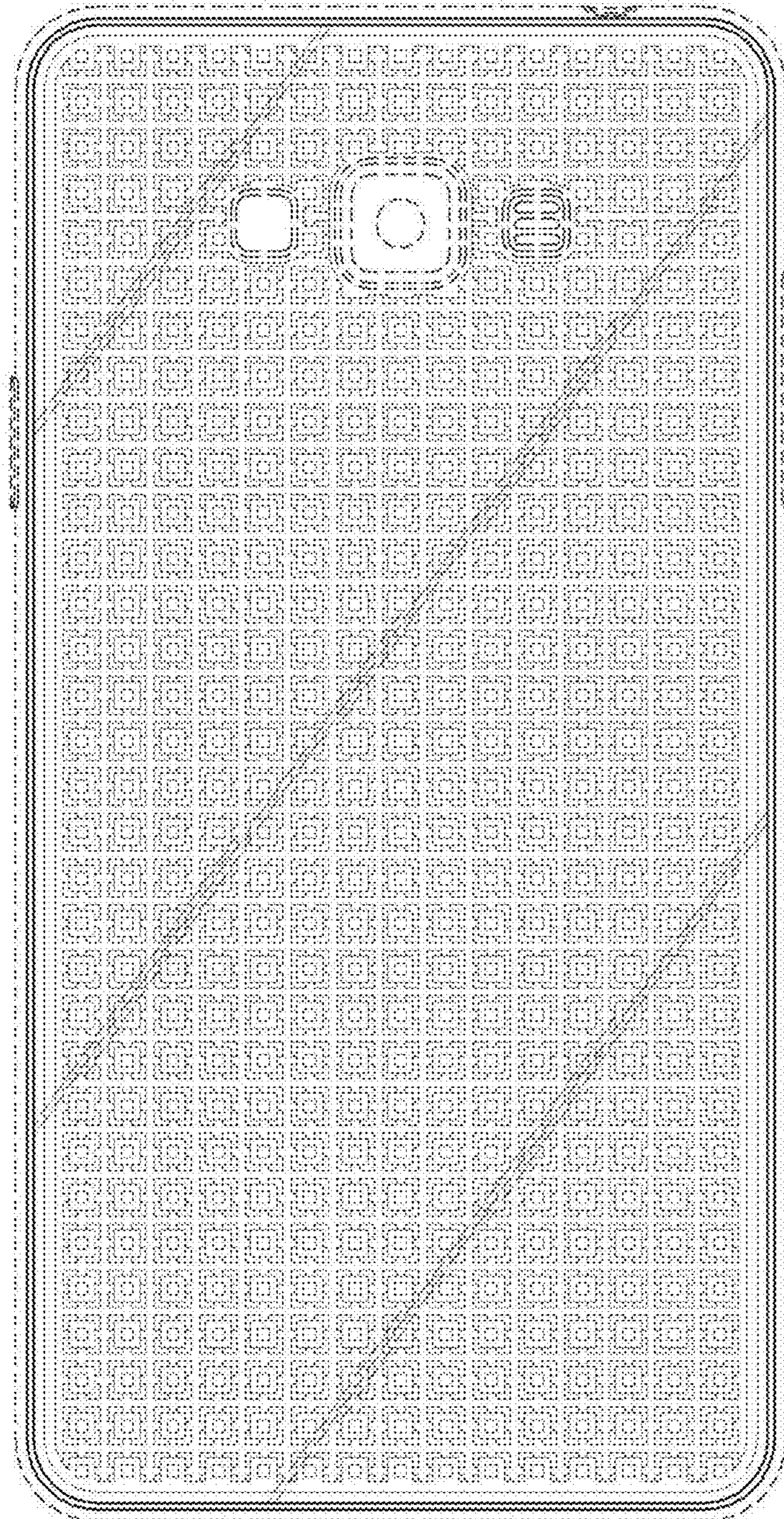

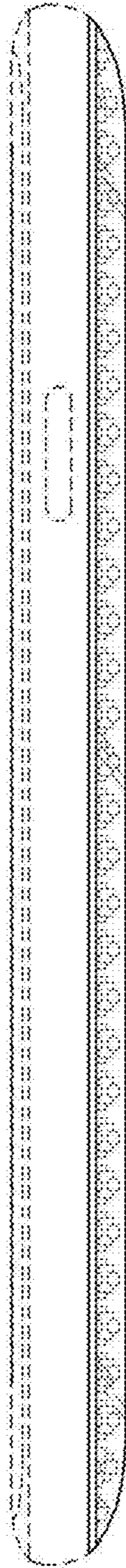
