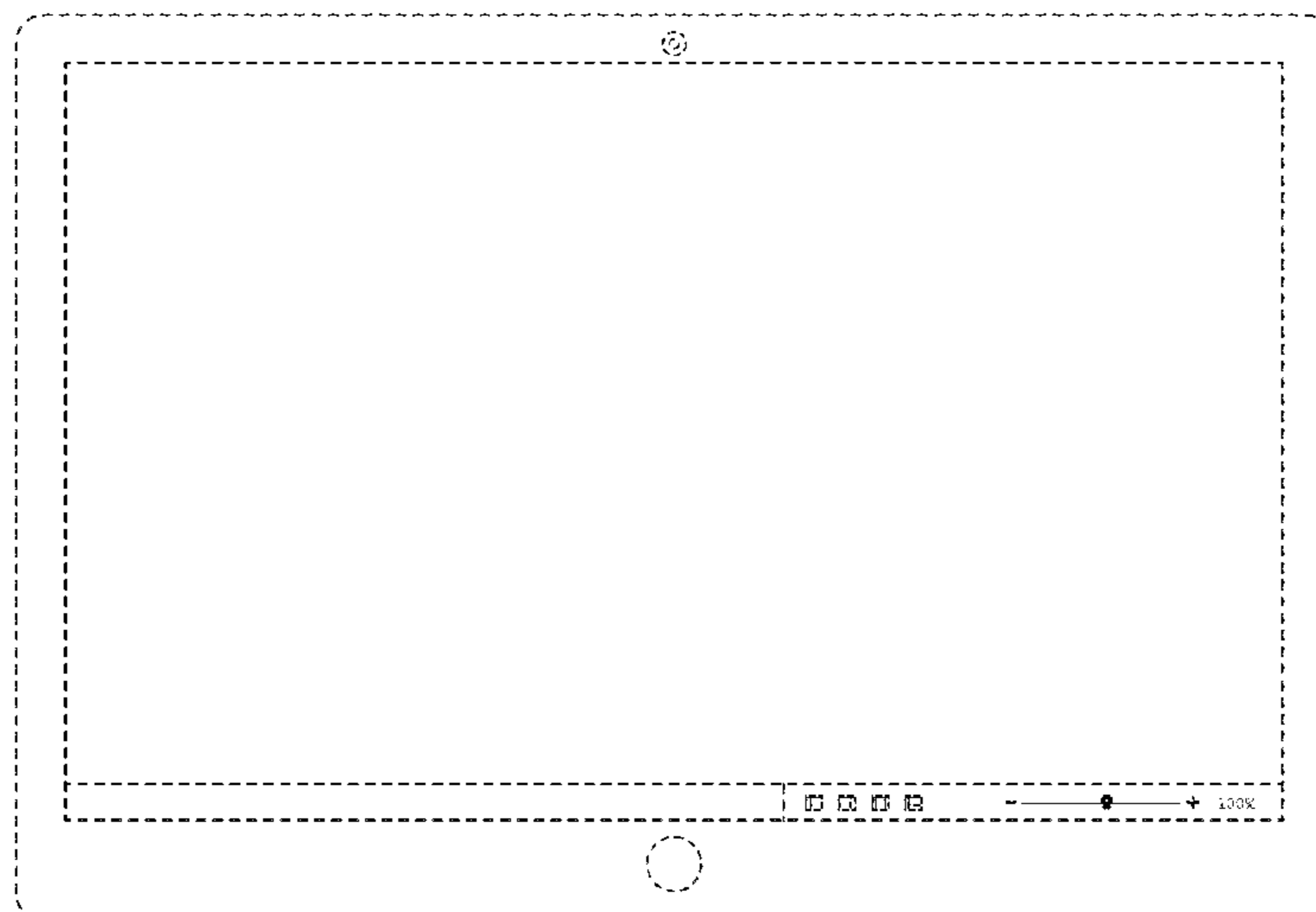
(57) **CLAIM**

The ornamental design for a display screen with user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with user interface showing the new design; FIG. 2 is a front view of a display screen with user interface of FIG. 1 with a region for enlargement; and, FIG. 3 is an enlarged view of the region identified by FIG. 3. The broken line showing of the alphanumeric characters in FIG. 1, the remainder of the user interface, and display screen is for environmental purposes only and forms no part of the claimed design.

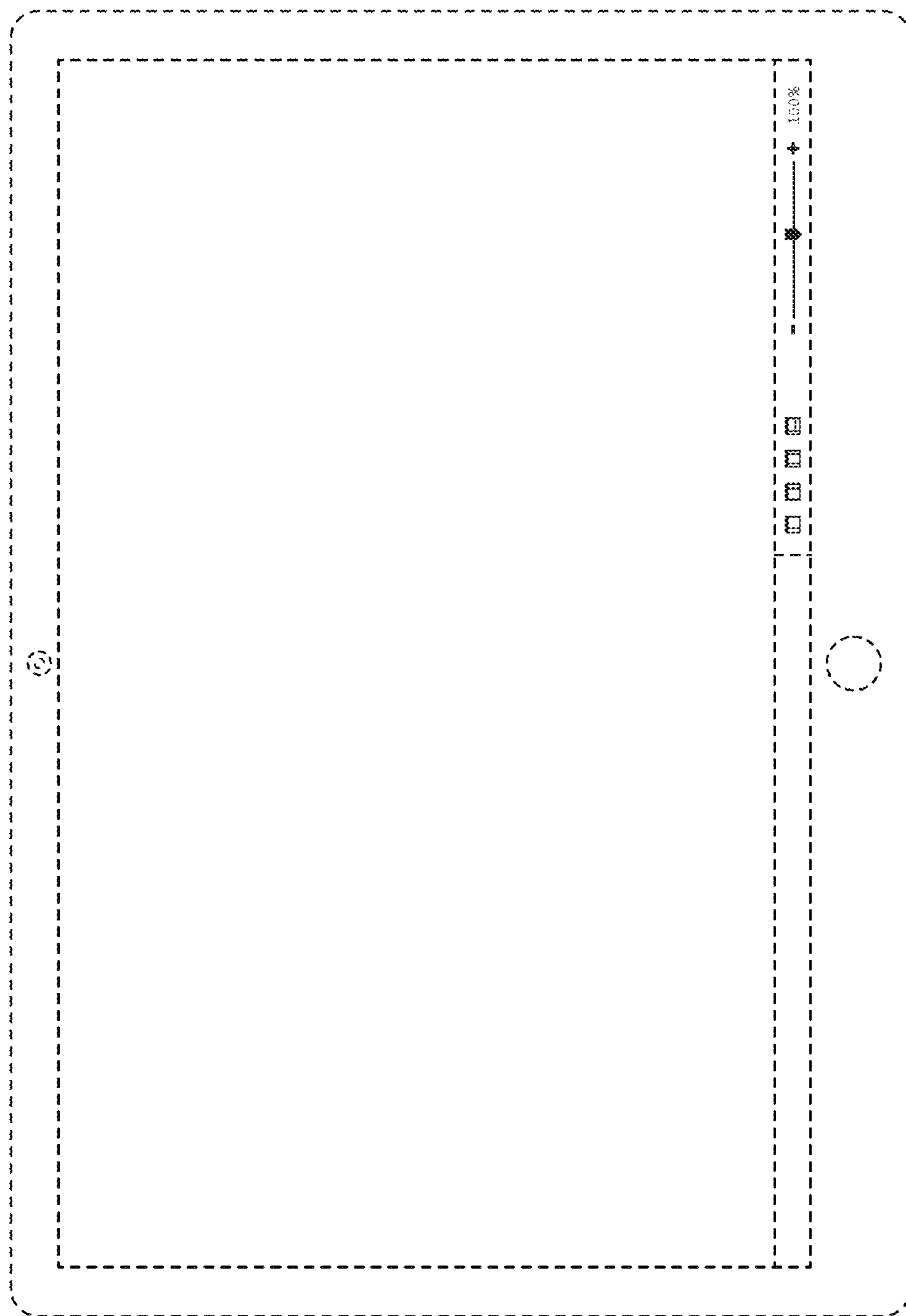

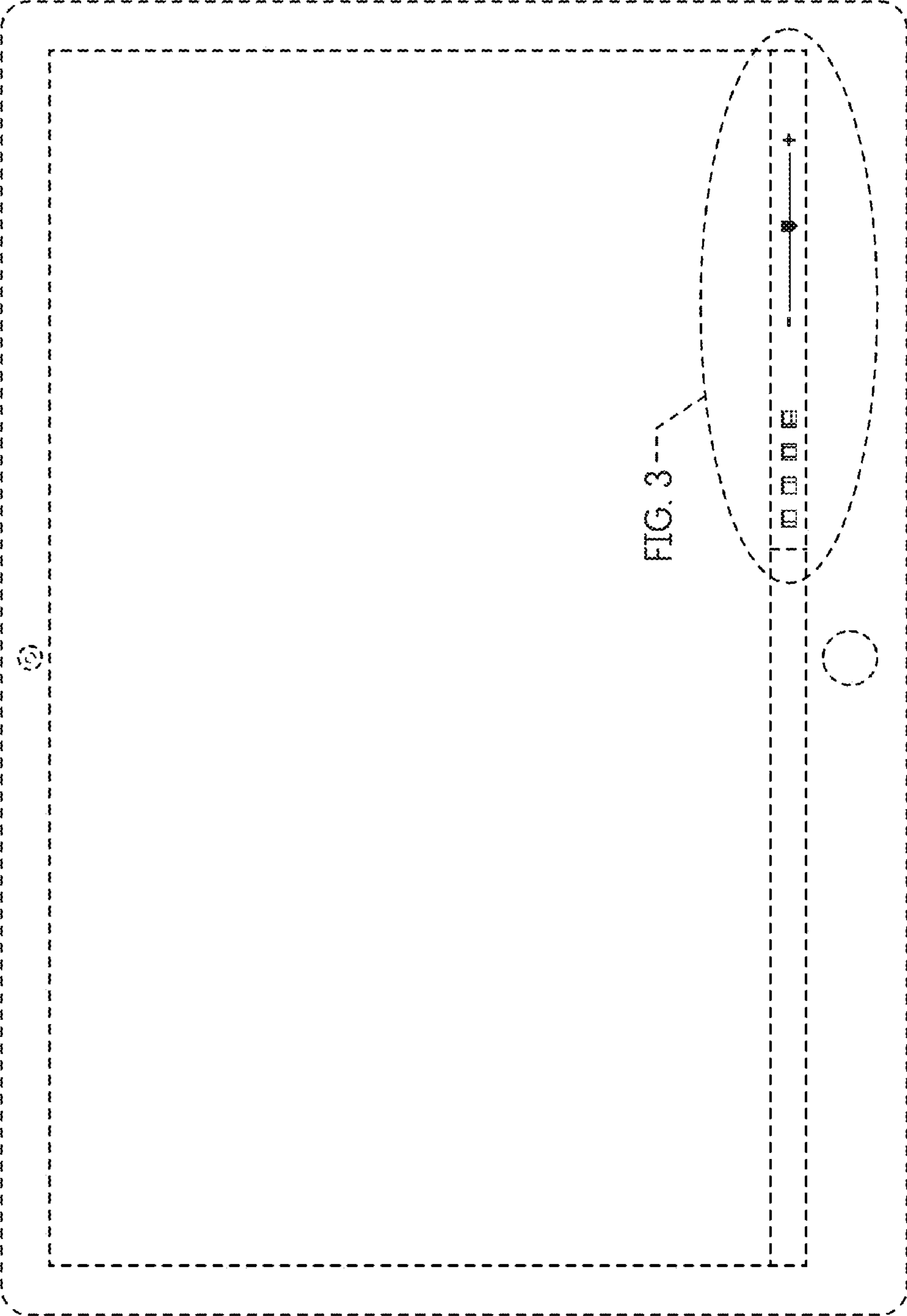

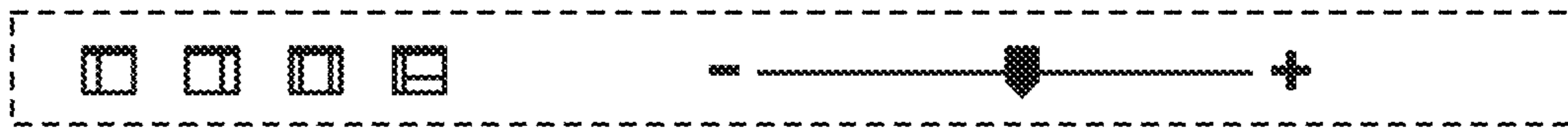
