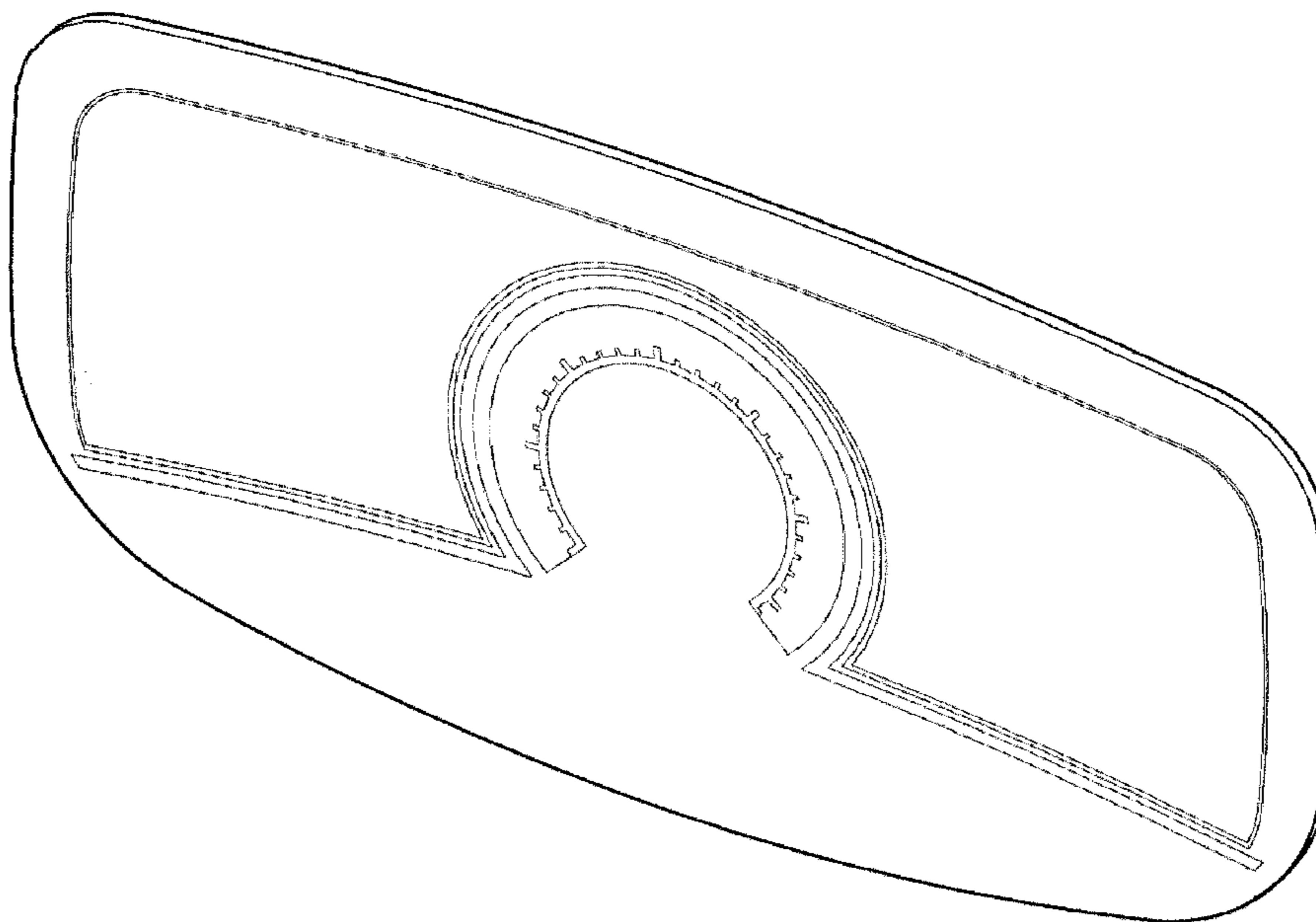
The ornamental design for a meter panel, as shown and described.

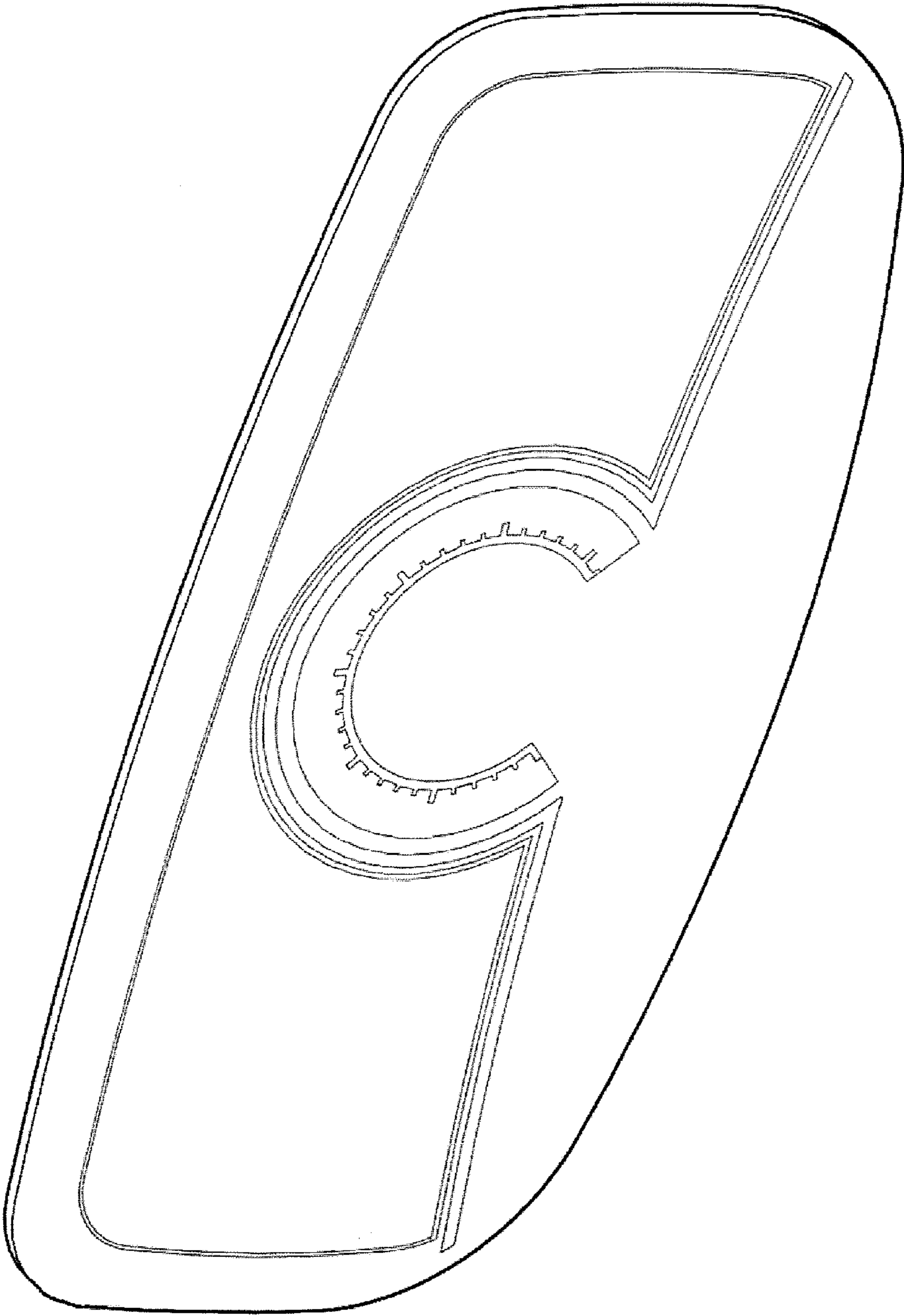

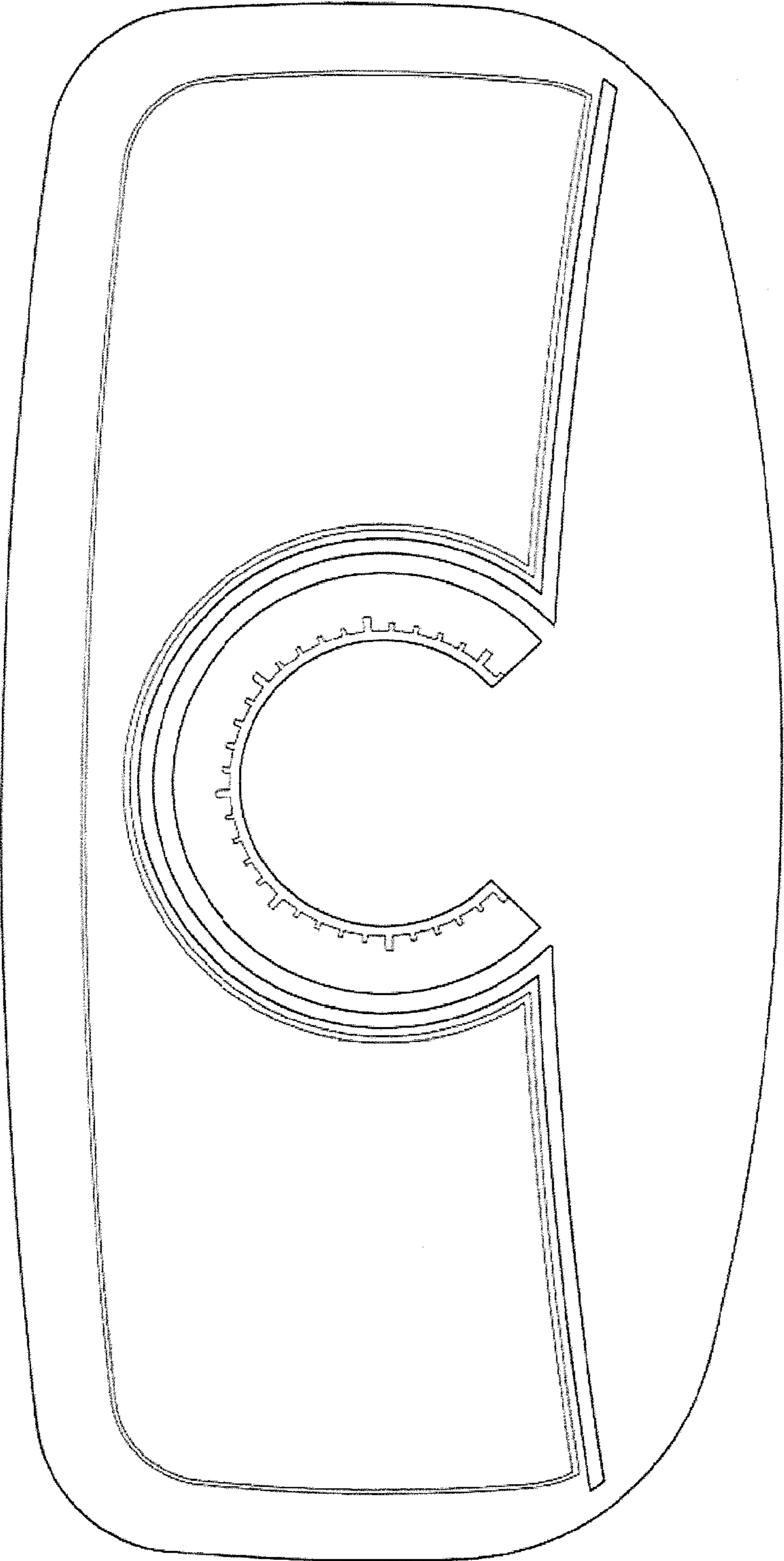
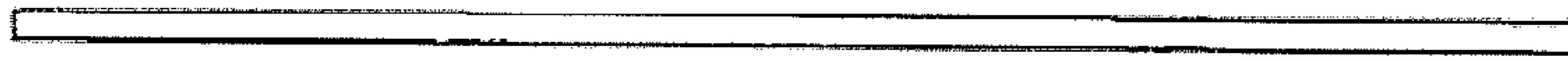
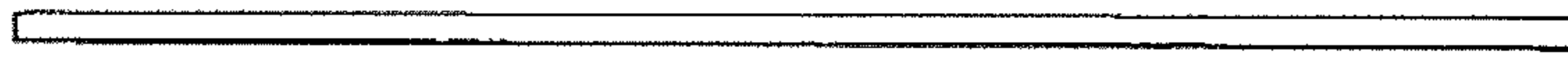


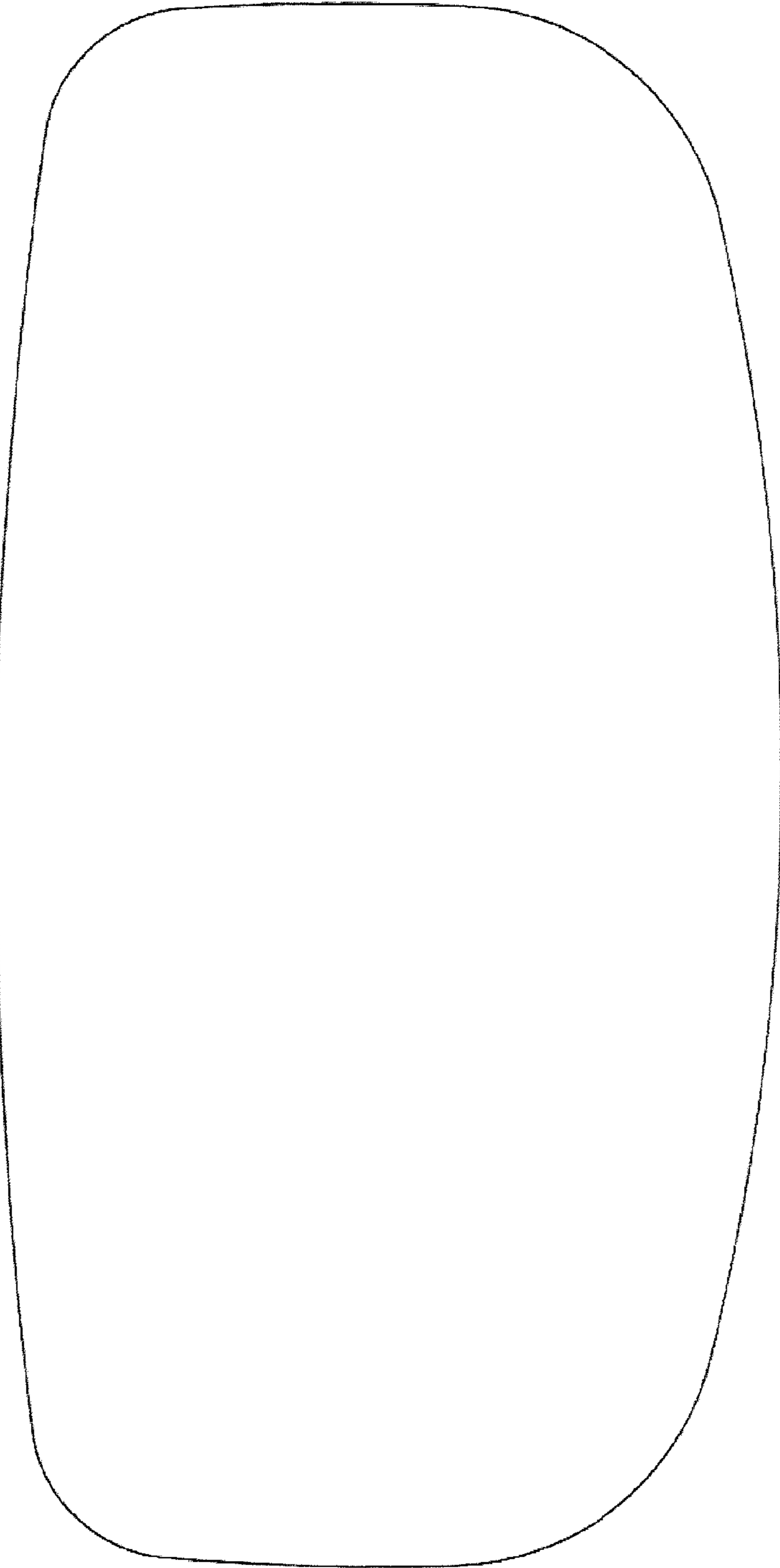

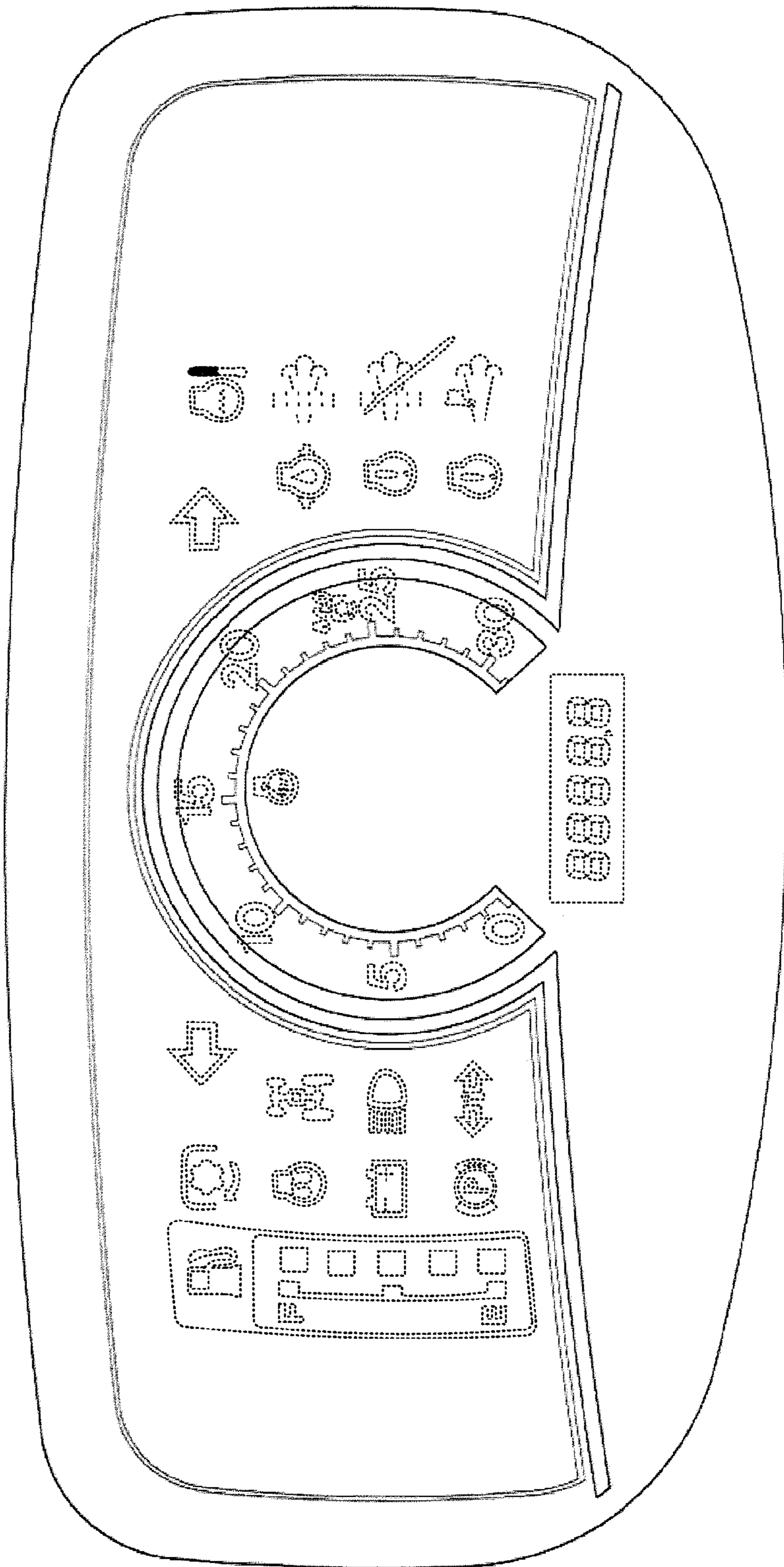
