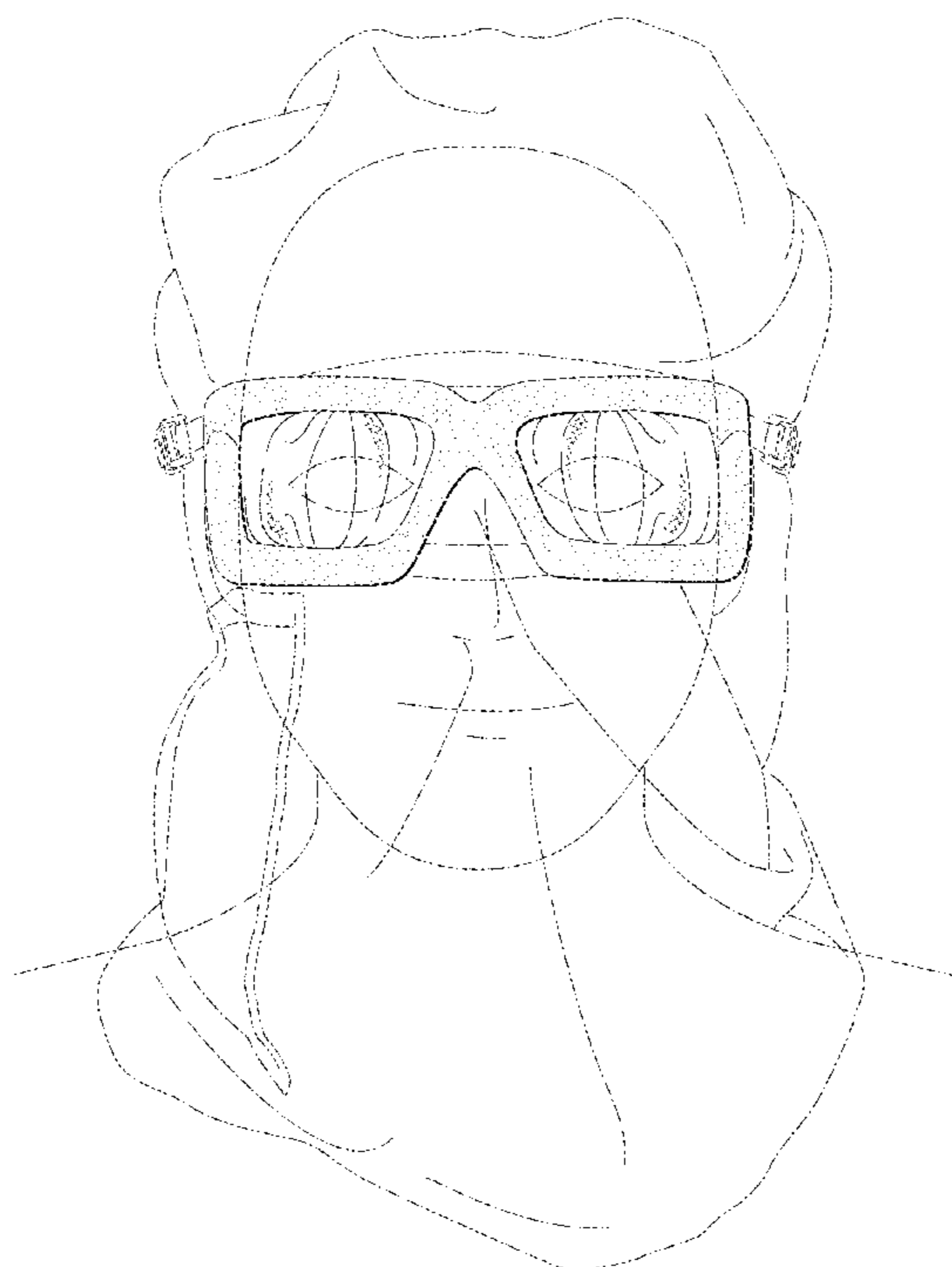
FIG. 1 is a front illustrative view of the present design.

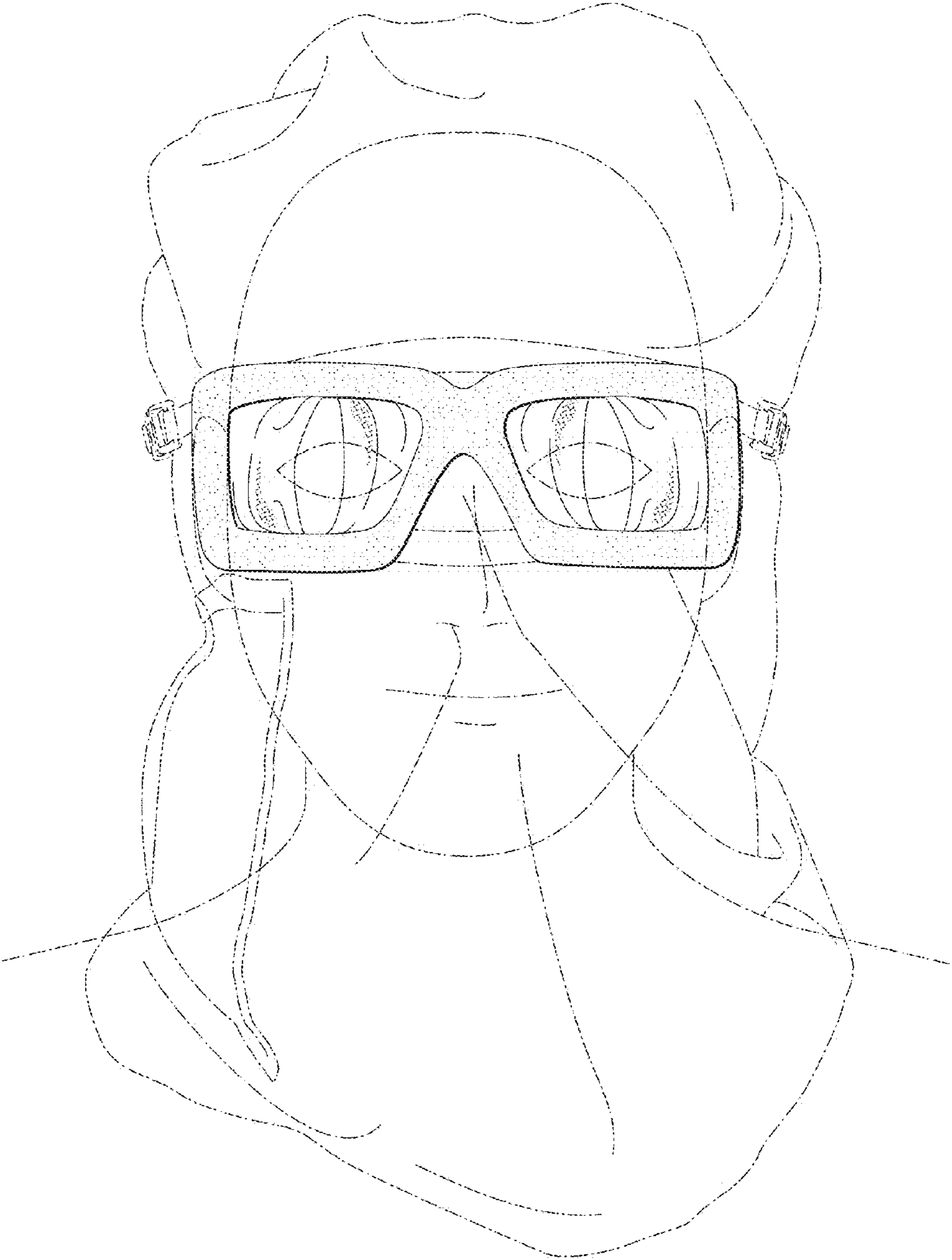

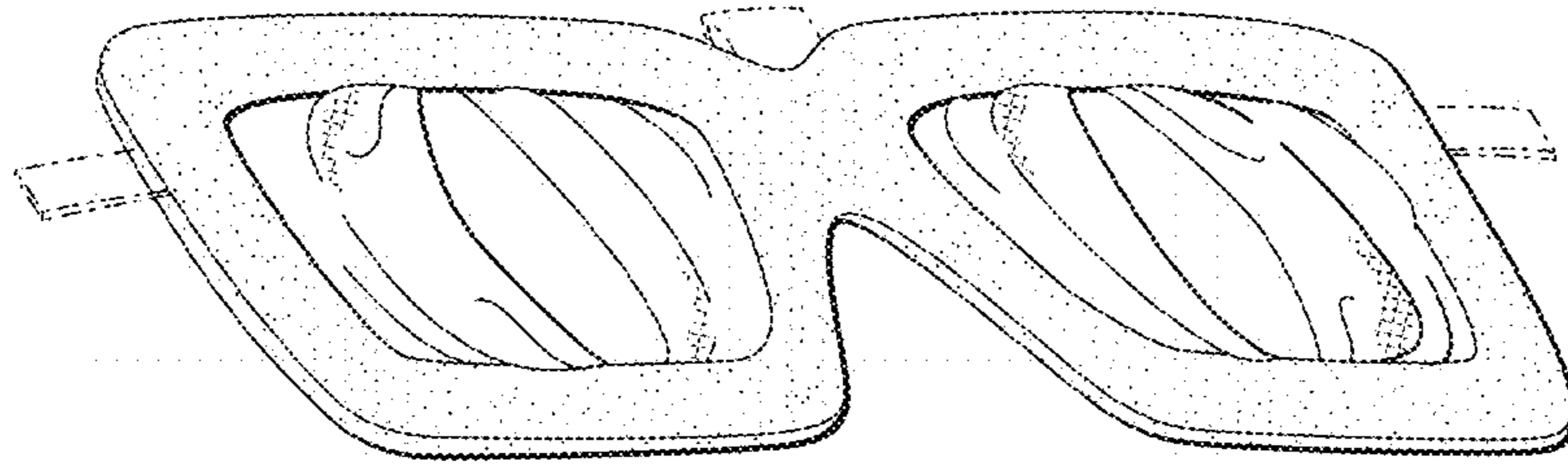

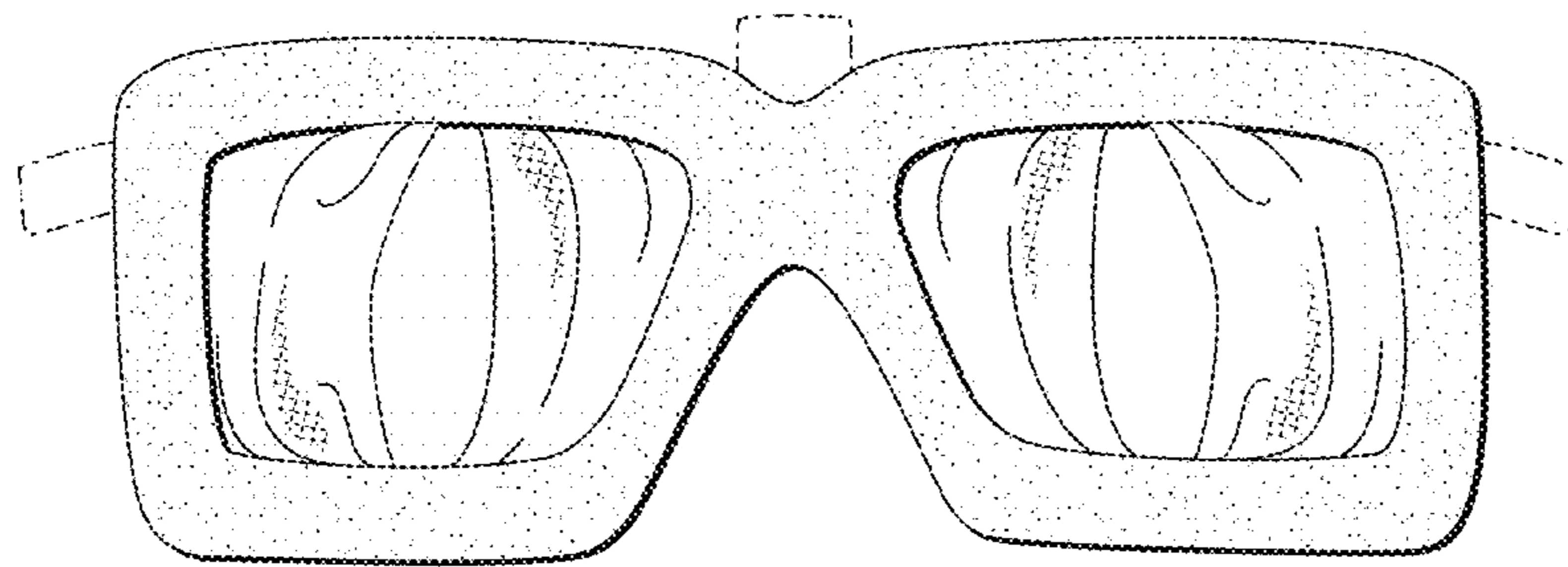

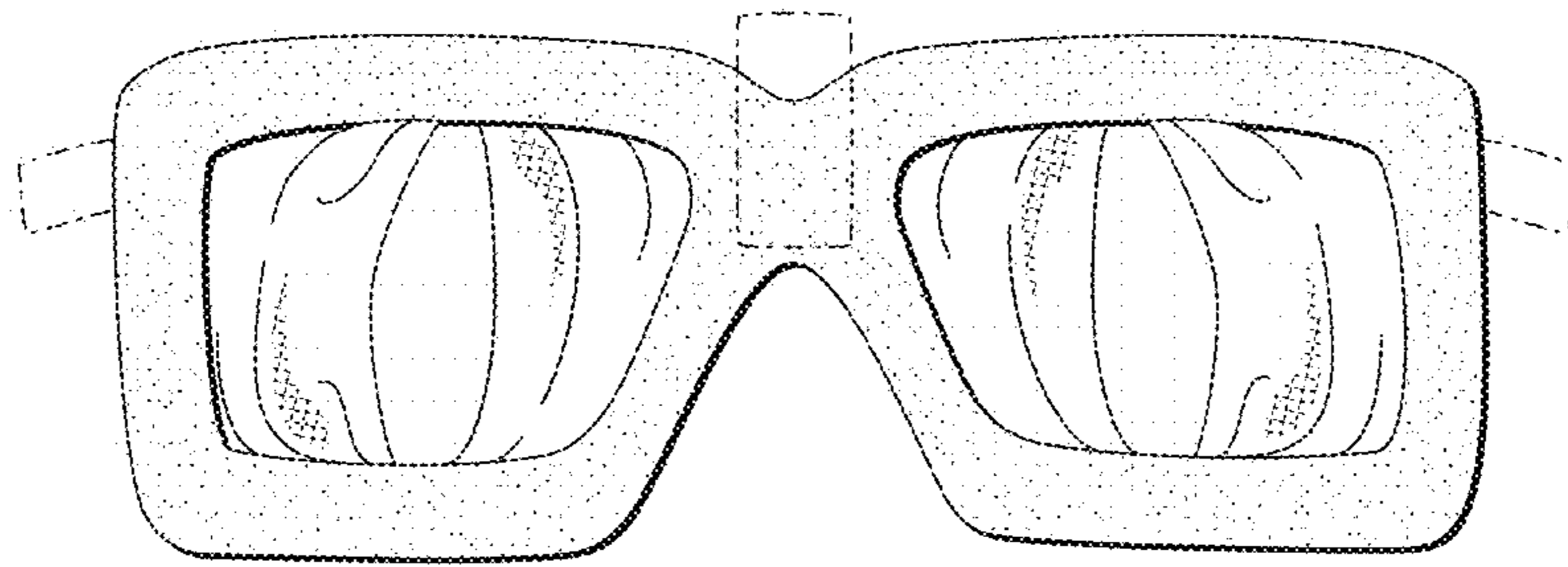

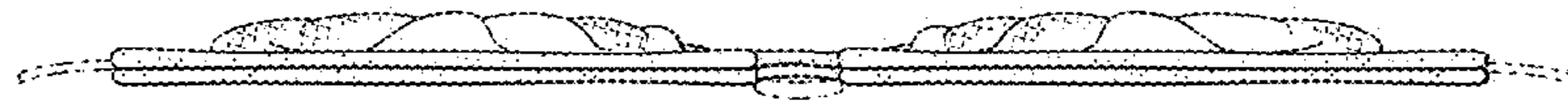

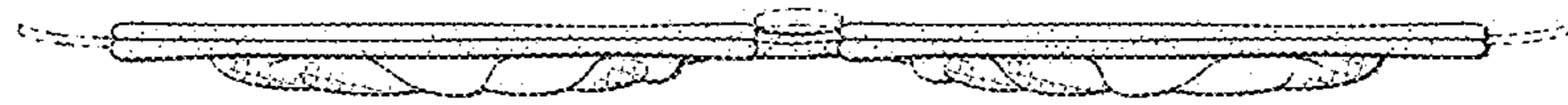

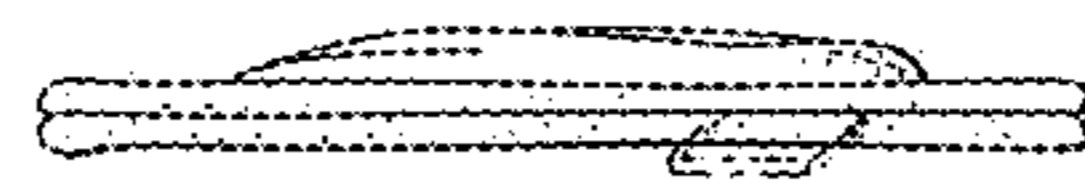
