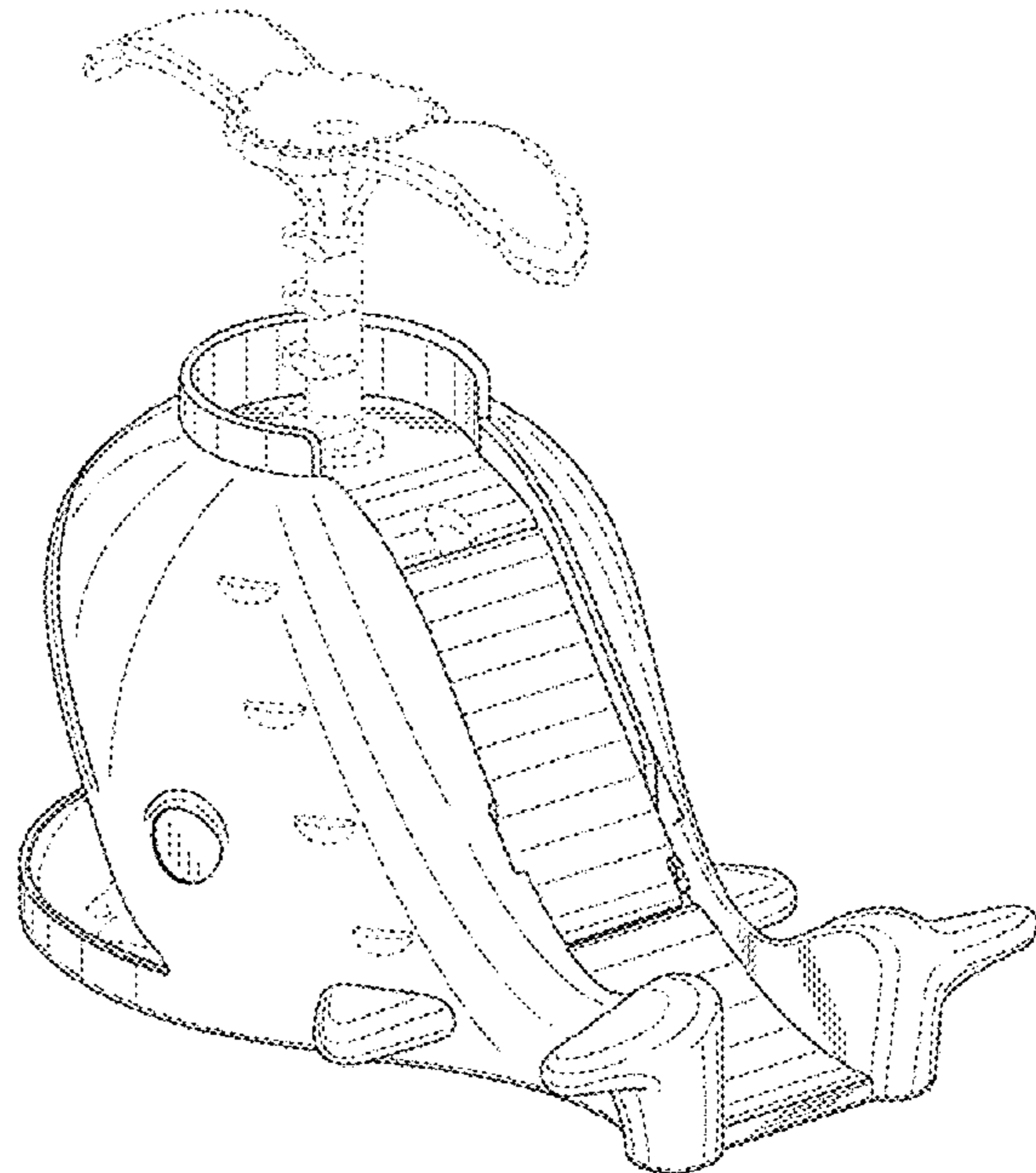
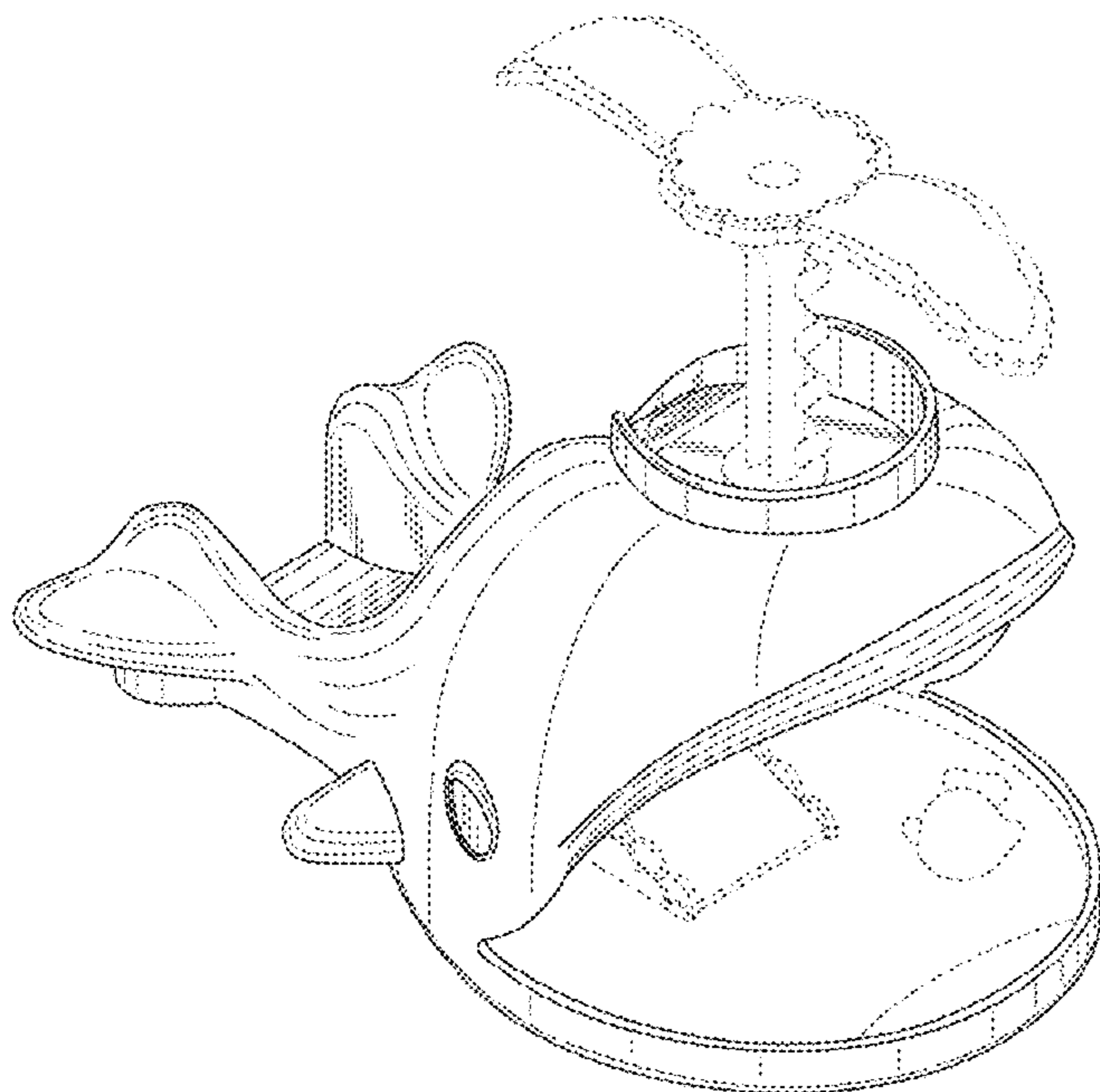
(57) **CLAIM**

The ornamental design for a toy slide, as shown and described.

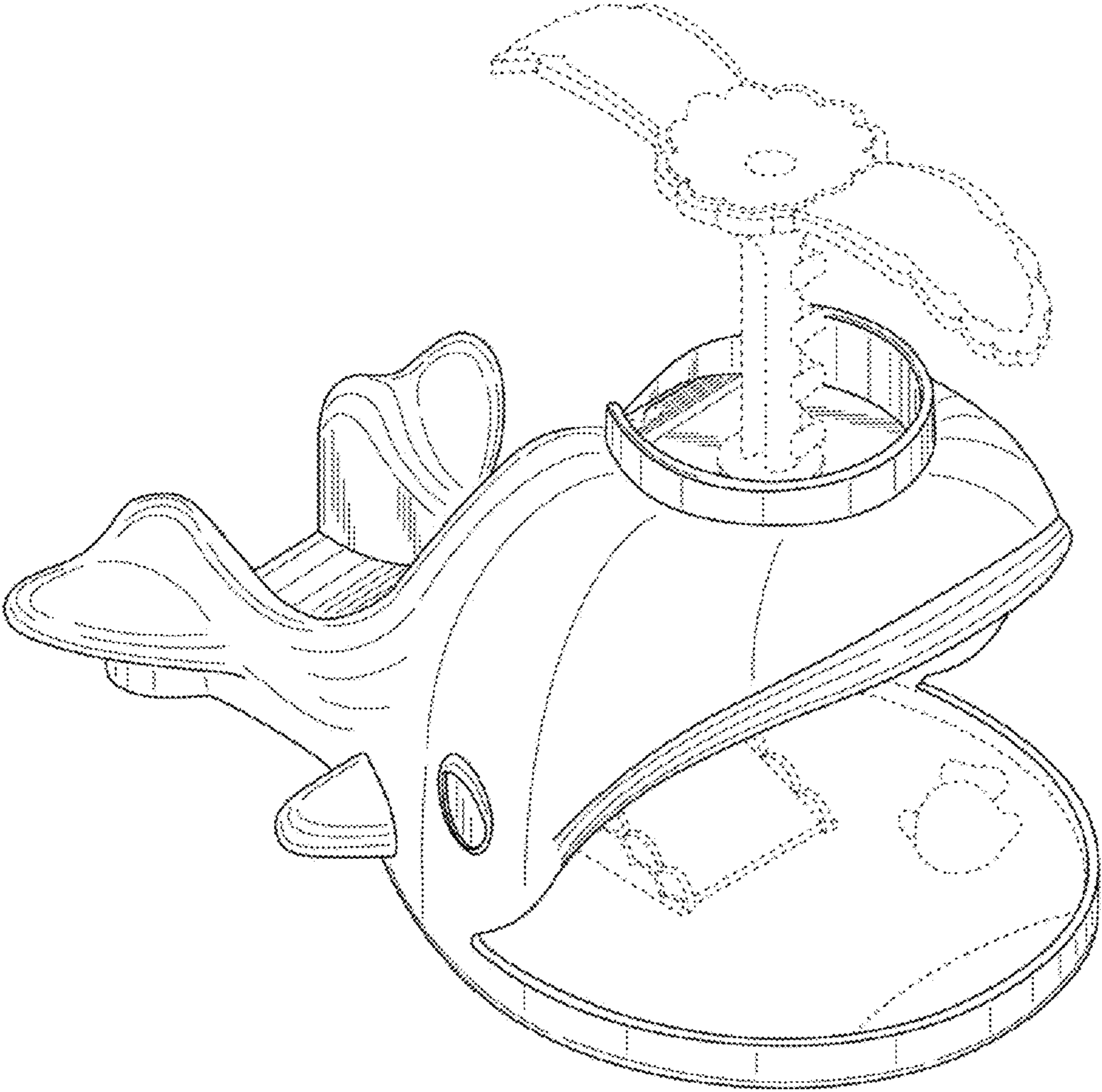
**DESCRIPTION**

FIG. 1 is a left rear perspective view of a toy house showing my new design;  
FIG. 2 is a right front perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a right side elevational view thereof;

The broken lines illustrate portions of the toy slide and form no part of the claimed design.

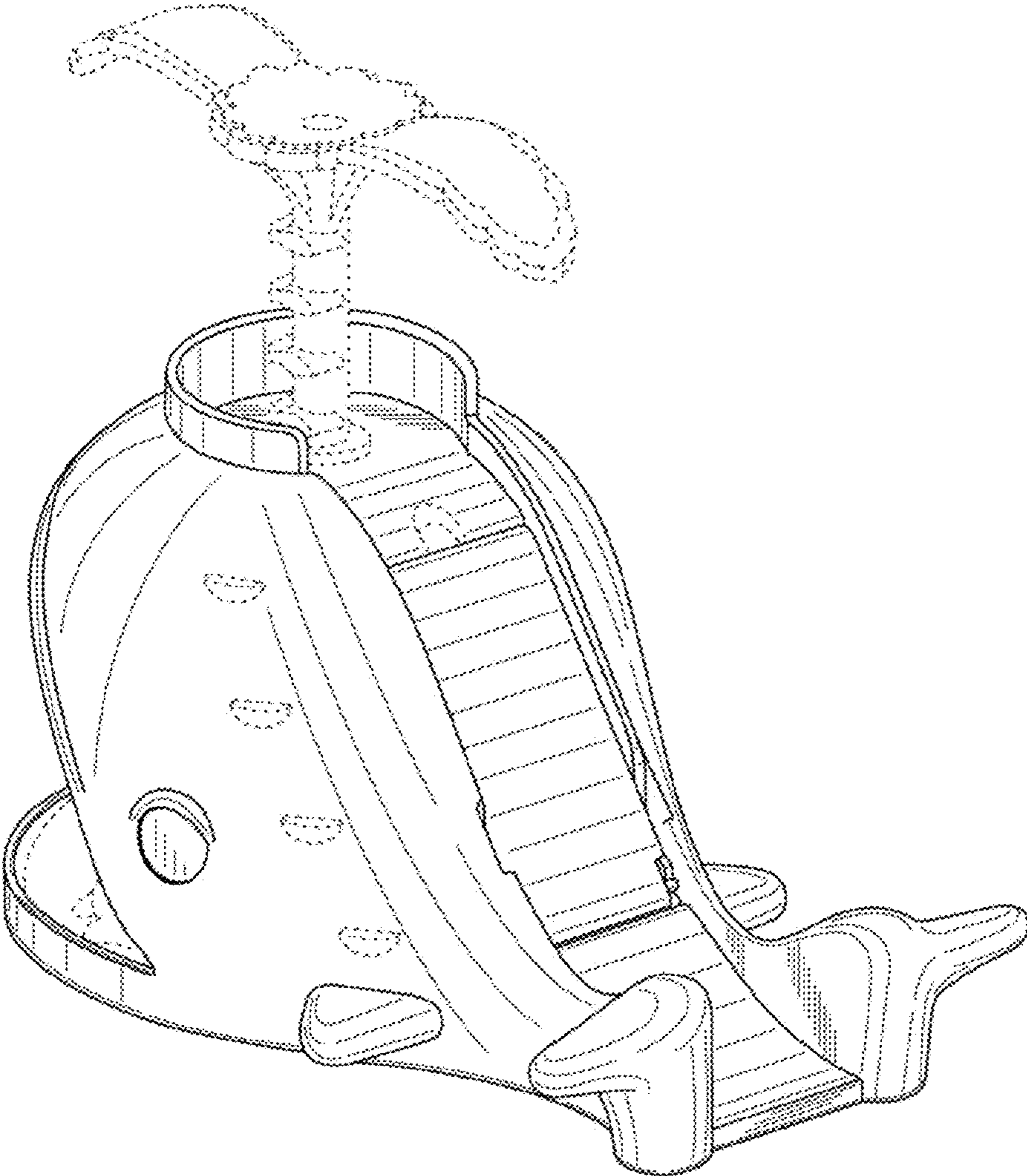

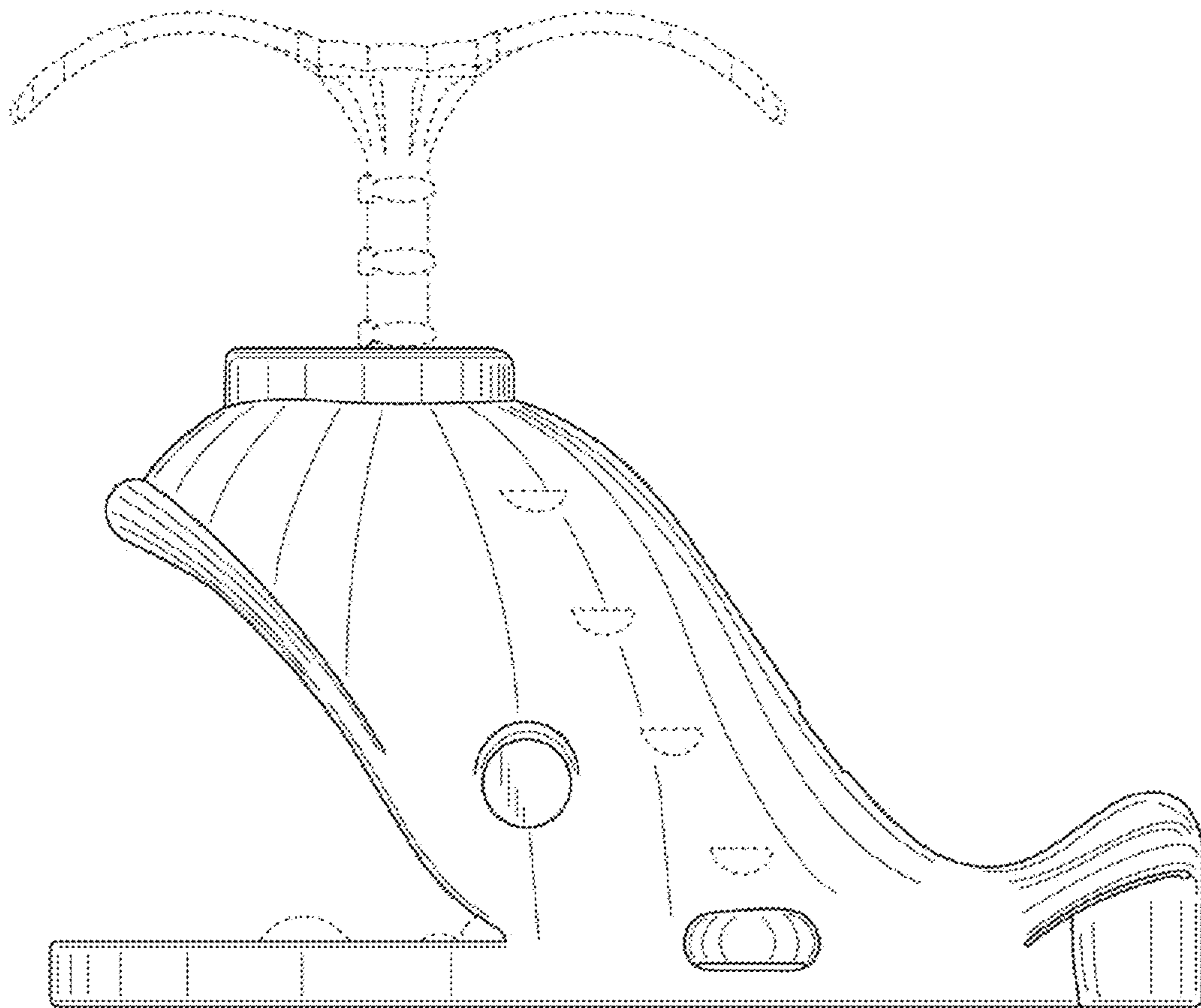

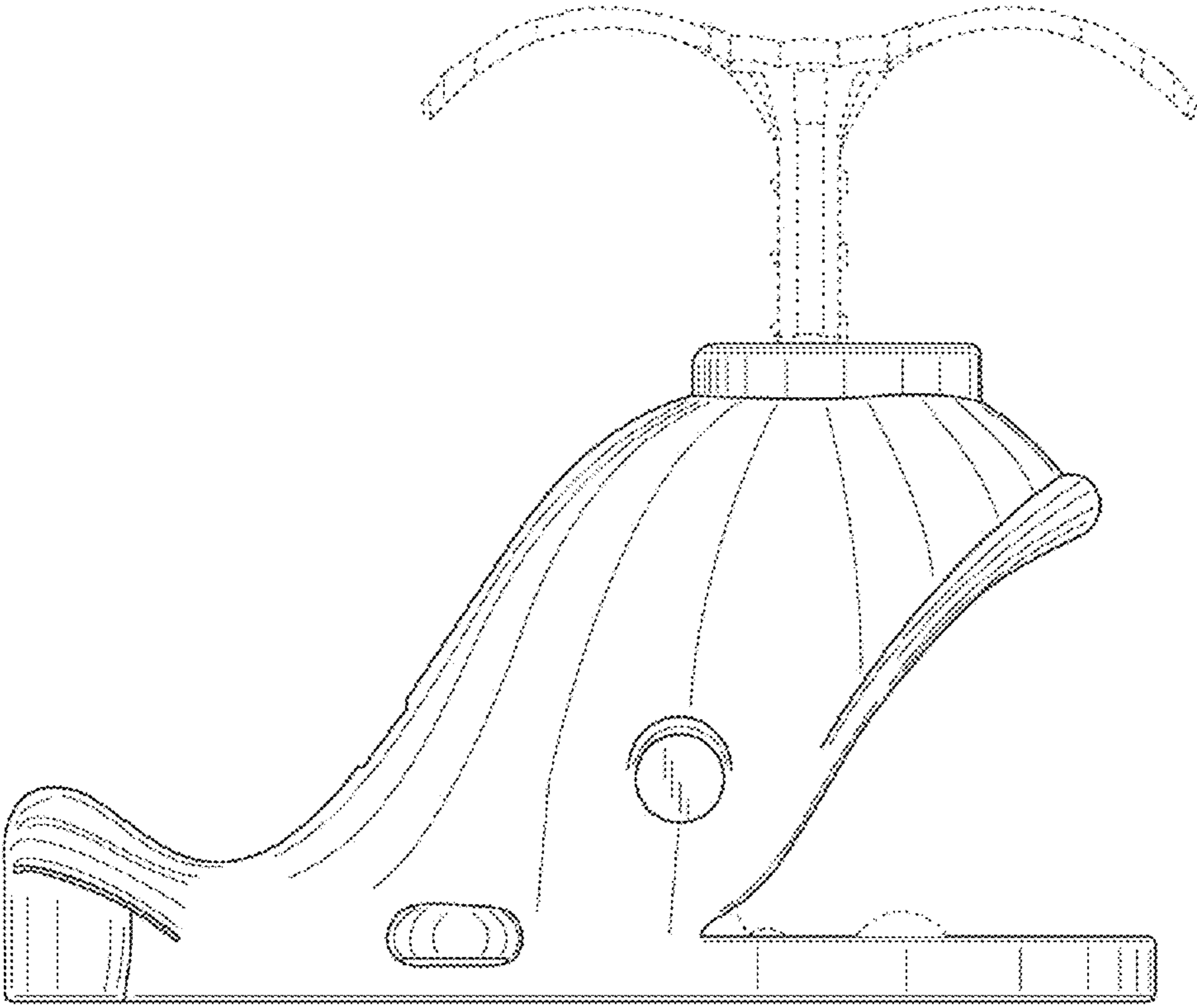




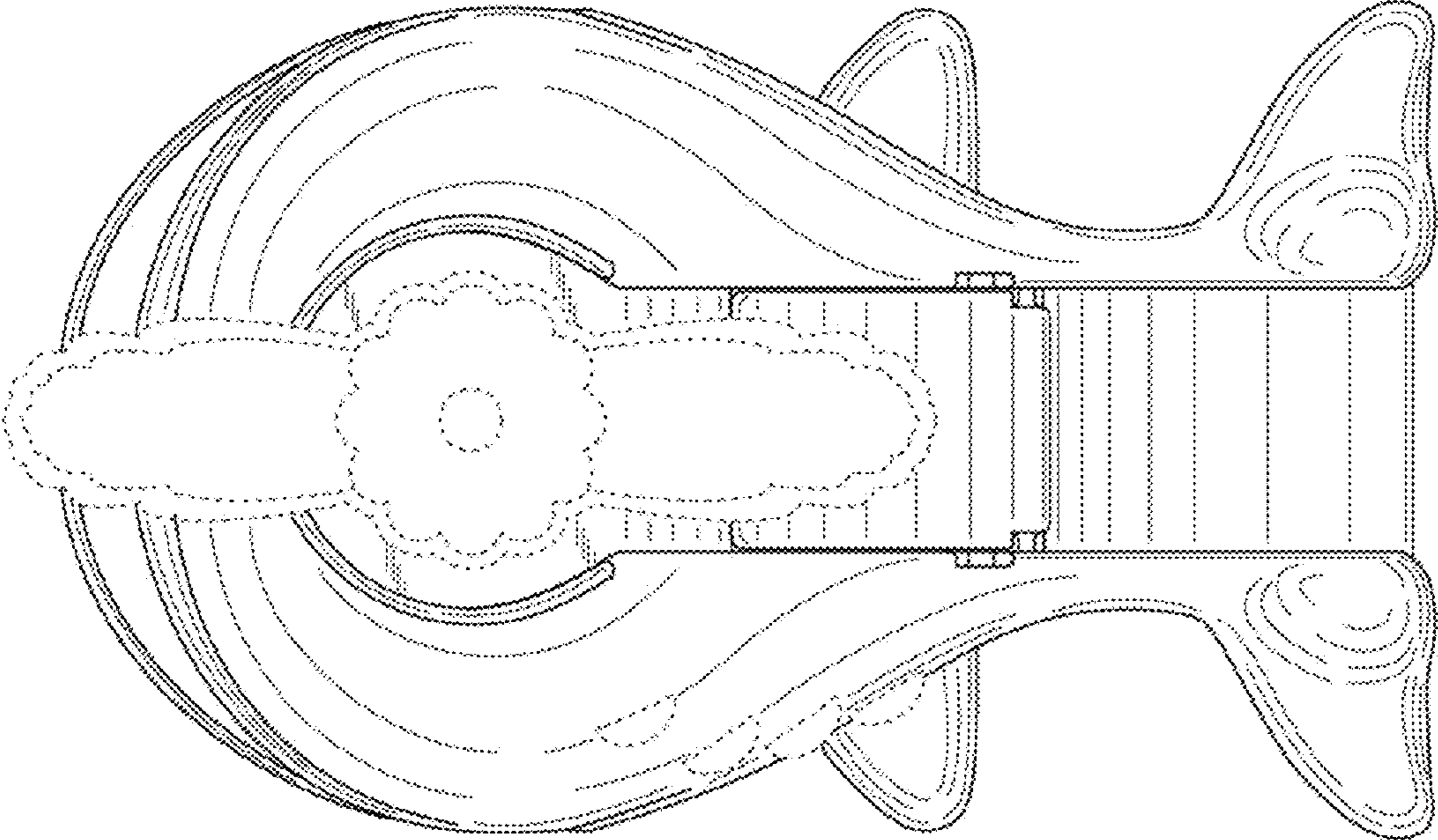

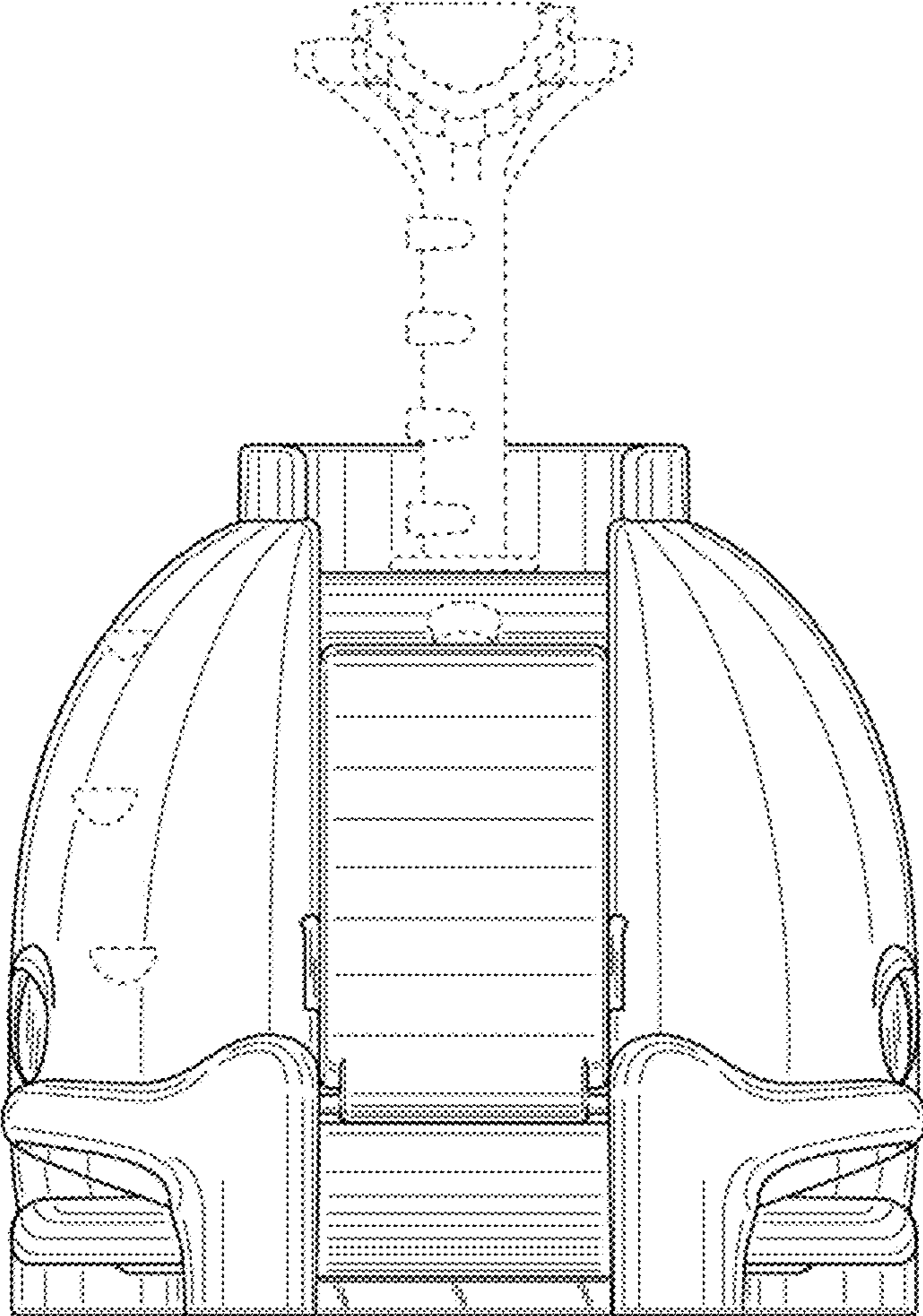

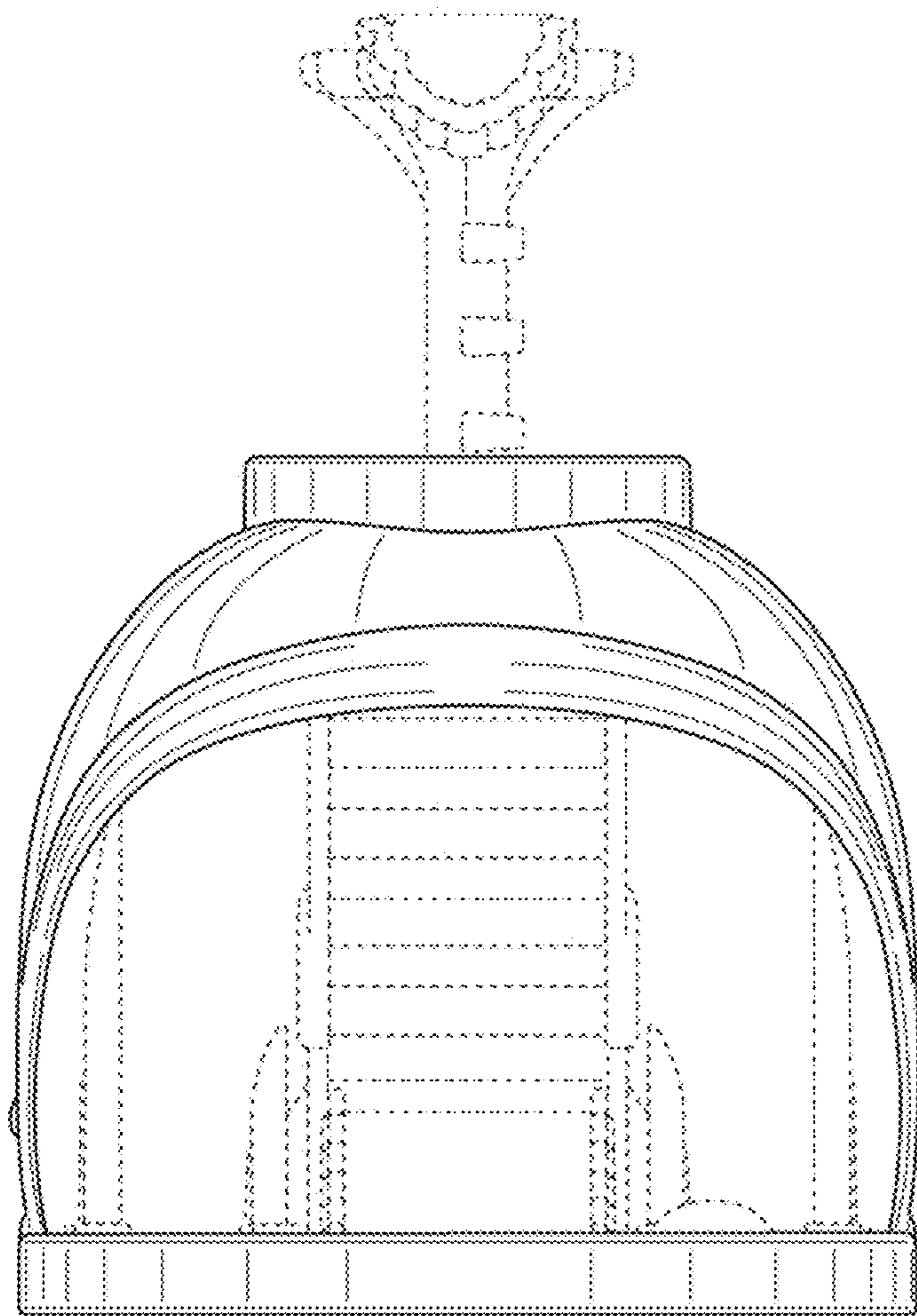
