**DESCRIPTION**

FIG. 1 is a front, right side, perspective view of a wall mounted air conditioner showing our new design;

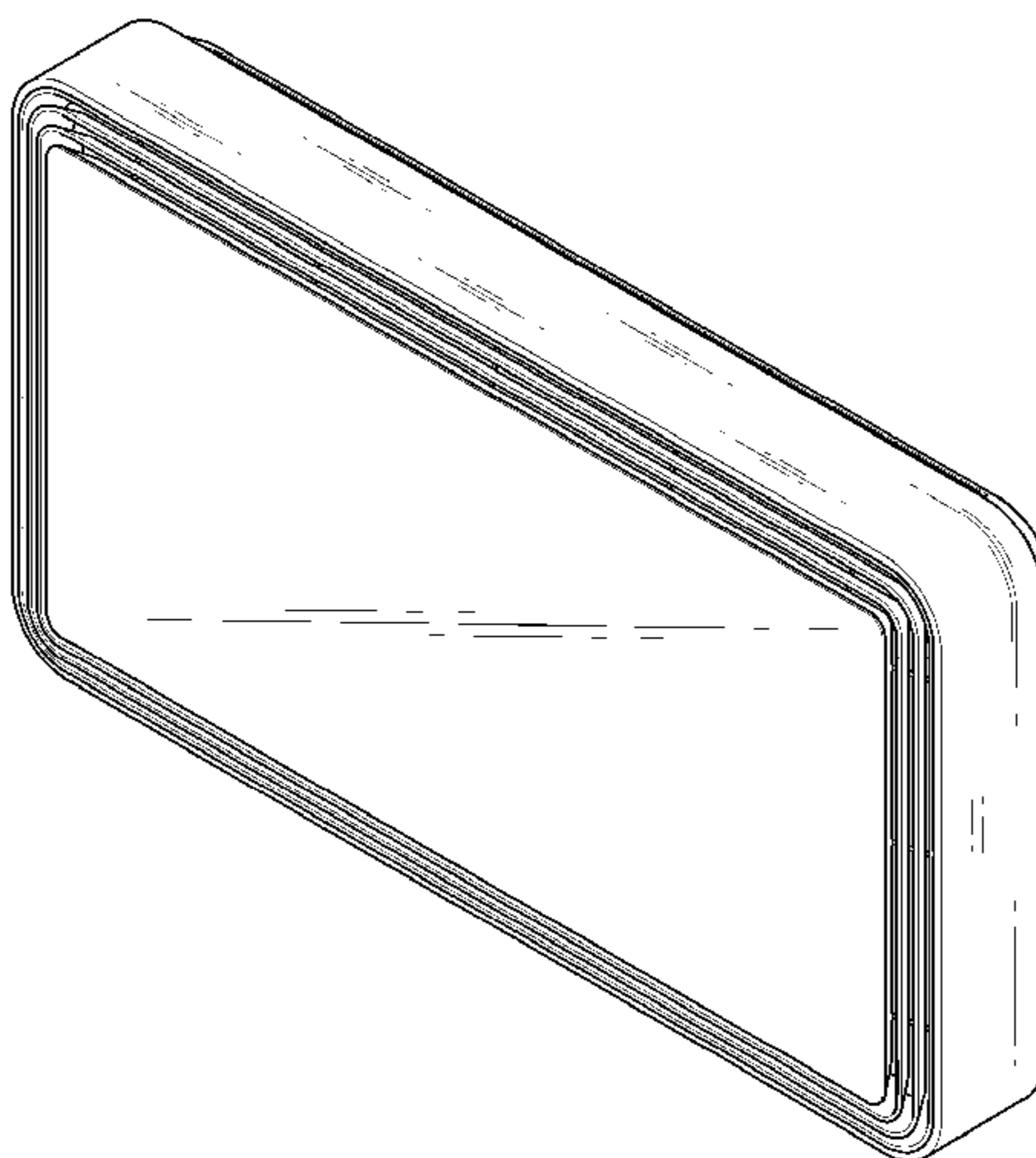

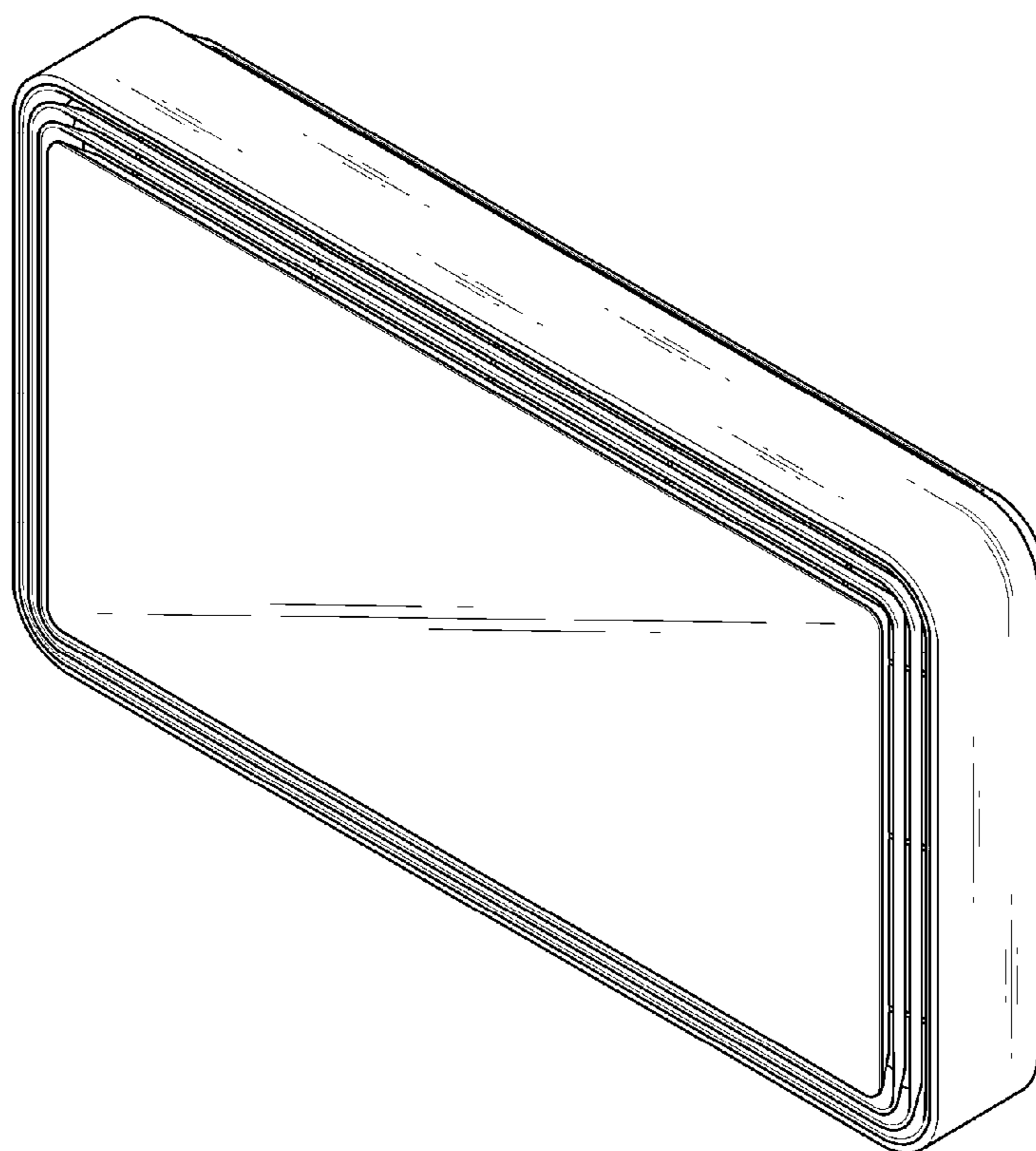

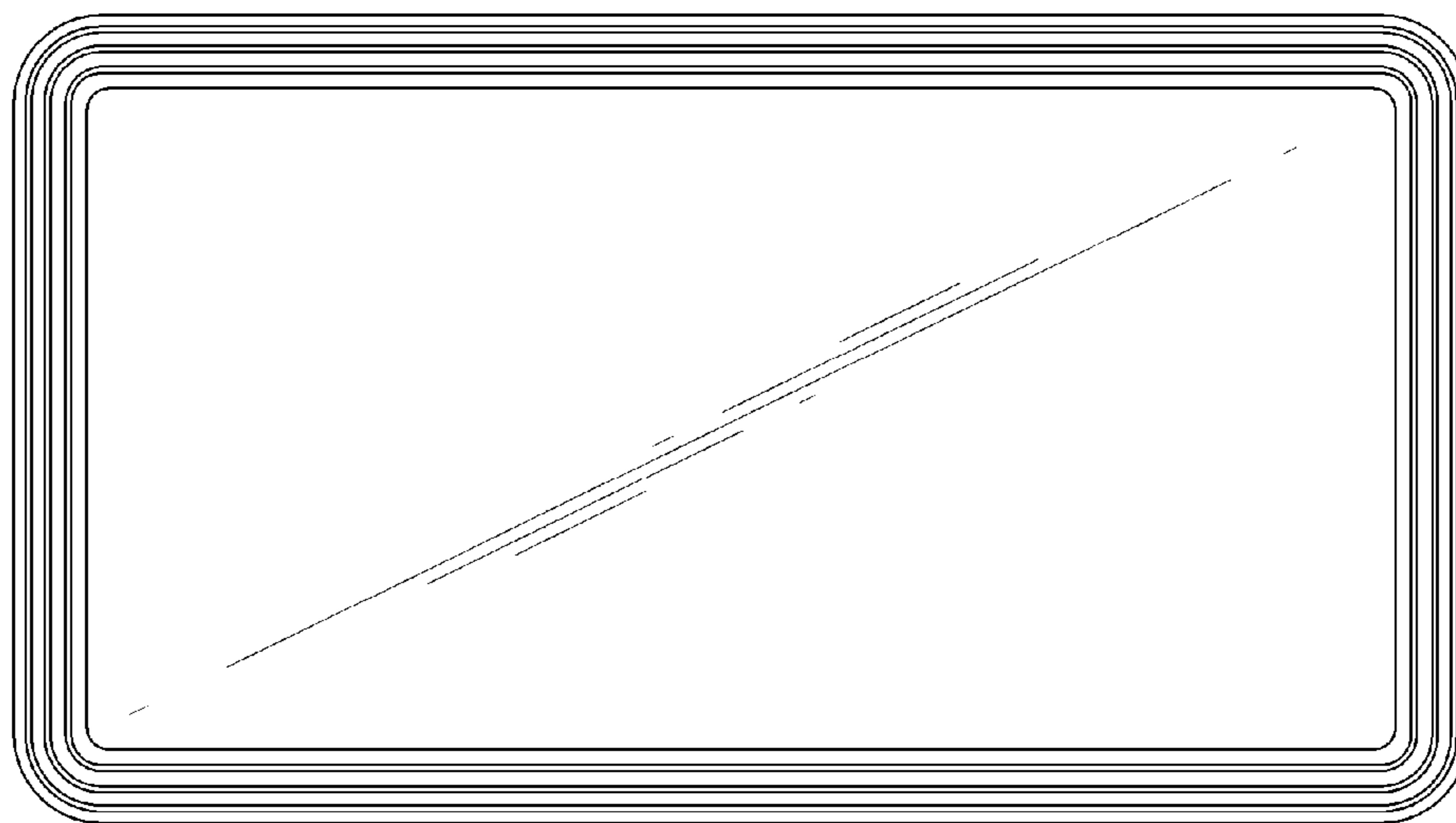

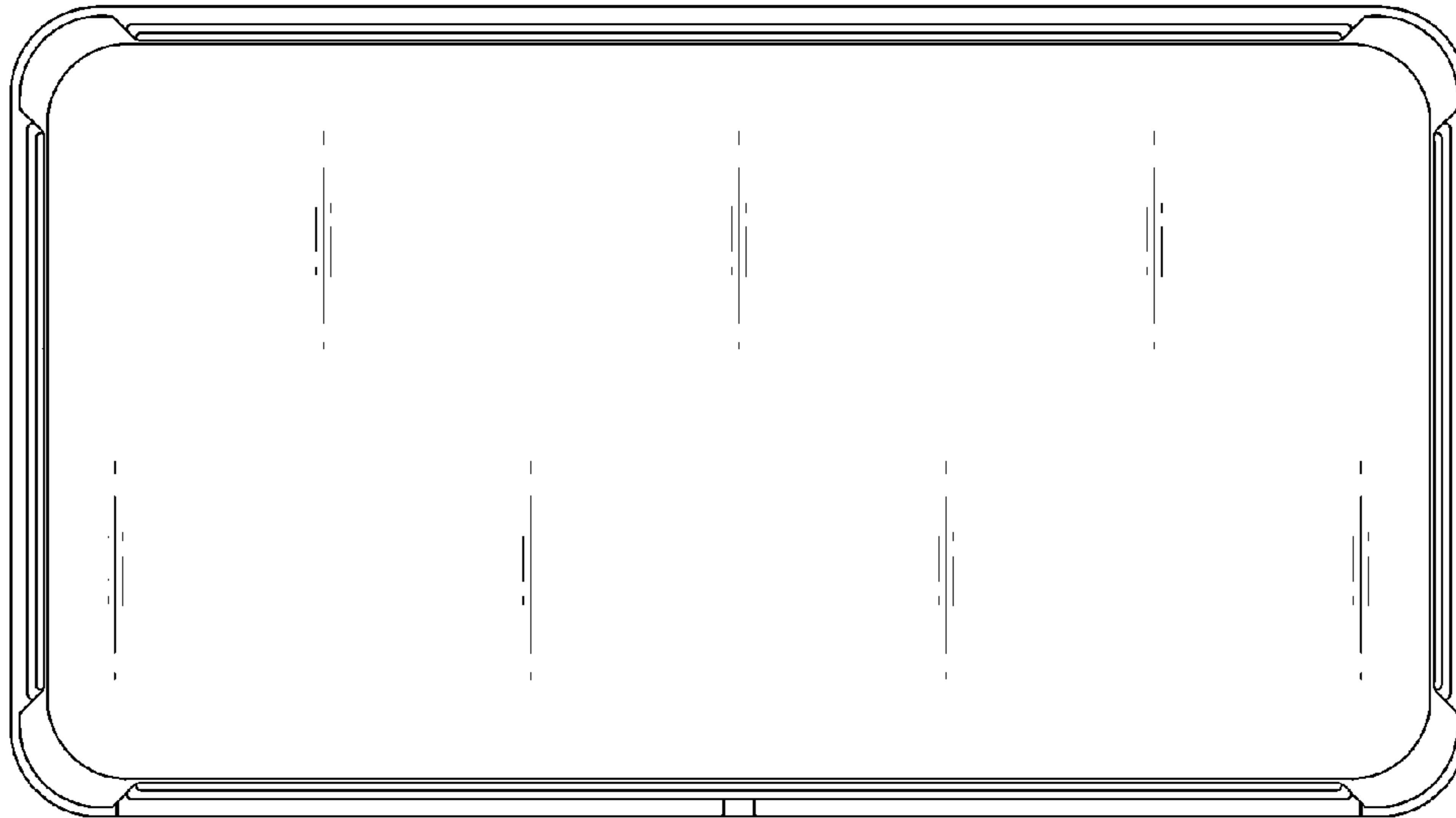

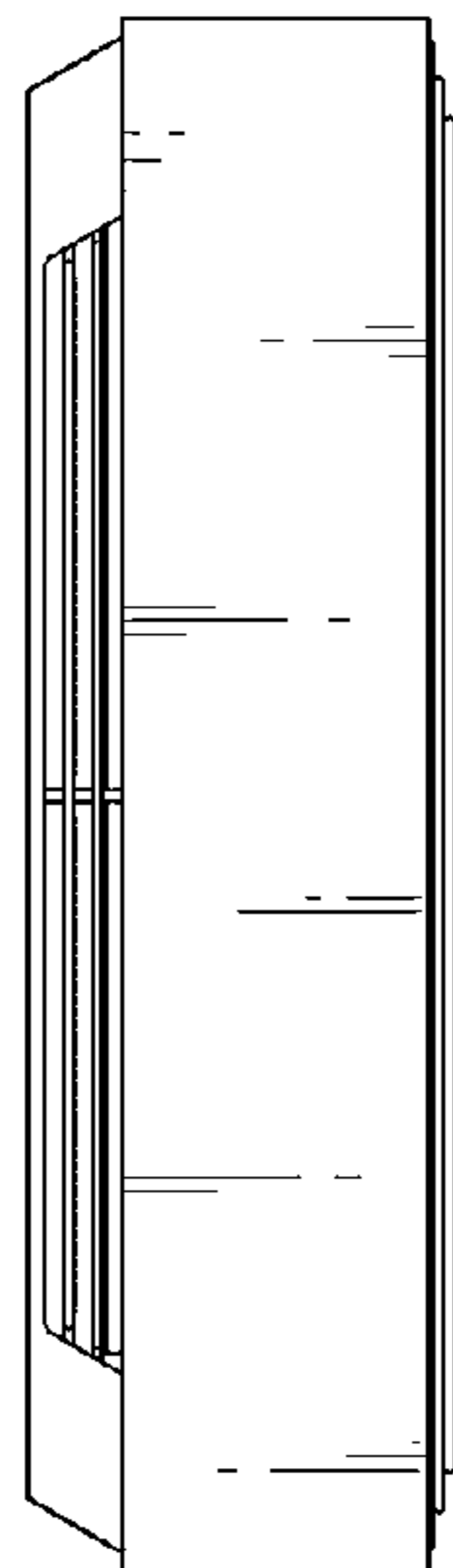

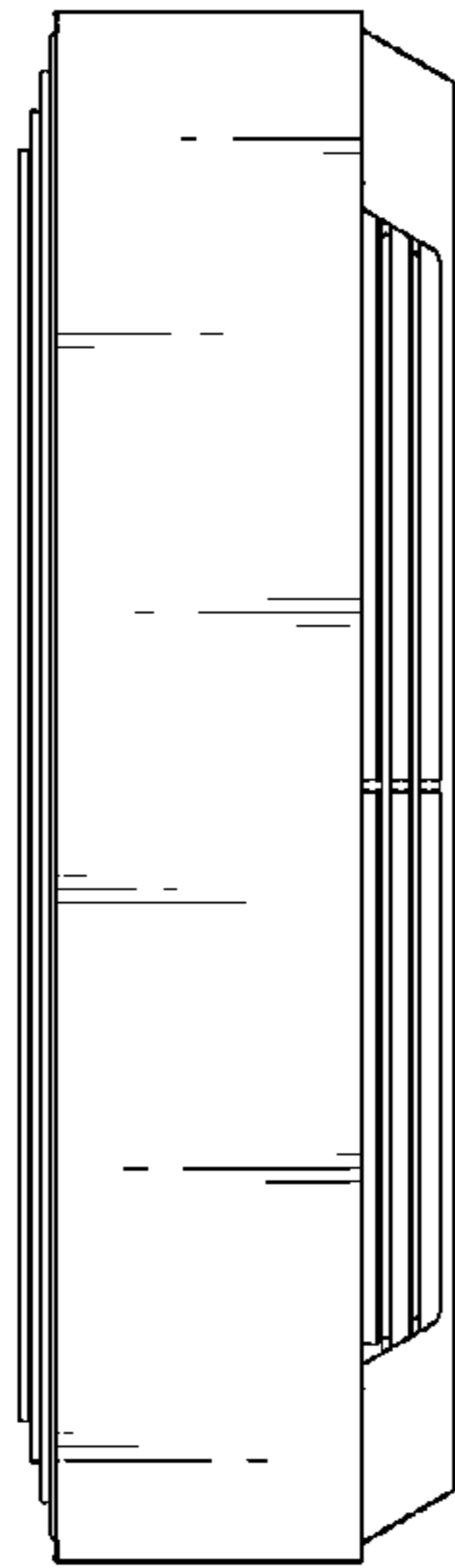

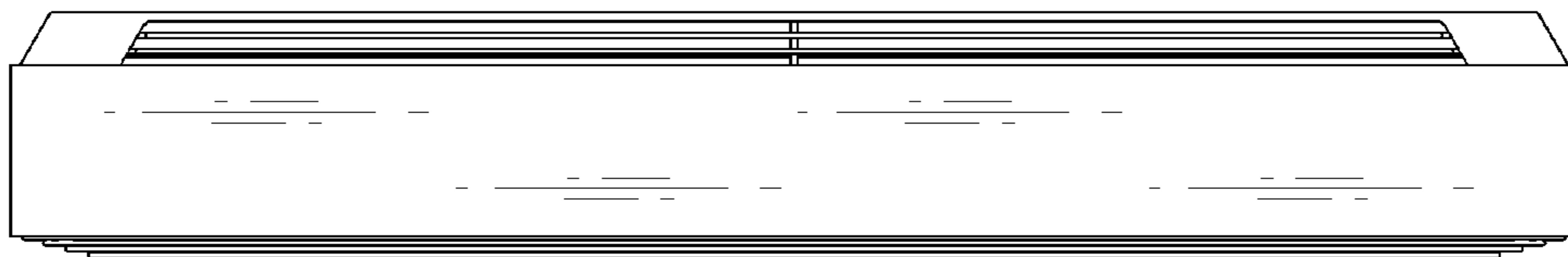
