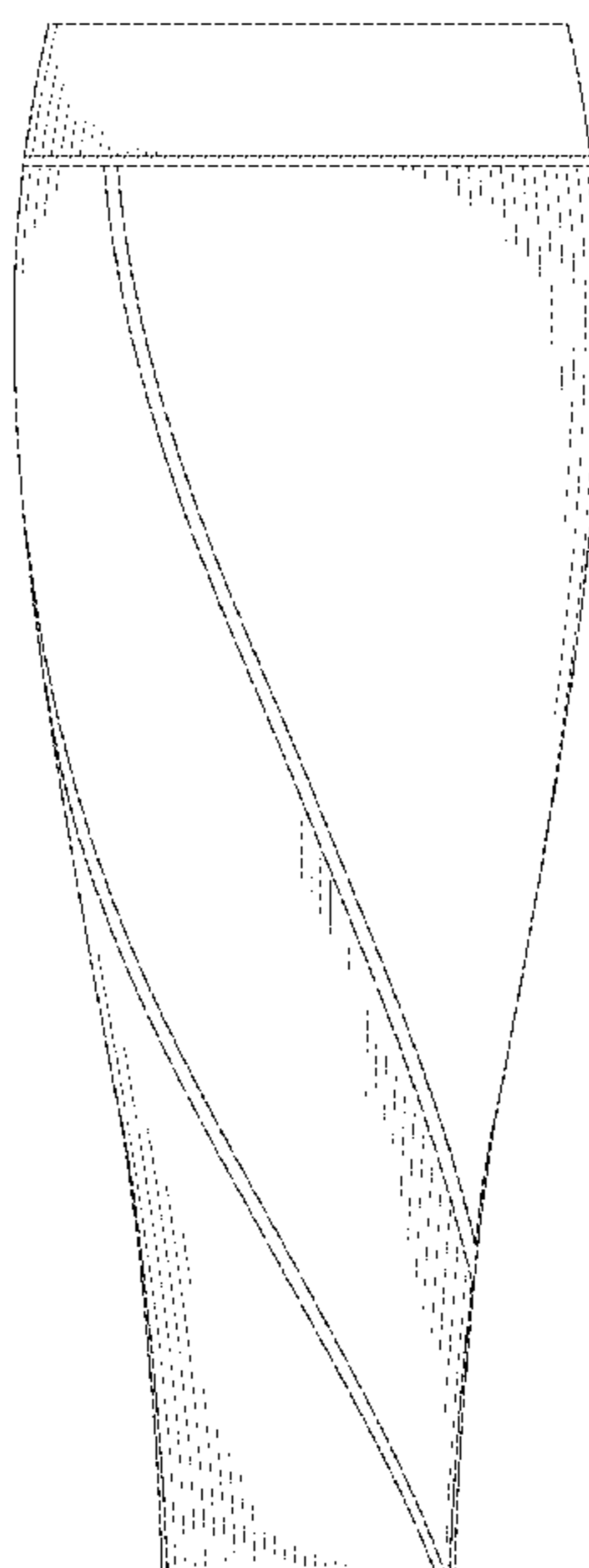

DESCRIPTION

FIG. 1 is a front view of a calf supporter of the present invention.

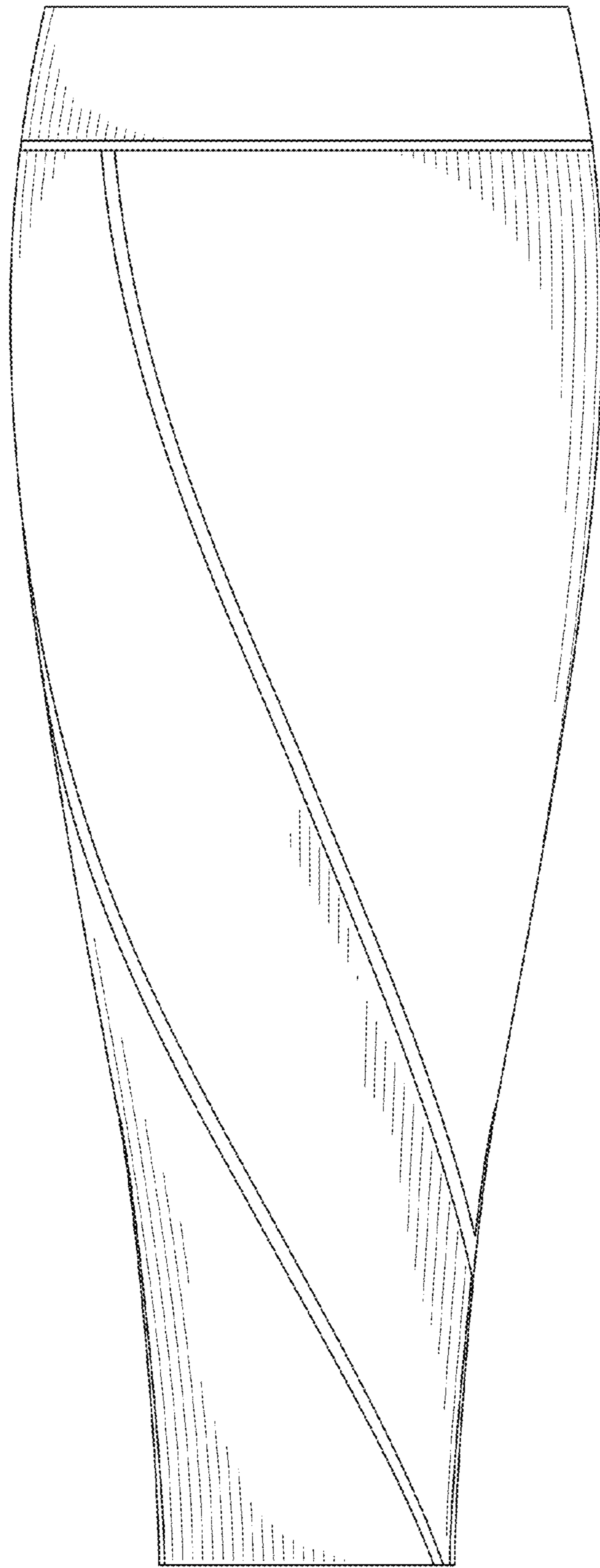

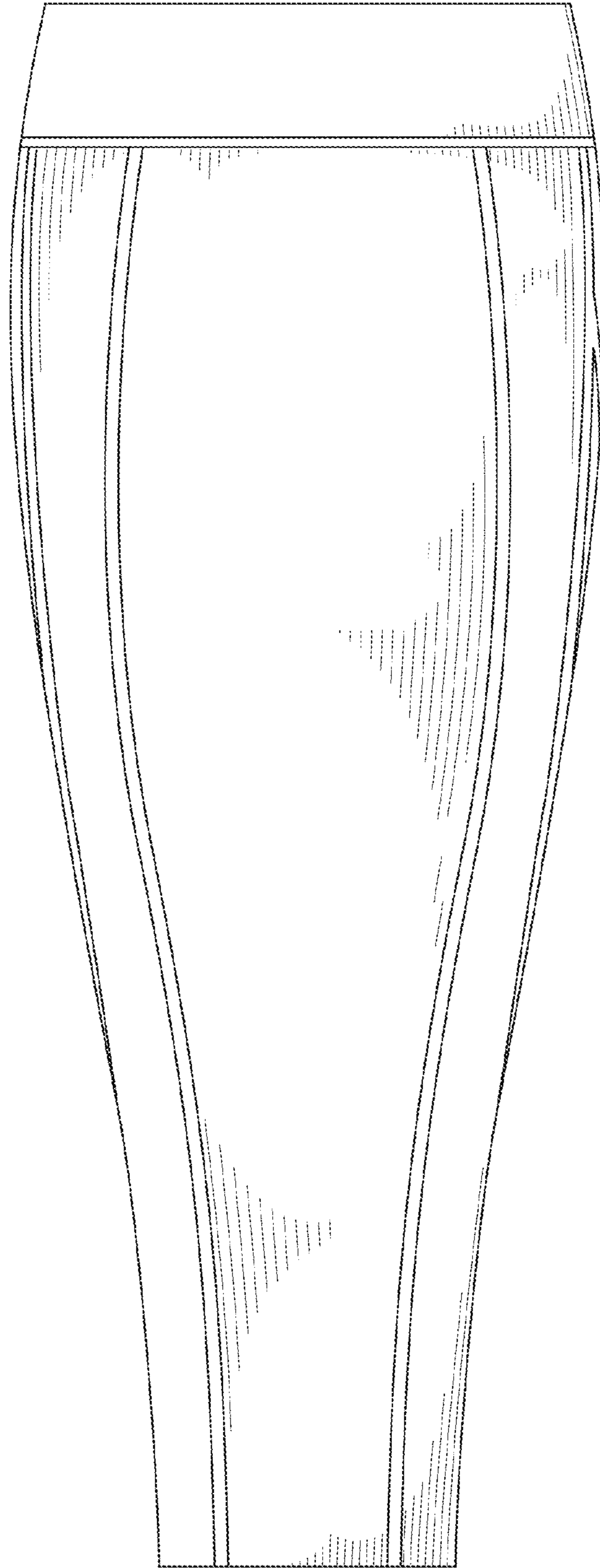

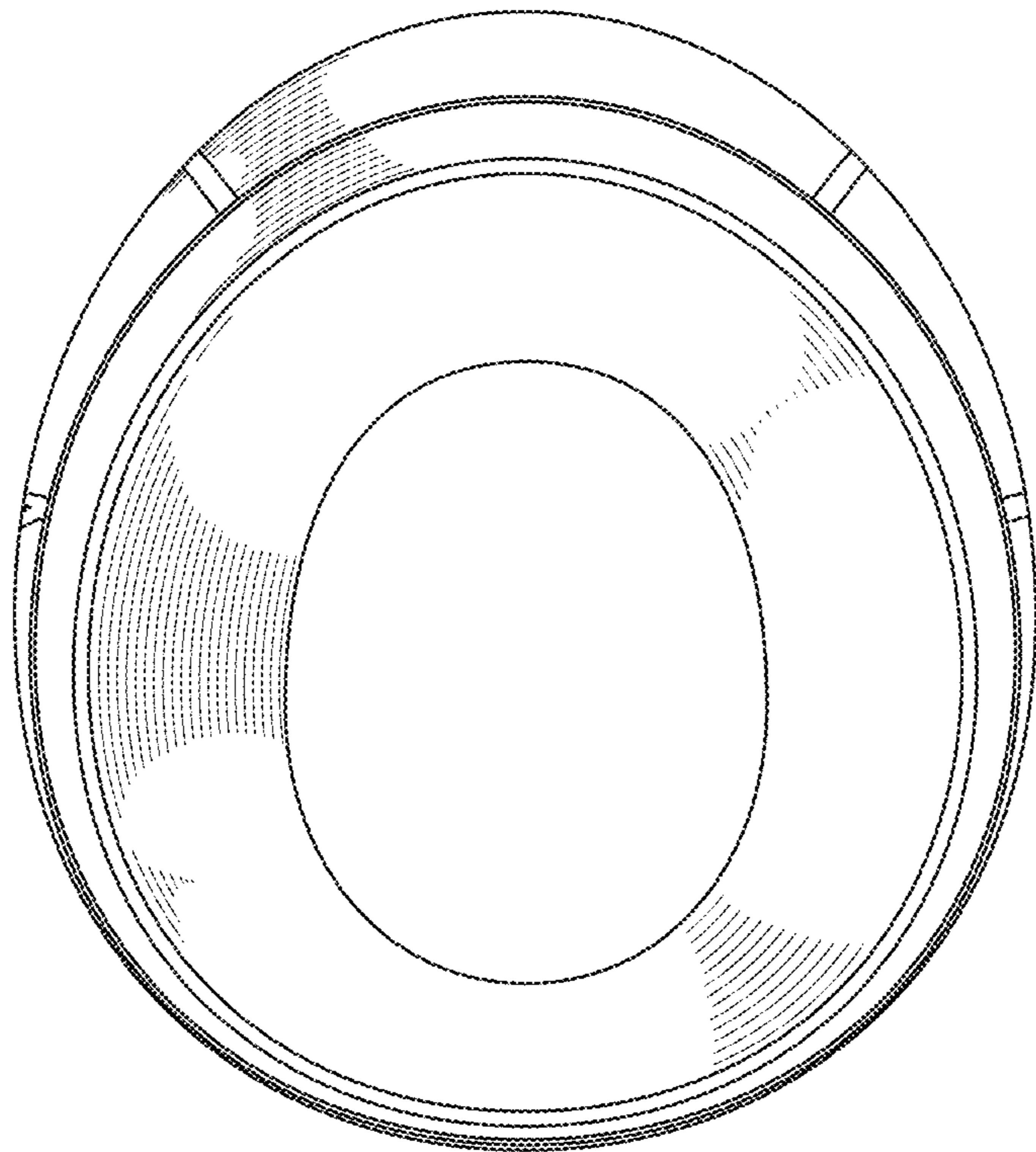

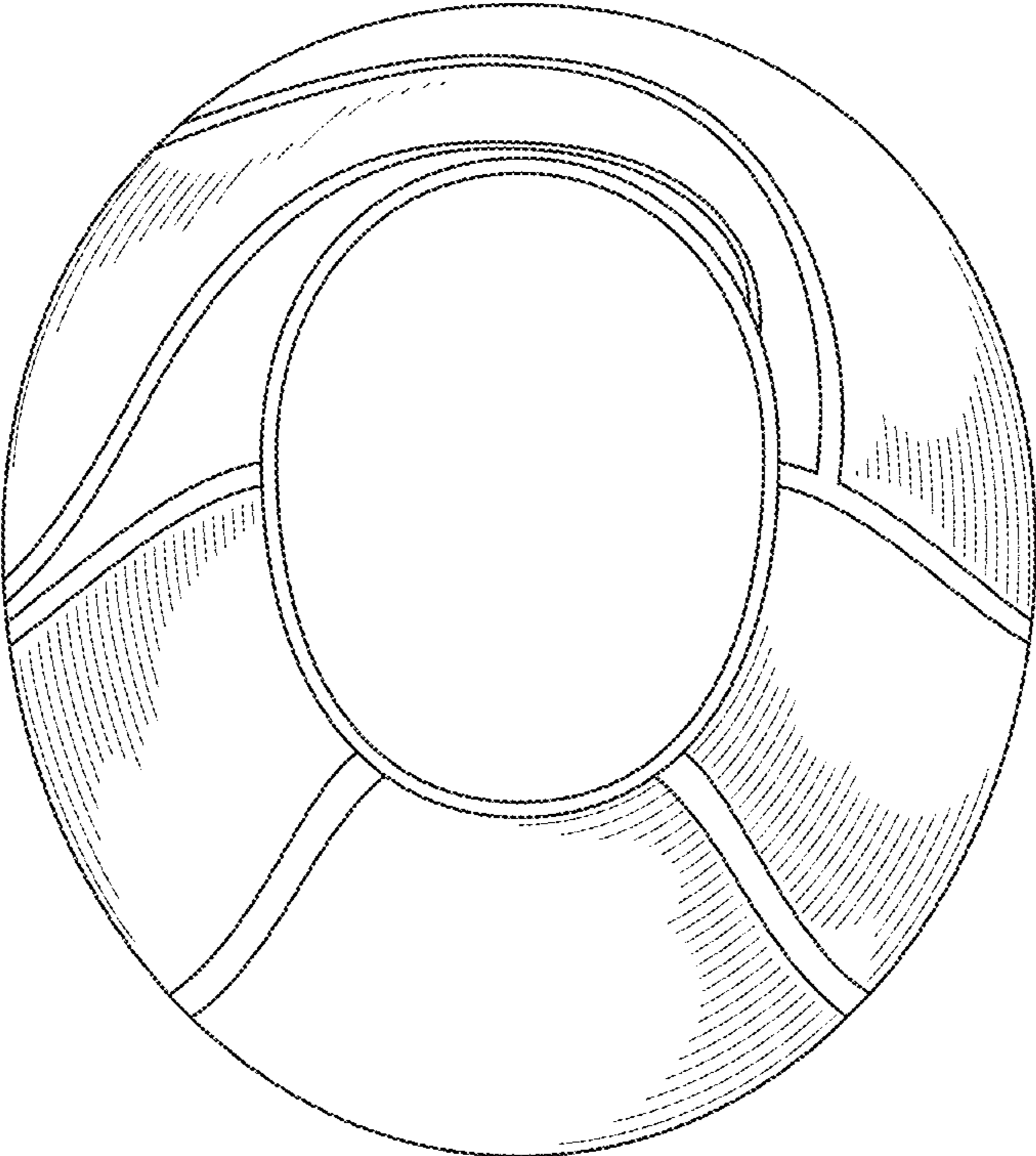

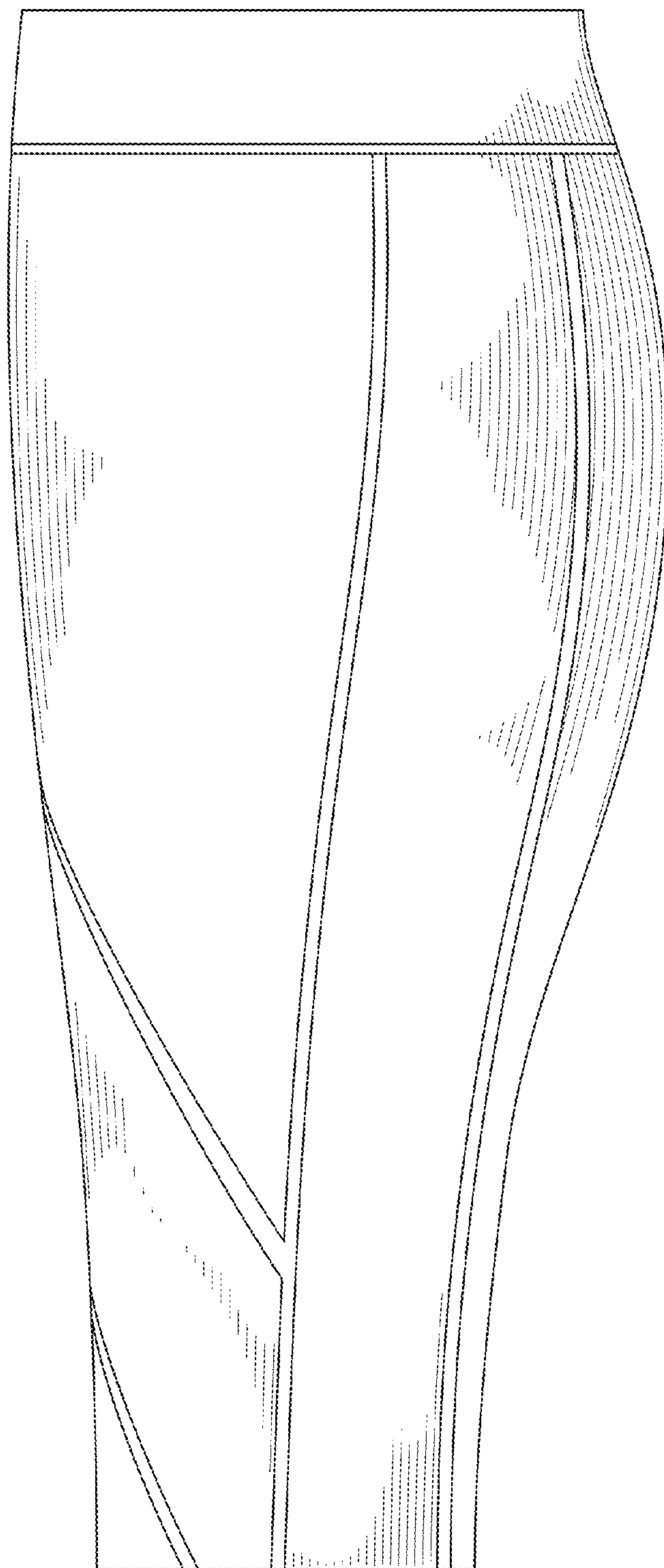

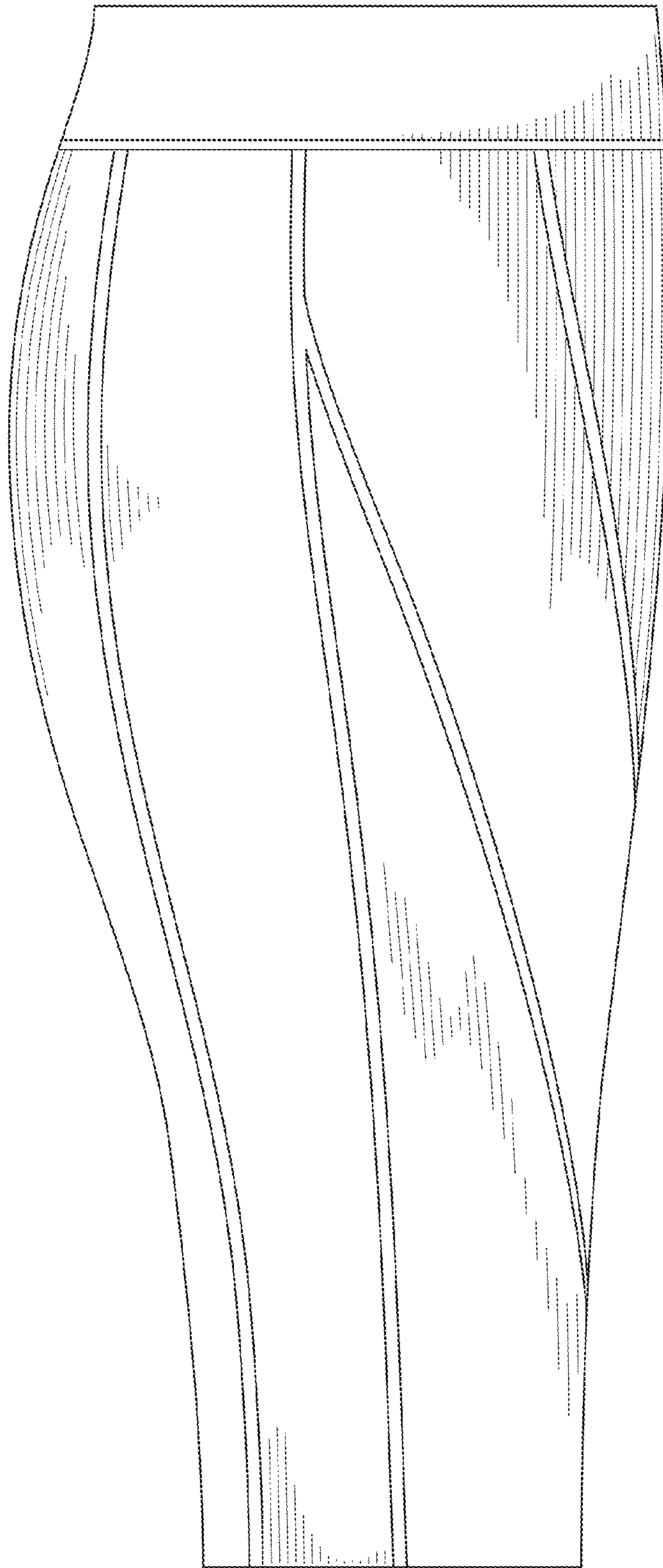

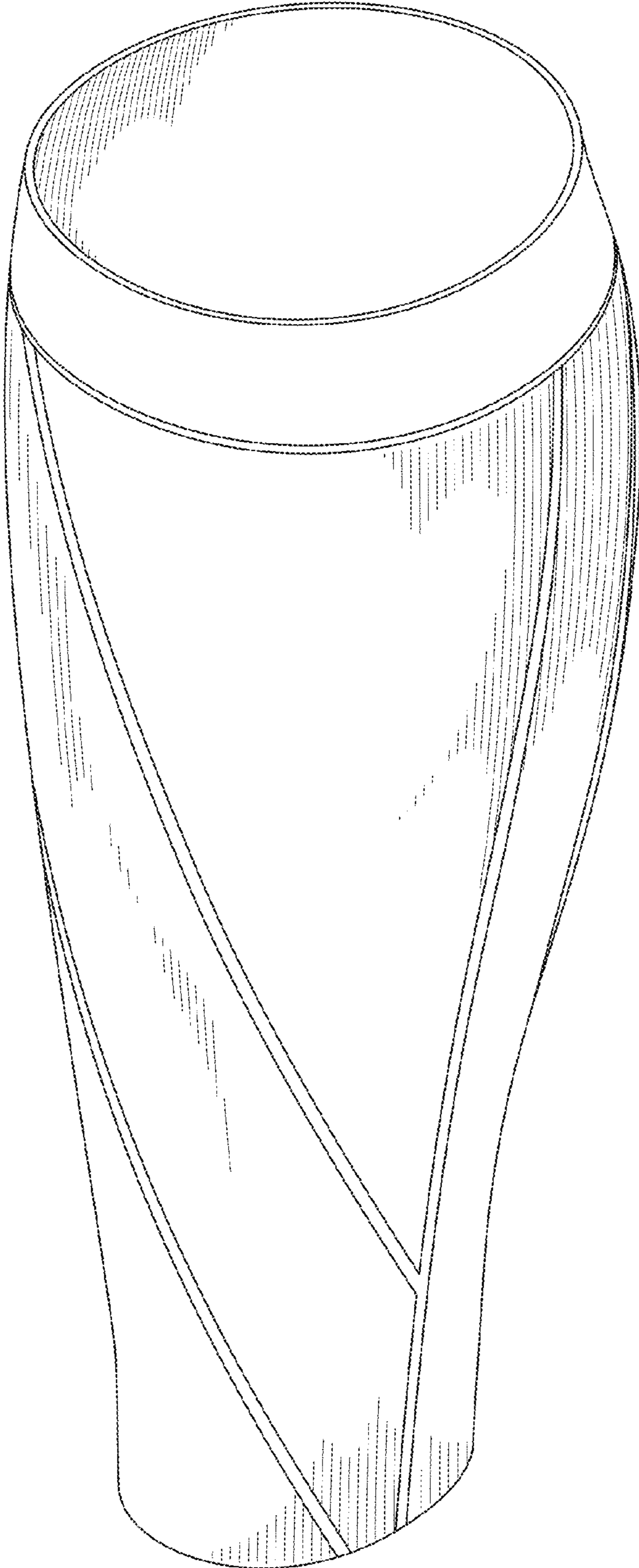

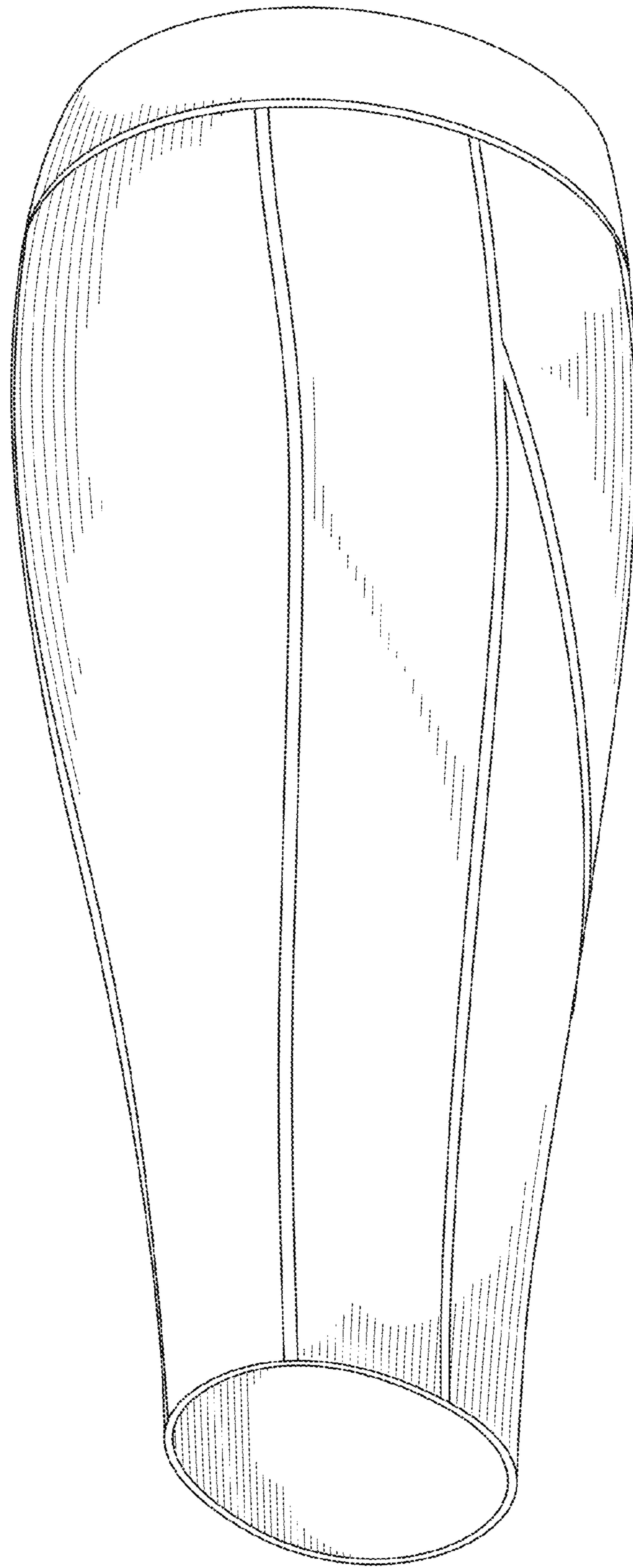

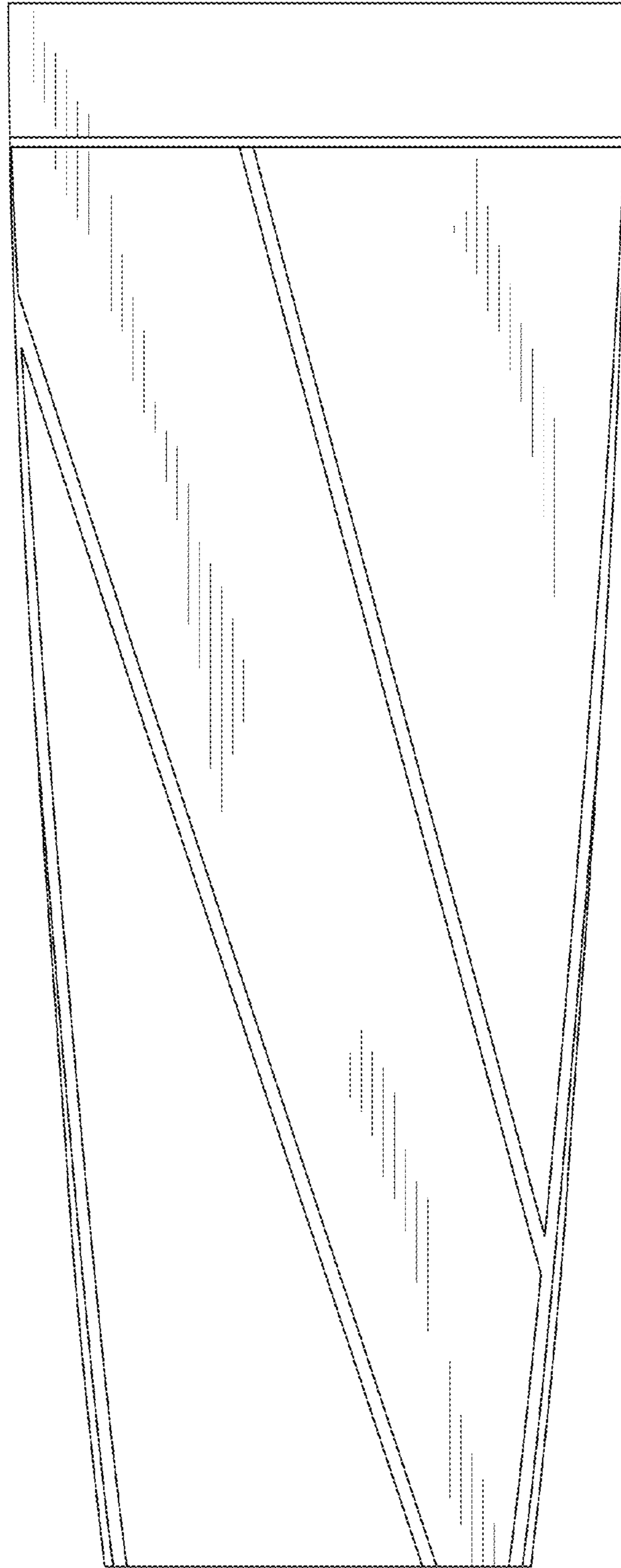

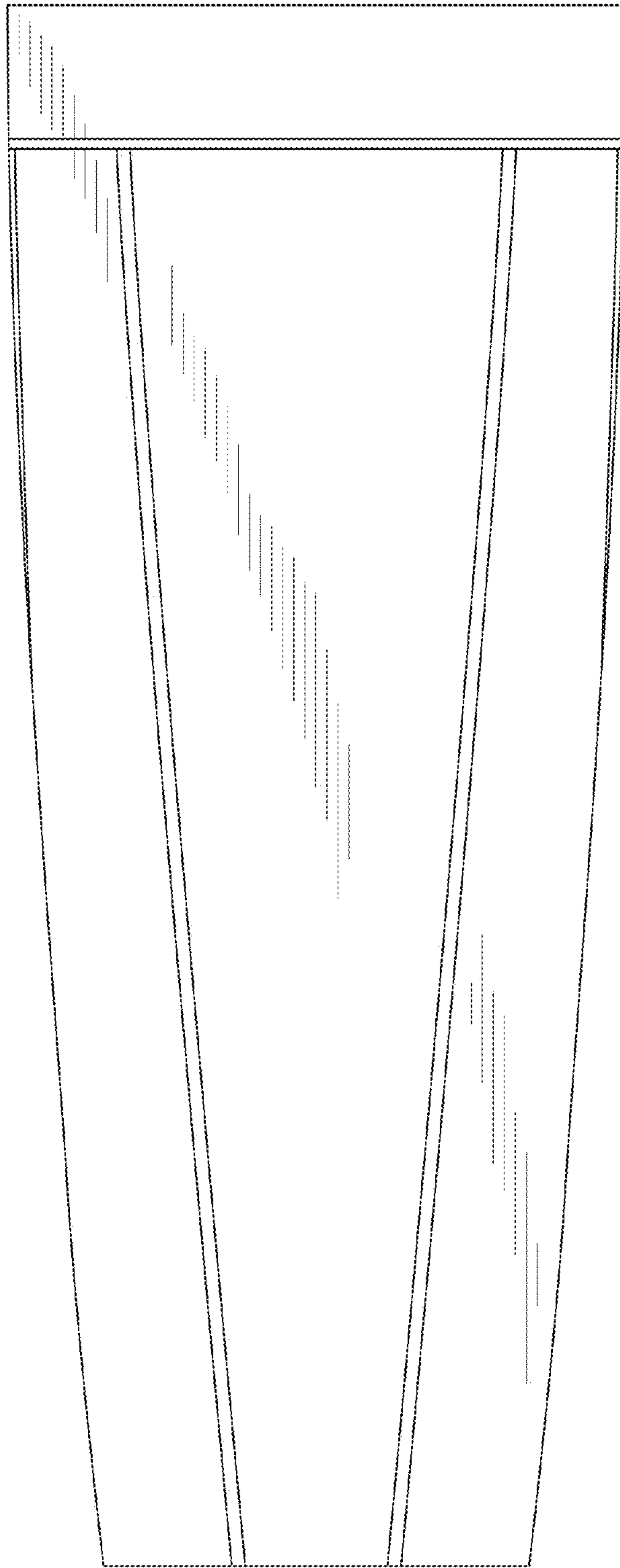
