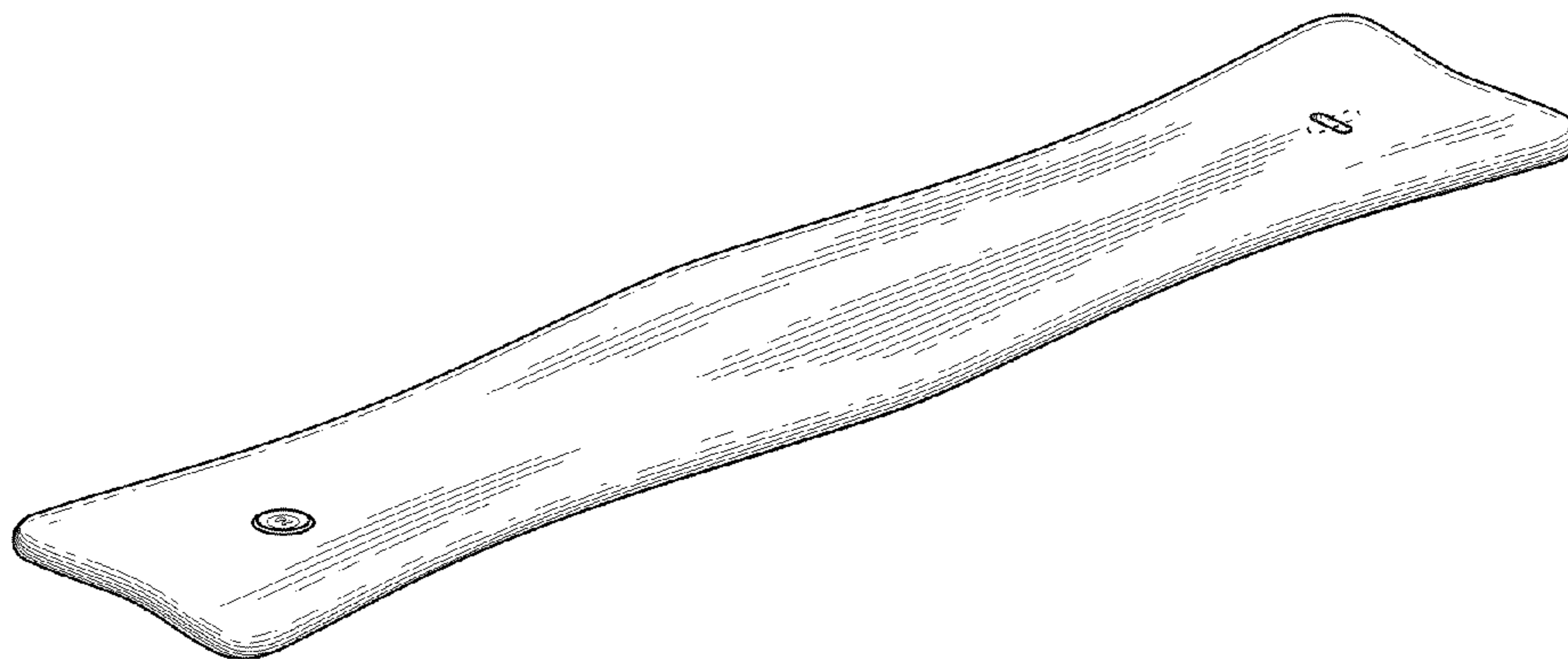
(57) **CLAIM**

The ornamental design for a night scarf, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing my new night scarf;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a back view thereof;
FIG. 6 is a left side view thereof, the right side view thereof being a mirror image of that which is shown; and,

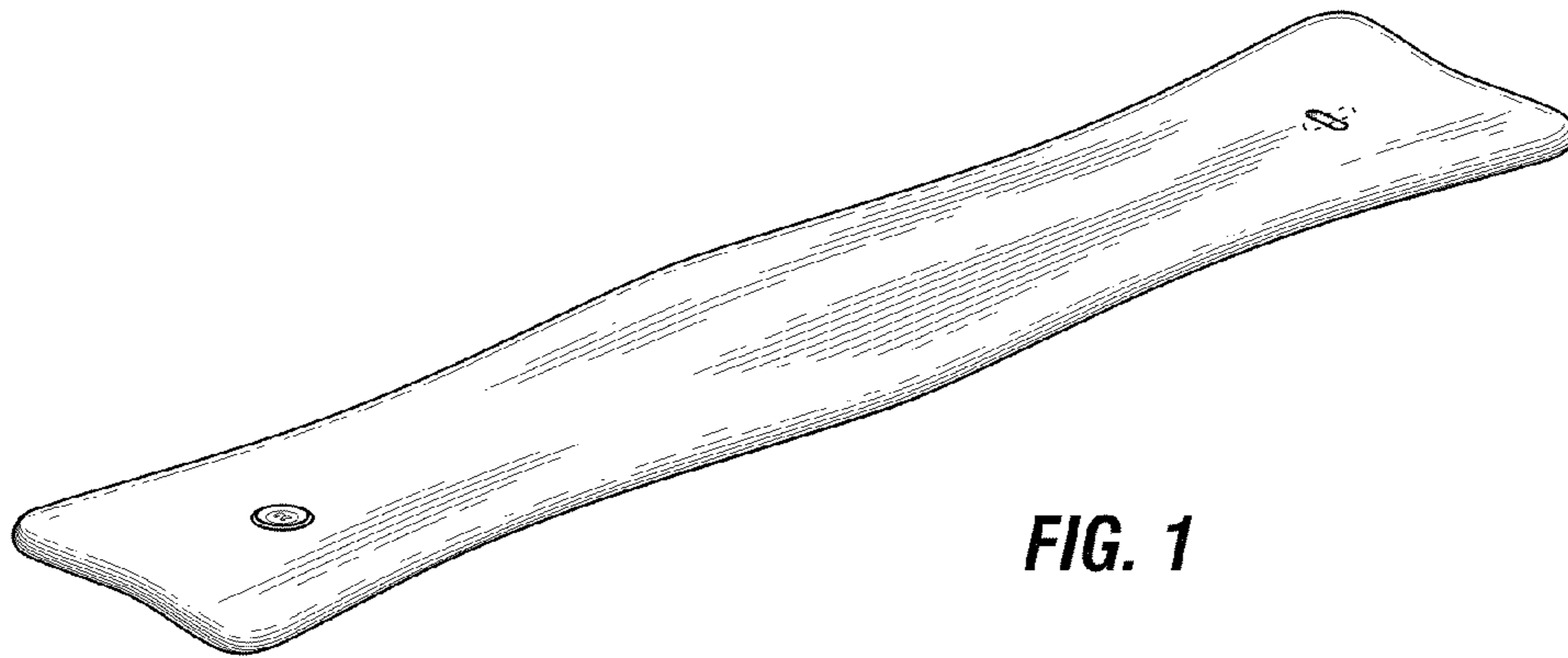

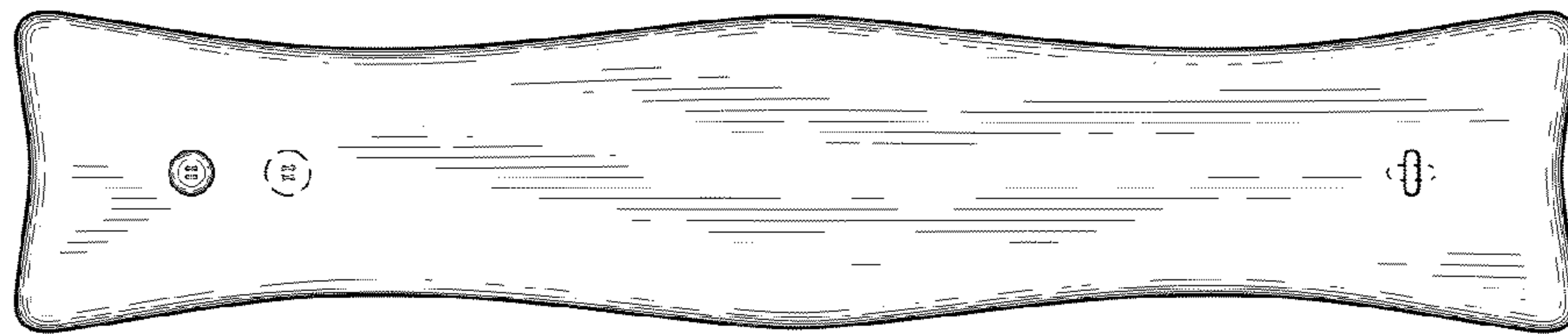

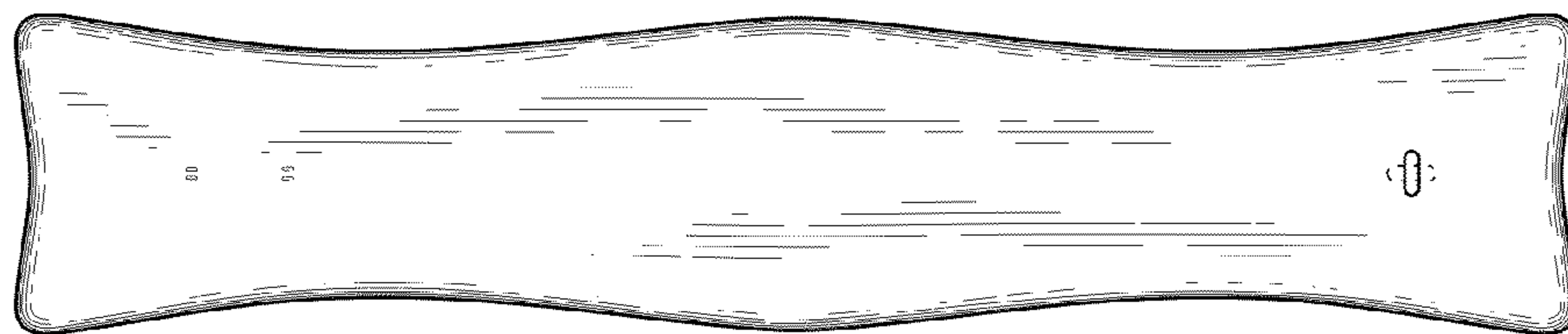

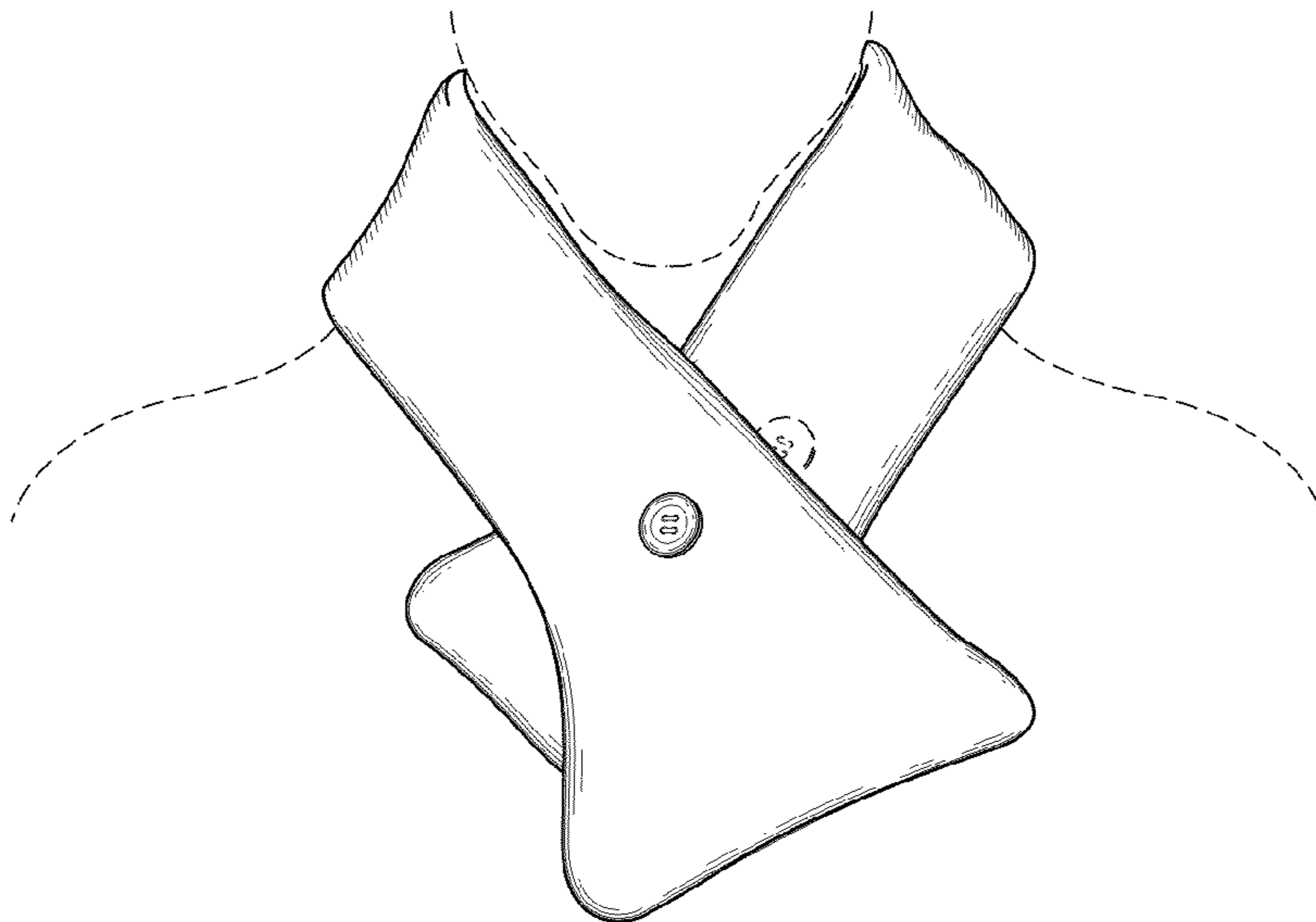
