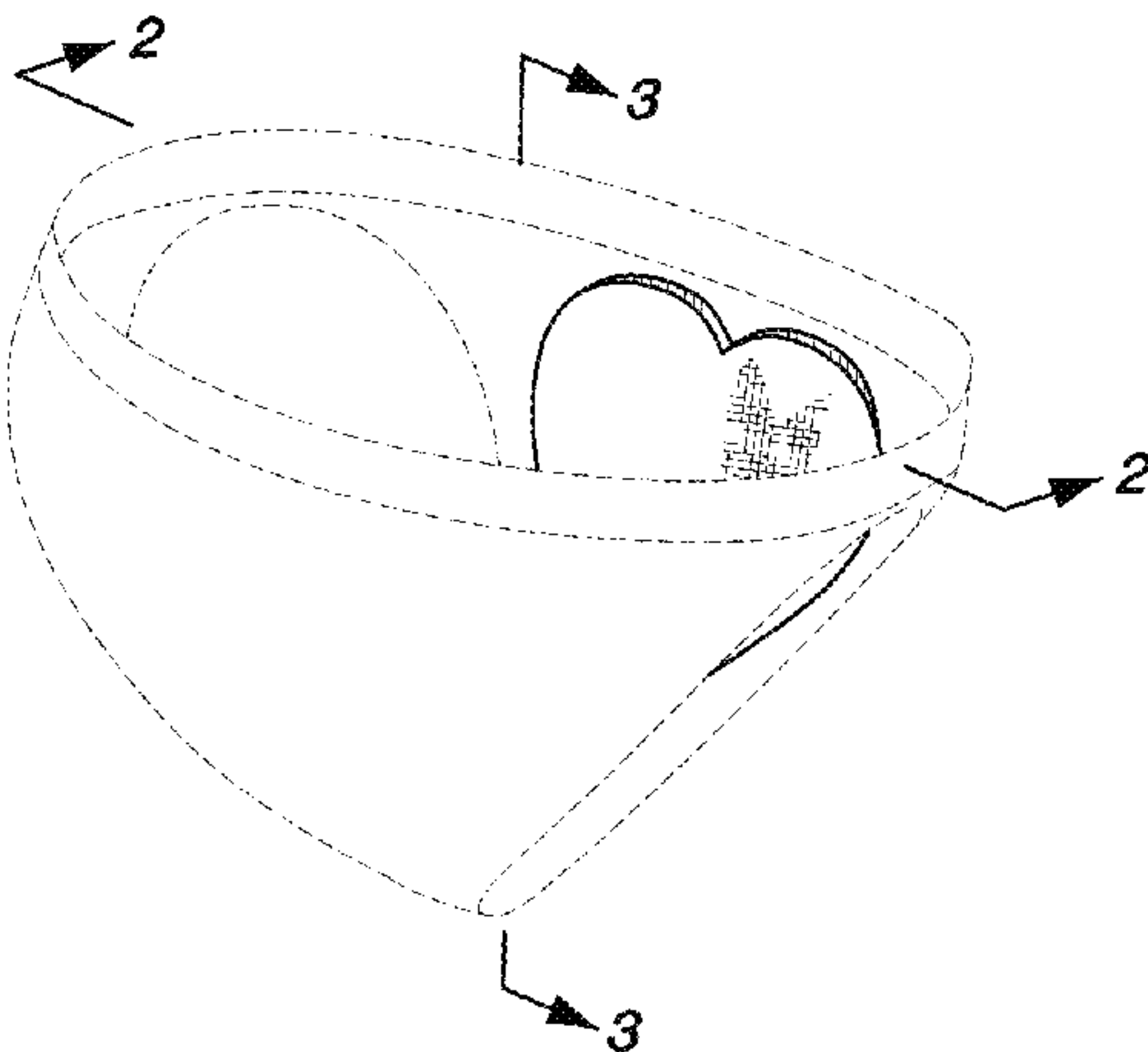
(57) **CLAIM**

The ornamental design for a pocket for the interior of an undergarment, as shown and described.

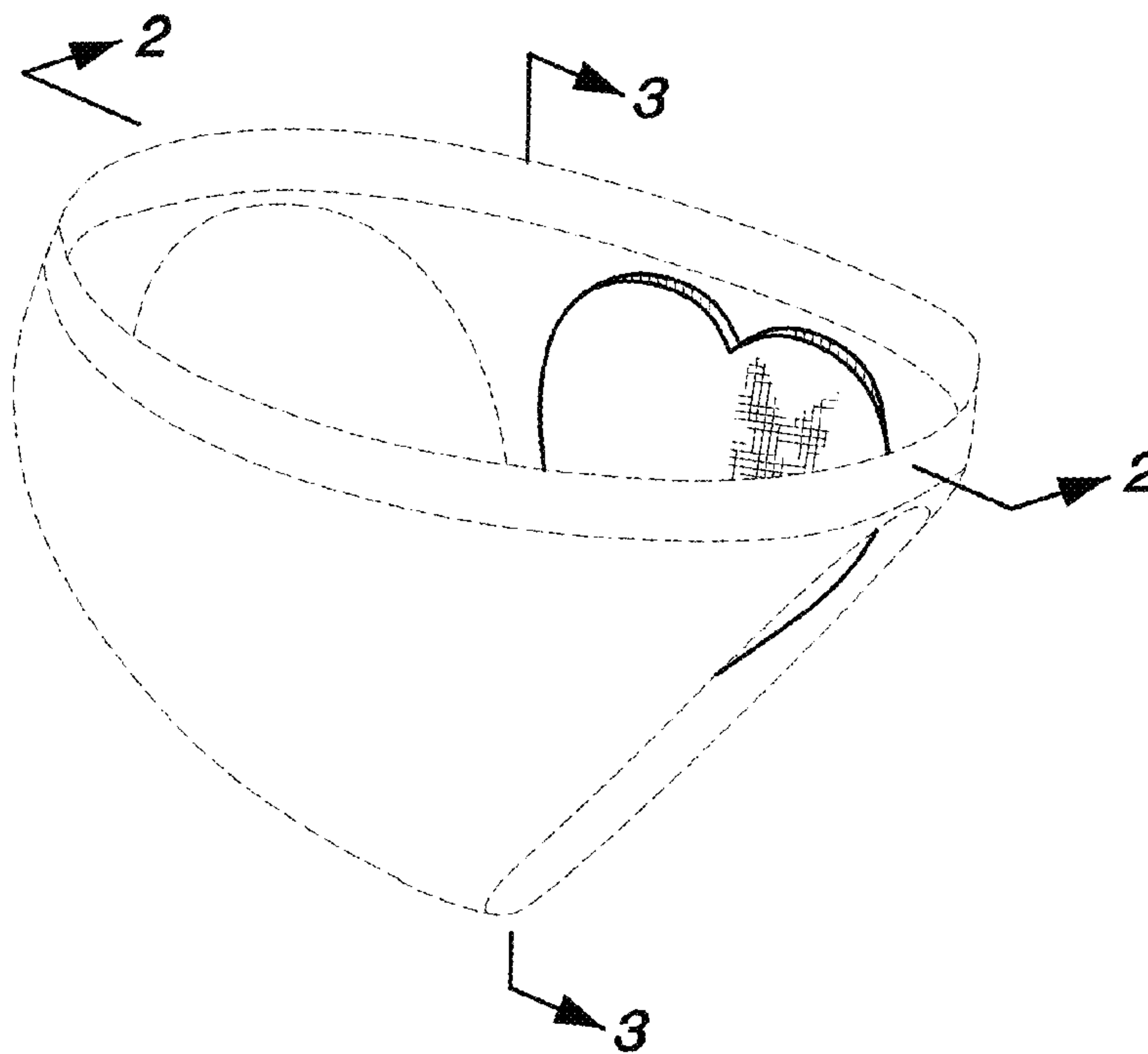
**DESCRIPTION**

FIG. 1 is a top perspective view of a pocket for the interior of an undergarment, with the remainder of the undergarment illustrated in phantom;  
FIG. 2 is a cross-sectional view of the pocket taken on line 2-2 in FIG. 1 thereof;  
FIG. 3 is a cross-sectional view of the pocket taken on line 3-3 in FIG. 1 thereof; and,  
FIG. 4 is a bottom view of the pocket illustrated in FIG. 1. The broken line showing is for environmental purposes only and forms no part of the claimed design.

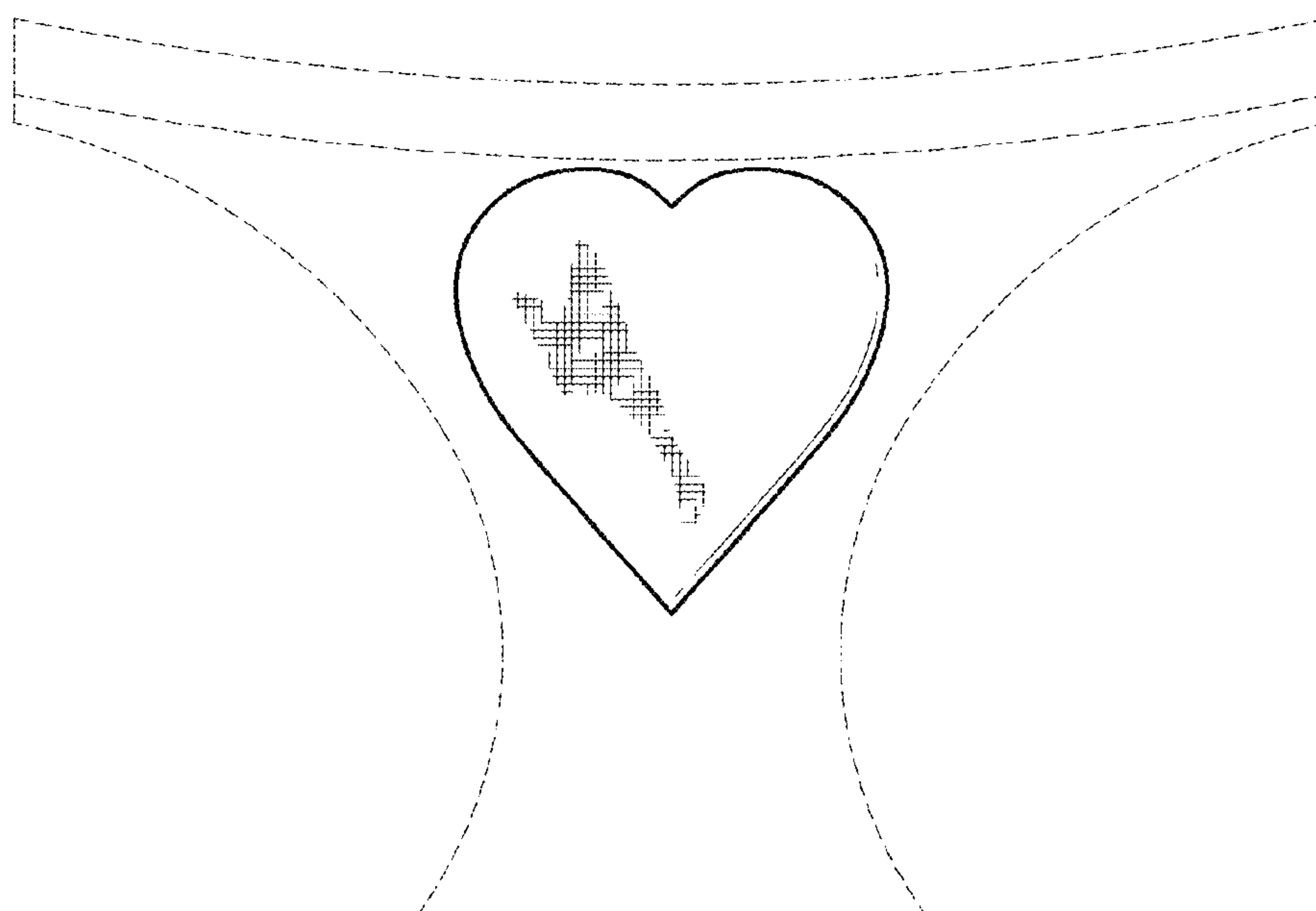

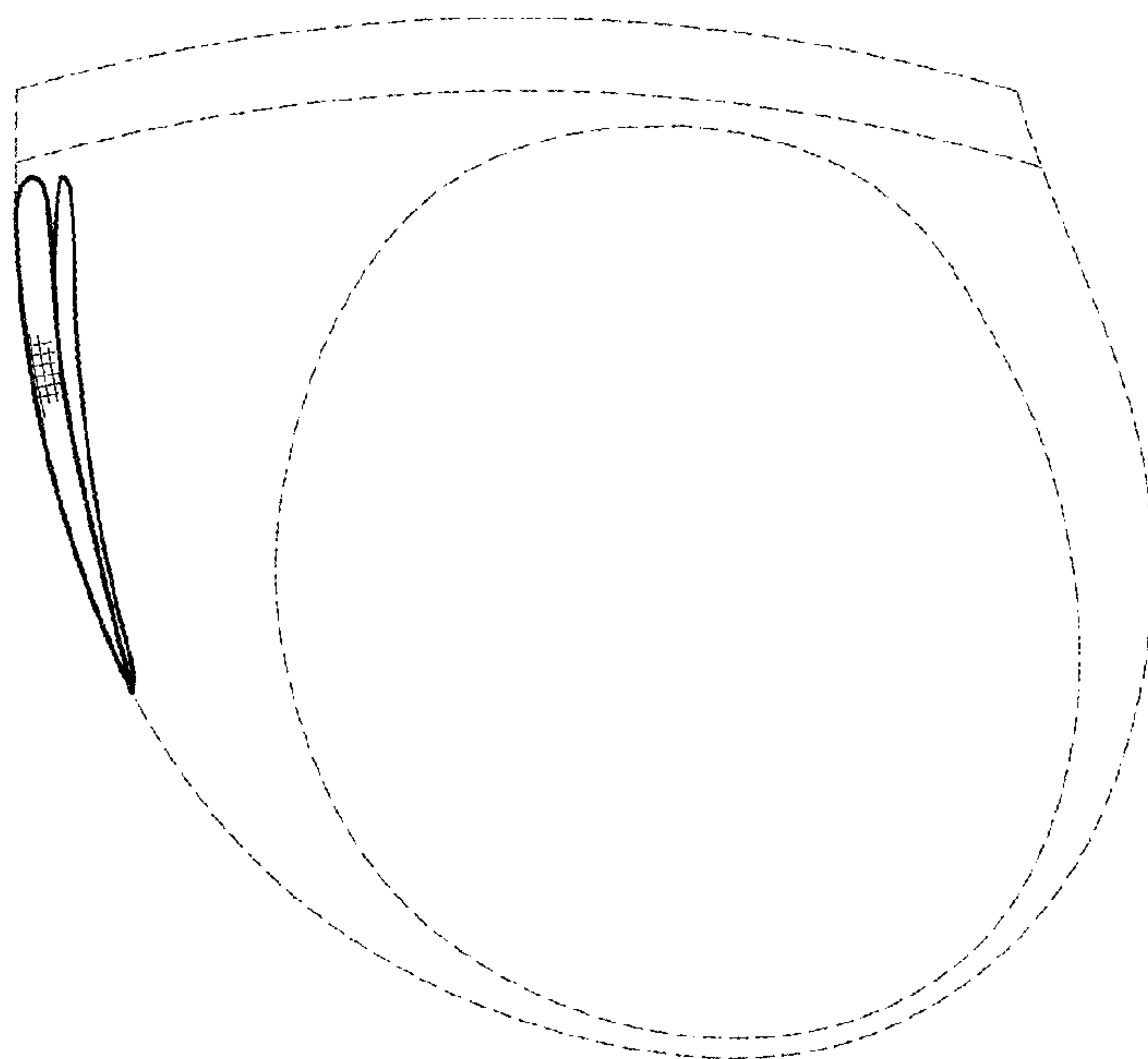
