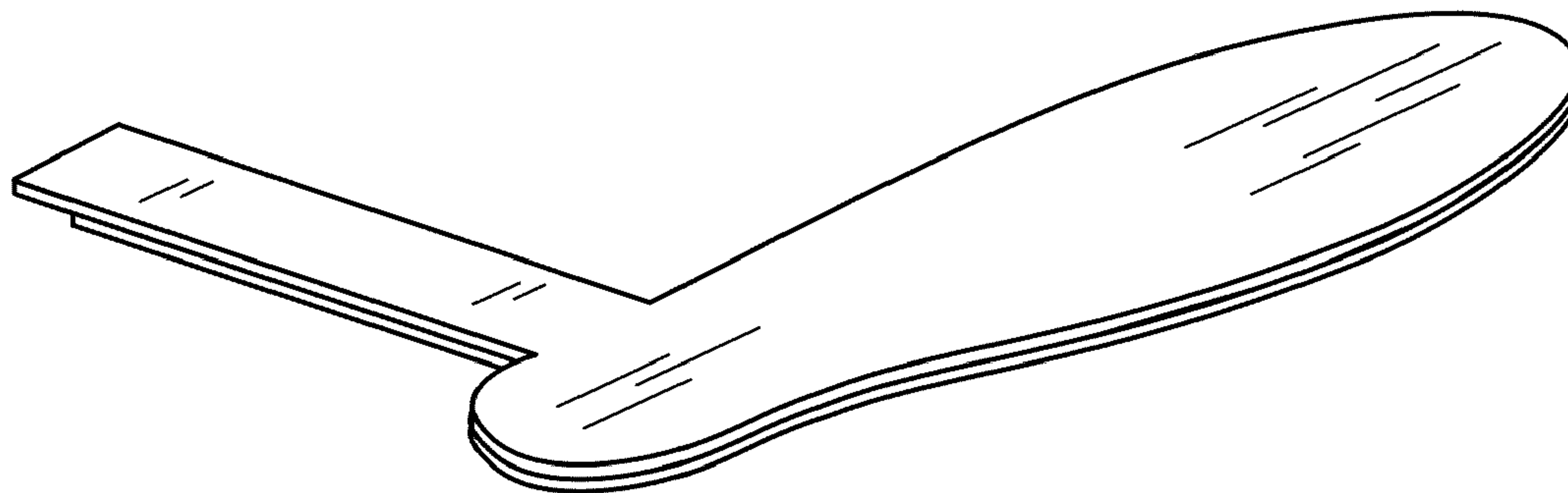
The ornamental design for a shoe sole insert, as shown and described.

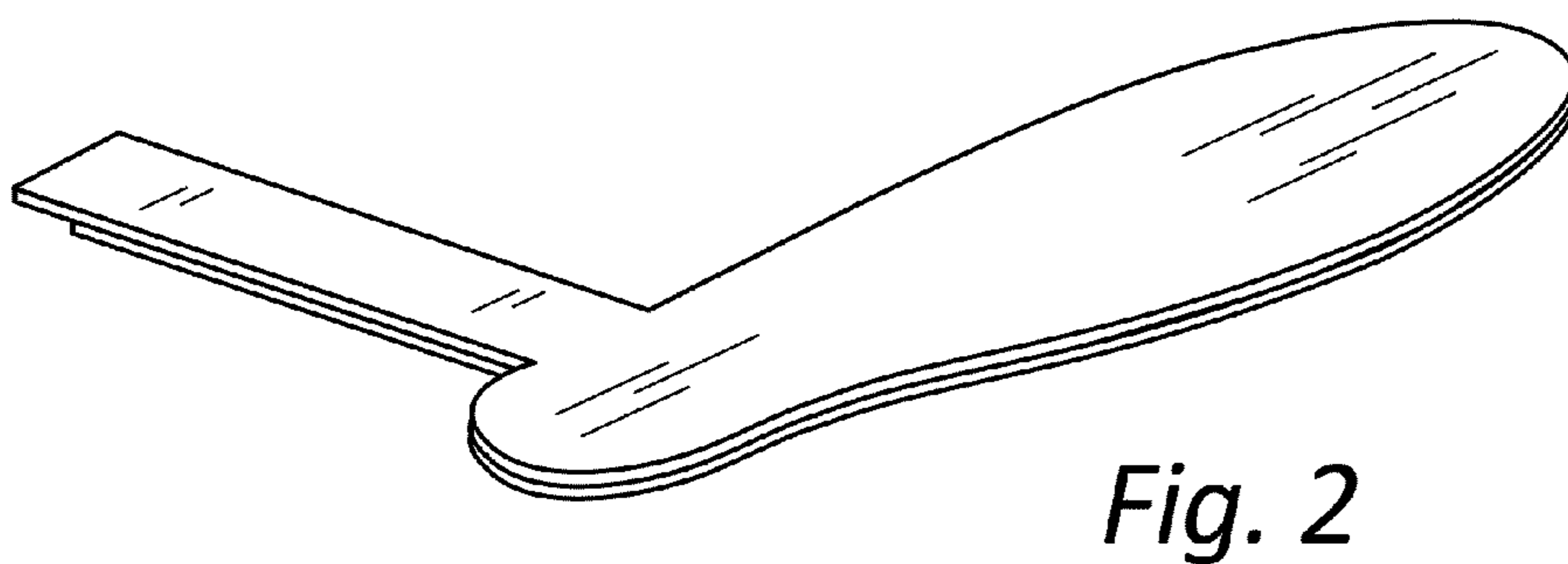
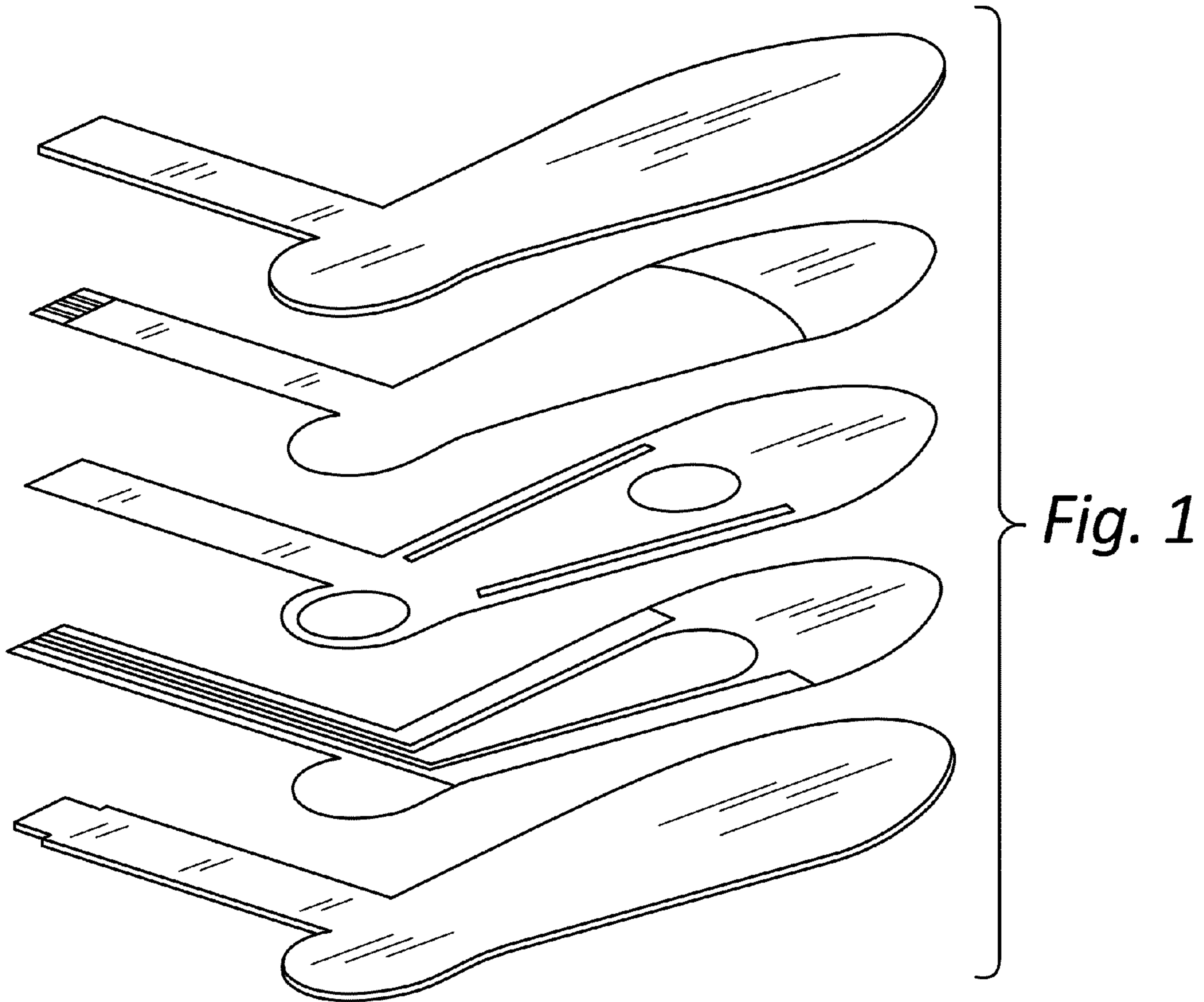
DESCRIPTION

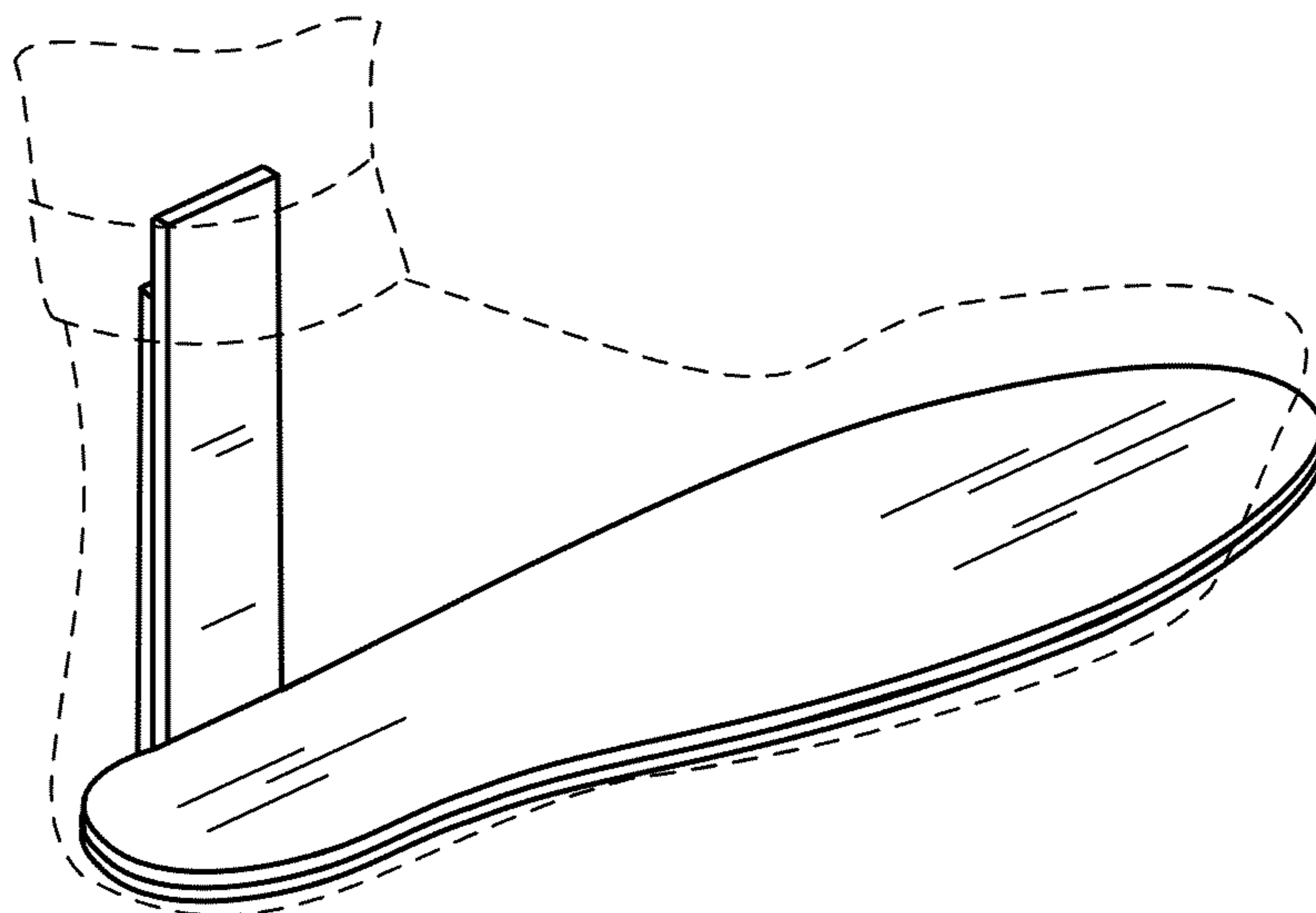

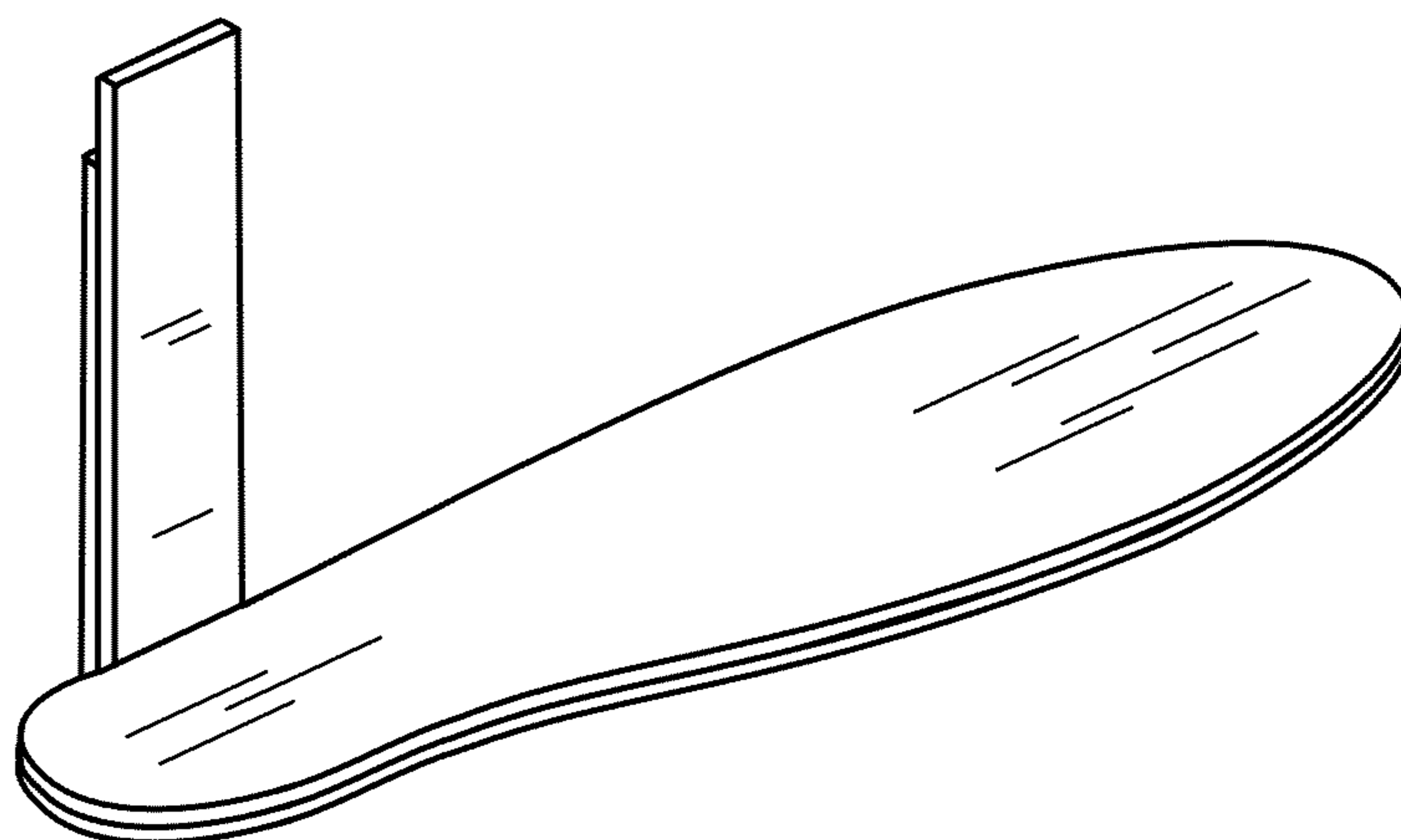
