(57) **CLAIM**

The ornamental design for an applicator brush, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the front, top and one side of my design wherein the brush is shown detached from the applicator handle;

FIG. 2 is a perspective view showing the front, bottom and other side of my design wherein the brush and handle are attached for use;

FIG. 3 is a plan view showing the top of my design;

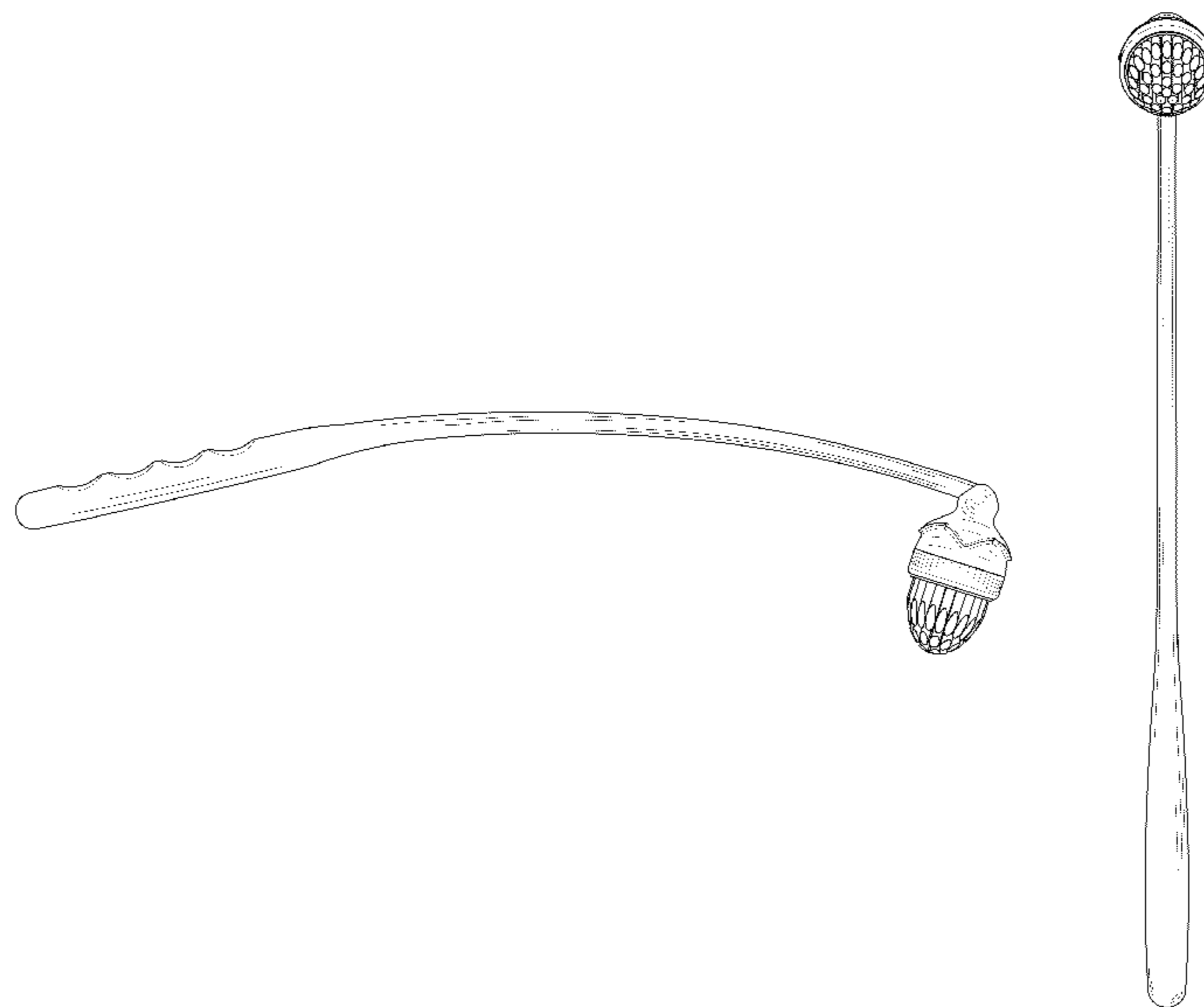
FIG. 4 is a plan view showing the bottom of my design;

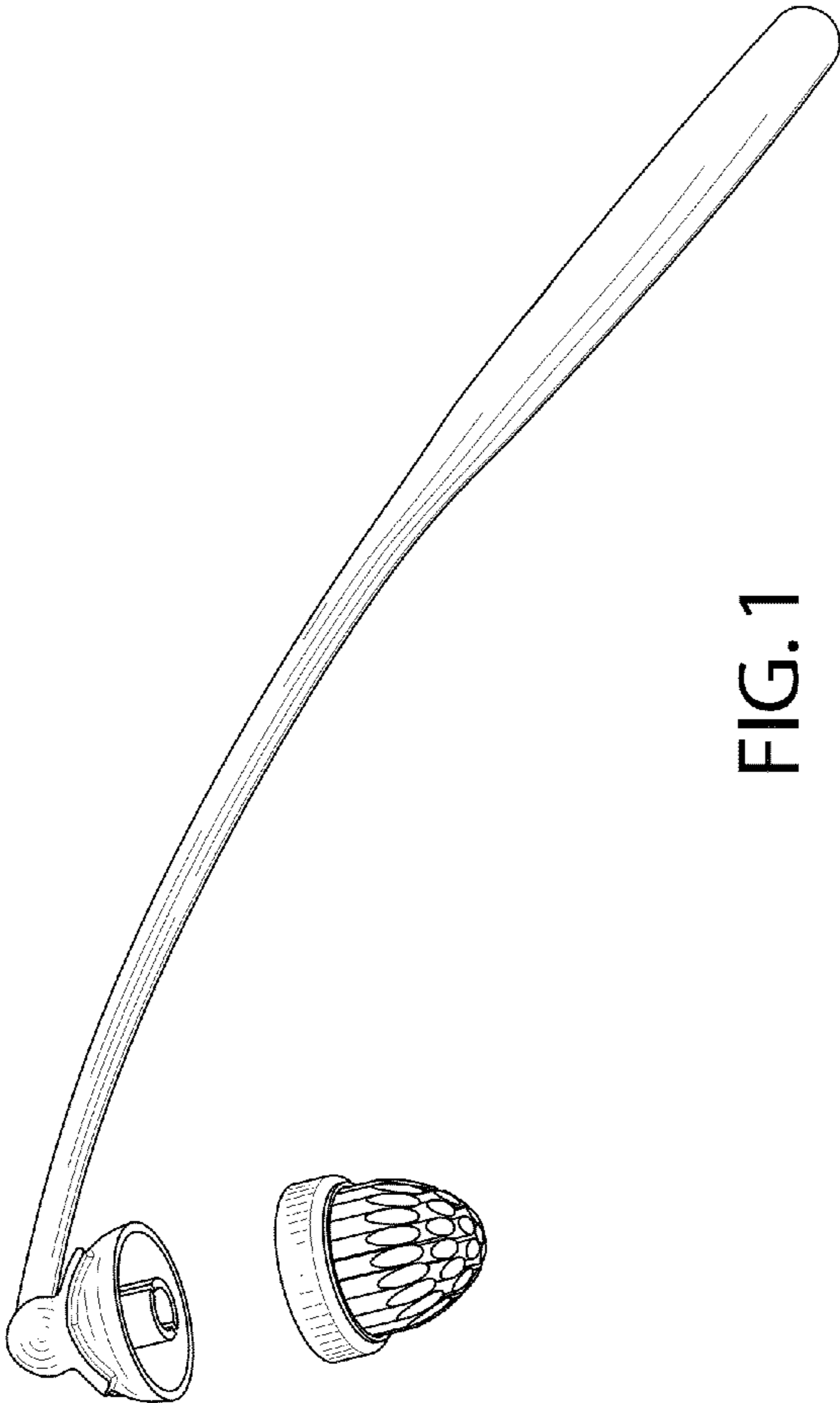

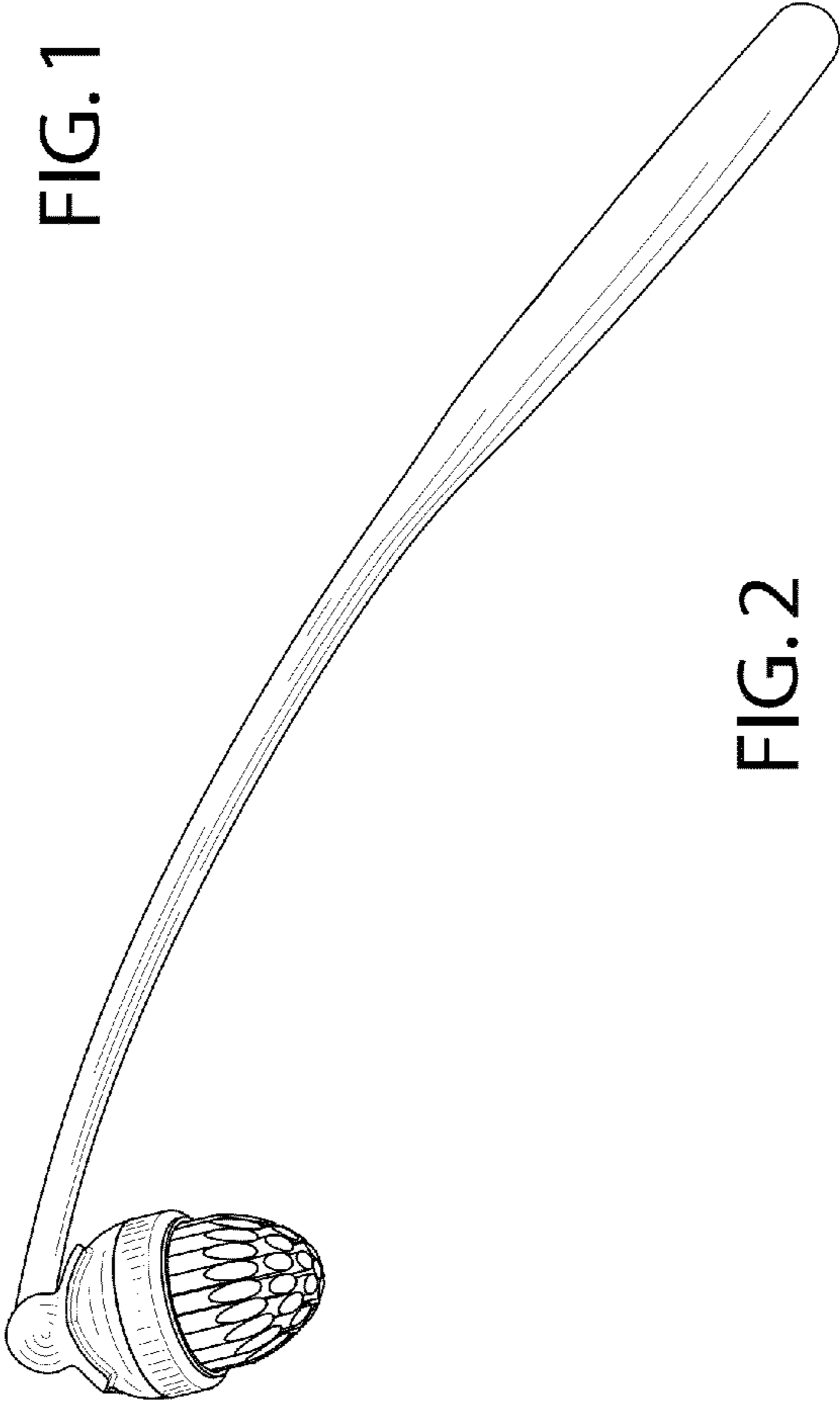

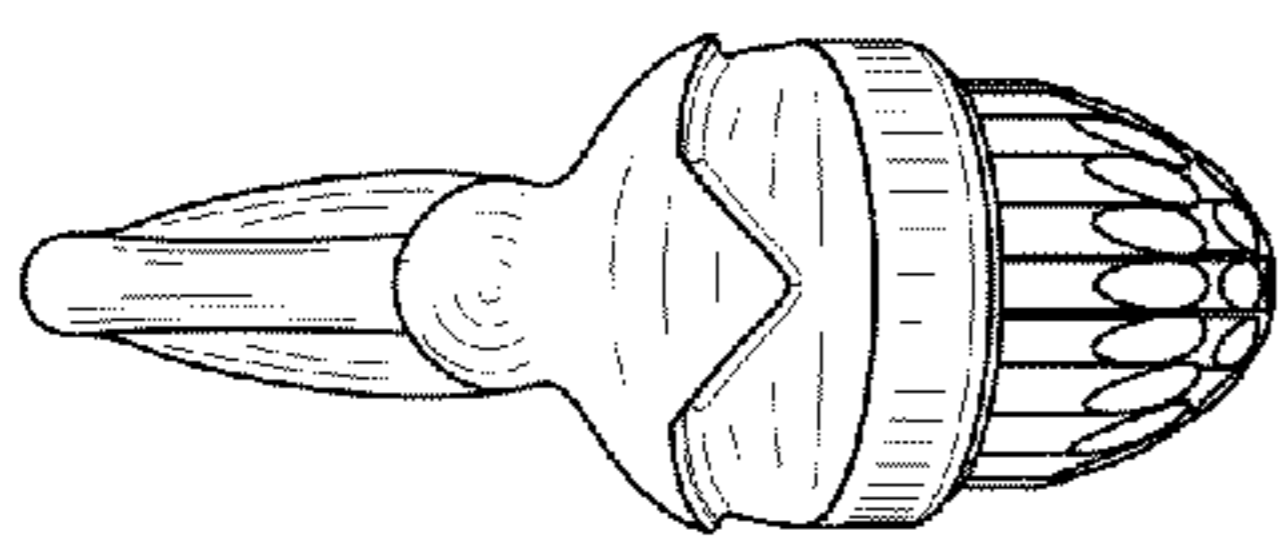

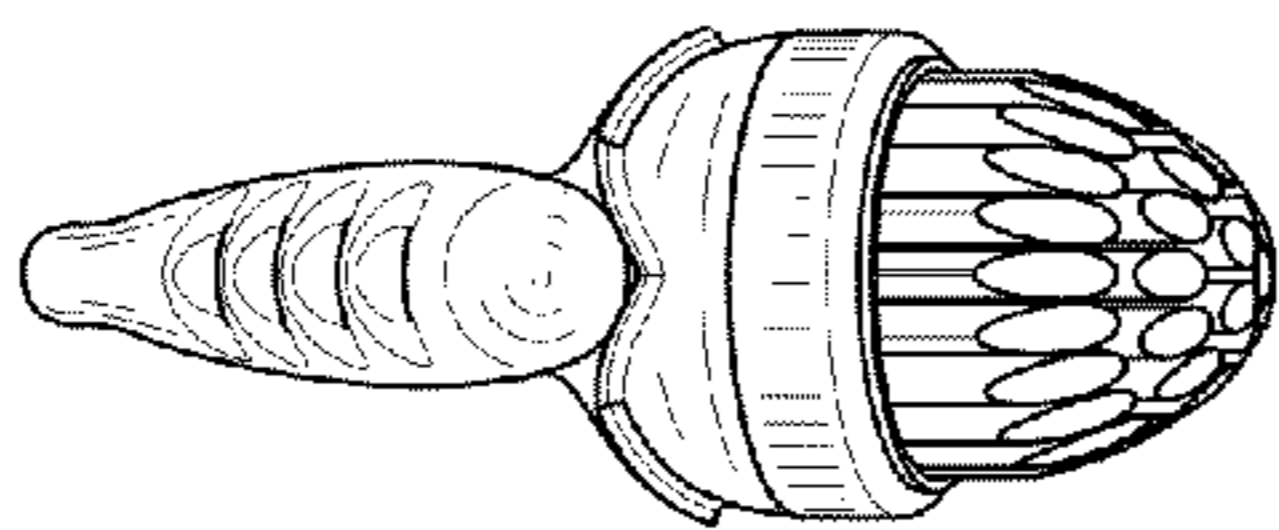

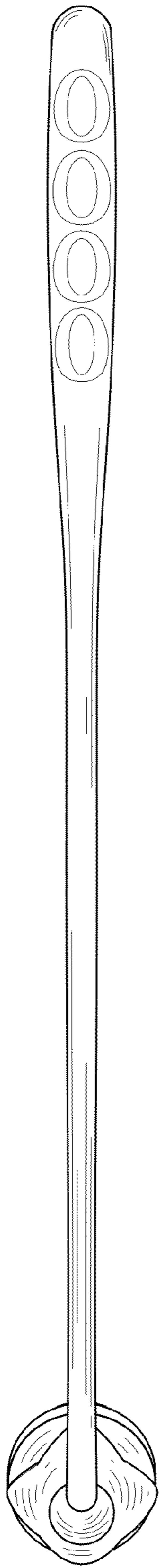

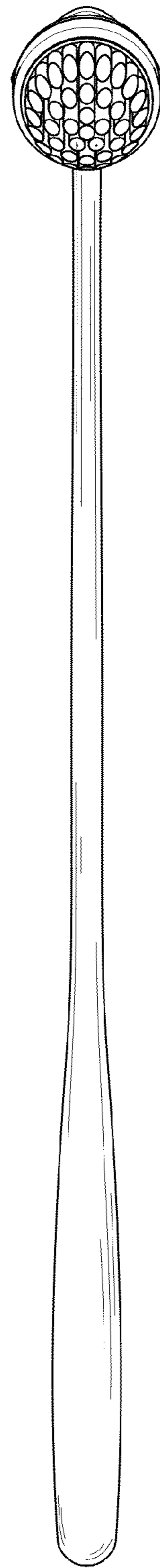
