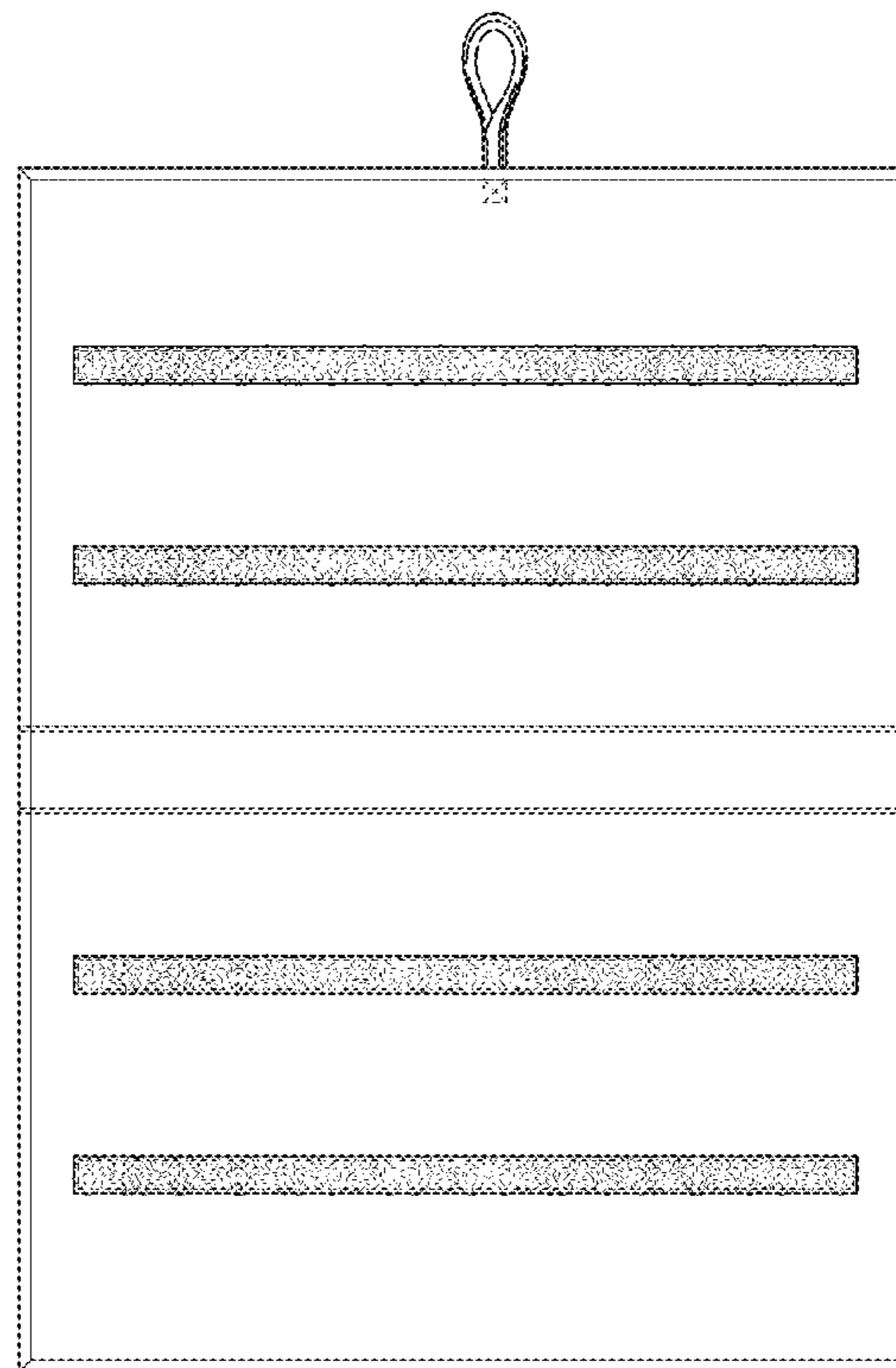
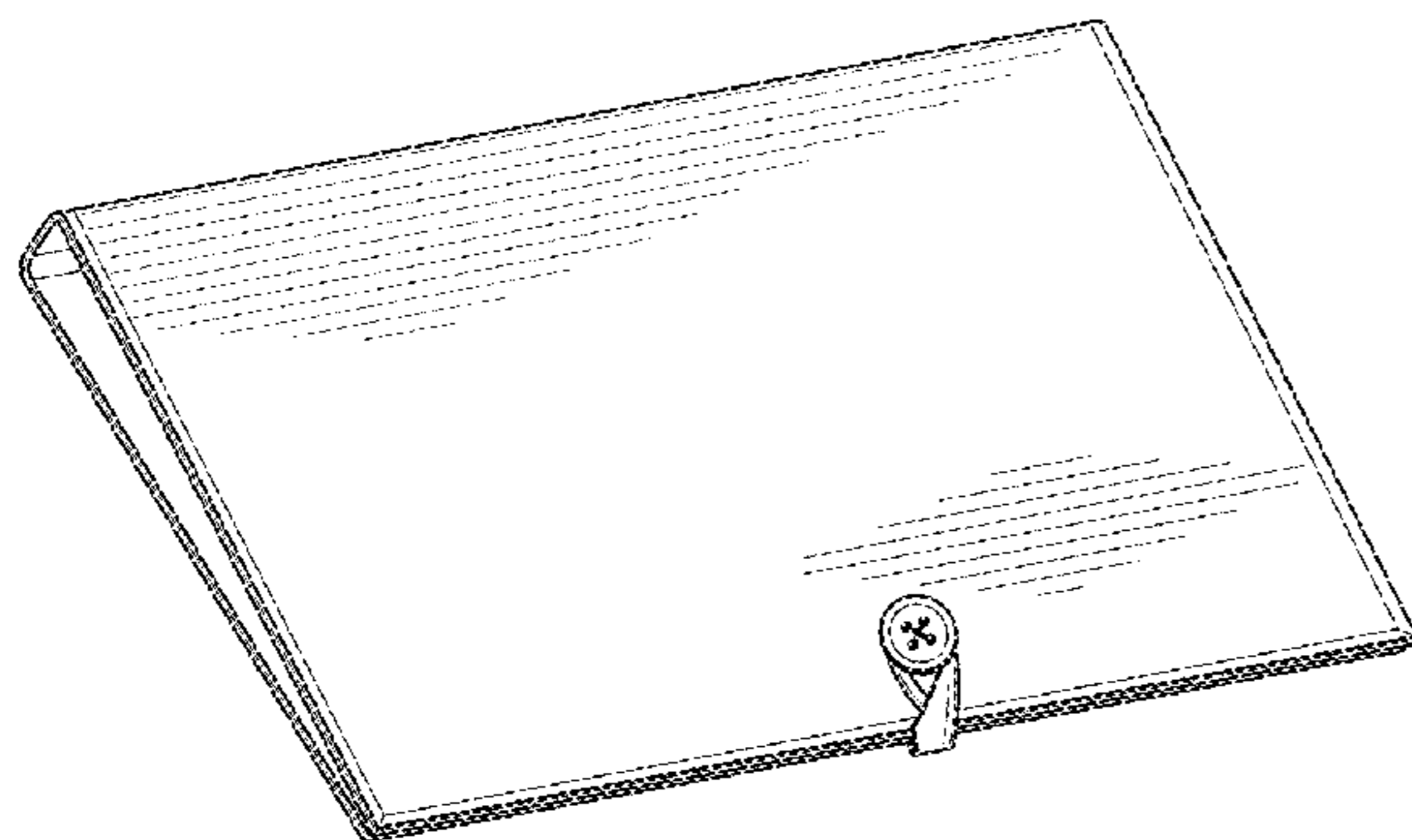
The ornamental design for a travel sandal hanger, as shown and described.

**DESCRIPTION**

FIG. 1 is a frontal perspective view of a travel sandal hanger in a closed folded condition;  
FIG. 2 is an end view thereof;

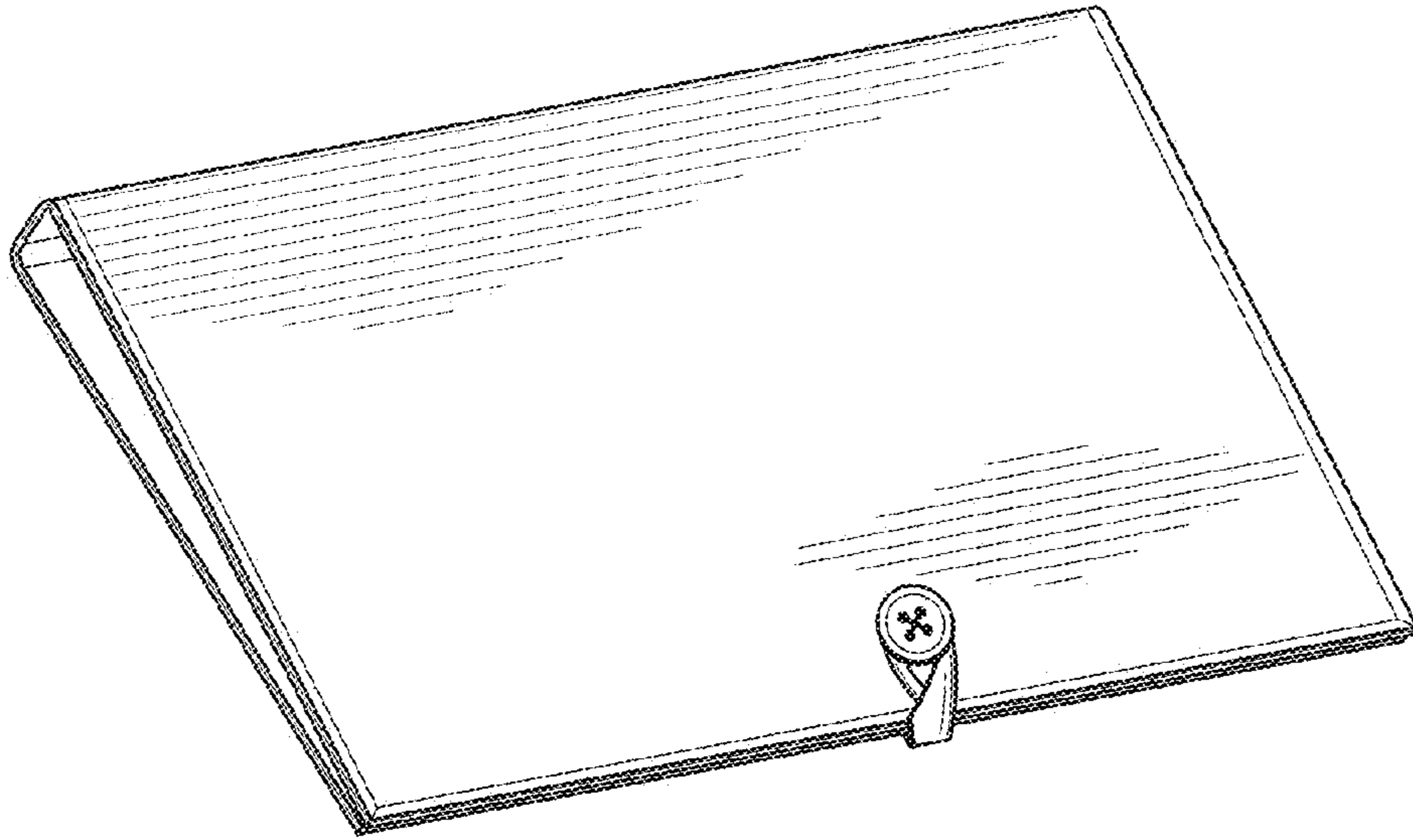

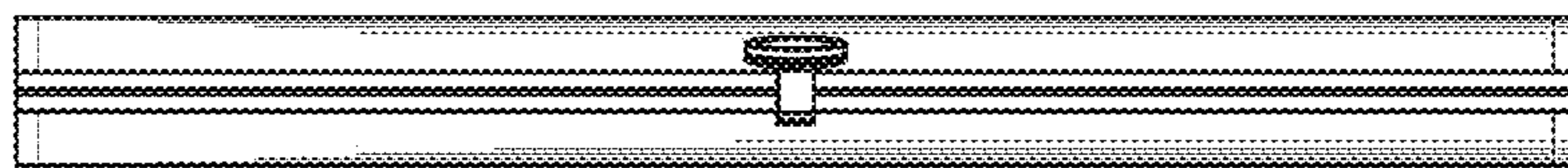

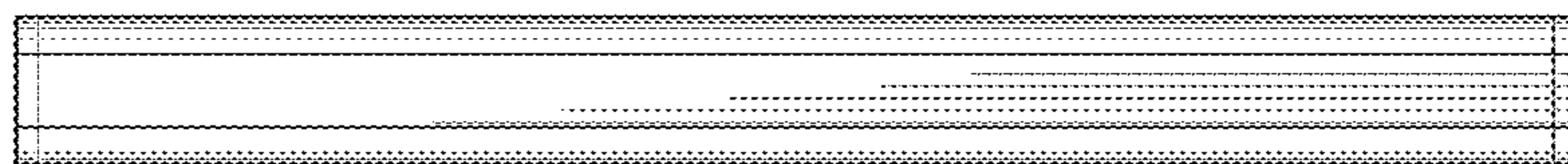

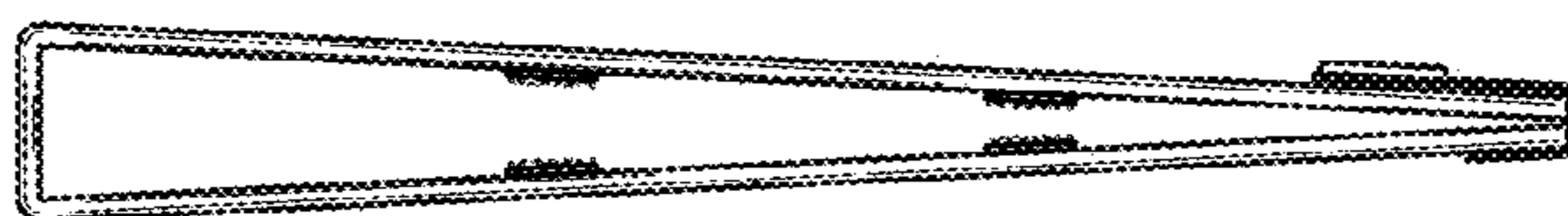

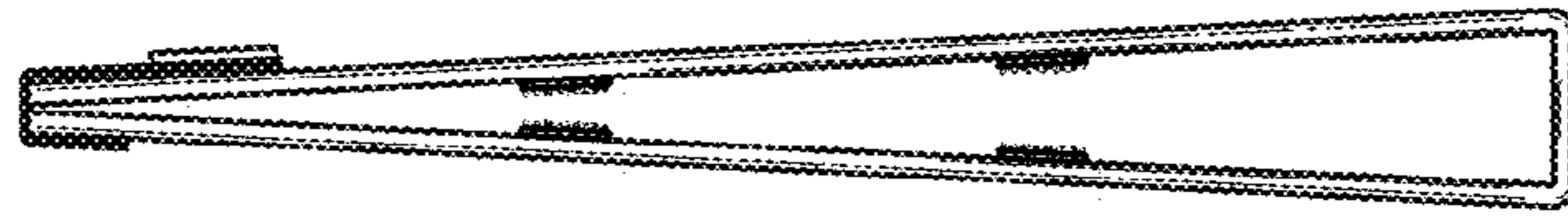

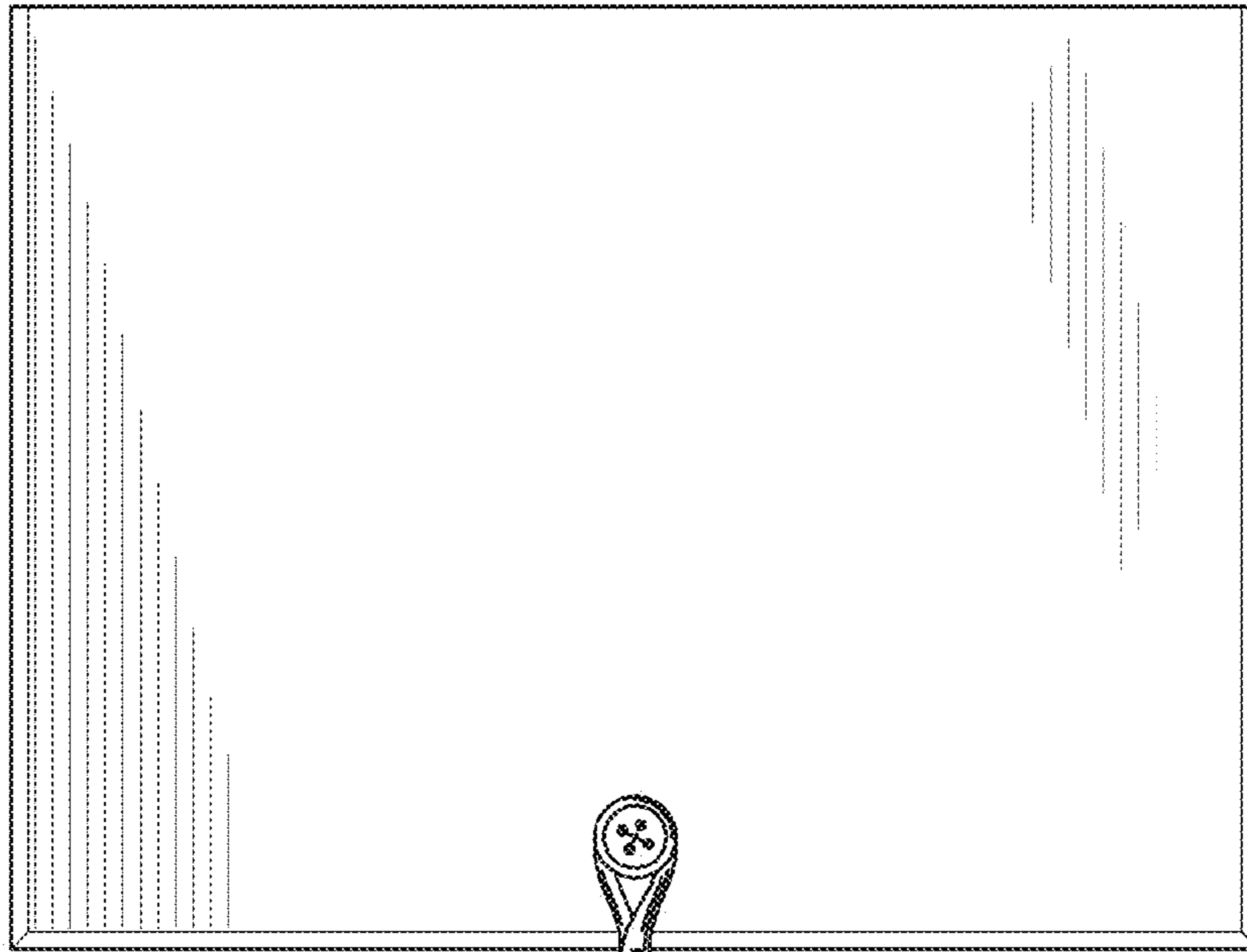

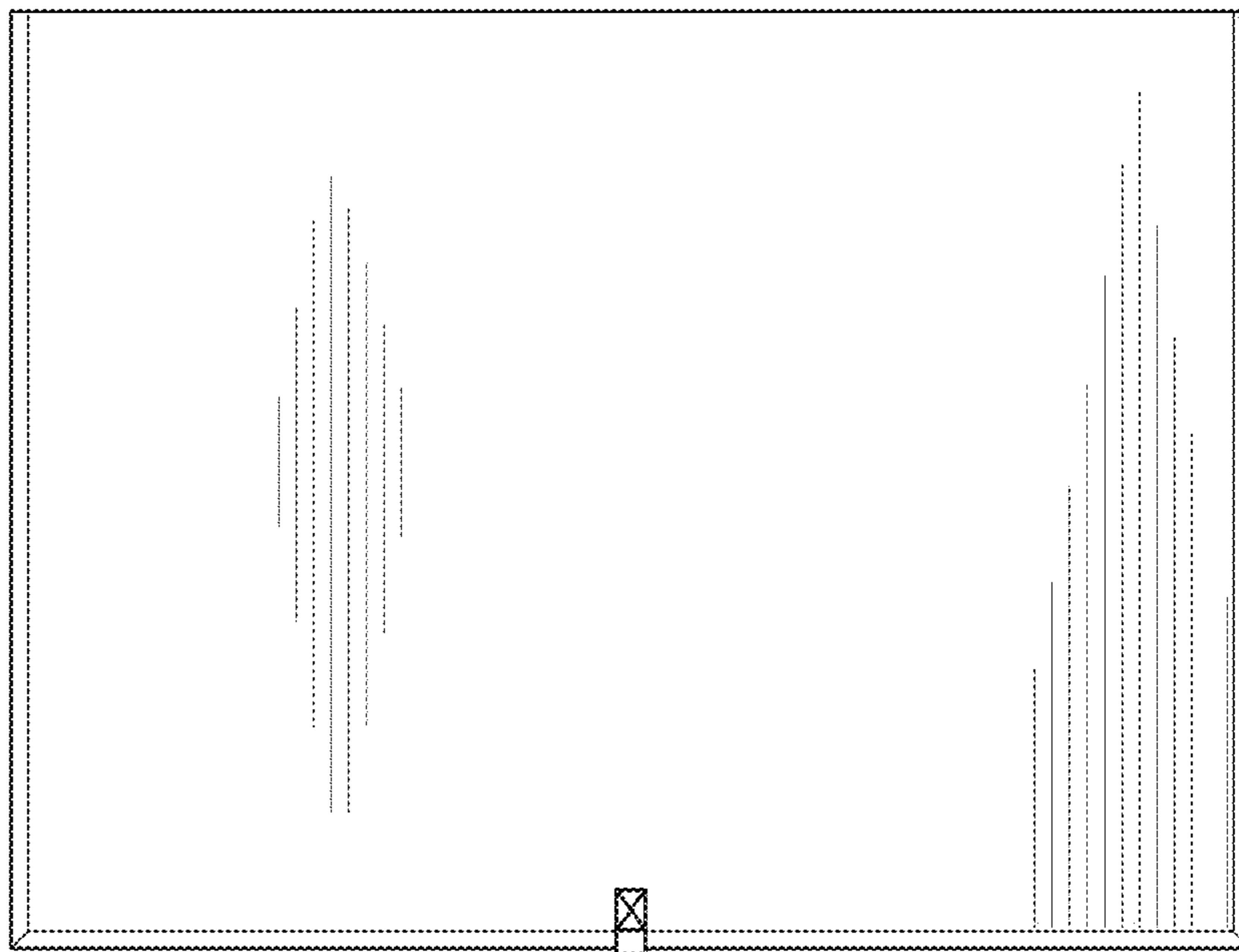

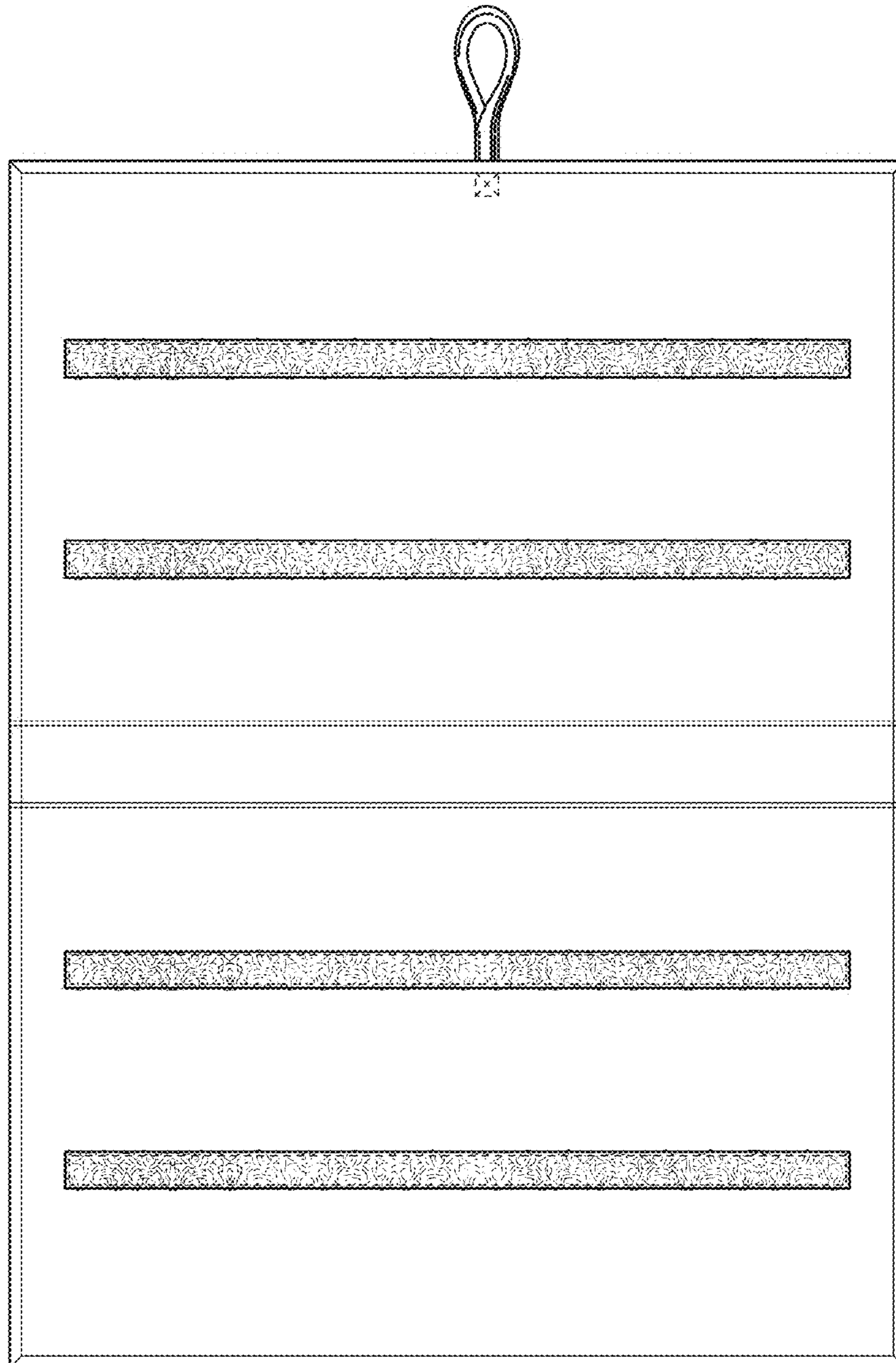
