(57) **CLAIM**

We claim the ornamental design for a furniture frame, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a furniture frame;

FIG. 2 is a detailed view of a portion thereof;

FIG. 3 is a left front perspective view thereof;

FIG. 4 is another left front perspective view thereof;

FIG. 5 is another left front perspective view thereof;

FIG. 6 is a front view of a second embodiment of a furniture frame;

FIG. 7 is a right front perspective view thereof;

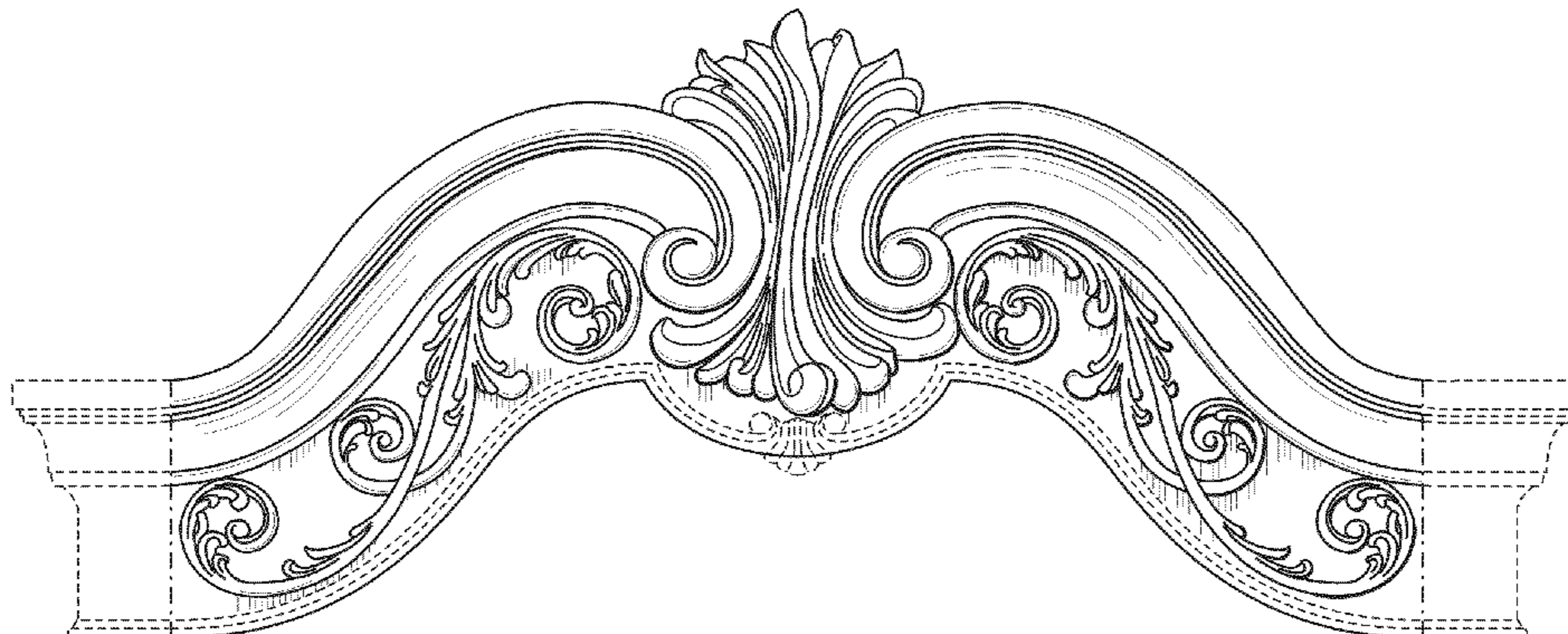
FIG. 8 is a front view of a third embodiment of a furniture frame; and,

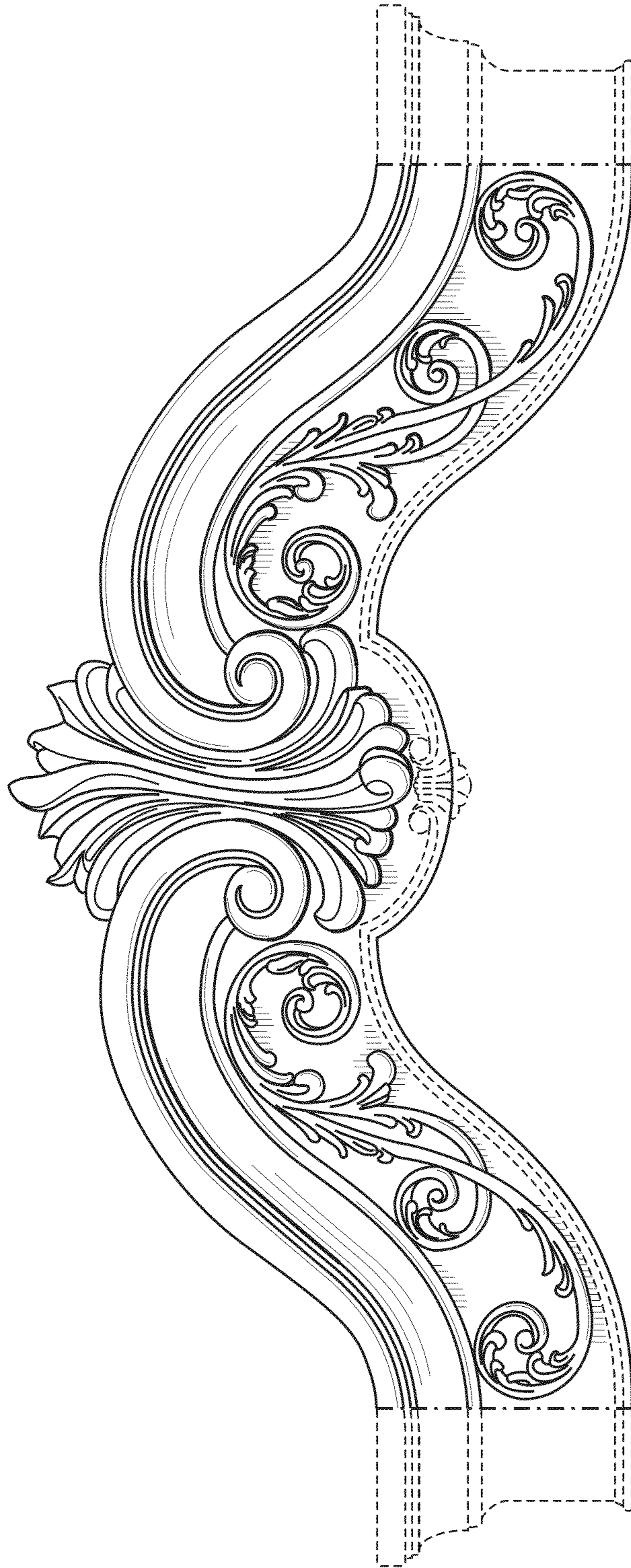

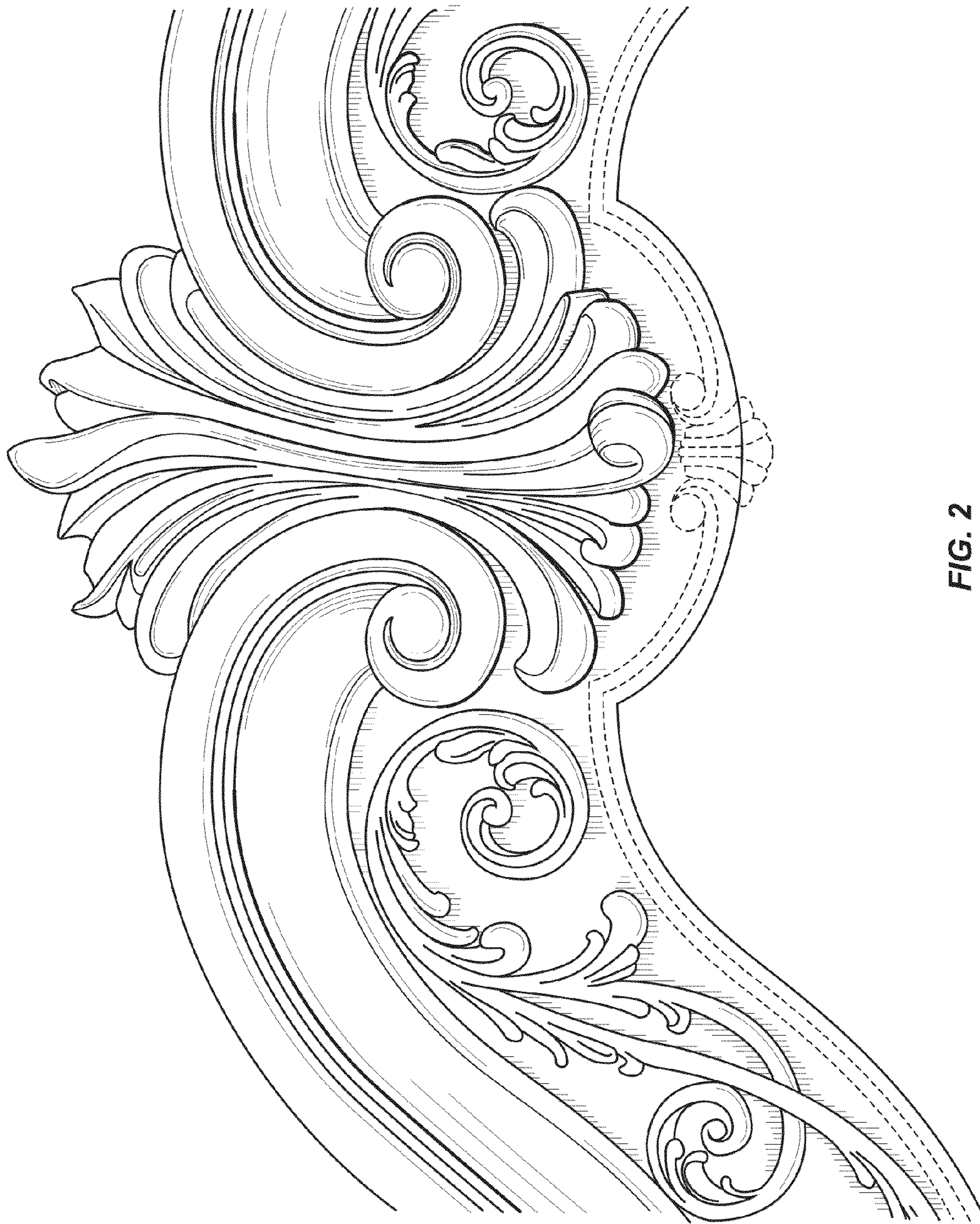

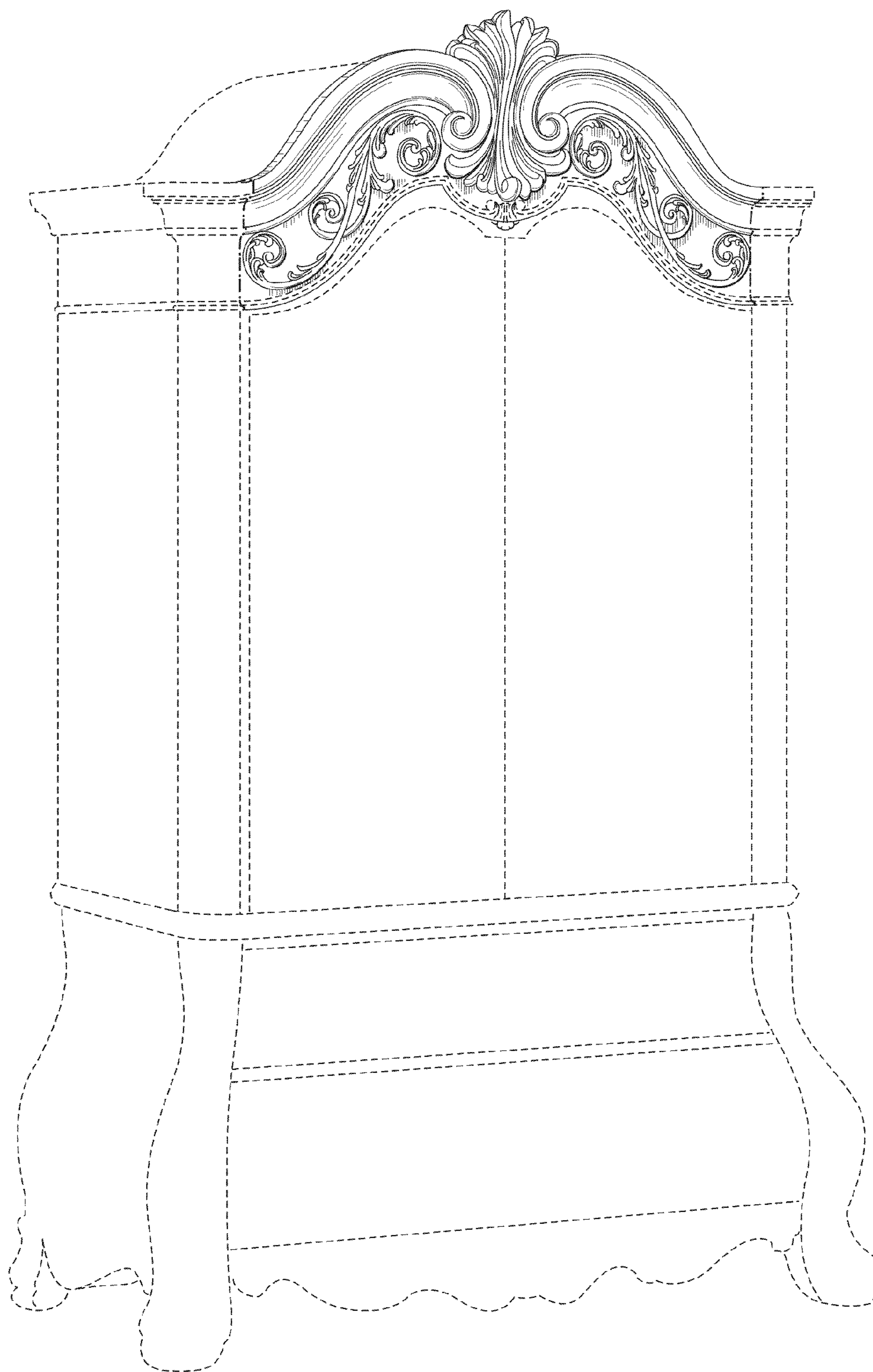

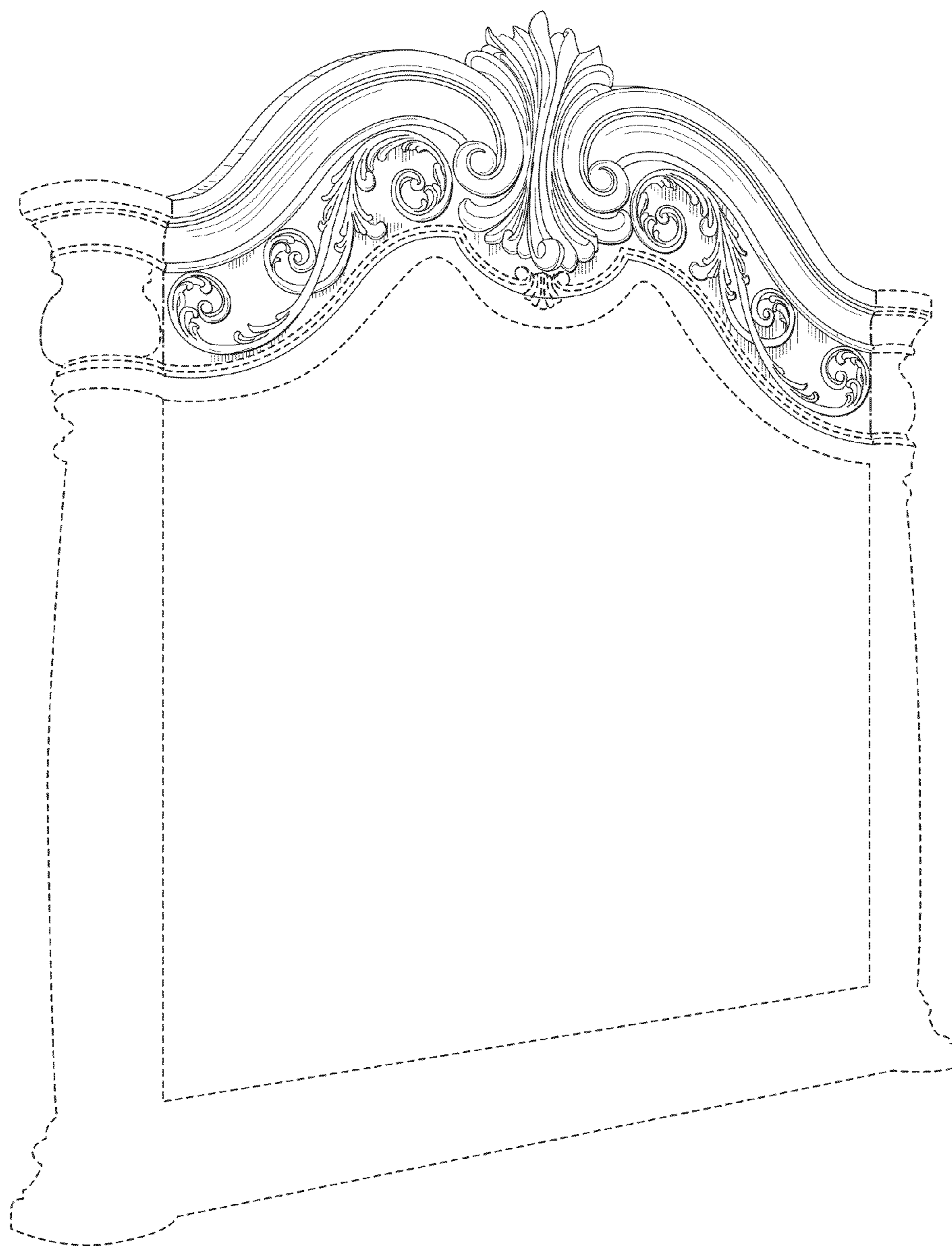

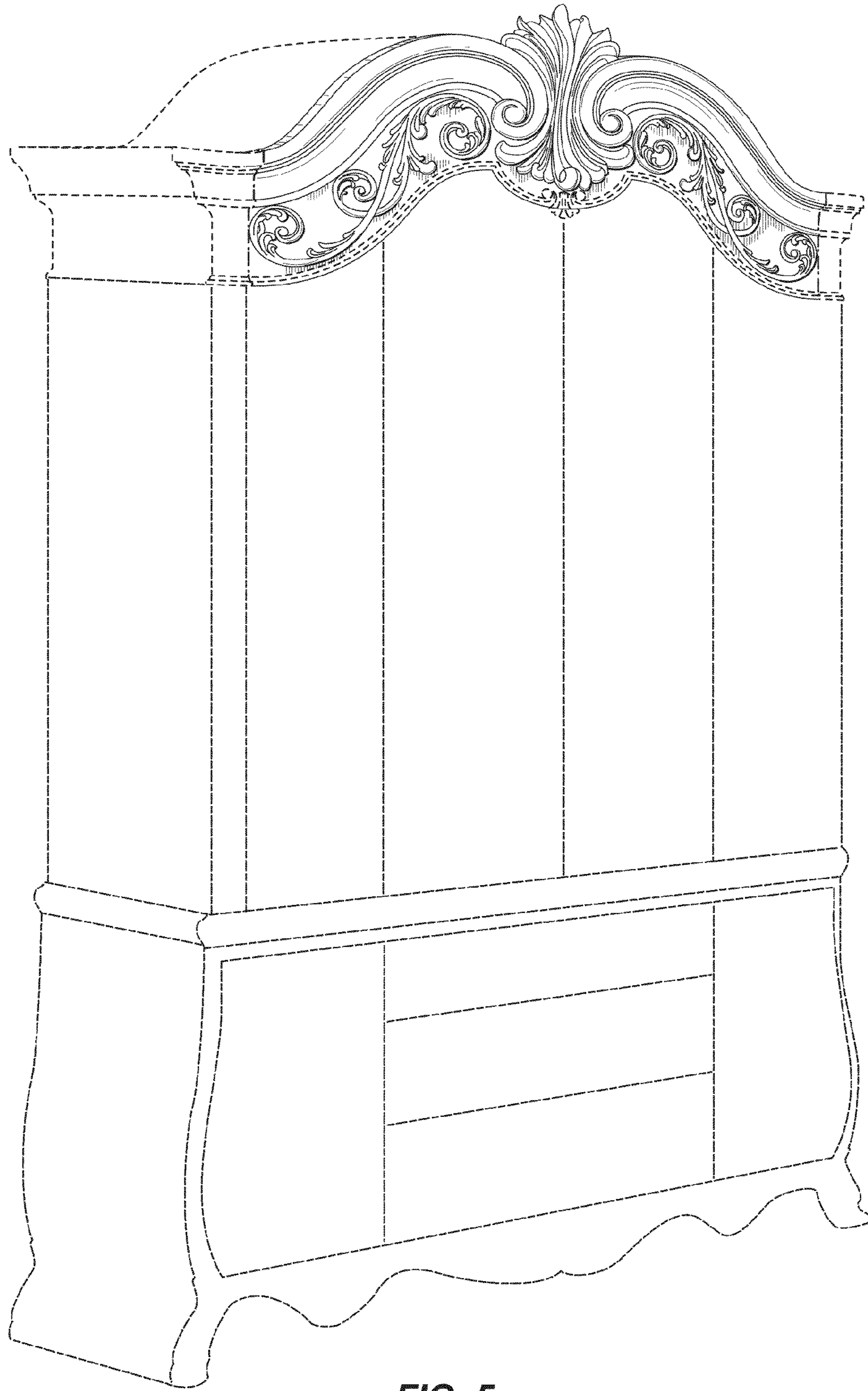

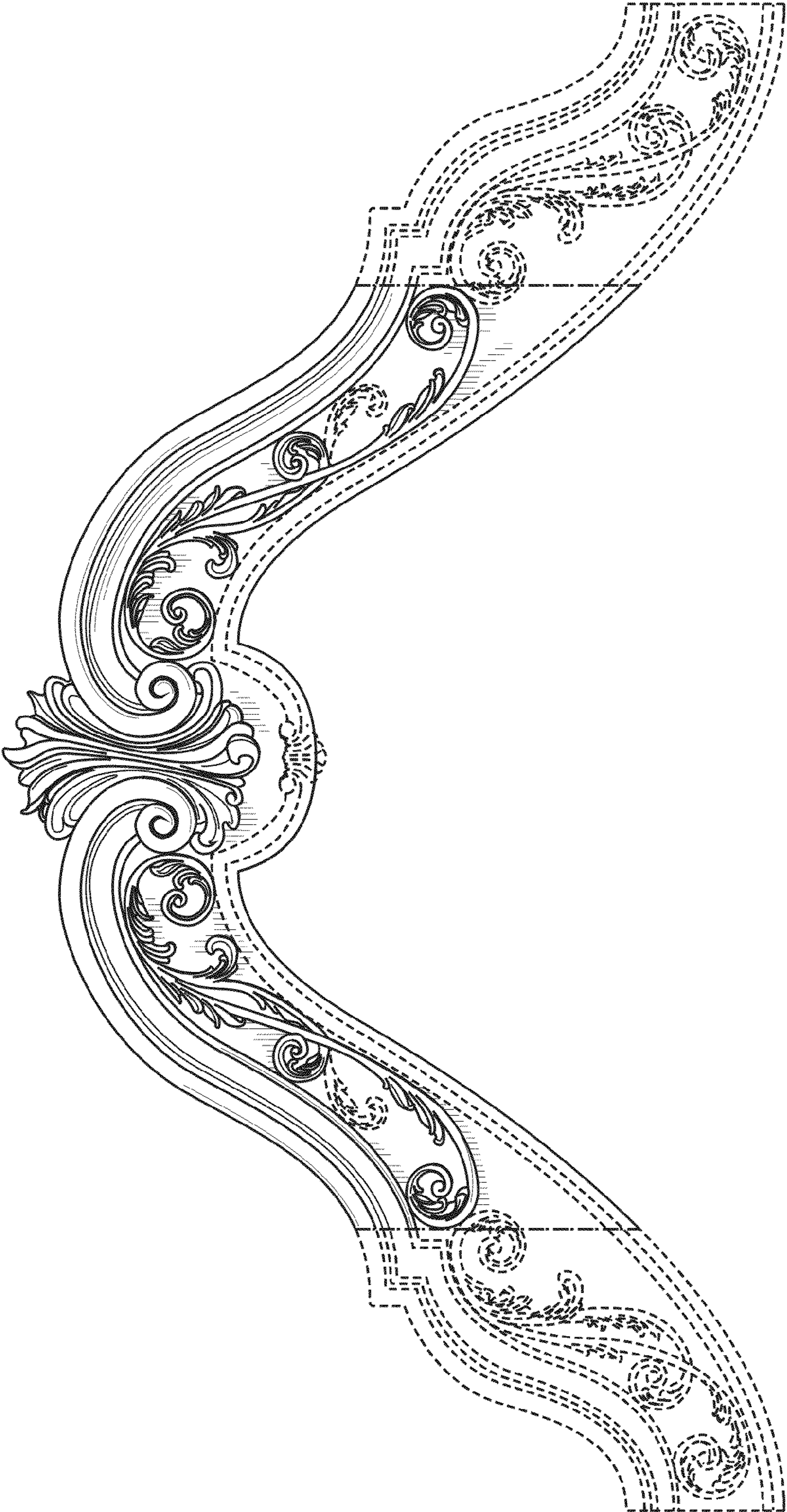

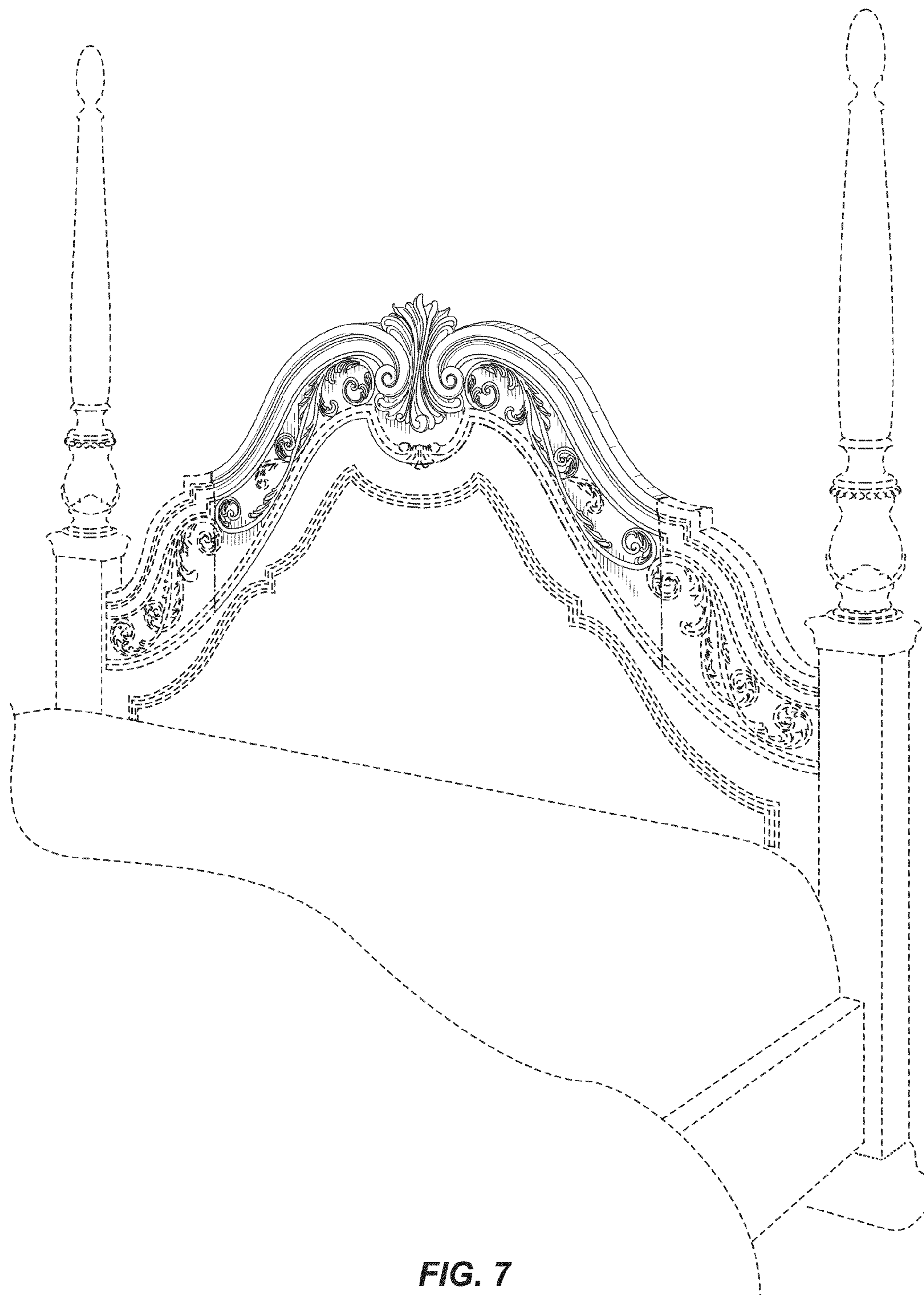

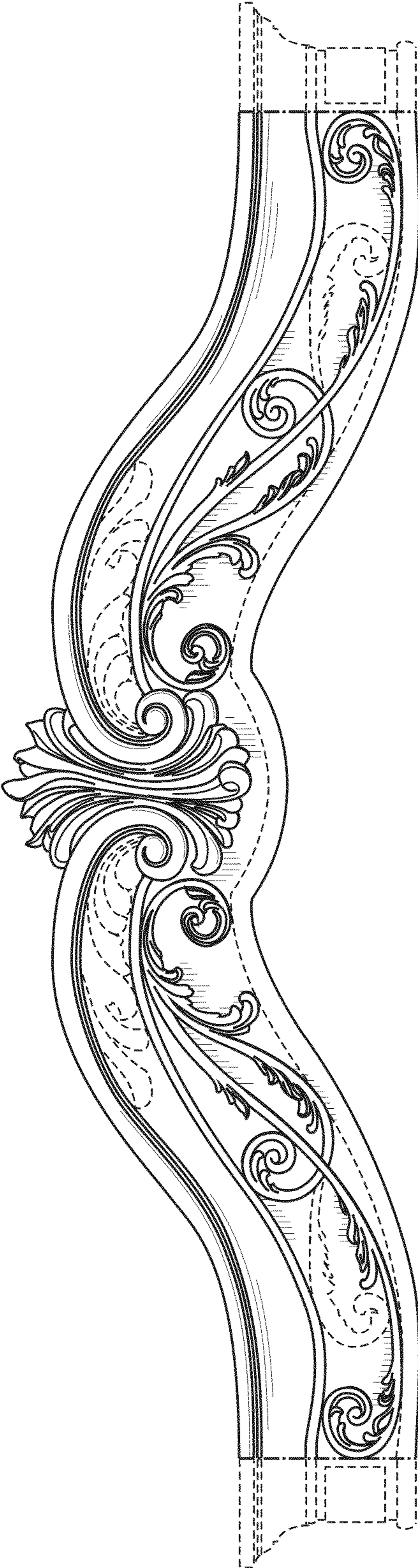

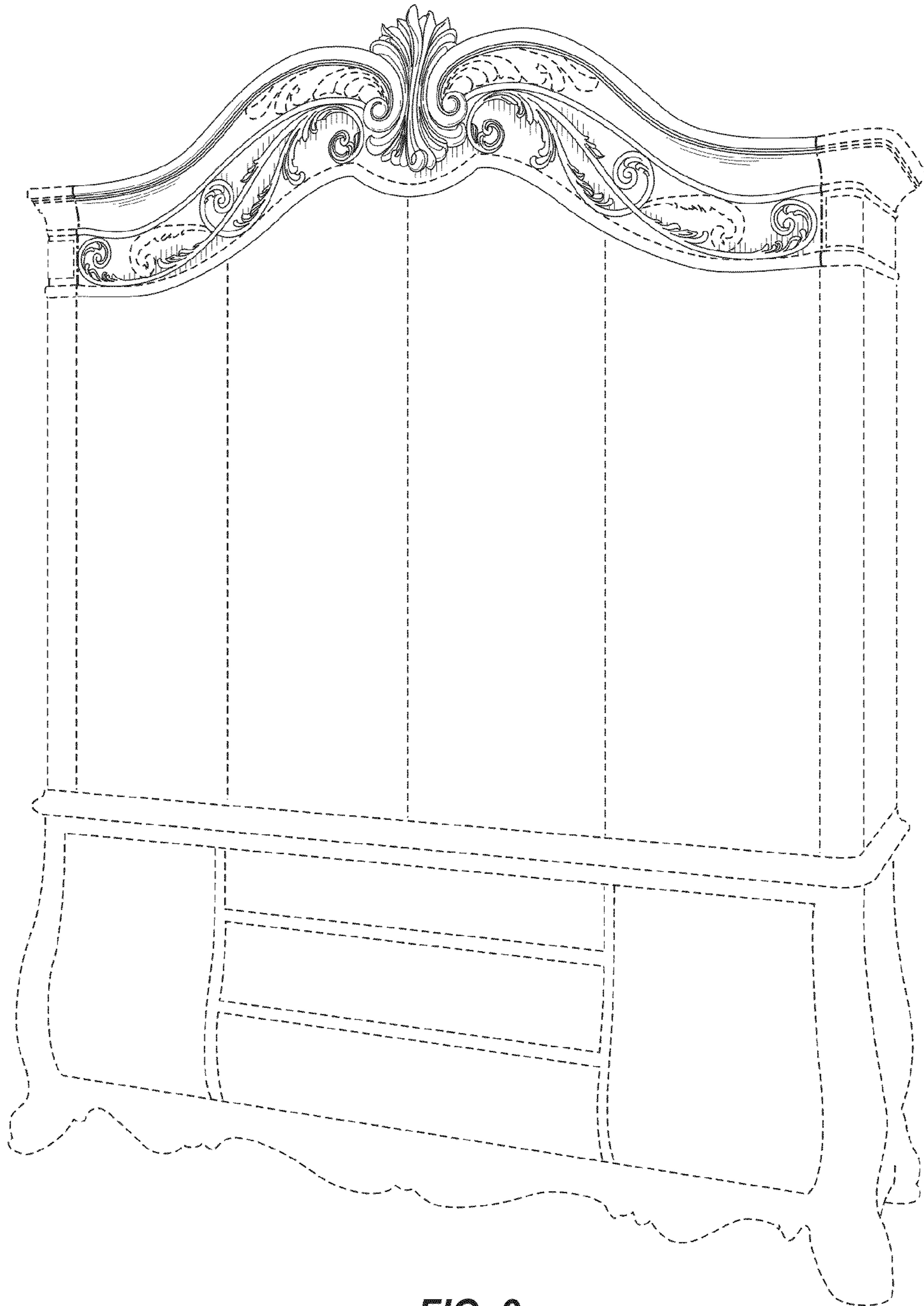
